## Croisant completes Horseshoeing School

Riley Croisant, 18, entered the Oklahoma Horseshoeing School, in Purcell, Oklahoma, after graduation from Beloit High School in 2024, and is now ready to take on offering farrier work in the Mitchell County area, and otherwise with traveling expenses paid.

Croisant is no stranger to horses, as she has been around them most of her life, and still owns a 24-yearold pack horse, "Classy," she got from the Rockies in Colorado.

"This has been my favorite horse of all times, as it acquired self survival tactics from where it came from, proudly said Croisant. "It will eat the bark off the trees to keep its teeth filed down and eats the bark that is good for deworming.'

Croisant has another horse, "Twister," that came from Florida, as it was suffering from asthma. She used this horse in 4-H shows, growing up.

All of this love for horses led Croisant to pursue a career in the Ag field, in working with horses.

Croisant chose the two week option of schooling because of her job at Mitchell County Hospital Health Systems. The school offers two, eight, or 12 weeks of schooling. During her two weeks, she mostly learned about trimming barefoot (no shoe) horses, which are mainly in the Mitchell County area. Shoes are not typically needed unless they are high dollar performance horses, need a corrective shoeing, or for lame issues. Croisant says it is hard to find barefoot trimmers in this area, and more and more are needing this kind of

attention. A farrier specializes in the hoof care of equine, such as horses, ponies, mules and donkeys. Typically, they clean, trim, and shoe horses' hooves.

## Fire permits discussed

David Dohe, Mitchell County Emergency Management Director, was present during Monday morning's Mitchell County Commissioners meeting, to discuss a recent unauthorized burn west of Cawker City. Because of the drought and the high winds at the time, no permits were being issued for outside burning activities.

On Oct. 4, 2023, Mitchell County Resolution 23-3 was published in the Beloit Call outlining the process that must be followed regarding any outside burning.

The Resolution states: Any person desiring to do controlled burning of grass, leaves, crops, crop residue, weeds, trash, structures, field, fencerows, ravines or wild lands, shall make application for a burn permit to be furnished by the Mitchell County Communications Center (785-736-3523). The application's contents shall include, but is not limited to, the following:

- 1. The 911 location of the burn
- 2. The number of acres
- 3. The owner of the property
- 4. The tenant of the property (if any)
- 5. The substance to be burned
- 6. The name of the person responsible for the controlled burn operation

In this recent unauthorized burning situation, the undersheriff was dispatched to investigate the situation. It was discovered that no permit had been requested for this outside burning arrangement. Undersheriff Martin issued a citation to the person conducting the burn.

Dohe requested a five-minute executive session to discuss non-elected personnel. No decisions were made as a result of this closed session.

- Superintendent of Public Works, Marty Hernandez, was present and requested a 15 minute executive session for the purpose of discussing employee evaluations. No actions were taken as a result of that closed session.

– Janelle Kircher, CEO of the Mitchell County Hospital Health Systems, appeared for one of her regularly scheduled visits with the commissioners. Kircher introduced Ashlyn Loomis, a senior at Beloit Jr. Sr. High School. Loomis is one of eight students participating in a nine-week job shadowing experience at the hospital. Kircher told the commissioners that most students who do job shadowing at the hospital are exploring careers in health services such as nurses or physicians. Loomis is different because she is interested in the business aspect of health care.

Kircher reported that 115 youngsters participated in the Teddy Bear Clinic at the hospital.

She also told the commissioners that MCHHS has

been named as one of the 350 cleanest hospitals in America.

## **Health Alert**

## State issues health alert after recent rabies cases in Kansas

TOPEKA-The Kansas Department of Agriculture and the Kansas Department of Health and Environment together advise Kansans to be alert to the human health risk caused by unvaccinated animals, following a second detection of rabies in a cat in the last two weeks, according to a media release from the Kansas Department of Agriculture.

The two cases were in Jewell County and Harvey County, and both involved outdoor cats which exposed multiple humans and other cats. The known human exposures have started rabies post-exposure prophylaxis, a series of five vaccinations to prevent rabies in

Rabies is a viral disease transmitted by the bite or scratch from a rabid animal. There have been six positive cases of rabies in cats this year, as well as several cases in wildlife. Both of the cases this month were in unvaccinated outdoor barn cats.

'Rabies is not unusual in the wildlife population, and unfortunately this often means domestic animals that roam freely can be

exposed to the virus," said Animal Health Commissioner Justin Smith. "It is vital to vaccinate domestic animals against rabies, especially animals that interact with humans, because humans can be infected. Vaccinating pets and livestock against the virus protects both animal health and human

Even if an animal is kept indoors, ensuring their vaccination against the virus is up-to-date serves as an important barrier if they are ever exposed to a wild or stray animal that could be carrying the disease. Those who have barn cats should have them vaccinated against rabies.

Many Kansas cities and counties have vaccination requirements; know what is required in your community and contact your veterinarian for more information about rabies vaccination.

Rabies attacks the brain and spinal cord and can take several weeks to months for symptoms to appear, but early treatment after an exposure can prevent rabies in both humans and pets that are up to date on vaccinations. The vaccination is highly effective.

If you notice unusual behavior in your animal, or you think your animal may have had contact with rabid wildlife, it is important to immediately contact your veterinarian to determine the next steps to take.

If you are a veterinarian, remember to always consider rabies as a potential diagnosis for neurologic animals. In Kansas, rabies is a reportable disease which requires a veterinarian to report a positive rabies test to the KDA Division of Animal Health.

In order to prevent the spread of rabies, people should teach children to be cautious around outdoor animals, wild or domestic, even if they look to be friendly; wash a wound from an animal encounter thoroughly with soap and water and get medical attention immediately; keep pet vaccinations current; and monitor pets when outside.



## "Do Catholics believe in the presence of demons and the idea of demonic possession? If so, why do we not see or hear stories of that sort of thing like in biblical times?"

As the demonic gets popularized this time of year a good topic for reflection. Catholic Teaching on the spiritual reality of angels and demons is not something that goes away or is changed according to popular belief, or lack thereof. The basis for our belief in this regard is deeply rooted in scripture. Throughout the Bible we see angels, who play the role of God's messengers and human protectors and, of course, demons are "fallen angels." "The devil and the other demons were indeed created naturally good by God, but they became evil by their own doing." (CCC #391)

"The power of Satan is, nonetheless, not

infinite...Although Satan may act in the world out of hatred for God and his kingdom in Christ Jesus, and although his action may cause grave injuries of a spiritual nature and, indirectly, even of a physical nature to each man and to society, the action is permitted by divine providence...It is a great mystery that providence should permit diabolical activity, but 'we know that in everything God works for good with those who love him." (CCC #395)

Another scripturally rooted phenomenon is the "possession" of a human being by demonic forces. Yes, we believe this can and does still happen. However, the devil does not just randomly select

someone, but the individual who experiences possession, usually invites it through meddling in the demonic or by searching in realms outside of Christianity, therefore opening themselves up to "possession." "When the Church asks authoritatively in the name of Jesus Christ that a person or object be protected against the power of the Evil One and withdrawn from his dominion, it is called exorcism...In a simple form, exorcism is performed at the celebration of Baptism...Exorcism is directed at the expulsion of demons or to the liberation from demonic possession through the spiritual authority which Jesus entrusted to His Church." (CCC #1673)

Why do we not see or hear stories of possessions or exorcisms? Traditionally, the priest who acts in the role of exorcist for a diocese is not made public knowledge. This is to protect his own anonymity as well as that of the individuals or families involved in an exorcism. Therefore, when an exorcism occurs, its not something that the priest takes to the papers and says, "Look what I

Why do they seem less frequent than in the early Church? There are no official Church statements on this topic; therefore, my answer to this question is personal speculation.

Demonic possession is typically a violent attempt by the devil and his de-

mons to make a last ditch effort to grasp on to something or someone in an attempt to regain control.

Therefore, it would seem, it usually happens when the diabolical is in a desperate situation of losing control generally as a result of the spread of great holiness. The early Christian Church is a perfect example. Pure, resilient, intense faith was spreading at an incredible rate through the world by way of the Apostles and disciples of Jesus Christ, and it was logical that the devil would struggle to lash out to regain control. Why not today? Does the devil really have the same need to regain control? Or is he cruising in comfortable control of our West-

ern Culture? Today we are experiencing a deep crisis of faith and in my opinion there is no need for the devil to lash out, he already has a steady grasp on things. When great faith arises and spreads we can expect that the devil will not be happy and will lash out as a result.

Such things should not scare us, or keep us from acting upon our faith, but rather they should deepen our resolve that the battle is already won, and we have a role as Christian disciples to rescue those who are under the hand of the demonic, through prayer, acts of sacrifice and living as faithful and joyful followers of Jesus

## **Eminent Domain Abuse:**

The Supreme Court predicted it in 2005; 43 states did something about it; Kansas did not!

Dear Editor,

Grain Belt Express (GBE or GBX) is a controversial project that proposes to transmit electricity from Kansas to Indiana after passing through Missouri and Illinois. It intends to send 5,000 megawatts through high-voltage lines so that Kansas wind power might benefit electric grids in the Northeastern United States. The project, first proposed by Clean Line Energy Partners in 2009, was acquired in 2018 by Invenergy Transmission LLC, a privately-owned company based in Chicago. Invenergy has invoked eminent domain to obtain easements on the property of thousands of Midwestern farmers, homeowners, and businesses.

Eminent domain derives from the "takings clause" of the Fifth Amendment of the U.S. Constitution, which states that the government or its delegate may use land for the public good as long as fair compensation is provided. One of the most notable interpretations of the takings clause resulted from the 2005 U.S. Supreme Court decision titled Kelo vs. City of New London (the basis for the movie Little Pink House.) Susette Kelo purchased what she regarded as her dream home in 1997 in Fort Trumbull, a park in New London, Connecticut. It was a well-kept, close-knit neighborhood.

In 1998, Pfizer Pharmaceuticals built a plant next to Fort Trumbull, and the city of New London decided that the park was a depressed neighborhood in need of economic development. The city wanted to generate revenue when it learned that Pfizer wanted to expand into Susette's neighborhood. The city therefore invoked eminent domain over Fort Trumbull so that the New London Development Corporation could seize the land for public use. Susette and her neighbors fought hard to keep their homes, but the U.S. Supreme Court ruled that such economic development was in the public good.

It's important to note the opinions of the dissenting justices. Justice Clarence Thomas claimed that the urban renewal project offered "a vague promise of new jobs and increased tax revenue." Justice Sandra Day O'Conner wrote that "Nothing is to prevent the State from replacing any Motel 6 with a Ritz-Carleton, any home with a shopping mall, or any farm with a factory." The dissent claimed that "The beneficiaries [of the decision] are likely to be those citizens with disproportionate influence and power in the political process, including large corporations and development firms."

Clean Line Energy Partners began GBX, but there were other renewable energy projects on the books, including one to deliver wind power to Oklahoma, Illinois, Arkansas, and Tennessee (Plains and Eastern Clean Line). Clean Line, however, folded for a number of reasons. The Tennessee Valley Authority didn't want any of the line's electricity, and the State of Illinois didn't regard Clean Line as a public utility acting in the public interest and denied the company a certificate of convenience. The Department of Energy therefore terminated its financial support for the line. Most importantly, however, lawmakers in Arkansas viewed Plains and Eastern Clean Line as an obvious abuse of eminent domain. The state had no intention of allowing a Kelo-like scenario to occur in its jurisdiction.

In the aftermath of Kelo vs. City of New London, the Institute for Justice, which had represented Susette and her neighbors, warned that eminent domain abuse would continue and launched a campaign titled Hands Off My Home. Within five years of the U.S. Supreme Court verdict in 2005, forty-three states enacted legislation to prevent the abuse of eminent domain in the name of economic development, and nine states' supreme courts restricted the use of eminent domain for the same reason. Because of these proactive measures, forty-four projects that sought to invoke eminent domain for private gain were shut down.

But why didn't Kansas legislators or the Kansas Corporation Commission adopt the same tough measures to protect its citizens? On July 1, 2007, the Kansas legislature enacted K.S.A 26-501a, which prohibited the taking of private property by eminent domain for transfer to a private entity. On the same day, K.S.A 26-501b was enacted, an amendment that stipulated that the Kansas legislature could authorize eminent domain for "private economic development purposes." In essence, Kansas did nothing at all to protect its citizens. The amendment to K.S.A 26-501a allowed Kansas to commit the same abuse as the New London Development Corporation.

As for the Kansas Corporation Commission, they granted the permit for Grain Belt Express because Invenergy was touting job creation for the state and an economic boon of \$7 billion to \$9 billion for the area. The KCC acted no differently than the city of New London. Eminent domain could be invoked for private economic development and gain at the expense of Kansas landowners regardless of the devastating impact GBX would have on property owners who treasured their homes and land as much as Susette had valued her dream home in Fort Trumbull.

But it's dubious that any economic windfall will benefit Kansas at all. Invenergy has pledged that construction of the line will result in approximately 8,000 jobs in Kansas, but given that the state's labor pool would not support this number, the jobs would be allocated to out-of-state residents. The jobs would be temporary, and there are no specifics as to where \$7 billion of economic investment would come from. One can hear the echoes of Justice Thomas's words about "a vague promise of new jobs and increased tax revenue." But the larger point is that after the Kelo decision, granting eminent domain for private corporate gain should have been off the table in Kansas.

While legislation is occasionally introduced into the Kansas Legislature that would prohibit eminent domain abuse, it always dies in committee. It's obvious that, while some Kansas lawmakers take the issue seriously, Kansas Legislative

leadership doesn't. One can only speculate as to why these elected individuals do not want to take a stand on seizing land for private economic development, but surely the role of lobbyists cannot be dismissed. Again, one can hear the echoes of the U.S. Supreme Court dissent in 2005, which predicted that people with disproportionate influence and power in the political process will be favored over the average citizen.

K.S.A 26-501b also stipulated that eminent domain could be invoked by a utility. This is not uncommon, but as the State of Illinois stated for both Plains and Eastern Clean Line and Grain Belt Express, these merchant lines with a "transmission utility status" only are not valid utilities operating in the public good. No one is forced to buy energy from a merchant transmission line.

It's disturbing that the KCC cannot see the parallels between GBX and Plains and Eastern Clean Line. Grain Belt Express is running into all the same problems as Plains and Eastern Clean Line permitting issues, claims of eminent domain abuse, a lack of funding, a lack of customers, and an uncertain future alliance with the Department of Energy. Surely it is madness for the KCC and State Legislators to allow eminent domain to be invoked when the project hangs in limbo. Surely it is eminent domain abuse when land is taken for a project that has remained speculative for over twelve years. And as of now, the Midwest Independent System Operator, or MISO, has not included GBX on its grid because it questions whether GBX can deliver affordable electricity. It is a project with "ever-shifting assumptions and specifications."

Why is Kansas beholden to a company that is interested in private economic gain rather than the farms and legacies of Kansans? Every Kansas Legislator, state or federal, should be made to answer one simple question: Are you for or against this land grab that constitutes federal overreach and eminent domain abuse?

One might say that Invenergy is the Pfizer of Kansas. It seeks economic benefit at the expense of Kansas landowners - the average person like Susette Kelo who wanted to preserve a simple way of life and hold onto her home. The U.S. Supreme Court dissent got it right: political influence and big corporations are abusing eminent domain. For the record, the Fort Trumbull urban renewal development never materialized. By 2010, Susette Kelo's neighborhood consisted of vacant lots that generated no tax revenue for the city of New London. After Hurricane Irene hit the area in 2011, the neighborhood was turned into a trash dump for storm debris. Will this be the fate of farmland, homes, and businesses that have been in Kansas for generations? The answer to that question lies in the hands of the KCC and our Legislators.

#### Post Rock Extension Answers

#### Planting wheat in dry conditions

It certainly seems that "Mother Nature" has shut the moisture off for north central Kansas! Even though fall harvest can continue, fields for wheat drilling are needing moisture. There is still plenty of time for drilling as the optimum planting time for wheat in north central Kansas is Sept. 15 until Oct. 20, so here are some options when drilling into dry conditions.

According to the most recent drought monitor map, most of our district is in the "moderate" drought category with no favorable precipitation in the near future.

The first option would be the "old school" saying of "dusting in" your wheat and your grain bins will bust! Simply plant at the normal seeding depth and the recommended planting dates. With this option, you are waiting for the moisture. According to studies at K-State Research and Extension, this may be the best option where soils are very dry. The seed will remain viable in the soil until it gets enough moisture for germination. According to the 10-day forecast, it predicts below-normal rainfall and higher than normal temperatures.

Planting deeper than usual can work also if the variety to be planted has a long coleoptile and there is good soil moisture within reach of the seed. The advantage of this option is that the crop should come up and make a stand during the optimum time in the fall. Even if you plant deep to get to moisture, and the coleoptile of the wheat variety is too short, it would germinate, but not emerge. If you would like to know the coleoptile length of your wheat varieties, just give me a call if you are unsure. Generally, it's best to plant no deeper than 3 inches with most varieties in Kansas.

Frequently, if a rainfall occurs, crusting or stand failure happens, so producers may decide to wait until it has rained and soil moisture conditions are adequate before planting. It is recommended to increase your seeding rate about 10% each day after the optimum planting date and use a starter fertilizer along with a seed treatment. K-State Research and Extension studies have shown to use a maximum seeding rate of 120 lbs./acre or calculate the seeding rate in seeds per acre. Be cautious with in-furrow nitrogen as the salt in the fertilizer can make it more difficult for the seed or the plant to absorb water for germination. When applying fertilizer with the seed, nitrogen rates should be limited to no more than 20 lbs./acre to avoid potential toxicity to the seedling.

## Calling Out the DOJ

Sen. Marshall joins effort calling out DOJ for refusing to provide answers on prosecutions of illegal aliens registering to vote

WASHINGTON, D.C. – U.S. Sen. Roger Marshall, M.D. joined a letter led by Sen. Bill Hagerty (R-TN) and Rep. Andy Biggs (R-AZ-o5) calling out U.S. Attorney General Merrick Garland on the Department of Justice's (DOJ) failure to prevent illegal aliens from registering to vote in American elections or prosecute those who evidently have done so.

"We are deeply concerned by reports of non-citizens registering to vote and voting in federal elections," the members of Congress wrote. "As of today, there has been no response from you or your Department regarding the inquiry on July 12, 2024, seeking information on efforts undertaken by your Department to enforce laws prohibiting non-citizen voting. Given that the 2024 Presidential Election is in less than 34 days, your Department's inaction and refusal to provide any information regarding its efforts to promote public trust and confidence in our elections is especially alarming."

State officials across the country have recently taken steps to prevent, deter, and investigate cases of illegal voter registration by non-citizens, including in South Carolina, Georgia, Ohio, and Tennessee. Since the members of Congress sent their initial letter, cases have emerged in the states of Virginia and Texas.

"Clearly, there is a non-negligible amount of voter participation by non-citizens in federal elections, which is not only a serious threat to the integrity of our elections and the democratic process they represent, but also has the potential to reduce Americans' trust and confidence in election results," the members of Congress continued.

A copy of the letter below states:

Dear Attorney Gen. Garland:

We are deeply concerned by reports of non-citizens registering to vote and voting in federal elections. As of today, there has been no response from you or your Department regarding the inquiry on July 12, 2024, seeking information on efforts undertaken by your Department to enforce laws prohibiting non-citizen voting. Given that the 2024 Presidential Election is in less than 34 days, your Department's inaction and refusal to provide any information regarding its efforts to promote public trust and confidence in our elections is especially alarming.

Since the initial letter, several more concerning reports have been released by state officials indicating that a large number of non-citizens appear on their voter rolls. For example, the Virginia Attorney General recently announced that 6,303 non-citizens were identified on and removed from Virginia's voter rolls in 2022 and 2023. In another troubling report released in August, over 6,500 non-citizens registered to vote in Texas were identified and removed from voter rolls. Of the 6,500 non-citizens identified, 1,930 had a voter history.

Clearly, there is a non-negligible amount of voter participation by non-citizens in federal elections, which is not only a serious threat to the integrity of our elections and the democratic process they represent, but also has the potential to reduce Americans' trust and confidence in election results.

Accordingly, we respectfully reiterate the July 12 request for information on your Department's enforcement efforts. The initial deadline for providing this information was July 26, 2024, so the response is now 9 weeks overdue.

Please provide responses to the following no later than October 16, 2024:

- 1. Please provide the number of aliens who have been charged, tried, or convicted under 18 U.S.C. § 611 since January 20, 2021, including the status of each case.
- 2. Please provide the number of aliens who been charged, tried, or convicted under 52 U.S.C. § 20511 since January 20, 2021, including the status of each case.
- 3. Please provide the number of aliens who have been prosecuted under 18 U.S.C. § 911 since 2021, including the status of each case.
- 4. Please provide the number of referrals received from other government officials or the public in reference to the statutes cited in questions 1 through 3.
- 5. How does the Department of Justice investigate allegations received of non-citizen voting or voter registration?
- 6. What affirmative steps have the Department of Justice taken to detect, prevent, and deter illegal aliens and other non-citizens from registering and voting in federal elections?
- 7. What affirmative steps have the Department taken to obtain relevant information from the Department of Homeland Security on aliens who have registered or voted in elections?
- 8. What steps have been taken by U.S. Attorneys and the Public Integrity Section of the Criminal Division, which is responsible for prosecuting election crimes and assisting U.S. Attorneys in prosecuting election crimes, to obtain jury-related information that indicates aliens have unlawfully registered to vote?
- 9. As the 2024 election nears, what steps will the Department take to detect, investigate, and prosecute non-citizens who violate 18 U.S.C. § 911, 52 U.S.C. § 20511, or 18 U.S.C. § 611 by voting or registering to vote in the 2024 election?
- 10. What steps have the Department taken to contact Virginia and Texas election officials to obtain information and the voter registration and voter history files on each of the aliens removed from the voter rolls who were unlawfully registered and voting in those states?

During her first day at the Horseshoeing School, Croisant had a demonstration on how to trim a foot and then had to perform the procedure on her own, but under supervision.

The second day demo, she had to shoe a horse's foot, and on the third day, they did the procedures on their own, but with partners. They rotated with different partners and were then assigned a horse with orders on what needed done. The school provides a business as well, working with outside horses brought in.

A glue on demonstration, for major corrective shoeing, was also presented, along with a multitude of different cases. "We definitely saw a lot of things," said Croisant.

If going again, Croisant said she wouldn't have chosen the middle of August, as the heat was unbearable.

"It was a lot of hard work on your body with all of the forges going at once," Croisant said. "We would start a class every Monday, only two in the two weeks classes, but always a lot more going on during the longer times.'

The eight week program offered how to make handmade shoes - corrective shoeing, equine pack – a gel-like substance that goes on the sole of the foot, as a shock absorber. The bar shoes are the more specialized shoes for the horses.

The 12-week program offered care in teeth floating – taking sharp points off the teeth so the horse can chew properly.

As of now, Croisant would like to offer farrowing to the Mitchell County area and will travel if provided mileage.

The Beloit High School has asked her to demonstrate for the students as well, and she is looking

forward to doing that. When asked about

her experience, Croisant said she really liked the hands-on aspect. "It is a sink or swim program," she said. "The instructors really do care about you. I will probably go back for continued education in shoeing, and later get into more shoeing as well."

One of her experiences including taking care of a 12-year-old rescued horse that was skin and bones.

The owner said it probably had thrush foot. On Croisant's testing day, she had to put shoes on that horse. After looking at the horse and digging it out, there was no sensitive part. After knifing out the sole of the foot with a curved blade and a square-cut hook on the end, used to trim a horse's hooves before shoeing – it is usually white and chalky looking,

as a dead sole, and you have to be careful after getting through that dead sole — she could tell the horse was neglected and not cleaned for a while. 'That was the interest-

ing case I learned on my testing day," said Croisant.

"I met some lifelong friends while at school. Some were from Mexico, Canada, and a lot of different places. I would recommend this school to others, especially if you are a hands-on learner. They really teach you in what you are interested in. They let me work on what I want to be specialized in – barefoot horses – with trimming."

Croisant also says 4-H and FFA Ag classes in school prepared her with the hard work ethics she learned.

With just over three years at Solomon Valley Veterinary Hospital, she says it prepared her through working with animals in general - lameness in cattle, etc. "I was able to choose and watch procedures I wanted to.'

"They set me up for great success, because I learned about bone structure, proper bone structure, different angles of bone structure on being able to take care of that foot," said Croisant. "Watching our farriers for years on our own horses helped as well."

Croisant now has a company name she designed, and is waiting for the four to six week approval, from the time of her applying.

"I have been looking for a brand for a while, and now will have a proof of ownership behind it," said Croisant. "When approved, I will go through a business for them to make the brand for me.'

"From draft horses to mini ponies, with my Grandma owning mini's, I will keep busy with those, 'to help me in my learning process," laughed Crois-
