

# **Bolivar R-1 moves to a mask recommended option**

olivar R-1 students and staff will no longer be required to wear masks, following a unanimous vote by the school board Thursday, Oct. 21.

While various health professionals' advice had previously urged the board to maintain the masking requirement, the district said new options from the Missouri Department Elementary and of Secondary Education factored into the board's decision.

After learning about a test-to-stay option put forth by DESE, the board decided to transition from the mask requirement to the recommended mask option. This will apply to "staff and students K-12 districtwide See R-1, Page 2A

## Central Polk County Fire again seeks levy increase

A local volunteer fire protection district is again asking voters to increase its tax levy after the ballot measure failed in the last municipal election with a tie vote.

According to Polk County Clerk Rachel Lightfoot, the Central Polk County Fire Protection District is asking voters to approve an additional 30 cents per \$100 assessed valuation to the district's

## current tax levy.

The district's current tax levy, about 30 cents per \$100 assessed valuation, was set in 2013, per previous coverage.

Lightfoot said this is the only issue on the Tuesday, Nov. 2, ballot for Polk County. Because there's only one

election issue for the county, Lightfoot said her office will consolidate down to one polling place at the Polk

County Courthouse on election day.

Central Polk County Fire asked voters to approve the same ballot issue in the April municipal election earlier this year.

According to the official results, 97 voted for the tax and 97 voted against. Former Polk County Clerk Bobbi Lear previously told the BH-FP the tie meant the mea-

sure failed.

The district did not pursue a recount See Levy, Page 3A

## Local calls now need area code

People will now need to take a moment to dial a few extra numbers when making local phone calls.

According to a social media post by the City of Bolivar Office of Emergency Management, those making a phone call will need to start using the 417 area code when dialing a local phone number as of Sunday, Oct. 24.

"Whether on your landline or cell, you must use the 10 digit number to call local," the post stated. "... If you try calling with just the 7 digits, your call will likely not go through."

The post stated it's important for people to plan ahead and possibly update saved phone numbers in their cell phones.

## Closing the digital divide Bolivar R-1 awarded FCC funds

On Friday, Sept. 24, the Bolivar R-1 School District was awarded \$126,900 from the Federal Communications Commission, which will be used for chromebooks and laptops. This funding

comes from the FCC's \$7.17 billion Emergency Connectivity Fund Program, which committed \$1,203,107,496.88 for 3,040 schools, 260 libraries and 24 consortia that applied for support, according to an FCC news release.

"The (ECF) covers devices and internet connectivity," technology and communications director Brad Sterling said, but the district favored the former option.

Sterling explained that Bolivar along with other school districts - re-

alized purchasing hotspots was not a good solution. That kind of purchase came with additional NITED STATES

costs like data plans. Additionally, not all students would have had a good enough signal to even use the hotspots.

Therefore, the district turned to applying for laptops and Chromebooks, Sterling said. Specifically stated in the application, the lap-

tops would be designated as replacements for the school's sevenyear-old desktop computers teachers currently use.

"That will make the teachers more mobile in the classroom," he said.

It also will allow teachers a "good robust device that could do all things," he said, which would help if the district went into another pandemic situation and everyone had to stay home. See Funding, Page 3A

beginning Monday," board member Kyle Lancaster said during Thursday's session.

This decision includes a 7% warning threshold within each school building and a 10% threshold for Polk County. These percentages relate to how many quarantines and positive cases there are within these groups.

The board said if a building or the county reaches these thresholds, it will revisit the issue to determine the cause of the rise in numbers and decide where to go from there, instead of reinstating the requirement automatically.

The discussion on the use of masks for this school year is one the board has been having since August, superintendent Richard Asbill said. The focus since day one has been to keep kids in school, as Asbill has said multiple times in the past. To do that, a mask requirement was previously the board's solution.

With masks, the district utilized a modified quarantine option — as long as a student was wearing a mask when exposed to a positive case, they would not have to quarantine.

On Friday, Oct. 8, DESE announced its test-to-stay option, and the Department of Health and Senior Services endorsed it.

The test-to-stay option allows students to come to school even after being exposed to a positive case.

Per the guidelines, if students are exposed, they can come to school as long as they take three COV-

However, if the student is exposed from within their household, this option does not apply, and they must be quarantined for the designated period.

Board member Branden VanDeren — who has previously expressed wariness about removing the mask requirement said he has spoken to a few local health professionals. He said since they think the test-to-stay option is a viable solution, then he felt comfortable with the mask recommended option.

Public comments came at the end of the Thursday meeting, after the board had voted to move to the mask recommended option. Some of those who spoke during this time talked about their disapproval of the past mask requirement and future testing options.

All board members were present during the open session.

The district's previous masking requirement drew the ire of many outspoken critics, as previously reported in the BH-FP.

Last week, Springfield attorney Kristi Fulnecky — who has filed unsuccessful lawsuits alleging civil rights violations against municipalities and school districts that instituted COVID-19 prevention measures - gathered a group at BMS's front entrance while school was in session to speak out against the district's mask policy.

While speaking to the crowd, Fulnecky threatened to sue the school district if it did not remove its mask requirement, per previous coverage. Asbill released a statement saying Fulnecky did not have permission to gather with the group at the middle school's entrance. A group of around Bolivar High 11 School students also left classrooms and protested the mask requirement on the high school's front steps. ## ID-19 tests in a sevenday window.

The board decided those three tests would be taken on Mondays, Wednesdays and Fridays.

If the tests come back negative, the student can still come to school.

Additionally, this option expands to more than just the school district.

If a student is exposed to COVID-19 outside of school — at the store, at a party or anywhere else — this option still applies.

# **Teen injured in Sunday** afternoon crash

A teenager was hurt in a two-vehicle crash in Bolivar on Sunday, Oct. 17.

According to a Bolivar Police Department news release, officers were called to the area of Mo. 32 and Hartford Avenue for a report of a two motor vehicle crash with injuries at around 1:07 p.m.

The release stated a 2001 Chevrolet Silverado pickup, driven by Ricky Churchill, 19, of Humansville, was eastbound on Mo. 32 when he struck a 1998 Ford F150 driven by a 17-year-old Hermitage girl that was also eastbound.

While the drivers were

not injured as a result of a release. this crash, the release stated Chelsi Horn, 18, of Pittsburg, who was a passenger in the Ford truck, did complain of injuries and was taken by ambulance to Citizens Memorial Hospital for treatment.

Churchill's vehicle was disabled from the crash and was removed from the scene by Wakefield Towing of Bolivar, the release stated.

Cpl. M. Gilmore investigated the crash.

### Bolivar man hurt in wreck

Officers also responded to a vehicle versus lawnmower wreck in the area of Aldrich Road and Boston Place at around 8 a.m. Sunday, Oct. 17, according to

According to the release, a 2018 Ford Focus sedan, driven by Thomas Bledsoe, 22, of Bolivar, was eastbound on Aldrich Road when it struck a riding lawn mower pulling a trailer operated by John Taylor, 52, of Bolivar.

Bledsoe attempted to pass the lawnmower but failed to move far enough to the left, the release stated.

Taylor was injured, the release stated, and taken by ambulance to Citizens Memorial Hospital for treatment. His lawnmower was disabled from the crash and removed from the scene by A&J Towing of Bolivar.

The crash was investigated by Ofc. W. Whalen.

One benefit of the funding is that the district had already decided it needed to replace the old desktop computers. It had allocated some funds for that purchase, but then the ECF funding came in, which inevitably saved the district quite a bit of money, he said.

Once the district receives those laptops and issues them out to teachers, it will then round up the Chromebooks given to teachers last year -"roughly 225," he said.

Those devices will then be given to Bolivar Primary School in carts.

Therefore, "every classroom at the primary school will have a cart Chromebooks," of he said, which will make the district one-to-one from kindergarten through 12th grade.

"As of this year, we are one-to-one take home in grades 3-12," he said, meaning each of the students in those grades have a Chromebook assigned to them, which they can take home and bring back daily.

At BPS, he added, "we're going to be oneto-one with carts where, when they're in their classroom, there is a Chromebook for them."

This includes the special education classrooms, as well.

"Right now, we have everybody accommodated at (BPS) except for kindergarten," he said.

After adding roughly 10 more carts to the primary school, "every classroom will have a cart full of Chromebooks."

All of these specifications, he added, were written down in the request for the funds to the

With that \$400 cap, the district was awarded \$104,000.

For the Chromebooks, the ECF would cover the devices but not the Google Chrome licenses to go with them, which are \$30 each, he said.

Having requested \$25,250 for 100 devices, the district was then awarded \$22,900, which went to the devices and excluded the licensing.

"I've already purchased 50 of those," he said, and now he is just waiting on the other 50.

He also said he ordered the laptops, but they are on backorder, and he doesn't know when they will come in.

of the votes from the April election, per previous coverage.

Fire district board chairman Sammy Bowden told the BH-FP in April the district's board discussed doing more to educate voters and then seeking to put the item on the ballot in the next countywide election.

Bowden previously told the BH-FP board members voted to place the question on the ballot because additional funding is needed to cover the cost of the district's growing needs due to the county's increasing population and the district's incorporation of the Polk Rural Fire Department in 2018.

"We have outgrown our tax," he previously said. "We felt at this point we need to upgrade the tax. The equipment is getting more expensive. The standards continue to get higher, and we've grown in area."

Bowden said the additional funding would have helped the district purchase upgraded and newer equipment, pay for upkeep on its current equipment and eventually hire personnel "for at least daytime service, if not 24-hour service."

He previously explained the importance of paying personnel for daytime service.

"That's one of the bigger things we were looking for is, sooner than later, putting a staff member on shift during the day," he said. "It's hard to find manpower during the day because our volunteers work other jobs."

Bowden said, preferably, at least two firefighters would be on shift and ready to respond.

Newer equipment also remains a priority, he said. The district's ladder truck is 25 to 30 years old, and they've had trouble finding parts for it.

"We'd really just love to have people come to our public board meetings, so they can ask us questions about why this funding is important," Bowden said.

Board meetings are 6:30 p.m. the second Tuesday of each month at the CPCFPD station at 1039 Rt. B, just off Mo. 83 north of Bolivar.

take effect across many other areas across the nation.

The change is being implemented by the Federal Communications Commission in order to create a new national suicide hotline, the post stated.

Per the FCC website, found at fcc.gov, there are more phones in America than there are people, and each phone needs its own phone number.

"Beginning in the early 1990s, to accommodate the growing need for more phone numbers, some areas began to add a second area code for local calls," the website states. "Dialing both the area code and the seven-digit number was necessary

P.O. Box 330, Bolivar, Mo. 65613-0330

to ensure the call reached the intended recipient."

The website states that a second local area code may be added as more area codes begin to run out of new seven-digit phone numbers to assign. This change requires a transition to 10-digit dialing.

"In 2020, the FCC established '988' as the new, nationwide threedigit phone number for the National Suicide Prevention Lifeline," the website states. "The new threedigit dialing code will be available nationwide by July 16, 2022, and will provide an easy to remember and easy to dial three-digit number to reach suicide prevention and mental health counselors, similar to '911' for emergencies and '311' for local government services."

To help with the creation of 988 as the national suicide hotline, area codes that use the numbers "988" as a local exchange or the first three digits of a seven-digit phone number need to use 10-digit dialing.

According to the FCC website, transitioning to ten-digit dialing will not affect people's current telephone numbers.

"Your phone number, including your area code, will not change," the website states.

For more information, visit fcc. gov/consumers/guides/ten-digit-dialing.







First-year golfer and junior Jylee Tennison did not make it to state, but she "improved" and "made huge


Absent from most of the tournaments this season due to a hand fracture, senior Cadence Akins was able to participate in the Ozark Conference tournament and at districts.


