WHEREAS, under the provisions of Article VI, Section 26(B) of the Louisiana Constitution of 1974, as amended, and other constitutional and statutory authority, including an election held in the Parish of Livingston, State of Louisiana (the "Parish") on Saturday, November 18, 2023, the Parish Council of the Parish of Livingston, State of Louisiana (the "Governing Authority"), as governing authority for the Parish, desires to renew the levy and collection of the ad valorem tax as authorized at the election by virtue of the favorable passage of the proposition attached hereto as Schedule A setting forth the rate and duration of the tax; and

WHEREAS, in compliance with the provisions of said authority and other applicable constitutional and statutory authority, an election was held in the Parish on Saturday, November 18, 2023, to authorize the renewal of the levy and collection of the ad valorem tax, it is now the desire of the Parish to renew the levy of the ad valorem tax and to provide for the collection thereof and other matters in connection therewith as hereinafter provided in this Ordinance.

NOW, THEREFORE, BE IT ORDAINED by the Governing Authority, that:

- SECTION 1. Pursuant to the authority of an election held in the Parish on Saturday, November 18, 2023, there be and there is hereby levied within the geographic boundaries of the Parish for the purposes stated in the proposition attached hereto as Schedule A, an ad valorem tax of ten (10) mills on the dollar of assessed valuation of all property subject to taxation in the Parish, beginning with the year 2025 and ending with the year 2034, for the purpose of acquiring, constructing, improving, maintaining and operating the Livingston Parish Library, all in the manner and subject to the provisions and terms of those portions of Title 33 of the Louisiana Revised Statutes of 1950, as amended, applicable to property taxes levied by the Parish.
- SECTION 2. That the ad valorem tax described in Section 1 above shall be levied, assessed, imposed, collected, paid and enforced according to law.
- SECTION 3. The obligations and rights of taxpayers in connection with the ad valorem tax levied hereby shall be as provided by the provisions of law applicable to ad valorem taxes levied by the Parish.
- SECTION 4. If any one or more of the provisions of this Ordinance shall for any reason be held to be illegal or invalid, such illegality or invalidity shall not affect any other provision of this Ordinance, but this Ordinance shall be construed and enforced as if such illegal or invalid provisions had not been contained herein. Any constitutional or statutory provision enacted after the date of this Ordinance which validates or makes legal any provision of this Ordinance which would not otherwise be valid or legal, shall be deemed to apply to this Ordinance.
- SECTION 5. Upon adoption, this Ordinance shall be published in full in one (1) issue of the *Livingston Parish News* and shall be recorded in the mortgage records of the Livingston Parish Clerk of Court.
- SECTION 6. The Chairman of the Governing Authority be and he is hereby authorized, empowered and directed to take any and all such action as may be necessary to carry into effect the provisions of this Ordinance.
 - SECTION 7. This Ordinance shall immediately take effect upon adoption.

TOWN OF LIVINGSTON PUBLIC AWARENSS NOTICE FOR NATURAL GAS CUSTOMERS

The Town of Livingston owns and operates a natural gas distribution system in the town. The gas system consists of and underground network of pipelines throughout the town and unincorporated areas adjacent to the town limits. The purpose of the gas system is to provide a reliable and safe economical source of energy for heating purposes to the homes and businesses adjacent to the underground gas pipelines. The pipeline system has the capacity to reliably deliver natural gas to the customers.

The hazards of natural gas are it is odorless, colorless, tasteless, lighter than air, and can ignite and/or explode with tremendous force when mixed with the right amount of air.

Prevention measures taken include:

- Adding odorant to the gas to give it that distinctive smell, similar to rotten eggs, to warn us
 of its presence
- Testing the odorant level each calendar quarter
- Performing annual gas leakage surveys
- Conducting periodic pipeline patrols

The following are signs that may indicate a gas leak:

- A hissing or roaring sound (caused by escaping gas)
- A patch of dead or discolored vegetation in an otherwise green setting along a pipeline route
- Blowing dirt, grass, or leaves near a pipeline
- Continuous bubbling in wet, flooded areas
- A gas smell similar to rotten eggs

Anyone who may smell this odor or notice any unusual conditions on or near gas mains, vents, service lines, meter sets, or especially inside of a building should call the Town of Livingston immediately. If you smell a strong gas odor inside a building, notify everyone in the building to leave. Do not operate any switches or use the phone. Go a safe distance away upwind of the gas smell and call the Town of Livingston.

Pipeline markers are maintained to inform the public of the gas line location. State and federal laws require excavators to notify LA One- Call two full working days before digging. If any excavation is planned you must notify LA One- Call which will notify the Town to locate the gas lines. The Town of Livingston maintains memberships on the LA One –Call program.

To obtain additional information or report gas related issues call the Town of Livingston at 225-686-7153 (24 hours). The LA One-Call Center phone number is 811. This information and the pipeline signs are provided ad public awareness and damage prevention awareness notices.

ORDINANCE NO. 23-33 ADOPTED ON SEPTEMBER 14, 2023, IN REGARD TO THE CONSTRUCTION AND DRILLING OF CLASS VI INJECTION WELLS, FOR WELLS SPECIFICALLY USED FOR GEOLOGIC SEQUESTRATION OF CARBON DIOXIDE IN THE PARISH OF LIVINGSTON; SAID EXTENSION SHALL BE APPLICABLE ONLY TO WELLS DRILLED AND OPERATED ON PRIVATE PROPERTY AND SHALL BE FOR AN ADDITIONAL TWENTY FOUR (24) MONTHS OR UNTIL ZONING IS FULLY IMPLEMENTED AND IN PLACE.

WHEREAS, on September 8, 2022, the Livingston Parish Council adopted an ordinance to enact a twelve (12) month moratorium which halted the construction and drilling of Class VI injection wells; and

WHEREAS, the twelve (12) month moratorium has expired on September 22, 2023; and

WHEREAS, on September 14, 2023, the Livingston Parish Council adopted an ordinance to enact a one hundred twenty (120) day moratorium which halted the construction and drilling of Class VI injection wells; and

WHEREAS, the one hundred twenty (120) day moratorium will be expiring on January 20, 2024; and

WHEREAS, the Livingston Parish Council now desires to extend this moratorium only for Class VI wells drilled and operated on private property within Livingston Parish for an additional twenty-four (24) months or until zoning is fully implemented and in place in an effort to provide for definitions and permitting that will set the following regulations and mandates for construction and drilling of Class VI injection wells on private property within Livingston Parish; and

WHEREAS, the Livingston Parish Council, governing authority of the Parish of Livingston, hope that these measures will provide additional protection and safety for the citizens and residents of Livingston Parish from any such well sites being proposed for companies to Carbon Capture and transport to Livingston Parish through pipelines and other means of transportation for carbon management; and

WHEREAS, in order to prevent waste, carry out an orderly program of development, protect the correlative rights of each owner in the common source(s) of supply, prevent the pollution of fresh water supplies and unnecessary damage to property, soil, animals, or aquatic life and to protect the health and welfare of the public, has issued the following Order:

-

BE IT RESOLVED AS FOLLOW: THAT, AS TO CLASS VI WELLS DRILLED AND OPERATED ON PRIVATE PROPERTY, THERE WAS HEREBY ENACTED AN EXTENSION OF THE TWELVE (12) MONTH MORATORIUM, BEING L.P. ORDINANCE NO. 23-33 ADOPTED ON SEPTEMBER 14, 2023, WHICH EXPIRES ON JANUARY 20, 2024 ON THE CONSTRUCTION OF SUCH INJECTION AND DISPOSAL WELLS, FOR AN ADDITIONAL TWENTY-FOUR (24) MONTHS OR UNTIL ZONING IS FULLY IMPLEMENTED AND IN PLACE TO FURTHER EVALUATE THE FOLLOWING NEEDS:

- Extensive site characterization requirements
- Injection well construction requirements for materials that are compatible with and can withstand contact with CO₂ over the life of a GS project
- Injection well operation and location requirements
- Comprehensive monitoring requirements that address all aspects of well integrity, CO₂ injection and storage, and ground water quality during the injection operation and the post-injection site care period
- Financial responsibility requirements assuring the availability of funds for the life of a GS project (including post-injection site care and emergency response)
- Reporting and recordkeeping requirements that provide project-specific information to continually evaluate Class VI operations and confirm USDW protection
- A map or site plan must be submitted to the planning department and filed in the clerk of court office. The map or site plan must display all permanent inhabited residential structures, all Class V wells used for monitoring Class VI wells, all Class VI wells, all closed and active oil wells. The mapped area must display and extend a minimum of 3 miles beyond the plume. The projected and actual CO2 plume must be displayed and distinguished on the map. The map must be updated every five (5) years. All water wells and water systems must be displayed on the map.
- Class VI wells must be a minimum of two (2) miles from any permanent inhabited dwelling.
- Class VI wells must be located in an area zoned and classified for industrial use.
- Any water wells and water systems located within five (5) miles of the projected plume must be tested and analyzed for any contaminants annually at the expense of the owner and or operator of the class VI wells.
- A lease agreement must be signed by all property owners where the projected and planned CO2 plume is being stored below ground.
- A community alarm and notification system shall be required and activated in the event and incident occurs and an evacuation is needed. The alarm and notification system must be tested monthly. The alarm and notification system shall have the ability to notify all residents extending 3 miles beyond the projected CO2 plume.
- The owner and or operator must have an onsite emergency response team capable of handling any emergency due to any type of injection well failure or any type of CO2 release. If the owner and or operator is unable to provide emergency service with an onsite emergency response team, then the local volunteer fire department must be compensated and agree to provide the emergency service.
- Class VI wells may not be drilled in an area where an abandoned or active oil well is within the projected CO2 plume where the oil well is within two (2) miles of an inhabited residential structure.

NOW THEREFORE BE IT ORDAINED, by the Livingston Parish Council; governing authority of the Parish of Livingston, as of the effective date of this ordinance, the former twelve (12) month moratorium on the construction of Class VI injection wells and disposal wells that is due to expire on September 22, 2023; and was also whereupon extended again on September 14, 2023 due to expire on January 20, 2024; will hereby be extended for Class VI injection wells and disposal wells drilled and operated on private property in Livingston Parish from that date for an additional twenty-four (24) months and will expire upon September 22, 2026 or until zoning has been fully implemented and in place.

BE IT FURTHER ORDAINED by the Livingston Parish Council, governing authority of the Parish of Livingston, that if any provision of this ordinance is held invalid, such invalidity shall not affect other provisions, items, or applications of this ordinance, which can be given effect without the invalid provisions, or application, and to this end the provisions of this ordinance are hereby declared severable.

BE IT FURTHER ORDAINED by the Livingston Parish Council that all ordinances or parts of ordinances in conflict with this ordinance be and the same are hereby repealed.

The effective date of this ordinance shall be as prescribed by law.

SECTION 1. <u>Election Call</u>. Subject to the approval of the State Bond Commission and under the authority conferred by Section 338.54 of Title 47 of the Louisiana Revised Statutes of 1950, as amended (La. R.S. 47:338.54) and the applicable provisions of Chapter 5, Chapter 6-A and Chapter 6-B of Title 18 of the Louisiana Revised Statutes of 1950, as amended, and other constitutional and statutory authority, a special election (the "*Election*") be and the same is hereby called and ordered to be held in the District on SATURDAY, APRIL 27, 2024, between the hours of 7:00 a.m. and 8:00 p.m., in compliance with the provisions of Section 541 of Title 18 of the Louisiana Revised Statutes of 1950, as amended, and that at the said Election there shall be submitted to all registered voters qualified and entitled to vote at the said Election under the Constitution and laws of the State of Louisiana and the Constitution of the United States of America, the following proposition, to-wit:

PROPOSITION

Shall Special Taxing District No. 5 of the Parish of Livingston, Louisiana (the "District") be authorized to renew the levy and collection of a 1/2% tax (an estimated \$2,100,000 reasonably expected at this time to be collected from the levy of the tax for an entire year) (the "Tax") upon the sale at retail, the use, the lease or rental, the consumption and storage for use or consumption, of tangible personal property and on sales of services in the District, for a period of ten (10) years, commencing on August 1, 2025, with the proceeds of the Tax (after paying the reasonable and necessary expenses of collecting and administering the Tax), to be dedicated and used to acquire drainage works, equipment and facilities necessary to construct, maintain and operate outlets for the waters of the District, and prevent flooding; and further shall the District be authorized to fund the proceeds of the Tax into bonds to the extent and in the manner permitted by the laws of Louisiana?

SECTION 2. Proceeds of the Tax. Conditioned on the passage of the Tax at the Saturday, April 27, 2024 Election authorized pursuant to this Resolution, all avails or proceeds of the Tax for a period of ten (10) years, commencing August 1, 2025, (after paying the reasonable and necessary expenses of collecting and administering the Tax) collected shall be used to acquire drainage works, equipment and facilities necessary to construct, maintain and operate outlets for the waters of the District, and prevent flooding; and further shall the District be authorized to fund the proceeds of the Tax into bonds.

SECTION 3. <u>Publication of Notice of Special Election</u>. Pursuant to La. R.S. 18:1285, there shall be published in the *Livingston Parish News*, a weekly newspaper of general circulation within the District, published therein, and being the official journal of the District, once a week for four (4) consecutive weeks, with the first publication to be made not less than forty-five (45) days nor more than ninety (90) days prior to the date fixed for the Election, notice of said Election, which notice shall be substantially in accordance with the Notice of Special Election annexed hereto as <u>Exhibit A</u> and incorporated herein by reference the same as if it were set forth herein in full.

SECTION 4. <u>Canvas of Election Returns</u>. This Governing Authority shall meet at its regular meeting place, in the Council Chambers in the Governmental Building, 20355 Government Blvd., Livingston, Louisiana, on Thursday, May 23, 2024 at 6:00 p.m., and shall then and there, in open and public session, proceed to examine and canvass the returns and declare the result of the said Election.

SECTION 5. Polling Places; Commissioners. The polling places set forth in the aforesaid Notice of Special Election and situated within the corporate limits of the District be and the same are hereby designated as the polling places at which to hold the said Election in accordance with Section 1286(A) or Section 1286.1, as the case may be, of Title 18 of the Louisiana Revised Statutes of 1950, as amended, and the Commissioners-in-Charge and Commissioners, respectively, will be those persons designated according to law in accordance with Section 1286(A) or Section 1286.1, as the case may be, of Title 18 of the Louisiana Revised Statutes of 1950, as amended.

SECTION 6. <u>Designation of Commissioners and Commissioners-in-Charge</u>. The officers designated to serve as Commissioners-in-Charge and Commissioners, respectively, pursuant to Section 5 hereof and in accordance with Section 1286(A) or Section 1286.1, as the case may be, of Title 18 of the Louisiana Revised Statutes of 1950, as amended, or such substitutes therefor as may be selected and designated in compliance with Section 1287 of Title 18 of the Louisiana

Revised Statutes of 1950, as amended, shall hold the said Election as herein provided, shall make due returns of said Election for the meeting of the Governing Authority, as governing authority of the District, to be held on Thursday, May 23, 2024, and that the compensation of said officers be and the same is hereby fixed at the sum prescribed by law. All registered voters in the District are entitled to vote at the said Election.

The Council clerk stated that this was proposed ordinance 23-50, the Public Hearing would be on December 28th, at 6:00 p.m. In the event that the December 28, 2023, Public Hearing could not be held on that date, the Public Hearing would be held on January 11, 2024, at 6:00 p.m. The chair asked if the Parish Legal Counsel could confirm that date would be acceptable, and Jim Ryan stated that there was plenty of time, and that as long as it was adopted by August 2024 when Assessor Jeff Taylor certified the rolls all would be great.

Thereupon the chair declared that the Motion had been carried and was adopted on the 14th day of December 2023.

The chair addressed agenda item number 25, "Public Hearing and adoption of L.P. Ordinance No. 23-47: 2023 Budget Amendments and 2024 Budget – Jennifer Brady, Parish Finance Director."

Jennifer Brady addressed the Council and drew attention to the additional sheet that she had provided them with a quick list of the largest amendments approved over the year that was added in for the 2023 year. She noted that the entirety of the number was not in the totals for 2023 because some projects were split like 50/50, 80/20, etc.

The chair directed the Council clerk to read the ordinance by title as follows:

L.P. ORDINANCE NO. 23-47

AN ORDINANCE AMENDING THE 2023 BUDGET AND ADOPTING THE 2024 BUDGET OF THE LIVINGSTON PARISH PRESIDENT-COUNCIL RELATIVE TO THE GENERAL FUND, SPECIAL REVENUE FUNDS, DEBT SERVICE FUNDS AND CAPITAL IMPROVEMENT FUNDS.

The chair opened the Public Hearing. He asked if there was anyone present who wished to speak for or against this proposed ordinance. None being, he closed the Public Hearing.

The chair asked if there was a motion to adopt the ordinance. Councilman Delatte requested clarification if the chair was addressing agenda item number 23 or 24. Ms. Brady explained that it was for the 2023 amendments and the proposals for 2024. The chair allowed an extensive discussion between Councilman Delatte and Ms. Brady regarding the buy-outs of 2023 employee compensatory and vacation time. Councilman Delatte did not feel that the buy-outs were a good use of taxpayers' money. He wished to propose that the 2024 budget not be adopted, and consequently, this would allow them the use of only fifty percent (50%) of the budget. Ms. Brady cautioned the Council members that if they did not approve the 2024 budget, some of the projects that the Council had previously approved, either by resolution or by ordinance, flowed over into the 2024 year. She advised that some of these projects were listed on the documents before them and some of them were prior to the year of 2023. She explained that those spendings would occur in 2024.

The chair wished to advise that this particular budget had been introduced at the last Council meeting and its proposed adoption would be at that evening's meeting. He continued to clarify that if there was something in the budget that was not correct, the Council could amend the budget in

January. Councilman Tracy Girlinghouse concurred and advised that this had been done in their first term.

Councilman Delatte stated that amending the budget was not an issue, but that once the money was gone, it was gone. Councilman Maurice "Scooter" Keen agreed with Councilman Delatte's statement. Councilwoman Sandefur asked why they did buy-outs now and if this was a typical practice at the end of the year. Ms. Brady explained that it was cash outs for vacation leave and compensatory time and had been historically practiced every year.

Councilman Delatte questioned if cash outs had occurred for that year yet? Ms. Brady advised that sometimes, if there were disasters, it happened multiple times during the year. She explained employees may have worked multiple hours of compensatory time, and once the Parish received reimbursement from federal government, and the cash was in the bank, Administration would then do the cash outs accordingly.

The discussion between Councilman Delatte and Ms. Brady continued regarding the effects of the budget concerning employee pay outs from their accumulated leave.

Councilman Delatte had several questions about expenditures that had been recently paid at the end of that year and stated that he saw several problems in the way that the budget was being presented. He questioned Ms. Brady extensively and expressed his displeasure with the disbursements that had been made.

Councilman Keen asked if this procedure was customary. He agreed with Ms. Brady that if the employees were owed this, then the Parish would either have to pay them, or they would take time off of work with this accruement of leave. He asked how many employees were affected by the pay outs. Ms. Brady advised that there had been approximately forty (40) to forty-five (45) employees. Councilman Keen concurred with Ms. Brady's earlier statements advising that if employees took their accrued time off of work, that would create a big disruption in their workforce. Ms. Brady wished to clarify that this practice began when Administration was having issues with super high compensatory time balances.

The chair wished to reiterate that all of the money from the pay outs were reflected in this currently written, already introduced, budget for the year of 2023. Ms. Brady agreed and stated that this issue would not have to be addressed in the 2024 budget.

Councilman Delatte disagreed. He stated that he did not see the need to pay this money out and challenged that if they were worried about disruption, allow him to worry and address these concerns when he takes office in two (2) weeks.

The chair stated that adopting or not adopting the budget did not have anything to do with the current Parish President and if he had made the pay outs or not. He further advised that this was bookkeeping of where the money was at, and asked if his statements were correct.

Councilman Delatte advised the chair that he was not correct. He stated that they had received a couple of hundred thousand dollars, and that a couple hundred more thousand was about to be written.

Councilman Girlinghouse wished to clarify Councilman Delatte's statements. He asked if Councilman Delatte was indicating that pay outs had already occurred and that there would be more. Councilman Delatte confirmed this and stated yes.

Councilman Girlinghouse had questions regarding the increase of budget funds for zoning and legal in the budget that was presented. He advised that the Council had allotted funding in the budget the prior year for zoning maps to be drawn by Alvin Fairburn and Associates. He questioned if this proposed increase was in addition to that funding. Ms. Brady advised that it was. He further questioned if the increased amount of three hundred thousand dollars (\$300,000.00) would be for needed zoning amendments. She explained that this amount had been placed in the budget for funds that had been spent in 2023, for the reason being, it was above what was originally proposed in December of last year for the projected year's budget.

The chair stated that the Public hearing had been opened and closed. A request from the audience was made to speak on this agenda item. The chair allowed additional time for public input. He met no objection to this from the Council members. A motion was made by Councilman Tracy Girlinghouse and seconded by Councilman Keen to open the public hearing for public input from Mr. Mickey McMorris.

Public Input: Mickey McMorris, resident of Livingston Parish

Mr. McMorris wished to state that most governments allow employees to accumulate leave in mass quantities, but when they retire, it is then converted to retirement time. He advised when this occurred, all of that liability shifts to retirement. He argued that you really don't want to carry a huge liability like that and then cash it out as it could break the whole system. He further indicated that this was the purpose of allowing accumulation.

The chair asked for a motion to adopt the budget as it had been introduced at the last meeting for the 2023 Budget Amendments and 2024 Budget. Having no one who wished to make a motion or a second, the proposed ordinance then died for lack thereof.

The chair addressed agenda item number 15, "Livingston Parish Finance Department: Ratify the resolution that was adopted at the November 30, 2023 regular meeting of the Livingston Parish Council to Accept the Finance Department's recommendation for accepting the lowest responsive bidder from Randy DePaula Electric, LLC and authorize the Parish President to enter into any applicable agreement or contract for this service the New Coroner Building - Jennifer Brady, Parish Finance Director."

He stated that this was approved at the last council meeting, but that they did not call by name the person that had been the lowest bidder, that being Randy DePaula Electric.

Mrs. Brady stated that this was adding twenty-seven thousand dollars (\$27,000.00) for the construction administration to the entirety of the project, and that they had money ear-marked in their budget so it would not take dollars from anyone else.

MOTION was made by Randy Delatte and duly seconded by Tracy Girlinghouse to authorize the parish president to approve an amendment to the engineering agreement between the Livingston Parish Council and G.E.C., Inc., for the American Rescue Plan Act (ARPA) funded Town of Springfield Sewer Pump Station Resiliency Project.

The chair addressed agenda item number 12, "Progress report from our Planner, Steven Villavasso – Erin Sandefur", and called upon Councilwoman Erin. Sandefur.

Councilwoman Sandefur advised that she wished to pull this agenda item and wanted to explain the reason that she wished to do so. She explained that Mr. Villavasso had COVID and could not be in attendance at the meeting that evening.

The chair then went back to the regular order of the agenda and thanked everyone for their patience.

The chair addressed agenda item number 7a, "Presentations: Announcement of Christmas Card Winner".

He explained that each year the Council members ask for children to submit drawings for the Livingston Parish Council's Christmas card. Upon these submissions, the members of the Council come together and select the art for a winning card to be used for that year.

He then called upon Councilman Jeff Ard and asked if he would like to take the opportunity to brag on these children's artistic abilities that had been submitted.

Councilman Ard accepted his invitation and stepped down from his seat at the dais and addressed the audience from the lectern at the front of the Council chambers. He wished to acknowledge and explain the history behind the creation of the Johnny F. Bell Artistic Achievement Award. He conveyed that Mr. Johnny Bell was a local artist from Denham Springs. Among Mr. Bell's many achievements, he was known for his two (2) famous paintings, one (1) being the Louisiana state painting and the other that many know is a portrait of Mike the Tiger stepping over Tiger Stadium and his stripes bear the repeated reading of "LSU". He further advised that Mr. Bell had been a very close family member and was his oldest brother's father-in-law. Councilman Ard described how dear to him that it had been when the Council created this award and how it was given each year to the winner of their Christmas card contest. He further advised that this award had been presented to Laine Hardy the year that he had won American Idol. His hope was that the new members of the Livingston Parish Council would continue this tradition and showcase the talent that they had in Livingston Parish. He wished to first introduce and acknowledge Ms. Dena Olinde, the art teacher whose student had won that year's award. He then announced that the winner that had been selected was Miss Sara Mae Campo, a Live Oak High School student in the tenth grade. He went on to read the certificate aloud.

The Livingston Parish Council is proud to present this Certificate of Achievement to recognize an original art entry that was chosen for the 2023 Parish Council Christmas card cover. We are proud to honor Sarah along with the students and teachers who are part of the Livingston Parish School Board's Gifted-Talented Program. Congratulations on a job well done!

Ms. Olinde wished to thank the Council members for this opportunity that was presented and also advised that students do not get many venues to showcase their artwork. She stated her sincere appreciation to them for this gesture.

The chair allowed a photo opportunity at that time.

The chair remained at the podium and addressed agenda item number 7b: "Presentations: Recognize Rick Foster, Denham Springs, Building Official and Karen Meche, Supervisor – Randy Delatte".

The chair requested that Mr. Rick Foster and Ms. Karen Meche come forward from the audience as Councilman Delatte made remarks explaining the organization known as CASA.

Councilman Delatte advised that Mr. Foster and Ms. Meche worked for a non-paying, volunteer organization called CASA, which was an acronym for "Court Appointed Special Advocates". He further advised that these were everyday citizens who had been trained to be an advocate for abused and neglected children in the court system. Councilman Delatte explained that they are appointed by a judge to represent the child's best interest and to help them reach a safe and permanent home as quickly as possible. He stated that he wished to share a little bit about each of their backgrounds. He accredited that their actions were speaking for themselves, and not their words. He expressed how extremely proud that he was to be able to acknowledge them that evening in the Council chambers. He added that they were always looking for volunteers, and that the work done through these volunteers showed true leadership.

Councilman Delatte read aloud the certificate presented to Ms. Karen Meche and Mr. Rick Foster as follows:

In recognition of your outstanding contributions and dedication to our community. Thank you for your friendly, dependable service through every season. Your hard work does not go unnoticed. The Council wishes you continued success in your future endeavors.

The Chair allowed a photo opportunity at that time.

Mr. Rick Foster requested to speak and address the Council members. He thanked them for their recognition and also wished to recognize the many other incredible volunteers that serve in the same capacity throughout the parish and state who touch lives and ensure that our children are kept safe. He shared the purpose of their organization known as CASA. Mr. Foster conveyed the need for volunteerism in the Parish of Livingston. He encouraged everyone to consider becoming a CASA representative. He stated that Child Advocacy Services was ready to put them to work and submitted contact information for recruitment.

The chair called upon Councilman Randy Delatte who explained that he placed this on the agenda because he had been advised that the Council needed to take action on it. He stated that he would like to hear some more public discussion and make sure that no one has changed their mind.

The chair recalled that the Council had spent a great amount of time at the previous Council meeting on this agenda item. He requested that if anyone wished to have Public input on this item and wanted to submit anything that been changed since the last Council meeting or they wished to present new information, they would pick that up. However, if there had been no new information, then they may wish to defer this to the incoming newly elected Council members.

Public Input:

Deric Murphy of Quality Engineering and Surveying, 18320 Highway 42 in Port Vincent: representing Ascension Properties which is the developer for the project

Wade Holden, 9160 Harris Road, Denham Springs: advised that he was representing someone who could not be in attendance and read prepared questions/statements

Councilman Randy Delatte asked if the waiver that was being requested would be for sewer only. He called upon Mr. Deric Murphy for input.

Mr. Murphy advised that there was still the density of three (3) acres per lot per density. He stated that the waivers were still in play, and the only thing was that the asphalt would not be required, so they were offering that as an enhancement to the project.

Councilwoman Sandefur questioned why it was not going back before the Planning Commission for approval based on their ordinances. She asked why if under litigation they were even discussing it.

MOTION was made by Randy Delatte and duly seconded by Erin Sandefur to <u>deny</u> The Woodlands (LA Highway 444) waiver requests as follows:

Before moving to the next agenda item, Parish Legal Attorney Brad Cascio wished to clarify for the record that item 18ai, authorized approval of the preliminary plat; agenda items number 18aii and 18aiii were for the waivers. He advised that for the record, if the waivers were denied, then agenda item number 18ai, authorizing the approval of the preliminary plat for The Woodlands becomes moot and can be removed from the agenda. He asked the Council members if that was their intent. The chair turned to Councilman Delatte and asked if that was the intent of his motion, and he agreed. He stated that was his intent, but he would also accept the advice of Mr. Cascio.

Mr. Cascio stated that Mr. Delatte's intent was fine for the motion of the resolution. Mr. Cascio further explained that it was his desire to make sure of that intent for the record before moving on. The chair thanked Mr. Cascio for clarifying the motion and intent of the adopted resolution as stated.

The chair addressed agenda item number 19, "Introduction of Ordinance: Donation to be made to the Town of Livington of the Old/Previous 21st JDC Livingston Parish Courthouse property, located at 20180 Iowa Street, Livingston 70754 – Jeff Ard".

The chair called upon Councilman Jeff Ard who advised that Mayor "JT" Jonathan Taylor of the Town of Livingston had reached out to him concerning the old courthouse located in the Town of Livingston. He explained that the old courthouse was full of mold, was falling apart and the property was owned by the Parish. He further advised that the Town of Livingston had received a significant amount of funding. He wished to read aloud what had been submitted to him from the Town of Livingston's Mayor, Jonathan Taylor, in regard to this agenda item:

Old Courthouse Updates:

- Property was donated to the Livingston Police Jury in 1936 for the purpose of courthouse, jail or other public uses
- Courthouse was built in 1940
- It has been abandoned for eight (8) years
- He has met with Parish officials in early 2021 to discuss possibilities of the Town acquiring the property
- Senator Pope provided two hundred thousand dollars (\$200,000.00) in appropriations in the summer of '21 to begin inspections of the facilities from the drainage to the roof
- Inspections were completed and the Town Council decided to move forward with the project
- We applied for 0two million dollars (\$2,000,000.00) in Capital Outlay and was awarded the two million dollars (\$2,000,000.00)
- This will cover the first phase which includes a new PD as well as a few office spaces and an outdoor park area
- We began working with DEQ in '22 to assess the removal of hazardous materials
- We received a grant from them to pay for the cleanup
- We received another one hundred thousand (100,000) from Pope in '23 to pressure wash and weatherproof the facility which has been completed

- Cassidy has been able to place eight hundred thousand (800,000) in appropriations for the restoration of the courthouse
- We should receive this funding in '24
- Our intentions are to restore the property back to the original 1941 plans, which we have obtained, and make it the Town Hall of Livingston
- We will also have available office space for other government entities
- We have received 3.1 million so far for the restoration of this property
- Although this facility is not yet in the historical registry, it is one of the only historical structures left here in our Parish and I believe that it should be restored and not torn down

Councilman Ard explained that because this money was given to the Town of Livingston, they are required to have ownership of the building. He further explained that this was a time sensitive matter. Councilman Ard advised the Mayor that this would be placed on the agenda to have the ordinance introduced. Because there are some legal matters that the Mayor is currently addressing, Councilman Ard requested that the Public Hearing and adoption of the proposed ordinance be dated for the new Council's first meeting. At that time, the Mayor will provide whatever appropriate documentation is needed, and if amendments to the ordinance are necessary, they can be voted upon at that time.

The chair requested that the Council clerk to read the ordinance by title as follows:

The chair asked if there was anyone who wished to make the motion for the introduction of this proposed ordinance.

Councilman Jeff Ard advised that he wished to make the motion and would like to add that there is a digital video that illustrates what the Town of Livingston's intentions are for their courthouse project. He offered that if anyone wished to access the video, he could provide it to them.

Councilman Maurice "Scooter" Keen questioned if the proposed ordinance would be donating the entire property and the building or just the building? Councilman Ard confirmed that the ordinance to be introduced included both the property and the building.

The chair confirmed that there had been a motion made by Councilman Jeff Ard and it had been seconded by Councilman Tracy Girlinghouse. He then requested if there was any discussion and called upon audience members who wished to have Public input.

Public Input: Rodney Miller, resident of Livingston: asked if no one had read the courthouse's original document, that when donated, it clearly stated when the courthouse moved to the new location it would revert back to the original owners.

The chair allowed an open discussion in regard to the old courthouse's ownership and the demolition of the back section.

Councilwoman Erin Sandefur questioned if the Council should introduce the proposed ordinance without proper documentation as it seemed irresponsible.

The open discussion continued.

Councilwoman Sandefur advised that she needed attorney clarification as to how they could introduce an ordinance if they did not know if they could donate it.

Mr. Brad Cascio, Parish Legal advisor, explained that the ordinance that was being proposed was an introduction to begin the process, it would start the timeline giving public notice and the opportunity for a public hearing for the adoption of the ordinance. He further advised that if in

between that evening's meeting and the next Council meeting when the adoption occurs, if the title work is completed and it is determined that the donation is not going to be possible, then the ordinance should not be adopted by the Council.

Councilman Jeff Ard explained the time sensitivity was because of the grant. Mr. Cascio advised that if the grant funding was not used within a certain time period, it would be awarded to another eligible party.

Councilwoman Erin Sandefur wished to quantify why she would be voting in favor of the introduction of the ordinance. She explained that she would follow up on the property's title verification that was needed. She also wished to state that she felt that the other Council members agreed with her, she did not want to speak for everyone, but that the Council members did not wish to donate property that did not belong to them.

Public Input: Wade Holden: questioned the timing of the proposed introduction of ordinance

The chair wished to make it known to everyone and share his feelings on this matter. He stated that he found it hard to give away property that the Council members were not even sure that they owned. He further advised that the worst case scenario would be that after this went to an attorney and a title attorney, as well as the production of an abstract of the property, you cannot legally give away property that you do not own. He stated that it would just be impossible and called for the vote.

He defined those injection wells to be where CO2 has been injected underground for carbon sequestration to be used as long time storage. He further advised that the Parish Council has been trying to zone the Parish for a couple of years, which was still in the works from his understanding. He stated that the newly elected Parish Council members had plans to work with the new Administration to zone Livingston Parish. Councilman Mack advised that this may take approximately a couple of years to get that accomplished. He stated that this moratorium needed to be extended until zoning is in place. He explained that it was his interpretation of the state statute that this would be defined as a disposal well and this statute allowed local governments to have some say so in where these wells could be placed in a parish. He further explained that this moratorium was necessary and he wished to make the motion to introduce the proposed ordinance. He offered that if anyone had any questions he would be happy to answer them. He also wished to advise that this moratorium would be for land that was defined as private property in Livingston Parish.

The chair confirmed that the Council clerk had read the ordinance by title and advised that Councilman Tracy Girlinghouse had made the second for the introduction of the proposed ordinance.

The chair questioned if Councilman Mack wanted to set the Public Hearing and adoption of this ordinance for the first meeting in January. Councilman Mack responded in the affirmative.

Mr. Brad Cascio, Parish Legal Advisor, wished to counter her question and stated that the way the ordinance was worded, it is a maximum of forty (40) lots. He further explained that if there were any applicant who wished to develop a subdivision, they must fit the requirements of the ordinances.

Councilman Shane Mack stated that his thought on Councilwoman Sandefur's question of having forty-one (41) lots or more, is that they would follow the ordinances for subdivisions with or without improvements.

Mr. Cascio suggested a solution for an easy fix would be just to close the open ended question that states: "a maximum of forty (40) lots,with one (1) lot per three (3) acres", and add the wording: "should a development of large lots exceed the maximum of forty (40) lots, then they shall be governed and fall under the with or without improvements regulations."

Councilmen Maurice "Scooter" Keen questioned the reasoning behind the proposed ordinance amendment. He discussed previous work that he had accomplished where he was trying to make people build estate size lots instead of "little bitty" lots. He stated that the Council did away with the curb and gutter and set the lot size at ninety (90). He questioned again what was the reasoning for cutting it in half, they would build two (2) right next to each other on the same piece of property. He felt that it was kind of redundant to change it unless Councilman Mack had a reason.

Councilman Mack explained that his interpretation of the existing ordinance for Large Lot Subdivisions was that it did not have a cap on the number of lots. He advised that he did recall when the Council amended the ordinance and how it stated that if you were to do ninety (90) lots are less, then you were allowed to have individual sewer treatment systems. However, if there was more than ninety (90) lots, then community collection would be required and it could be two to three hundred lots. He stated that he remembered that the ordinance was adopted to promote large lots and was reminded how the Council waived many of the previous regulations to reduce the cost of building a Large Lot Subdivision.

Public Input:

Jeremy Glascock, 29960 Marks Drive, Livingston: argued that this was not the same issue that Councilman Girlinghouse previously had. He agreed with people needing a place to live, but questioned granting the waiver for four (4) trailers that would be put on this property.

The chair allowed Councilman Ard and Mr. Glascock to have an open discussion.

Councilman Girlinghouse also had input in the open discussion with Mr. Glascock.

Eddie Aydell, of Alvin Fairburn and Associates, noted that the intent was never to dictate what type of resident you put on any lot. In his opinion, that was the realm of subdivision regulations. It was left in by accident and wasn't intended to dictate a stick built or mobile home in Agricultural, R-1, R-2 or R-3 or R-4. He explained that was never their intent. He continued to explain that upon the latest version of the ordinance that Alvin Fairburn and Associates had prepared, they had stripped out all the references to that and to leave that up to the subdivision regulations.

Councilman Girlinghouse referred to the many conversations beforehand, and stated that short of the subdivision regulations, he did not discern between a mobile home and a house. He stated that if the subdivision stipulated that it was not allowed, then it was obviously not permissible, but he also questioned how a personal piece of property should be distinguished differently.

Councilman Delatte wished to note that the issue they were discussing was a major issue all over the Parish. He was also receiving issues with the placement of mobile homes and zoning restrictions. He advised that people would be living in mobile homes and they did not have any distinction in the zoning ordinances regarding where to put the mobile home. He further indicated that this issue had been omitted by mistake. Councilman Delatte wished to share that he had received two (2) text messages from constituents during the meeting that were being denied permitting for mobile homes because their property was located in R-2 zoning, whereby having many mobile homes located throughout area. He further explained that there were things in the 2023 budget that the Council had approved and voted upon and the budget is the bookkeeping for it.

The chair addressed agenda item number 35:

The chair confirmed with each of the committee chairmen that they were no reports to be given.

The chair addressed agenda item number 36, "District Attorney's Report:

- a. Act 393 of the 2023 Regular Louisiana Legislative Session; Changes to Open Meetings Law
- i. Adopt a resolution to approve the adoption of Parish Council rules, regulations and policies relative to the Americans with Disabilities Act (ADA) needing special assistance to participate in compliance with the Open Meetings Law
- ii. Introduction of an ordinance: to adopt and approve the ADA Policy for Open Meetings in the Parish of Livingston"

The chair called upon Councilman Delatte who stated that he had some information that he wished to share and he asked the chair to call upon him to comment on this agenda item. He stated that the Parish President's Association and the Police Jury Association had a meeting concerning this matter and in addition, legislators have formed a task force because there are no penalties if you do not comply. He stated that it was not clear what the Parishes were supposed to do. He further stated that our Parish, as well as the other sixty-four (64) parishes, were already in compliance, and that the rules were hurriedly drawn up leaving no policy if one didn't comply.

Councilman Delatte stated that the thing that was being requested, they would not be able to comply with, and that is why the task force had been appointed. He encouraged everyone to review what was being presented and not to make any adoption. It was his understanding that Guy

Cormier, from the Police Jury Association, was in the process of mailing something out to further explain. Brad Cascio, Parish Legal Advisor, noted that paragraph "H" of Act 393 had some language that tends to say that it didn't necessarily apply to them.

The chair requested if this item should be pulled, and Mr. Cascio agreed that they could for now.

Mr. Cascio wished to speak about his job as the Assistant District Attorney. He spoke of working alongside CASA and DCFS Investigators. Livingston, he said at one point, had the highest number of children in foster care out of every parish in the state. He said that there was a shortage of foster parents and CASA volunteers. He encouraged anyone leaning towards that type of service and felt that the impact on those children's lives was immeasurable.

The chair wished to note and make clear that the ordinances that were introduced earlier in that evening's meeting would not be heard at the next Council meeting and wished to reiterate and it made clear that could very well be January. He confirmed with the Council members that they did not have anything that was pressing that needed to be addressed for the December 28, 2023 meeting date. He asked if there would be a quorum at the next council meeting. He advised that all other Parish offices would be closed on that date. He also wanted to wish everyone a Merry Christmas, and not hold the December 28th meeting and pick everything back up with the new Council on January 11th.

The chair called upon Councilman Jeff Ard who wished to speak under Councilmen's comments. He recognized the Livingston Parish Basketball Tournament where the Walker boys won for the 8th straight year. He wished to add that the Walker girls won beating Denham Springs in both games. Also, in the upcoming NFL football draft, Brian Thomas Jr. will probably be a first round draft. This, being the first Livingston Parish student in that draft. He thanked District 1 for giving him the opportunity to be their voice over the past eight (8) years. He stated that it was not an easy task to be a seated Councilmember and do want everyone wants, but he hoped that he showed that instead of sitting out there and complaining, he got up and did everything that he could. He further stated that in the last two (2) years he finally seen this Parish wake up and show up in the Council chambers, because it was not like that the first six (6). He stated that he set out to make changes in our Parish and he thanked them for that opportunity.
