RE: Public Notice for Livingston Parish Drainage Improvement Project

To: All interested Federal, State, and Local Agencies, Groups, and Individuals

This is to give notice that the Livingston Parish Government has conducted an evaluation, as required by Executive Orders 11988 and 11990, in accordance with HUD regulations at 24 CFR 55.20 Subpart C Procedures for Making Determinations on Floodplain Management, to determine the potential affect this activity in the floodplain and wetland will have on the human environment.

The proposed project includes the removal of storm- and construction-related debris from eleven culverts along Interstate 12 in the cities of Denham Springs, Walker, Livingston, and Albany in Livingston Parish: 3N/S, 6N/S, 7N/S, 14N/s, 17N/S, 20 N/S, 21N/S, 42.5N/S, 45N/S, 46.7N/S, and 47N/S. The proposed project also includes the removal of storm-related debris from twenty-four waterways in the cities of Livingston, Albany, Denham Springs, Holden, Springfield, Walker, Port Vincent, Maurepas, and Killian: McLin Ditch, Tributary of Blood River, John L. Lane Creek, Hammack Road Creek, Allen Bayou, Holden Creek, Springfield Creek North, Perrilloux Road Creek, Kiss Creek, Smary Branch, Cane Market Canal, Lowe Road Ditch, Goodtime Canal, Grand Canal, Gunboat Landing, Steward branch, Off Road Tributary, Mayhaw Branch, Taylor Branch Extension, Chinquapin Canals, White Oak Creek, Lower Rome Creek, West Colyell Creek, and Middle Colyell Creek. Approximately 3,753 acres of floodplains will be temporarily impacted during construction of the proposed project.

There are three primary purposes for this notice. First, people who may be affected by activities in floodplains and those who have an interest in the protection of the natural environment should be given the opportunity to express their concerns and provide information about these areas. Second, an adequate public notice program can be an important public educational tool. The dissemination of information about floodplains can facilitate and enhance Federal efforts to reduce the risks associated with the temporary impacts to the special areas. Third, as a matter of fairness, when the Federal government determines it will participate in actions taking place in floodplains, it must inform those who may be put at a greater or continued risk.

WHEREAS, Fire Protection District No. 10 of the Parish of Livingston, State of Louisiana (the "District") will adopt a Resolution on January 25, 2024 (the "District Resolution") ordering and calling a special election to be held in the District on Saturday, April 27, 2024, for the purpose of renewing the levy and collection of a 11.1 mill tax on assessed valuation of all property subject to taxation in the District, for a period of ten (10) years, beginning with the year 2025 and ending with the year 2034, for the purpose of purchasing fire trucks and other fire fighting equipment, and for acquiring and constructing buildings to be used to house fire fighting equipment, and for acquiring, maintaining, operating and developing the District's fire protection facilities and equipment (including first response emergency vehicle services) (the "Tax"), all in the manner conferred by Article VI, Sections 30 and 32 of the Louisiana Constitution of 1974, as amended, La. WHEREAS, the District has made application to the Parish Council for approval to call and hold such election on Saturday, April 27, 2024, as more fully set forth in the District Resolution.

WHEREAS, Article VI, Section 15 of the Louisiana Constitution of 1974, as amended, and Section 1415 of Title 33 of the Louisiana Revised Statutes of 1950, as amended, grant power to the Parish Council to approve any proposal submitted by the District to levy a tax.

NOW, THEREFORE, BE IT RESOLVED by the Parish Council, as the governing authority of the Parish of Livingston, State of Louisiana, that:

SECTION 1. Pursuant to a request submitted to this Parish Council by the District and in accordance with Article VI, Section 15 of the Louisiana Constitution of 1974, as amended and La. R.S. 33:1415, approval is hereby granted to the District to call and hold an election on Saturday, April 27, 2024, for the purpose of authorizing the renewal of the levy and collection of a 11.1 mill tax on assessed valuation of all property subject to taxation in the District, for a period of ten (10) years, beginning with the year 2025 and ending with the year 2034, for the purpose of purchasing fire trucks and other fire fighting equipment, and for acquiring and constructing buildings to be used to house fire fighting equipment, and for acquiring, maintaining, operating and developing the District's fire protection facilities and equipment (including first response emergency vehicle services) (the "*Tax*"), in the manner conferred by Article VI, Sections 30 and 32 of the Louisiana Constitution of 1974, as amended, La. R.S. 40:1501 and the applicable provisions of Chapter 6 and Chapter 6-A of Title 18 of the Louisiana Revised Statutes of 1950, as amended, and other constitutional and statutory authority and as more fully set forth in the District Resolution.

SECTION 2. In the event the foregoing proposition passes, approval, consent and authority are hereby granted to the District to levy and collect the Tax described in Section 1 hereof.

SECTION 1. SECTION 2. SECTION 5. A real necessity is hereby found for the employment of special counsel in connection with the Election, and accordingly Butler Snow LLP, Special Counsel, is hereby employed and requested to do and perform comprehensive legal and coordinate professional work with respect to the Election. Said Special Counsel shall prepare and submit to this Governing Authority for adoption all of the proceedings incidental to the authorization of the Election and shall counsel and advise this Governing Authority as to the Election. The fee of special counsel in connection with the Election is hereby fixed at a sum not to exceed the maximum hourly fee allowed by the Attorney General's fee guidelines for comprehensive legal and coordinate professional services, plus "out-of-pocket" expenses. A certified copy of this Resolution shall be submitted to the Attorney General of the State of Louisiana for his written approval of said employment and of the fee herein designated.

SECTION 6. This Resolution shall take effect immediately upon adoption.

BE IT RESOLVED by the City Council of the City of Walker, State of Louisiana, a municipality located in Livingston Parish, Louisiana, by motion offered by Mr. Wales, seconded by Mr. Griffin, hereby stating that:

A Resolution ordering and calling a special election to be held in the City of Walker, State of Louisiana (the "City") on Saturday, April 27, 2024, for the purpose of authorizing the renewal of the levy and collection of a one-half of one percent (1/2%) sales and use tax within the City; making application to the State Bond Commission; and providing for other matters in connection therewith.

WHEREAS, the City Council of the City of Walker, State of Louisiana (the "Governing Authority"), acting as the governing authority of the City, desires to order and call a special election to be held in the City on SATURDAY, APRIL 27, 2024, to authorize the renewal of the levy and collection of a one-half of one percent (1/2%) sales and use tax for a period of twenty-five (25) years, commencing April 1, 2025, upon the sale at retail, the use, lease, rental, consumption and storage for use or consumption, of tangible personal property and on sales of services in the City, with the proceeds to be used for the purposes of extending, improving, maintaining and operating the sewerage system of the City, constructing, improving and maintaining public streets and drainage facilities, including equipment therefor (the "Tax"); and

NOW THEREFORE, BE IT RESOLVED by the Governing Authority, that:

SECTION 1. Election Call. Subject to the approval of the State Bond Commission and under the authority conferred by Article VI, Section 29 of the Constitution of the State of Louisiana of 1974, as amended (the "Constitution"), La. R.S. 47:338.1 and the applicable provisions of Chapters 5 and 6-A of Title 18 of the Louisiana Revised Statutes of 1950, as amended (the "Election Code"), and other constitutional and statutory authority, a special election (the "Election") is hereby called and ordered to be held in the City on SATURDAY, APRIL 27, 2024, between the hours of 7:00 a.m. and 8:00 p.m. in compliance with the provisions of Section 541 of Title 18 of the Louisiana Revised Statutes of 1950, as amended (La. R.S. 18:541), and that at the Election there shall be submitted to all registered voters residing in the City qualified and entitled to vote at the Election under the Constitution and laws of the State of Louisiana and the Constitution of the United States of America, the following proposition, to wit:

PROPOSITION (RENEWAL)

Shall the City of Walker, State of Louisiana (the "City") be authorized to renew the levy and collection of a tax of one-half of one percent (1/2%) for a period of twenty-five (25) years, commencing on April 1, 2025, upon the sale at retail, the use, the lease or rental, the consumption, and the storage for use or consumption, of tangible personal property and on sales of services in the City, all as defined in R.S. 47:301 through 47:317, inclusive, with the net proceeds of the tax (an estimated \$1,800,000 reasonably expected at this time to be collected from the levy of the tax for an entire year), to be expended for the purpose of extending, improving, maintaining and operating the sewerage system of the City and constructing, improving and maintaining public streets and drainage facilities, including equipment therefor, and shall the City be further authorized to fund the proceeds of the tax into bonds to pay the cost of any of the aforesaid capital purposes to the extent and in the manner permitted by the laws of Louisiana?

SECTION 2. <u>Proceeds of the Tax</u>. Conditioned on the passage of the Tax at the Election authorized pursuant to this Resolution, all avails or proceeds of the Tax (after paying the reasonable and necessary expenses of collecting and administering the Tax) collected in the City shall be used entirely and to be dedicated and used exclusively for the purposes set forth in the proposition.

SECTION 3. <u>Publication of Notice of Special Election</u>. Pursuant to La. R.S. 18:1285, a Notice of Special Election concerning the Election will be published in the *Livingston Parish News*, a newspaper of general circulation within the City, and is the official journal of the City, once a week for four (4) consecutive weeks, with the first publication to be made not less than forty-five (45) days nor more than ninety (90) days prior to the date fixed for

the Election, which notice shall be substantially in accordance with the Notice of Special Election annexed hereto as Exhibit A and incorporated herein by reference, to the same extent as if it were set forth in full.

- SECTION 4. <u>Canvass of Election Returns</u>. This Governing Authority shall meet at its regular meeting place, on Monday, May 13, 2024 at 6:00 p.m. at City Hall, 13600 Aydell Lane, Walker, Louisiana, and shall then and there in open and public session proceed to examine and canvass the returns and declare the result of the Election.
- SECTION 5. <u>Polling Places</u>; <u>Commissioners</u>. The polling places set forth in the aforesaid Notice of Special Election and situated within the corporate limits of the City be and the same are hereby designated as the polling places at which to hold the said Election in accordance with Section 1286(A) or Section 1286.1, as the case may be, of Title 18 of the Louisiana Revised Statutes of 1950, as amended, and the Commissioners-in-Charge and Commissioners, respectively, will be those persons designated according to law in accordance with Section 1286(A) or Section 1286.1, as the case may be, of Title 18 of the Louisiana Revised Statutes of 1950, as amended.
- SECTION 6. Designation of Commissioners and Commissioners-in-Charge. The officers designated to serve as Commissioners-in-Charge and Commissioners, respectively, pursuant to Section 5 hereof and in accordance with Section 1286(A) or Section 1286.1, as the case may be, of Title 18 of the Louisiana Revised Statutes of 1950, as amended, or such substitutes therefore as may be selected and designated in compliance with Section 1287 of Title 18 of the Louisiana Revised Statutes of 1950, as amended, shall hold the said Election as herein provided, shall make due returns of said Election for the meeting of the City Council, as governing authority of the City, to be held on Monday, May 13, 2024, and that the compensation of said officers be and the same is hereby fixed at the sum prescribed by law. All registered voters in each precinct and residing in the City are entitled to vote at the said Election.
- SECTION 7. <u>Authorization of the Clerk</u>. The Clerk of the Governing Authority be and is hereby empowered, authorized and directed to arrange for and to furnish to said election officers, in ample time for the holding of said Election, all equipment, forms and other items which may be required by State and/or federal law in order to hold said Election.
- SECTION 8. <u>Furnishing Election Call.</u> In accordance with La. R.S. 18:1285(B)(1), certified copies of this Resolution shall be forwarded to the Secretary of State, the Clerk of Court and Ex-Officio Custodian of Voting Machines in and for the Parish of Livingston, State of Louisiana, and the Registrar of Voters in and for said Parish, as notification of the Election herein called, in order that each may prepare for said Election and perform their respective functions as required by law.
- SECTION 9. <u>Estimated Collections</u>. Pursuant to La. R.S. 18:1284(C), an estimated \$1,800,000.00 is reasonably anticipated at this time to be collected from the levy of the Tax for an entire year.
- SECTION 10. <u>Application to State Bond Commission</u>. Application be and the same is hereby formally authorized to be made to the State Bond Commission (the "*Commission*") for consent and authority to hold the aforesaid Election as herein provided and that a certified copy of this Resolution will be forwarded to the Commission on behalf of the Governing Authority, together with a letter requesting the prompt consideration and approval of said application.
- SECTION 11. <u>Additional Notice Requirement</u>. This Governing Authority made the announcement with respect to this Resolution required by La. R.S. 42:19.1, at its public meeting on Monday, December 11, 2023 and published said announcement in the official journal on Tuesday, December 12, 2023. Such announcement was also transmitted via email to State Senators and Representatives on Thursday, December 14, 2023.

Section 2: Any qualified person desiring to become a candidate for the office shall file a notice of candidacy, accompanied either by a qualifying fee or a nominating petition, as required or authorized by law, with the appropriate election official in the manner and form, and under the procedures and conditions, provided by R.S. 18:461 *et seq.*, and all other applicable provisions of the Louisiana Election Code, R.S. 18:1 *et seq.*, during the period commencing Wednesday, July 17, 2024 and ending at 4:30 p.m. Friday, July 19, 2024.

Section 3: The special election shall be held and conducted under the applicable provisions of the Louisiana Election Code, R.S. 18:1 *et seq*.

Section 4: The primary election shall be held Tuesday, November 5, 2024, and the general election shall be held Saturday, December 7, 2024, at the times and places and in the manner, prescribed by law.

Section 5: The Secretary of State, Commissioner of Elections, Parish Board of Election Supervisors, Clerk of Court, Registrar of Voters, and all other persons charged with any power, function, right, duty or responsibility in conducting elections in the jurisdiction of the School Board, District 2, Parish of Livingston, are hereby authorized, requested, directed and empowered to exercise every lawful function and to do every act necessary to conduct the special election, to cause the returns to be made, to canvass and promulgate the results, and to perform all related and incidental functions.
