WHEREAS, upon contact and communication with the Livingston Parish Planning Department, recommendation was suggested that the Livingston Parish Council amend Section 125-1, "Definitions", to be consistent with numerous amendments of Chapter 125, "Subdivision Regulations", and;

WHEREAS, upon this determination, the Livingston Parish Council now wishes and desires to amend the Chapter 125, "Subdivision Regulations", by amending Section 125-1, "Definitions," which defines the term "Subdivision", located in Part Four (4), by removing the verbiage "and Parish Council".

NOW, THEREFORE, BE IT ORDAINED by the Parish Council of Livingston, Louisiana: Section 125-1, "Definitions", that defines the term "Subdivision", Part Four (4), of the Code of Ordinances of the Parish of Livingston, Louisiana is hereby amended to read as follows: Section 125-1 Definitions

Subdivision:

All subdivision and/or re-subdivision developments with and without improvements (4) consisting of a combined total of ten (10) lots or more, not previously submitted, must submit for approval to the Parish Planning Commission and Parish Council, all requirements set forth in Section 125-13 or 125-14, accordingly.

BE IT FURTHER ORDAINED by the Livingston Parish Council, governing authority of the Parish of Livingston, that if any provision of this ordinance is held invalid, such invalidity shall not affect other provisions, items, or applications of this ordinance, which can be given effect without the invalid provisions, or application, and to this end the provisions of this ordinance are hereby declared severable.




