### **K-W School Board faces Budget Cuts**

Kenyon-Wanamingo school board look at the 2021-22 school year expenditures. At the January board meeting the board terminated the SRO contract for the coming school year as well as closing the Knight's Kids learning center. This will save nearly

Budget cuts are the main focus as the \$100,000 annually. The board also approved a salary cap for the board members saving nearly \$10,000 per year. The activity shuttle is also being scrutinized since the district is losing over \$10,000 annually on the service. A drop of thirty students this year has also cost the district about \$200,000 in state

funding.

The board will have to approve a financial plan by June 30th to maintain fiscal solvency. The failure to pass the operating levy last fall has put the district in this position.

### **Goodhue County's COVID Vaccination Rates Surpass Positive COVID Case Rate**

Goodhue County, Minnesota - On February 2, 2021 the number of Goodhue County residents who have received at least one dose of COVID-19 vaccine exceeded the number of positive lab confirmed cases of COVID-19 in Goodhue County. Almost 4,000 Goodhue County residents have rolled up their sleeves to receive the COVID vaccine. This is an exciting moment in the COVID-19 pandemic for Goodhue County.

In Goodhue County, there have been more than 3,681 positive lab confirmed cases of COVID-19. Sadly, this includes 64 deaths related to COVID-19 that have been confirmed by the Minnesota Department of Health (MDH). This number also includes 171 cases requiring hospitalization. This total number comes after almost twelve months of the COVID-19 pandemic.

2020 ended with Goodhue County agencies receiving their first doses of the COVID vaccine in late December. In only 2 months, the number of vaccinated residents has exceeded the number of positive lab confirmed cases of COVID-19 in



Goodhue County. As of Feb 3, there are 3,791 people who received at least 1 vaccine dose and 1,095 people with completed vaccine series (2 doses) in Goodhue County. This is an exciting time and highlights the

importance of COVID-19 testing as well as continued efforts by all Minnesotans to limit the spread of the disease.



lived, died, and rose again to set us freethen we are His followers; and His love lives in us. There are times when it is tough to love someone. There are people that may be very annoying, or mean, or hateful to us or to the people we love, but Christ reminds us that He loves them too. He loved us before we were very lovable. As we celebrate the month of "love" may we learn to extend the same love that God has displayed towards us to all the people that He created and for whom He died for. In reading stories about people like the man in this episode, people who don't really under stand Jesus, I'm tempted to look people who don't really under stand Jesus, I in tempted to look down on them. The man appears to have been wealthy, and he had a high opinion of how well he kept the law. But he seems to have had no idea that Jesus was simply calling him to give his whole life to God—or maybe he just didn't want to do that. I think to myself, "I guess he just doen't get what it means to follow Jesus."

Often I don't catch what Jesus is about, or understand what he has just said, or realize what he expects of me. But in this story, Jesus doesn't look down on the man. Jesus looks at him and loves him, the Bible says. I am so thankful that—even though the man had it all wrong— Jesus didn't just dismiss him or condernn him. Instead, Jesus loved him and invited the man to follow him. Right there is something wonderful I can learn from Jesus.
- When I don't understand his teachings, or when I misunder stand the truth about Jesus and his kingdom, there is still a loving invitation from Jesus to follow him and keep learning.
- Whatever else Jesus says to the man in the story, it's in the intext of Jesus' love for a person who doesn't fully get it. That reassuring to me!
- Thank you, Jesus, for looking at me with love even w ave it all wrong. Instead of seeing what I have done, she hat you have done for me. Amen.

**COVID-19** Variants Variants are common with a virus like COVID-19. Viruses constantly change through mutation, and new variants of a virus are expected to occur over time. Multiple COVID-19 variants are circulating globally. Variants first detected in the United Kingdom (UK), Brazil, and South Africa have been detected in the United States. The UK and Brazil variants have been identified in Minnesota. MDH and our partners are actively testing new positive test samples to continue to detect variants

and learn more. Minnesota Commissioner of Health Jan Malcolm stated, "We know that even as we work hard to defeat COVID-19, the virus continues to evolve as all viruses do. That's yet another reason why we want to limit COVID-19 transmission – the fewer people who get COVID-19, the fewer opportunities the virus has to evolve. The good news is that we can slow the spread of all COVID-19 variants by using the tried-andtrue prevention methods of wearing masks, keeping social distance, staying home when sick, and getting tested when appropriate.'

There have been several cases in Minnesota of COVID-19 variants. "These cases illustrate why it is so important to limit travel during a pandemic as much as possible," said State Epidemiologist Dr. Ruth Lynfield. "If you must travel, it is important to watch for symptoms of COVID-19, follow public health guidance on getting tested prior to travel, use careful protective measures during travel, and quarantine and get tested after travel." 



A lawsuit filed last October in Minnesota District Court challenges the agreement claiming the requirement violates the U.S. Constitution's commerce clause. A Wisconsin based garbage hauler has handled refuse from Countryside Disposal, Advanced Disposal and Flom Disposal. These three haulers provide a third of their business. The new ordinance will double the tipping fees these hauler pay to deliver garbage. Flom Disposal has asked the city of Kenyon for a 25% increase in rates to defray the raise. 
### **Commissioner Corner**
