The Knight Kids program also has run a loss of over 108,000 for the year due to a drop in enrollment and other Covid related issues.

Kenyon Native Named Goodhue County Citizen of the Year

Ray Sands of rural Kenyon, was named Goodhue County Citizen of the year this winter. Ninety-year old Sands started his musical journey eight decades ago when as a nine year old he received an accordion as a gift from his parents. Soon after he was playing music with the family and he knew he always wanted to be a musician. One of Sands favorite band leaders is Lawrence Welk. He recalls seeing him many years ago at the Prom Ballroom in St. Paul, where he watched him from the front row and decided right there to be a band leader. He was also a farmer, milking his cows and running his land until he was eighty years old.

The Polka Dots were formed in 1949 to play a concert to raise funds for a new community hospital in Zumbrota. They continued to play together and recorded their first album in 1953. The band has played continuously since that time, but Ray is the only original member left. Sands remembers the original band members as all great guys. They drove to many venues to perform over the years and recalls one night traveling to Hersey, Wisconsin. "Coming into town and



we see a streetlight. Turns out it was a Hiawatha Train going 85 mph. The car stopped just inches from it. It took the boys a while to calm down before playing. On the way back out of town we stopped to check the railroad crossing out," Sands relates. "Blown over by the wind and laying in the grass was the black and white crossing sign. We could just imagine the headlines Entire Orchestra Killed by Train."

Scripture Reading — Genesis 11:1-9

Scripture Keadang — Genesis 11:1-9
"Let us ... make a name for ourselves ... [and not] be scattered over the face of the whole earth." - Genesis 11:4
God created people so that they would increase in numbers and populate the earth. At the time of the tower of Babel, everyone had the same language, and the people said they wanted to make a name for themselves and not be scattered across the earth. But God ultimately scattered them.

why did they build a tower? They said, "Come, let us build ourselves a city, with a tower that reaches to the heavens. . . ." From ancient civilizations we have learned that the top of a tower was seen as a holy place where gods lived. But instead of having a holy place that would honor God, the people at Babel wanted this to be a place where they made a name for themselves. They wanted to honor themselves instead of God. In doing so, they banished God from their lives and disobeyed his command to "fill the earth and subdue it" (Genesis 1:28). Because of this rebellion, God confused their language and scattered them. Imagine how God felt as he confused the people's language. They couldn't understand each other. They couldn't work together anymore. They stopped building, and they moved away from each other.

In the end, people who drive out God cannot do well. They cannot understand each other, and they cannot work to gether to build a community that honors God.



Some of the highlights for the band include being invited to play at the International Polka Festival in Kitzbuhel, Austria. One hundred and fifty friends and fans accompanied the band. A few years later, the band and its fans toured Scandinavia. Another highlight was performing a concert at the John F. Kennedy Center for the Performing Arts in Washington DC representing the state of Minnesota in 1997.

In November of 2000, Ray Sands and the Polka Dots were inducted into the

Minnesota Music Hall of Fame One of his most notable appearances was in October of 2010 when he did a show with Garrison Keillor at the State Theater in Zumbrota. The following January 23rd the band performed at the Rochester Mayo Civic Center with Keillor's Prairie Home Companion along with "Sweet Dreams" a girl's trio from Kenyon, Wanamingo and Goodhue. This show appeared on over 700 stations to 4.3 million viewers worldwide.

Ray wrote "The Polka Dots Waltz" and "How Soon?". His wife Sue composed "Bryan's Polka" for their grandson. His favorite song is the Ping Pong Polka, which was popular in the early 1950's. "Flyswatter" is a unique tune that was recorded by the California alternative rock band, The Eels. They asked Sue to arrange it "polka style" and was performed by The Eels on the Late Night Show with David Letterman.

Sands said he and the band's music was featured in a 2016 film called "His Neighbor Phil," about a woman with Alzheimer's disease. The movie features

Stephanie Zimbalist and Daniel Roebuck. Sands said the first sound of the movie is from the group's old-time hit song "The Ping Pong Polka." He said the reason the band was asked to participate in the movie was because of music's known effect on

people with Alzheimer's.

Ray says "we only played four gigs in 2020. So, you get out of practice. I picked up the accordion to play and my fingers were rusty. We have some shows to do this year, but it is getting close to the end."





K-W Schools Face Budget Cuts

The district was facing a fund balance of -2.88% by the end of the fiscal school year. The state considers a -2.5% fund balance as statutory operating debt status and can step in to demand corrective steps. Last month the board announced the termination of the school resource officer program as one of the steps to balance the budget.

The state of Minnesota has promised a Covid relief package in excess of \$320,000 for this year but as of yet the district has not seen any of it materialize and are not certain in which ways the funds may be required to be allocated. The Knight Kids summer program may be moved to Kenyon partly due to the Kenyon pool having a 1' and a 2' kiddie pool separated from the larger pool. Superintendent Boysen is looking at areas such as transportation costs, vendor contracts, activities shuttles and spending freezes to reduce expenditures. All contracts are subject to examination to determine areas which can be reduced or eliminated for cost savings. At this point the school budget deficit is anticipated to come in at -2.39% for the end of the fiscal year leaving the district little room for unexpected expenses.



Like dull color, browning tips, yellowing or leaf drop. What could be going on? A few things. Our homes aren't getting as much light and humidity at this time of year and that has an

My Norfolk Pine is not pleased... and frankly, I'm embarrassed. BUT, my home is very dry and I didn't check the mois-


ture as well as I should have. But my Mother-in-law tongue is a happy camper.

Two plants, different needs. Something very helpful I've learned is, when you first purchase your houseplant, keep it in the pot it's been growing in. These are designed to drain.

Place the new plant in your decorative pot, if there's no drainage to that one, then either make a hole in the decorative container or use a plastic saucer underneath so your plant doesn't sit in water. That's the quickest way to kill them.

Another thing, invest a few bucks in a moisture meter. I had no idea how helpful that it was going to be! Mine also measures pH but you can buy ones that measure soil temperature too!

For plants that require humidity, pebble trays of water and/or misting are two of the best things you can do for them.



Minnesota Produce Farmers Asked to Complete Annual Questionnaire

The Minnesota Department of Agriculture (MDA) is urging all Minnesota produce farmers to fill out the 2021 Grower Questionnaire. Produce farmers are asked to complete the questionnaire annually to determine how the federal Food Safety Modernization Act (FSMA) Produce Safety Rule applies to their operation and what steps they must take to comply with safety regulations which are based on several factors including sales outlets and volume.

By completing the questionnaire, farmers receive official notice from the MDA Produce Safety Program regarding their farm's requirements, as well as get information about trainings and general on-farm produce safety. While participation in this questionnaire is voluntary, farmers who opt out will be contacted by the MDA to determine the farm's regulatory status under the Produce Safety Rule.

Data collected from the annual questionnaire provide the MDA with a more accurate assessment of Minnesota's expanding produce farming sector including the number of farms and annual sales. This information also assists the MDA in developing resources to meet the needs of produce farmers.

Data collected from approximately one third of the state's estimated total number of produce farms has verified that Minnesota:

Has at least 80,000 acres dedicated to produce production

Has at least \$39,000,000 in annual produce sales

Has more than 1600 produce growers and that number continues to increase each year

The privacy of questionnaire respondents is safeguarded; farm contact and location information are classified as private or non-public data. The 2021 MDA Grower Questionnaire is available online at www.surveymonkey.com/r/ProduceSafety

Preliminary results from pesticide study show widespread neonicotinoid exposure in Minnesota white-tailed deer

Preliminary results of a study testing white-tailed deer spleens for presence of neon-icotinoid pesticides show exposure of deer throughout the state, according to the Minnesota Department of Natural Resources (DNR).

Further analysis is required to determine if the levels of exposure seen are high enough to adversely affect deer health. Additional study results related to exposure levels will be available this spring.

Neonicotinoids, often referred to as "neonics," are the most widely used class of insecticides worldwide and are found in more than 500 commercial and domestic products in the U.S. They are present in a wide array of products used for insect control in homes, gardens, yards, and crops, as well as on pets.

The DNR launched a research project in fall 2019 following a study conducted on captive deer in South Dakota that raised concerns about potential adverse effects of neonicotinoid exposure, including reduced fawn survival.

The DNR asked Minnesota deer hunters to submit spleens from their harvested wild deer. Nearly 2,000 people requested sampling kits to participate in the study and 800 spleens were collected from all areas of the state.

"We wanted to know if wild deer in natural settings are being exposed to neonics and if certain habitat types had a higher risk," said Michelle Carstensen, DNR's wildlife health program supervisor. "Minnesota is a great place to ask this question, as deer are dispersed across the forest, farmland, prairies, and urban landscapes."

The DNR's preliminary results show that deer across the state have been exposed. Of the 800 deer spleens that hunters harvested in Minnesota during the 2019 hunting season, 61% of samples indicated exposure to neonicotinoids.

While these preliminary data focused on deer, Minnesota Department of Health believes there is likely little-to-no human health risk for consuming venison from deer that may have been exposed to neonicotinoids. These early findings suggest concentrations found in the deer spleen samples were far below the U.S. Environmental Protection Agency's allowable levels for consumption of other foods, like fruit or beef, that may have neonicotinoid residue.

The Minnesota DNR is planning additional sampling this fall and is exploring future research options on neonicotinoids in wildlife.
