# K-W School Looks to Pass Third Operating Levy



The K-W school board is hoping the third time is the charm with a passage of an operating levy. The

existing operating levy of \$296 per pupil will expire at the end of the year. The school district attempted to pass an operating levy in 2019 to replace the current one but it failed at the ballot box. They tried again in 2020 with a failed result as well, with about 60% of voters against the increase.

The district made a number of cuts to the budget last year in order to stay out of statutory operating debt. The district is currently operating at a 2.31% general fund deficit. If the negative number hits 2.5% the state would enact strict budget restraints and possibly with hold state aid if improvement was not seen. The district budget has held steady with the end of the fiscal year only weeks away, but there needs to be progress toward increasing the budget reserve.

The school board is looking at a public survey to gauge the sentiment for a fall vote

on a ten-year operating levy referendum. Without the additional funding, it is obvious deeper cuts would have to be made to balance the budget.

# Stand Firm

When we think of something strong and immovable, we don't think of jello, do we? Jello wiggles: it's soft, it's squishy- but we don't think of it as something firm- a foundational material. We wouldn't use gelatin to set the walls in our basements- we would use cement. Cement sets up solid and unmovable. That's why we use if for foundations, for holding our posts in, for setting up our swing sets or our basketball poleswe want something that is going to hold and to stay firm.

It's important for believers to have a solid foundation for their faith as well. It is impossible to grow our faith and become the person that God has created us to be if our faith is wiggly- or wavering. Paul said "thanks be to God! He gives us the victory through our Lord Jesus Christ. 58 Therefore, my dear brothers and sisters, stand firm. Let nothing move you. Always give yourselves fully to the work of the Lord because you know that your labor in the Lord is not in vain." 1 Corinthians 15:57-58.

Paul says, THANKS be to GOD- He gives us victory!!! Victory- who doesn't want to be victorious. What does Jesus gives us victory over? Jesus defeated death. Jesus died on the cross- laid in the tomb for 3 days and He rose victorious out of the grave! That's power!!! That's a miracle! That's Jesus! Paul has corrected, disciplined, encouraged, loved, and he has come to the end of his letter. He wants to leave them encouraged, empowered, and

hopeful for the future. Thanks be to God!" Jesus gives us victory through His mercy and grace. He gives us victory over death and over sin. Jesus didn't leave us with 'Jello' type promises, he gives us cement to build our lives on. The unswerving, unchanging, unwavering truth of Jesus Christ-HIS Word and we hold it here in our hands!

The prophet Elijah challenged the people of Israel, "How long will you waver between two opinions?" You can find this story in 1 Kings chapter 18. The definition of waver is: a) shake with a quivering motion. b) become unsteady or unreliable. c)be undecided between two opinions or courses of action. Kind of sounds like a date night, 'honey where would you like to go, oh I don't care- where would you like to go? I don't care- you pick. I really don't care either you pick! That can go on for a while. We're so busy trying to please someone else that we are missing the importance of making a choice and sticking to it. In choosing a restaurant- probably not a big deal- but in regard to our faith: it can have eternal implications. We can't be wishy washy about our faith and our life. Alexander Hamilton said, "Those who stand for nothing fall for anything." The people of Israel were worshiping an idol by the name of Baal- Elijah challenged the people- and Paul challenges you and me: it's time to choose!

We admire people that have stood firm despite terrible opposition: Dietrich Bonhoeffer stood firm in his faith. His is a story of faith, of conviction, of standing firm in his beliefs- and was willing to die for those beliefs too. Dietrich Bonhoeffer was a German Lutheran pastor during the Nazi regime. He spoke out against Hitler's policies, especially of the extermination of

the Jews. He also worked against Hitler and his Nazi party. Dietrich was arrested and 2 days before the Allies arrived, he was executed for his unwavering faith and his belief that all Hitler stood for was diametrically opposed to the laws of Jesus Christ.


Paul wrote, "Always give yourselves fully to the work of the Lord, because you know that your labor in the Lord is not in vain." We are called to give ourselves fully to the work of the Lord. Deitrich understood that— he gave himself totally and sacrificially to the work that God had called him to do. He was willing to give his all to the work that Christ called him to do.

God's calling is different for each of usand even during our lifetimes our calling will change or morph into something different. And to us it may seem like a different direction, but all along the way, God uses those circumstances, those learning experiences to prepare us for what He has called us to in the future. Because of the experiences that I have went through in my life, I am better able to relate to people in similar journeys. The day I laid my all on the altar- was the day that truly began my life- I did become a new creature in Christa new person- filled with the Holy Spirit's power to live a new life.

God is calling you. He is calling each of us. He isn't calling all of us to be pastors, or theologians, or teachers, or missionaries, or even to be activists, but He is calling us to be fully devoted followers of Jesus. He is calling us into the workplace, into the schools, into our homes and into our communities. When we walk with Christthat's what it is—a walk—a life—it isn't a sprint-it's a marathon. We are all called to be fully devoted followers to whatever he has called us- we can become 'marketplace missionaries.' This is a term being used

more and more to describe men and women that don't leave their faith at church or on the shelf in their bedroom, but men and women that live their faith in the workplace. They share their faith stories and invite others to join them in following Jesus.

Only God is God, and He alone knows what is best for us. He alone is the path to life, love, and victory. God is calling you. God desires you to fully follow Him. To put aside all the distractions, to lay aside your plans and be totally on board with His plans for you. Will he send you to deepest darkest Africa? maybe or maybe not. He will send you to work; to go and tell, to love Him with all you heart, soul, and mind. If Jesus is Lord of your life "Follow Him" if Baal- is your god- follow him. Time to choose: No More JELLO!

### Seeing and Welcoming

Scripture Reading — Hebrews 11:1-2, 13-16 They did not receive the things promised; they only saw them and welcomed them from a distance. — Hebrews 11:13

Hebrews 11 gives us a glance in the Bible's rearview mirror. The faithful witnesses mentioned in this chapter lived long ago, even before Jesus came. And they had this in common: they all lived by faith in God's promises. And before they died and were taken to live with the Lord, "They did not receive the things promised; they only saw them and welcomed them from a distance."

"Seeing from a distance" is how we can describe the sights, sounds, and scenes in the book of Revelation. Revelation 11 closes with a scene in which all heaven rejoices and gives thanks to God because "the kingdom of the world has become the kingdom of our Lord and of his Messiah." It is a powerful picture of God reigning on earth as in heaven. And the promise is that "he will reign for ever and ever." Hallelujah!

With eyes of faith, we can see this "from a distance." Close-up in the world around us, though, we often see terrible things such as cancer, COVID-19, poverty, racism, violence, addiction, and death. And there are times when these appalling things make us weep. At such times, faith is the Holy Spirit's muscle that enables us to see "from a distance."

Faith also welcomes the future of God's full kingdom today. Faith has this power because it is "confidence in what we hope for and assurance about what we do not see."

Prayer: "Our Father in heaven, hallowed be your name, your kingdom come, your will be done" here today—"on earth as it is in heaven." Amen.

# 2021 Goodhue County Breakfast on the Farm Dairy Drive-Through Event

The Goodhue County dairy farmers, the Goodhue County American Dairy Association, and 1250 KCUE Radio will be showcasing dairy farming and wholesome products at their annual Breakfast on the Farm Dairy Drive-Through Experience held Friday, June 25th. The purpose of the Breakfast on the Farm event is to share with the public how the dairy industry works and contributes to the local economy and way of life. Events like these provide visitors the opportunity to get a first-hand look at where their wholesome and nutritious dairy products come from, and how dairy farmers care for their cows and land.

This year's breakfast will be hosted by the Lexvold Dairy in rural Goodhue. Brent and Wendy Lexvold currently milk approximately 400 cows, raise young stock, and farm 420 acres of corn and hay to provide feed for their cattle. Originally started almost 60 years ago by Lyle and Loretta

Lexvold, the third generation of the Lexvold family is currently actively part of their dairy operation.

Guests at the Lexvold Dairy will be able to drive through the family's operation, seeing first-hand the facilities and how the family and their employees work to produce milk used in wholesome dairy products. There will also be opportunities to interact with local FFA members, various volunteers from agricultural agencies, the Goodhue County Dairy Princesses, and agricultural related business professionals. The 67th Princess Kay of the Milky Way, Brenna

Connelly, will also be on hand as the goodwill ambassador for Minnesota's dairy industry. Visitors will have the opportunity to get a look at the farm's milking parlor in action, various calf and cow housing facilities, and some of the farming equipment used.

Each area will be staffed by volunteers who will explain milking practices, farm safety, cow care, and answer other questions in regards to modern farming.

While a slightly different event than previous years, visitors will still have the opportunity to name a calf, receive dairy goody bags, play farm bingo, and take pictures

with the Goodhue County Dairy Princesses. A highlight of the event is always the nutritious and delicious dairy treats.

The Goodhue County Breakfast Dairy Drive-Through Experience runs from 7:00-11:00 am. The Goodhue County Breakfast on the Farm committee is led by local dairy producers and sponsored by KCUE Radio of Red Wing and other local businesses.. KCUE will be producing their morning broadcast live on the farm sharing information and talking with the many contributors to the dairy industry. 

ADOPT AGENDA: Ohr motioned to the agenda, seconded VanDeWalker. Passed 5-0-0.

**CONSENT AGENDA:** Flotterud motioned, seconded by Dierks. Passed 5-0-

### **PRESENTERS:**

- A) Monty Schaefer reported on:
- 1) Swimming pool concrete patch work completed to main pool sidewall and kiddie pool decking as part of requirements by MN Department of Health. The pool has been pressure washed, acid washed, and painted. The pool is currently being filled up with
- 2) Riverside Park water turned on, bathrooms open, and getting ready to be open for season.
- 3) Mowed at the WWTP, community garden, undeveloped lot boulevards, and other various areas around town
- 4) Starting to spray weeds around town at the parks, various City properties, public sidewalks, and along the curbs of all the streets
- 5) WWTP clarifier motor repaired by Olson Motor Repair
- 6) Completed jetting all sanitary sewer main lines around the community
- 7) Started to patch potholes with cold mix around the community
- 8) Plan on repairing water shut off valve (curb stops) in the near future. 8-10 of them were damaged by snow plows over the win-

Flotterud asked when the Mingo View water tower would be drained and cleaned out. Schaefer stated that the plan was to drain and clean out the Mingo View water tower in the next 2-3 weeks.

Mayor Holmes presented the Wanamingo Maintenance Staff the 2020 Minnesota Pollution Control Agency Certificate of Commendation for the Waste Water Treatment Plant. The MPCA recognizes exceptional compliance with its Minnesota Pollution Control Agency NPDES/SDS wastewater permit during the 2020 review year.

- B) Julie and Dylan Steberg reported on:
- 1) Pool is set to open on June 7th with an expected closure Labor Day (Depending on guard availability)
- 2) 20 new lifeguard applicants with 8 returning guard. Plan to hire 9 new guards. There are great applicants and not all will be able to be hired in order to get enough shifts for all guards.
- 3) Dan and Katie VanEpps are getting WSI (Water Safety Instructor) certified to teach swim lessons.
- 4) Mandatory in-service for Staff will be on June 4th

- 5) Hoping to have pass and lesson sign-up available to the public, starting May 12th. Sign-ups will be available at City Hall until the pool opens. Once the pool opens, signups will be available at the pool.
- 6) Outdoor and swimming pool COVID restrictions have been lifted by the Governor. There will be no additional restrictions or changes in place at the pool beyond regular rules/policies.
- 7) Thanked City Council for past support. A request was made to purchase water aerobics weights. The City Administrator will work with the pool manager to gather estimates for what weights cost to see if the request can work into the pool budget.

### **NEW BUSINESS:**

**RESOLUTION:** 

Accepting the 2020 21-034 = Wanamingo Audit: Ohr moved to approve, seconded by Dierks. Flotterud shared his concerns with why the City asked for an 8.33% increase in 2021 property taxes when it ended the 2020 fiscal year with \$511,000 in the general fund reserve. Flotterud stated that he understood the City's policy position to have \$500,000 in the general fund reserve in order to obtain better bond ratings on future projects. Boulton reminded the Council the 6.5% of the 8.33% increase went towards the 2020 Roadway Improvements Project debt service. Ohr stated that the City has numerous needs in the near future including road maintenance work, a skid loader, and dump truck. Flotterud stated that the Council should have considered a 5% increase to the levy in 2021 rather than an 8.33%. Flotterud stated that he had no concerns with higher taxes if the Council can

the public direct benefits. show VanDeWalker stated that the Council was concerned with the State's projected budget deficit and what that could mean to LGA.

VanDeWalker stated that past drops in LGA funding significantly hurt the City for years because they were not planned. VanDeWalker stated that he was worried about keeping up the conditions of the roads in town and that much of the maintenance equipment is in need of upgrades. Flotterud stated that Citizen complain to him on property taxes regularly. Holmes stated that he is approached at his business regarding high property taxes/City Levy. VanDeWalker, Ohr, and Dierks stated that they have never been approach about property tax/City levy concerns. Holmes stated that he believed the City is committed to showing the budget process and is working toward lower levy increases in the future. Boulton stated that the City could create street equipment and/or street maintenance accounts to levy or transfer funds from the general fund reserve (anything more than \$500,000 reserve) in order to save up to address street maintenance and equipment needs in the near future. Flotterud stated that people move to Wanamingo for cheap lots and reasonable property taxes and that policy decisions such as tax levies need to be mindful of this. Holmes stated that he appreciated Flotterud's concerns and that the Council should be better able to budget and show the public where funds are spent. Passed 5-0-0.

21-035 = Approving the Combination of Tax Parcels: VanDeWalker moved to approve, Seconded by Flotterud. Administrator Boulton informed the

Council that Mark and Ruth Revland are planning an expansion in Fall 2021. In order to expand their two tax parcels would need to be combined so that the building is not constructed over property lines and meets setbacks. The proposed expansion will be roughly 35' x 60'. Boulton stated that there will be a public hearing in June to consider a variance for Minimum Bldg. Setback Side Line Property and Back Line Property in C-2 HWY Commercial District. Once the public hearing is completed the Council will consider approval of a variance for the building expansion to be closer than the C-2 property setback requirements. Passed 5-0-0.

21-036 = Accepting 2021 YearlyDriver's License Checks for City Employees: VanDeWalker moved to approve, Seconded by Ohr. Passed 5-0-0.

21-037 = Setting Swimming Fees and Schedule for the 2020 Season: Dierks moved to approve, Seconded by Ohr. Boulton stated that the only proposed fee change would be an increase to the water aerobics seasonal pass from \$85 to \$95. Passed 5-0-0

21-040 = Authorizing a TemporaryLiquor License for the Wanamingo Fire Relief Association July 3rd Dance: Dierks moved to approve, seconded VanDeWalker. Passed 5-0-0.

### **OLD BUSINESS:**

21-038 = Receiving Bids and Awarding the bid for the 2021 Crack Sealing Project: Flotterud moved to approve, Seconded by Dierks. Boulton stated that the bid is 25% less than the engineer's estimate. VanDeWalker stated his pleasure

with the cost and stated that more could be spent in 2022 for street maintenance. Boulton stated that the City will be looking at a \$40,000-\$50,000 chip sealing project in

2022. Passed 5-0-0.

21-039 = Extending and Emergency – COVID-19: Dierks moved to approve, seconded by VanDeWalker. Holmes stated that he approved placing this item on the agen-

da. The intention is for the emergency only to utilize electronic option for meetings. Holmes and Boulton had attended a League of Minnesota Cities (LMNC) listening tour May 4th. Holmes and Boulton advocated to LMNC to lobby the legislature for additional, but limited use of electronic meetings moving forward. Boulton stated that he and Holmes do not intend to bring a resolution for extension forward to the June City Council meeting. Passed 5-0-0.

Administrator Boulton provided a memo update regarding the Prairie Ridge Estates Park Improvements. Jessup DeCook purchased the Prairie Ridge Estates in 2018. In the summer of 2018, the City worked with Jessup DeCook to replat a large portion of the Prairie Ridge Development. The replat included swapping land for the park location within the development. The new park location gave the City additional area within the interior of the development for a park.

The Wanamingo parks and recreation advisory board had researched Prairie Ridge Estate park improvements. Discussions centered around future improvements such as an open-air park shelter/pavilion, playground equipment such as an arch disc swing, and a basketball hoop off the asphalt parking area. The committee agreed that the highest priority would be a shelter/pavilion. Estimates to construct a 20' x 24' x 12" (concrete slab) with an open shelter were roughly \$15,000-\$20,000. Concrete costs for the shelter were estimated at \$3,500, while construction materials were estimated at \$6,000, electrical was estimated at \$2,000, and labor was estimated \$5,000-\$10,000 (depending on volunteers and/or donated labor). An arch swing piece of playground equipment is estimated at \$6,000-\$8,000. A tough-duty playground basketball hoop is estimated to cost roughly \$1,000-\$1,500.

Any park improvements will need to be divided out and addressed one at a time due to costs. Jessup DeCook pledged \$2,500 matching contribution toward the construction of a shelter/pavilion. The Wanamingo Lions are planning on conducting fundraising (minimum goal of \$2,500) towards the Prairie Ridge Estates Park shelter/pavilion once COVID restrictions are lifted. The Lions may need up to a year to raise these funds. The City would welcome other private donations or fundraising. The City will contribute the remaining funds (Roughly \$10.000-\$15.000) toward the shelter/pavilion after private funds raised. The City would be able to budget the \$10,000-\$15,000 funds by 2022 or 2023.

In the meantime, City Staff have obtained an estimate (\$3,000) from Zumbro Valley Landscaping finish final grading, add black dirt, and seed the area down. Jessup DeCook and the City have agreed to cost sharing on the final grading, additional black dirt, and seeding. The Wanamingo Parks and Recreation Advisory Committee recommends Council approving the Zumbro Valley Landscaping grading and seeding estimate. As for park equipment and a basketball hoop these improvements would be fundraising and or budgeting that could be worked toward after the shelter is complete. The City Council has been placing spending priorities on street maintenance and repair the previous few years and next two years. So, the general fund is

stretched thin for items such as park equipment. However, in the next 2-3 years the City will be putting more emphasis on parks and other spending priorities.

Dan Fritz stated that he had been a part of Stewartville's park improvements in the past. He stated that this plan shows commitment from the City of Wanamingo to build a shelter in order to provide an anchor to the park. VanDeWalker stated that the park needed a shelter for those that could get stuck in a storm. Dan Fritz stated that once a shelter is built volunteers could approach local businesses for donations toward additional equipment. Ohr stated that he liked the idea of a shelter being build first in order to show the City's commitment. Dierks moved to approve the \$3,000 estimate based upon the \$2,000 City/\$1,000 Jessup DeCook cost share agreement, seconded by Flotterud. Passed 5-0-0. Boulton stated that work would start when the dirt piles are moved from the townhome lots to the east. These townhomes are currently under construction.

Boulton stated that the parks and recreational advisory board had also reviewed Rex Welch's request to have a bike trail through the Wanamingo Nature Trail. There was discussion to have any proposed trail stay out of the South densely-wooded area and limit the number of passes though the rowed evergreen area as to not spook the wildlife. The board also recommended that Welch and volunteers focus on one section of the bike trail at a time. If the group ceased to exist, nature would take back over the bike path. The board also recommended piling removed debris near the trail so that City staff could mulch it back onto the trail, pending available time. A formal public hearing will be held at the June City Council meeting. Administrator Boulton will publish a public hearing notice is the newspaper. The public hearing will be followed by a resolution to consider approval of the request.

Administrator Boulton provided a Sanitary Sewer District Update. Five of the Sanitary Sewer District members (Craig Britton - Widseth, Pine Island Engineer, Bill Angerman - WHKS, Zumbro Engineer, Elizabeth Howard - Pine Island City Administrator, Brian Grudem Zumbrota City Administrator, and Wanamingo City Administrator Michael Boulton) met with State Senator Mike Goggin and Dave Senjem along with State Representative Steve Drazkowski and Duane Quam Friday May 7th in Zumbrota. The information meeting on the regional wastewater treatment plant for the Cities of Goodhue, Pine Island, Wanamingo, and Zumbrota went well. Legislators suggested further involving Prairie Island Indian Community in the discussion since they own land for roughly 200 homes and potential commercial endeavors within the City of Pine Island. Elizabeth Howard informed the group that there is a sewer line stubbed out to the development to service the land in question. Howard stated that Pine Island had made initial contact with Prairie Island Indian Community on their sanitary sewer needs for the area. It was stated that Prairie Island Indian Community involvement could help bridge bipartisanship (including the Governor's office) for the bill. The Legislators suggested submitting informa-

tion to put Senate and House bills for the end of the session. Submitting bills in this session will help be considered for next session. Legislators also suggested applying for State Bonding before feasibility report completed. The bill can be modified once concrete information is provided by the feasibility report. The bonding bill will include language for the creation of a sanitary district and up to 50% funding of the project. The bill will also make the potential district eligible for American Recovery Act (ACA) federal water and sanitary sewer funds being sent to the State. The state is being given \$179 million directly for water and wastewater and an additional \$2.5 billion that could include additional water and sanitary sewer funding. The hope by legislators and the committee is to obtain some of the ARA money for engineering costs up front while the bonding bill would not be available until May 2022. An initial bonding bill application was put together by the committee and submitted to Senator Goggin and Representative Quam in order to put together House and Senate bills. In the coming months the City Councils of Wanamingo, Pine Island, Zumbrota, and Goodhue will consider approval of resolutions supporting the House and Senate Files (bills). The committee named the North Zumbro Sanitary District on the bonding bill application.





# **Top Minnesota Dairy Farms Honored for Superior Cow Care**

Minnesota Agriculture Commissioner Thom Petersen today released the annual list of top Minnesota dairy herds with low somatic cell counts (SCC). Somatic cell count is a key indicator of milk quality – a lower SCC count is better for cheese pro-

duction and a longer shelf life for bottled milk. In honor of June Dairy Month, 96 Minnesota dairy farms are being recognized for superior herd management skills by achieving an average SCC of under 100,000.

"I'm honored to be able to recognize these 96 dairies for their high level of excellence," said Commissioner Petersen. "These dairy farmers work hard 365 days a year to produce high quality, wholesome dairy products for all of us to enjoy, and I thank them for their contributions to feed Minnesota and the world."

Although somatic cells occur naturally and are not a food safety concern, dairy farmers monitor them because they can be used as a measure of the health of their cows. Processors also pay a premium for

milk with low counts. A farmer whose herd has a very low count can receive a significantly higher price per hundredweight compared to a farmer whose herd average is

The Minnesota Department of Agriculture (MDA) and University of Minnesota dairy experts have worked with the state's dairy farmers to lower somatic cell counts. When the initiative began in 2003, the 100 herds honored that year included those with SCC averages as high as 144,000, compared to the current goal of obtaining a SCC under
