Cyruлик resigns as mayor

Edmunds will serve as interim until election

CLINTON — Mayor Roger Cyruлик submitted his letter of resignation to the city clerk effective July 28. Cyruлик told the Clinton Journal earlier he intended to tender his resignation as mayor.

Cyruлик presided over the July 18 council meeting, as usual. He turned in his keys and code book on July 19 to the city clerk's office.

Cyruлик told the Journal he felt it was time for him to leave. He had no other comments except to say he planned to issue a statement later.

Clinton also has been without a city administrator for more than a year as progress to hire a new one has been slow.

Cyruлик was just reelected earlier this year for a new four-year term.

Commissioner of Accounts and Finances Tom Edmunds will automatically step into the role of interim mayor pending a special election. Edmunds has performed a similar duty before, having served twice as mayor after resignations of sitting mayors.

Cyruлик also served earlier terms as Clinton mayor.

The city will have to hold a special election to fill Cyruлик's seat on the council. The State Board of Elections suggests the election would take place in April 2025, but some city officials believe it would come next spring.

Slip renters present long list of marina issues

Complaints come as county puts marina up for sale

CLINTON — County board members listened to a boatload of complaints last week about problems at Clinton Lake marina.

Former county board member Christy Pruser addressed the board on behalf of Clinton Lake slip renters, and the picture she painted was a grim depiction of the state of the marina.

Pruser spoke during the board's July 20 meeting saying board members might not be aware of the conditions at the marina.

"The slip rents have continued to rise, but we have lost most of our amenities," Pruser said. "An example is the loss of bathrooms during off-season months. A port-a-potty that is blown over is not a viable replacement."

She said other services lost until Memorial Day weekend included

running water, laundry facilities, garbage cans and dumpsters.

"Boating season is year-round with fishermen and slip renters enjoying our home away from home," Pruser said.

She touched on earlier discussions about a \$3 million grant, "that was supposed to bring back the amenities and do the majority of the repairs."

Pruser also cited a lack of an on-site mechanic, boat parts and supplies and marina management or employees available after hours. She also said slip renters' power bills were not emailed on a regular schedule, and emails did not include a copy of the actual bill detailing usage and fees.

"Emails and phone calls to the marina are rarely answered," Pruser said. "Trees and branches were supposed to be cleaned up but are still there since before the Fourth of July holiday, and a light pole is still laying in the grass."

Pruser continued, reading a list of items, such as a supply shed for the gas dock she said was promised but never

materialized, parking for slip renters being used by day-boaters, garbage cans floating in the marina and pieces of an old broken breakwater wall scattered across the lake.

She added, tasks the county planned but did not complete included removal and disposal of the old gas dock, mitigation of shoreline erosion, electrical work in the marina restrooms, and

no safety lighting and restriping of the parking lot.

While the board has addressed some maintenance issues at the facility over the past couple of years, board members have not always agreed on what direction the marina future should take.

Pruser asked the board to address the issues, and she also asked that marina committee meetings

be held at a time more convenient for slip renters to attend.

In later business, the board voted to advertise to accept bids to purchase the Clinton Lake marina. County officials also are meeting with representatives of the Illinois Department of Natural Resources (IDNR), which has expressed interest in buying the marina.

County fines Enel after June 29 weather warnings

Fine for not curtailing wind turbines during warnings

CLINTON — The county board voted July 20 to fine Enel Green Power \$5,000 for failing to curtail its wind turbines during a June 29 thunderstorm and tornado warning.

Residents living in the area of Enel's Alta

Farms II wind energy facility told the county's land use committee July 10 the wind turbines continued to rotate during the warnings. Operators are required to slow the turbines' rotation, known as curtailing, following severe weather warnings, according to its agreement with the county.

A spokesman for Enel told the Journal an oversight resulted in operators not curtailing turbines but the company had taken steps to prevent the oversight from reoccurring.

Board member Joe Witte proposed the question whether the thunderstorm and tornado warnings constituted separate events allowing the county to assess two fines. Ultimately, the consensus was the warnings were related, making a single event.

This week, Gov. J.B. Pritzker added DeWitt County to a growing list of counties declared disaster areas following the storm.

DeWitt County added to list of counties declared disaster areas after June 29 storm

SPRINGFIELD — DeWitt County has been added to a list Gov. J.B. Pritzker has expanded following the storm that went through the area on June 29.

The original disaster proclamation also now includes 13 additional counties based on the severe weather, tornadoes, and derecho that affected communities across the state from June 29 through

July 2. The disaster proclamation includes Coles, Cook, Edgar, Hancock, McDonough, Morgan, Sangamon, and Washington counties, with the addition of Calhoun, Christian, Clark, Cumberland, DeWitt, Douglas, Logan, Macon, Monroe, Moultrie, Pike, Scott, and Vermillion Counties.

The new declaration is the result of work by the Illinois Emergency

Management Agency and Office of Homeland Security (IEMA-OHS) with local governments to assess the effects of the storms on the communities in the 20 counties listed.

State officials have been coordinating with local and county agencies and providing resources to affected communities.

This new proclamation allows additional local entities increased access to state resources and emergency personnel who can assist in response and recovery efforts.

“My administration stands with communities across the state in the work to recover from recent severe weather,” said Pritzker. “To continue to support those impacted, I have signed a broader disaster proclamation to mobilize every available resource, accelerating the recovery process and providing relief for our residents. I want to thank IEMA-OHS and local officials for their ongoing coordination.”

Beginning June 29, several rounds of severe storms passed through Illinois producing heavy rainfall, flash

flooding, hail, tornadoes, and straight-line winds. Central Illinois experienced a derecho that brought damaging straight-line winds resulting in five confirmed tornadoes, along with wind gusts in excess of 100 miles per hour across multiple counties. The tornados and straight-line winds resulted in large debris fields, affecting homeowners, businesses, utilities, and local governments. The storms also caused disruptions to transportation due to flash flooding and debris on the roadways.

On July 2, additional severe storms dropped eight inches of water in a short period of time in a historic rainfall total. This caused flash flooding in and around the Chicago area. The storms also

downed numerous trees and caused widespread power outages in northern Illinois.

“County Emergency Management Agencies continue to share damage assessments with our Recovery Division from each of the affected communities,” said Illinois Emergency Management Agency and Office of Homeland Security (IEMA-OHS) Director Alicia Tate-Nadeau. “These damage reports allow us to verify and validate information which shows an increase in communities who were impacted by the severe weather on June 29 through July 2.”

Based on reports received by the Illinois Emergency Management Agency and Office of Homeland Security

(IEMA-OHS), local resources and capabilities in the communities hit by these storms have been exhausted, and State resources are needed to recover from the effects of these severe storms.

This disaster proclamation specifically covers original Coles, Cook, Edgar, Hancock, McDonough, Morgan, Sangamon, and Washington Counties and now includes Calhoun, Christian, Clark, Cumberland, DeWitt, Douglas, Logan, Macon, Monroe, Moultrie, Pike, Scott, and Vermillion Counties for damages incurred on June 29 through July 2 in Illinois.

The disaster proclamation goes into effect immediately.



Red Cross offers heat safety tips

Soaring temperatures could pose danger; take precautions to stay safe

DECATUR — High temperatures are expected throughout much of the Illinois region this week. It is important to take precautions to avoid heat exhaustion or heat stroke. The Red Cross offers steps you can take to help stay safe when the temperatures soar.

Hot cars can be deadly. Never leave children or pets in your vehicle. The inside temperature of the car can quickly reach 120 degrees.

Stay hydrated by drinking plenty of fluids. Avoid drinks with caffeine or alcohol.

Check on family, friends and neighbors who do not have air conditioning, who spend much of their time alone or who are more likely to be affected by the heat.

If you don't have air conditioning, seek relief from the heat during the warmest part of the day in places like schools, libraries, theaters, malls, etc.

Avoid extreme temperature changes.

Wear loose-fitting, lightweight, light-colored clothing. Avoid dark colors because they absorb the sun's rays.

Slow down, stay indoors and avoid strenuous exercise during the hottest part of the day.

Postpone outdoor games and activities.

Take frequent breaks and use a buddy system when working outdoors.

Check on animals frequently to ensure that they are not suffering from the heat. Make sure they have plenty of cool water and shade.

Excessive heat can lead to sunburn, heat cramps, heat exhaustion and heat stroke. If someone is experiencing heat cramps in the legs or abdomen, get them to a cooler place, have them rest, lightly stretch the affected muscle, and replenish their fluids with a half a glass (about 4 ounces) of cool water every 15 minutes.

Heat Exhaustion

If someone is exhibiting signs of heat exhaustion (cool, moist, pale or flushed skin, heavy sweating, headache, nausea, dizziness, weakness and exhaustion), move them to a cooler place, remove or loosen tight clothing and spray the person with water or apply cool, wet cloths or towels to the skin. Fan the person. If they are conscious, give small amounts of cool water to drink. Make sure the person drinks slowly. Watch for changes in condition. If the person refuses water, vomits or begins to lose consciousness, call 911.

Heat Stroke

Heat stroke usually occurs by ignoring the signals of heat exhaustion. Heat stroke develops when the body systems are overwhelmed by heat and begin to stop functioning.

Signs include hot, red skin which may be dry or moist; changes in consciousness; vomiting and high body temperature. Call 911 immediately if someone shows signs of heat stroke. Move the person to a cooler place. Quickly cool the person's body by immersing them up to their neck in cold water if possible. Otherwise, douse or spray the person with cold water, or cover the person with cold, wet towels or bags of ice.

Risk Factors

Heat is the leading weather-related killer in the U.S. More than 600 people in this country die every year from heat-related illnesses, according to the Centers for Disease Control and Prevention (CDC).

Some people are more at risk of developing a heat-related illness, including adults over 65, those with chronic medical conditions, people who work outside, infants and children, and athletes. Some may take medications that make the effects of extreme heat worse. People with heart disease, poor blood circulation, obesity and mental illness are also at risk for getting sick if the temperatures climb.

Home Fire Response

Even during times of extreme heat, Red Cross volunteers continue to assist families impacted by home fires. Volunteers in the Central Illinois chapter responded to five home fires in Champaign, Farmer City, Havana, Rankin and Urbana in the past two weeks and provided assistance to 13 individuals, through supplying them with items to meet immediate needs after a fire, and additional support in the form of health and mental health services and one-on-one support.

A new drug for Alzheimer's Disease

The FDA recently approved a new drug that is supposed to slow the progression of Alzheimer's.

Earlier this year, the FDA gave conditional approval to Leqembi, pending more safety and efficacy trials. Now, with "accelerated approval," the drug has full approval.

Another drug, Aduhelm, launched in June 2021, still only has conditional approval and is waiting results from more trials.

Both drugs work in a similar way, targeting the proteins in the brain. There are differences, however.

One difference between Leqembi and Aduhelm is the way it's delivered. Aduhelm is given by spinal infusion and Leqembi is given intravenously every two weeks (although other means are being studied in trials that are still going on).

Another difference is in what the drugs do: Aduhelm targets the plaques in the brain, while Leqembi targets the proteins that create the plaques.

The other is the cost. Leqembi will likely cost \$26,500 per year, although that can vary by patient weight and what schedule of maintenance dosing the patient is to get. Medicare will likely cover the majority of patients if they have a supplemental drug plan. The rest will likely pay the 20% coinsurance not covered by Medicare.

Aduhelm had much different pricing when it first came out -- \$56,000 per year. Our Medicare Part B went up by \$21.60 in 2022, up to \$170 per month, likely due to the cost of Aduhelm, which Medicare initially

expected to cost close to \$3,000. Some insurers said they wouldn't cover the drug unless prices came down. The cost of the drug eventually did come down, to \$28,200.

The caveat about Leqembi, however, is that the experts point to the very small degree of slowing of early Alzheimer's in the patients in the trial. In many, the result could be quite subtle. Still, some researchers say it does buy patients time and could delay the coming of the later stages of dementia.

Illinois avoids federal sanctions, advances air rule change

SPRINGFIELD — A proposed change in state air pollution regulations will move forward despite an objection from a legislative oversight committee, allowing the state to avoid federal sanctions that otherwise would go into effect next month.

The change, which came from the Illinois Pollution Control Board and the Illinois Environmental Protection Agency, repeals existing language that allowed factories, refineries, power plants and other facilities to exceed their emission limits during shutdowns, startups, and malfunctions.

The previous rules also gave the owners of those facilities a certain level of immunity from civil lawsuits for exceeding their emission limits during those events.

The change was necessary because of recent court decisions that prompted the U.S. EPA to change its interpretation

of the federal Clean Air Act, a program that is largely administered and enforced by state and local governments.

Illinois was first informed about that change in 2015 and was told, along with many other state and local governments, to repeal those regulations and submit new state implementation plans, or SIPs. Illinois did not immediately act on that notice, however, and two years later, the then-new Trump administration put the change on hold.

The Trump administration issued new guidance in 2020 saying such provisions were permissible in some circumstances, but when Democrat Joe Biden came into office in 2021, his EPA administrators reversed course again. In January 2022, Illinois was told for a second time to submit a new SIP.

That notice, known as an "SIP call," became effective Feb. 11, 2022. From that date, Illinois and other jurisdictions subject to the SIP call had 18 months to come into

compliance before the first set of sanctions would take effect — drastically stricter emission limits on new or significantly altered facilities.

After 24 months of noncompliance, the state's access to federal highway funding would have been tightly restricted.

The process by which the state agencies proposed the changes, however, upset many industrial firms as well as lawmakers on the Joint Committee on Administrative Rules, or JCAR, a 12-member bipartisan body that has oversight authority on administrative rules.

That's because even though the agencies were told in January 2022 that they needed to make the change, they did not officially publish the rule change until November of that year, forcing them to use a "fast-track" approval process that greatly limited the time allowed for public comment and negotiations.

JCAR considered the proposed rule change at its monthly meeting in June but postponed the

rulemaking for 45 days to give the regulated industries more time to discuss the issue with lawmakers, the agencies and U.S. EPA.

Meeting again Tuesday in Chicago, the committee voted to issue a formal objection to the rule change based on the agencies' use of the fast-track approval process. That does not stop the rule change from going into effect, but it does require the agencies to submit a response within 90 days.

"Recognizing that while we can't go back and address what's already occurred, we are going to ensure that the steps are in place so that the next time there is a rule like this — which there will be because of the nature of our federal implemented programs — that we have a structure that doesn't lend itself to that type of concerns that brought us here last month," IEPA deputy director James Jennings said in response to lawmakers' questions at the hearing.

Question:
I'm 17 and eager to start my first summer job, but my mother misplaced my Social Security card. How can I get another?

Answer:
If you know your Social Security number, you may not need to get a replacement card to obtain employment. However, if a prospective employer requests it, you can get a replacement Social Security card by following the steps below. There is no charge for a Social Security card, but you are limited to three per calendar year and 10 replacement cards during your lifetime.

You will need to:

- Show the required documents. We need to see different documents depending on your citizenship and the type of card you are requesting. Go to www.ssa.gov/ssnumber to find out what documents you will have to show.

- Fill out an Application for a Social Security Card.

- Take or mail your application and original or certified copies of the original documents to your local Social Security office.

Question:
I am receiving Social Security retirement benefits and I recently went back to work. Do I have to pay Social Security (FICA) taxes on my income?

Answer:
Yes. By law, your employer must withhold FICA taxes from your paycheck. Although you are retired, you do receive credit for those new earnings. Each year Social Security automatically credits the new earnings and, if your new earnings are higher than in any earlier year used to calculate your current benefit, your monthly benefit could increase. Retirement

Question:
I know that Social Security's full retirement

age is gradually rising to 67. But does this mean the "early" retirement age will also go up by two years, from age 62 to 64?

Answer:
No. While it is true that under current law the full retirement age is gradually rising from 65 to 67, the "early" retirement age remains at 62. Keep in mind, however, that taking early retirement reduces your benefit amount. For more information about Social Security benefits, visit www.ssa.gov/planners/retire.

Question:
I'm trying to decide when to retire. Can Social Security help?

Answer:
The best place to start is with a visit to the online Social Security Statement. The Statement provides you with estimates of benefits for you and your family as well as your earnings record and information you should consider about retirement and retirement planning. It is easy to access your statement online by creating a my Social Security account. To create an account, please visit www.ssa.gov/myaccount. The "right" time to retire is different for everyone and depends on your individual situation. To help you make your own decision, we offer an online fact sheet, When To Start Receiving Retirement Benefits, that highlights some of the factors to consider. Disability

Question:
I am 57 years old and I currently receive Social Security disability benefits. Can I still get my regular Social Security retirement benefits when I reach full retirement age?

Answer:
If you are still receiving Social Security disability benefits when you reach your full retirement age, we will automatically switch you from disability benefits to retirement benefits at that point. The money amount will remain the same. For more information on disability benefits, visit www.ssa.gov/benefits/disability.



Question:
Will my Social Security disability benefit increase if my condition gets worse or I develop additional health problems?

Answer:
No. We do not base your Social Security benefit amount on the severity of

your disability. The amount you are paid is based on your average lifetime earnings before your disability began. 



Veteran suicide in a VA emergency room

A veteran with a documented history of suicidal thoughts and attempts, as well as drug abuse and PTSD, committed suicide while being left unattended in a VA facility emergency room.

The Department of Veterans Affairs Office of Inspector General investigated, and they unearthed the facts ... which are not pretty.

It's this: The veteran showed up at the VA facility ER with bladder complaints and depression. He'd been there before, and it was noted in his file that he'd had admissions for substance abuse and suicidal thoughts.

The first medical person

("Nurse 1") did a triage, which is asking questions to decide how to classify the patient. Instead of using the computer to ask him specific questions (per policy) and record his answers, she did it from memory. Nurse 1 allegedly told the physician (who was resting in another room) there was a patient waiting. Another person, Nurse 2, did a bladder scan.

An hour later, no physician had shown up. An additional hour later, Nurse 1 left for the day and handed off the records to incoming staff.

Later a technician found the veteran on the floor of the room, dead by suicide, still unseen by a



doctor.

The OIG investigation revealed:

During the investigation, Nurse 1 could not recall from memory the risk assessment questions she supposedly asked the veteran. Nurse 1 also did not actually alert the physician that patients were waiting.

The physician did not respond to an alert from Nurse 2 either about patients waiting and did not get up until the boss came on shift.

The "Door to Doc" policy was severely

violated. That performance policy states that the target is 25 minutes from the time a patient walks in the door to the time he's seen by a doctor -- not the two hours and 20 minutes this veteran languished by himself.

Information surfaced that showed facility admin sought to interfere with the OIG investigation, instructing in emails that "appropriate responses to direct questions are: yes, no, I don't know, and I don't remember."



Chinese cuisine: Southern region

Welcome to my little corner of culinary delights. When we think of Chinese food, it is common to think of rice as the staple diet. But rice is not grown in all regions of China. Most of your rice comes from the Cantonese sector due to the climate and terrain. Although hilly, there are enough flat lands for growing various vegetables. Rice farming is generally terraced. This utilizes the land for farming by terracing the hills. The climate is also ideal for growing rice. It is warmer than the northern region as well as rainy. The frequent rainfalls help keep the rice fields flooded. A condition conducive for rice plants to flourish. Due to such ideal conditions, this area can produce two rice harvests per year. This enables them to export tons of rice annually. It is a cheap but most nourishing grain. The Cantonese cooking technique and style uses less seasonings and scant spices as compared to other regions of China. The expertly blending of flavors creates a cherished gastro delight that must not be diminished by over

seasoning. Refer to my past article "A little is a lot" regarding seasonings. Never think that more herbs and spices improve the food. The herbs and spices need to properly match and blend with the flavors in order to compliment the dish. But I am digressing. Recall in my last article the difficulty we have locally in providing the necessary ingredients for some of the Chinese dishes? In this region are grown many such exotic fruits. I will list a few. Have you heard of such fruits as lychee, longan, and loquats? I am sure you have seen bananas, papayas, guava, pineapples, and coconuts that are grown in the Cantonese area. Among some of your vegetables that are unusual here are taro, tiger lily lotus roots, and lotus seeds. Of course, there are many other vegetables of which we know such as Squash, beans, etc. However, I

care not to list every crop they have that is familiar to us. My purpose is to educate. The sauces commonly used in this region are hoisin, oyster, plum and soy sauces. Because of the rivers, lakes, and coastal lands in this region, there is a lot of seafood in their diet. The type of cookware most desired in this region is the stir-fry pan for fast cooking. The advantages of fast cooking are to preserve the food's natural flavors and vitamins better, and to maintain the color and texture of the fresh vegetables, I shall do an article in a few weeks that teaches how to stir-fry. I may also detail the types of pans and equipment used. Steaming foods is also a quick form of cooking that is popular in Cantonese cooking. I use this form often. Barbecuing, pig roasting, and simmering are popular Cantonese cooking procedures. Lacquered meats are very popular in this region. I might teach you how this is done under "techniques". Until next time, peace to all.



We don't condone the N-S bidding, we just report the facts. Back in the good old days West's Double might have been thunderous, but now we have bidding boxes, keeping down the decibels on those occasions when West thinks he is on to a sure thing.

After leading the ♠K, West got the first bit of bad news when he saw the ♥K in Dummy, and realized that he did not have four certain trump tricks. "No matter", thought West, "surely we can scrounge up a trick or two in the side-suits". Not so! Declarer was able to abscond with 10 tricks thanks to this well-timed line of play:

- At Trick 1 he won the ♠A
- Then he cashed the ♠A and ♦A
- Over to Dummy with a Spade ruff
- Cash ♠K and ♠Q (pitching Diamonds)
- Diamond ruff
- Spade ruff

By now Declarer had 8 tricks. Next came another Club winner, and luck was on Declarer's side when it turned out that West was the defender with four Clubs. East gamely ruffed the Club with the Eight, but was overruffed by Declarer's Nine.


Now for the *coup de grace* or, more specifically, a *coup en passant*. West's last four cards were the AQJT of trumps, and Dummy was down to the singleton King. But, when Declarer led her last Spade, that singleton King would score a trick one way or the other ... if West ruffed high then the King would be good ... if West ruffed low then Dummy would overruff.
