"I'm honored to receive this distinction, and I would like to thank the Oregon staff for their support and dedication to the education and growth of all our students," Mahoney, who has been an educator for 32 years and superintendent of Oregon CUSD #220 for 13 years, said. "While this award is named the Superintendent of Distinction, it is really a reflection of the

work our board and staff do on a regular basis."

Those nominating Mahoney noted Oregon CUSD #220's academic growth during his tenure. In 2018, the district implemented a new vertically-aligned K-12 curriculum, common formative assessments and benchmarks. Despite implementation challenges during the pandemic, the district experienced academic growth, including:

The Illinois Assessment of Readiness composite score rose 58 percent in English Language Arts and 30 percent in math compared to 2021.

Oregon Elementary School's results are above the state average for the first time.

At Oregon Junior

High School, the seventh grade ELA cohort of students who met or exceeded state performance levels increased by 308 percent.

The seventh-grade math cohort of students who met or exceeded state performance levels increased by over 78 percent.



This single document will contain tax information and payment stubs for both installments. Therefore, property owners need to save this bill as no additional notice will be mailed prior to the second installment.

Payment methods include cash or check (payable to Ogle County Collector). In-person payments can be made at the treasurer's office or at any bank in Ogle County. The treasurer's office is in the old courthouse located at 105 S. 5th St. in Oregon. Office hours are 8:30 a.m. - 4:30 p.m. Monday-Friday excluding holidays. Their mailing address is Ogle County Collector, P.O. Box 40, Oregon, IL 61061. Mailed payments must be postmarked by the due date to be considered timely. Late payments will incur a fee of 1.5 percent per month or part of a month after the due date and must be remitted by mail or at the collector's office.

Collector O'Brien's office is also offering the option of online credit card payments. You may go to the Ogle County website at www.oglecountyil.gov and then select the Treasurer's department. Choose the Online Tax Payments link and click the Pay Now button. Fill in the information as prompted. Be sure to receive a payment conformation for your records. 

### **MOMENTS IN** TIME

\* On May 27, 1679, the Habeas Corpus Act passed, strengthening an individual's right to contest unlawful arrest and imprisonment. The act is considered one of the most important rulings in English constitutional history.

\* On May 24, 1887, President Chester A. Arthur and New York Gov. Grover Cleveland opened the Brooklyn Bridge. At the time, it was considered engineering's greatest achievement, with a span of 1,600 feet, which made it the longest suspension bridge in the world.

\* On May 22, 1906, Wilbur and Orville Wright were granted a patent for their "flying machine." Their first application was rejected, and the overall process took three years, after which they sold the patent to the newly formed Wright Company for a sweet \$100,000, 40% of the company's stock, and a royalty of 10% on all aircraft sold.

\* On May 23, 1962, 12 doctors at Massachusetts General Hospital in Boston performed the first successful reattachment of a human limb -- the severed arm of 12-year-old Everett "Red" Knowles. After four years of recovery, he had regained complete mobility and use of it.

\* On May 26, 1993, Major League Baseball's Jose Canseco and the Texas Rangers were playing against the Cleveland Indians when the latter team's infielder, Carlos Martinez, famously hit a fly ball that bounced off Canseco's head. \* On May 25, 2011, "The Oprah Winfrey Show" came to an emotional end after 25 years and 4,561 episodes, with its longtime host telling her audience, "You and this show have been the greatest love of my life." It remains one of the highest-rated daytime TV talk shows in American entertainment history. \* On May 28, 2016, a gorilla named Harambe was relaxing inside the Gorilla World habitat at the Cincinnati Zoo when a 3-year-old boy climbed into the enclosure and fell into the moat. While it seemed that Harambe was protecting the boy from drowning, zoo officials decided to shoot the animal as they feared he might accidentally kill the child.

#### Reports

USDA released two big reports recently. Quarterly Grain Stocks addresses grain leftover from 2022. Prospective Plantings is an annual report that sets the tone for the new year by estimating harvest data and planted acres of principal crops at the state level. These two survey-based reports set the tone for the marketing year and can be used for a wide variety of purposes by farmers, market analysts and others.

The Quarterly Grain Stocks report is a survey-based document published four times per year. The survey addresses old crop stocks in two ways: location (state) and position (on-farm or offfarm storage). This particular report provided information on old crop U.S. grain stocks. Grain stocks reports are subject to revisions which typically occur in the following quarterly report. USDA's annual Prospective Plantings is also a survey-based report but is published only once per year. This publication presents last year's harvest data and

anticipated planted acres for the marketing year for principal crops and tobacco.

Corn stocks on March 1, 2023, were estimated at 7.4 billion bushels, down five percent or 180 million bushels from March 1,

2022. This is about 69 million bushels below trade analysts' average estimate.

USDA estimates farmers intend to plant four percent or 3.42 million more acres of corn than last year. This estimate comes out to about 92 million acres compared to trade analysts' average estimate of 90.88 million acres.

Soybean stocks on March 1, 2023, were estimated at 1.69 billion bushels, down 13 percent or 240 million bushels from March 1, 2022. This number is about 57 million bushels below average analysts' estimates of 1.74 billion bushels.

USDA estimates farmers intend to plant 87.5 million acres of soybeans. This is only slightly more than 2022 and unchanged in 15 of 29 states.

USDA estimates all old crop wheat stocks are 946 million bushels, down eight percent from March 1, 2022. This was 12 million bushels above average analyst estimates of 934 million bushels.

USDA estimates farmers intend to plant 49.9 million acres of wheat in 2023. That's nine percent or 4.1 million acres more than 2022. Further, this number comes in higher than USDA's February estimate of 49.5 million acres.

To further break down wheat estimates, USDA expects all wheat acres to include 10.6 million acres of spring wheat (down two percent from 2022), 37.5 million acres of winter wheat (up 13 percent from 2022) and 1.78

million acres of durum wheat (up nine percent from 2022).

This is a complicated time of year to evaluate crop markets. Traders, analysts and producers will spend time



evaluating USDA WAS-DE numbers against Quarterly Grain Stocks, **Prospective Plantings** and global export situations to try to develop marketing plans and prepare for what lies ahead. USDA's Ag Outlook

Forum estimated larger corn production for 2023 with a crop estimate of 15.085 billion bushels. If we use last year's harvest percentage of 91.32. percent and multiply this by expected acres and a trendline yield of 181.5 bushels per acre, we have an estimated crop size of 15.25 billion bushels. If we add in grain stocks and imports from USDA's Grains and Oilseeds Outlook, the crop size comes in at 16.54 billion bushels. Bottom line – this is a bearish number for corn.

Since USDA's soybean acreage is largely unchanged, weather and demand factors will play a bigger role in directing soybean prices until spring planting wraps up. Soybean stocks on the other hand, came in much lower than expected. The 1.69-billion-bushel stocks number is 247 million bushels below March 1, 2022.

Wheat acreage was a surprise with planted acres forecasted 400,000 higher than USDA's February estimate. This is substantially higher than analyst expectations that were much closer to last year's 45.74 million acres.

like to read things that I disagree with.

Doing so not only gives me greater empathy for those with whom I differ, but every once in a while, it changes my own viewpoint.

A movement is afoot to censor what books libraries and schools can offer.

Such efforts are pernicious malignancies that metastasize from community to community, from state to state.

Dr. Sarah Bonner, who until last month taught in Heyworth school district, learned about this evil firsthand.

The English teacher in the rural Mc-Lean County, Illinois, school district became the subject of a school board meeting because of one of the books offered in her class.

The tome in question is titled "This Book Is Gay." It explores topics teenagers encounter as they navigate through adolescence: dating, sex and safe sex practices.

And, no, it wasn't required reading. It was one of more than 100 books that students in her class could choose from.

According to the reporting of my friend Edith Brady-Lunny the debate went viral after a pupil published images of certain pages on social media.

More than 80 people attended the next school board meeting. They didn't come bearing pitchforks and torches, but they certainly wanted Bonner's head. And before the meeting was over, she was forced to quit.

"Our kids deserve learning experiences that prepare them for our world and not just our town," she told the school board.

Ironically, Bonner quit the same week Illinois legislators voted to withhold funding from public schools and libraries that ban books. The bill has passed the House and is pending in the Senate.

Unfortunately, pressure to censor comes from both the left and the right.

Last year, my own daughter's class was reading "To Kill a Mockingbird" in a Springfield school when a parent complained about a racial epitaph used in the book. A school administrator ordered the class to discontinue studying the classic. Some of the youngsters never learned how the anti-racist tome ended.

Increasingly, our society is losing any sense of nuance.

In the book the lawyer Atticus Finch tells his young daughter, "Don't say n-----er, Scout. That's common." She responds that everyone at school says it. He retorts, "From now on it'll be everybody less one."

In the context of the book, a life lesson is being taught – that even though a particular slur is common, it shouldn't be said.

Isn't that the lesson we want our youngsters to learn, in this age where that racial vulgarity

increasingly finds its way into music and popular culture?

According to the American Library Association these are some of the most banned books:

"To Kill a Mockingbird," by Harper Lee "The Catcher in the Rye," by JD Salin-

"The Lord of the Flies," by William Golding

The Illinois legislation would prohibit libraries from banning books or other material because of partisan or doctrinal pressure.

House Bill 2789 is being pushed by Secretary of State Alexi Giannoulias, whose office oversees the Illinois State Library and administers grants for public and school libraries.

It's a measure whose time has come.

Most of the opposition to the bill came from Republican lawmakers who said it takes control away from local library and school boards.

But my prediction is that in coming years if this bill becomes law, folks on the left as well as the right will be frustrated because they won't be able to remove books they don't agree with from library shelves.

It is commendable that parents are monitoring what their children are reading. But it's deplorable that some adults believe they can use government to keep other people's children from reading something they disagree with.
