for participation in RTHS athletics to meet a new IHSA state mandate.

Harper said homeschooled students in the district will now be required to take one course at RTHS. The district's policy previously had no requirement for homeschooled students to take any courses at RTHS to participate in athletics.

based on the feedback we got from parents and the board and based on conversations with the IHSA to meet the mandate so our students can continue to compete in IHSA-sponsored events. If we didn't adhere to this policy, our students would have become ineligible."

ROCHELLE—At its monthly meeting Monday, the Flagg-Rochelle Community Park District **Board of Commissioners** held interviews with board applicants to fill the position vacated by Commissioner Ryan Tartaglia's resignation.

Following applicant interviews in executive session, the board voted unanimously to appoint Kristi Gonzales to the commissioner position for a two-year term. She was then sworn in by Park District Executive Director Jackee Ohlinger.

Spring Lake

Ohlinger and Superintendent of Recreation Andrew Murray said preparations are ongoing for the summer opening of Spring Lake Pool and opening day is planned for Saturday, June 3.

Murray said orientation was recently held with all Spring Lake staff for the summer and two more orientation sessions will take place. Pool passes are now available for sale online or at The REC Center. All-inclusive members of The REC get admission to Spring Lake for the summer.

"Staff has been working on projects within the bath house at Spring Lake and the maintenance team has been working on the splash pad and the functions of the pool," Ohlinger said. "I'm thankful for everyone and their hard work. I'm just really glad that our staff can work so hard to prepare all of our facilities for a safe season."

Ohlinger said the park district has been working with Spring Lake staff year round on training, orientation, swim lessons and more which has helped with employee retention from season to season.

"Many facilities are unable to staff their outdoor pools or locations and I'm thankful that we're not in that boat," Ohlinger said.

Pegasus Special Riders hosts grand reopening event Rides to start back up June 6-7: 'It's been a work of love and contributions'

OREGON — On Friday, May 12, a grand reopening and ribbon cutting event was held at Pegasus Special Riders in Oregon following the structure completion of its arena.

The facilities at Pegasus Special Riders sustained storm damage twice last year, halting its operations. The nonprofit, located at 6668 S. Carthage Road near Oregon, has been operating since 1997. It's a therapeutic riding program for children and adults with special needs. Volunteers perform all of the required duties, such as working with the riders, caring for

the horses and facilities, raising funds and providing the necessary administrative support.

The damage on Aug. 28, 2022 included the facility's loafing shed for its horses and severe damage to a storage building. Back on March 5, 2022, a windstorm severely damaged the main arena building. High winds tore off about 120 feet of canopy, twisted the steel frame and the large front door was blown off and landed inside of the

Pegasus Special Riders has been unable to perform any rides since the storm damage and was dealing with pandemic restrictions before that. The nonprofit worked on cleanup, construction and dealt with insurance providers over the past year. The damage in March was over \$300,000. "This has taken a long

time," PSR Board President Donna Fellows said. "We still have a lot to do. We're moving forward because we now have a covered arena again and an outdoor arena to have lessons if the weather is nice. We don't have all the electric work done or any water yet. Electric is what we're waiting for, so we can have water, fans and lights. Other than that, the building is good to go. We thought we'd be further along, but here we are."

The Oregon Chamber

of Commerce attended Friday's events and congratulated PSR on its grand reopening. Fellows said equine activities will resume starting on June 6-7. An outdoor arena will be used if the indoor arena isn't all the way completed by that time.

PSR's funding is nearly completely made up of donations.

"We've had wonderful people that have helped," Fellows said. "It's been volunteers and people that are willing to just help us out. We've had contractors that have helped us out. That was wonderful. It's overwhelming, because what you thought you were going to have to spend and

what actual cost is, it's been yards away. And if you have the funds to do it, then you don't have the materials. But we've been blessed with contributions and help. It's been a work of love and contributions."

PSR has seen donations come from Rockford, Sterling, Wisconsin and "all over," Fellows said.

"We've had people that donated and we didn't even know who they were," Fellows said. "I don't even know how they found out about it. It's been wonderful to know that people are out there that want to help us do our job for the people that need to have our services."

Fellows called the feel-

ing of being able to offer rides and equine services again "heartwarming."

"We've waited for three years with COVID-19 and everything else," Fellows said. "We've been very anxious to be able to get things done. We have volunteers that are waiting and calling and asking when the rides will start. We have students and their parents calling. We fill a need that unless you have a challenged individual close to you, you don't even know about. I say sometimes that we're the best-kept secret in Ogle County. I just want to thank all of the people that have contributed to us all these years and especially during this disaster."

Center for Research by Undergraduates. A variety of judges, including faculty, graduate students and peers as well as members of the Iowa City community, were on hand to discuss the

students' work and provide valuable feedback.

"This is an incredible opportunity for Iowa students to practice and hone their communication skills,"Bob Kirby, director

"From designing a poster, to giving a short pitch about what they study and why it matters, to fielding questions from experts in their field as well as non-experts, everything about this experience is designed to help students boost critical communication skills that will help them succeed in whatever comes next for them "

Ashley Rhodes of Chana participated in the area of mathematics & engineering.. Her presentation title was: Novel Gas Entrapping Materials to Improve Treatment of Solid Tumors.

Presentation abstract: "Gas entrapping materials can have many far reaching

and impactful applications. Gasses have been shown to have therapeutic properties, and the ability to deliver gas to a specific area within the body can be beneficial for wound healing, improving cancer treatments, and decreasing inflammation. Many current methods for gas entrapment and delivery are inefficient and difficult to administer We have fabricated a solid, biodegradable implant that has the capability of high-volume gas release. The goal is to deliver a variety of gasses in vivo and be able to control their dissolution to optimize timing of gas delivery. We are working to evaluate the potential of

form amorphous crystalline arrangements and to alter the properties of the material to control the timing of its dissolution within the body. These innovative devices can be used to store drugs, oxygen, and any other desired material to be delivered to biological systems. One specifically beneficial application is penetrating the hypoxic microenvironment commonly found in tumors, which causes therapeutic resistance. Methods to improve tumor oxygenation have been shown to improve response to standardof-care cancer treatments, such as radiation therapy, and these GEMs provide a controllable, novel solution

Signage has been added to the splash pad regarding its use operations. When the pool is not open, the splash pad is open for free use by the public. When the pool is open, use of the splash pad is part of the cost of admission.

Director comments

During her director comments portion of the meeting, Ohlinger provided updates on a number of ongoing projects.

The park district has purchased a new brush hog machine that has previously been used for clearing brush at Midwest and Skare Park. The work has involved opening space for walking paths and the disc golf course at the Skare Park and dealing with areas impacted by the 2014 tornado in the area. More work will take place on the project this summer.

Ohlinger said Hagemann Horticulture has been working on landscaping projects at various district parks. Back in February, the park district approved a landscaping design and maintenance program agreement with Hagemann Horticulture for \$24,971.39. The next landscaping work will take place at The REC Center.

"You should see all of our parks finishing the new plant material here in the next few weeks," Ohlinger

New signage has been placed at multiple park district properties including at its maintenance shop, at Skare Park and Lake Sule.

Lake Sule's shore work has been completed, Ohlinger said. The work involved clearing trees and shrubs around the outside of the lake to open it up for more activities and visibility of the property. The park district has plans to clear the entire perimeter of the lake and apply chemicals to prevent willow trees and shrubs from growing back.

"It's really great to have that visual of the lake," Ohlinger said. "The water looks very welcoming. But I would remind the public that walking on the concrete slab shore is not safe and to stay on the grassy bank."





Nickason (Donna Murphy, RTHS Class of 1974). Donna was so moved by a summer theater experience she had during her high school years that she wanted to pass it on," Creuziger said

Nickason believes, "The experience and exposure of speaking and acting promotes team building, self-confidence and assists in any career a student might choose. I encourage the Rochelle School Board to see great value in these skill sets."

Nickason said she wanted to, "Give honor to Clinton Clarke, our teacher, our motivator (who was) a great person as well as to other significant RTHS Theater students of the day including David Ledler, Ron Shields, Joan Allen, Don Gruben, Melanie Kubale, Deb Thiele, Alice McCaslin and many, many other drama students that set the bar for team building in the 70s."

Creuziger then presented three students with 2023 Nickason Scholarships. They will attend theatre camp for five days and five nights this summer. These students were asked to share in writing what theater means to them and why they want summer training.

First, junior Violette Hull explained that theater is a "safe place to try things, and not be afraid."

Some of Vi's theater contributions include: being the house manager for the spring play, Lost in Yonkers. Vi directed and performed in the Winter One Acts, Milo in The Phantom Tollbooth, Masha, in Vanya & Sonia & Masha & Spike and the Prince in Romeo & Juliet.

Next, Junior Karma Lidren: "Theater has helped me to express myself in ways I never imagined."

Karma most recently was Aunt Gert in Lost in Yonkers, as well as the student director, costume stitcher and scenic painter. Karma was a Winter One

Act director and performer. The Mathemagician in The Phantom Tollbooth and when someone couldn't go on, Karma stepped in to play the role of The Senses Taker. In Romeo & Juliet, Karma played Juliet.

And finally, senior Mikayla Preston: "Theater, to me, is a way to understand the world around us, and in a unique way to connect with ourselves and those around us by understanding the people we portray."

This year, Mikayla served as acting guru, being available to answer questions and share acting suggestions with others.

She played Bella in Lost in Yonkers 2023, and was a Winter One Act performer, writer and director this year. She played The Humbug in The Phantom Tollbooth, Sonia in Vanya & Sonia & Masha & Spike, Romeo in Romeo & Juliet, multiple roles in the spring play 2021, which was a movie RTHS-TV including the role of Pearl who we see from youth to middle age to old age, and a typical morning show host.

Mikayla played Ebenezer Scrooge in A Christmas Carol The Radio Play, as a freshman was cast as Bella in Lost in Yonkers 2020 (COVID-19 prevented that show from ever going up) and fall her freshman year played a few characters in the in-the-round production of The Park Bench Plays including the role of Doreen in Alan Ayckbourne's A Talk in the Park.

Nickason has acted throughout her post high school life. She has had roles in TV shows like Dallas and films like: Halt and Catch Fire, The Ritual, Inspector Mom, Friday Night Lights and The Safety of Others. Inviting Illinoisans to identify statesmanship in Prairie State

6 A statesman," said the great Prussian diplomat Otto von Bismark, "is a politician who thinks of his grandchildren."

Three years ago, former Illinois Governor Jim Edgar and I decided to create the Paul Simon-Jim Edgar Statesmanship Award to shine a spotlight on remarkable leadership that is taking place in our state and our communities.

We were looking for Illinois political leaders who are thinking about their grandchildren – and acting to create a better future for them.

The annual Simon-Edgar Statesmanship Award is presented to an elected state or local government official in Illinois who has demonstrated a pattern of public service characterized by vision, courage, compassion, effectiveness, civility and bipartisanship.

I believe that Governor Edgar and Senator Paul Simon, the founder of the Institute that I'm privileged to lead, represent the best of Illinois statesmanship. Governor Edgar, a loyal Republican, and Senator Simon, a steadfast Democrat, were always willing to work with members of the other party and independents to get things done for Illinois.

RE we free? At least as much as we have desired to be free? Let's look at the Preamble to the Constitution of The United States. "We the People of the

United States, in Order to form a more perfect Union, establish Justice, insure domestic Tranquility, provide for the common defense, promote the general Welfare, and secure the Blessings of Liberty to ourselves and our Posterity, do ordain and establish this Constitution for the United States of America." As much as we might

hope that our Constitution pertains to individuals, we can see in the preamble that it pertains to a perfect union. Union, in Merriam-Webster's dictionary, has a definition of "an act or instance of uniting or joining two or more things into one." So, we, as American citizens, are united together in this country, to establish Justice, ensure Tranquility, provide defense, promote general Welfare, and secure blessings of Liberty.

Our Constitution is not for me, nor is it for you.

It is for all of us. In this country we are free to do anything we want if we don't infringe on others. We should be concerned about the general welfare of the people not our individual welfare. We must provide defenses for all. Not for a small group of people we are beholding to. Justice for all, not just

So, do we really have freedom? Women, and I do mean all women as a united body, did have the freedom to choose what was best for their health and welfare. That was until last June when Roe V. Wade was overturned. But they have not lost only their ability to have an abortion, they are losing their rights, one by one, state by state, to be able to keep their bodies healthy and safe.

In this case, have we promoted the general welfare of every individual? If it hadn't been overturned, who would be suffering? Having the right to do something is not the same as an action that must be done. The right to choose should never be taken away. A woman's welfare is now

being challenged. And, today, why can't the public vote on this rather than the courts rule on it? Freedom taken away.

There is no one I know in the country that doesn't feel that our Union of individuals has a right to own firearms. Although it's very ambiguous, it says so right in the Constitution. So why is our government trying to take them away? The simple answer to this is that they

are not. There is no one I know of that has said let's remove all firearms from our citizens. In 1994, the federal government placed a restriction on assault-type rifles. This ban lasted 10

years and reduced deaths by about 25 percent. Were we worried about our guns

How does this pertain o any loss of freedom? Well, do we feel safe going to the grocery store, the mall, to school? Do our children get to grow up with knowledge and life lessons without being walked through shooter drills? Are you worried

about going to place you used to frequent without worrying about the shooting that just took place at that location? Do you watch parades or concerts without looking around each corner or at the top of each tall building? Are you getting tired or stressed thinking about these things? Freedom taken away.

Some will tell you that 70 percent of deaths are caused by using

handguns. This, I believe, is correct. Though we usually hear where at least two or more guns are involved with two, maybe more, deaths and injuries inflicted. With assault rifles,

though the perpetrator may have more than one gun on them, usually one gun is used and 10 or many more are dead or injured. And, of course, more is happening each month.



RTHS netters earn first conference tournament crown since 1949 on Saturday

OTTAWA — Junior Jimmy Chavez was one of the final players on the court Saturday afternoon, when the Rochelle Hub varsity tennis team traveled for the Interstate 8 Conference tournament looking to achieve a feat that no team at Rochelle Township High School had done since 1949.

With four schools in the running for the tournament title, Chavez had an opportunity to clinch the trophy for the Hubs during his third-place match against Sycamore's Regan Ni at No. 2 singles. Having split the first two sets with his opponent, Chavez needed a third-set victory to secure a top-3 finish in his bracket and more importantly, the tournament championship for his team.

"I knew that our seniors from last season would want this and I knew that our seniors this season wanted this," Chavez said. "If we wanted to be history makers, we had to win this and that's what motivated me to go out there and play my hardest. I wanted it more than the energy going into the third

set and I knew I had to take advantage of that."

Playing with confidence and determination, Chavez dominated the third set against Ni, ultimately winning the match 6-4, 5-7, 6-1 to take third in the No. 2 singles bracket and secure Rochelle's first conference tournament title in 74 years. The Hubs finished with 23 points in the tournament to edge out runner-up finisher Ottawa, who scored 22 points in the meet after narrowly defeating Rochelle to take home the conference tournament at RTHS last season.

"When I came back and told my teammates, they lifted me up and threw me in the air," Chavez said. "We're all confident and we know that we can beat whoever's standing across from us. We're confident in our abilities and we're confident in what we've learned this season."

Seniors David Wanner and Owen Haas returned as the defending champions at No. 1 doubles and successfully repeated as champions this season. Smardo to continue softball career with Waubonsee CC

OCHELLE senior Morgan Smardo will be reuniting with both her pitching coach and several of her teammates from the Kishwaukee Valley Storm travel softball club as she continues her academics and her softball career at Waubonsee Community College next year.

A four-year member of the varsity team at Rochelle Township High School, Smardo has carried the load for the Lady Hubs this season, leading the team in several hitting and pitching statistics including batting average (.467), on-base percentage (.500), slugging percentage (.717), hits (28), singles (19), runs (19) and RBIs (15) as well as innings pitched (75.2) and strikeouts (111). The senior said she intends to study nursing in order to pursue a career

"About half of my travel team is going there so I know most of the girls there and I play really well with them," Smardo said. "My pitching coach is also their pitching coach and she knows what I do best and where the right fit is for me. It's a privilege to play the sport at a higher level and it's what I love to do. Their coach said I will either be pitching or playing center field."

While Smardo didn't have a freshman season due to the COVID-19 pandemic, she broke out during her sophomore campaign in 2021, earning All-Conference First Team honors in the Interstate 8 after slashing .417/.485/.617 with 25 hits including 16 singles, four doubles, 19 runs and 14 RBIs.

Smardo also struck out 40 batters over 28 innings as a sophomore, pitching behind former starter Bella Lodico, who now plays collegiately at Benedictine University.

"Playing at a higher level since my freshman year has helped me improve a lot and it's allowed me to reach the next level," Smardo said. "My hitting and pitching have improved a lot. I didn't feel like I was the strongest pitcher at first, but I think I'm a lot better now and hitting-wise, I've moved up in the batting order and recorded a higher batting average. I know Waubonsee is losing a very strong pitcher and I'm looking to be a great pitcher and outfielder for them."

Smardo was named an All-Conference Honorable Mention during her junior season, where she slashed .311/.391/.508 with 19 hits and 19 RBIs while adding 98 strikeouts over 68 innings from the pitcher's circle. Atwo-sport athlete at RTHS, Smardo spent four years with the varsity cheerleading team, earning All-Conference honors four times as well as the RTHS Cheerleader of the Year Award twice and the RTHS Most Improved Cheerleader Award once. Smardo was also honored with the 2022-23 Rochelle News-Leader Scholar-Athlete Award this year.

"I'm super excited that Morgan is continuing her career at Waubonsee," Lady Hubs head coach Deanna Jacobs said. "Their head coach [Joe Spitzzeri] took over two years ago and the program is doing very well. Morgan is going to fit in with their program well and I can't wait to see what she accomplishes at the collegiate level."







Hubs finish eighth at Interstate 8 Championships Mickley earns All-Conference in discus during conference meet on Thursday

ROCHELLE — The Rochelle Hub track and field team traveled to the LaSalle-Peru Sports Complex for the Interstate 8 Conference Championships on Thursday. The varsity team finished eighth with eight points and the fresh-soph team took fifth with 65.33

points in the meet.

Junior Landon Mickley earned All-Conference honors in the discus, taking third with a personal-record throw of 41.14 meters. Sophomore Kenny Overton received an All-Conference Honorable Mention in the pole vault, finishing sixth with a clearance of 9 feet 6 inches. Junior Carlos Tomas placed eighth in the shot put with a heave of 11.28 meters and junior Nathan Sergeant finished ninth in the triple jump with a personal-record distance of 11.92 meters.

Junior Luis Hernandez finished ninth in the 1600-meter run with a time of 5:24.93 and earned an All-Conference Honorable Mention in the 3200-meter run, taking sixth with a time of 11:45.41. Junior Irving Escalante took ninth in the 100-meter dash with a time of 11.98 seconds and junior Abel Huerta placed ninth in the 800-meter run with a time of 2:29.21. Junior Bruno Fernandez finished 10th in the 400-meter dash with a time of 56.76 seconds and senior Ethan Bergeson finished 10th in the 110-meter hurdles with a time of 18.46 seconds.

Rochelle's 400-meter relay team (Irving Escalante, Landon DeLille, Bruno Fernandez and Nathan Sergeant) and 1600-meter relay team (Nolan Johnson, Nathan Sergeant, Bruno Fernandez and Chris Hickey) each took seventh with respective times of 48.12 seconds and 4:00.32. Sergeant finished 14th in the long jump with a distance of 5.62 meters.

Freshman Caden Goodwin won the triple jump with a distance of 11.73 meters and sophomore Colton Czekala took third in the shot put with a mark of 11.72 meters. Freshman Wyatt Worthington finished third in the pole vault with a clearance of 9 feet 6 inches and freshman Jorge

Worthington took third in the 110-meter hurdles with a time of 18.05 seconds and third in the 300-meter hurdles with a time of 46.25 seconds. Freshman Declan McGee finished second in the 3200-meter run with a time of 11:24.74 and seventh in the 1600-meter run with a time of 5:32.32. Freshman Elijah Mayen took fifth in the 400-meter dash with a time of 58.91 seconds.

Sophomore Jackson Smith placed 10th in the 100-meter dash with a time of 12.19 seconds and sophomore Virgil O'Dell took ninth in the 200-meter dash with a time of 25.57 seconds. Freshman Johnny Morales finished eighth in the 800-meter run with a time of 2:42.15. Rochelle's 400-meter relay team (Caden Goodwin, Jackson Smith, Virgil O'Dell and Reece Harris) took third

with a time of 47.52 seconds. Rochelle's 800-meter relay team (Caden Goodwin, Jackson Smith, Virgil O'Dell and Reece Harris) and 1600-meter relay team (Caden Goodwin, Jackson Smith, Elijah Mayen and Wyatt Worthington) each finished fourth with respective times of 1:40.80 and 3:57.32.
