# Four Lee County Deputies awarded sheriff's asssociation 2022 Deputies of the Year

LEE COUNTY — On Jan. 13, 2023, the Illinois Sheriff's Association honored Chief Deputy Derek Ranken, Deputy Nathan Hollinger, Deputy Joe Presley, and former Deputy Kolton Morgan with the 2022 Deputies of the Year Award. These gentlemen earned this distinction for their efforts in locating and saving the life of 3-year-old boy over the evening of December 22, 2021 in Harmon.

At approximately 12:56 a.m., the Lee County Sheriff's Office received a call regarding a 3-year-old boy that was missing from his home in Harmon. The night shift, consisting of then Sergeant Derek Ranken, Deputy Joseph Presley, Deputy Kolton Morgan, and Deputy Nathan Hollinger, immediately

responded to the area. Not only were they searching for a small child, but the child was last seen wearing only a diaper and the temperature that morning was 17-degrees Fahrenheit. Deputies searched the immediate area, as well as the home, extensively. The search area broadened, and additional resources were called in to assist with the search.

At approximately 2:27 a.m., Deputy Morgan located the child, naked and lying face down near a ditch on the east side of town. Deputy Morgan wrapped the boy in his jacket and then handed him to Deputy Hollinger so he could get some additional blankets from his squad. The child was unresponsive. It was believed that the child was exposed to the elements, unclothed, for approximately two hours.

At the direction of Sergeant Ranken, Deputy Morgan and Deputy Hollinger transported the child to KSB Hospital in Deputy Morgan's squad car. This location in the county is somewhat remote, with no ambulance service in close proximity. It was immediately apparent that time was of the essence.

Deputy Presley was the lead car to ensure the safe passage along the route to the hospital. While enroute, Deputy Hollinger performed CPR on the child twice, which resulted in the child reacting positively. Dixon City Police Officers were at the city limits, and they assisted with traffic control as the Deputies rushed to the hospital.

# Sublette board approves purchases, looks at future projects

SUBLETTE — The village of Sublette board approved a few purchases during their monthly meet-

The board met in session at 7 p.m., on Monday, Feb. 13, in the Ellice Dinges Center. All members were present except for village board member

MacKenzie Belan. The board approved a purchase of a Hach meter for the water department at a cost of \$2,085.50. The meter will be used to test water.

The board also approved a motion to purchase an eight foot and a 14 foot step ladder for the Ellice Dinges Center. In other board news:

• The board approved a temporary liquor license for Sublette 365's event on Feb. 25.

• Don Dinges reported to the board that he and Sublette Village Trustee Julie Kessel compiled a list of Sublette events for 2023. He also said he has lined up a speaker for the Memorial Day service.

• Stenzel reported that all Cross Connection/Service Line water surveys and Comprehensive Plan surveys were sent out. As of the previous Saturday, 34 water surveys were returned and 44 comprehensive plan surveys were returned.

• The board has approximately \$57,000 to use as part of the American Rescue Plan

Act. They discussed using the money for playground equipment for toddlers, speed signs and/or speed bumps for the village, or downtown projects. Board members will continue to look into options.

• On the April 4 Consolidated Election, there will be three village board seats up for election. On the ballot are: incumbent MacKenzie Belan, Linda Klaser, Brigantia O'Sadnick and Richard Klaser. Two candidates are officials write ins - incumbents Scott Hanson and Jeff

## **P.F.C. Arthur Cyril** Michel

rthur C. Michel was born on Nov. .7, 1923 in West Brooklyn, to Jacob and

the oldest of Arthur's five brothers would eventually take charge of the barbershop until his retirement many decades later.

After completing his education at Amboy High School, Arthur began working at the Green River Ordinance Plant west of Amboy. At age 18, he registered for the draft, and was inducted into the U.S. Army in February of 1943.

At the time of this writing, we were unable to locate Arthur's service records which



honor roll for Lee County soldiers who died during service in World War II, having achieved the rank of Private First Class in the U.S. Army. His listing indicates that he

died of non-battle causes.

P.F.C. Michel was likely at home on furlough when, on Sept. 14, 1944, he died in a drowning accident on the Rock River near Nelson. No other details of this tragedy were found in public records. We do know that P.F.C. Michel was actively involved in the war effort with the U.S. Army, and showed his

willingness to sacrifice for his community and country. Citations:

Upon arrival at KSB, waiting nurses and doctors performed CPR, while also using the AED approximately four times, as the child coded. Eventually, all efforts were successful, and the child regained consciousness. He was subsequently stabilized and transported by helicopter to St. Francis Medical Center in Peoria for further treatment.

Statements made by the attending ER personnel at KSB Hospital summarize this best - "the quick actions and de-

cision-making by on-scene personnel, rapid transport to the hospital, warming the child and performing CPR while enroute, saved this child's life."

"I cannot adequately express my gratitude and pride in knowing how exemplary our personnel responded and performed that morning. This was an outstanding team effort by all involved. Their quick action, decision-making, coordination, and response to this incident, provided us the best opportunity for a successful outcome," Sheriff John C.





"These individuals are ready and willing to assist taxpayers in filing their state and federal tax returns accurately and on time by the April 18 deadline."

How taxpayer assistance is provided and when services are available varies by region, based upon volunteer capacity.

"Even modest tax refunds can be a significant boost to older adults' household budgets," said Illinois Department on Aging Director Paula Basta. "By seeking free tax prep assistance from a trusted local program, you have the best likelihood of getting your full refund and of getting your taxes done on time, correctly and hassle-free."

The IRS'Volunteer Income Tax Assistance (VITA) and Tax Counseling for the Elderly (TCE) programs offer free basic tax return preparation to qualified individuals needing assistance in preparing their own tax returns. People making \$60,000 or less, persons with disabilities and limited English-speaking taxpayers can take advantage of this service. In addition, the TCE program offers free tax help, particularly for those who are 60 years of age and older, specializing in questions about pensions and retirement-related issues unique to seniors. VITA and TCE sites are generally located at community and neighborhood centers, libraries, schools, shopping malls, and other convenient locations across the country.

The AARP Foundation Tax-Aide Program provides free tax assistance, with a special focus on taxpayers over the age of 50 or who have low-to-moderate income. Availability is determined at the local or community level. AARP membership is not required to receive assistance.

In Chicagoland, the Ladder Up Tax Assistance Program (TAP) provides free basic tax return preparation for families earning up to \$60,000 and individuals earning up to \$32,000 annually. IRS-certified volunteer tax preparers assist in filing federal and state returns.

Taxpayers can search for a free tax assistance provider closest to them by visiting IDOR's website tax.illinois.gov. Individuals with questions should contact IDOR's Taxpayer Assistance Division at 800-732-8866.

Taxpayers may also visit any of IDOR's offices located in Chicago, Des Plaines, Fairview Heights, Marion, Rockford, and Springfield to receive assistance. Staff at these locations can help with any Illinois state income tax filing inquiries and are available weekdays from 8:30 a.m. to 5:00 p.m.

## Whooo's there? it's only one of our many owls

'n February, when our outdoor, natural world seems locked in the icy grip of winter, the Great Horned Owl lays her eggs. If you walk through a quiet recess of woods where few people go, you may see a Horned

Owl sitting on her nest. It is usually the former nest of a hawk, high in the crotch of a tree. I knew one nest that was occupied every February for years. It is a large bird, two-feet long with a five-foot wingspan. The tufts on the head are erect like the ears of a cat. They have powerful feet and claws. They can swoop down at night on wings that produce no sound and grab rabbits or skunks or even

Guinea-fowl in trees.

The Barred Owl is only a little smaller than the Horned Owl. They have a barred chest and no horns. The Barred Owl has a very distinctive way of hooting. It is called the "eight-hooter" in some areas. The call is "Hoohoo are you. Hoo-hoo are you all." The hoots are equally spaced with a growled "all" at the end. The Barred Owl is seldom seen, and when it is, it is usually being mobbed by a flock of crows. I have heard the Barred Owl in Franklin Grove, Bartlett Woods, and

The shivering calls of the Screech Owl are seldom heard today; they once were common every evening in the summer. I can remember, as a boy, having my cap knocked off by a Screech Owl on Mason Street. I later learned that the owl was nesting there. It didn't want company and was chasing people.



Long

The tiny Sawwhet Owl is also remarkably fearless. I have met several in winter in different places over the years. I approached within three feet of one in a bush. I slowly moved my hand toward the bird and got my finger within a few inches

before he flew. I approached another within six feet and walked past. When I looked back, he was still there.

Our owls all gulp down their food, hair, feathers, bones, and all. They regurgitate the indigestible parts in the form of pellets. The pellets often pile up beneath an owl's nesting place. If you carefully pull the pellets apart, you will find a few mouse skulls and small bones among the hair.

Editor's Note: James Brady Long was born in Amboy on June 12, 1926. Known by many as "Mazie", he grew up in Amboy, served in the army during World War II, then studied forestry at the Michigan College of Mining and Technology. His studies in botany and forest protection continued as he ventured into farming here. A beloved story-teller, his farm became a place of learning and adventure for relatives and friends. In his later years, he contributed a series of local nature articles to The Amboy News. *Upon his death in 2000, his* many hand-written drafts were gathered and initially curated by Brenda Boyle. 

It is minus twenty degrees and the winter season has just begun. He sets the machinery in motion, but as the chairs ride down toward him, he sees a figure in one of the chairs. "It looks like a mannequin—and yet it doesn't. The human features are there, but every sign of life has been obliterated. The eyebrows and eyelashes are thick with snow crystals, the face has stiffened in an icy grimace. The skin is blue white, the lips shrunken from the cold. The chair sways, and the body slides off and lands on the snow at his feet. He stares openmouthed at the frozen corpse. 'Damn,' he whispers. 'Not you.'"

It's a great opening to a thriller. But it makes no sense me that over a third of this long novel is devoted to the urgent search for this missing girl when we already know that she will freeze to death. Her name is Amanda Halvorssen,

Åre is too small to rate a police detective, so Detective Inspector Daniel Lindskog spends some of his time there, especially during the winter season. Soon after the alarm is raised, he organizes a huge search party, because "around here a teenager who isn't warmly dressed can freeze to death in a few hours." Hanna, who is going stir-crazy in the big house, joins the search.

When Amanda's body is finally discovered on the chairlift, the murder investigation commences in earnest. Hanna becomes involved, but is sidetracked by her discovery of possible human trafficking in Are. Daniel, overworked and miserable, gratefully hires her after she proved herself a firstclass detective. Suspects proliferate. The action accelerates, as when Hanna is involved in a white-knuckle car chase. Our patience is at last rewarded.







# Lady Clippers fall short in Regional final

AMBOY - Despite its youth and limited varsity experience, Amboy managed to win 24 of its 28 regular-season games, earning it the top seed in the regional.

After the Lady Clippers churned out a hard-fought victory over Ashton-Franklin Center in the semifinal-round, they had a date with conference rival Polo - itself a narrow winner over Forreston in the semis - in the championship game of the Amboy Class 1A Girls' Regional Basketball Tour-

The teams split their two regular season games by close margins, and the third meeting did not disappoint. The Lady Clippers played like grizzled veterans, but their fourth-quarter comeback attempt just came up short as Polo pulled out a 49-43 victory on Feb. 17 at the AHS gym.

The loss ended Amboy's outstanding season at 25-5, while the Marcos (18-11) earned the right to play on their home floor against Orangeville in the Polo Sectional. They were the second of two semifinal games on Tuesday night, with Galena going up against Pecatonica in the opener. The two winners will meet for the sectional title at 7 p.m. Thursday, Feb. 23.

Amboy was slow out the gate, seeing Polo double up the score, 12-6, in the early going. But the Lady Clippers clawed their way back and scored the final seven points of the opening stanza to take a 13-12 lead after one. Sophomore Addison Pertell keyed the rally when she nailed a three-pointer and a conventional hoop to draw Amboy to within one. Then junior Elly Jones put up a threepoint try at the buzzer that misfired, but she was fouled on the play and converted two of three free throws for a 13-12 Amboy lead.

The game remained close in the second period as Polo's Lindee Poper connected on a shot at the horn to give her team a 25-20 halftime advantage.

Amboy's goal was the keep Polo off the free throw line, but that didn't happen. Courtney Ortgiesen was nailed with two quick fouls, and Maeve Larson and Tyrah Vaessen also picked up a pair of fouls apiece in the first half. Vaessen went back into the game and was hit with her third foul. Amboy ended the first half with a junior, two sophomores and two freshmen on the floor.

Jones opened up the third quarter with a three-pointer 39 seconds into the half to draw Amboy within two, but the Marcos tallied the next six points, including four of four free throws from Poper, to open up the biggest lead of the game by either team, 31-23. It wasn't until the 3:38 mark of the quarter that the Lady Clippers scored again on another triple from Jones.

Polo built its lead back to eight (34-26) with under a minute to play in the quarter before Jones and Pertell sandwiched three-pointers around a Poper rebound basket to make it 36-32 heading to the final frame.

Amboy got to within three points on two occasions over the first two minutes of the quarter, but a two by Poper and triple by Sydnei Rahn


stretched the margin to eight again (45-37) with 3:32 left.

Amboy scored the only points over the next two minutes and 40 seconds on a Jones free throw, a nice basket by Pertell off an inbounds pass and another trifecta by Jones with 52 seconds left to make it 45-43. But that proved to be the final points for the Lady Clippers as Polo connected on four of six free throws to hold on for the win.

Jones led all scorers with 25 points while Pertell finished with 12. Amboy held Polo's three leading scorers to 12, seven and three points,

but Rahn, their fourth leading scorer, exploded for 24 points, while Poper chipped in with 12 tallies.

Jones added seven rebounds and two steals for the Lady Clippers, while Pertell had a season-high eight boards and dished out three assists. Also, Vaessen grabbed five rebounds and had four assists, Kiera Karlson scored a basket and snared two rebounds, Ortgiesen had a free throw and five caroms, and Larson picked off three rebounds and swiped two steals.


