Plans underway for 2023 Sublette Antique Tractor and Toy Show

SUBLETTE — Santa Claus already brought his toys for the holiday season.

Now it's time for the 41st Annual Sublette Antique Tractor and Toy Show to get ready to present its toys on March 18 and 19, 2023.

The show, which is \$3 admission and free to six and under, will feature toy vendors with all varieties of farm toys and tractors, cars, semitrucks, and arts and crafts.

Each year the Sublette Antique Tractor & Toy Show features a specific tractor. This year's special guest is the J.I. Case Tractor.

"Quite a few years ago, we started featuring a different kind of tractor at each annual toy show," said the Sublette show's secretary, John Stenzel. "This year we're featuring the J.I. Case tractor. It has a symbol of a globe and an eagle (introduced in 1865 based off of Old Abe, a Wisconsin Civil War Regiment's mascot). I read about the J.I. Case a while ago, but if I remember right, the tractor started in Wisconsin."

Founded by Jerome Increase Case, the Case Corporation (originally the J.I. Case Threshing Machine Company and also called the J.I. Case Company) manufactured agricultural machinery and construction equipment from 1842 until it closed in November of 1999.

At one point, Case was one of the top options for steam engines, portable engines, traction engines, and steam tractors.

New year to bring new laws in Illinois

phancock@capitolnewsillinois.com **SPRINGFIELD** – For most people who work a minimum wage job, the new year will bring a pay raise to \$13 per hour, a \$1 increase over the current wage. That's the result of a law Gov. JB Pritzker signed in 2019, his first major legislative victory after being sworn into office a month earlier. The law will eventually raise the wage to \$15 an hour

on Jan. 1, 2025. The new \$13 hourly rate does not apply to all minimum wage earners. People who receive tips at work will see their base wage rise to \$7.80 an hour. And people younger than 18 who work fewer than 650 hours per year will see their wage go up to \$10.50 an hour.

The higher wage will probably come as welcome news for those who drive a car to and from work. That's because the new year will also bring higher motor fuel taxes.

The same year Pritzker signed the minimum wage bill, he also signed a

multi-year, \$45 billion transportation and capital improvements bill known as "Rebuild Illinois," which is funded in part with higher motor fuel taxes that are scheduled to increase with inflation each year.

The adjustment in the tax rate is supposed to take effect on July 1 of each year, the first day of the state's fiscal year. But last spring, in the face of rising inflation and healthy state revenues, lawmakers authorized a six-month delay in the scheduled increase, putting it off until Jan. 1.

As a result, starting Jan. 1, the motor fuel tax people pay at the pump will go up 3.1 cents per gallon, and then it will increase again when the next regular adjustment date comes around on July 1, 2023.

Criminal law

Several new criminal laws will go into effect Jan. 1, including three that deal with sex offenses. One of those prevents people who solicities from a minor or a person with a

solicit sex from a minor or a person with a severe or profound intellectual disability

from asserting a defense that they simply did not know the person was underage or intellectually disabled. House Bill 4593, signed into law May 27, puts the burden of proof on the defendant that they did not know the age or disability status of the other person, rather than the other way around.

Another new law changes the definition of when a person is "unable to give knowing consent." Under current law, a person cannot give knowing consent when the accused person "administers any intoxicating or anesthetic substance or any controlled substance" that causes the victim to lose consciousness of the nature of the act.

House Bill 5441, signed June 16, broadens that definition to include when the victim has taken any intoxicating or controlled substance causing them to lose consciousness of the nature of the act, even if the substances were administered by someone else.

Judge invalidates cash bail reform in some counties; Supreme Court appeal pending

SPRINGFIELD – A Kankakee County judge ruled Wednesday that lawmakers overreached their constitutional authority in passing a measure to abolish cash bail in Illinois, while other provisions in the wide-ranging SAFE-T Act criminal justice reform were not affected by the ruling.

The ruling by Judge Thomas W. Cunnington leaves the impending cash bail reform in limbo in at least 64 of Illinois' 102 counties that had joined the consolidated lawsuit ahead of the reform's scheduled Jan. 1 implementation.

The reform remains scheduled to take effect in the more than 30 counties that did not sue, which contain roughly two-thirds of the state's population. Of the state's 10 most populous counties, six were not part of the lawsuit (Cook, DuPage, Lake, Kane, St. Clair and Champaign). The counties of Will, McHenry, Winnebago and Madison were all part of the lawsuit.

The ruling did not invalidate other provisions of the SAFE-1 Act which had already taken effect, such as reforms to police officer training and certification standards and police body camera requirements. Cunnington wrote in a 36-page decision that the cash bail provisions effectively and improperly amended a section of the state's constitution that states, "all persons shall be bailable by sufficient sureties," except in a few specific circumstances. He also wrote that ending cash bail is an improper overreach by lawmakers, who have no constitutional authority to govern the administrative functions of Illinois courts due to the separation of powers. Bail, Cunnington wrote, has been held by the Supreme Court to be "administrative" in nature. The constitution also specifically mentions bail in a section on victims' rights, when it states victims have a right "to have the safety of the victim and the victim's family considered in denying or fixing the amount of bail." Cunnington found that eliminating bail prevents courts from "effectuating the constitutionally mandated safety of the victims and their families."

Increase for Illinois minimum wage starting Jan. 1, 2023

SPRINGFIELD – The Illinois minimum wage is set to increase another dollar on Sunday, January 1, 2023, making the new required minimum wage \$13 an hour.

Minimum wage workers are encouraged to keep a close eye on their paychecks in the new year as any time worked in 2023 must reflect the new \$13 an hour minimum wage.

There have been five increases in the state minimum wage since Governor JB Pritzker signed historic legislation in 2019 that establishes a schedule of wage increases, putting Illinois on the path to a \$15 an hour minimum wage by 2025. Prior to the first of these minimum wage increases in 2020, the last time workers in Illinois received an increase in the minimum wage was more than a decade ago in 2010.

"Illinois workers deserve a minimum wage that keeps up with the rising costs of living," said Governor JB Pritzker. "That's why, during my first year as Governor, we raised the minimum wage with a gradual ramp to \$15 an hour. Starting Jan. 1 minimum wage workers will get a raise and businesses will continue receiving tax credits for providing their workforce with a living wage."

The minimum wage for workers who regularly earn tips will increase to \$7.80 an hour on Jan. 1; these workers must still earn the minimum wage after receiving tips, or the employer is required to make up the difference. Workers under 18 who work fewer than 650 hours a year will earn a minimum wage of \$10.50 per hour beginning Jan. 1. All employers in Illinois are required to post the "Your Rights Under Illinois Employment Laws" poster in the workplace where notices to employees are regularly posted. The color poster, which also covers other Illinois labor laws, can be found here in English, Spanish, and Polish.

"Minimum wage laws improve the standard of living for all workers of our state," said Jane R. Flanagan, Director at the Illinois Department of Labor. "Employers and employees should be aware of the increase to the minimum wage in Illinois."

A Look Back At Amboy area Heroes Who Served During World War II

Editor's note: The Amboy News will be publishing a series of articles on veterans who served during World War II. These heroes are part of Amboy's history and it is our honor to publish these articles so you can learn about their service to our country. This article was researched by Jack Mead and Tom Dempsey, and written by Dempsey.

P.F.C. Albert James Klausen

lbert Klausen was born in Sublette, on Dec. 9, 1921 to James and Martha Klausen of China Township near Franklin Grove. Albert's father James had immigrated to America from Denmark in



1911, with Danish as his primary language, and became a naturalized American citizen during the year of Albert's birth. The Klausens went on to have four children, earning a living as farmers.

As with most American families, the Klausens would see the 1920's give way to the hard times of the 1930's,

finding ways to make ends meet. Albert attended grade school at Kesselring, a country school, before graduating from Lee Center High School with the class of 1939. For the next several years, Albert earned his own wages working for several farmers in the Franklin Grove area.

At age 20, Albert James Klausen registered for the military draft. Following his induction into the U.S. Army in August of 1942, he was sent to Scott Field in Illinois before going to Camp Wheeler, Georgia to complete his basic training. He would eventually earn the rank of Private First Class with Company A of the 550th Airborne Infantry Battalion, and during 1943 he served in Panama. Upon America's entry into World War II, defense of the Panama Canal was critical since our armed forces were engaged in both the Atlantic and Pacific Oceans. In September of that year, P.F.C. Klausen returned to the United States, stationed at Maxton Army Base in North Carolina.

In April, 1944, the 550th A.I.B. was sent to North Africa as an airborne glider battalion to prepare for action in southern Europe.

At the time, the Allied leadership had planned to liberate France from Nazi occupation by simultaneously invading the Normandy beaches from the west (Operation Overlord) and the Mediterranean coast from the south (Operation Dragoon) during June of that year. But owing to a shortage of resources, the latter operation was postponed until later that summer to ensure adequate preparations. The D-Day Invasion took place as scheduled on June 6, allowing Allied troops to open the western front against the German Army.

On Aug. 14, 1944, American forces invaded southern France under the code name Operation Dragoon, with the goal of securing ports along the French Riviera. Hindered by Allied air supremacy, the American Navy, and armies of the French Resistance, the Germans were quickly defeated and another front was opened.



Illinois Attorney General Kwame Raoul said in a news release the state will appeal the decision directly to the state Supreme Court, but a timeline for a ruling from the

high court is unclear.

"Most of the SAFE-T Act's provisions have been in effect for more than a year, and regardless of today's circuit court decision,

all parts of the SAFE-T Act, including the pretrial release portions addressed in the court's decision, will go into effect Jan 1," Raoul said. "For instance, the right of individuals awaiting criminal trials - people who have not been convicted of a crime and are presumed innocent-to seek release from jail without having to pay cash bail will go into effect in a few short days, despite the court's ruling against those provisions.'

Cunnington rejected other arguments by the dozens of state's attorneys that centered on the legislative process, namely that the bill was not given a proper hearing and violated the "single subject" rule. Court precedent holds that as long as the House speaker and Senate president certify that a bill is properly passed, courts have no standing to intervene, he wrote.

Another bill expands certain employment restrictions that apply to convicted child sex offenders. Currently, they are prohibited from being employed by, or even being present at, child day care centers, schools that provide before- and after-school programs for children or any facility that provides programs or services exclusively for people under age 18.

Senate Bill 3019, signed May 27, expands that to prohibit convicted child sex offenders from working at carnivals, amusement enterprises, county fairs and the State Fair when people under age 18 are present.

Another new law expands the list of professionals who are required to report suspicions of child abuse or neglect. Starting Jan. 1, under Senate Bill 3833, signed May 13, occupational therapists and assistants, physical therapists and assistants, and athletic trainers will be added to that list.

Carjacking

Three new laws taking effect Jan. 1 are intended to address a spike in carjackings around the state. All were signed on May 26

90 credit hours to obtain a substitute teaching license. Before, applicants had to hold a bachelor's degree or higher from an accredited institution of higher education.

House Bill 4716, signed May 27, calls on the Illinois State Board of Education to adopt "rigorous learning standards" for classroom and laboratory phases of driver education programs for novice teen drivers. Those will include, at a minimum, the Novice Teen Driver Education and Training Administrative Standards developed by the Association of National Stakeholders in Traffic Safety Education in association with the National Highway Transportation Safety Administration.

Higher education

In an effort to get more people to pursue careers in human services, Senate Bill 3925, signed June 10, establishes a student loan repayment program. Subject to appropriations, the Illinois Student Assistance Commission will award loan repayment grants to qualified individuals with an associate degree or higher who works for a human services agency that contracts with or is grant-funded by a state agency that provides "direct or indirect services that ensure that individuals have essential elements to build and maintain physical, emotional, and economic well-being at every phase of life." Awards can be made for a maximum of four years. Maximum amounts are \$3,000 per year for someone with an associate degree, \$15,000 per year for a person with a bachelor's degree and \$25,000 per year for a person with a master's degree or higher, with a \$5,000 per-year add-on if the applicant holds certain professional licenses. Meanwhile, students currently enrolled in any program at a public university or community college will have access to trained individuals who can help them apply for federal, state or local assistance based on their financial need. House Bill 4201, signed June 7, requires those institutions to designate a "benefits navigator" to help students identify and determine their eligibility for various benefit programs.

Senate Bill 3707, signed May 27, requires all employees and people who work for agencies that contract with the Illinois Department on Aging who provide direct services to individuals participating in its Community Care Program to receive at least two hours of training in Alzheimer's disease and dementia, as well as safety risks, communication and behavior associated with the disease.

Hunting

Starting Jan. 1, deer hunters in Illinois will have a new option for the type of firearm they use. House Bill 4386, signed May 27, authorizes the use of single-shot centerfire rifles – guns that can fire only a single round of ammunition that contains primer in the center of the cartridge and not in the rim of the cartridge. Before, only shotguns, handguns and muzzleloading rifles were allowed.

State symbols

Illinois will have two new official state symbols effective Jan. 1. House Bill 4821 establishes the eastern milksnake as the official state snake. That was an initiative of Gentry Heiple, a snake enthusiast and Carterville Junior High School seventh grader. And House Bill 4261 establishes dolostone as the official state rock. That was an initiative of a group of students from Pleasantdale Middle School and Maplebrook Elementary School.





House Bill 601 expands the crime of possession of burglary tools to include possession, with the intention to enter and steal a vehicle, of devices to unlock or start a vehicle without the key to that vehicle, or devices that capture or duplicate a signal from a key fob to unlock or start the vehicle.

House Bill 3699 expands an existing state council charged with providing grants and financial support to law enforcement agencies to aid in identifying, apprehending and prosecuting carjackers and recover stolen vehicles.

And House Bill 3772 ensures that victims of carjackings are not liable for costs and fines associated with impounding a vehicle that was stolen or hijacked, provided the owner files a police report in a timely manner.

Senate Bill 3609 allows those drivers to apply for a one-time \$25 rebate, "if the vehicle is manufactured in this state and the application for title is made no more than one year after the month in which the vehicle was manufactured."



A CHICAGO CRIME THRILLER

ike all big cities, Chicago has its share of scary places. Though I have no clear idea why it has such an effect on me, but Lower Wacker Drive always gave me the willies. Perhaps it's because it feels strangely remote (it was built in 1926) as it snakes underneath Upper Wacker Drive through the heart of the city. So I wasn't surprised that Lower Wacker would figure prominently in Tracy Clark's Chicago crime thriller, "Hide."

Clark's detective is smart, no-nonsense Harriet (Harri) Foster. She is assigned to a new precinct after her partner of many years "had woken up on a Tuesday, fed her kids, kissed her husband, Mike, goodbye, then driven to work and blown her brains out in the CPD parking lot." Harriet is paired with Jim Lonergan, an obnoxious, racist (Harriet is Black), oldschool cop and she is immediately assigned that morning's murder case. A woman's body, naked, her throat slashed ear to ear, was found on the River Walk next to Lower Wacker.

For Harriet the stakes are high, failure could well end her career. Moreover, all of Chicago is entranced by the gruesome murders (of course there are always multiples), City Hall is putting on the pressure. Harriet tries hard to ignore Lonergan, but he is so awful and makes so many mistakes, she soon gets a new partner.

As the detectives hold their collective breath waiting for the next attack, a parallel story about twins Bodie and Amelia unfolds. Bodie has just been released from a psych ward. Helpless, he appeals to Amelia for help, and as always she stands by him. They share a terrible secret: Their father was addicted to murder. "Their basement was his killing field, and they'd known it since the age of twelve, when they'd found the basement door unpadlocked and wandered downstairs to find what remained of someone's daughter."

The investigation is going nowhere. The front-page murders are titillating, but the cops can't get ahead of the killer. They arrest Bodie. Harriet has eminent reason to doubt his guilt. But no one listens to her. Frustrated she pursues the killer on her own. The danger to her is mounting, yet she thinks nothing of retracing in the dead of night the killer's possible escape route along Lower Wacker. Shocking twists and revelations keep mounting. In short, Tracy Clark knows how to keep your attention.






