A Review of Some of the Local Stories from the Past Year



January

County clerk Dana Smith and county treasurer Gloria Wills each announced they would not seek reelection in 2022. Smith and Wills notified in letters county Republican chairman Dustin Peterson of their decisions.

The county reported five county inmates tested positive for COVID-19. Some inmates began complaining of sore throats and other cold symptoms. Rapid COVID tests were later administered, and the inmates tested positive for the virus. The sheriff's office worked with Warner Hospital and the health department in regard to testing and treatment. During the same period, schools superintendent Curt Nettles released new COVID guidelines from the CDC and IDPH for the isolation and quarantine of students

from the Illinois Prairie Community Foundation. The library received \$1,500 for "Access for All: Enhancing Inclusive Collection." The program offered a collection of books, movies and digital content featuring diverse authors, characters and settings.

The school board authorized litigation against the Illinois State Board of Education and the state superintendent of education to prevent the "loss of recognition status of the school district." The board was affirming its plan to use the school district's own return-toschool protocol in regard to COVID mitigation rather than the ISBE mandated plan.

February

Boaters who use the Clinton Lake marina visited the county board to express their dissatisfaction with a plan to increase the price of slip rentals. Slip renters who attended the county board meeting said they felt the marina did not offer

sufficient amenities to justify the rental increase. The board approved the increase, but members were divided on how to plan the marina's future.

A Clinton resident addressed the city council to question a commissioner's use of city-owned gas pumps for his personal use. He produced records provided by the city through a Freedom of Information Act (FOIA) request he said showed the commissioner did not properly record his use of the pumps.

A judge in Sangamon County ruled in favor of the 145 Illinois school districts that wanted to use its own return-to-school COVID protocol rather than a plan mandated by the Illinois State Board of Education. Clinton schools superintendent Curt Nettles said the ruling appeared to give the school district the authority to use its own plan.

position regarding short-term rentals

Commissioners offered Tuesday clarification on their recent discussion of short-term rental units.

City attorney John Hoblit, at a previous meeting, said residents who opened short-term rentals in residential areas were possibly in violation of city ordinance. He based this on the fact that the city code does not address the topic.

Hoblit said if the code did not provide for the specific activity, it was not allowed.

Clinton resident and owner property Curt Ware addressed the council during its Tuesday meeting. He said he had a problem with some of the language used during the council's discussion of short-term rentals.

Ware owns a home which is currently empty and he would like to operate as a rental on a temporary basis.

"It's a home I would like to come back to when my wife retires," Ware said.

The home formerly belonged to Ware's parents.

"There's nothing in zoning that says what you can or cannot do," Ware said.

Hoblit said in the previous council meeting that codes were written primarily to address what was allowed, not to address what was not allowed. Ware said he did not know if he would use the Airbnb booking platform to rent his house. But, he said it was no different than using other methods for renting a house for a week on vacation or renting a house in the city of Clinton. "If we went through the city of Clinton and looked at how many houses are rented, I don't think the city knows how long the term is on the rent or how

long a person stays in a house in Clinton," Ware said.

He said he assumed it wasn't public knowledge, "yet, the city wants to step in and tell a person how long they can rent their property because they're using a source like Airbnb."

Ware said he wanted to rent his house out for longer terms but wanted the right to rent to a family that might need it for a shorter length of time. He said he felt it was discriminatory to restrict a property being rented for a short term that was in the same neighborhood as a house being rented long term.

Ware said operating short term rental properties protects the landowners against tenants who won't pay and refuse to leave.

"As a short-term lease or rental, they're going to take care of that property because you're going to get a review," he said.

Commissioners said their intention in addressing short-term rentals as part of the city code was not intended to prohibit the type of rental but to regulate them.

"We need to look how at we make that classification," commissioner John Wise said. "We do not have it on our books."

Wise said Hoblit was correct in saying the ones that were operating currently were doing so without any zoning in place that would allow their operation. Some of those rentals would be required to pay hotel/ motel tax to the city. "We want to look at how we have that in our code and have that classification," Wise said. Wise said he did not oppose Airbnb-types of rentals but that the city needed language in the code covering the activity to create a "level playing field."



Warner Hospital CEO Paul Skowron reported the hospital was gradually returning to normal as statewide COVID cases continued to decline. In spite of much lower COVID and Omicron variant numbers, Skowron reminded residents it was still flu season and urged caution.

Police officers were out reminding residents about the rules concerning the city's snow routes. Chief of Police Ben Lowers said the city hadn't vigorously enforced the rules for a while and there would be a return to more compliance enforcement. A list of designated snow routes in on the City of Clinton website under "Government," then click "City Code Book." Residents living along snow route streets must remove their vehicles prior to a forecast winter storm.

March

The DeWitt County Board voted to sell 75 acres it owned at Clinton Lake marina. The plan included use restrictions requested by Exelon/ Constellation, owner of Clinton Power Station.

Election scheduled for June. County board members Terry Ferguson and Melonie Tilley filed for reelection, while candidates Tom Farris, Kristina Deerwester and Joe Witte also filed. Incumbent sheriff Mike Walker filed for reelection, Kari Harris filed for county clerk, and Sara Jade Russel and Codilee Snow filed for county treasurer.

The county board's land use committee announced a major review of the county's zoning code. The intent was to remove or revise parts of the code that may no longer be relevant and expand or modify portions to address emerging issues, such as solar energy projects and short-term rental properties.

April

Three businesses and a nonprofit organization were awarded during the annual Clinton Chamber Business Expo. The Clinton Journal received the award as small business of the year; the medium-sized business of the year award went to Calvert Funeral Homes and the large business of the year award went to


Candidates for office 2022 filed for the DeWitt County Primary the First National Bank & Trust Company. The Vault was awarded as the nonprofit organization of the year.

As cases of COVID-19 continued to decline, the new budget for Warner Hospital & Health Services reflected the change, assuming it was unlikely the city would see a major resurgence in the virus.

The county board approved a revised ordinance placing restrictions of commercial solar power projects. The change confines solar development to areas designated as "industrial" zones.

May

Meta, Facebook's parent company, announced it would draw power from DeWitt County's Alta Farms II wind energy project. The announcement designated Alta Farms II as a source of power for Meta's data center expansion in DeKalb.

Clinton resident Robert Kreitler questioned the city council about what he felt was an improper and dangerous method of supplying electricity to a hospital out-building.

After spirited debate, the county board extended for one year its contract with 1125 Property Management to manage the Clinton Lake marina. Some board members felt the county's contract with 1125 favored the management firm too much financially. Other members pointed out the management firm already had committed to upgrades to the marina that already were under way.

The school board banned student cell phones at Clinton Junior High. The administration concluded the phones created a distraction for students during school hours.

The city responded to allegations the fire department's training not up facility was to proper codes. А representative from the fire department said the department was making every effort to comply with the NFPA 1402 Standards on Facilities for Fire Training and Associated Props.

Farnsworth Group engineers worked toward getting the street completed in the city's new subdivision, located along Illini Drive. The work had been delayed because of winter weather and also because soil samples showed additional work was necessary on the road bed before concrete could be poured.

July

The school district's lawsuit against the Illinois State Board of Education was declared moot. The district had sought to implement its own returnto-school COVID policy rather than the mandated plan by ISBE. While declaring the suit moot, the judge nevertheless wrote he doubted the ISBE acted properly, opening the door for school districts to follow their COVID own plans.

June

Cummins' engineers reported to the county board that work was under way installing foundations for the Aircraft Detection Lighting System at the Alta Farms II wind energy project. The county hired Cummins to monitor progress on the project.

The U. S. House of Representatives votes for its Speaker on Tuesday of this week. That will tell us much about how Washington politics will proceed. I would also note this article is written before that vote will be cast.

It takes 218 votes to be elected Speaker. The Republicans have 222 seats, which should make the election of Kevin McCarthy a shoe in. The problem is the Republican Freedom Caucus of the House is essentially opposed to McCarthy.

If at least five of those members hold fast in their opposition to McCarthy, he doesn't have the votes. Agree on disagree with Democratic Speaker, Nancy Pelosi, you have to give her credit for getting her ducks in a row before her election to Speaker.

The Democrats have their centrist base and then some radical leftists led by AOC. But the key is that Pelosi reigned in the opposition or effectuated a deal to pass the Democratic legislation. Nancy Pelosi was a brilliant Speaker in getting her party's agenda moved forward to passage. Republican Former Speaker John Boehner and Paul Ryan were both at odds with the Freedom Caucus and were severely hampered in their tenure as Speaker.

Even if McCarthy is successful in obtaining the Speakership, the question will be how much power will the Freedom Caucus have in the next two years. There appears to be too much chaos in the Republican-dominated House for the Republicans be effective to by themselves as a party.

If both parties choose to operate on strictly partisan agendas then chaos will be the result. However, if some true leaders in both parties actually sit down and debate the issues we may see the return of a true bi-partisan House. That would truly be interesting. Both political parties have put themselves in front of the nation's needs. Perhaps there is some hope that a change is occurring.

State wide the Pritzker administration suffered a setback when a judge in



Kankakee County ruled against the new no bond laws. Sixty-five State's Attorneys opposed the new law and filed a lawsuit against the legislation on constitutional grounds. Somebody in Springfield needs to take note of the factor that 2/3 of elected attorneys the in Illinois opposed a Chicago generated piece of legislation. The lawsuit was consolidated and held in Kankakee. Two things are of note. First the Kankakee State's Attorney who opposed the legislation is a Democrat.

Second it is the urban counties, or those with large college aged voters, who support the new legislation. This legislation again shows the real divide in Illinois is between rural and urban constituencies.

When legislation gets local one can see that

rural votes are greatly outnumbered and Chicago will probably get its way. It's a new year, but this divide is long standing and appears to be getting wider.

more information at www. va.gov/change-directdeposit.

It can take a little while to think about this kind of change if you've never had direct deposit. But it can be rather disconcerting to have a neighbor from a block away show up at your door with a check that was mistakenly delivered to them.

You can eliminate a big source of worry and potential problems if you consider signing up for direct deposit for your benefit payment.




Culinary favorites





Weather History

January 7

1979: The southern half of Illinois was affected by a winter storm, with the heaviest snow across far southern parts of the state. 8 inches or more of snow were found west of Carbondale. Further north, up to 5 inches of snow fell near Vandalia. Illinois Weather Trivia for January National Weather Service, Lincoln, IL Page 3

1989: Several out-of-season tornadoes occurred across southern Illinois. The strongest tornado, ranked as a "4" on a scale of 0 to 5, affected the town of Allendale, in Wabash County. Most of the town was destroyed, including 10 businesses and 47 homes. Although 50 people were injured, no one was killed.

The city council discussed the variety of trees that are discouraged in Clinton. Considered invasive species, the city works closely with the local Tree Commission to keep a list of the offending trees. The discussion was prompted by comments from a resident made during a council meeting.

The Clinton school district approved an e-learning plan for schools. The plan makes it possible for students to do schoolwork online during days considered emergencies, such as snow days or other weather-related events. This way, students would be counted as being in attendance rather than the district adding on makeup days at the end of the school year.

The county announced it would update its hazard mitigation plan. The mitigation plan ensures funding for large mitigation projects and anything after a disaster. The plan is paid for through a Federal Emergency Management Agency (FEMA) grant.

October

The CO2 issue looked as though it were headed to the forefront of the county's controversies as county board members discussed a proposal to sequester CO2 in the county. The plan would involve a pipeline that would carry liquid carbon dioxide emissions from ethanol plants in Iowa to DeWitt County. Special wells would pump to CO2 about a mile down into geological designated structures. CO₂ sequestration is estimated remove massive to amounts of carbon dioxide from the atmosphere as one way of alleviating climate change.

Warner Hospital & Health Services CEO Paul Skowron announced the facility would ease its masking rules for COVID per the Center for Disease Control & Prevention (CDC). Barring a resurgence of COVID in the area, visitors no longer are required to wear masks in non-patient care areas of the hospital.

Energy Harbor won the auction this year to supply electricity to residents of the county living in unincorporated areas served by Ameren. The winning bid resulted in a fixed rate of \$0.1210 cents for a 22-month term beginning in February.

Clinton Power Station parent company Constellation officials announced they would apply for a 20-year extension of the plant's operating license. Thanks to funds made available through the Federal Inflation Reduction Act, Constellation said the plant could remain operation past its planned closure in 2026. The credit provided by the FIRA applies to power generated by existing nuclear plants through December 31, 2032. The provision of the FIRA making the credit possible is the "zero emission nuclear power production credit." It is another method aimed at curbing CO2 emissions.

City attorney John Hoblit said there didn't appear to be any mention of shortterm rentals, or Airbnbs, in the city's code book, which would make them essentially illegal.


Nest leads the +J and when Dummy goes down you can count only 11 ricks: six trumps in hand, two Diamonds and a ruff in Dummy, and wo Spades (regardless of who holds the **♠**K). Where's the 12th trick?

To make your contract, you will need to score a third Spade trick. After the AQ has been successfully finessed on the first round, how do you play to the second round of Spades? You are doomed to failure if the missing Spades are 5-1 ... and destined for success if the suit is 3-3 ... so what's the play that gives you the best chance when the Spades are 4-2? The two choices are:

- Either, cash the A, hoping that West started with a doubleton King.
- Or, lead the AJ from hand (which West will cover with the King). This caters for East holding the doubleton Ten or doubleton Nine, allowing Declarer's mighty 12th trick!

That should be an easy decision! Kx with West is one winning chance ... Tx or 9x with East is two winning chances. It doesn't need a mathematician to figure out which play is more likely to succeed. After the percentage play brings home the slam, Declarer will avoid saying "My 6♥ was a bit optimistic, but of course I wouldn't have bid it without the Spade Seven". Unless, that is, he wants to infuriate the opponents.






