Walk 'N Roll raises over \$23,000 Kissack: 'It was awesome to spend my 16th birthday that way'

ROCHELLE — On Sept. 25, Bryn Kissack of Rochelle celebrated her 16th birthday with a Walk 'N Roll event to raise monev for the Illinois Spina Bifida Association at the Helms Field track.

Over 400 people attended the event and over \$23,000 was raised. People of all ages joined Kissack by walking or rolling by her side on the track. The Rockford Chariots organization attended and brought wheelchairs. Buzzed by Sonset played live music and Ralfie's BBQ provided lunch.

Bryn's mother, Jennifer, said the ISBA told her it was the biggest event they've had in over a decade. The ISBA is a 501c3 charity serving more than 900 families throughout Illinois, including Bryn and the Kissacks. It provides community programs and services for individuals affected by spina bifida as well as research, advocacy, education and support initiatives.

"It meant a lot for us to raise that money for the

ISBA, and I know it meant a lot to them," Bryn said. "I'm very thankful we decided to help them out as much as we did because they've done so much for me and for our family and they're still helping and working with us. They're

very supportive of every family with kids that have my disability."

Bryn's journey began at her parents' 20-week ultrasound when they were told their baby had a birth defect known as spina bifida. Bryn's spinal

cord did not form properly. There was an opening in her spinal column and her spinal cord was outside of her body. Bryn had a severe

degree of spina bifida. Bryn was born in 2006. Her first surgery followed 12 hours later. Over the past

15 years, Bryn has had a total of 14 surgeries, mostly dealing with her spine, brain and legs. Spina bifida is a lifelong condition that causes physical and intellectual disabilities.

Overpass dedicated to late state senator

John B. 'Jack' Roe honored during ceremony in Rochelle

ROCHELLE — On Tuesday, a ceremony was held dedicating the Illinois Route 251 overpass in the heart of Rochelle to the memory of the late State

Sen. John B. "Jack" Roe. In 1976, Sen. Roe was approached by local civic and business leaders to obtain assistance and funding to place an overpass on then-U.S. Route 51 through Rochelle. At that time, U.S. Route 51 was the major north-south thoroughfare through Illinois. The City of Rochelle had two sets of railroad tracks, the Chicago Northwestern and Burlington Northern, with as many as 80 trains a day going through the city, creating delays of 15 to 20 minutes for each train. Consequently, Rochelle became known as "Jamtown" and "Delaysville" by truck drivers. Sen. Roe secured the necessary funding to construct the Rochelle overpass to remedy the logiam and facilitate

Brian Stewart, who co-sponsored House Joint Resolution 57 in Springfield to designate the Illinois Route 251 overpass

in Rochelle in honor of Sen. Roe. The resolution was passed unanimously earlier this year.

Signs in Roe's honor were placed at both ends of the overpass on Tuesday. Bearrows called the work on the dedication "a long process" and thanked Demmer, Stewart and

local attorneys Dave Tess and Russell Crull for their work on it.

"We always talk about projects that will last into the future," Bearrows said. "The overpass idea was originally not popular with everybody. There were people that didn't like the thought of it. Try to take it

away today, and see how much havoc you're going to raise. It was an amazing project that truly looked into the future for this community. Jack had the future of his community, territory as state senator and the entire state in mind."



Bryn has minimal feeling, muscle and movement in her legs due to the severe nerve damage. She wears leg braces for stability and uses a wheelchair to get around. Her condition requires specialized medical care and daily attention to health and wellness.

Bryn is now a sophomore at Rochelle Township High School and takes part in extracurricular activities both at and outside the school such as swim team. horseback riding, cheer and managing the volleyball team.

"It was awesome to spend my 16th birthday that way," Bryn said. "I wanted to do something like that for so long. This year, I just kind of said, 'Let's do it.' I've learned so much over the years about my disability and how it affects my life, my personal appearance and how it'll affect the rest of my life. I wanted to do something that helps me learn more about it and get the whole community and family and friends together. I wanted to see other people that have been impacted by spina bifida there. I wanted to bring everyone together and have a lot of fun."

Jennifer said friends and family from near and far came to the event, which was well-sponsored and attended by the Rochelle community. Businesses made donations and provided raffle items. "There was a ton of

community support, which I think is really neat for our small town," Jennifer said. "It's what small towns are all about, really. Everybody comes together for each other and that's definitely what happened that day. Everybody came out.'

Bryn called the feeling of seeing everyone together "amazing" and said it had been years since she saw some of the attendees. She enjoyed spending the day with people and sharing more about spina bifida with them.

The Kissacks said they were surprised by the turnout and expected around 100 people.

"And it just exploded,"

Jennifer said. "I think it was a pretty neat experience. It was fun. It just shows how much people care and want to give back and support Bryn. A lot of it has to do with her and her personality I think. She never meets a stranger. She's always very caring and generous and giving to others. I think it speaks volumes on who she is and what she means to other people."

Putting the event together required "a lot of work," the Kissacks said. Members of the community and the ISBA lent helping hands. Another event like it may happen sometime in the future after last week's success.

"It was a lot of fun and it was nice to give back," Jennifer said. "A big thank you to all of the sponsors and everybody that donated raffle items. That was huge. It wouldn't have happened without everybody's support and help."

The National Merit Scholarship Program is an academic scholarship competition for recognition and university scholarships. is currently 3.989. Sanford's schedule includes: AP calculus, dual credit advanced composition, anatomy/physiology I, AP statistics, sociology,



Domestic Violence wareness Month Recognizing and reporting child abuse

O one wants to imagine a scenario in which a child is threatened or unsafe. Unfortunately, children confront abusive situations every day.

The Centers for Disease Control and Prevention defines child abuse as any emotional, physical mistreatment, neglect or sexual abuse perpetrated by an adult in a role of responsibility on someone who is under the age of 18.

Everyone, whether they have children of their own, work with children or even people who do not routinely interact with children, can do their part to protect children by learning to recognize the warning signs of child abuse.

For the past few years, people all over the world have been told to stay close to home to reduce the spread of COVID-19. However, home may not be the safest place for children who suffer from child abuse.

In many instances, school officials and teachers are some of the first people to recognize potentially abusive situations in children's homes. Throughout the pandemic children who would normally go to their teachers or principals for help did not have that secure option away from home.

The general public can

possible signs of child abuse; they may be a hurting child's only advocates. Here are some signs of potential physical and emotional abuse.

Unexplained injuries, such as bruises.

Depression or excessive crying.

Sudden changes in the child's behavior or de-

Poor hygiene and unsuitable clothing.

stant hunger.

Increase in attention-seeking behaviors.

Increased absences from school. Witnessing an adult pinching to inflict pain,

slapping or tripping a Knowledge of an adult withholding sleep, food or

medication from a child. Seeing a child flinch when touched.

A child wearing inappropriate clothing for the season to cover up injuries.

OMESTIC abuse is a serious issue that's more prevalent than people may realize. Data from the Centers for Disease Control and Prevention indicates that nearly 20 people per minute are victims of physical violence by an intimate partner in the United States, and researchers suggest the pandemic contributed to increased instances of do-

mestic violence.

A study from the University of California, Davis released in February 2021 found that 39 percent of the nearly 400 adults surveyed indicated they had experienced violence in their relationships during the COVID-19 pandemic. Researchers noted that the increased social isolation during the pandemic created environments in which victims and aggressors,

or potential aggressors in a relationship, could not easily separate themselves from each other.

Victims of domestic violence often feel helpless against their aggressors, and those feelings might have been exacerbated during the pandemic, when people were urged to stay home as much as possible. But domestic violence victims are not alone. Anyone can help by learning to recognize the warning signs that someone is being abused, and WebMD notes

that such signs include: Excuses for injuries.

Personality changes, like low self-esteem in someone who had previously been a confident individual.

Constantly checking in

with their partner. Never having money on hand.

Overly worried about pleasing their partner.

Skipping out on work, school or social outings for no clear reason.

Wearing clothes that don't align with the season, such as long sleeve shirts in summer to cover bruises.

Concerned individuals also can learn to spot the warning signs of an abuser. According to the National Coalition Against Domestic Violence, abusers come from all groups, cultures, religions, and economic backgrounds. In fact, the NCADV notes that one study found that nine out of 10 abusers had no criminal records and were generally law-abiding outside their homes. That can make it hard to spot abusers, though the NCADV indicates that such men and women may

exhibit certain warning signs, including, but not limited to, the following: Extreme jealousy.

Possessiveness. Unpredictability.

A bad temper. Cruelty to animals. Verbal abuse.

Extremely controlling behavior.

Antiquated beliefs about gender roles within relationships. Forced sex or disregard

of their partner's unwillingness to have sex. Sabotage of birth control

methods or refusal to honor agreed upon methods. Blaming victims for

anything bad that happens. Sabotage or obstruction of the victim's ability to

work or attend school. Controls all the finances. Abuse of other family members, children or pets.

Accusations of the victim flirting with others or having an affair.

Control of what their victim wears and how the victim acts.

Demeaning the victim, either privately or publicly. Embarrassment or hu-

miliation of the victim in front of others.

Harassment of the victim at work.

Instances of domestic abuse have been on the rise since the onset of the pandemic.



Lyle Fredrick 'Dutch' Kunde PRESCOTT, Ariz. love for his family, Lyle

Lyle Fredrick "Dutch" Kunde was born April 21, 1925 in Rochelle, the son of Lela (Parker) and Herman H. Kunde. After a full life of 97 years, Lyle departed this earth on Sept. 27 for new adventures in Heaven above.

Lyle attended Rochelle elementary schools and graduated in 1943 from Rochelle Township High School (RTHS). Immediately he enlisted in the Naval Air Corps Pilot Training Program, during World War II, flying an SNJ Stearman aircraft. Following his military service, he enrolled at the University of Arizona (UofA), graduating with the class of 1948 with a degree in business.

On Feb. 18, 1951, Lyle married Lois Lenore Gilbert at the United Methodist Church of Rochelle. They had two children: Karen and Kim. They were married for 54 years.

Lyle enjoyed several careers before finding his life's calling serving for 13 years as director and three years as Ccommissioner of the Flagg-Rochelle Community Park District, from which he retired in 1992. Then, for seven years, he was employed as a parttime field representative for the Flagg Township Assessor's Office. In 2011, he moved to Prescott, Arizona to be near his daughter Karen and son-in-law Gary Weinreich.

In addition to a devoted

loved sports! It began in grade school, climbing out of the window to play football with friends instead of practicing his trombone! His RTHS sports included playing football, basketball, baseball and tennis. He earned honors in each, including the coveted Hackett Trophy. During his enlistment in

the Navy and his time at the University of Arizona, Lyle excelled at his team sports, as well as, tennis and boxing. While attending the UofA, he was a member of the Phi Gamma Delta fraternity. Lyle participated in the

City of Rochelle Men's Sports, bowling, and in later years, he enjoyed golf with other duffers. He was instrumental in starting and coaching Little League in Rochelle.

From 1948 to 1978, his was the voice announcing RTHS football games, and for several years, he announced the basketball games and kept score.

Bearrows thanked Roe's family for allowing him to be so involved in the community. Sen. Roe passed away in November 2020 at the age of 78.

"I knew Jack as a friend," Bearrows said. "He had the uncanny ability to seem to always be able to settle things down. He'd always give you a little piece of advice. We're blessed to have had the time we had with Jack. Each and every one of us here today benefitted from Jack's presence."

Roe was a lawyer and public defender in Ogle County and was elected the youngest state's attorney in Illinois in 1968. He was elected state senator of the 35th district of Illinois in 1972 and was the first freshman senator

to be appointed to the committee of committees. He also served on the legislative investigative commission.

He was appointed chief justice of the Illinois court of claims in 1979. He was a member of the Rochelle Grade School Board of Directors of District 230 from 1982-1984. He practiced law in Rochelle from 1973-1995. He was appointed circuit judge in 1995 by the Illinois Supreme Court and was elected as a circuit judge in 1996. He retired as a judge in 2000.

"It's not just an overpass," Demmer said. "It's an overpass we're dedicating to a person who served his community in a variety of capacities over many years. The overpass is not the only legacy that he left."

Following speeches by Bearrows, Demmer and Stewart, the Roe family was presented with House Joint Resolution 57. Demmer called it "a privilege" to offer the resolution and said he's glad to know Roe's contributions over this many years of service will forever be a part of the state's official record.

Stewart remarked at how the resolution was introduced, passed and carried out within a year. He believes he knows why that happened so fast.

"I think it was Jack's legacy that caused this resolution to be passed so quickly," Stewart said. "Springfield doesn't often do things this fast. There are resolutions that have been pending in Springfield for years on overpasses and roads and bridges. I'd like to

As I have written before, my wife and I are not only dog lovers, but work with an area rescue to support saving bully-breed dogs. These dogs are over-bred and are clogging shelters. Many are dumped and left

In May, our adopted boy Mr. Pibb died after a series of seizures. He was a senior dog who had suffered incredible abuse earlier in his life, but he was such a goofy, sweet and loving boy. We were crushed, as was our girl dog Dyna, who missed playing with Mr. Pibb and snuggling on the couch with him.

Later that same month the rescue put out a call that fosters were needed immediately for a couple of dogs that were on the list to be put down. So, although still grieving our sweet boy, we said we were available. That is how Fozzy came

We had Mr. Pibb for a very short year and a half. Before him, we had a 10-year-old named Mac we only had for about two years before he too died. But these older dogs

need a calm, loving home too. And we are glad to provide it. Yes, they can be more expensive with vet visits and can bring some strange behaviors with them. But we love them and are dedicated to making sure the last few years of their lives are the best years. So, in comes Able. Able

is an American Bully, which is an actual breed. He is a little boy with a giant head and a personality to match. He is eight years old and was rescued in Chicago.

After fostering Fozzy for a few months, we were ready for another full-time family member. Understand, we loved and love Fozzy with all our hearts. He is such a wonderful,

good boy. But Able needed a home, and as senior adopters, we knew we were ready to bring him into our family.

Fozzy is now with another foster in Chicago, who absolutely loves him. We are sure Fozzy will find his

Examples of the goals include, but are not limited to, finalizing intergovernmental agreements with IDOT, Lee/Ogle Counties and other public/private

entities, continuing fostering more community engagement, developing a customer service training program for all employees, continuing to invest in employee education and development, diversifying commercial retail throughout the city, developing new public/private partnerships, expanding inclusivity initiatives and

improving and maintaining infrastructure including flood prone areas. An additional

project the council led during their community workshop was an SWOC (strengths, weaknesses, op-

portunities and challenges) exercise. Performing this assessment helped guide the overall conversation and led to the formulation of the goals. In my opinion, the most important function of the new plan is to expand upon our strengths, to ensure challenges are met and addressed, to turn weak-

nesses into opportunities and to turn opportunities into strengths.

Finally, it is important to remember that our organization's most important asset is our team members. Our elected officials continue to show their commitment to our staff by reinvesting in their success. Their success leads to a better organizational culture, which supports successful core service delivery.





Pitfalls to avoid falling into debt

IGH consumer debt can compromise individuals' financial futures and have an adverse effect on their overall health. Debt has long been an issue that threatens individuals' well-being, but the good news is that certain debts seem to be on the decline.

According to the "Quarterly Report on Household Debt and Credit" that was released in May 2021 by the Federal Reserve Bank of New York, credit card balances were \$157 billion lower by the end of the first quarter of 2021 than they had been at the end of 2019. 

As enticing as such savings can be, consumers should recognize that a recent study by CreditCards. com found that the average retail credit card APR is 25.9 percent. That's more than 6 percent higher than a general purpose credit card. Consumers who cannot pay balances in full each month could end up paying much more in interest if they use retail credit cards instead of general purpose cards. Too many accounts:

A 2019 study from the

credit reporting agency Experian found that the average American has four credit cards. Though many consumers can effectively manage that many cards, the more cards an individual has, the easier it can be to lose track of spending. More cards also means a greater potential for more debt, as each card has its own limit that is unrelated to the limits on other cards.

Bonus hunting: Another pitfall to avoid is the temptation to use credit cards instead of cash in an effort to accumulate more travel miles or cash back bonuses. Consumers should aspire to use cash over credit whenever possible. Doing so ensures consumers are not spending money they don't have, which is one of the most common ways that individuals build significant consumer debt.

Failure to budget: A



budget is the most effective way for individuals to gain control of their spending. That lesson seems to resonate more with young people than older men and women. A 2019 poll from Debt.com found that 74 percent of consumers be-

tween the ages of 23 and 38 use a budget to govern their spending, while only 67 percent of consumers between the ages of 39 and 54 use a budget. A failure to budget can increase the risk of spending impulsively and make it hard for consumers to see what's coming in and what's going out. That's a recipe for accumulating debt.

Avoiding certain pitfalls can help consumers avoid accumulating debt that can adversely affect their financial futures.

Ohlinger earns Interstate 8 First Team recognition

MENDOTA — Rochelle senior Griffin Ohlinger entered Monday's Interstate 8 Conference Championship at Mendota Golf Club having earned All-Conference Honorable Mentions over each of his last two seasons. While Ohlinger admitted his season fell short of his goals, his efforts throughout the fall allowed him to secure First-Team All-Conference honors for the

Ohlinger fired a team-low round of 91 to lead the Hubs, who finished seventh out of eight schools in the Interstate 8 Conference at Mendota Golf Club with a 384 team score. Freshman Ian Metzger followed with a 95, while senior David Wanner carded a 96 and senior Damen Harrington rounded out the top four varsity scorers with a 102. "It meant a lot to make All-Conference this season after barely missing it last

Ohlinger took seventh with 100 points in the final Interstate 8 Conference standings to earn First-Team All-Conference recognition for the season. The Hub senior averaged a nine-hole score of 41.3, shooting low rounds of 39 against Kaneland, Plano and LaSalle-Peru. Metzger earned 64 points with an average score of 44.3 in the conference, while Wanner totaled 62 points with an average score of 45. Harrington recorded 57 points with an average

score of 46. "I'd describe my golf experience with the team as a blast," Ohlinger said. "I created many memories that will last a while. I enjoyed the practices the most because there was always a good vibe around practice and everyone was out there having fun and enjoying themselves."




KINGSTON — Rochelle senior Thomas Koziol always looks forward to competing at the Genoa-Kingston Matt Walter Invitational. Running one of his favorite 3-mile courses, Koziol turned in his fastest time of the season on Tuesday, when the Rochelle Hub varsity cross country team earned a fourth-place trophy finish while two Lady Hubrunners medaled.


