Council OKs ordinance dealing with solar farms

MENDOTA - The Mendota City Council approved an ordinance concerning solar farms at its July 18 regular meeting.

Alderman John Hessenberger presented the Plan Commission results from its July 11 meeting pertaining to text amendments to solar farm requirements. Per the recommendation of the Plan Commission, the council approved the ordinance. The ordinance amends the text of Articles IV, VII and XII of the zoning chapter of the Mendota Municipal Code to allow solar farms as a permitted use in Conservation-Recreation Districts



In other action from Hessenberger's report, it was learned the Zoning Board of Appeals will meet at 5:30 p.m. Monday, Aug. 8 to discuss a setback variance request from Beck's BP on 13th Avenue. Beck's is asking for a setback variance on the south side of the lot from 40

feet to 20 feet.

Alderman Jim Fitzpatrick informed the council of a request from the Ballet Folklorico De Colores group to use Strouss Park to hold a fundraiser for the academy on Tuesday, Aug. 23 at 4 p.m. The council approved

ComEd to pay millions back to its customers

☐ Company to issue monthly checks

CHICAGO- ComEd customers will start seeing monthly checks from the utility company as they are required to pay back \$434 million over the next three years.

The payments come from excess deferred income taxes collected by the company as a result of the Tax Cuts and Jobs Act of 2017. The plan comes after the Illinois

Commerce Commission approved nearly \$485 million in tax refunds to the state's electric customers beginning in 2023.

Abe Scarr of the Illinois Public Interest Research Group, or PIRG, explained the payment process to The Center Square.



'The checks will be around \$3 a month for the next three years," Scarr said. "So it's not incredibly significant, but it will hopefully balance out a little bit of this pending [utility] rate increase."

The proposed rate hike would raise average bills by \$2.20 a month, but ComEd added that offsets and other decreases due to a reduction in energy capacity costs would result in lower bills by next year.

Around \$65 million will be distributed by the utility in 2023 with between \$195 million and \$282 million in 2024. The remaining amount will be paid out in 2025, according to ComEd spokesman David O'Dowd, as reported by the Chicago Tribune.

Scarr said the original plan was to pay out customers over the next few decades.

"It has always been our money, and they've always needed to return it," Scarr said. "A couple of years ago, they convinced regulators to give them 39 years to repay it, and a law was passed last year that said they have until 2025.'

In 2016, the utility's parent company, Exelon, secured large subsidies from the General Assembly for two of its nuclear power plants. In 2020, ComEd admitted wrongdoing in a deferred prosecution agreement with federal investigators and paid a \$200 million fine after admitting it gave jobs and contracts to allies of then-House Speaker Michael Madigan in exchange for favorable legislation.

Scarr worries that this could be a public relations move by Commonwealth Edison.

"I do have some worries that ComEd is using these refunds, which is the customer's money to begin with, to clean up previous issues," Scarr said.

Pritzker pushes for assault weapons ban, federal action

☐ Bill pending in General Assembly would prohibit further sales

the wake of a July 4 mass shooting in Highland Park that left seven people dead and dozens more injured, Gov. JB Pritzker is calling for a ban at both the state and national levels on military-style assault rifles and high-capacity magazines.

The governor made those calls on national cable television and at the White House in recent days.

"While I support an assault weapon and high-capacity magazine ban at the state level, we urgently need federal regulation on the weapons of war and high-capacity magazines that are used only for mass murder," Pritzker said in a statement released last week. "Illinois is not an island, and even with some of the strictest gun laws in the nation, our state is

only as safe as the state with the weakest laws — many of which border Illinois."

The weapon used in the Highland Park shooting has been identified as a Smith and Wesson M&P 15, a semi-automatic rifle that holds 30-round magazines of 5.56mm ammunition.

The alleged shooter, Robert Crimo III, reportedly used three such magazines during his attack on a Fourth of July parade, firing off more than 80 shots in a matter of just a few minutes.



Illinois officials remind residents to use caution when recreating in Illinois waters

SPRINGFIELD - As temperatures begin to rise, the Illinois Environmental Protection Agency (Illinois EPA) and Illinois Department of Public Health (Illinois DPH) are reminding recreators to use caution in Illinois waterways this summer when harmful algal (cyanobacteria) blooms are possible. Cyanobacteria, also known as blue-green algae, are microscopic organisms that naturally occur in lakes, streams, and ponds. Rapid and expansive growth of cyanobacteria is referred to as a "bloom." While most blooms are harmless, some produce toxic chemicals that can cause sickness or other health effects in exposed people and pets.

When a bloom producing toxins has been confirmed, local officials are advised to post appropriate signage to warn residents to avoid

Therefore, residents are advised to avoid contact with water that:


- looks like spilled, green or blue-green paint;
- has surface scums, mats,
- · has a blue or green crust at the shoreline;
- is discolored or has green-colored streaks; or

 has greenish globs suspended in the water below the surface.

Residents or local officials who suspect a cyanobacteria bloom may report the bloom to the Illinois EPA, which recently released a new Bloom Report Form Application accessible on computer or phone. The App and other reporting methods are available on the Illinois EPA website at https://www2.illinois.gov/ epa/topics/water-quality/ monitoring/algal-bloom/ Pages/reporting.aspx.

are most at risk to adverse health effects attributable to algal toxins. Individuals are most often exposed to algal toxins while swimming or participating in other recreational activities in and on the water. The most common routes of exposure are direct skin contact, ingestion of contaminated water, or inhalation of water droplets in the air (e.g., while water skiing or tubing). Symptoms of exposure to algal toxins include rashes, hives, diarrhea, vomiting, coughing, or wheezing. More severe symptoms may result from longer or greater amounts of exposure. If you are concerned you have symptoms that are a result of exposure to algal toxins, contact your health care provider or call the Illinois Poison Center at 1-800-222-1222.

Residents are also advised to keep pets out of water that may contain cyanobacteria. Do not allow pets to drink from the

camping, picnicking, biking, and hiking are not affected. With all activities, wash your hands with soap and water before eating if you have had contact with lake water or shore debris.

PERU - Following an abbatial election on July 13, a new abbot has been elected to serve the Saint Bede community.

Abbot Michael Calhoun, OSB is the ninth abbot of St. Bede Abbey.

"I feel humbled and honored to serve the St. Bede community as its Abbot. I pray for God's grace to strengthen me and ask for the entire St. Bede community to remember me in their prayers," Calhoun said.

He succeeds Abbot Philip Davey, OSB whose term expired on his 75th birthday on April 3, 2022.


Since then, Davey has been serving as interim abbot until the abbatial election could be held this July. Davey has successfully completed an 11-year term.

A Benedictine abbot is elected by the members of the monastic community. A six-month period of prayerful reflection began the process of discernment for a successor prior to the election proceedings on the morning of July 13. Nomination of candidates then took place by secret ballot followed by a discussion of each candidate one by one. The election itself took place under the supervision of Rt. Rev. Jonathan Licari, OSB, President of the American-Cassinese Congregation of Benedictines.

Abbot Michael is the son of Mr. & Mrs. Michael (Linda) Calhoun of Blue Springs, Miss. He is a 1989 graduate of St. Bede Academy. He was professed on Dec. 8, 1994, and was ordained to the priesthood on June 1, 2002. Abbot Michael holds a

Master of Arts degree in Scripture from St. Vincent Seminary, Latrobe, Pa., and a Master of Arts Degree in Monastic Studies from the School of Theology, St. John's University, Collegeville, Minn.

Beginning in 1995, Abbot Michael served as a faculty member of St. Bede Academy teaching religion during the years he was not furthering his graduate







White: Look out for scams involving emails and texts

SPRINGFIELD - Secretary of State Jesse White is reminding residents to be on alert for scams claiming to be from the Secretary of State's office or from "Illinois DMV" seeking personal information to defraud Illinoisans. White said there is a new round of fraudsters' attempts to entice the public into falling victim to scam texts and emails.

"I have zero tolerance for scammers who prey on people in desperate times," said White. "My office is committed to protecting Illinoisans from falling victim to these fraudulent schemes." The most recent scam is a

text message claiming to be from "Illinois DMV." The text message states, "Due to increased fuel prices, State of Illinois has initiated rebate payments of \$1500 per vehicle. Check eligibility." This is a scam; do not click on the link. Visiting these fraudu-

lent websites could place malware on the recipients' devices or trick them into disclosing sensitive personal information. The Secretary of State's office never requests personal information, like a Social Security number, via email or text message.

"Delete the text or email," said White. "Do not click on these texts or emails and do not provide any of your personal information to these fraudsters.'

White encourages people to take steps to protect their personal information: · Delete emails and texts that promise or offer

access to driver's licenses or

- state ID cards. Do not click on any links contained in such emails or text messages, as they may place malware on · Hang up on any calls, including robocalls, that ask individuals to take immediate action or provide
- personally identifiable information, such as a Social Security number or bank account number. · Keep software up to date, including phone and computer operating systems and antivirus protection programs. Most phones, computers and antivirus software

can be set to update automat-

ically when new software

versions are released. White encourages the public to provide screenshots of fraudulent emails or texts by submitting them to ScamAlert@ilsos.gov. Individuals who have clicked on a link, have provided personal information or believe they have been a victim of identity theft, should call the Illinois Attorney General's Identity Theft Hotline at 866-999-5630.



Although the letters "M&P" stand for "Military & Police," it and others like it have been widely available to civilians at sporting goods stores throughout the country.

The weapon used in Highland Park is also similar to guns used in other recent mass shootings, including the May 24 shooting at an elementary school in Uvalde, Texas, that left 19 children and two teachers dead, and the May 14 shooting at a Buffalo, N.Y., grocery store that killed 10 people.

All those weapons are modeled after the Colt AR-15, a semi-automatic version of a rifle originally designed for the military.

Pritzker and Highland Park Mayor Nancy Rotering were recently at the White House for an event with President Joe Biden marking the recent signing of the Safer Communities Act, the first significant federal law addressing gun violence in nearly 30 years.

"We had a number of conversations immediately after the attack in Highland Park and I've been impressed with the way they've handled things. It's been extraordinary," Biden said. "And as the three of us have discussed, we have more to do.''

Later in the day, Pritzker appeared on CNN's "State of the Union," and he repeated his call for additional measures to control gun violence.

"I think that there are probably three things that need to be looked at here: One is changing some of the verbiage in the law on red flags so that something could have been filed that would have prevented the FOID card from being issued. That's one," he said. 'Two is that we need to ban assault weapons, not just in the state of Illinois, but nationally. And then third, high-capacity magazines."

Authorities investigating woman's death

MENDOTA - The cause of death of a 30-year-old Mendota woman is under investigation. Kelsey J. Zoss, 1218 Jefferson St., was pronounced dead at the scene after Mendota EMS and police units responded to her residence at 4 a.m. July 13.

Emergency personnel responded to the Jefferson Street address in regard to an unresponsive female. Upon arrival, officers and EMS personnel attempted life-saving measures, however, the victim did not regain consciousness and was pronounced dead.

Following the EMS and police response to the residence, Mendota Police obtained a LaSalle County search warrant for the home and executed the warrant shortly thereafter with the assistance of the Illinois State Police Crime Scene Services.

Further investigation into the cause of death is ongoing pending autopsy, toxicology and pathologist findings. The LaSalle County Coroner's Office, the Illinois State Police, the LaSalle County State's Attorney's Office and the Mendota Police Department are working together in the death investigation.

A bill pending in the General Assembly would make it a felony to buy or sell assault-style rifles and high-capacity magazines. House Bill 5522, by Rep. Maura Hirschauer, D-Batavia, would also require existing owners of such weapons to register them with the Illinois State Police, and it would prohibit those owners from selling them in-state to anyone but a federally licensed firearms

Hirschauer, a first-term lawmaker and organizer of a local chapter of Moms Demand Action for Gun Sense in America, introduced the bill in January, but it was never considered in a substantive committee. Since the July 4 mass shooting in Highland Park, however, 50 more lawmakers, all Democrats, have signed on as co-sponsors.

"I think that my colleagues have been moved by the tragedy in Highland Park, but also moved by the gun violence that affects the entire state, and constituents all over Illinois have been reaching out to their state representatives and state senators, telling them how important this bill is," Hirschauer said.

Gun rights advocates, on the other hand, argue that eliminating one type of gun from society will not address the underlying causes of gun

"We certainly understand the emotional response of anti-gun politicians in light of the evil and violence the $world\,witnessed\,in\,Highland$ Park ... just like the equivalent of 47 Highland Park

shootings that have taken place in the city of Chicago year to date," Richard Pearson, director of the Illinois State Rifle Association, said in an email. "Evil and violence do not lie in an inanimate object but in the hearts of people. At some point politicians must tackle the "Why" of violence instead of the easy way out by trying to ban inanimate objects."

Lawmakers had planned to convene a special session this summer, primarily to respond to the U.S. Supreme Court's decision striking down a constitutional right to abortion. Before the Highland Park shooting, however, those plans were put on hold and no special session has yet been scheduled.

Republican gubernatorial candidate Darren Bailey also called for a special session to repeal a criminal justice reform bill passed in January 2021 and convene a mental health task force consisting of "doctors, first responders, patients, home caregivers, parents, teachers, and churches." The Pritzker campaign,

in turn, blasted Bailey for voting against gun safety bills and state budgets that increased mental health The next scheduled meet-

ing of the General Assembly is Nov. 15 when the regular fall veto session convenes.

States embracing tax cuts, but Congress headed in wrong direction

Nearly all Americans have felt the impact of "stimulus" spending signed into law by Presidents Donald Trump and Joe Biden. Inflation has topped 8 percent and prices for everything from food to gas to timber for home construction has soared through the roof. For all the financial turmoil inflicted on U.S. households, federal and state policymakers are making extraordinarily poor use of this newly printed money...for the most part. Fortunately, some governors and state lawmakers have decided to give these dollars back to the American people in the form of tax relief. More politicians should learn from their example, while making sure that spending is kept under control.

According to a July 5 report from The Washington Post, elected officials (primarily in red states) are using federal relief funds to cut a variety of taxes. For example, Florida Gov. Ron DeSantis (R) used these dollars to pause the state's fuel taxes and deliver \$200 million in relief to Floridians. Mississippi lawmakers signed onto a plan to lower top state income tax rates to 4 percent from 5 percent, while Georgia is set to flatten its brackets and reduce rates from 5.75 percent to 4.99 percent. Even blue states have been getting in on the action. Illinois has enacted a property tax rebate of \$300 per homeowner and New Jersey is pioneering an ambitious \$2 billion property tax relief program. Policymakers have been especially sensitive to their constituents' concerns about spiking grocery prices. Illinois, Kansas, and Tennessee are leading the charge to roll back grocery taxes.

State and local tax cuts spurred by federal funds have proven controversial because the American Rescue Plan Act (ARPA) bars states from, "directly or indirectly offset[ting]a reduction in net tax revenue" using Fiscal Recovery Funds. However, federal courts have found that this language impermissibly coerces states by denying them their fiscal autonomy and goes far beyond normal "strings attached" to federal spending packages. In addition, Congress failed to clarify the meaning of an "indirect offset," a troublingly vague phrase with disturbing implications. Under a broad reading of that text, a state or local tax cut enacted three years post-ARPA could be struck down because ARPA funds indirectly freed up long-run funds for tax cuts. The legal fight over the language in ARPA is far from over, but for the time being, states seemingly have a free hand to cut taxes as they wish.

And that's a good thing, because tax cuts are linked with bolstered growth and prosperity over the long term. According to a comprehensive 2022 review of the evidence by the Tax Foundation, "research almost invariably shows a negative relationship between income tax rates and gross domestic product (GDP)." Reduced rates do far more than make the country's economic accounting look rosier. Flattening tax brackets and lowering rates is linked to higher real wages and an increased, "likelihood of an employed head of household obtaining a better

job within a year..." Because of this strong link between tax cuts and

growth, policymakers should be especially wary about reckless spending on the federal level as a way to "help" people. Persistently high deficits will eventually require higher federal taxes, effectively cancelling out tax cuts at the state and local level. Congress can avoid this scenario by signing onto a sustainable deficit reduction program that zeroes out unneeded spending such as the wasteful F-35 program and out-of-control farm subsidies. Americans can reap the reward of lower taxes at all levels of government, but only if lawmakers embrace fiscal responsibility.

School boards wrestle with finances – 1986

(The following is from Jessica Nashold's Backtracks & Sidetracks column reprinted from July 17, 1996.) **By Jessica Nashold**

Ten years ago the high school board of education received the bad news that there had been a \$2 million drop in valuation for District 280. In consequence, the Working Cash Fund bond would be dropped from \$830,000 to \$800,000.

Athletic director Paul Kimrey's new training rules were adopted. Use of possession of alcohol and illegal drugs after an organized team began practice would mean removal from the team "for the duration." Each student athlete would be required to sign a paper indicating knowledge of and agreement to the rules.

The west bleachers were going to be moved 12 feet further away from the football field and placed on a concrete

The work will be done before the first home football game.

The grade school board was also dealing with financial problems. A budget with a \$300,000 deficit was approved, that amount to be borrowed from the Working Cash Fund.

Interest earned by the Transportation Fund (\$6,000) and the Working Cash Fund (\$10,000) was transferred to the Building Fund. These transfers were allowable if the recipient fund demonstrated "most need." The "need" was the result of a new boiler at Lincoln School and roof work at Blackstone.

The board also requested the Illinois Association of School Boards to review its policy manual and explain any recommended changes they might come up with. Grade school board president Mike Worman expressed an opinion -

There is a lot in our policy that shouldn't be there.

The Mendota Fire Department was able to repay loans from the First State Bank and National Bank of Mendota one year early. The loans had been taken out to purchase a heavy duty rescue van. Sale of the old rescue van, profit from the Firemen's dance for four years, plus other fundraisers and donations from individuals and service clubs made the early payment possible.

Backtracks Sidetracks

Mayor James Troupis appointed three new members to the library board Harry D. Conkey, Ken Kurth and Ed May. A letter from Watson Bartlett was read stating his term had expired on April 30, but the mayor had appointed him to replace retiring board member, Lois Moore. He had not accepted, he wrote, and after 48 years of service on the board, wished to step down.

A levy increase from \$35,990 to \$55,466 was approved. The new library director, Susan Ginocchio, had a degree in library science, accounting for an elevated salary requirement.

This action was taken to bring the library up to state standards.

Also, costs of running the library had increased.

President Louis Elsesser said that since the board had voted not to move to the civic center, it was now committed to improving the present library building. He added -

If the library had moved to the new civic center it would have had to ask for \$75,000 to pay rent there, plus an amount to keep up standards.

For the good of the country, Biden shouldn't run again

Perhaps the best decision Joe Biden could make as president is to stand down.

It would be a welcome act of statesmanship and self-awareness if the 79-year-old president dropped the insistence that he's running for a second term, and instead announced some-

time after the November midterms that he isn't running again. He was too old to run in 2020 but made his way into the office he had coveted for decades by default.

In two and a half years, Biden won't be any younger and the chances of something going catastrophically wrong only increase with time.

The country's experience with a 78- and 79-year-old president hasn't been pretty. Just wait until Biden is 82 (at the time of his theoretical second inauguration), or 84 (after the second midterms), or 86 (at the end of his second term).

A New York Times report confirms about what you'd expect of White House aides. They fear that Biden, who increasingly shuffles when he walks, will trip over a wire. They hold their breath hoping he can get to the end of remarks without making a gaffe. They generally don't have events for him at night and try to keep the weekends free.

In an office that requires vigor and forcefulness, he's mumbly and bleached out. In a position that makes young men suddenly look much older, he's already quite aged. In a job where words matter, he can't keep his straight.

Yes, there have been elderly leaders of nations who have been unquestioned giants -- Konrad Adenauer, Charles de Gaulle, Ariel Sharon. No one is mistaking Biden for a statesman of such caliber, though. He's more like President Jimmy Carter with a quarter century more on the odometer.

Even if in the unlikely event Biden's age isn't affecting how he can do his job now, it will at some point.

Then, there are the disaster scenarios. We should all hope that Biden lives to be a 100 but were he to die in office of natural causes, it would be a significant national trauma. We

haven't had a president die in office in half a century and it would create comparisons to the gerontocracy of the late

If anyone thinks American politics is poisonous now, just wait until there's an unelected president (the vice president would succeed Biden in this scenario) and an unelected vice president appointed by the unelected president. All this would be the process set out by the 25th Amendment; it would

generate legitimacy concerns all the same.

If a health event prevented Biden from performing his duties, meanwhile, it would create a crisis at the top of our government. The natural tendency of politicians and their loyalists is to be less than forthcoming about health problems. What Edith Wilson did when Woodrow Wilson had an incapacitating stroke -- hide it as much as possible and carry on regardless -- wouldn't be possible in the current media age. That doesn't mean there'd be transparency.

The process for sidelining a debilitated president under the 25th Amendment is a mess, especially if the president doesn't think he's incapable of discharging his duties -- such a scenario would make an impeachment look neat and clean by comparison.

Perhaps none of this would ever come to pass and a re-elected Biden would make it to the finish line with ease, proving that 85 is the new 75. It's also true that anything could happen to anyone of any age -- even a 45-year-old president could fall ill. But the longer Biden serves, the higher the risks.

And for what? Biden isn't uniquely gifted, ideologically compelling, irresistibly likable, or very good at being president. His claim to be the only Democrat who can beat Donald Trump in 2024 looks more attenuated by the day. In short, there's no good reason for Biden not to make





Unemployment claims reaching record lows, Illinois labor market strengthening

SPRINGFIELD—The Illinois Department of Employment Security (IDES) announced the state has reached a new historic low of continued claims for regular state unemployment insurance benefits since the beginning of the series in January 1987.

In particular, job growth in the non-durable goods manufacturing, transportation and warehousing, professional and technical services, and business services have exceeded pre-pandemic levels. In addition to providing unemployment

insurance benefits to eligible individuals who have lost work through no fault of their own, IDES provides a robust number of training and employment services to jobseekers and employers to help individuals find the next step in their careers. These services include resume and interview skill building workshops, virtual and in-person job and hiring fairs, and workforce training opportunities.

In 2020, working with IDES and the Illinois Department of Commerce and Economic Opportunity (DCEO), Governor Pritzker launched Get Hired Illinois, a one-stop-shop website to help connect job seekers with hiring employers in real time. The site features virtual job fairs, no-cost virtual training, and includes Illinois JobLink.com (IJL), the state's largest job search engine. There are currently more than 162,000 jobs posted on IJL from registered employers.



Sublette Board discusses railing repair/replacement

SUBLETTE — On the agenda for the Sublette Village Board meeting was the approval of repairing/replacing the railing and the concrete on Main Street. But after some discussion, mostly on the large cost of the project, the matter was turned back over to committee to review.

The Board met July 11 at the Ellice Dinges Center. Sublette Village President John Stenzel was absent. Sublette Village Trustee Julie Kessel ran the meeting in Stenzel's absence.

Sublette Village Trustee Robert Bulfer presented the board with estimates he received for repairing/ replacing the railing and the concrete on Main Street. Bulfer said one bid came in at \$104,000 and that was to replace the railing and square posts with stainless steel. Another bid for \$64,000 was to take down broken railing and put new railing up. A bid to do the cement patching, cleaning up the cracks, drill and add rebar came in around \$9,200. Sublette Village Trustee Jeff Myers

said that that was a lot of money, and that the village doesn't know what's coming down the pike for the future.

Kessel recommended returning the matter back over to committee because it was a lot of money for the village to commit to. "I admit it's a lot of money," Bulfer

said. "But if someone leans on the railing and it falls over, that's going to be a lot of money too.' Sublette Village Trustee Larry Ellis

said the village it still looking into how much it's going to cost to repair/replace the roof at the Ellice Dinges Center.

Myers recommended finding out how much of the railing needed to be fixed before the committee meeting.

In other board news:

 Don Dinges told the board that the upcoming one-day tractor drive will be held on Wednesday, Aug. 3. He said they have a wagon with seats for people to ride on furnished by Green River Oaks Camping. Other upcoming events include Hops and Harmony on Sept. 3, Pullin in the Park on Sept. 11, and the car show on Sept. 17. Dinges said they are looking to reschedule a cruise night because the event in May was rained out. He said they are still looking at dates for a night for Sip and Stroll and Drive Your Truck to Town.

Dinges also reported that the state of Illinois is looking into placing a historical marker in Sublette in honor of Dr. Angear and the Twilight Sleep Hospital.

- The board sent the matter of updating the bathrooms and fixing the roof of the Ellice Dinges Center to committee.
- The board approved the purchase of a new refrigerator for the Ellice Dinges Center in the amount of \$597.
- The board approved the purchase of four tons of cold patch for the ruts by the park dumpster. • Kessel said that Stenzel left a note
- asking the board to consider a water rate increase. The last increase was approved on Aug. 9, 2010 at \$4.80 per 1,000 gallons. The next Sublette Village Board

MENDOTA - Erik Van Loon, a Netherlands native, had been to San Francisco before but he wanted to see more of the United States of

Turning 50 in 2021, he thought another trip to the states would be a great birthday present. But then he decided he wanted to party. But not any old birthday

He wanted it in a train and involving poetry.

"It was a dream for me as a child to travel east to west New York to California. I had been in San Francisco before for a film I made," said Van Loon, who is an artist and owns a bookstore in the Netherlands called The House of Craziness. "I decided not to go to San Francisco again because I wanted to go to other places, so I went to Los Angeles.

"I turned 50 years old last year and I wanted to celebrate my birthday with my dream of traveling the United States from the east to the west coast on a train. Every city that I had to stop at, I decided to do something nice. I threw my own party to try to find Americans who wanted to party.

"I tried to find as many poets as possible during my trip. I asked at every train stop, wrote on social media, and asked in person if anyone wanted to join. The party ended up with 12 poets. They wrote me a poem last year. I invited eight of them to the L.A. Poetry Festival and two of them came."

Van Loon is now embarking on a second voyage as he has decided he wants to meet new people and help others network. To him it was easy, why

not include poetry and make it the L.A. Poetry Train as it will tour from New York to L.A. and stop at 64 different towns and cities across the country including Mendota, Princeton, Chicago, Naperville, and Galesburg in Illinois.

We want to travel and pick up as many poets as possible. We hope to pick up at least one poet at every stop. There are 64 stops on the route. We want to bring 64

poets to L.A. It's a one-way ticket to paradise. I'm not taking the poets back home. They will have to arrange for them to get back home.

"This year, we are going to get an Amtrak train. We have to follow their schedule. Eventually, when we're able to get a train full of poets, we will be able to lease our own train and we'll be able to have the disco car, the library car, and the others. We will also be able to decide how long we spend at each stop."

Van Loon visited the United States in April and drove the route the poetry

From New York to Las Angeles, he drove almost 4,500 miles and stopped at 200 local independent bookstores, 53 of the 64 train stations, and 50 libraries, including the Graves-Hume Public Library.



That's how amazing God's love is! And when you trust His promise of forgiveness, any burden of guilt that you have will be lifted from your shoulders.

Breaking the Habit of Guilt

I had a terrible problem with guilt for many years. I grew up in an angry, unstable, abusive atmosphere, which caused me to become a negative, angry, judgmental adult. As a result, I didn't like

myself or anybody else for that matter, and I often behaved in ways that I regretted later, especially in my relationships.

Through the years, guilt became so ingrained in me that I just didn't feel right if I didn't feel wrong. And I carried those negative feelings with me right into the early years of my ministry. For example, whenever I went to God in prayer, I would automatically focus on twothings—my problems and my mistakes.

I'll never forget the morning God spoke to my heart and said, "Joyce, are you going to spend time with Me today or are you going to keep focusing on your sins?" At that moment, I realized God wasn't mad at me; He loved me. And He was encouraging me to drop the dead weight of my guilt.

God Does Not Expect Perfection

Many people struggle with guilt because they think God expects more of them than what they can deliver. Some people even think He expects perfection, but that couldn't be further from the truth. God's Word says in

Romans 3:23, "All have sinned and fall short of the glory of God." The Bible also says that "where sin increased, grace increased all the more" (Romans 5:20). This verse isn't saying you should live a sloppy life and sin as much as you want; it means when you



fall short of perfection in any area of your life, you will always have another chance to get back up, brush yourself off and try again with God's help. What Does God

Expect from Us?

The apostle Paul explains what God requires of us in Philippians 3:12-14, which says, "Not that I have already obtained all this, or have already arrived at my goal, but I press on to take hold of that for which Christ Jesus took hold of me. Brothers and sisters, I do not consider myself yet to have taken hold of it. But one thing I do: Forgetting what is behind and straining toward what is ahead, I press on toward the goal to win the prize for which God has called me heavenward in Christ Jesus."

God simply expects us to grow, and we can't do that if we're stuck in guilt. In Christ, we can forget about what lies behind us—the things we cannot change—and press on, doing our best in the present moment.

One thing that has helped me get over my guilt trips (which I used to take on a daily basis) is completely useless. They certainly didn't help me behave any better. Actually, all they did was make me act worse.

The truth is the only way to make progress is to let go of what lies behind.

Race at Your Own Pace

We will never be perfect in this life and God knows that. He is full of mercy and He doesn't want you to get up each day and worry about what you did yesterday or what you might do wrong today. God wants you to trust His love for you and receive His forgiveness so you can move forward, completely guilt free.

Jesus said, "...Ask and you will receive, and your joy will be complete" (John 16:24).

When you ask God for His forgiveness, don't just stop there. Take a moment and receive His forgiveness. Say out loud, "God, I receive Your forgiveness. Thank You for giving me a fresh start. Because of what You have done for me, I am filled with joy."

You don't have to waste any more time focusing on your mistakes


and weaknesses. Spend time with God and learn from His Word. And remember, God loves you and He is always cheering you on to victory.


