MENDOTA - When listing the services available at Mendota Area Senior Services (MASS), it's easy to forget a few or run out of room if jotting them down.

However, if MASS doesn't receive some financial help, some of those services may be left off of the list on purpose, cut, or diminished.

"It's gotten really serious. Obviously, COVID-19 took a toll on us because we weren't able to hold a lot of our normal fundraisers like the spaghetti dinner because you couldn't have those groups of people together," said Rayanne Sester, the MASS Executive Director who has been involved with the organization for 29 of its 44 years of operation. "Donations were down, are down, and continue to go down because people are struggling. With the prices of everything rising, they're trying to hold their own.

"Our federal and state funding is part of the problem also. I was just composing an email to one of our legislative offices, so they're aware. With our grants, we're required to spend our own money for all of our expenses first. Then we report them on a monthly basis to be re-reimbursed.

"That's where the problem lies because sometimes, we wait for months to be reimbursed with those monies. We're spending money, and if we're not getting donations or not getting it back from the

federal and state grants...the coffer goes empty. There's no money there."

The grants Sester writes brings in 45 percent of MASS' funding as the grants are overseen by Western Illinois Area Agency Aging, who reports them to the Illinois Department of Aging, and it releases the money.

Sester said the process is slow, but it's almost half of the funding. The rest of the organization's funding comes from the United Way of the Illinois Valley, and fundraisers and donations.

MASS and its Board of Directors are trying to find the best solution without cutting any corners, declining the services offered, or losing hours in the office.

MENDOTA - Life is forever changing, adapting, manipulating time, or consistently throwing challenges.

It's a constant every individual, family, group, organization, state, country, society, or era has endured since the beginning of time.

The Graves-Hume Library in Mendota is welcoming a guest, the Mobile Museum of Tolerance (MMOT), the week of Monday, June 20 through Thursday, June 23 to help empower people of all ages and backgrounds and open eyes to the issues we have faced in our history or in our current lives when it comes to Semitism, bullying, race, hate, and intolerance to promote human dignity.

The MMOT will have its doors open to the community in the library's parking lot from 11 a.m.-4 p.m. on Monday, Wednesday, and Thursday, while Tuesday will be from noon-7 p.m.

'When the bus is here and open, there will always be a person from the museum there. I don't staffit at all," said Graves-Hume Library Director, Emily Kofoid. "I saw the MMOT in a newsletter, so I filled out an application to see if it would come here. They said, 'Sure, great.'

"I don't know what to really expect, but I am super excited. I know racism, bullying, and hate isn't as prevalent here as Chicago or other cities, but

## **It's Not a Game:** IDOT campaign highlights real consequences of unsafe driving

SPRINGFIELD – The Illinois Department of Transportation is launching "It's Not a Game," a multimedia safety campaign that drives home the message there are no extra lives, no respawns and no second chances to get it right when you are behind the wheel. "It's Not a Game" continues the comprehensive approach by IDOT to reduce injuries and fatalities associated with motorcycles, bicycles, pedestrians, seatbelt use, work zones as well as impaired and distracted driving.

"The rising number of traffic fatalities in Illinois and across the country is deeply concerning, especially since almost all of them are preventable," said Illinois Transportation Secretary Omer Osman. "It's Not a Game' is a clever way to reinforce the message that bad choices can cost you your life or someone else's and the only acceptable number of fatalities is zero."

The creative material relies on the appearance of an old-school video game platform to educate drivers that safety is not a game, comes with real consequences and everyone is a winner when "wreck-less" driving is the shared goal.

The campaign is running throughout the year on various media, including digital placement in bars, restaurants and gas stations, social media and online platforms, as well as traditional radio and TV channels. Ads will run in the 23 counties that are home to the majority of the state's population, with ones in Spanish airing in the Chicago market and appearing across social media channels. More information is available at www.itsnotagameillinois. com, where the public can follow the campaign and access additional resources.

An online quiz, itsnotagameillinois.com/roadsafetyquiz, also will inform drivers on safety statistics and provide them with results they can share on social media.

According to provisional data, 1,341 people died on Illinois roads in 2021, the sixth consecutive year of more than 1,000 traffic fatalities in the state, mirroring a national trend in recent years. This year, there have been 448 deaths in Illinois, based on preliminary statistics through May 31.

"It's Nota Game" is made possible by federal traffic safety funds administered by IDOT.

He had three brothers and a sister. He was preceded in death by both parents, Edward and Alicia Bumba, a brother Richard, and his sister Donna.

## Gov. Pritzker designates Dolostone as state rock

CHICAGO — Governor JB Pritzker recently joined legislators, students, and teachers at the Morton Arboretum to designate Dolostone as the official rock of the State of Illinois.

House Bill 4261 began as an initiative led by a group of elementary school students from Pleasantdale Middle School in Burr Ridge and Maplebrook Elementary School in Naperville. After the students discovered that Illinois did not have a state rock, they created a ballot and had students across the state vote for a winner. The chosen rock was Dolostone.

Dolostone, a form of limestone, forms the majority of Illinois's bedrock, establishing a foundation for the state's other natural terrain. Its name comes from its original discovery in the Dolomite Alps

Illinois recognizes several other official symbols of the state, including; state birdthe Northern Red Cardinal, state flower- the violet, state tree- the white oak, and state fish- the bluegill. More officially designated state flora and fauna can be found on the Illinois DNR website.

"Seeing young people use their voices and the democratic process to make change in our state is truly inspiring," said Governor JB Pritzker. "These young leaders have a bright future of organizing and civic engagement that I am excited to watch. They could not have picked a better rock to represent the strength and

stability of Illinois." "Students developed and drove this legislation," said State Senator Laura Ellman (D-Bloomingdale). "It was not only a fantastic learning experience for them, but an opportunity to show others of any age that they have power in Springfield. I encourage Illinoisans to learn more about Dolostone."

"With today's bill signing, we're not only establishing an official state rock with a long history of economic and geological significance to Illinois, we're building the foundation for a new generation of lifelong learners who are civically engaged and ready to contribute to their communities," said State Representative Yang Rohr, (D-Naperville).

Among the students recognized are Amanda Barrett of Mendota, College of Letters and Science, Dean's List, and Ella Massey of Mendota, School of Human Ecology, Dean's Honor List.

Students who achieve at a high level academically are recognized by the dean at the close of each semester. To be eligible for the Dean's List, students must complete a minimum of 12 graded degree credits in that semester. Each university school or college sets its own GPA requirements for students to be eligible to receive the distinction. Most call the honor "dean's list," but some grant the "Dean's Honor List" and "Dean's High Honor List."



it is here. It's definitely here. I remember high school and there was bullying. Bullying also plays into mental health, which is very important. If we don't talk about these things like bullying and Semitism, problems and issues arise because others are unaware. It's a topic we should be talking about instead of saying, 'It happens to someone else because we don't live in Chicago.'

"It happens here, too, just not on a large scale because we don't have the same type of press or attention. It's great that Mendota isn't on Channel 9 News because of a race or bullying matter, but we can't act like it doesn't happen here either.'

Once a visitor steps inside of the MMOT, they will be welcomed like it's an open house as it is a self-guided tour and there will be documentary films about the Holocaust and the Civil Rights Movement.

There will also be a trained facilitator to help guide, educate, and answer any questions.

Alison Pure-Slovin has answered many questions for people behind the scenes or on the MMOT as she is the Director of the Simon Wiesenthal Center (SMC) Midwest Regional Office in Chicago.

The SMC is an International Jewish Human Rights Organization founded more than 40 years ago. The Museum of Tolerance in Los Angeles is one of the first Holocaust museums in the United States and was named after Simon Wiesenthal, who survived five concentration camps, weighed 86 pounds and lost 89 members of his family upon liberation.

"The Mobile Museum of Tolerance, where we got that idea is, the friends of the SWC, our Canadian office has the tour for humanity," said Pure-Slovin, who was born and raised in Chicago and has been the director of the Midwest office since 2012. "It's a bus that goes around Canada teaching and educating students. It's almost 10 years old. It gave us the idea that we needed to do it in the United States. "We built the Mobile Museum of Tolerance using the lessons and the educational aspects from the Museum of Tolerance in Los Angeles. Illinois is the first state to have the mobile museum. Students in Illinois don't have resources to come to the museums that we have in Chicago. That's what makes the MMOT so unique because we're bringing it to the schools. We are in the backyard, or the libraries, or the educational facilities." The MMOT first took to the road in February 2021 and caught steam as it has since made 27 visits (19 schools, four libraries, and four other institutions such as museums) bringing 4,210 visitors on board. "I think this is extraordinarily important because we're having conversations with adults and/or students that are uncomfortable ones that are not necessarily discussed," said Pure-Slovin. "Through the lens of history, we teach through either the Holocaust or Civil Rights, but afterward people start talking about it from their own perspective. "Students have been forthright on the bus and unfortunately we've heard a lot of instances where they feel they've been bullied, body shamed, or can't be honest about their identity. So, we create that safe space for them. "These conversations are so important because we are witnessing so much hate today and we're not necessarily talking about it in a safe environment. These workshops are critical to help students or others understand what bullying is, what it leads to, or how it makes someone feel."

Pure-Slovin said the MMOT hasn't had to do too much marketing as the locations requesting the mobile museum have seen it somewhere else or heard about it through word of mouth.

The MMOT has had to turn down a few requests because it is booked until March 2023 in Chicago, Springfield, and the surrounding suburbs.

Looking at the list of MMOT locations, Mendota is the first rural destination for the museum.

Kofoid is using the mobile museum as an educational instrument, an entertainment option, as well as an aide for the 3rd Tuesday Book Discussion.

The library director selected 'How the Word is Passed: A Reckoning with the History of Slavery<sup>2</sup> written by Clint Smith and published in 2021 for the book club to coincide with the teachings of the MMOT.

"I'm excited to have the book club read something that is out of the norm for them. We usually read fictional novels," Kofoid said. "They don't usually like my choices because I pick topics they wouldn't read on their own. I make them read science fiction, fantasy, and books that are not mainstream so we can have discussions.

"We do have really good discussions about different cultures and different ways of thinking, which this one is going to be huge. The author traveled to different monuments and locations that were places of events during the Civil War. It could be where a slave trade happened. He talks to people that are there during his visits. How do they interpret the history? How

did we turn the facts into what we believe as truths or non-truths of today? What do they think happened? What, as a society, do we not talk about that we should?"

Jane Rabel, who has lived in Mendota since birth and graduated from Mendota High School in 1953, joined the book club when Kofoid started it in 2018 and is thankful for the unique, different, challenging books she has read.

Rabel mentioned the books are sometimes about different cultures, generations, or situations she isn't familiar with. The avid reader may not like every book or agree with the author's perspective, but Rabel feels she does need to know about the subjects and what is going on in the world, and how it's changing our society.

"Although, I'm somewhat familiar with some of these stories, there is a lot in the book that I was not familiar with," Rabel said. "Mendota has always been a white community with one black family. The issues in the book have never touched my life.

"I am so concerned with the way our nation is currently so divided. The way we thought African Americans were inferior to us during slavery and Civil Rights they're not inferior, they're people just like everyone else is – and we're starting to do that again whether it's the Jewish or Asian-Americans.

"It's wrong. If we want to survive, we better change our attitudes and forget that some of us have different colored skin. I think we just have to learn how to get along with each other. We're all people and I don't care if they were raised differently, we are all equal."

"I have one board member who says, 'We need to close.' That's not the solution. Plus, we can't really do that because we signed a contract to provide services," Sester said. "Obviously, if it gets to the point where I can't pay the staff - my main priority along with paying the taxes and keeping the vans going – we'll have to make some cuts

"We're trying to cut expenses everywhere we can. I talked to my staff this week and told them what was happening. I pretty much carry everything on my shoulders, but I felt the staff deserved to be told since it will be out in public. I said, 'This is where we're at and MASS is broke. If we don't start generating cash flow back in here, we're going to have to start cutting services and possibly hours.'

MASS employs 10 people with three of them being full-time and seven of them part-time.

Sester is joined regularly by Jill Hartley, Information and Assistance Specialist, and Laurie Moore, Outreach Specialist, who assist seniors with any and all needs including Medicaid, Medicare, and any other senior benefit or discount.

There is an event coordinator, a route assigner, and van drivers to take all La Salle County clients to all appointments or errands.



## Celebrating Flag Day – 1929

(The following is from Jessica Nashold's Backtracks & Sidetracks column reprinted from June 16, 2004.) **By Jessica Nashold** 

The date was June 14, 1929, and on that evening, members of the Mendota Elks Lodge, headed by their Drum Corps, paraded around the business district. They then assembled at the lodge for a program honoring the American flag. The obersvance was mandatory in 1,500 Elks Lodges nationwide.

In Mendota, the committee in charge was composed of Ralph Madden, Dr. B.C. Hartford, Harold Sonntag, Robert Cummings and C.L. Ray. Exalted Ruler Spencer Moss announced that this year the Boy Scouts would give the history of the flag. His son, Gilford Moss, assisted by several scouts, made the presentation.

It commanded the applause of all present.

Speaker of the evening was Past Deputy Exalted Ruler Weyrauth of Sterling. He explained that during wars, patriotism was high. But later, enthusiasm tended to dwindle. Observing this tendency, Elks Lodges took the lead in establishing a day to honor the American Flag, and making it mandatory throughout their organization. June 14 was the date selected.

With Clara Reul at the piano, the audience sang The Star Spangled Banner to open the program, and America at the conclusion.

Speaker Weyrauth urged listeners to



extend its building south to Sixth Street.

The Rockford to Cairo Coach Line applied to the city for permission to run over city streets. The Mendota City Council instructed the city attorney to file an objection with the Illinois Commerce Commission.

Mendota papers had been following every step as Prescott Brothers acquired property and cleared a site on which to open a Texaco service station. Opening day was Saturday, June 22, 1929. The station was located on the southwest corner of 13th Avenue and Washington Street. Prescotts advertised at Opening Day offer. With every purchase of five gallons (or more) of gasoline, they would use a card entitling the bearer to a credit for half the cost of the Texaco Golden Motor Oil used, when a change of oil was next needed.

SIDETRACK – Second and third generation Prescotts will be marking the 75th anniversary of some of them two feet deep, following heavy rain in June 1929. Armed with a pitchfork, he made a couple of stabs at a fish, and on the third try, landed a sixpound carp. The Kleins had a fish dinner.

## However, Mat is not very fond of this sort of fish.

Over the years, Mendota stores have sometimes closed at noon on Thursdays during the summer months. In 1929, groceries and bakeries announced they would remain open on Thursdays for the convenience of their customers. In the June 26, 1929 issue of The Mendota Reporter, 35 merchants were listed who had agreed to close at noon in July and August.

Waldorf, Faber Electric Shop, Adolph Karger, Mendota Electric Shop, E.H Truckenbrod, Chas. Sonntag, Huss & Bush, Margaret Hoye, George H. Neff, E.J. Degenhardt, Blass & Farmer, Yohn & Ossman, Kramer & Cannon, F.R. Bailey, F.H. Gurney, Coss Cash Shoe Store, Edwards Hardware.

## Is Donald Trump boring now?

Donald Trump implicitly endorsed a half-baked conspiracy theory for why his candidates lost in the Georgia Republican primaries, and it created barely a ripple in the political world.

The man who shocked and outraged his way through four transfixing years as president of the United States has become a known commodity, indeed predictable and even monotonous.

It's a blessing and a curse for formerly cutting-edge musicians to see their once radically counter-cultural material show up in TV ads for cars. There's no danger that Trump will ever be similarly laundered into the mainstream. But he can become boring, which will put at risk one of the pillars of his appeal as the most wildly entertaining, mad-cap national political figure of our lifetimes.

Now, I say this as someone who thought Trump's act might begin to wear thin some time in 2015. I was wrong then, and I may well be wrong again. At the very least, though, Trump can't benefit from the shock of the new a second time, or a third time, depending on how you're counting.

The rallies, once an innovation and still his campaign signature, long ago fell into a groove of familiarity -- the stilted reading of scripted remarks off the teleprompter, interrupted by spontaneous riffs and ridicule of his enemies.

Perhaps, by now, the terms of abuse have become such timeless classics that fans would be disappointed not to experience them live, a little like going to a Beach Boys concert anytime over the last half-century and not hearing "California Girls."

Yet you could have heard the same lines at any Trump rally at any place on any occasion over the last several years. The media is still "Fake News." MSNBC is still "MSDNC." Adam Schiff is still "shifty" and Chuck Todd still "sleepy."

And, as you might have heard, Chris Wallace always wanted to be like his father Mike of "60 Minutes" fame, but sadly didn't have the talent.

Much of his focus is backward-looking. Republican voters care, as they should, about the beginnings of the poorly predicated Russia probe that consumed so much time and attention during Trump's first couple of years in office, but there's no way they care as much as Trump does.

The former president said the words "Russia" or "hoax" innumerable times during a rally the other day for Liz Cheney's opponent in Wyoming. The casual observer could have been forgiven for thinking it was an event primarily about the Mueller probe with some throwaway lines about Harriet Hageman mixed in purely for variety's sake.

He talked about his two impeachments, and, of course, his "perfect phone call" with Ukrainian president Volodymyr Zelenskyy.

There is wisdom in the famous William Faulkner line that, "The past is never dead. It's not even past." It's an adage that's traditionally been best suited to Southern gothic novelists, though, rather than American politicians who usually benefit from putting an accent on the future.

Trump's signature 2016 boost of, "I alone can fix it," has become, "I alone can fixate on it."

The candidate who brought relatively neglected issues that mattered to the average voter into the center of the political discussion in 2016, from immigration and trade to opioids, is now largely telling voters about the slights and ill-treatment that matter to him in 2022.

All that said, there's no doubt that rally attendees still enthusiastically enjoy Trump's lines. And there's also no beating something with nothing. If Trump's rallies are stale, what hot new event in Republican politics is going to supplant them? The fact is that Trump at his most dull still may be more interesting than a conventional Republican at his or her most entertaining.

A Trump march toward the GOP nomination will elate his supporters and create a five-alarm fire in the press and among Democrats. But at least this time around, everyone will know what he's going to say next.







## The one true gospel for eternal life

Jesus came to give us a new way to live. In John 10:10 (AMP), He says, "I came that they may have and enjoy life, and have it in abundance [to the full, till it overflows]." When we put our faith in Christ, trusting Him to be our Savior and forgive us of our sins, we can have the abundant life He died to give us.

The apostle Paul was passionate about teaching the Gospel of Jesus Christ as much as he possibly could. When he first went to Galatia, the people there were idol worshippers, but by God's grace, Paul was able to bring many of them to a saving knowledge of the Lord Jesus Christ through preaching. Later on, he wrote the book of Galatians to defend the Gospel because it had come under attack by people seeking to draw the early Christian believers back into legalism, which is based on following rules and regulations about how everything involving our relationship with God must be done.

In Galatians 1:6-8 (NIV), Paul says, "I am astonished that you are so

if we or an angel from heaven should preach a gospel other than the one we preached to you, let them be under God's curse!" Paul uses strong words to convey to the Galatians the danger of accepting or even entertaining the idea that any gospel other than the one he has preached to them has any validity at all. He knows the danger of deception and does not want the Galatians to lose their newfound freedom. In the same way, we must be firm in what we believe, and although we should not be narrow-minded and unwilling to learn new things, we also shouldn't be so open-minded that we are ready to believe anything we hear or read.

In verse 8, Paul says, "If we or an angel from heaven should preach a gospel other than the one we preached to you, let them be under God's curse!" Now, he isn't actually cursing people, but by divine inspiration of the Holy Spirit he is pronouncing that divine judgment must fall on anyone who leads others into error. The pure unadulterated message of the Gospel of Jesus Christ is the only true gospel, and anything that teaches that we need Jesus plus something else will lead us in the wrong direction. Of course, we should obey God and pray, but those spiritual activities do not save us. We are saved by God's grace through faith in Jesus Christ (see Ephesians 2:8-9).

The Jews who held the belief that it was good to have Jesus as long as certain Jewish laws were also followed were called Judaizers, and Paul considered them dangerous to anyone who was not firmly and deeply rooted in the truth regarding the Gospel. Paul's missionary trip to Galatia had been one of his most successful-sinners were saved, miracles were performed, and churches were planted. And now, he could hardly believe that after what the Galatians had witnessed and experienced, they could so quickly begin falling away.

I have heard it said that the church's greatest troublemakers (both now and then) are not those outside the church who criticize, oppose, ridicule, and persecute it, but those inside who try to change or per-

vert the gospel—people who take sound theology and twist or distort it. They don't totally deny it, but they add to it or take away just enough to turn it into a false doctrine without the people even realizing what is going on.






