



Dirt holds up street

City looks to jump start stalled work on subdivision

CLINTON — Commissioners acted Tuesday to resume work on the city’s new subdivision, located along Illini Drive near the junior high school.

Work to complete the subdivision’s street, which the city expected to be completed last November, has been at a standstill. Neil Finlen, of The Farnsworth Group, a Bloomington-based engineering firm, addressed the city council at its regular meeting.

Finlen surveyed commissioners on the project’s current status and what it would take to get it back on track.

“If you shoot the messenger, I certainly understand,” Finlen told the council. “But, I do need to speak to you to decide, at least, where this heads from here.”

Commissioner Ken Buchanan, as well as other commissioners, questioned why Stark Excavating had not completed site preparation and poured the concrete pavement for the street last fall. Subsequent winter weather and then spring rains hampered completion of the street.

Soil test samples failed to come up to necessary conditions for finishing the street. Finlen laid out the choices the city has to deal with the problem.

Genealogical research results in return of portrait

FARMER CITY / CLINTON — A few weeks ago, Bob Tharp, with the Farmer City Historical and Genealogical Society, brought a large framed family portrait to the DeWitt County Genealogical Society.

The name “E. H. Summers” was written in pencil on back of the photograph, along with

instructions for delivery to rural Wapella, the date “May 12-15, 1901,” and a fee of \$9.50.

Tharp hoped that DCGS could find out more about the Summers family and possibly locate a descendant who might want the 33-inch by 29-inch portrait.

After a bit of genealogical sleuthing on Ancestry.com,

“E. H.” was identified as Edward Hamilton Summers (1870-1957), and a second-great-granddaughter, Stefani Summers, was contacted.

On June 17, Stefani, with her mother Cheryl and sister Staci, drove from their home in Indiana to meet with Bob Tharp and Terri Lemmel, President of

the DeWitt County Genealogical Society, to take possession of the portrait.

It now rests in the hands of grateful descendants who intend to display it with pride.

CLINTON — On Tuesday, May 17, during the Clinton High School Gold Star Banquet, Clinton Community Educational Foundation presented several scholarships to CHS high school seniors.

The first scholarship was the Constellation-Clinton Power Station Scholarship. The power plant is a viable asset to the local community and central Illinois, and CCEF evaluates the applications to choose the recipients.

This year's award was presented by Constellation representative Wendy Swartz and given to Wesley Harrold and Jacob Sterr. Wesley plans to go to Millikin University in Decatur and major in exercise science. He plans to play baseball as well. Jacob Sterr plans to attend Southern Illinois University in Edwardsville and pursue a major in engineering.

The second CCEF scholarship presented was for the James Adcock Teacher Scholarship. The recipient was Dennis Lux. He plans to attend University of Illinois in Springfield, majoring in mathematics and minoring in secondary education.

Next was the Vincent Beggs Memorial Scholarship, which was given on behalf of the late Mr. Beggs. The Foundation awards four students each year with a scholarship of \$1,250 to continue their education at an accredited college or university to pursue an undergraduate degree. This scholarship can be renewed each year by the student. This year's recipients were Wyatt Crutcher, Emma Culbertson, Jaxson White and Trevor Willis.

Wyatt plan to attend Western Kentucky University, majoring in meteorology. Emma is attending Illinois State University, majoring in accounting with a minor in international business. Jaxson is attending Southern Illinois University

in Edwardsville and planning on majoring in computer science. Trevor is attending Illinois State University and majoring in engineering technology.

CCEF also awards up to two Vincent Beggs Technical/Vocational Scholarships for students planning on enrolling in an accredited vocational or technical institution of post-secondary education including programs at community/junior colleges. These scholarships are a one-time award of \$2,500.

CCEF understands that not all students' futures involve a degree but instead they pursue a certification for a workforce job.

This year's recipients were Maranda Henry and Clayton Stapleton. Maranda will attend Richland Community College and obtain her associates degree of science in nursing. Clayton plans on attending Richland Community College to study CAD for trade and agriculture business.

For the first time, CCEF was able to award the Vincent Green Memorial Scholarship. This year's recipients were Jacob Sterr and Denton Stapleton. Denton plans on attending Richland Community College to major in Agricultural Marketing and Communications. Lastly, the Gerald "Jerry" Ryan Ag

Scholarships were awarded to Grace Arnold, Elizabeth Maier, and Anna Mills.

Jerry was a DeWitt County farmer for many years. This scholarship is awarded to a graduate of CHS who has been accepted or is currently enrolled full-time in an undergraduate agricultural-related program.

Grace will attend Oklahoma State University with a major in Animal Science. Elly is attending Eureka College and majoring in criminal justice and digital media and design. Anna is attending Southern Illinois University in Edwardsville and majoring in Pharmacy.

Waste not

Welcome to my little corner of culinary delights. I have covered with you only a few things you can make do with what you have. Of course, I could cover many more. But this should be enough for putting the mind along the right track. Now I wish to cover ways to not waste our valuable resources. This includes time.


Along these lines, I have already covered, in past articles, many timesavers as well as saving on energy, food and materials. I will now go past this by including the not so obvious.

Water is becoming more and more polluted. As a result, it is scarce in some parts. Where it is more plentiful, it is also more expensive for making it suitable for human consumption. This makes it more expensive. Let us consider a town with a population of 8,000 people. Let us say that each person wastes one cup of water per day. That amounts to 500 gallons wasted per day.

In weight, that would be 4,000 pounds or 2 tons of water.

In my kitchen, I basically recycle the water. By that, I mean I use a pot of water for more than one cooking process. When I steam vegetables, I use a stack steamer. I might then use that same water for blanching or boiling eggs. Then it might be switched over to a double boiler for melting chocolate, making cheese sauce or meringue, etc. I might even let it cool and water my house plants with it.

Out on the farm, my grandmother saved rainwater for washing

her hair. It was also used for watering plants in the garden and for the animals.

When we finish a box of breakfast cereal, I save the plastic bags. For one thing, I know it is "food safe". For another, it is tougher than waxed paper and other sheet plastic. It is ideal for crushing such things as crackers and nuts between folded layers and a rolling pin. It makes a good freezer wrap.

You can even roll out pie dough on it and easily transfer it to a tart pan or small pie pan. It also cleans up easily for future use. As for the box, please recycle it.

What do you do with your raw garbage? My grandmother used to bury it out in the garden. Do not do this. To bury it in the garden or send it to a land fill, the vegetable waste is trapped and produces methane gas.

It works on the same principle as fermentation. That is why oil wells also have methane gas coming out with the oil. This gas is harmful to our ozone layer. The best thing is to compost it. In that way, useful bacteria break it down into rich fertile soil. It enriches the garden. No Methane is produced.

It is a win - win situation. Seriously compost all the raw vegetables that you can and recycle.

Red Cross offers safety tips to cope with heat waves

Illinois residents have been experiencing high daytime temperatures lately. The American Red Cross has some safety tips to help keep you and your family safe during the heat wave.

Stay Connected

- Never leave infants, children, older adults, individuals with disabilities or pets in a vehicle unattended. Cars can quickly heat up to dangerous temperatures, even with a window cracked open.
- Check-in on older adults and individuals with chronic health conditions at least twice daily. When visiting, ask yourself these questions:
 - Are they drinking enough water?
 - Do they have access to air conditioning?
 - Do they know how to keep cool?
 - Do they show any signs of heat stress?

- Be on the lookout for signs of heat-related illness. Act right away if you notice someone with symptoms.
- If someone is showing signs of heat exhaustion or heat stroke seek emergency medical care immediately.

Stay Hydrated

- Drink plenty of fluids: Don't wait until you're thirsty to drink. Avoid sugary, caffeinated or alcoholic drinks. Avoid icy beverages because they can cause stomach cramps.
- Replace salt and minerals: Heavy sweating removes salt and minerals from your body that need to be replaced. A sports drink or a snack can replace the salt and minerals you lose in sweat.
- Keep pets hydrated: Provide plenty of fresh water for your pets and leave the water in a shady area.
- Warning: If your doctor limits the amount of water you drink or has you on water pills, ask how much you should drink while the weather is hot. If you are on a low-salt diet, have diabetes, high blood pressure, or other chronic conditions, talk with your doctor before drinking a sports beverage.

Stay Cool

- Stay cool indoors: Stay in an air-conditioned place as much as possible.
- Wear appropriate

clothing: Choose lightweight, light-colored, and loose-fitting clothing.

- Don't use an electric fan when the indoor air temperature is over 95°F. Using a fan can be more harmful than helpful when indoor air temperatures are hotter than your body temperature. Fan use may cause your body to gain heat instead of losing it. Focus on staying hydrated, taking a cool shower or bath to cool your body, shutting out the sun and heat with curtains, and moving to an airconditioned place to cool off.
- Use your stove and oven less.
- Schedule outdoor work and other activities carefully: Try to limit your outdoor activity to when it's coolest, such as morning and evening hours. Rest often in shady areas so that your body has a chance to recover.
- Cut down on exercise during the heat.
- When outdoors, protect yourself from the sun by wearing a wide-brimmed hat, sunglasses, and sunscreen that says "broad spectrum" or "UVA/UVB protection."

Here’s how I saved on prescription drugs

The price of prescription drugs has, like everything else, inched up. In some cases, the cost has made a massive, sudden jump, and it comes as a shock when you check out at the pharmacy. But there are ways around this horrible surprise.

I recently discovered a way to save a lot of money (\$80 on a 90-day prescription) by doing two things: I changed pharmacies, and I started using GoodRx. Here’s how:

Go to the GoodRx website (goodrx.com) and put in your ZIP code so that all the local pharmacies show up. Enter the name of the drug you take, as well as the dose and number of pills. See what each pharmacy charges using GoodRx. They will vary widely.

Boy, did I get a shock. It took me all of two minutes to call a new pharmacy and ask them to have the prescription transferred.

Then I printed out the GoodRx coupon showing the pharmacy name, the drug and dose, the price and so on. I took that to the pharmacy and voila! Eighty dollars saved.

Here are a few other ideas if GoodRx isn’t going to work for you:

-- Ask your doctor if a generic would be just as good, or if another drug would work just as well.

-- Find out if you qualify for the Extra Help program to pay for your drugs by calling Social Security at 1-800-772-1213, or read


the information at www.ssa.gov/pubs/EN-05-10508.pdf.

-- See if you qualify for the Pharmaceutical Assistance Program. (www.medicare.gov/plan-compare/#/pharmaceutical-assistance-program)

-- Get a different Medicare drug plan more in line with the drugs you take (www.medicare.gov/plan-compare).

One note: You can’t use GoodRx along with a deductible from Medicare or Medicaid, but you can use it instead of those. Beware whether you’ll reach your annual deductible if you don’t use a Medicare drug plan or if you’re in the doughnut hole (cover gap) already.



ILLINOIS PRIMARY ELECTION JUNE 28

Local elections

After COVID, Illinois was one of several states that changed its primary election date. The Primary is now set for Tuesday June 28.

Early voting is going on at this time if you wish to go to the county building and cast your ballot. This article should be viewed as some brief background with no endorsements of the candidates.

With the 10-year census, there have been some changes. County board districts remain the same, but state Senate and Representative districts have some changes. DeWitt County will be split east of Clintonia Township for the 88th District with current Representative Dan Caulkins running as a Republican. There are no Democrats running at this time.

Clintonia Township and the western part of the county will be part of the 87th District, and two Republicans are running, Mary Burress and William Hauter. Again, no Democrats are running at this time.

The Senate district has gone west, and Sally Turner, the current Senator from Logan County is running for office after having been appointed. Sally is the former County Clerk of Logan County. I have known Sally for many years and have always found her

to be conscientious and forthright in her job.

It should be noted that County Clerk Dana Smith and County Treasurer Gloria Wills are retiring after serving multiple terms of office for DeWitt County. Both ladies have served DeWitt County quite well.

Kari Harris is running unopposed for the DeWitt County Clerk position. She has been the senior deputy clerk in that office for several years. Having known and worked with Kari I can state she knows the job and I would anticipate a very smooth transition.

The County Treasurer's race has two candidates running,

Sarah Jade Russell is currently an employee of the Secretary of State in Springfield working in the DUI section. She studied agriculture at ISU and still works weekends at an emergency vet clinic in Bloomington.

Codilee Snow is currently the business manager with a dental firm and has an accounting degree from Blackburn College. Both women have deep roots to DeWitt County and backgrounds that would assist them as they transition to County Treasurer.

County Board Districts A, B and D each have three Republicans running unopposed. County District C has four



Republicans running for three seats.

Megan Myers, the incumbent, is being challenged by Thomas Farris, Kristina Deerwester and Steve Oswald. Myers and Farris both have numerous yard signs out in the community.

A few yard signs for Oswald are now starting to appear. None of these candidates have put out any election literature that I have seen.

Myers has the experience of having been on the board. Farris was a previous DeWitt County Sheriff back in the 1980s and has been a chief of police in Florida communities before moving back to DeWitt County, where he retired as a security supervisor at the power plant. Deerwester is a CAT employee with a background in financial planning and an interest in Second Chance for Pets animal rescues.

I cannot say that I know anything about Mr. Oswald.

In looking at the ballot, it is obvious that at least five of the 12 county board members to be elected in November will be doing their first

term in office. A 41.66-50 percent changeover of members will create a difficult learning curve for the board since county government is always ongoing. The board will function, but the members will have to put in some extra effort and time to acclimate themselves to the nuances of DeWitt County government.

As to the Governor's race, I will only make this comment. The candidate and his supporters who run the least amount of negative attack ads will get my vote. The only thing that is appropriate for such ads is the trash can, and mine is getting very full.

"What we have is soft subgrade material that has been a struggle for quite some time, especially in the spring back into the late fall as well," Finlen said.

Farnsworth's geotechnical engineer reported silt in the soil combined with moisture from the spring are the main culprits preventing work from going forward, Finlen said.

Essentially, compactness of the soil needs to meet certain standards before contractors can pour the concrete pavement. Failure to properly prepare the road bed would likely result in the concrete later failing.

"None of these are

excuses," Finlen said. "But the soil is too soft, and if we were to do that (pour the concrete prematurely), it would fail."

Finlen explained two choices. A road grader could be used to scrape up approximately 18-20 inches of soil followed by disking the ground to expose the moisture to dry.

A more expensive and lengthy process involves mixing cement with the damp soil. The dry cement would absorb the moisture. Lime sometimes can be used for this, but Finlen said lime would not work in this instance because of the amount of silt present.

Clinton public works director Steve Lobb

avored moving ahead with a plan as soon as possible to prevent losing more time on the project. Other commissioners agreed, while also expressing frustration over Stark's apparent failure to complete the work last fall.

Commissioners arrived at a consensus that the first option should go ahead to get the project going again. They also, however, were in favor of enforcing any contractual obligation on Stark's part to avoid paying for additional work.

The council will meet in a reconvened session Tuesday, June 28 to officially approve the plan.





Microclovers making a comeback as lawns grow in biodiversity

URBANA, Ill. – Clovers are making a comeback in lawn seed mixes. Today many families want to attract more pollinators to their yards. They are searching for ecologically sound ways to grow grass, including adding white clover back to the turf seed mix. Clover adds diversity to lawns and provides food for bees says Nicole Flowers-Kimmerle, University of Illinois Extension horticulture educator.
“If you are looking for an eco-sustainable alternative to lawns, try adding clover to your lawn,” Flowers-Kimmerle says. “The short growing, self-fertilizing, low maintenance, long-living micro clover species will provide a more biodiverse, durable grass lawn.”
White clover, *Trifolium repens*, was common in lawns before the introduction of broadleaf weed herbicides in the 1950s. Although broadleaves weeds were typically the target of these chemicals, white clover was often damaged or killed.
All clovers are in the legume, or pea, family. Legumes are very useful plants for our environment because they pull nitrogen from the air and convert it into nitrogen in the soil that helps feed plants. Unlike any other plant, legumes create their own fertilizer. Because of these characteristics, there is interest in using microclover in lawns to enhance turfgrass growth and reduce nitrogen fertilizer applications which helps limit fertilizer runoff into waterways.
Unfortunately, white clover sometimes forms clumps and competes with desirable turfgrass, resulting in a non-uniform lawn appearance. Microclover (*Trifolium repens* var. ‘Pirouette’ and ‘Pipolina’) is a selection of white clover with smaller leaves and a slower, less aggressive growth habit.
Preliminary research finds that microclover mixes better with most turfgrass species

than common white clover when seeded at appropriate rates. The microclover seed often comes coated with a Rhizobium bacterium – a natural organism that the plant needs to fix nitrogen, sometimes lacking in residential lawn soils.
There are many benefits to adding microclover to a lawn. It mixes well with turf grasses and provides a uniform appearance while its flowers are a food source for bees. Microclover is competitive with weeds, so less herbicide is necessary. And it helps prevent soil compaction which reduces nutrient runoff.
“Lawn clippings that include microclover are a natural organic nitrogen source, which means you can reduce how many times you apply nitrogen,” Flowers-Kimmerle says.
But microclover may not be suitable for every lawn. It does not tolerate high heat and drought and does not do well in shady conditions. Microclover may require reseeding for long-term growth in the lawn and its top growth dies back in the winter, which can leave bare spots and lead to erosion. Its seeds are expensive and not readily available in retail stores. Most broadleaf herbicides labeled for use in lawns will kill microclover.
To establish micro-clover in a lawn, plan to plant between early spring to late summer. No tilling is required. Mow the grass low before seeding. Set the mower to the lowest setting to reduce competition with existing grass. Rake and core aerate the soil.
Sow microclover seed by hand or use a broadcast spreader for a more even distribution in larger areas. Water the area every day for the first seven to 10 days because the soil needs to stay moist until the microclover has sprouted. White clover typically blooms in mid-March and grows slower during the summer months.


