### Lee County residents head to the polls for Tuesday's primary election

**LEE COUNTY** — Lee County residents will take to the polls on Tuesday, June 28 for the Illinois Primary Election, casting ballots for either the Democratic or Republican Party. On the ballot are federal, state and local offices.

On the Democratic ballot – which is green

For United States Senator, incumbent Tammy Duckworth is running unopposed.

For Governor and Lieutenant Governor of the State of Illinois, incumbents JB Pritzker and Juliana Stratton are running against Beverly Miles and Karla Shaw for the Democractic nomination.

Incumbent Kwame Raoul is running for another term as Illinois Attorney General

The Secretary of State race has four Democratic candidates running for the office being vacated by five-term Secretary of State Jesse White, who will be retiring when his term is complete. The candidates include Alexi Giannoulias, David H. Moore, Anna M. Valencia and Sidney Moore.

Incumbent Susana A. Mendoza is running unopposed for State Comptroller.

Illinois State Treasurer Michael W. Frerichs is seeking another term unopposed.

Three candidates are seeking the Democratic nomination for Lee County Board District 1 and they include David McCarver, Emily Rose and David Bingaman.

#### **Board gets updates on summer projects** on at all three buildings. BY GEORGE HOWE

AMBOY — It was a hot and steamy

summer day outside Thursday, June 16, as the Amboy School Board met in regular session. Despite the cool temperatures inside the

junior high school cafeteria, the board members were blazingly fast as they efficiently took care of business on a rather meager agenda. In his evening report Amboy CUSD Superintendent Joshua Nichols informed the board of some of the summer projects including at the Central Elementary School, the landscaping has been cleaned up and redone in front of the building, while the outdoor classroom's construction is progressing well.

At Amboy High School, the portion of the parking lot that wasn't done with the building project and has had the cracks filled, resealed, and restriped. Summer school is still going

In other news, the student handbooks for the 2022-2023 school year was ratified as presented. At the junior and high school, the only changes are the dress code and tardies. Helm Maintenance will continue to provide service for the district. An action resolution was approved authorizing the sale of junior and high school surplus equipment such as desks, tables and chairs. An application for a consolidated district plan also was passed by the board.

A support staff collective bargaining agreement was reached between District 272 and the Teamsters Local Union No.722 on a new four year agreement. Nichols explained the terms including one additional day off along with pay increases of \$1.25 for the first three years and \$1 the last two to bring the employees up to the required minimum wage.

Upon arrival, deputies found a female, Emma Hicks, 19, with an apparent injury. Deputies also discovered Garrett R. Hicks, 21, who was deceased from an apparent gunshot wound.

very few generations, the world brings destructive forces that seem to overpower and sweep aside individual lives as if they were leaves blowing in a strong autumn wind. At times, these events are driven by the steadfast brutality of a few in combination with the inactions of many. In the end, we depend on ordinary people to do extraordinary things. The personal actions of one Amboy man during World War II helped the world to turn back the forces of evil and bend the arc of history

toward the better nature of



his life would be cut short at Normandy, France during the D-Day invasion on June 6, 1944. Known then as a hero, the full extent of his valor would not be fully revealed until 50 years later. John Joseph Fanelli was

born in Amboy on March 13, 1921 to Joseph and Helen Fanelli, both Italian immigrants. Like other Amboy kids of his era, John saw the rise of cars and electronics in the 1920's, lived with scarcity during the Great Depression, and heard radio reports of the attack on Pearl Harbor, and Nazi aggression in Europe. It seems John was

not given to inaction and on

July 8, 1942, he enlisted in

Rockford. After basic training, John was attached to the Army Air Corps 439th Troop Carrier Group, 91st Squadron, and was later based at Upottery Airfield in England. He reached the rank of Second Lieutenant, qualified to pilot a C47 Skytrain, designed to carry paratroopers into combat zones. These dual prop planes would typically carry five flight crew and about a dozen infantry paratroopers. Upottery airbase was built by the U.S. Army in preparation for the secretly planned D-Day Invasion by Allied Forces (code-named

"Operation Overlord"). On the evening of June 5, 1944 the soldiers at Upottery were informed that within a few hours they would go into action as part of the largest airborne landing force in human history. The mission - to drop thousands of U.S. infantry a few miles behind the Normandy Beaches in France to attack German garrisons and secure exit routes from Omaha and Utah Beaches (American landing zones) eventually setting

German forces in Europe. At around 9 p.m. that

evening, Flight 66 took off with Lt. Harold Capuletto as pilot, and 2nd Lt. John Fanelli the co-pilot along with three other flight crew. On board were Lt. Thomas Meehan, Company Commander and 16 other paratroopers from one stick of "Easy Company," of the 101st Airborne Division. In 2001, the T.V. mini-se-

ries Band of Brothers was based on actions of Easy Company from their landing on D-Day to the capture of Hitler's Eagle's Nest in the spring of 1945. Episode 2 of this series shows the flight and demise of John Fanelli's

As Fanelli's plane flew over the English Channel in twilight toward the Normandy Coast, he could look

down and see hundreds of Allied naval vessels carrying tens of thousands of soldiers toward the fortified beaches of France. We cannot know how each soldier prepared mentally during this two to three hour flight. The goal was to reach their target zone by 0000Z, or midnight. Approaching the Utah

Beach coast near midnight, Flight 66 began to take heavy flak from German artillery, with the plane still short of the drop zone. As the intensity of this assault increased, one of the engines caught fire, resulting in immediate and catastrophic descent for Fanelli's aircraft.

In desperation, Capuletto and Fanelli attempted to land the C47 in a farm field, but one of the wings clipped a hedgerow causing the plane to crash and explode, killing everyone on board.

On June 7, as Allied Forces secured all five Normandy beaches and began moving inland, John Fanelli, the flight crew, and the soldiers of Easy Company on Flight 66 were buried in the field at the crash site near the town of Beuzeville-au-Plain. At this point in time, their identities were not known.

Like many other soldiers who were shot down during Operation Overlord, they were often not identified until years had passed. Flight 67 carried Lt. Richard Winters and other paratroopers from Easy Company successfully to the drop zone. Winters would assume command of the company for the remainder of the war.

In March of 1945, shortly before the war ended, John's step-father Ralph, and his mother Helen were presented with the Air Medal, in recognition of John's aerial flights in the European theater during the war. At this time, John's fate was unknown, and he was officially considered to be "missing in action," since his remains were as yet not identified. It is likely that for the balance of their lives, Mr. and Mrs. Fanelli received no more definitive information about their son's heroic actions or the circumstances of the crash.

In the early 1990's, the

The foundation would provide the community of Beuzeville-au-Plain with a monument and memorial to the crew of flight 66 and the soldiers of Easy Company. Just before the anniver-

sary of D-Day in June of 2000, the monument, shaped like the tail wing of a C47, was unveiled along with the names of the flight crew and soldiers of Easy Company. After almost 50 years, the full story of Flight 66 was revealed, and a place of honor established.

Upon identification, the remains of Lt. John Fanelli, four other members of the flight crew, and all 17 Easy Company paratroopers were memorialized at Fort Jefferson Barracks in St. Louis County, Mo. The pilot, Lt. Harold Capuletto, is buried in the American Cemetery at Colleville-sur-Mer, on the bluff above Omaha Beach.

IDPH has an agreement with the Illinois Natural History Survey Medical Entomology Laboratory (INHS MEL) to conduct active tick surveillance across the State. Ticks are collected and tested by the INHS MEL. The results are displayed on an interactive Tick Surveillance Map that documents the counties in Illinois where the different tick species have been confirmed and the

types of pathogens present in those ticks.

Public health officials offer the following additional tips for how to avoid tickborne illnesses and have a healthy time in the outdoors:

- Learn about tick removal and symptom awareness (IDPH website).
- · Walk in the center of trails. Avoid wooded, bushy areas with high grass and leaf litter.

• Wear light-colored clothing to make ticks easier to find. Tuck long pants into socks and boots.

• Apply an EPA-registered insect repellent containing 20% DEET, picaridin, IR3535, or Oil of Lemon Eucalyptus according to label directions. • Conduct full-body tick

checks on family members

(underarms, ears, belly but-

ton, behind knees, between legs, waist, hair and scalp) every two to three hours. Also check any gear or pets taken on outings. • Put your clothes in the dryer on high heat for 10

minutes (or one hour for damp clothes) to kill ticks. · Bathe or shower within two hours after coming


· If you find a tick on yourself, it is often helpful to keep the tick for species identification.

Place the tick in rubbing alcohol or in a sealed bag/ container to bring to your healthcare provider, or you can submit the tick sample, or photos of ticks, to the INHS MEL for identification. Submission information can be found on the INHS MEL website.

If you become ill with fever and/or rash after being in an area where ticks may have been, contact your health care provider. Some tick-borne illnesses can be life-threatening. For example, if untreated Rocky Mountain Spotted Fever may cause death as quickly as five days after symptom onset.

### Orchids on the prairie

Lee County residents don't have to go to a tropical jungle to see an orchid. We have 16 different kinds growing right here.



n orchid's flower can best be described as odd. One of its petals develops

into a lip that as-

sumes all manner of shapes and colors. It may be fringed, divided, elongated, and decorated with brightly colored hairs. There is a reason for this: To transfer the pollen, each type of orchid will grow colors and exude scents designed to attract only a certain type

Some of our orchids are found only in the woods, many are found in wet places on the prairie. Most are rare and hard to find. In order for an orchid to develop from seed, the seed must fall in a suitable habitat. Orchid seeds are very small. One capsule produced by a single flower may contain 10,000 seeds and more.

Orchid seeds can blow in the wind for many miles. They are like grains of ground pepper. When the seed germinates it produces a tiny root and a plumule that eventually produces the orchid plant. The tiny root has no food and would quickly die if it were not for specialized mycorrhiza (microscopic fungi, relatives of the mushroom) that live in the soil where the

orchids grow. The fungi feed the root and grow with it for the life of the plant.

It may require five or ten

years for the root of an orchid to develop enough to produce a single leaf. Some orchids may spend many years in the ground, even after they have produced flowers and fruit. They may bloom in one place for several years, then disappear, only to

bloom again years later.

Orchids are considered to exhibit the highest form of development and specialization among the flowering kingdom. Their downfall will be the abundance of chemicals used today to control insects and weeds. When the insects that fertilize them are gone, the orchids too, will disappear.

Editor's Note: J a m e s Brady Long was born in Amboy on June 12, 1926. Known by many as "Mazie", he grew up in Amboy, served in the army during World War II, then studied forestry at the Michigan College of Mining and Technology. His studies in botany and forest protection continued as he ventured into farming here. A beloved story-teller, his farm became a place of learning and adventure for relatives and friends. In his later years, he contributed a series of local nature articles to The Amboy News. Upon his death in 2000, his many hand-written drafts were gathered and initially curated by Brenda Boyle. The present, renewed series draws from those drafts, both unpublished and previously published.

# The Book Nook By: Tatjana Kazan

#### VITA'S GARDEN

The more I prowl round my garden at this time of year, especially during that stolen hour of half-dusk between tea and supper, the more do I become convinced that a great secret of good gardening lies in covering every patch of the ground with some suitable carpet." So wrote Vita Sackville-West in one of her very popular weekly columns in "The Observer" called "In Your Garden." She wrote her column for fifteen years and in the process made Sissinghurst, the garden she created in 1930, one of the most famous gardens in England.

'Sissinghurst: Vita Sackville-West and the Creation of a Garden" is a wonderful volume of gardening advice, observations, tips, and discussions of flowers and shrubs from Vita's columns combined with a history of Sissinghurst, past and present, by horticulturalist Sarah Raven, who is married to Vita's grandson Adam Nicolson. Though Sissinghurst is owned by the National Trust, Sarah and Adam lived there for ten years. A well-known writer of over a dozen novels, Vita's columns were elegant but never fussy, as for example when she describes the foxtail lily looking "like a cathedral spire flushed warm in the sunset.'

Vita was born in 1892 at Knole (built in 1455), her ancestral home in Kent. As a woman she could not inherit Knole, a source of life-long bitterness, but in 1930, Vita and her husband Harold Nicolson bought Sissinghurst, not far from Knole. They first saw Sissinghurst at night: "The hard winter starlight revealed an untidy courtyard, enclosed by ruined walls, and opposite, an arrowy tower springing up to a lovely height with glinting windows." For Vita, "Sissinghurst's disintegration, its melancholic dereliction, were part of its romance and beauty."

On the principle that "there should be the strictest formality of design, with the maximum informality in planting," Harold created the architecture for the garden and Vita did the planting based on her own principle of "Cram, cram, cram, every chink and cranny." Raven comments: "You have plants popping up in the paths: you have plants trained over almost every square inch of wall; and where there's a gap, Vita encourages plants to grow in the walls. As she says of herself, 'My liking for gardens to be lavish is an inherent part of my garden philosophy. I like generosity wherever I find it, whether in gardens or elsewhere. I hate to see things scrimp and scrubby. Even the smallest garden can be prodigal within its own limitations ... Always exaggerate rather than stint. Masses are more effective than mingies [something stingy, miserly].'... 'Fine carelessness' is a carefully calibrated phrase. And it takes some doing.'

Roses, mistletoe, irises, "the small-flowered, delicate butterfly gladiolus," peonies, and sweet-briar are some of Vita's favorites. "I like my flowers small and delicate - the taste of all gardeners, as their discrimination increases, dwindles

towards the microscopic."





# Clipper Highlights: #62 Drew Goy

in previous high-Llights, I have an extreme bias for the Class of 2008 and what they meant to Amboy Football as a whole. This week we get the honor of highlighting one of those Clippers.

This week's Clipper was among the best vocal leaders that I've been around. He was also one of those few football players who, no matter the opponent or challenge, he made you feel safe. He wasn't going to allow any cast of doubt going into a game. This week's Clipper is a friend to so many and one of our best Clipper lineman. On top of that, this Clipper has been a lifelong friend and gave me the honor of standing as an usher at my wedding.

I take great honor and pride in announcing this week's Clipper, 2-time All Conference Offensive Lineman, #62 Drew "Tough"

Drew was a 2008 graduate of Amboy High School. Drew was a key component to our Clipper offensive and defensive lines in our back to back Quarterfinal seasons (2006 and 2007). Drew also excelled on the baseball diamond and was one of the most fundamental, naturally gifted athletes throughout his entire Clipper career.

Drew's Junior season, he started at Offensive Guard next to Center, Jordan Willstead and Tackle, Jacob Stewart. To that time, those three Clipper greats have been playing next to one another since Junior Tackle. They would lead a young Clipper Offensive Line that would help propel Senior Running Back, Daniel Saunders' second All-State season.

"Daniel made our jobs easy because we knew he would get at least three or four yards every play," Drew

Drew was injured with a slight MCL tear and had to miss three games during the 2006 season. Drew returned for the rest of the regular season contributing to a 7-2 record going into the playoffs. Two dominating wins and the 2006 Clippers were in the Quarterfinal where we would (arguably) face our toughest opponent in history, Plano. Although the season ended that day at The Harbor, a vast amount of experience was gained by Drew and his junior teammates. Drew earned 2nd Team All Conference honors at the conclusion of his Jr. season.

Drew's Senior season, 2007, we entered the year with high expectations as a team to not only make another deep playoff run, but go farther. The 2007 season began with a mandatory team meeting at Coach Nauman's house. The message was simple, a reminder of the opportunity we had and what we were a part of. Drew was one of several great leaders of that team. His style and role as a captain most certainly was reminiscent of other Clipper greats before him such as Dennis McCoy, Joe Nauman, and his dad, Brad Goy. Drew wasn't afraid to tell you if you made a mistake and he expected you to correct it. Drew got the most from everyone on the team, even the other stars because letting him down would hurt more than losing.

Several key games stick out, a dominating 2-0 start to the season with shutout wins against St. Bede and Bureau Valley. A great team win at home against undefeated Fulton to go 4-0 on the season. A heartbreaking 4th quarter loss at the Coliseum against Newman and the class of 2008's only loss against the Comets in their entire career. The season ended with three straight wins and another 7-2 regular

season finish. "We lucked out and went south during the playoffs," Drew shared as he spoke

of our first round matchup against Hamilton West Hancock. "Those guys were huge, watching them and PORTA on film it was intimidating because they were big and fast but didn't play the caliber of football we played in the northern part of the state."

A31-0 victory over Hamilton landed us a three hour charter bus trip to Petersburg PORTA. Adding to the adversity, the Blue Jays were 10-0 and rated #1 in 3a. As I mentioned, it was because of Drew and the other leaders on that team why we were victorious that day. Drew looked adversity in the eye and his will to win never broke. Drew made sure all of us had that same mindset and we had our best victory of the season, breaking the charter bus curse.

The following week, in the Quarterfinal matchup with Aurora Christian our mindset as a team was set on victory.

"They're too fast, they are too good, they are coached by a former NFL player," echoed throughout that week in the newspapers and media buzz surrounding the game. Because of guys like Drew Goy, none of that mattered to us. They took us as far from our element as they could (Melrose Park), on a turf field, and thought we wouldn't show up. In typical Amboy fashion, our crowd exceeded their own.

"It was a crazy atmosphere, 6-7 rows deep around the whole field, everyone was damn near on the sideline," Drew shared.

The ship came to a stop that night and it's a hurt that all of us on that team feel today. The older we get that game is referenced most but not for our near victory. We think about the heroics of Drew, Travis, Tay, Jake, Anthony, and Jordan (among others) who gave all they had against adversity in its toughest form and it showed when the final whistle blew.

Drew ended his Clipper career earning 1st Team All Conference honors Offensively and Defensively and earned 1st Team All Area

Anthony Wells, Travis Nauman, Jordan Willstead, Jake Stewart, and Tay Kaleel all provided statements this week which all show how much Drew meant to our success as a team. I can speak for those listed above, any summation of Drew in words doesn't compare to what we

all feel for him as a friend. Anthony Wells shared, "When I think of Drew Goy the first word I think of is committed. Drew, being Brad's son made him a huge part of the history of Amboy

football. He was committed to the team, community, and to trying to get another title. Drew's nickname 'tough' was just based on his character. He didn't just act tough, he was tough. He was a great teammate and leader for our team. Drew was a great lineman and really a galvanizing piece for our D and O line that had a few young faces. Drew was always able to get you to know when it was go time. He held those trenches down every Friday night. I'm glad to have him as a friend and as a man he's one of the best I know."

Travis Nauman shared, "I loved playing with Drew. It was a great feeling knowing that guy was on the first line of defense. He was the ultimate competitor on the field. More times then not if you messed up a play or missed an assignment, it was Drew on you to figure it out. No doubt one of the backbones to our team and our success."

Jordan Willstead shared, "Drew Goy was the glue to the offensive line in the 2007 season, he was the all around package. He had the size and smarts along with being one of the most Relentless guys I've ever met. Drew never really said much but when he did you could hear a pin drop and then entire team turned to listen. He was one of the guys in practice that you hated going up against because you knew it was gonna be a dogfight the entire time. I never got to see his dad play but I would've loved to watch Drew and Brad go at it in a football game, in my own been like two caged gorillas go head to head. With the last name Goy he has a lot of weight on his Shoulders but he always made his family and teammates proud. Drew till this day you are like one of my brothers thank you for always being there man. Your

one of the best. Congrats." Jake Stewart shared, "Drew was the leader for all of the lineman in the football program. Hands down one of the toughest guys on the team, and one of the smartest. He pretty much set the bar on

how lineman should think and perform. If one of the lineman screwed up costing us yards, or them gaining yards he would let you know about it. With that being said by the one off chance he did something wrong he would want you to let him know what he did wrong. Without Drew, I don't believe we would have had the success that we had. To this day Drew is still one of the toughest guys I know, and is still my best friend. Congratulations Drew "Tough" Goy."

Tay Kaleel shared, "Like many guys I played with, Drew carried that winning attitude with him always. I can't think of anyone else that had such a raw talent at pretty much everything he did, and still does. I've known Drew my entire life, being my cousin and best friend for as long as I can remember, and some of our greatest memories are from our days playing football together. Drew never let me or anyone else on the team down. It was such a great time and I'll cherish those Friday nights spent with him and our teammates forever. Such an honor to play with Drew and a very well deserved highlight.

No matter the sport, it would be hard to find a better teammate than Drew Goy. For as talented and successful as he is to this day, Drew's humility is second to none. In our conversation Drew gave high praise to his fellow offensive lineman, coaches, running backs, and Clipper community.

'We highlighted and emphasized playing as a team. We got that early on from guys like my dad, Dennis Nauman, Mike Willstead, and Uncle Mark. They sacrificed a lot for us and worked hard to not only teach us how to play but why it was important" he said.

The "why" is clearer for us all today when we talk

Drew concluded with what Amboy Football means to him, "You were the town pro sports team. You wanted to play well because you were representing your community. 
you have fortified the pillars of our program and continue to uphold them in your life today. A great leader, a great teammate, but an even better friend. Sail on!
