

**OREGON** – Chris Chapman and his wife Cassandra were considering opening a Western store in town.

Instead, they decided to go in a completely different direction and opened Rustic Ridge Axe Throwing at 117 N. 4th St., in Oregon on May 28.

# **Byron** teachers earn grants

BYRON - Two teachers at Mary Morgan Elementary School in Byron Community School District 226 were recently awarded grants through Western Governors University's (WGU) "Fund My Classroom" initiative.

Dana Franchi, a K-5 art teacher, received a \$787.80 grant that will be used to purchase materials for creativity building stations in her classroom to increase students' fine and gross motor skills. Lauren Gura, a fourth-grade teacher, receiveda\$890grantthatwill allow her to purchase supplies to create a makerspace for students to explore their passions and interests. Both Franchi and Gura learned they were selected for the grants on May 3 when they were surprised with check presentations at their school. The \$787.80 grant awarded to Franchi will be used to purchase a variety of interactive items to fill a void in the classroom that the regular art budget cannot accommodate. Franchi has noticed a recent decline in creativity and fine and gross motor skills among her art students as exposure to technology has increased over the years.

"We decided we were going to do it before we even threw the first time," Chapman said of opening the business.

And after they threw, they felt it would be perfect for Oregon.

So, they went to work learning about the sport and business. Chapman, who runs the business, said he and friends and family built all of the throwing lanes inside themselves. They started in April and finished the week of

the opening. Along the way, Chapman also became a

certified axe throwing coach.

As for the targets, Chapman said they use cottonwood.

"It is a softer wood," he said. "When you throw the axe in it, it actually spreads the fibers of the grain a little easier."

But even with the softer wood, all purchased from a place in Princeton, Ill., the boards only last a day or two.

"It depends on how hard people throw," Chapman said.

Rustic Ridge is affiliated with the World

Axes, actually hatchets, like the one above are very sharp. Chapman said they are very strong on safety.

Axe Throwing League, and Chapman said he hopes to launch league sign-ups in the next couple of weeks. For league play, all boards will be new.

The cost is \$20 per person per hour to throw. Closed-toe shoes are required, and people must be over the age of 14 to throw.

The grant from WGU will help to foster creativity and imaginative play in her classroom by allowing her to add wooden block sets, a Lincoln Logs farm playset, magnetic building tiles, farm and zoo animal figures, a Play-Doh Fun Factory set, calligraphy art set, marble maze and Lego set to the mix.

Gura will use the \$890 grant to create a makerspace in her classroom, containing tools, crafts, technology and other supplies that will allow her students to build, make, explore, solve problems and creatively show their learning. The space will also give students a chance to work collaboratively with one another. Since returning to school after COVID-19 lock downs, Gura has seen many of her students struggle with finding their purpose in their education.

Gura said she believes this space will help her students take control of their learning and work on skills that are necessary for success in school, including the ability to organize ideas, conduct research, collaborate with peers and think through alternative solutions. The funding provided by WGU will allow Gura to obtain items such as stackable storage containers, craft materials, beginner sewing kits, a 3Doodler Pen and more to bring this makerspace to life.

The innovative class-

room projects were among 27 across Illinois chosen by WGU to receive funding. The nonprofit, fully online university issued a call in March for K-12 teachers across the state to nominate proposed classroom projects by April 17 for the opportunity to receive full or partial funding through its "Fund My Classroom" initiative.

More than 80 nominations were received statewide. Most grants were awarded during Teacher Appreciation Week, which ran from May 2-6.

"Wereceived nominations for some amazing classroom projects, and we are happy to bring so many to life through this year's 'Fund My Classroom' initiative," said Dr. Terrance Hopson, Regional Director of Western Governors University.

"When it comes to expanding classroom curriculum and employing innovative techniques to engage and challenge students, teachers are often limited by costs. This initiative is an opportunity for WGU to give back to teachers, who go above and beyond to educate our students, by providing them with funding they can use to further enhance learning both in and out of the classroom."

Anyone ages 14-17 must be accompanied by a parent or guardian.

They sell prepackaged snack and drinks and have some T-shirts and hats for sale as well.

Chapman said when people come in, they get a safety talk and some instruction on throwing. He said the coaches keep an eye on people and offer tips to help them be successful.

"When people first start out, they are all over the target," he said. "By the time they are at the end of their hour they usually tend to hit threes, fours and fives."

He said the key to good throw is, like anything else, practice.

The axes themselves, actually they are hatchets, weigh between 2 and 3 pounds and are very sharp. Chapman said they will eventually have full size axes as well as knives for throwing too.

He said he has seen people coming back not long after their first session, and some are even coming to throw as a date night. He said it is perfect for private parties and corporate events.

"Most people are addicted very quickly," Chapman said.

He is also preparing a mobile unit that can be used for parties and events.

Rustic Ridge Axe Throwing is open daily. Monday is set aside for appointments only.

# Mary Morgan Elementary gets light tables for kindergarten classrooms

BYRON – The Byron Foundation recently granted light tables and transparent manipulatives to the five kindergarten teachers at Mary Morgan Elementary School.

In a society of technology, using different types of resources that engage students in unique, fun ways is needed to keep students participating. Through creative learning, partners will use the light table for kinesthetic learning involving letter/ sound matching, building words, exploring numbers and counting, shapes and sight word practice. The teachers said that in kindergarten, play is an important part of learning. Utilizing light play in kindergarten classrooms, allows for student practice, reinforcement and discovery in the areas of literacy, math and social/ emotional development. The light tables will benefit nearly 100 kindergarten students each school year.

The Byron Foundation, 501c3 non-profit, established in 1993, is an independent organization, founded to provide the Byron School educators access and opportunity to impact learning that empowers students and provides an enriched education beyond the district tax dollars. 

But there are people walking, jogging and biking in the lanes made for them right next to cars with drivers who seem to be in a constant hurry. It is just around the corner from our house, and a popular place for tourists to stop for a tour or grab gifts from the gift shop across the road.

The problem is to get across that road, people must use a crosswalk on a road marked 30 mph where I have seen people pass on the right while going 60 mph.





# The Rainbow Has Been Hijacked

The origin of the rainbow is found in the Bible. God told Noah that He was making a covenant with the earth, an agreement between himself and His creation. The rainbow was the token that God would never again destroy the earth by a universal flood.

Evidence for the universal flood exists. Consider the Grand Canyon. At some point in history there was a lot of water leaving the center of the North American Continent. The little river that now flows there could never have carved out such a canyon. Or consider the many places that tremendous sedimentary layers puzzle our best scientists with a plausible explanation of how they came to be. Consider the deposits of coal and crude oil that are clearly huge carbon deposits of plant and animal matter. Consider the legends of every ancient civilization about The Flood. Or consider with me the Bible record.

The Bible gives us our best explanation of how the flood came about, and why. Today we want to consider the "why". Why did such a great catastrophe ever happen? "And GOD saw that the wickedness of man was great in the earth, and that every imagination of the thoughts of his heart was only evil continually. And it repented the LORD that he had made man on the earth, and it grieved him at his heart. And the LORD said, I will destroy man whom I have created from the face of the earth; both man, and beast, and the creeping thing, and the fowls of the air; for it repenteth me that I have made them. But Noah found grace in the eyes of the LORD." We find these words in the Bible, in Genesis 6. The story of The Flood follows. God sent The Flood to put a stop to the desperate wickedness of man. He saved Noah and his family because of their obedience to Him.

After The Flood, God told Noah about the rainbow. God said it means He will never again send a flood to destroy the whole earth. Does it then carry a message from God that we can do as we please, and that there will be no consequence if we disobey His laws, both natural and spiritual, that He has given us to live by? No; people today would like to take it that way, but the rainbow has been hijacked. It has been diverted from its original purpose and message. Hijackers will need to answer to God for their deeds. Their deeds will not change the true meaning of the rainbow.

In subsequent history it becomes evident that God will not permit us to follow any and every evil desire. Several hundred years after the flood, we find the story of Sodom and Gomorrah. "The men of Sodom were wicked and sinners before the LORD exceedingly" Genesis 13:13. God told Abraham that He was aware of the evil there, and

that He was going to destroy Sodom and Gomorrah. Abraham pleaded that for the few righteous, the city should be spared. God promised that if He found ten righteous people in Sodom, He would spare them all. They were not to be found, but God sent angels to bring Lot, Abraham's nephew, and his family out. "Then the LORD rained upon Sodom and upon Gomorrah brimstone and fire from the LORD out of heaven" Genesis 19:24. Lot and two of his daughters were the only people spared.

The name Sodom has come to represent sexual depravity and the judgement that will follow. But today, many religious people insist that God is love, and that He accepts all people as they are. God is love; God is merciful; but He will not accept as good, any type of disobedience. He calls all people to repent of any and every evil and disobedience to His laws. He has promised not to destroy this evil world with a flood, but He will destroy it, this time with fire. 'Whereby the world that then was, being overflowed with water, perished: But the heavens and the earth, which are now, by the same word are kept in store, reserved unto fire against the day of judgment and perdition of ungodly men" 2 Peter 3:6-7. Because God in His mercy has waited a long time, many people believe they can do as they please, and God will not bring judgement on the earth. But today as in the days of Noah, "every imagination of the thought of man's heart is only evil continually". Paint the rainbow any way you want to. Make it mean whatever you want it to mean. Live as you please, "but know thou, that for all these things God will bring thee into judgement" Ecclesiastes 11:9. Are you hijacking your present and future happiness?
