Life readers please return Requester Card inside paper

All Ogle County Life readers who receive their Life paper each week through the mail will find a white Requester Card inserted in between Section A and Section B of today's Life paper. "We are asking every

household receiving the Life paper each week by mail to return their postage paid card as soon as possible, so that we can satisfy our post office mailing requirements which enables us to continue delivering your Life paper free of charge to your home," said general manager Mike Feltes.

In order for the Life to maintain its Periodicals Class mailing permit, the office must have on file updated Requester Cards from its readers every three years, so it is important each household fill out and sign and date a card, and include a correct address and a valid phone number.

"Based on Periodicals post office standards, we are required to keep the updated cards on file and be able to present them to the post office to verify that readers have requested to receive the Life," Feltes said. "We are paying the postage, so all we need is someone from each household to locate and fill out the card completely, sign and date it and drop it in the mail. That's all there is to it and it will help us assure that you continue to receive your Life paper each week."

"It is important for readers who receive a Requester Card to send it back, indicating they still want to receive the Life at their home free of charge," he said. "The cards are necessary for us to assure that there is no disruption in delivery to your home and we can continue delivering it free."


Warren Miller

Warren Pullman Miller passed away peacefully, on May 24, 2022, at home in Santa Barbara, Calif., surrounded by his family. He died after a losing battle with lung cancer one day short of his 82nd birthday. Mr. Miller was born in Chicago to Florence Lowden Miller and Dr. C. Phillip Miller. HIs grandfather, Frank O. Lowden, was the Illinois governor from 1917-1921. His great-grandfather George Mortimer Pullman developed the Pullman sleeper car and founded the company town of Pullman, now part of Chicago's Southside. Throughout his life, Mr.

Miller had a passion and love for the environment, conservation, travel, flying and above all his family, both the two-legged and four-legged ones (many cats and dogs were lucky enough to call the Miller household their home).

Mr. Miller spent his early life in Illinois. His weekends, holidays, and summers were spent primarily at Sinnissippi Farm, the family's farm and forestland established by his grandparents, located 100 miles west of Chicago, in Oregon. He attended Lawrenceville Academy in New Jersey and received his undergraduate degree in Political Science from Harvard University in 1962. Upon graduation, he joined the Marine Corps Reserve serving for four years.

Mr. Miller's early career was taken up by governmental management, natural resources administration and the for-



est products industry. He served on several advisory panels for state and local governments and as an officer, director, and trustee of several non-profits in the Midwest.

In 1966, Mr. Miller joined the newly formed nonprofit and Presidentially appointed Citizens Advisory Committee on Recreation and Natural Beauty. During that time, he met and married his first wife, Nancy. Throughout the years, he remained close to the family property and businesses at Sinnissippi and in 1978 he and Nancy moved to Oregon to help run the family business. They built a new lumber mill, expanded the logging operations, increased the size of the Christmas tree farm to become the second largest Christmas tree grower in the state for some time. He became involved with the Pullman Historic Foundation and the Pullman Historic District in Chicago and continued as a board member of the George M. Pullman Educational Foundation; a foundation established by his great-grandfather in 1949. The Foundation is ongoing awarding scholarships to outstanding high school seniors throughout Illinois.

In 1989, Nancy wanted to reconnect with her family in California, eventually settling in Santa Barbara. Nancy passed away unexpectedly in 1997. Mr. Miller continued to be active in a number of Santa Barbara's community organizations, among them the Santa Barbara Historical Museum, the Hope Ranch Park Association and the Land Trust for Santa Barbara County. He met Gallery owner Marlene Schulz, and they married in 1999. This would prove to be a new chapter in his life. They collaborated on numerous art exhibitions and publications.

Warren Miller is survived by his wife, Marlene R. Miller, two nieces; Kimberley Lowden Miller, Jennifer Pullman Tadjedin (Amir), cousins; Deborah Lowden Daspit (William), Elizabeth Pullman Daspit, Richard Winslow Daspit Jr. (Cecilia), Anne Deverman Daspit (Kenneth), Amy Drake Daspit, Catherine Elizabeth Culbertson (Charles), Edward Albert Culbertson (Robin), George M. Pullman Drake Jr. (Linda), Christopher A. Drake (Lori), Patricia Lowden Drake, Scott Folker Madlener and numerous grand nieces and nephews. A sister-in-law, Ingrid Cali and her children; Marty Fiolka (Susan), Leeann Folse (Dee).

MOMENTS IN TIME

- * On June 20, 1782, Congress adopts the Great Seal of the United States after six years of discussion. The seal depicts a bald eagle clutching an olive branch in its right talon and arrows in its left. On its breast appears a shield marked with 13 vertical red and white stripes topped by a bar of blue. The eagle's beak clutches a banner inscribed, Epluribus unum, a Latin phrase meaning "Out of Many One."
- * On June 26, 1807, lightning hits a gunpowder factory in Luxembourg, killing more than 300 people. When lightning struck the underground armory, two entire blocks were leveled by the blast.
- * On June 21, 1916, the controversial U.S. military expedition against Mexican revolutionary Pancho Villa brings the U.S. and Mexico close to war when Mexican troops attack U.S. Gen. John J. Pershing's force at Carrizal, Mexico. The Americans suffered 22 casualties, and more than 30 Mexicans were killed.
- * On June 25, 1942, Gen. Dwight Eisenhower becomes commander of all U.S. troops in the European theater of World War II. He would be appointed Supreme Allied Commander of all forces in Europe in 1943. "Ike" would later become America's 34th president.
- * On June 24, 1953, Jacqueline Bouvier and Massachusetts Sen. John F. Kennedy publicly announce their engagement. Kennedy gave her a 2.88-carat diamond-and-emerald ring. He went on to become the 35th president and Jackie became one of the most popular first ladies ever.
- *On June 22, 1964, Dan Brown, author of the "The Da Vinci Code," is born in New Hampshire. Brown's bestselling novels are known for symbols, conspiracies and secret societies.
- * On June 23, 1992, Mafia boss John Gotti, nicknamed the "Teflon Don," is sentenced to life in prison. Moments later, hundreds of Gotti's supporters stormed the federal courthouse in Brooklyn and overturned and smashed cars before being forced back by police reinforcements.

I am not ashamed to admit that I shed a few tears for the children murdered in a senseless act of violence in Texas on May. 24.

A shooter went into a school and killed 19 children and two teachers. The parents of those kids will never see them grow up. They will never hold them again. They will never get to tell them they love them It broke my heart.

There have been more

than 200 mass shootings in the U.S. this year. There were eight the weekend after the massacre in Texas. The numbers are sim-

ply numbing. This is an epidemic, clearly. But it is one we don't talk about seriously and with the intent to change things. This is generally a

country of action. But we are frozen when it comes to gun violence. The reason? People are so deeply entrenched on each side of the issue, no one listens to those that disagree with them. Not listening or seeking compromise is also an epidemic in this

You see, there are those of you who have read this column up to this point and are convinced I want all guns melted down and turned into monuments of those killed. I don't. There are others who read that sentence and are convinced I have a stash of semi-automatic rifles in my home. I don't. I am a gun owner, but

something must be done about these mass shootings. Something real, something meaningful, something that will save the lives of countless Americans - especially

our children. Our children do not deserve to be gunned down anywhere, but especially at school, a place of learning and discovery.

I am not here to offer up solutions – there are many of them already out there and known to pretty much anyone paying attention. And no, the solution is not home schooling all children as some have suggested. If we go that route, we might as well just give up. But the problem, again,

comes back to listening. We can't find workable solutions because we can't do the first thing we need to do – sit down and talk about this. And by us, I mean politicians.

Sadly, they spend way more time grandstanding on this issue – and many others – than actually finding solutions. They are bought and paid for by special interests so they can't even pretend to want to find solutions to this horrible and growing problem.

Instead, it falls on places like schools to try to

keep children safe. Soon, schools will be like prisons. Will that matter to those entrenched on each side of this issue? They will say yes, but their inaction will say a very loud "no."

Elected officials, please do something. Start by listening. Listen to things that make you uncomfortable or angry or sad. Listen. Listen to those you strongly disagree with. Hear what they have

That is where we must start. It is a conversation we have never really hadit is generally yelling and sloganeering and inaction. Well, inaction just won't cut it anymore.

The leading cause of death among children and teens in the U.S. is now firearm-related injuries, according to the New England Journal of Medicine. I find that sickening and shocking. Clearly, we

It all starts with an honest, open conversation.

Always looking for ways to make school safer

In light of the tragic and horrific events in Uvalde, Texas, in late May, I have fielded quite a few calls on school safety. As such, I thought it would be appropriate to update the community on what our district is doing to create the safest possible environment for our kids. In doing so, I want to be clear. No matter what we do, the instinct will be to always do more because there is nothing more important than the safety of our kids. Moreover, before I begin I want to be clear that by expressing the steps we have taken to ensure student safety we are in no way trying to condemn or criticize the actions or inaction of any other school or district, particularly schools that have faced the most horrific of tragedies. In the last five years,

we have completely revamped how we do crisis management in our district. We have been fortunate to have incredibly strong relationships with our local first responders and the leadership of their organizations that have been able to help guide our actions and provide us counsel and perspective

school leaders.

The first major shift was to move from the typical lockdown protocol to AL-ICE procedures. ALICE stands for Alert, Lockdown, Inform, Counter, Evacuate. This protocol changed the previous strategy of hunkering down in a corner and gave students and staff autonomy in decision-making to make the decisions that they believe will provide them the greatest safety.

Next, we moved to the CrisisGo app for building and districtwide alerts. Any staff member can push these alerts if they are aware of a threat and it notifies the district and first responders. This has allowed for cleaner

and quicker communication than relying on someone to notify the office who then would notify other staff and authorities. The app also allows for attendance tracking and additional communication features. Additionally, we are in the process of installing gunshot detectors in some of our buildings with a built-in video that will track directly to first responders and immediate notification to local police and fire. Another technology-based solution we have begun using is LobbyGuard. This allows us to track every person who enters our building. While this may not impact a crisis event, it allows us to know exactly who was in our building at all times in the case an emergency event ever occurred.

Third, in every room, we have Nightlock devices installed. We were one of the first districts in the state to utilize these tools and had to work through many layers of beurocracy at the state level to deploy these tools. Nightlock is a simple tool that makes breaching a door nearly impossible. A simple five-second application of the tool provides better

protection than stacking desks and chairs in front of the door.

Additionally, we are in the process of writing a grant application to receive funding to create more secure entrance vestibules to create an additional barrier between the outside and our students. We are doing so with the support of local law enforcement and are hopeful for positive feedback in the coming months.

Additionally, and probably most importantly, we have added a School Resource Officer. While Officer Ruggeberg adds many other benefits to our district, having him on campus at all times is both a deterrent and reassurance. He also has become our on-site lead (in addition to Crisis Manager, Joe Mullikin) to lead us through drills and

safety practice. As stated before, I never think we can do enough. But given the news that is weighing on everyone's mind, I thought it appropriate to share that we are constantly looking at ways to make our schools safer.

Then, that evening a news story reported that as of 2020, firearms are now the leading cause of death for children. Just days later the unthinkable happened and 19 children and 2 teachers in Texas were shot and killed in their school building. This is unacceptable.

The U.S. has the highest incidence of gun violence of all develped countries, but the least restrictive gun laws. Surveys show

the vast majority of gun owners favor universal background checks to purchase a gun, but many states allow concealed carry of a weapon without a permit OR training.

We need your help.

Our country is fortunate to provide security for its citizens in multiple forms of law enforcement at the city, county, state, and national levels with several branches of military protection. And yet nowhere in our country seems safe from gun violence - not a theater, rock concert, shopping mall, Wal Mart, grocery store, church, synagogue, high school, elementary school, or sitting in your own home. What is the common element in all these shootings? The gun. I'm not referring to

your hunting rifle, or the gun used to protect livestock or used for target practice, but I assume you have been instructed on its proper use. I'm referring to assault style weapons and ghost guns made on digital printers. Most tragic is that now children have become the shooters. We need your help.

Those like me who aren't gun owners feel powerless to solve this problem. As a mother, grandmother and former teacher, I feel morally obligated to speak out about this national problem. Thoughts and prayers aren't working. Taking action might. We need YOU to speak out that with our 2nd Amendment rights comes responsibility, as does our right to free

speech. But all of us do have the power to vote out of office those lawmakers who refuse to make sensible restrictions on gun ownership and/or usage. Other countries have done so. How many children must die before we come to our senses and do the right thing to keep our children safe? To ensure our country's security we need YOU to convince our legislators to address this appalling situation so our children are protected. I love my country, but right now I am not proud of my country. Please make me proud again.
