Amboy Fire Department brings more to the celebration

AMBOY – Everyone knows the 4th of July means the sky will be lit with beautiful, fantastic, freedom celebrating fireworks.

The Amboy Fire Department wanted to bring a little extra community bonding, more fun, and a bigger celebration to the annual Independence Day festivities.

In 2017, Fire Chief Jeff Bryant Sr. debuted the City of Amboy and Amboy Fire Department Independence Celebration and it continues this year on July 2.

“It started when the Amboy Fire Department was celebrating its 145th year in 2017 as we became a vigilant fire company in 1871, the Amboy Fire Company 1 in 1873, Amboy Fire Department in 1922, and Amboy Fire Protection District in 1944,” said Ashley Bryant, AFD’s administrative assistant, volunteer fire fighter, EMT, and Chief Bryant’s daughter-in-law. “We had the celebration when we were founded, and we had planned all of the same activities for the celebration. We wanted to get our name out there and celebrate our community.

“We joined it with the July 4th celebration

and now we’ve made a tradition to keep it up every year.”

This year’s activities start with kid fun from 4-7 p.m., as a water slide, bounce houses, face painting, axe throwing, foam machines, a mobile game room, superhero characters, and bubble making stations will be available.

There will also be popcorn, popsicles, and water for refreshments.

A party isn’t a party without music as Snap Shot, a family friendly classic rock band, will be on stage from 7-11 p.m.

The City of Amboy will host the firework show at dusk.

“July 4th itself is worth celebrating. This is an event that we’ve done for the last three to four years,” Ashley Bryant said. “We really have fun hosting it and having a fun day for the community and the visiting families from surrounding areas and the campgrounds.

“It’s something we take pride in hosting and putting on free entertainment for the kids and the community. We want to make sure everyone is invited and they’re free to come down and enjoy themselves. We look forward to seeing everyone have a fun night.”

The expenses for the fire department’s event are funded by donations from about 20 business in Amboy and surrounding communities.



Amboy Depot Days 50/50 tickets go on sale July 1

AMBOY – Before we know it Depot Days will return to downtown Amboy.

In preparation, antique cars are getting tuned up and polished, kids are figuratively – maybe literally – creating the list of carnival rides they’ll ask their parents to ride, and 50/50 tickets can be purchased starting July 1 in hopes of winning the grand prize.

“When the 50/50 first started, 31 years ago, I was the one who raised his hand and said, ‘Hey, I’ll do the 50/50’ and here I am 31 years later still involved,” said Jeff Gerdes, Amboy Fire Department Lieutenant, who has been with the AFD for six years. “Back then, Depot Days was a small carnival. There were 10-12 antique car and hotrod enthusiasts that said, ‘Let’s try to put a car show together and see what happens.’ Sure enough, it was a success although it was small. Every year it just keeps growing and growing.

“The first winner of the 50/50 drawing won \$750. As the car show grew, the attendance to the weekend grew and we sold more tickets. It’s just snowballed into what we have now.”

Last year’s 50/50 winner took home \$105,580.

The largest Depot Days pot was a little over \$149,000.

“It is new life money. Over the past, we’ve had winners pay off college debt, pay off or put down a deposit on a new house, buy vehicles, and pay bills,” Gerdes said. “It’s not a \$100 pay out; it’s a lot of money. It’s life changing for everyone who wins in some way or another.”

When tickets go on sale July 1, they will be sold for \$1 each or \$5 for six tickets.

The 50/50 tickets will be available for purchase until Aug. 28, which is the last day of Depot Days.

Collision claims life of long-time civic servant

AMBOY – John Fritts spent many hours, days, months, and years serving his community.

Around 3 p.m. on Monday, June 20, Fritts passed away in a two-vehicle collision doing what he had done for most of his life, serving the community.

“John will be missed by the entire Lee County Family,” wrote Wendy Ryerson, Lee County Administrator, in a press release on Wednesday, June 22. “He will be fondly remembered as a good man with a warm smile and a remarkable ability to remember names, a talent he demonstrated frequently

over the years when citizens would visit the courthouse.

“John was also known for his ability to perform math calculations without the use of a calculator or a computer, a quality that stood out in the many County Board Finance Committee meetings he attended.”

On Monday, June 20, Fritts was serving as the campaign manager for Republican Bradley J. Fritts, who is running for Illinois State Representative.

The vehicle both John and Bradley, along with a few other family members, were in during their campaign trail collided with another vehicle at the intersection of Route 34 and Ottawa St. in Earlville. The police report

reads there were numerous ambulances and a helicopter on the scene.

On the Citizens for Bradley J. Fritts Facebook page, Bradley Fritts wrote:

“My family suffered a tragic loss on Monday when my campaign chairman Uncle John was killed in a car accident. I was hospitalized overnight but have been released and am physically well. John was a pillar of our large Fritts family because of the leadership, faith, and love that he showed. He set a wonderful example of Christian values. Thank you for the tremendous outpouring of love, prayers, compassion, and support. Generous supporters and volunteers will continue the campaign in the absence of my family, while we take the time to mourn the loss of John.”

Fritts served as the Lee County Treasurer for 24 years (1994-2018). Before his election in 1994, he served on the Lee County Board for eight years.

The Board honored and remembered Fritts’ many years of public service with a moment of silence during the June 23 board meeting.

“John’s public service was not limited to the Lee County government. He exemplified service in his everyday life by volunteering for many other boards, committees and events,” Ryerson wrote. “His passing has left a void in the heart of the Lee County family – and the broader community.”

City council hears presentation on waste water grant opportunities

AMBOY — Summertime city council meetings seem to have a different vibe. The agendas tend to be short and sweet. That was the case on June 20 at the regular session held at the Amboy Community Building.

The proceedings got underway with a presentation from Jason Stoll about grant opportunities for both the city waste water and sewer lining. Stoll is the grant writer for the city and explained that he continues to research both state and federal grant opportunities to help offset the costs of large projects such as these. He will report back in a future

meeting with his findings.

A couple of ordinances that were ratified included increasing commercial building permit fees, and vacating a portion of Water Street, from East Bluff Street, to East Avenue which is part of the city contract agreement with Jared Zellhoffer, owner of Z- Best Enterprises.

The council also approved a pay raise for city sewer worker Rich Schrock who recently completed his training and received a certified sewer license.

A number of holidays and events are just around the corner and that means the council approved a city donation for fireworks.

Sheriff’s office releases more information on incident in Amboy

LEE COUNTY — On Sunday, June 19, 2022, at approximately 8:52 a.m., the Lee County Sheriff’s Office was dispatched to the 73 E. Kellen Drive, Amboy, in response to a neighbor asking for help.

Pursuant to the evidence collected at the scene, multiple interviews and inquest, the sheriff’s office preliminary investigation indicates that there was an altercation between Garrett and Emma Hicks, whereby Emma, age 19, was injured and Garrett, age 21, died from a self-inflicted wound from a handgun.

Lee County Detectives were called to the scene to continue the investigation. An inquest is being scheduled by the Lee County Coroner’s Office.

Emma Hicks was transported to KSB, then to OSF in Rockford for treatment of her injuries.

The Sheriff’s Office was assisted at the scene by the Amboy Fire Department, Amboy Police Department, Illinois State Police Crime Scene Services and Lee County Coroner’s Office.

More information will be available upon the conclusion of the investigation.

Lightning is only one flash away

SPRINGFIELD – June 19-25 is National Lightning Safety Awareness Week and the Illinois Emergency Management Agency (IEMA) wants everyone to be safe indoors during thunderstorms.

“It is extremely dangerous for people to stand outside and take pictures of lightning,” said Alicia Tate-Nadeau, Director of IEMA. “During a storm, everyone should remain inside.”

Summer weather in Illinois is unpredictable. The Illinois Emergency Management Agency is partnering with all emergency management agencies and the five National Weather Service offices that serve Illinois. Together, we emphasize the dangers of lightning strikes and share ways to be safe during a thunderstorm.

Sleep is good medicine

STERLING — The CGH Sleep Center is participating in the national campaign launched by the American Academy of Sleep Medicine (AASM), “Sleep is Good Medicine” by reminding you about the importance of sleep. The campaign is designed to increase public awareness about sleep and its connection to health.

In 2021, the AASM issued a position statement that sleep is essential to health. In that statement, it reads, “Healthy sleep is important for cognitive functioning, mood, mental health, and cardiovascular, cerebrovascular, and metabolic health...” They conclude that while significant resources have been invested to address health-related lifestyle factors such as nutrition, exercise, and smoking, programs focusing on sleep health have been rare. The “Sleep is Good Medicine” campaign is calling for a greater emphasis on sleep health in education, clinical practice, inpatient and long-term care, public health promotion, and the workplace.

The AASM recommends that the average adult should sleep 7 or more hours per night on a regular basis to promote optimal health. The National Sleep Foundation suggests for school-age children 9 -11 hours of sleep and 11-14 hours or more for toddlers and infants.

Healthy sleep allows the body to boost immunity, reduce stress, manage weight, and reduce the risk of chronic diseases. This requires adequate sleep duration, appropriate timing, regularity, and the absence of sleep disorders.

Most sleep problems are not as severe as chronic insomnia or sleep apnea. Lifestyle changes like spending more time outdoors or avoiding caffeine late in the day can make a big difference. However, there are a wide variety of sleep disorders. If you have more challenging sleep problems, talk to your doctor. Or you can work with the sleep team at an AASM-accredited sleep center to find a solution that works for you.

Lightning safety tips include:

- Avoid open fields, hills, or ridge tops
- Stay away from tall, isolated trees or other tall objects
- Set up camp in a valley, ravine, or other low-lying area
- Stay away from water
- Your weather radio will provide real-time thunderstorm warning and information

Indoor lightning safety tips:

- Stay away from anything connected to electricity, landline phones, and plumbing
- Close and stay away from exterior windows and doors
- Stay away from balconies, porches, and open garages
- Do not lie on concrete floors or lean against concrete walls
- Bring your pets inside

With half of the money going to the owner of the lucky ticket selected, the other half goes back into the community.

“We keep enough for the upcoming year’s expenses. We’ve been doing it so long now that we have a real good idea of future costs, so we set that money aside for the next year,” Gerdes said. “The remainder goes to local charities and non-profit organizations such as the Honor Flight for our veterans – we’re a

big supporter of that – and the Amboy Depot Museum.

“That is really the original idea of the 50/50. It was to help support the museum, keep it open, and pay for bills. It got to the point where we had more than enough money to support the museum, so we donate to local charities and organizations.

“It’s a great thing and we’re able to help a lot of people.”

The 50/50 earnings have also helped churches, food pantries, the Amboy Library, Amboy High School, and the Amboy Junior High.

Actually, the money will go to a good cause or to a good reason anywhere in the community.

“It’s a good feeling and what really keeps us going. It’s an incredible amount of work to put on a show this big and organize the 50/50

drawing,” Gerdes said. “On Sunday of the car show, we have about 20 people working just on 50/50.

“If someone in town becomes ill or wheelchair bound, we will buy the materials, build them a ramp, and do whatever we can to help them become more accessible in their own home. It’s a good feeling and that’s why we continue to do it.”

West Nile Virus reported in seven counties

CHICAGO – The Illinois Department of Public Health (IDPH) is reminding the public that along with summer, Mosquito Season is now underway in Illinois and that positive batches of West Nile Virus have been reported in seven counties around the state. The reminder comes as public health officials around the country are highlighting the importance of taking protective action to "Fight the Bite" during National Mosquito Control Awareness Week.

While no human cases of West Nile virus have been reported in Illinois so far this year, there were 64 human cases (which are significantly under-reported) and five deaths attributed to the disease in the state in 2021.

"West Nile virus is a serious illness, and we want to remind everyone to protect themselves from mosquito bites at this time of year when so many of us are spending more time outdoors," said IDPH Acting Director Amaal Tokars. "The most important things we can do are to wear insect repellent if we are spending time outside and eliminate standing water where mosquitos breed around our homes. These precautions are especially important for those with weakened immune systems"

The first mosquitoes to test positive for West Nile virus in Illinois in 2022 were reported on May 24 in Roselle in DuPage County. Since then, six more counties - Cook, Will, Logan, Edgar, Macoupin and Washington - have reported batches of mosquitos that tested positive for West Nile virus. Updates on where cases have been reported can be found on the IDPH West Nile Virus Surveillance page.

Last year, 48 counties in Illinois reported a West Nile virus positive mosquito batch, bird, horse, and /or human case

Monitoring for West Nile virus in Illinois includes laboratory tests for mosquito batches, dead crows, blue jays, robins and other perching birds, as well as testing sick horses and humans with West Nile virus-like symptoms. People who see a sick or dying crow, blue jay, robin or other perching bird should contact their local health department, which will determine if the bird will be picked up for testing.

Popular Illinois land conservation program reopens, enrollment begins June 15

SPRINGFIELD – Farmers, ranchers and agricultural landowners with property prone to flooding and nutrient runoff will have the opportunity to enroll in Illinois' reopened land conservation program, now available in 68 counties.

The Illinois Conservation Reserve Enhancement Program (CREP) – administered by the Illinois Department of Natural Resources (IDNR) in partnership with the U.S. Department of Agriculture, Farm Service Agency (FSA) – is one of the oldest and most popular in the nation and an important tool in addressing climate change and natural resources conservation challenges.

"Programs like CREP provide critical support to private landowners who want to implement sound conservation practices on their property," said IDNR Director Colleen Callahan. "These efforts help reduce runoff, protect our precious soil and improve wildlife habitat."

Illinois CREP will reopen for enrollments June 15 for the first time since 2015. State funding for the program is provided through Gov. JB Pritzker's Rebuild Illinois capital program.

Through Illinois CREP, federal and state resources are made available to program participants to voluntarily enroll in 14-to-15-year federal CREP contracts and a subsequent 15-year or permanent conservation easement with the State of Illinois. It expands the voluntary, incentive-based Conservation Reserve Program available through FSA to Illinois agricultural producers and landowners within the Illinois and Kaskaskia River watersheds.

"CREP is one of our most flexible tools when it comes to voluntary, locally led, partner-drive conservation efforts, and we're so glad we're able to put it to work again in Illinois," said Scott Halpin, USDA Farm Service Agency State Director in Illinois. "This initiative previously had a positive impact in Illinois, and we look forward to broadening the reach of the program to new agricultural producers and landscapes. We are so grateful to have support from Illinois leaders to make this program possible."

Illinois CREP assists farmers, ranchers and agricultural landowners to improve water quality and conserve natural resources. Participants remove cropland and marginal pastureland from agricultural production and convert the land to grasses, trees or other approved vegetation.

In return, FSA provides participants with rental payments, a 50% cost-share payment for installing approved conservation practices, and incentive payments for certain practices. The State of Illinois provides a cost-share match in addition to a one-time payment for all land entered into an easement.

CREP conservation practices include of permanent native grasses, hardwood tree plantings, permanent wildlife habitats, shallow water areas for wildlife, filter strips, riparian buffers, wetland restorations, non-floodplain wetland restorations, and rare and declining habitat for prairie and oak savanna ecosystems.

The Illinois CREP includes all or portions of the following 68 counties in the Illinois and Kaskaskia river watersheds: Adams, Bond, Brown, Bureau, Calhoun, Cass, Champaign, Christian, Clinton, Coles, Cook, DeKalb, DeWitt, Douglas, DuPage, Effingham, Fayette, Ford, Fulton, Greene, Grundy, Hancock, Henderson, Henry, Iroquois, Jefferson, Jersey, Kane, Kankakee, Kendall, Knox, Lake, LaSalle, Lee, Livingston, Logan, McDonough, McHenry, McLean, Macon, Macoupin, Madison, Marion, Marshall, Mason, Menard, Monroe, Montgomery, Morgan, Moultrie, Peoria, Perry, Piatt, Pike, Putnam, Randolph, St. Clair, Sangamon, Schuyler, Scott, Shelby, Tazewell, Vermilion, Warren, Will and Woodford counties.

SAVING A LIFE

In Margot Livesey's brilliant coming-of-age novel, "The Boy in the Field," on a September afternoon in 1999, siblings Matthew, Zoe, and Duncan Lang are walking home from school when they find a boy lying in a field, bloody and unconscious. Duncan, who will become a painter, imagines the scene from the perspective of a bird: "Looking down at the boy lying in the grass, his blue shirt and black shorts and red legs ending in black trainers, slightly dusty, pointing at the sky. And the three of them in their white shirts, kneeling beside him, keeping vigil." They save his life.

But the hunt for the perpetrator does not take center-stage, rather the novel unfolds into a portrait of the three Lang children as they absorb and react to the crime. The boy had uttered a word, which each of the siblings heard differently. The portraits emerge from these three words. Matthew, the oldest, is practical and down-to-earth, and he hears "coward." Which leads him to search for the suspect, a man in a blue car. Duncan, at twelve, the youngest of the three, hears "cowslip," a pretty primrose flower found in woodlands; and Zoe hears "cowrie," the beautiful shell of a sea snail, which she has been collecting. The cowrie possesses protective qualities, and she gives one to Karel, the boy she had saved.

Livesey's portraits are flawless: her language is low-key, yet always rings true and her characters are fully realized. Duncan in his innocence and yet clear-eyed perceptions is a truly memorable character. He was adopted as a baby by the Lang's. His skin is dark—his mother was a Turkish girl—and he's had to bear the inevitable taunts at school. Soon after finding Karel, he has a ghostly vision one night of a woman standing in the garden. He is convinced his "first" mother is looking for him, and so goes in search of her, helped, of course, by the rest of the family.

The most poetic of the three, Zoe has a secret ability, as she describes it, to "slip between the teeth of time." She has moments when she leaves her body and hovers above the scene. Yet at sixteen, she is mostly interested in boys. When she goes to Oxford (her family lives some miles from Oxford, England), she wanders the streets looking at men to find the suspect who is described as utterly ordinary. On one such excursion, a man looks back at her and smiles. Instantly smitten, Zoe begins to follow him. His name is Rufus and he is an American graduate student in philosophy. When he tells her about the philosopher Spinoza, she looks him up and finds a perfect quote: "Desire is the very essence of man." They soon become lovers.

DCFS increases monthly financial support for fosters parents

CHICAGO—The Illinois Department of Children and Family Services (DCFS) is increasing the financial support provided to foster parents, caregivers and older youth in care to help offset the recent increases in cost of living expenses experienced by families throughout the state.

DCFS had already planned on providing these families and youth a 3 percent cost of living adjustment in the new fiscal year. The new, additional support of \$14.6 million is supported by a decrease in youth coming into DCFS care and reuniting youth with their biological families.

"Foster parents and foster youth deserve our state's investment," said Governor JB Pritzker. "As living costs continue to increase throughout the nation, Illinois is working to provide needed resources to these vulnerable children. By increasing financial support to foster parents, caregivers, and young adults in care, we are standing up for our most vulnerable youth, and we will continue to do so."

"Foster parents are one of the key pillars of our child welfare system and these additional resources will help many families whose budgets have been impacted by inflation and other increased costs continue to provide

a safe and loving home for every youth in our care," said DCFS Director Marc D. Smith. "These families have opened their homes and their hearts to help have a positive impact on the lives of our state's most vulnerable youth, and redirecting these funds will help ensure that foster families have the resources and support they need."

The average additional increase, beyond the already planned COLA, for the more than 9,600 licensed foster families in Illinois will be \$74 a month, although families will receive between \$52 and \$111 more depending on the age of the child. Foster families caring for children between the ages of 1 and 4 will see the lowest increase, from \$492 to \$544 per month; while families caring for children between the ages 9 and 11 will see the largest increase, from \$545 to \$656 per month. More than 8,100 foster families who have opted to remain unlicensed will receive an increase of \$66 a month, from \$322 a month to \$388. Youth in care over the age of 18 who are living in transitional programs will see an increase from \$511 a month to \$586, and those pursuing higher education will see their monthly stipend increase from \$1,317 to \$1,506.

As part of the last budget cycle, DCFS projected 18,511 youth in care at the end of the fiscal year that ends on June 30. DCFS currently has more than 17,800 youth in care, approximately 700

fewer than the projected number. This reduction is a reflection of fewer youth entering the child welfare system and youth being successfully reunited with their biological parents.

Social Security Administration (SSA) impersonators warn the targeted individual that their identity has been stolen and

Almost all government impostor scams use a law enforcement angle, with some directly impersonating law enforcement agencies. In

- Government agencies like the Social Security Administration, IRS or FBI do not call people with threats or promises of money.
- Do not trust your caller ID, as scammers can spoof legitimate numbers. If you receive a phone call, check with the real agency by going to the agency's website directly, then
