## Substation project complete City officials celebrate \$13.8 million electric facility

**ROCHELLE** — On Friday, the City of Rochelle and Rochelle Municipal Utilities held a celebration for their recently-completed \$13.8 million electrical substation project at 1630 Ritchie Court.

The project broke ground a year ago in an effort to serve current customers and attract new industrial growth. The new substation will increase reliability for nearby industries and create the ability to have redundant feeds. This substation will also introduce a new voltage class for the city to be able to provide electricity to larger users and will be the first substation project split into two yards with the distribution yard owned and operated by RMU and the transmission yard owned and operated by ComEd.

In 2019, the city purchased just over 16 acres for construction of the substation to support growth in Rochelle's southern corridor. Zekelman Industries, which will soon be opening next door to the substation in the former Nippon Sharyo buildings, will be one of the city's

an "amazing partner to

largest power users.

'This is an amazing project," Rochelle Mayor John Bearrows said. "It takes care of not only our businesses today, but it also gives us expansion capabilities for the future. That's one of the things the city has always been good about, looking forward and seeing what we'll need in the future, not just today. This project will be the catalyst for not only current service, but to promote expansion down the road." Bearrows called ComEd work with" on the project, which came together over 18 months ahead of schedule amid supply chain and workforce shortages. The mayor thanked City Manager JeffFiegenschuh, City Attorney Dominick Lanzito, RMU Superintendent of Electric Operations Blake Toliver and staff members for seeing the project through. "You all played a big

"You all played a big part in this," Bearrows said. "Everybody with the city really is a team. We don't always agree, but we can reach a compromise that's good for everybody. Thank you all for being here."

The mayor spoke of the importance of having infrastructure in place to attract future businesses and growth.

"This project is for today and for tomorrow," Bearrows said. "And for decades. If somebody wants to come here, we have close to 1,000 acres that are shovel-ready."

**ROCHELLE** — About \$10,000 in damage resulted from a garage fire at a home in the Flagg Center area on Monday afternoon, Rochelle Fire Department Chief Dave Sawlsville said. There were no injuries and the homeowner will not be displaced.

The Rochelle Fire Department and all Ogle-Lee Fire Protection District Departments (Steward, Hillcrest, Flagg Center and Creston) responded just after 2 p.m. to the fire at 11169 E. Oak Court.

Sawlsville said the homeowner arrived home and her garage door opener wouldn't work. She went inside and smelled smoke from what was a fire that started in the attached garage.

Fire department personnel took a hose in through the front door because the garage door wouldn't open.

"There wasn't anyone home, so we didn't have

to worry about getting people out," Sawlsville said. "It would've been a different story if she hadn't come home at that time or had even gotten home 15-20 minutes later. The fire would've gotten to the attic and spread from there."

Firefighters eventually had to cut through the

"We're still investigating the cause of the fire," Sawlsville said. "It seemed like it started in the back left corner of the garage. We were probably on-scene for an hour. We had to sift through everything in the garage to make sure the fire was out."

## Retirees recognized Harper, RTHS Principal



## **Park board approves Tilton Park drainage project** Executive Director Ohlinger: Spring Lake Pool scheduled to open June 4

**ROCHELLE** — At its Monday meeting, the Flagg-Rochelle Community Park District Board unanimously voted to move forward with a \$19,965 drainage project at Tilton Park with Countryside Professional Land Services.

Tilton Park, which houses the fields that Rochelle Little League uses, has seen drainage issues with surface water on fields in the past. Countryside Managing Partner Dave Casey spoke at the meeting and said the idea of the project is to stop surface water from sitting on the fields for so long.

"Clearly the park district has invested in this park for baseball and it's certainly something we knew long ago was important to the community and this is just an addition to some of the earlier investments we've made," Park District Executive Director Jackee Ohlinger said. "I think it's important that we do it."

Ohlinger said the work won't begin until after the little league season ends. Following the drainage work, there's potential that hard surface paths may be added to the complex.

"There's always been a plan to do the drainage and then potentially a hard surface that goes from the concessions area through the fields all the way to the little league field," Ohlingersaid. "That would probably be our next phase to look at is some sort of hard surface to connect everything."

## Director

### comments

During her director comments portion of the meeting, Ohlinger said work at Spring Lake Pool is in "full force." The park district has been working to hire staff and prepare the facility for opening. There are tentative plans to open Spring Lake on June 4.

"We're having some work done on the slide and the climbing wall so they look great," Ohlinger said. "We had someone come in to work on the pool drains. They'll be coming back to get the pool ready to be filled in the next week."

Ohlinger also said the park district was recently provided with recent round numbers from Fairways Golf Course. 13,053 rounds of golf were played in 2021, which looked similar to 2019 and 2018, she said.

"We had 4,800 rounds of golf from Rochelle residents and about 4,200 rounds from residents outside Rochelle," Ohlinger said. "I thought it was interesting that those numbers were that close.

Kishwaukee College will be using Fairways as its home course and there will be five different meets at Fairways this year. That's great for the community and city."

Park District Superintendent of Recreation & Fitness TC Hager said the Kickin' It For a Cause kickball tournament held over the weekend in conjunction with the Rochelle Chamber of Commerce went "really well."

The event benefits the

park district's ENGAGE program to help with financial assistance for members of the community to utilize park district programs, along with the chamber's scholarship fund.

"It was a really good event and went smoothly," Hager said. "People had a lot of fun and we raised quite a bit of money for our ENGAGE program. Overall, we had nine teams and it was all positive comments from the community."

## Sealcoating

The board unanimously approved a contract with Wyatt Pavement for sealcoating work this year in the amount of \$16,818 that will take place in June.

"We're looking this year to do two basketball courts, the maintenance shop parking lot and driveway and Lake Sule," Ohlinger said. "It's a large amount of sealcoating. We'll do the cracks, sealcoating and striping." Officers

## How to dispose of unused medications in Ogle County

**OREGON** — Often overlooked but present in most homes are old, unused, expired and unneeded prescription and over-the-counter (OTC) medications. Medications around the home can be abused, or be accidently ingested. Flushing medications down the toilet can introduce these substances to our water supply, as water treatment facilities are not designed to handle this sort of water contamination. Sending medications to the landfill is discouraged as well, as the medications

wrong hands and are disposed of properly. Police departments in Byron, Forreston, Mt. Morris, Oregon, Polo and Rochelle, as well as the Ogle County Sheriff's Office in Oregon, have permanent, secure drop-off boxes so residents can properly dispose of their unwanted medications. The drop-off boxes at the Ogle County Sheriff's Office, as well as the drop-off box at the Polo Police Department, are available 24 hours a day, while the other police department locations are available during normal business hours. This is a free program for area residents. The drop boxes provide Ogle County residents with a safe and convenient disposal program for prescription and over-thecounter medications. Accepted items include all prescription and overthe-counter medications, vitamins, supplements

and pet medications. Place pills into a sealable plastic bag and place into drop box. You may recycle the empty containers with your regular recycling material after removing the labels. For liquid medications or ointments, block out any personal information, place bottle into sealable plastic bag,

and place bag into drop

box. Items that are not

accepted include needles

or sharps, thermometers,

aerosol cans, hydrogen

abused, or accidently ingested, and can help protect our water supply and the environment. If you have questions regarding this program, please call the OCSWMD at 815-732-4020, visit www. oglecounty.org, or you can contact the Ogle County Sheriff's Office or your local police department.

The Ogle County Solid Waste Management Department (OCSWMD) encourages residents to clean out medicine cabinets and closets of unwanted or expired medications. Doing so can prevent the medications from being


On May 16 deputies arrested Steven Dodson, 44, of Chana for domestic battery. Dodson was held in lieu of bond at the Ogle County Jail.

Memorial Day weekend marks the unofficial start of summer, a popular time for traveling to visit family and friends. Whether you are traveling down the block or across the country, make sure you buckle up every time. Wearing a seat belt can reduce the risk of fatal injury by 45 percent. Seat belts save lives every day, but they are only effective if they are used. While Illinois currently has a 93.5 percent seat belt use compliance rate, unbelted occupants still account for more than half of those killed in motor vehicle crashes. The simple click of a seat belt could save thousands of lives each year. The "Click It or Ticket" campaign is administered by the Illinois Department of Transportation with federal highway safety funds.

Rogers also investigates crimes that occur and makes any apprehensions if need be, observes and respondes to various emergency and non-emergency situations and follows policies and procedure set forth by the department and city.

"My favorite part of my job is community policing," Rogers said. "I enjoy being able to get out and be involved with the community and the people in it."

Rogers has wanted to be a police officer since the age of five.

"I had contact with officers on a few occasions as a child and they always seemed to come when times were rough," Rogers said. "Their presence always made a difference and made me feel safe and I want to be that comfort for this community in any way that I can be."

Rogers attended Ashton-Franklin Center schools until her junior year in high school before transferring to Dixon, where she graduated from in 2009. She joined the Army National Guard in 2007 as a cook and trained with the military police and was honorably discharged in 2015 with the rank of specialist. She earned an associate's degree in criminal justice from Sauk Valley College.

Officer Rogers' interests include hunting, fishing, kayaking and working out and being healthy (she recently lost 40 pounds). She plays co-ed softball with the Oregon Park District. Spending time outside with her family is something she loves. She has an 11-year-old son and 12-year-old stepdaughter with her wife of six years, who works as a physical education teacher for a local school. The couple has two Labrador retrievers (one black and one brown) and two cats.

Rogers was working as a dispatcher for RPD in 2015 when the EF4 tornado hit just outside of town.

"I'll never forget the flood of 911 calls that were received that day," Rogers said. "What is amazing about working






## Sound the Alarm event held

## Farm-related stress and mental health

ARMING is a challenging and sometimes dangerous business. Weather, machinery, logistics and livestock can cause difficulties within a day's work.

Yet these can pale next to the concerns and stress that a farmer carries inside. Farmers are among the most likely to die by suicide, compared with other occupations, according to a 2022 study by the Centers for Disease Control and Prevention. The study also found that suicide rates overall had grown by 40% in less than two decades.

A new support system is available to help the Illinois farming community. It's as close as your phone. A helpline (1-833-FARM-SOS) will connect farmers to health professionals and services as part of a new statewide program.

The Farm Family Resource Initiative (FFRI) is a joint program of Southern Illinois and the Illinois Department of pilot program. Part of that regularly.

Agriculture. SIU's Center for Rural Health and Social Services Development has created a statewide network of resources to address the mental health

needs of the farming and agricultural workforce. In addition to the 24hour helpline, farmers can now access free webinars, blogs and trainings on psychological signs of stress at the website siumed. org/farm.

SIU Medicine con-

ducted a needs assessment in 2020 that found two out of three Illinois farmers considered farm-related stress and mental health to be significant problems. In addition to the regular stresses of farm management, the pandemic has created labor and supply chain disruptions.

In 2021, the Illinois Department of Agriculture received a \$500,000 USDA grant that al-

funding allowed the FFRI to go statewide. The remaining portion went to the University of Illinois Extension for farm mental health programming. The SIU

School of Medicine and University of Illinois Extension partner on many efforts.


## **ISP donating equipment to Ukraine**

**SPRINGFIELD** – The Illinois State Police (ISP) is donating more than 3,000 pieces of protective equipment, including body armor, ballistic face shields and ballistic helmets to help the Ukrainian citizens enduring the Russian

invasion.

By U.S. standards, this equipment can no longer be used by ISP or any other law enforcement agency within Illinois. Most body armor in the U.S. has a standard five-year life span. However, it will still offer some protection to civilians, humanitarian aid workers and others in the Ukraine. This surplus equipment must be disposed of if it is not donated to the Ukraine. ISP coordinated the donation with the Illinois National Guard, the United States

Department of Homeland Security, the United States Department of Commerce and the United States Department of State to transport the equipment as well as ensure compliance with all federal and state laws and regulations.

"We have the power, sewer, water and everything it takes. I'm very proud of that. I want to thank our city council for being exceptionally supportive. They want the community to be on track and to grow. This is a great project, and it will be the catalyst for many great things to come."

Toliver called being able to pull the project together on time in the middle of the COVID-19 pandemic and uncertainty "a huge feat." The new substation is the largest RMU has energized to date. He thanked project contractors BHMG Engineers, Whittaker Construction and Morse Electric for their work.

BHMG Project Manager Jason Jackson said the substation will provide reliability to make sure RMU is known as a reliable power source. The city is planning to build another substation in coming years on the west side of town.

"The electric department puts reliability first, and that's dedication," Jackson said. "Existing customers come first here. The team worked diligently. The supply chain is brutal, but the team did a great job of staying cool and working through the progress. I think it was a very successful project and I look forward to the next one."

## RTHS Girls Track **Trio advances to Charleston** Henkel, Meyers & Hayes qualify for 2022 IHSA State Championship meet

GENOA — Alivia Henkel's last race in the 300-meter hurdles saw her take a tumble near the beginning of the back straightaway that left several cuts and scrapes on her back. Friday's IHSA 2A Genoa-Kingston Sectional was a far different story, with Henkel clearing every obstacle and blazing past the field to win the event and earn her first trip to the IHSA State Championships.

Henkel hadn't run the 300-meter hurdles in under 48 seconds before the sectional, but that changed Friday evening, when the speedy sophomore clocked in at a personal-record time of 46.69 seconds, beating Kaneland runner-up Olivia Pastovich by nearly two seconds. Henkel will be one of three athletes who will represent the Rochelle Lady Hub varsity track and field team at the IHSA State Championships, which will begin at Eastern Illinois University next Thursday.

"I've been really excited for this meet and I had been anticipating this

said. "It means a lot to me to earn the chance to go to state and compete with my senior teammates. I've been working a lot on my form during practice and I think that was the biggest key for me today. It's a huge confidence booster and I'm hoping to do the best I can at state.'

Senior Liberty Hayes will join Henkel at the state meet next weekend. Hayes, who entered the sectional meet seeded seventh in the 100-meter dash, found her stride early and closed out a secondplace performance with a time of 13.53 seconds to secure her first-ever berth in the state meet. Hayes is the first 100-meter dash state qualifier for the Lady Hubs since Macey Ryan, who won the sectional title during the 2019 season despite being seeded fifth.

"I feel really good about advancing to state because I know the sectional won't be my last meet ever," Hayes said. "I was really nervous before the race, but I was really excited afterward. I had no idea what to expect before the race, but I knew I had to do my best."



Rounding out the Lady Hub trio of state qualifiers Friday evening was senior Teagan Meyers, who won the sectional title in the high jump with a clearance of 1.60 meters. Meyers went head-to-head with Sycamore's Karissa Clawson, who finished second on Friday after edging Meyers for the title during the Interstate 8 Conference Championships earlier this week.

"She was seeded above me at the sectional meet last season and she won while I took second," Meyers said. "I was seeded above her at the conference meet this season, but she got first and I took second again.
