Those shaggy cows

Scottish cattle now a familiar sight in Clinton

f you're new to Clinton, you might have caught a glimpse of an unusual creature, at least in these parts. No, it's not Bigfoot. And, no, it is not a muskox, although that would be a closer guess. These animals are real, and they have a long and

distinguished lineage. "I had gone to visit my brother near Denver, and his son was in the City of Denver pipe band," Becky Adams said.

Highland games were taking place nearby,

and they went to see him compete with his band. Becky was born a McIntosh.

"We were looking at displays and listening to Scottish singers, and they had a bunch of Scottish animals," Becky said. "And, the most gorgeous cow and calf we had ever seen." Dean and Becky had just bought their farm, located on the south edge of Clinton.

"And, we said, 'that's what we want out here," Becky said.

With a recently-arrived calf, the Adams now have 14 head of Highland cattle. The Adams recently received The Lee Wolfgang Recognition Award during the Heartland Highland Cattle Association (HHCA) convention. Wolfgang was a founder of the association in 1994. The HHCA was recognized fully by the national association in 1999.

"The award is for promotion and education about the breed," Becky said.

The Wolfgang award is the highest award given by the HHCA. Wolfgang and his family were some of the first people Dean and Becky met in the association when they began raising Highland cattle. The Wolfgang's were based in southwest Missouri. The HHCA is headquartered in Tunas, Mo. The organization is geared toward Highland beef producers, while the American Highland Cattle Association focuses more on farmers producing primarily show cattle. The first Highland cattle herd book dates to 1885, but they are known to have been traded as early as the 1720s. The breed developed in the Scottish Highlands and Outer Hebrides and are able to tolerate cold nearly as well as artic-dwelling caribou and reindeer.

Sen. Rose sponsors gas price relief bill

CHAMPAIGN – As gas prices continue to skyrocket, State Sen. ChapinRose(R-Mahomet) is sponsoring legislation to provide permanent tax relief for residents at the pump.

"Gas prices are out of control," said Rose. "While we can't control what a barrel of oil sells for, we can stop politicians from trying to reap a windfall off of the price spikes."

The legislation, Senate Bill 4159, would cap the state's sales tax on motor fuel at last year's level before the gas prices increased. The plan could potentially save drivers \$1 billion over the next fiscal year if gas prices reach \$5.50 per gallon as many experts predict.

The legislation works by targeting the sales tax on gas, so critical infrastructure dollars for road repairs would not be affected.

"The government shouldn't gouge you at the same time the price at the pump goes through the roof," Rose said.

The legislation was filed on March 10 and has so far received over a dozen cosponsors.



Land use committee talks major zoning review

CLINTON — The county could be on the verge of a major review of its land use rules after discussion by the land use committee probed the subject on Monday.

"There are a lot of things that don't apply that are in our book," committee chairman Terry Ferguson told committee members. "And, we've got a lot of things we're dealing with right now and need clarification."

The county board currently is dealing with how to approach commercial solar energy facilities erected on private lands, much as it had with the wind energy issue. A solar developer already has plans to build a facility near Weldon.

Some board members favor a less restrictive code with regard to solar development, while others prefer a heavily restricted solar ordinance. Other zoning topics that could be reviewed for change include ministorage facilities and Airbnbs, as well as agritourism.

"In order to avoid confusion, we need to get all that on the books in a logical place ...," Ferguson said.

"Some will be quick and easy, but others will need input," committee member Buck Carter said.

Reference also was made to the possible use

of the Land Evaluation and Site Assessment System (LESA), used by McLean County.

Based on its current zoning map, new residential development McLean zones in County, outside of the Bloomington-Normal area, are clustered contiguous to towns and villages. This virtually eliminates new residential development in open countryside in areas of wind energy projects.

Adams started The raising Highland cattle with four cows, in 1998.

Dean Adams grew up on a farm in southeast McLean County. He said his family's farm was still a "mixed operation," which included cattle, chickens, and, sometimes feeder pigs." They also grew corn, soybeans and clover.

"He was way behind by modern standards," Dean said.

Dean eventually went to college and received a degree in ag education. Becky is a retired Clinton Junior High School teacher.

"We hadn't been selling calves," Dean said. "We had been raising enough that one went to some friends of ours here in town, our son got one, and we got one."

Their friend helped watch the Adams' cattle when they were gone, so the calf was a thank you present.

Then, two years ago, COVID when the pandemic took hold in the U.S., Highland cattle prices "went crazy," Dean said. "We had been eating them or giving them to people to eat, when they were processed," Becky said. "But, the price more than doubled from 2020 to 2021." Generally the cattle the Adams sell go to people for breeding to create their own small herds. They have sold Highlands to people in Iowa and in southern Illinois, among other places.

winter.

"They're easier to raise than the Anguses and the Angus-crosses that I raised when I was in high school and college," he said.

And, Becky said Highland cows birth calves much faster than other breeds. Usually five to 15 minutes, she said.

"They're a little later than others," Becky said. "They're three years-plus when they have their first calves."

The Adams had one that calved a little earlier, at two and a half. That was one time when they had to call a veterinarian.

"And, that was 23 years after we first started raising them," she said. "We had never had to pull a calf until then, and that's why we called out a vet."

In fact, Highland cattle tend to give birth so quickly, it was the first time they had actually seen one of their calves born.

While most people are curious about the big,

"They would walk around with a foot of snow on their backs but not care," Becky said.

Then one March, the cattle disappeared. Dean and Becky searched their pastures, but no cows.

"I thought maybe they'd gotten loose and were wandering around Hillcrest or somewhere," Dean said.

Then they checked the barn, and there they were, hunkered down out of the weather.

"It was windy and raining and blowing rain in their faces," Becky said. "And, they didn't like that."

The Adams feed their Highlands on grass, hay and some protein. Becky said the meat marbles well and often wins taste tests over Angus steaks.

"In blind taste test, a chef will pick a Highland steak over an Angus every time."

Highlands live longer and take longer to grow. "It takes 24 to 30 months to get one of these insulating layer. The longer, outer coat is to shed rain and snow in bad weather.

"It's really wet in the Highlands," (Scottish) Dean said. "In 1997, we were there for 21 days and got rained on for 20 of them."

Like Dean, Becky also grew up on a farm. Her father worked in a factory but also enjoyed having the farm. Her family had a couple of cows, pigs and chickens.

"The cows were to provide milk," she said. "I had teenage brothers who would drink a gallon of milk, a jar of peanut butter and a loaf of bread as a snack after school."

They usually sold the pigs they raised. Money from one pig went into Becky's account for college, and the money from the other pig went into her younger brothers' account.

While they enjoy raising Highland cattle, the Adams avoid naming most of them because,

Illinois Extension looking for deer donation partners and sponsors

DECATUR – One in 10 people in Illinois struggle with hunger every day, including one in eight children. The Illinois Deer Donation Program, a new pilot project to expand community access to venison protein is coming this fall to twelve eastcentral Illinois counties.

University of Illinois Extension educators coordinating the program are on the hunt for meat processors, hunters and hunting organizations, and food pantries in and around Clay, Coles, DeWitt, Cumberland, Douglas, Effingham, Fayette, Jasper, Macon, Moultrie, Piatt, and Shelby counties to join them. The project will engage hunters to donate their deer and meat processors to produce ground venison, which will go to area food pantry clients. Clients will receive recipes and resources from Illinois Extension to help them prepare venison at home, which might be unfamiliar to some individuals and families.

this program successful," says Caitlin Mellendorf, Extension educator. "We look forward to building this network to increase food access in our communities, support our local businesses. and recognize the role of hunters."

Organizations and community members are also encouraged to donate to the program. Donations will go toward reimbursing meat processors for their time and effort. The program is funded in part by the Health Equity Achieved Together Project, a multidisciplinary collaboration with University of Illinois Supplemental Nutrition Assistance Program Education.

The Adams' said Highlands are easier to raise than other breeds of cattle.

"They're the closest thing you can get to a selfraising calf," someone commented to Dean.

Dean said they run their cattle through their three pastures, and then feed them hay during the



furry-looking cattle, Becky said the cattle's long horns sometimes put people off. But, the Highland breed is actually very docile.

"They're docile and have a maternal instinct," she said.

While Highland cattle were originally bred for cold climates, they do well in most areas. The Adams have helped people start successful herds in places like in Texas, Arkansas and Louisiana, as well as more harsh winter areas of the Midwest. Highland cattle are also raised in Australia.

They are so able to accommodate themselves to the weather, it turned out to be a long time before the Adam's cattle ever used the barn.

guys ready for market," Dean said. "And, that's on grass."

He said it was possible to raise them in 24 months, "by pouring the grain to them.'

"To me, that kind of defeats the purpose of the breed," Dean said.

Because it is a slower process to bring Highlands to market compared to other breeds, they tend not to be popular among large cattle producers.

"They want to bring their cattle to market in 18 months," Becky said.

Plus, because of their heavy coats, Highland cattle would have a difficult time surviving in a big feed lot. Under a Highland's long coat, the hair is about an inch long, which is the animal's

eventually, they are headed for the dinner table. Still, the cattle that make up the heart of their operation do have names.

Henry, the bull, watches over the "fold," as Highland herds are often called, and performs his necessary duties. Then, there is Mia, Aggie, Fiona and Flora.

In addition to their beef qualities, Highlands also do a good job of keeping their pastures clean.

"They're good pasture renovators," Dean said.

A dog and a couple of cats also roam the Adams' property, but it's the other animals that draw the attention.

Residents new to the Clinton area often comment about seeing "those shaggy cows."



Clinton Eagles Lodge raises record \$46,000 for fire departments

CLINTON — The Clinton Eagles Lodge is well known for its annual fundraising to help the Clinton, Kenney and Wapella fire departments. Each year for about a dozen years, the organization has been able to top its previous year's effort. But this year, their fundraising reached some new heights.

"COVID hit in 2020, and then in 2021 we tried to do something," said the Clinton Eagles' Deanna Long. "We had to do the drive-through breakfast and different events."

The Eagles had a small event for the Daytona race in August, "and had a pretty decent turnout," Long said.

"We ended up raising \$40,000, which was crazy," she said.

In 2020 the group raised \$37,000; in 2019, \$30,000.

Long said after spending a tough year running a number of fundraising activities, "we thought, we're never going to beat that,"

After the Apple N' Pork Festival, in September, Long said the group felt it had asked for so many donations during 2021, they would give it a rest until the day of their NASCAR event in Feb. 2022.

"We didn't know what to expect," Long said. "It was just going to be one day and done."

"But, then we raised a record amount again."

When it was all said and done, Clinton Eagles raised \$46,000 total from its single-day NASCAR event.

"It was the generosity of the people who were here," Long said.

Their race day auction was bringing in as much as \$2,000 for a pie from the Chestnut Family Restaurant.

"And then, the (restaurant) owner asked his wife if she would bake another one, and they sold another one. There were lots of people here supporting the fire department; it was wonderful."

Long said the public was overwhelmingly supportive of the Eagles NASCAR event but wanted to remind residents the Eagles conducts other fundraising during the year as well.

"Even in the off year (2021), we still gave to 20





of Veterans Affairsrated disability, heads up. They're proposing changes to the schedule for disabilities for auditory, respiratory and mental disorders.

If you receive compensation for one of those service-connected conditions, your rating won't change. The reason for changing the schedule, they say, is to "incorporate modern medical data and terminology" so veterans can receive more accurate and consistent decisions. Ratings will be based on "the most current medical knowledge" for the condition.

Some of the proposed

changes are:

-- Looking at tinnitus as a symptom of an underlying disease instead of a standalone disability.

-- Modernizing the rating criteria for sleep apnea and how it impacts earning capacity.

-- Evaluating mentalhealth conditions in terms of interpersonal relationships, life activities, self-care and cognition. It's proposed that the criteria include a 10% minimum and won't require "total occupational and social impairment" to reach 100%.

-- No current ratings will change, they say. If they're finalized, veterans can apply for increased

compensation. There won't be any reduction in compensation unless there's an improvement in the disability.

If you want to read more, see the Federal Register where the document has to be open for comment for 60 days. Go to www. federalregister.gov and search for "FR Doc. 2022-02049" for two of the disorders, and "FR Doc. 2022-02051" for the third one. Be sure to look through the public comments. A vast majority have to do with sleep apnea and its daily life impact, including earnings.

What concerns me at first glance is that there's a lot of removing subparagraphs, combining other disability aspects, renaming headings, adding section notes and reorganizing the various sections. How, one wonders, are the ratings personnel supposed to do a realistic evaluation of impairment? Even ratings clerks who have a lot of experience are going to be starting all over again in learning the system.





Your work is half baked

Welcome to my little corner of culinary delights. After having roasted the pork butt roast, the work is not yet finished.

I do not like seeing waste. I hope you are the same. The pork roast has left some very good stuff behind. There are the bone scraps and juices for stock. There is the oil rendered from the fat. There is the fond (bits of crisp meat) left in the pan. All of this can be converted into most wonderful results. All of this is covered in my articles regarding stock making and sauces. I shall refresh your memory on the procedures. The average person does not have a double sieve. A course and fine china cap or even strainers will work. For this article, I will use the double sieve. support the double sieve on the rim of a bowl or holding container. Pour the liquid from the roasting pan through the double sieve. The upper part with the course mesh strains out the larger chunks such as the onions, celery and garlic pieces. It allows the fond to slip on through with the liquid. The lower part with the finer mesh catches the fond and lets the liquid on through. The lower sieve is detachable. It is now easier to remove the undesirables from the fond. Refrigerate the fond until needed. The chunks caught above are trashed. The holding container now has the meat juices (pre-stock) and the oil. If you do not need to use it right away, then store it in the refrigerator. The oil will set and the juices should gelatinize. This is

In the event you need to use it right away, then the oil can be carefully spooned off. Or a baster that looks like a giant eye dropper can be used to suck it up. Refrigerate whatever is not immediately used.

What is to be done with these remains? Put the pre-stock into a pan with any pork bones you might have. Add water to cover is optional and then simmer. Reduce it to a demiglace. In the meantime, mix two parts of the pork fat to three parts all-purpose flour by weight. This becomes your roux.

After it cooks for five minutes, whip in the demiglace. Thin with prestock if necessary. Mix in a drizzle of Worcestershire sauce, a pinch of white pepper and salt to taste. Constantly whipping with a whisk. Mix in the fond and mild herbs if desired. While constantly whipping, bring to a full boil so the starch will set. Then remove from the heat. Consult my article béchamel on making sauce.

Lightly sauté stripes of roasted pork in its own fat and arrange them on either a bed of rice or noodles. Drizzle the gravy over that. Adjust seasonings and serve.



BRIDGE BITES

COUNTING THE HAND

This week we start a series of hands where the key to success is counting the opponents' distribution, in each case turning a guess into a sure thing.




West leads the ♦A and shifts to the ♣T. East wins the Ace and returns the suit, vainly hoping that West can ruff. But Declarer's King wins the trick, then comes the A, and a second Spade won by East. Declarer wins the Club continuation in Dummy, and leads the ♥Q which East declines to cover. What next?

Three tricks have been lost and Declarer must bring in the Heart suit for no losers if she is to make her contract. She can either play a low Heart to the Ace, hoping that East has started with doubleton King ... or she can lead the Jack, hoping to squash West's doubleton Ten and set up the Nine. There's no need to guess this one. West has six Diamonds for his 2+ bid, and has shown up with two Spades and two Clubs. That leaves three Hearts! So, Declarer plays a low Heart from Dummy and, sure enough, the King pops out of East's hand.

Of course, if East had known that Declarer would be so unsporting as to count out the distribution, then he would have covered the Queen with the King and given Declarer a guess for the ♥T.
