City planning for RV park

Fiengenschuh: 'We'd like to do it in the next couple of years'

ROCHELLE — The City of Rochelle has preliminary plans to put its own RV park at the Rochelle Municipal Airport in the future, City Manager Jeff Fiengenschuh said last week.

The idea came about when trying to coordinate with Chicagoland Skydiving Center, which operates at the airport and has an RV park of its own. The city wants more people to go to CSC events and visit the airport. Fiengenschuh said he wants to make sure the area is viable long-term, which the RV park would help to do.

"I really do think the airport is a valuable asset to the community and you have the Flight Deck Bar & Grill and CSC and I think there's a lot of things we can do to continue to move the airport forward," Fiengenschuh said. "Part of that was the RV park and if somebody wants to come out and watch the skydivers for a couple of days and CSC's RV park is full, is there a place we could put them at the airport where

they could stay and enjoy the festivities and earn some rental income for the airport?"

The city council unanimously approved an update to its airport zoning at a recent meeting that allows for special use permits for banquet halls, brew pubs, restaurants, assembly/meeting halls and public recreational facilities.

That issue came about after city staff conversations about and budgeted money for an RV park at the airport to generate more revenue. Fiengenschuh said a permanent RV park is in the city's five-year plan. He said the city would like to start work on the project "in the next couple of years."

The only property tax that is assessed at the airport goes to paying debt on the community hangar that will be paid off in 2025 or 2026. Otherwise, the airport is funded primarily by lease rentals of facilities like hangars and the sale of airport fuel.

Capital projects at the airport are funded 95 percent by state and federal dollars and five percent

local match, Fiengenschuh said.

"Obviously if we do something like [an RV park,] we want to make sure we can include that in those capital projects so we have funding coming in and it's not all on the local," Fiengenschuh said. "We have to be on our five-year funding plan. What drives that project is making sure we can get federal and state funding and if we can, where do we fall on their timeline for funding? Because they might have ideas of other projects that are more im-

portant to fund first. So we have to get on their schedule for funding."

About a year and a half ago, the city had discussions about the cost of putting in an RV park being in the neighborhood of \$80,000, Fiengenschuh said. But the city manager said that number likely would not be accurate in the future.

Another aspect of the project could be upsizing the airport's sewage line if it was going to see more usage.

Liquor license moratorium approved

City Council unanimously passes ordinance Monday evening

ROCHELLE — At its Monday meeting, the Rochelle City Council unanimously approved an ordinance limiting the number of class B (bar) liquor licenses in town.

The ordinance places a moratorium on class B licenses until May 1, 2023. A class B liquor license allows for the retail sale on the premises of specified alcoholic liquor as well as other packaged retail sale of liquor. The city will have no more than 10 class B licenses during that time unless the council decides otherwise. For the past few years, several council members have approached city staff about the idea of limiting the number of gaming machines in Rochelle.

Gaming licenses are granted by the state to businesses with the necessary liquor licenses and the city has no other way to limit gaming other than by limiting liquor licenses. The ordinance exempts all

current holders of class B liquor licenses and does not affect any other type of liquor license.

"Just to be clear, if we have someone come in that wants to start a new business, we could always change the ordinance at that time if it's something we want to do," Mayor John Bearrows said. "We have no control over gaming other than liquor licenses. We saw in the past two years as licenses came on board, the gaming revenue didn't increase, it was just spread out more. We all kind of felt like we reached a saturation point."

During an earlier and separate portion of the meeting, the council unanimously approved an ordinance to delete one class B liquor license for Sissy's Wild Card Saloon at 417 Cherry Ave. to create a liquor license for Kevin Crandall and Shane Erdman, who recently bought that business. Liquor licenses can't be transferred from former to new business owners.

Training facility

The council unanimously approved a resolution authorizing an agreement with Fehr Graham for no more than \$36,000 for the design and construction oversight of a fire training facility for the city and the Ogle-Lee Fire Protection

District. The facility will be at 920 S. Main St. and is also slated to serve as a utility training facility for Rochelle Municipal Utilities and could also be used by other city departments and area organizations.

Fehr Graham has helped develop concept plans for

the multiple sites considered for the project and is "very knowledgeable" about the needs of the city and the OLFPD, the meeting's agenda packet said. Costs will be split between the city, RMU, and the OLFPD.

NW Illinois districts struggle with teacher vacancies

86 percent of region's schools reported teacher shortages in IARSS survey

SPRINGFIELD — Schools were struggling filling teaching positions before the COVID-19 pandemic reached Illinois nearly two years ago.

The challenges of educating students during a prolonged health crisis has been an “added stress” for teachers in northwest Illinois schools, said Chris Dvorak, superintendent of the LaSalle, Marshall and Putnam County Regional Office of Education.

“I believe things have continued to get worse from the standpoint of COVID,” Dvorak said. “... I think it created more of a problem than we were before.”

The 2021 Illinois Educator Shortage survey released Tuesday by the Illinois Association of Regional Superintendents of Schools shows that 86 percent of school districts in the northwest region reported that shortages of teachers and substitute educators continue to worsen. The region spans from Jo Daviess County to Rock Island County to LaSalle County to Winnebago County.

The study noted that the top reason reported for educator vacancies has been retirement.

Chris Tennyson, superintendent of Lee, Ogle and Whiteside County Regional Office of Education, noted that one of the big things with teachers retiring early seemed to be the added stress of dealing

with COVID.

“It just made them think about maybe [retiring] quicker only because when they signed up for teaching, none of us ever imagined that we’d have two years like this,” Tennyson said. “It’s really nothing that you can prepare for.”

The most common strategy for covering vacancies is combining classes followed by outsourcing to third-party vendors and utilizing long-term substitutes. But, 96 percent of school districts statewide reported minor to serious problems with substitute shortages.

Regional superintendents reported that COVID-19 has made finding substitutes more difficult since those who have regularly filled those positions tend to be retired teachers who now do not want to come to a school and risk getting the virus.

“We had a good workforce of retirees, people that had worked in the classroom that were willing to come back and work within the district that they retired from,” Dvorak said. “A lot of those people pulled back and said, ‘Not knowing if it’s safe or not, I don’t want to put my health and myself at risk.’”

Not having substitute teachers to depend on, districts reported pulling instructors from class preparation time to cover for absences elsewhere. They also have been using administrators to teach, and have combined classes.

Joshua Nichols, superintendent of Amboy Community Unit School District 272, said the district there had to move Spanish classes online, combine classes and move teachers around to address staffing shortages.

“It’s very difficult because you’re trying to fill one hole and you’re trying to find the highest need,” Nichols said.

Being in a rural area, Nichols noted that staffing can be difficult, but the district has managed to do so by hustling to find people — especially those who just graduated with a teaching degree.


Fifty-two percent of districts statewide said the location of their schools negatively impacts the ability to recruit new teachers, the number one reason noted in the survey.

Over the past five years, superintendents continue to report fewer qualified applicants for teaching positions.

Dvorak noted that when he was a school principal, numerous applications would file in, but when he talks to schools around the district, they are happy if they get one or two qualified candidates.

“The question is going to be when we get out of (COVID) is how can we think and work to create some allowances where districts have the ability to put qualified people that are good with students in these positions when emergencies occur,” Dvorak said.

In the study, the IARSS recommends an effective

strategy to address shortages is through local solutions such as connecting middle and high schools to early education pathway networks, partnering with community colleges and offering educator preparation programs that would provide them with a student teacher experience.

Anji Garza, director of professional learning and education services for Lee, Ogle and Whiteside County Regional Office of Education, has focused on expanding the college and career education pathway program with the help of grants received from the state board of education.

School districts can work with local businesses and colleges to provide

students with a hands-on learning experience, along with offering incentives and tuition scholarships for students with a college and career pathway endorsement.

“We started having conversations about how we could address some of the pipeline issues and really grow our communities,” Garza said.

Through the CCPE program, Garza said that high school juniors and seniors have been able to receive a student teaching experience. The district has partnered with Northern Illinois University and Western Illinois University, along with Sauk Valley Community College, in offering dual credit classes.

Partnering with Illinois State University and local community colleges in his region, Dvorak said,

provides some remote classes so students don’t have to drive. Dvorak noted districts also do a lot of advertising and are constantly looking at potential candidates and trying to hire them if they are interested.

“So many educators that I talked to can give me one or two teachers in their life that got them thinking about education or made a difference in their life or ignited that passion,” Tennyson said. “And that’s what we need to remember — that we’re the best sales people for our profession.”

UTVs

The council approved an ordinance amending its code relating to non-highway vehicles by a 4-3 vote that will now allow golf carts and UTVs to drive on Caron Road, 20th Street, Veteran's Parkway and Steward Road.

In the original non-highway vehicles ordinance, UTVs and golf carts were prohibited from driving on higher-traffic roads utilized by semi trucks including the above roads and Illinois Route 251, Illinois Route 38, Interstate 88, Interstate 39, Flagg Road and Dement Road.

Recently, residents approached council members to request that non-highway vehicles be allowed on currently-prohibited streets, particularly Caron Road from 7th Avenue to the Wal-Mart entrance.

Councilwoman Kate Shaw Dickey voted against the change to the ordinance.

"When we did this, it was to be a neighborhood community thing, but safety was also at the forefront of what we were doing," Shaw-Dickey said. "To me, I don't believe that these vehicles belong on truck routes."

Bearrows said there have not been many issues with non-highway vehicles since the original ordinance and voted for

the change.

"I think people have shown that they're pretty responsible thus far and the police have said there haven't been a lot of problems with golf carts or UTVs," Bearrows said.

Shop local

A presentation was made at the meeting on the city and RMU's recently-completed Shop Local program.

The program encouraged residents and businesses to patronize local small businesses deemed nonessential who were forced to close during the COVID-19 pandemic. A \$60 reimbursement in the form of a credit on a future RMU bill was given to those that submitted receipts totaling \$300 from local businesses.

The program yielded over 5,755 participants, \$538,500 in RMU credits and \$2,981,109 in benefits to businesses.

Retirement

During the meeting, the city recognized Rochelle Police Deputy Chief Jeff Leininger, who retired Friday. Leininger was presented with a plaque by City Manager Jeff Fiegenschuh and had many RPD employees in attendance.

Leininger spent 23 years with RPD in numerous roles.

George W. Howe



"If we want to see more usage on that, we're going to have to do that and it could potentially be expensive," Fiegenschuh said. "But that hasn't been discussed in a while. The number one priority is getting on

that five-year funding plan through the FAA and we'll go from there." Fiegenschuh touted the airport's value to the community, including the nationally-known CSC, which hosted the skydiving national championships in recent years.

"The airport is a huge asset for us," Fiegenschuh said. "When you think of small towns, you typically don't think of airports. I think our mayor and council and those volunteers on that airport advisory board that give us ideas, a lot of them are pilots, their priority is to

keep the airport up and going and functional and they want to see it as one of our crown jewels. And I agree with that. We're blessed to have it and we need to continue to find ways to keep it sustainable and solvent. Part of that is getting more people here to visit."

An RV park would provide another recreational amenity for the community. Fiegenschuh called recreational amenities an important part of any community and said the future project could add to the list of things in town like The REC Center, the golf course,

tennis courts and parks. "It's a quality of life issue and what people value and it's important to have those types of amenities," Fiegenschuh said. "The airport is one key to a successful community. We want to make sure that key is working at all times."

How Stanley Larson came home

STANLEY “Mike” Larson was the pride of Rochelle in many ways.

Stan lettered in football three years, basketball three years, tennis four years and track one year. Conference championships, regional championships and three trips to the state tennis championships. Stanley was the 1943 Hackett Trophy winner. With 11 varsity letters, Stan was obviously a great athlete and is a member of the Rochelle Athletic Hall of Fame. Stan was also a member of the National Honor Society, Drama Club, president of the Student Council and a member of the band. In June 1943, Stan graduated from Rochelle High School.

In July 1943, Stanley enlisted in the Army and became a member of 394th Infantry Division. On Dec. 16, 1943, 19-year-old Stanley Larson found himself in the Ardennes Forest between the borders of Belgium and Germany. The Battle of the Bulge had begun.

At 5:30 a.m. the Germans began an artillery barrage followed by an attack led by the German 6th Panzer Army. The Allies fell back and the Germans held the area for the next month. When the Allies returned, they found that their dead had been buried and any taken prisoner were gone.

Stanley Larson was one of those missing. It was Feb. 1945 before Stanley’s status was changed to killed-in-action. His body was still not found. Stanley became just one of the more than 78,000 Allied WWII troops that were missing in action.

Flash forward to 1978 when teenagers Jean-Philippe-Spender and Jean-Louis-Seel were souvenir hunting in the Ardennes Forest. The two lived nearby and the Ardennes always had treasures to give up to those willing to search closely.

Six years later, the boys found their first body, a German soldier with a hole in its skull. In 1988, they found their first American soldier. This second find led the boys to form a club of like-minded

searchers. The “Diggers” would meet as often as they could, armed with metal detectors, shovels and maps, the group searched areas of the Ardennes for lost soldiers.

Searching near Hunningen, Belgium near the border with Germany, in March 2001, the Diggers discovered remains. Once they had ascertained that the find was actually human remains, the Diggers notified the German government.

Exhumation is a delicate process, protection of the evidence is essential for the identification of the remains. Every soldier found, German, American or other is treated with dignity and respect. Today Germany and the United States work cooperatively.

The German Army exhumed the bodies and found the remains of three American soldiers. The remains and artifacts from the site were packaged and shipped to the U.S. Army Central Identification Laboratory at Hickman Airforce Base, Hawaii. The experts at the laboratory did what they do best and using artifacts, dental records and DNA, they identified the remains of the three soldiers. Sgt. Frederick Zimmerman, PFC Erwin Fiddler and PFC Stanley Larson had been found.

The families of the deceased now had a choice. The remains could be buried in Belgium, they could be interred at Arlington National Cemetery or they could be returned to the family. For the Larson family, the choice was already made.

In 1947, Elmer and Ella Larson, Stanley’s parents, had purchased a plot and placed a marker honoring Stanley at Lawnridge Cemetery, Rochelle. On July 22, 2002, Rochelle’s Stanley Larson was laid to rest. More than 50 years after he had gone to war, his battle was over. His family finally knew the fate of their son, he was home.


accounting from ISU in 2014 and returned to FNB as a management trainee. In 2017 he continued his career path with Central Bank and was named an assistant vice president loan officer.

ROCHELLE — The Rochelle Lady Hub varsity bowling team battled DeKalb in a nonconference home match on Wednesday, falling 2,444-2,317. Freshman Cassidy Vincent rolled a team-high 505 series for the Lady Hubs (4-7, 3-4 Interstate 8) and sophomore Faith Adams followed with a 430 series against the Barbs.

The Lady Hubs avoided the sweep on Wednesday, winning the third game 793-758 but losing the series by 126 pins. Royalty led the Barbs with 188 to finish with a match-best 564 series, while Condon totaled 159 for DeKalb.

Lisle

The Rochelle Lady Hub varsity bowling team picked up a nonconference road win against Lisle on Thursday, winning 2,304-1,801. Freshman Cassidy Vincent shot a team-high 469 series for the Lady Hubs (5-7, 3-4 Interstate 8).

Rochelle outlasts Morris

Darby leads Lady Hubs to 43-37 win

ROCHELLE — Kendyl Darby looked like a freshman during the first half of the Rochelle Lady Hub varsity basketball team's home matchup against Morris on Friday. The second half was another story, however, as Darby showed confidence down the stretch and led the Lady Hubs to a 43-37 victory over the Redskins.

With multiple players out due to injuries, Rochelle needed someone to step up in the fourth quarter after struggling to hold off the Redskins throughout the game. That someone was Darby, who scored eight of her team-high 14 points in the fourth quarter to help Rochelle close out the Interstate 8 win.

"It felt really good to win that game," Darby said. "We came out really flat at the start of the game but I thought we came out after halftime with a much different mindset. My teammates were feeding me the ball and it felt amazing because I know I'm a freshman and even my coach said I played like a freshman in the first half. But I was ready to take over at the end and it's a really big confidence booster for me. We haven't had a double-digit winning season in a while so it was great that we earned our 10th

win tonight."

Rochelle (10-13, 3-5 Interstate 8) entered Friday's matchup without two starters including senior forward Abby Luxton and sophomore guard Alivia Henkel. Moriah Mayberry and Maddy Shannon spearheaded the charge for the Redskins, who came into the matchup seeking their first conference win of the season. Mayberry and Shannon each scored 11 points for the Redskins, who held a 13-12 lead after one quarter. Senior Adriannah Davis-Carter helped spark the Lady Hubs off the bench, knocking down a trio of mid-range jumpers to finish the first half with six points. Rochelle collectively struggled to convert key shots, however, allowing Morris to remain within two points of the Lady Hubs throughout the second and third quarters.

"We didn't play our best tonight, but coming out with a victory when we were losing at halftime and finishing the way we did was a big confidence booster for us," head coach Ryan McQuade said. "Adriannah has grown so much this season and it's been huge for us because not only has she been locking down on defense, but she's been producing on offense. Getting that level of production from her is huge for us." Darby began asserting

herself in the fourth quarter, attacking Morris defenders off the dribble and finding space inside to post up for shots around the basket. After scoring all six of her points on free throws in the first half, Darby converted layups on three consecutive possessions midway through the fourth quarter, giving the Lady Hubs a nine-point advantage and their largest lead of the evening on Friday. Senior Zoey Tabor scored eight points in the win.

"I got on our girls at halftime and I didn't speak directly to Kendyl, but I thought she played like a freshman in the first half," McQuade said. "But the way she responded in the second half... She grew up tonight and she looked like a varsity basketball player. Having the ability to get into a freshman like that and then see her respond the way she did... I really like that as a coach and it's a big moment for our team."

Sycamore

The Rochelle Lady Hub varsity basketball team faced Sycamore on the road this past Tuesday, falling 50-31. Senior Abby Luxton led Rochelle with eight points, while seniors Zoey Tabor and Josie Lundquist each scored seven points. Junior Torrin Nantz finished with six points.

RTHS Dance

Twirling to Bloomington

Chellettes advance to fourth straight IHSA State Championship meet

SYCAMORE—Qualifying for the IHSA State Championship has become second nature for the Rochelle Chellette dance team. Having reached the IHSA State Championship meet in each of the last three seasons, Rochelle sought out its fourth bid in a row on Saturday, with the girls putting together perhaps their best routine of the season in the IHSA 1A Sycamore Sectional.

Performing to Stephanie Rainey's "Simply the Best" and motivated for a return to the state meet, Rochelle scored 80.17 points to take third place out of 13 schools in the 1A class and seal a fourth consecutive state-qualifying berth. The Chellettes have formed a dance dynasty at RTHS, where they've advanced to the IHSA State Championship meet eight times in 10 years.

"We changed our routine halfway through the season and it felt really good to make it to the state meet with the changes we made so quickly," senior Jasmine Sarabia said. "We've advanced to the state meet in all of my years here at the high school and this opportunity is really exciting for

all of us. It's been amazing to see my teammates grow into the dancers they are now and the bonds we've made are a huge part of our success over the last few years."

It's been another successful season for the Chellettes, who won the Class 1A title at the Wau-bonsie Valley Invitational and finished fourth at the Interstate 8 Conference meet. Unlike past years where Rochelle's routine has expressed more sad emotions, senior Taylor Ponto said the team shifted its focus to a different routine that emphasized happiness and love.

"I thought the sectional was our best performance of the season," Ponto said. "We were a lot more confident with all of our turns and we didn't have many missteps. It's a much happier routine than we've had over the last few years. Our routine earlier this season was much more sad and angry, but we decided to switch things up and show more happiness and the sweetness of love. We really focus on portraying the emotions from the music throughout our routine."

RTHS for the IHSA State Championship meet on Thursday before performing in the preliminary round on Friday at 12:25 p.m. at the Grossinger Motors Arena in Bloomington. After missing out on the experience of performing live during the 2020-21 season due to COVID-19, senior Kayden Kannheiser and the Chel-

lettes are eager to return to the stage for their first live state performance in two years. Rochelle took 10th in Class 1A last season.

"The lights are on and it's a lot different than being on a gym floor where we can see everybody," Kannheiser said. "It's a different atmosphere at the state meet and I like it a lot. It's new and it's

an adrenaline rush for all of us. We're definitely excited and it means a lot, especially for me since it's my last year and I was injured last year. I didn't know if I would be able to come back and perform again after my injury, but it really means a lot to me."

Thirty teams in each class (1A, 2A and 3A) will participate in the pre-

liminary round, with the top 10 teams in each class advancing to the finals on Saturday. Rochelle last reached the finals during the 2019-20 season, when the Chellettes finished sixth in Class 1A. It's the first time in school history that Rochelle has reached the IHSA State Championship meet in four straight seasons.

Rochelle matmen bring home individual medal, ribbon honors

MAPLE PARK—The Rochelle Hub wrestling team shined at the Interstate 8 Conference Championship meet on Saturday, with several varsity and JV athletes bringing home individual awards during the tournament. Rochelle (19-6, 6-1 Interstate 8) finished second

in the varsity competition with 184 total points.

"Wrestling is about pride and honor and the kids need to continue wrestling hard for six minutes," head coach Alphonso Bruno said. "We talked throughout the day and I thought the kids really started to wrestle well and listen to what we've been working on during practice.

The kids really turned the tournament around and we took second in a pretty competitive tournament without one of our better wrestlers. The kids need to stay motivated for the regional and we want our whole team to be a part of that experience."

Freshman Xavier Villalobos won the 113-pound varsity championship, earning a 12-4 major de-

cision over Sycamore's Jonathan Buckheister before defeating Kaneland's Kamron Scholl by 7-4 decision in the finals. Freshman Joseph Nadig won the 120-pound varsity championship, scoring a first-period pin against Ottawa's Landon Marx and a second-period pin over LaSalle-Peru's Reegan Kellett in the finals.

Freshman Kaiden Mor-

ris won the 220-pound varsity championship, recording back-to-back pins against Sandwich's Kaiden Gustafson in the semifinal round and Sycamore's Jackson Funderburg in the finals. Sophomore Tommy Tourdot took second in the 106-pound varsity bracket, edging Morris wrestler Brandon Anderson by 4-2 decision before falling against Kaneland's

Cameron Phillips in the final round.

Junior Jaden Cook finished second in the 285-pound varsity bracket, winning by fall over Sandwich's Jaime Serrano and Morris wrestler Justin Hemmersbach but falling against Sycamore's Lincoln Cooley in the final round.
