Increase coming for Illinois minimum wage on Jan. 1

SPRINGFIELD – The minimum wage in Illinois is set to increase another dollar on Saturday, January 1, 2022. The new wage will be \$12 an hour.

Minimum wage workers are being encouraged to keep a close eye on their paychecks in the new year. Any time worked in 2022 must reflect the new \$12 an hour minimum wage.

Governor JB Pritzker signed legislation in 2019 putting the state on the path to a \$15 an hour minimum wage by 2025. There have been three increases in the minimum wage since the governor signed the wage hike legislation.

Prior to the increases in 2020, the last time Illinois raised its minimum wage was more than a decade ago in 2010 when it increased to \$8.25. In Chicago, the minimum wage is already \$15 an hour for employers that have 21 or more employees. It's \$14 an hour for smaller businesses.

The new law maintains provisions for employers to count gratuities to offset wages for workers, such as food servers, who regularly earn tips. Tipped employees may be paid 60 percent of the hourly minimum wage. However, these workers must still earn the minimum wage after receiving tips or the employer will make up the difference.

Workers under 18 years old and who work fewer than 650 hours in a year will earn a minimum wage of \$9.25 per hour beginning January 1.

The youth minimum wage rate will gradually rise to \$13 an hour by 2025.

All employers in Illinois are required to post the "Your Rights Under Illinois Employment Laws" where notices to employees are regularly posted. The color poster, which also covers other Illinois labor laws, can be found here in English and Spanish: Illinois Labor Laws

Lee County Dec. 20 COVID update

LEE COUNTY — The Lee County Health Department announces 196 new positive cases between Dec. 14-20.

Here are the ages that were reported: 47 under the age of 12, 29 in his or her teens, 16 in his or her 20s, 32 in his or her 30s, 25 in his or her 40s, 16 in his or her 50s, 18 in his or her 60s, 12 in his or her 70s, and 1 on his or her 80s. A total of 24 residents are hospitalized. The county also reported that the number of cases in unvaccinated individuals is 172 of the 196 cases.

As of Dec. 23, according to IDPH 45,297 doses of COVID-19 vaccine have been administered in Lee County, and a total of 18,839 people in Lee County are fully vaccinated, which is 55.05 percent of the population. A total of 20,471 have received at least one dose of the vaccine. A total of 8,147 people have received the vaccine booster shot.

2021 Lee County tentative multiplier announced

SPRINGFIELD — Lee County has been issued a tentative property assessment equalization factor of 1.0000, according to David Harris, Director of the Illinois Department of Revenue.

The property assessment equalization factor, often called the "multiplier", is the method used to achieve uniform property assessments among counties, as required by law. This equalization is particularly important because some of the state's 6,600 local taxing districts overlap into two or more counties (e.g. school districts, junior college districts, fire protection districts). If there were no equalization among counties, substantial inequities among taxpayers with comparable properties would result.

State law requires property in Illinois to be assessed at one-third (1/3) of its market value. Farm property is assessed differently, with farm homesites and dwellings subject to regular assessing and equalization procedures, but with farmland and farm buildings assessed according to standards based on productivity.

The equalization factor is determined annually for each county by comparing the sales price of individual properties sold over the past three years to the assessed value placed on those properties by the county supervisor of assessments/county assessor.

If this three-year average level of assessment is one-third of market value, the equalization factor will be one (1). If the average level of assessment is greater than one-third of market value, the equalization factor will be less than one (1). And if the average level of assessment is less than one-third of market value, the equalization factor will be greater than one (1).

Assessments in Lee County are at 33.39 percent of market value, based on sales of properties in 2018, 2019, and 2020.

The equalization factor currently being assigned is for 2021 taxes, payable in 2022.

Last year's equalization factor for the county was 1.0000.

The tentative factor is subject to change (1) if the County Board of Review takes actions which significantly affect the county assessments or (2) if local officials or others can present data showing that the Department of Revenue's estimates of the average level of assessments in the county should be adjusted. A public hearing on the tentative multiplier will be held between 20 and 30 days after the tentative factor is published in a newspaper of general circulation within the county.

A change in the equalization factor does not mean total property tax bills will increase or decrease. Tax bills are determined by local taxing bodies when they request money each year to provide services to local citizens. If the amount requested by local taxing districts is not greater than the amount received in the previous year, then total property taxes will not increase even if assessments may have increased.

The assessed value of an individual property determines what portion of the tax burden a specific taxpayer will assume. That individual's portion of tax responsibility is not changed by the multiplier.



Slow Burn

In a discussion of her new murder mystery, "A Slow Fire Burning" (2021), British author Paula Hawkins said, "Everything for me comes out of characters... people who are neither good nor bad, but who are essentially extremely complicated." She went on to explain that the way she creates these complex characters is by giving them a trauma or tragedy in their young past.

Thus there is Laura, a central character/murder suspect, who at age 10 was hit by a car which left her with lasting brain damage. She is in her early 20s, she drinks too much, makes bad choices, and generally can't help but get into trouble. Her illness, called disinhibition, accounts for her rudeness and tactlessness. Yet Hawkins calls her "plucky, someone who has a generosity of spirit." The trouble Laura is in this time is her limping away very early one morning from a dilapidated houseboat on Regent's Canal in London, blood splattered on her shirt and hands. In the houseboat, the body of young Daniel Sutherland lies sprawled in a pool of blood. They had a fight. Daniel called Laura a psycho-bitch. A witness watches her hurrying along the towpath.

Hawkins introduces a gallery of variously plausible suspects, each marked by tragedy, each coping with the slow burn of "guilt, shame, self-loathing, revenge." There is Daniel's Aunt Carla, cold, resentful, incapable of coming to terms with the accidental death of her toddler. For Miriam Lewis, Daniel's neighbor, it seems that the only thing that keeps her from exploding is her talent for manipulation. Irene is the only well-balanced character, a kindly old widow who is Laura's shelter from the storm. Theo Myerson is the sole male character, other than the corpse. He is Carla's ex-husband, a novelist who is not beyond stealing and publishing someone else's manuscript, but who is otherwise too good, too loyal not to be a suspect.

The best part of this murder mystery is the big reveal at the end, not so much of the perpetrator, but of who Daniel was and why he was murdered. But "A Slow Fire Burning" does have a serious problem. And that is Hawkins's equivalence of trauma with complexity of character. Human nature is far more complicated than she allows, or perhaps is capable of creating. For example, Laura is another version of Rachel, the protagonist in Hawkins's huge bestseller "The Girl on the Train." Both heroines are impetuous, unheeding, gullible. In short, Hawkins's characters are one-note actors reduced to what had happened to them rather than who they are. It makes for a monotonous landscape, which can be fatal in a murder mystery.




75 Years Ago Jan. 2, 1947

his year our church celebrated our Christmas Candlelight Service, something which is a very special and precious tradition for us. Another tradition in our family is watching, "A Christmas Carol."
