# Smithsonian Institution traveling exhibit coming to Clinton Jan. 3- Feb. 5

Voices and Votes examines the origins of American democracy and the people's right to vote

CLINTON — Vespasian Warner Public Library will host a traveling exhibit from the Smithsonian starting in Institution January. The Illinois Humanities Council notified the library in early 2020 it was selected as one of the sites in the state for the exhibit, Voices and Votes: Democracy in America. The exhibit is part of the Smithsonian's "Museum on Main Street exhibition program. "It was a two-step application process," Bobbi Perryman, Warner Library executive director said in 2020. "We had to write a grant, and then once we got past the first round, we had to write a more in-depth proposal, including how our space could accommodate the exhibit and what local exhibits we'd be putting along with it." The library hosted another Smithsonian exhibit in Institution 2009, "Between Fences." Warner Library's business manager Samantha Rusk attended training session a

CLINTON — Infectious disease experts say the Omicron variant of COVID-19 is growing at an exponential rate. That means the growth in cases jumps at an everincreasing rate compared to the previous recorded period. This explains why the world is seeing so many cases come on so rapidly.

All this, while the U.S. is still dealing with the Delta variant of the virus, not entirely, but primarily among unvaccinated people.

The Chief Nursing Officer of Warner Hospital & Health Services, Shanena Morris, issued a message on the hospital's Facebook page last week asking residents to be patient as it deals with the sudden increase in cases.

"Within the past month, our number of inpatient hospitalizations has Morris said Warner Hospital was allocating its resources to provide care for patients with the greatest need first.

"The reality of the situation is that you will experience longer than usual wait times throughout the hospital and outpatient services," Morris reported.

Morris posted Warner still was ahead of surrounding hospitals in dealing with the additional load but asked residents to be patient with the staff as its works through stressful times.

Voices and Votes and the Illinois Freedom Project, an examination of the pursuit of civil rights by and for African Americans in Illinois, will be open for viewing during library hours from January 3-February 5, 2022.

Illinois Humanities based its decisions on criteria such as each

applicant's organizational capability, its potential to benefit from the experience and the growth learning and opportunities associated with it, its preliminary plans for companion exhibitions and public programs, the suitability of its venue, the likelihood of community support and participation, and geographic distribution. Preference was given organizations to in communities with fewer than 25,000 residents.

"We're honored to partner with these six organizations to engage Illinoisans in thought and conversation about the vital role of civic



participation in our communities, our state, and our nation," said Gabrielle Lyon, executive director of Illinois Humanities. "All of these institutions make significant contributions to the communities and regions that they serve, and we're eager to support and learn from their work."




Image of "A woman living here has registered to vote" suffrage window sign, 1919. Courtesy of National Museum of American History & the Smithsonian Institution

"Many of our employees are working extra shift to ensure that we continue to meet our mission of providing our community with quality, compassionate care close to home," she posted.

In the health department's report for the period from Dec. 6-12, DeWitt County had 319 current active COVID cases. That included at least 67 new cases in Clinton.

The health department continues to offer COVID

vaccinations through their offices, including vaccinations for children ages 5-11, and they also are scheduling appointments for 3<sup>rd</sup> dose booster shots. DeWitt county has had 36 deaths from COVID, so far, up one from the previous week, with Piatt reporting County 14 deaths. More than 800,000 Americans have died from COVID, according to the Centers for Disease Control (CDC).

### Groups versus teamwork

elcome to my little corner of culinary delights. I shall begin by giving you the "bottom line" first. I do so in order to first get your mind on the right track. In this way, that which follows will be better understood. Bottom Line is "To be a member of a team is different from being a member of a group."

In culinary schooling, I learned proper procedures, as well as improper ones. This is how I interpreted my situation at the time. Groups of threes and fours were imposed upon us. The purpose appeared to be for cutting costs; paying a material's fee notwithstanding. In my view, this procedure gave no advantage educationally. I presume advantages to this can be given outside of cutting costs. However, I could see none. As a result, I am obligated to explain.

If I can learn from being part of a group vs. a team, I am delighted. However, if being in a group detracts from that education and/ or ignores any good suggestions given by a member, I am incensed. In my experience with novices, the one with least knowledge wishes to assume command. As a result, everyone suffers. That is not teamwork! That is an exercise in futility. One other feature to consider, is that in a group, there can be the occasional person that lacks necessary competence and therefore wishes to ride on another's proverbial coattails. By so doing, they do not learn. If then, everyone in the group is graded the same from the results, it is unfair for those that contributed



the most. The person that contributed nothing but receives an "A", has not earned it. It is not a true or fair evaluation. Examples will better explain.

In butchery class, I was assigned to a group. There were three of us. A man, insisting he knew the most from experience, assumed command. Disagreeing by observation, I elected The to go it alone. instructor initially refused but eventually, granted my wishes. Our project dealt with trussing a chicken, and creating a rolled roast. For the other two, the binding did not hold for the chicken and the twine on their rolled roast was much too loose.

The instructor tested the matter with a pencil. He would lift the roast up by the end-cord using that pencil. The weight of the roast should leave only a small gap. Their gap was roughly an inch. Mine had no gap. Needless to say, that if I was part of that group, my grade would have been an "F" rather than an "A". I was faced with a similar situation in advanced baking class regarding our final project. In this particular class, I had a different instructor. He was concerned that, if I went at it alone, my assignments would suffer without others to assist. Notwithstanding, I view that working with a proper team is great. But laboring under an ill prepared group is horrid. Until next time, peace to all.

1948 - The first completely solar-heated house became occupied in Dover, MA.


1951 - Libya achieved independence as the United Kingdom of Libya, under King Idris.

Joe ne man, Manchin, а West Virginia Senator, just put the proverbial monkey wrench in President Joe Biden's Build Back Better legislation by announcing his intention to vote against the bill. 



As the first quarter passed, the Maroons had five players scoring 17 points, while the Titans had only one player scoring for 2 points on free throws.


The second quarter was much the same with the Maroons going on an 11-4 run to go into halftime up 28-6.



### A PRACTICE FINESSE

The humble finesse is the first thing we learn, and we also learn that some finesses win, some lose. Later we learn that some finesses are purely for practice and serve no useful purpose. Here is a case in point.



**Both Vulnerable** South West North East 2NT Dbl 5♣ 1♠ 6+ All Pass Pass Pass West's 2NT was the "Unusual No Trump", showing both minors, and North eventually plunged (some would say recklessly) into slam. West leads a Club, your job is to make 12 tricks.


A Diamond loser is unavoidable, so you must guess the whereabouts of the ♥Q if this slam is to make. And

then there is the small matter of the Club suit. Do you take the finesse? Surprisingly, it's not necessary! We've already determined that you need to bring in the Hearts, and if that is the case then the 4th round of Hearts can be used to pitch the Club loser.

OK, you hop up with the A, and draw trumps, ending on the board. Who has the ♥Q? Surely East! West's bidding showed both minors (usually 5-5) and later he played three Spades. That doesn't leave room for many Hearts! So, Declarer runs the ♥J around and West predictably shows out. Another Heart finesse, the ♥A is cashed, over to the ♦A, then the Club loser goes on the ♥K. Making 12 tricks, losing just a Diamond.

Getting the Heart suit right did not require rocket science. Realizing that the Club finesse was not needed? Not so obvious. The winning train of thought was: I must lose a Diamond ... so I cannot lose a Heart ... if I don't lose a Heart then I can park the losing Club on the 4th round of Hearts.







If a pipeline right of way is adjacent to your property, you have a responsibility to ensure no new installations of landscaping or physical structures are placed in the right of way, which interferes with our ability to keep the pipeline safe through routine monitoring and maintenance.

Information about transmission pipelines operating in your community can be accessed online at npms.phmsa.dot.gov, courtesy of the National Pipeline Mapping System (NPMS).

### Carbon monoxide

- It is important that you have your furnace inspected by a qualified specialist.
- Be sure all furnace controls and emergency shut-offs are in proper working condition.
- Keep trash and other combustible materials away from your air, heating and water heating systems.

LOOK for blowing dirt, discolored vegetation or continued bubbling of standing water.

LISTEN for a hissing or roaring noise near a natural gas appliance or line.

SMELL for the distinctive, rotten-egg odor associated with natural gas. Natural gas is colorless and odorless, so we add a chemical odorant called mercaptan for easy detection of a suspected natural gas leak. This odorant has a distinctive "rotten egg" type odor. You should act any time you detect even a small amount of this odor in the air.

Note: Be aware that "odorant fade," while uncommon, can occur. Odorant fade occurs when a physical or chemical process causes the level of odorant in the gas to be reduced. This can happen in both existing gas pipe and new installations. Some individuals may not be able to detect the smell of the natural gas odorant because they have a diminished sense of smell, because the scent is being masked by other odors in the area or because the odorant has diminished so that it is not detectable.

If you detect even a small amount of this odor in the air:

DO NOT try to identify the source or to stop the leak yourself.

LEAVE the area immediately and move a safe distance away from the potential leak, while avoiding any action that may cause sparks.

AVOID using any sources of ignition, such as cellphones, cigarettes, matches, flashlights, electronic devices, motorized vehicles, light switches or landlines, as natural gas can ignite from a spark or open flame, possibly causing a fire or explosion. Natural gas is nontoxic, lighter than air and displaces oxygen. In severe cases, if not used properly, it can also lead to asphyxiation.

CALL Nicor Gas at 888.Nicor4U (642.6748) or 911 once you are out of the area of the suspected leak and in a safe place. Stay away until Nicor Gas or emergency personnel indicate it is safe to return.







### Seven tips to ready your outdoor power equipment for seasonal changes

(NAPSI)—After your lawn gets its last turn it off quickly and safely. cut before winter, it will be time to put away spring and summer outdoor power equipment, like lawn mowers, leaf blowers, and trimmers. What's next? Snow throwers, generators and other small engine equipment need to be readied for winter use. How and when you prepare your equipment for seasonal changes can save you time and money later, says the Outdoor Power Equipment Institute (OPEI).

With record-breaking sales of outdoor power equipment, homeowners are spending more time during the COVID-19 pandemic working or renovating their family yards. This means more people are using outdoor power equipment, and OPEI reminds everyone the importance of proper outdoor power equipment storage, maintenance and safe handling.

"During this very challenging pandemic, we've learned our outdoor spaces are more important than ever," says Kris Kiser, President and CEO of OPEI and the TurfMutt Foundation, which encourages outdoor learning experiences, stewardship of our green spaces, and care for all living landscapes. "Our yards, parks and schoolyards are our safe space for connecting with friends and family, acting as outdoor classrooms and offices. Green space also contributes to the health and wellbeing of people, pets and wildlife, and having the right outdoor power equipment to take care of it is key. But preparation is everything —understanding how to store equipment and get it serviced, how to operate it safely, and how to ready your space to use that equipment."

He adds, "Always follow your manufacturer's guidelines, and remember to keep kids and dogs away from operating equipment at all times."

Here are a few tips from OPEI to ensure your lawn mower and other spring equipment will be available for use when warmer temperatures return, and snow throwers and other winter equipment will be ready for use when the snow falls.

Review owner's manuals. Re-fa-1. miliarize yourself with how to handle equipment safely. Lost manuals can be found online. Save a copy on your computer if possible, so it can be consulted when needed. Be familiar with your equipment, and all its features, including how to

2. Service all equipment. Before storing spring and summer equipment, clean and service it or take it to a small engine repair shop. Drain and change engine oil and safely dispose of the old oil. Service the air filter, and do other maintenance as directed by the owner's manual. Check winter equipment and see if any maintenance and repairs are required.

Handle fuel properly. Unused 3. fuel left in gas tanks over the winter can go stale and even damage equipment. Before storing equipment, add fuel stabilizer to the gas tank, then run the equipment to distribute it. Turn the engine off, allow the machine to cool, then restart and run until the gas tank is empty. For winter equipment, buy the recommended type of fuel no more than 30 days before use. Use fuel with no more than 10% ethanol in outdoor power equipment. Use a fuel stabilizer if recommended by the manufacturer. Get more information on safe fueling for outdoor power equipment at LookBeforeYou-Pump.com.

Charge the battery. Remove and 4. fully charge batteries before storing. Don't store batteries on metal shelves or allow them to touch metal objects. Store them on a plastic or wood shelf in a climate-controlled structure.

5. Shelter equipment from winter weather. Store spring and summer equipment in a clean and dry place such as a garage, barn or shed. Winter equipment should be kept away from the elements, but be easily available for use.

6. Prepare, prepare, prepare. Make space in the garage or basement before the weather changes, so there is room to store larger yard items. Clean up the yard of sticks, debris, dog and kid's toys and other items that can damage or destroy equipment. Clear the paths used regularly in your yard, especially during the winter when snow can "hide" things.

7. Have the right weather appropriate extension cord for your generator. Keep heavy duty weather proof extension cords on hand to use with it. Ensure the length of the cord is necessary to operate the generator a safe distance from the house or building. Never operate a generator indoors, in a garage, breezeway or under an open window.
