Pritzker: Broader reopening of Illinois to begin this week

State still grappling with vaccine hesitancy

SPRINGFIELD - Gov. JB Pritzker said that Illinois will enter the "bridge"

And barring rent trends, Pritzker

Phase 5, or full reopening, will begin on June 11.

He also announced that residents can now obtain COVID-19 vaccines from their physicians' offices, rather than just designated vaccine sites, as public health officials continue to confront hesitancy within many communities to accept the vaccines.

Last week's announcement came as the state reached a new benchmark of having 55 percent of

adults age 16 and over, and 80 percent of people age 65 and over, having received at least one dose of vaccine, according to the Illinois Department of Public Health. Meanwhile, the daily number of new cases, hospitalization rates and intensive care unit usage have all been falling or leveling off.

"This good news comes with a caveat," Pritzker said. "We have all seen throughout this pandemic that this virus and its variants have proven to be unpredictable. Metrics that look strong today are far from a guarantee of how things will look a week, two weeks, a month from now. We saw that last August, and again last March.'

Historic window restoration being done at First Presbyterian Church

□ Church gets help from community members, businesses to fund project



MENDOTA - Scaffolding is in place and work has started on restoration of the stained glass windows at Mendota First Presbyterian Church. But to fund the costly project, as well as repairs to the building's chimney, the church had to ask for help. Thanks to support from church members, businesses and the community, they received enough donations to fund both projects.

First Presbyterian Pastor Susan Presley said she was overwhelmed with the response they received to their request. She explained that one large donor had given them \$30,000 for the projects and asked the church to match that amount. Hoping to meet that challenge, the church sent out one letter asking for donations.

"Between the church, the community and businesses that pitched in, we exceeded our goal and raised \$60,000 in two months," Presley said. "The response has been phenomenal. But this is a beautiful, historic church-it might be the oldest church building in continuous use in Mendota – and I think it is important to the community.'

The unique stone church was completed in December 1898, a year after the congregation's previous wooden structure had burned to the ground in October 1897. One of the early religious groups living in Mendota, First Presbyterian Church organized in 1855 soon after the founding of the town. The following year, they built a house of worship at the corner of Fifth Street and 10th Avenue – the same location as the current church - on lots donated by T.B. Blackstone. The steeple of the original frame building

is said to have cost about \$3,500 and there was seating for about 350 people.

As the town grew, in 1857 the Second Presbyterian Church was organized and they built a small church

building to the Universalist Society. The congregation, which had 19 members, then joined the First Presbyterian Church.

Soon after First Presbyterian lost their church in 1897,

to avoid another tragic fire. Fire was an ongoing threat in the early days of most communities. In 1870, a fire in Mendota had wiped out most of the businesses on the south side of Washington

Pritzker now says budget can include added \$350 million for K-12 schools



SPRINGFIELD - Citing an "improved" economic outlook, Gov. JB Pritzker announced his support to increase evidence-based education funding in the state by \$350 million in fiscal year 2022, which begins July 1.

In his February budget proposal, Pritzker originally proposed flat spending for education, citing "financial uncertainty" amid the COVID-19 pandemic.

It would have been the second consecutive year in which the state failed to add \$350 million to the funding formula – a number written into state statute as a goal aimed at driving new money to the districts that are furthest from funding "adequacy."

Adequacy is based on a number of factors, including class size and local capacity to fund a school district.



"Parents, students and educators can breathe a sigh of relief," Pritzker said in an unrelated news conference last week. "As an education advocate myself, I am really all too happy that our improved economic and fiscal condition allows us to increase educational funding.3

The announcement comes following the latest report from the Commission on Government Forecasting and Accountability, which cited improved revenue numbers for the

current fiscal year as the state works toward a full economic recovery from the pandemic.

Per that report, after revenues fell by \$2.74 billion last April, base general fund revenues in April 2021 grew \$1.779 billion, in part because April income tax payments were delayed one year ago.

"While the full story of FY 2021 revenues has yet to be written, given the onset of the pandemic, receipts clearly have performed much better than any prognosticator could have foretold one year earlier," the COGFA report stated.

"Despite periodic upward revisions in the revenue projections throughout the course of the fiscal year, each time those updated expectations have been met and exceeded," the report continued.

The Illinois State Board of Education, in appropriations hearings in the House and Senate earlier this year, pushed back on the governor's initial proposal to keep funding flat. Leaders in the General Assembly from both parties have done the same.

ISBE requested a 4.6 percent funding increase for FY 2022, including asking for an added \$362.1 million to the evidence-based



Compton firefighters rush to the rescue

COMPTON - May 1 started as a normal evening for the Kofoid family. Kyle Kofoid's parents were over for a cookout. In fact, he and his dad, Steve, both members of the Compton Volunteer Fire Department, were just starting the grill.

But at 5:46 p.m., the Compton Fire/EMS was paged to an emergency: "Female down, smoke in the house!" Although the home was in the far northern area of Compton's District, without hesitation Steve and Kyle both drove directly to the scene in rural Steward. On arrival, they first saw a kitchen with heavy, black smoke. Knowing someone was inside, they entered and found an unresponsive female on the floor. The Kofoids carried the woman out to the garage and when Compton's engine arrived, Kyle carried hose into the house and knocked back the flames. As other departments arrived, walls were torn out and the fire was extinguished.

The Paw Paw ambulance drove the patient to intercept with Mendota Advanced Life Support. If the Kofoids had not taken immediate action and left their cookout, the patient would not have survived.

Steve has been a member of the Compton Volunteer Fire Department for 34 years and Kyle has served for 20 years, first as a Cadet. "I saw my dad volunteer his time while growing up. When it was my turn, I joined the department. It just felt natural," commented Kyle. "I don't volunteer for fame. I do it hoping that if my grandma needed help, someone would volunteer their time and knowledge to help her."

The Compton Volunteer Fire Department is proud of Steve and Kyle for their quick response to this call. The Kofoids, along with nearly all fire and EMS in Lee County are volunteers, a fact not everyone in the area realizes. When a call for help goes out, these volunteers

In a story posted by ISU, McCauley said she was shocked to receive the award. Even as she was applying for it a year earlier, she thought there was no way she would ever get it. In fact, not so many years ago, McCauley did not even envision herself attending college. Even though she always had the

support of her family, in her younger years the school system was not a good fit for her. McCauley considered dropping out of high school but said she received positive feedback and encouragement from a teacher, which caused her perspective to shift. She began seeing herself as someone who was deserving and capable of learning and becoming. "The reason that I went into teaching

was because I wanted to be there for students too when they needed similar encouragement," she said in the article.

Rather than dropping out, McCauley graduated early from MHS and then attended community college. In looking for a four-year school to complete her degree, she wanted to go somewhere that had a good education program and heard amazing things about ISU's education program.

She has not regretted that decision and credits her ISU courses with Dr. Lisya Seloni, who taught her the value and complexities of multilingualism, and ISU Fulbright advisor Dr. Lea Cline for helping her achieve the dream of earning a Fulbright award. Even though it is a lot of work, McCauley encourages anyone considering a Fulbright application to at least try because you never know what life has in store.

McCauley is currently a student teacher at Chicago Public Schools' Benito Juarez Community Academy. She is excited about the opportunity to spend nine months living and working in Turkey where she expects to be around people who might think differently than her. She will also be immersed in a community where English is not the dominant language, which is also likely to shift her perspective and make her a more flexible educator.

The Fulbright program is the flagship international educational exchange program sponsored by the U.S. government and is designed to increase mutual understanding between the people of the







OGLESBY – Cannabis firm NuEra recently donated \$100,000 to Illinois Valley Community College's cannabis production certificate program.

NuEra's Principle Officer Keith McGinnis of Ottawa made the gift to IVCC President Jerry Corcoran, board member Jane Goetz and board chair Everett Solon at IVCC's Ottawa Center recently.

"This remarkably generous gift facilitated by Keith will aid significantly in our agriculture department's build-out of this program," Corcoran said, adding "It will provide the resources it needs to flourish.'

NuEra, headquartered in Wheaton, operates a cultivation center in Hillcrest, with medical dispensaries in Chicago, East Peoria and Urbana. NuEra also services

the adult use cannabis market in East Peoria, Pekin, Champaign, Urbana and two facilities in Chicago.

A pioneer in the Illinois cannabis market, the company formerly known as NuMed was one of the first licensed operators in Illinois' medical pilot program and has been serving the medical cannabis community since 2016.

Street, which prompted the formation of a fire company. Fire extinguishers were purchased and the city bought a hand-operated pump set on a truck. Water mains were laid and deep wells drilled but despite the efforts, they were not able to prevent a second huge fire the next year. The 1871 blaze began in a furniture store on Washington Street and within an hour, eight buildings were gone. Much early history was erased by uncontrollable fires including Mendota's Union Depot in 1885 and then the Presbyterian Church a decade later.

With the stained glass windows at First Presbyterian now well over 100 years old, Presley said it was important to have them restored and protected for the future. Over the years some of the leading had cracked and some of the windows had gotten bowed. In addition, the protective plexiglass coverings on the windows needed to be replaced. Presley noted that the largest window, which is 20 feet high, was originally installed in memory of a young woman who died in 1886.

Once funding was in place, the church turned to Willet Hauser of Minnesota to do the restoration work, which is expected to take about two weeks to complete. Presley explained that Willet Hauser is the main company that does restoration on large stained glass windows and the company

reopening of Phase 5 - certain capacity limits will be eased at various kinds of events. Restaurants, for example, will be allowed to increase from 25 to 30 percent of capacity, as long as people maintain six feet of distance from one another, while offices, personal care facilities and retail service counters can increase from 50 to 60 percent of capacity.

When the state reaches Phase 5, Pritzker said, virtually all mitigation restrictions will be lifted, although the state will still follow guidelines from the U.S. Centers for Disease Control and Prevention regarding wearing masks in large, crowded situations and maintaining safe social distancing.

Although Illinois has succeeded in getting a large percentage of its adult population vaccinated, IDPH reports that the daily rate of vaccinations has been declining as large segments of the population have been reluctant to receive their shots.

As of May 6, the seven-day rolling average of daily doses administered stood at 70,063, down from

per day in mid-April. But with the supply of vaccines now large enough to provide vaccines to anyone who wants one, Pritzker said he hoped that making them available through physicians' offices will make it more convenient for more people.

"This is about making it as easy as possible for those who have not yet gotten vaccinated to protect themselves from COVID-19," he said.

Still, there remain pockets of society that remain hesitant, whether that be for cultural, political or religious reasons, and the Pritzker administration is continuing its public relations campaign to reach out to those communities.

Joining Pritzker at the news conference was Dr. Rodney Alford, an African American pediatric and internal medicine specialist at Iroquois Memorial Hospital and a trustee of the Illinois State Medical Society.

"I myself belong to that community that has vac-cine hesitancy," he said. "I belong to the Black and brown community. I belong to the conservative Christian community. I belong

funding formula and \$50 million in added early childhood education grants. Their request would put

their state general revenue funding – which is the state's main discretionary spending account - at about \$9.3 billion.

Pritzker did not give details on the proposed ISBE budget, aside from giving his support to the \$350 million in added funding.

Per the budgeting process, both Houses of the General Assembly must approve a spending plan, then Pritzker would have the opportunity to sign or veto it.

House Majority Leader Greg Harris, D-Chicago, in a news conference that occurred in Springfield at the same time Pritzker's was going on in Chicago, said lawmakers are well into the process of planning a budget for the upcoming fiscal year. He said he was optimistic about the latest COGFA report, but the state's financial picture is still somewhat bleak.

Harris said. "The economy of the state of Illinois has been performing better than we had expected. And to be honest, we initially planned for this year very conservatively, not knowing what COVID would bring.²

Federal stimulus packages, including the recent American Rescue Plan signed by President Joe Biden, have aided the state's recovery, Harris said.

"It's given families some disposable income, that has allowed them to go out and spend, you know, to support their families," he said. "And that has in turn, raised our income taxes and our sales taxes in the state."

Lawmakers will have to project whether the rosy revenue projections for the end of this fiscal year will carry on into the next fiscal year. "We're seeing some very good numbers in the state, he said. "That being said, we still are looking at next year, a budget deficit of about \$1.4 billion that we'll have to solve for, and some new revenue could certainly help that. But it's not going to solve the entire problem.'

Jobless claims drop

Illinois also continued to see a drop in the number of new unemployment claims over the past week, although the total number of people unemployed remained at historically high levels.

The Illinois Department of Employment Security reported 15,134 new jobless claims were filed during the week that ended Saturday, May 1. That was down from 17,141 from the prior week, but it was considerably less than the 74,476 workers who filed initial claims during the same week a year ago.

Meanwhile, U.S. Department of Labor reported a total of just under 250,000 Illinois workers were receiving continuing regular unemployment benefits at the end of April.

One key part of the governor's proposal to balance the budget is to make several changes to the corporate tax structure - changes he calls closing corporate tax "loopholes," which Republicans call important business "incentives."

While Pritzker signed off on a number of those corporate tax cuts or credits in his first year, Harris said budgets are "dynamic things," and changing revenue pictures mean cutting expenditures.

"But the most important thing is we've got to protect the state budget, we've got to protect our core functions," he said. "We're happy to sit down and negotiate with the Republicans and the Democrats in the Senate, and if it's a will of folks to keep those in, I think that's what all of us would be willing to do." 

Pritzker is backtracking

SPRINGFIELD -- Politicians lie to get elected.

That's hardly startling. And in a state like Illinois, with its long and sordid history of corruption, that observation is about as newsworthy as: "the pyramids are old and big."

Still, one can't help but be disappointed when politicians back away from their word.

A case in point is Gov. JB Pritzker who ran for office on a platform of reforming the state's redistricting process.

During the last gubernatorial election, Springfield reporter Rich Miller surveyed every candidate seeking their party's respective nomination.

He asked each candidate if they would veto any redistricting measure not created by an independent commission.

Here is how Pritzker responded:

"Yes, I will pledge to veto. We should amend the constitution to create an independent commission to draw legislative maps, but in the meantime, I would urge Democrats and Republicans to agree to an independent commission to handle creating a new legislative map. That designated body should reflect the gender, racial, and geographic diversity of the state and look to preserve the Voting Rights Act decisions to ensure racial and language minorities are fully represented in the electoral process."

This wasn't one of those off-the-cuff remarks. Pritzker responded in writing to the question after having some time to think about it.


But today he is backtracking from that commitment.

Here is what he is saying now:

"Well, as I said, I will veto an unfair map. I have also said that in order for us to have an independent commission, we needed to have a constitutional amendment, something that would actually change the way the process operates today in the Constitution. That did not happen. So now, as we reach the end of this session and I look to the legislature for their proposal for a redistricting map, I'll be looking to it for its fairness. And that's something that's vitally important for our state, as an effect on the next 10 years and representation throughout the state."

Baloney.

The governor's original pledge wasn't predicated on a constitutional amendment. An independent commission can be formed by legislation or even a joint resolution.



Black brothers choose Mendota – 1900

(The following is from Jessica Nashold's Backtracks & Sidetracks column reprinted from May 17, 2000.)

It was just about this time of year 100 years ago that Mendota was gearing up for action in the 20th century.

High on the agenda was formation of the Mendota Industrial Association. Headed by a group of businessmen, it circulated information on Mendota's suitability as a factory site.


There were a few responses in early 1900. One from a feather-duster factory was considered briefly, but failed to attract financial support from the community. Then, on May 18. 1900, The Sun & Mendota Bulletin carried a small front-page item that proved to be of historic significance.

The item reported a meeting two days earlier between representatives of a manufacturer of mortising and sandpapering machines and officers of the Mendota Industrial Association. They met in the second-story club rooms of the Mendota Commercial Club on Main Street.

A brief account of the meeting indicated that owners of the company were four brothers named Black. They held patents on the machines they manufactured and were interested in a country location with room for expansion. Under the headline:

LAST CHANCE FOR A FACTORY

It was explained that the Black Brothers' product was superior "to any others made." Orders had been received from Berlin. After assessing what Mendota had to offer, they proposed renting the Donohue & Madden foundry. If citizens of Mendota would invest in capital stock in the amount of \$16,000, the brothers would take enough shares to maintain a controlling interest, protecting their patents. A new company would be formed in which salaries and some other business matters would be determined by a 2/3 vote of stockholders. The company would employ 40 to 50 skilled mechanics and was ready to move. Another meeting was scheduled for May 25 and in July it was agreed that Black Brothers Woodworking & Machinery Co. of Blue Island would lease the Donohue & Madden foundry building for five years or purchase it for \$14,000. Mendota citizens would purchase \$16,000 worth of stock and the brothers would own a \$16,500 share. The new firm would be Black Brothers Machinery Co. A contract was signed July 25, 1900.



Five carloads of machinery for the new factory arrived in Mendota.

Aug. 15-16, 1900, The Reporter exulted –

It will be a welcome sound when the whistle blows again.

SIDETRACK: As Black Brothers prepared to open in the Donohue & Madden foundry building, old-timers recalled that in 1869, D & M had provided hitching accommodations for 150 teams at their establishment. They also produced cast-iron hitching posts. One was mounted on Billy's train, which plied between Mendota and Chicago. Others could be seen at the curb in front of houses here and there around town.

Meantime, the 1900 census was being organized. In 1900, it was scheduled to begin June 1 and be completed July 1. The editor of the LaSalle Tribune was census supervisor for this congressional district. As the previous supervisor had recently died, the appointee pledged one-half his compensation to the widow. Enumerators in Mendota were J.G. Reul, 1st and 2nd wards; J.A. Lamberton, 3rd and 4th wards; Lawrence Prescott, "county district."

They receive 2 cents for each name.

It was estimated enumerators here would earn about \$100 apiece.

Kodaks were gaining in popularity. The Haass & Tesche drug store advertised a full line of dry plates, film, printing papers, developers and a "nice line of cameras." Mr. Tesche was a camera enthusiast himself and was confident "Kodak fiends" would be "taking a snap" of the eclipse of the sun expected May 28. sewer instead.

Those failing to do so will be prosecuted under city ordinance.

The death of the Rev. Justin Cronauer, pastor of Holy Cross since 1876, was deeply mourned. The funeral on May 8, 1900, was attended by 45 priests. School was dismissed so children of the parish could also attend. Father Cronauer was lauded as "stern by nature, but yet the friend of the poor and needy."

A more loved pastor could scarcely be found.

Had he lived one more year, Father Cronauer would have celebrated his 50th birthday and the 25th anniversary of his ordination. He had been suffering from rheumatism for many years.

Louis Waldorf, one of the prime movers in the Mendota Industrial Association, was completing a new cement sidewalk around his new building on the southwest corner of Illinois and Jefferson. Also on Illinois, there was a new cement walk the length of the block.

It is the finest stretch in town.

The Sun-Bulletin observed this made quite a change from when Dobbie's blacksmith shop stood where John Eckart's new building now held sway just north of Washington on Illinois.

Mushrooms were prolific in the month of May and many businessmen found time to go mushroom hunting.

Mushrooms are brought in by the bushel.

Admiral Dewey was feted at an entertainment in Central Music Hall, Chicago. A former Mendotan, Prof. C.W. Best, accompanied several vocalists on the piano.

Mr. Best sat within a few feet of the great soldier.

(Apparently Navy men could be

And, hey, he sure hasn't been banging the drum for a constitutional amendment since he entered office. The voters were hoodwinked.

Instead, Pritzker is kowtowing to Democratic leaders in the Legislature. The current process allows lawmakers to choose their voters rather than voters choosing their lawmakers.

"I don't think he realized, when he made the statement, just how important this is to legislators," said longtime statehouse observer Mike Lawrence. "He wants to get his proposals through the legislature and that isn't going to happen if he angers them by vetoing their map."

Illinoisans became far too familiar with this sort of mendacity under governors Bruce Rauner and Rod Blagojevich. It's disappointing that Pritzker has joined their ranks.

Pritzker spokeswoman Jordan Abudayyeh did not respond to requests seeking an explanation for the governor's change of heart.

Politicians distort and stretch their districts into strange shapes for two reasons: To get more seats for their political party and to get re-elected without having to run a substantial campaign.

Potential candidates don't run because they look at how a district has been drawn and know they can't possibly win.

Just consider: a 2014 study by Ballotpedia found that only 40 percent of Illinois lawmakers even had an opponent in the preceding election.

By comparison, during the same election cycle 100 percent of Michigan legislators had contested races. And California and Minnesota had competitive races in more than 90 percent of their legislative districts.

Worse yet, in at least half of the "contested" legislative races in Illinois, the incumbent only faces nominal opposition.

As for Pritzker's pledge to veto any "unfair" map approved by lawmakers, Lawrence said the odds of a partisan body such as the General Assembly approving a neutral, fair map are "slim to none."

House Republican Leader Jim Durkin was more blunt: "It will happen when hell freezes over."

That said, I have no doubt that if the Republicans controlled the process in Springfield they would be behaving in the same manner that Pritzker and Democrats in the legislature are.

Voters deserve to have choices when they vote and a governor who keeps his commitments.

Republicans no longer fazed by big spending

Once upon a time, Joe Biden's spending proposals would have launched mass demonstrations in opposition.

Little else would have been talked about in conservative media, and ambitious Republican politicians would have competed with one another to demonstrate the most intense resistance, up to and perhaps including chaining themselves to the U.S. Treasury building in protest.

In 2009, President Barack Obama created a spontaneous, hugely influential conservative grassroots movement on the basis of an \$800 billion stimulus bill and a health care plan estimated to cost less than a trillion. In 2021, Biden is proposing to spend about \$6 trillion in his first three big bills, and he can barely create more interest than the debate on wearing masks outdoors.

The conventional wisdom was that after the free-spending Trump years, Republicans would snap back to being deficit hawks when out of power. There's been some of that, but the relatively muted reaction to Biden's almost incomprehensible spending ambitions is testament to the fact that, no, Republicans simply aren't as interested in fiscal issues anymore.

The party has changed and would much rather talk about the border than the budget, and cancellations than Congressional Budget Office scores. Of course, no Republicans will vote for Biden's proposals and all will strenuously object, but that his plans won't engender the fierce reaction they would have 10 years ago is yet another way in which the Overton window has shifted on deficit spending.

What happened? The short answer is Donald Trump.

He demonstrated in vivid fashion that as the GOP coalition had become older and more working class, it didn't care as much about spending restraint or entitlement reform as the party's leaders had presumed.

Trump taught Republicans how to relax and love expansionary fiscal policy. By 2019, he was running a nearly \$1 trillion deficit at a time of peace and prosperity, and of course the pandemic blew the lid off in 2020.

After that, it's difficult for the party to come back and sound the klaxons again about the dangers of red ink.

Besides, the klaxons have issued false alarms before. Republicans realized that past dire warnings of imminent economic harm from deficit spending -- rising interest rates, spiking inflation, a debt crisis -- haven't panned out.

Indeed, this is one reason the center-left now believes all such admonitions should be ignored, and there's almost no upper bound on deficit spending.

Meanwhile, Republican politics has become focused on culture war issues, another change symbolized by Trump. These issues hit close to the bone in a way that fiscal matters don't. Conservatives worry about their free-speech rights getting trampled, about schools distorting the minds of their children, and about the country's history getting redefined -- and it's hard to get them to care more about a balance sheet than these other, more definitional questions.

None of this means that Biden has a free hand. He will presumably be less successful in getting all that he wants with his latest two roughly \$2 trillion spending bills. Even in a permissive environment, natural political exhaustion with the high levels of spending will kick in, and it's always more complicated when tax increases are proposed to pay for at least part of the bill.

Republicans aren't going back to their debt-obsession circa 2010, but they should aspire to be, if not the party of green eyeshades, the party of fiscal sanity.

Deficit spending hasn't led to damaging outcomes to this point, although that doesn't mean it never will. If interest rates do ever markedly increase again, the level of debt will strain the economy and force unpalatable choices on policymakers of steep tax increases or spending cuts or both. The status of the U.S. dollar as the world's reserve currency could be threatened.

Why increase these risks if it's not strictly necessary?

That question won't bring people into the streets, yet it's one that President Biden and his supporters can't persuasively answer.
