County board debates oversight of wind project

Begins search for third zoning official in just over a year

CLINTON - As the Alta Farms II wind energy project moves closer to construction, county board members varying with views on the role of zoning administrator continue to debate the role of that job and others connected to the project.

Board members who oppose and support the wind project also now find themselves scrutinizing a plan to build a large, commercial

solar energy project near Weldon. This has prompted the board to approve an expedited review of the county's solar energy ordinance.

The current status of the wind energy project dominated the board's Apr. 22 meeting.

Engineer Terry Fountain, with Cummins Engineering Corp., Springfield, gave lengthy overview to county board members during the meeting about his firm's functions in regard to the Alta Farms II special use permit.

Cummins has dealt primarily with roads and bridges but also has more recent experience with wind energy projects.

School board discusses local land acquistion

CLINTON At Monday night's monthly school board meeting, Superintendent Curt Nettles told board members the district was approached by Michael Killian about acquiring the three one-acre lots behind the First National Bank building across from the high school at no cost to the district. "I know at least a couple of you (board members) have interest in (acquiring the land)," said Nettles who added he had mentioned the offer to board members earlier in either an email update or verbally. The board needs to decide if they want to take the land and move forward with a plan for it, said Nettles. The superintendent said he would speak with the city leaders to determine what restrictions that land might have and then the board could brainstorm ideas for its use. Board president Dan Matthews said he didn't see why the district would not accept the land. "We'll figure out something to do with it."

Summer school Invitations to summer school have been distributed to selected students at all levels.

Douglas, Lincoln and Clinton Elementary school invites were mailed April 15 with a deadline of April 29. Clinton Junior High invitations were mailed last week with a May 7 deadline and high school students were invited in mid- March with a mid-May deadline. CES principal Sacha Young said she is pleased with the response and if the seats are not full on April 29, she will offer the session to more students. "I only had seven teachers say they would teach summer school and I want to keep my numbers between 10 and 12 in each classroom." High school principal Jerry Wayne said the high school will offer math and social studies in summer school. "I haven't gotten a lot of response back, but honestly, I'm not surprised. Most of my parents start worrying about summer school, and where they can get access, about the last week of school."

SPRINGFIELD

Members of a state Senate committee sharply criticized a recent audit of Exelon's nuclear power plant operations that suggested ratepayers may need to subsidize two of those plants by as much as \$350 million over the next five years.

Gov. JB Pritzker's office and the Illinois **Environmental Protection** Agency commissioned the audit last year, at a cost of \$208,000, after Exelon announced in August that it plans to shutter its Byron and Dresden power plants later in 2021.

The audit, by the consulting firm Synapse Energy Economics Inc., was released in redacted form on IEPA's website Aug. 14.

But Sen. Michael

who chairs the Energy Public Utilities and Committee, criticized many of the redactions and insisted lawmakers be given complete copies of the report.

"As my mom would say, son, you have more degrees than a thermometer," Hastings said. "And you expect me to make some sort of determination based off of a report that's halfway redacted. I expect more of us, and I expect more of our government in terms of a report. And I find it just very troubling."

Sen. Sue Rezin, R-Morris, the ranking Republican on the committee, also criticized the handling of the report, noting that the governor's office provided a quote for a news report about the audit that appeared online several hours before the report was given to lawmakers.

"So the governor's office felt compelled to release this report to the media and actually give the media a quote before any member who has

on this topic received the report, which we received at 10 o'clock that night," she said.

Deputy Gov. Christian Mitchell, who testified during the hearing, said the report had been redacted to protect company trade secrets, but he said lawmakers would be provided unredacted copies upon request.

He said also the governor's office responded media to inquiries because it began receiving inquiries about the report soon after it was delivered to Exelon, and because information about it was "out in the universe," the governor's office wanted "to make sure that we could get our side out."

Shutting down the two plants would be a huge setback for Pritzker's goal of transitioning Illinois' power industry to 100 percent renewable carbon-free energy or production by 2050, and the governor's office has already signaled its support for some kind of

But Mitchell said Thursday the administration has no intention of approving an agreement like the one made in 2016, as part of the Future Energy Jobs Act, that provided Exelon with subsidies totaling \$235 million a year for 10 years, "with no yearover-year review, or even midpoint review of the subsidy."

"At no point during that effort was Exelon forced to publicly open their books and demonstrate to ratepayers of Illinois that their subsidies were rightsized or necessary to keep the plants open," he said.

He also noted that Exelon's utility subsidiary Commonwealth Edison has been the target of a long-running probe by the U.S. Attorney's office in Chicago, "leaving the confidence of Illinois citizens and lawmakers at an all-time low after their admitted misconduct."

"Our main clientele is counties," Fountain said. "Working through the county engineers, we also have done a number of projects for townships."

Fountain said Cummins also performs work for private municipalities, companies and the Illinois Department of Transportation (IDOT).

Cummins has worked with wind energy projects in Macon, Logan and Mason counties, and now in DeWitt County.

"Of those five wind projects, this will be my three and a half wind projects," Fountain said.

Cummins is in charge of managing the road agreement for the project in addition to working with the county zoning office to ensure requirements for the Alta Farms II special use permit are met. Cummins contract is with developer Enel Energy.

"When I talked to chairman Ferguson (county board chairman) and Dee Dee Rentmeister (board administrative assistant) about what we were doing; it looks like we're going in the same direction," Fountain said.

Fountain attended earlier county meetings at which board members discussed the scope of an engineer's responsibilities in relation to the wind project.

"At that time, I wanted to make sure the county board was very clear that we were there to serve the county," Fountain said. "Even though we have that agreement with Enel, and they're paying for it, we wanted to ensure we are working for the county, and we have the best interests of the county foremost."

During those discussions toward the end of 2020, county board some members opposing the wind project questioned whether it was possible a firm working for Enel would be open and forthright with county officials. "We're still working on that premise, because once this project is over, we still want to have that working relationship on future projects that may occur within the county or with the townships," Fountain said. Fountain has been in regular contact with county highway engineer Mark Mathon and, until recently, zoning administrator Aaron Paque'. Ferguson mentioned during the meeting that Paque' had tendered his resignation a few days earlier. Paque' was zoning administrator for about a year, replacing Angie Sarver, who served the county through two contentious public hearing periods for the wind project special use permit. Mathon said he had worked with Terry Fountain since Fountain's days at IDOT and since with Cummins. "I have no reservation in that recommendation in selecting them to help us out with that part of the

process," Mathon said. After Fountain briefed the board about what Cummins was doing, the floor was opened for questions from board members.

Board member Aaron Kammeyer cited drainage and road issues with the Macon County wind project, asking Fountain if his firm had learned any lessons from that work.

"Yes," Fountain said. Fountain said in Cummins' experience with the Hilltopper wind project in Logan County, they visited some sites of the project several times to have issues, such as grading along roadways, corrected. He said similar issues on the Whitney Hill project also arose.

Enel Energy and White Construction were the companies building those projects as well as the Alta Farms II project.

Fountain said Enel and White also had learned from previous projects and adjusted their best practices.

"So, hopefully, those things they'll just do because they know it works," Fountain said. "It makes the county, the township and Cummins Engineering а little happier because it's done the way it should have been done."

Kammeyer zeroed-in on some of Fountain's language, questioning if the county could have confidence in what was promised being delivered. "You're using words like 'recommend' and 'maybe'," Kammeyer said. "I really hope we're looking to restore the county to the state it was prior to about two weeks ago," referring to the setup of the lay-down yard for the Alta Farms II project. The lay-down yard, located about a mile north of Hallsville, has social media buzzing with comments from people opposing the wind project, many whom will live in the vicinity of the wind turbines. The job of zoning administrator soon came into the sights of some board members. Kammeyer referred Fountain to portions of Cummins' contract. "It basically says you're taking directions from the zoning officer and what things you should be looking at, what things you need to be reviewing," Kammeyer said. "I'm troubled by that a little bit because, as you probably well know, most likely, being a zoning officer that actually has the acumen to interpret what you need to be looking at, all facets of that operation, is kind of an ambiguous situation." Kammeyer pointed out the county now was temporarily without a zoning officer.

project that most zoning administrators really don't walk into."

Fountain said his make firm would recommendations, "and it will be up to whoever the zoning administrator is to actually sign-off on those building permits."

The board appointed Dee Dee Rentmeister interim administrator zoning until a new permanent administrator is hired.

Fountain said he had made an effort to ensure he was versed on the county's requirement for the permits.

Board chairman Terry Ferguson said he had no reservations with respect to Cummins working for the county.

Kammeyer said he felt, since Cummins was taking advice from the county's zoning administrator, "we have somebody competent in that position to provide instruction."

Ferguson if said Cummins recognizes something in the project that is not in compliance they have the option to handle it themselves or refer it to the county zoning office.

Kammeyer said he didn't doubt Cummins' knowledge or capacity but felt the county needed "the appropriate resource that truly can fulfill the role as zoning administrator."

"I think they've got a good handle on what they need to do right now," Ferguson said.

Kammeyer continued to return to the subject of the zoning administrator.

"Do they not take direction from the zoning office," Kammeyer asked.

"If it's something they can handle themselves (Cummins) ...they're going to go ahead and take care of it," Ferguson said. He said issues that come up during the project would be identified and dealt with. Enel has a procedure to provide the county monthly with anv complaints that arise and how they were resolved. "And, I think this is where Cummins can assist the county," Fountain "We're working said. with zoning to get a daily report of any complaints along with resolutions." Ferguson has been reluctant to criticize former zoning administrator Aaron Paque', publicly supporting the job Paque' Kammeyer later did. commented he was not criticizing Paque' but was concerned about having a zoning official with little experience with wind energy projects. During the April land use committee meeting, Paque' came under sharp questioning by some committee members when they were caught by surprise by the appearance of the lay-down yard for the wind project a few days earlier.

require a building permit," Ferguson said. "Aaron (Paque') made the call that it did meet the criteria for the special use permit."

During that meeting, Paque' said a letter issued to Enel officials was clear that approval of the lay-down yard "did not absolve them of meeting the other conditions."

Paque' said his office would not issue permits unless it was certain Enel had met all conditions.

"That's the reason the permit (for the lay-down yard) was submitted on March 1 but didn't get approved until March 23," Paque said. "We wanted to make sure every bit of it was in order."

Land use committee members concluded they wanted more frequent communications from the zoning office with regard to the wind project.

During the public comment portion of the April 22 board meeting, former board member Lance Reece had harsh words for board members he felt were simply trying to delay progress of the wind project.

He suggested many of the board members? comments were grandstanding.

Reece said he felt a motion listed on the agenda about transparency contained "buzz words but they don't have any substance."

"The board is not the project manager," Reece said.

He said the wind project was the responsibility of the developer and the contractor.

"If there's a safety issue, absolutely, the county needs to be made aware of it, and it needs to be rectified," he said. "But, after listening to some of the comments about a zoning administrator, I would think it's going to be difficult to find somebody who wants to work in that environment."

A most important commodity

elcome to my little corner of culinary delights. Before getting into blanching with water, one should first know the basic functions of water.

Water is probably one of the most important elements on this planet. Science states that life could not otherwise exist. Legend holds the premortal ooze responsible for beginning life. Even the Holy Bible equates everlasting life to the waters of life. I am no scientist or theologian but a chef. So, let's cook.

Most vegetables are made up of 75 percent water. The human body is made-up of about 90 percent. Much of what we do in culinary is done with water. Water serves as a cooking medium, as an ingredient and for making beverages.

Conversely, it is desirable to extract excess water from things such as potatoes and onions for use in casseroles. Dehydrating foods for storage purposes is to remove as much water as possible. Water is a medium for boiling potatoes and cooking pasta. It works well as a solvent for blending flavors and seasonings as well as for rinsing foods and cleaning dishes and floors. Let us not forget its usefulness in steaming and canning foods.

Water, in pure form at sea level, freezes at 32° F / 0° C and boils at 212° F / 100° C. That is simple straightforward physics. higher altitudes, At water boils at a lower temperature. It is a fallacy to think that water boils faster if salt is added. The boiling point of water is slightly raised whereas the freezing point is lowered if salt or sugar is added.

As a rule, in good cooking, salt is added toward the end of the cooking process or after. The same is generally true for sugar. Heat affects foods in such ways that one must be vigilant and careful. One should know what can be done with water and how to do it well.

In cooking, the best way to get the water boiling is to fully raise the heat and keep the pot covered. A covered pot helps to trap the heat allowing it to build quickly in this enclosed area. However, do not increase the flame so high that the flames lap over the sides of the pot. That causes lost heat and thus unnecessary waste.

Once the water begins to boil, turn down the heat to simmer. Reaching the boiling point is dependent upon the BTU amount. That would be the British thermal unit. It indicates the amount of energy required to rise one cubic centimeter of pure water to one degree centigrade.

The PH level of water has importance. PH measures the acidic or alkaloid level. In pure water, the PH level is at seven. Any reading above seven indicates an alkaline or base solution. Conversely, a reading below seven indicates an acidic solution. The PH level slightly affects flavor, texture and even the nutritional quality of the foods being cooked. Culinary involves various sciences. Until next time, peace to all.







All vets now eligible for COVID vaccine

With the SAVE Act (Strengthening and Amplifying Vaccination Efforts), the Department of Veterans Affairs is opening the doors to vaccinating all veterans, spouses and caregivers. This is a major step forward from the previous rules of only vaccinating certain groups of veterans employees. and The numbers of those now eligible has gone from 9 million to 33 million.

First on the list are veterans who use VA health care, veterans who never enrolled but use care and medical services in the first 12 months after separation and the



caregivers for those veterans.

Under the new rules, the following will then be eligible to receive the vaccine:

* Veterans who can't enroll in VA health care;

* Veterans who are eligible for hospital care, medical services and nursing homes abroad in the Foreign Medical Program;

* Beneficiaries who are eligible for care due to a specific disability or death of a veteran;

* Caregivers of veterans participating in the VA's Medical Foster Home Program, Bowel and Bladder Program,

Home-Based Primary Care Program or Veteran Directed Care Program;

* Spouses of veterans. If you can't make it to the VA and can't find federal or state vaccination sites in your town, keep an eye out for VA-organized pop-up vaccine clinics. I recently went to an allveterans pop-up clinic held in my town, one of eight rural locations that were opened in my state. It was impressive. The event had been widely announced

on the news, on Facebook, in the newspapers. Somebody did a good job of spreading the word.





Weather History

April 30

1962: A squall line moved from St. Louis northeast to Chicago. The area from Hardin to Springfield to Hoopeston was greatly affected, as was the area from Pontiac to Joliet to Chicago. The southern end of the squall line experienced winds of 55 to 90 mph, while

the northern end had winds of 65 to 110 mph with unofficial gusts to 135 mph. At Rantoul, two people were killed by falling debris. In Springfield, a boy was killed when a chimney fell through a school roof.

1997: A line of severe thunderstorms moved across Illinois

during the afternoon and evening hours. Several tornadoes, most of them weak, were produced, as well as strong winds gusts as high as 70 mph. The most damaging tornado occurred in Fulton County, when two separate thunderstorms merged. In the town of Fairview, several homes were damaged, with two people injured. In Middle Grove, the tornado destroyed two mobile homes and damaged 25 houses. The tornado then took an intermittent northeast track across Fulton, southeast Knox, western Peoria, and Stark Counties. Other tornadoes touched down in Macon, McLean, Adams, Hancock, and Montgomery Counties.




Declarer's seat, with nds in view. West even, East plays the two Spades, a Heart nds will get you to ossibly go wrong?

Many Declarers would jump right in, grabbing the ♥A, and rattling off the Diamonds. But, as it happens, they don't rattle and the 5-1 split derails the contract. Declarer cannot cash four Diamonds, that would set up the defense's sixth trick ... and if he cashes only three Diamonds there is no way to come to eight tricks.

When things look easy, Declarer is advised to consider the worst-case scenario. In this case it is a bad Diamond break, giving Declarer only seven top tricks. Can Declarer do something about that? Yes, before going all-in with the Diamond suit, Declarer can hedge his bets by playing Clubs first, building a trick there just in case the Diamonds misbehave. The defense can take their three Hearts and two Clubs but that is all they get. Did you play on Clubs before Diamonds? Well done if you did!

One more point. Did you win the Heart at Trick 1? Or did you duck, planning to win the second Heart, in case the suit was 5-1? It's safe to win the first trick, the Hearts cannot be 5-1. East played the King, so he denies the Queen and cannot have five in the suit ... and if West had QJT87 he would no doubt have led the Queen. So, it's OK to win the first trick and play on Clubs, safe in the knowledge that the defense cannot cash six tricks. If you cautiously ducked the first Heart then it would be just your luck for the defense to find the killing Spade shift.






