# Apple 'N Pork Festival back in 2021

# Plan to safely open museum's 2021 season currently underway

CLINTON - Residents are celebrating on social media after the word went out last week that the Apple 'N Pork Festival is on for this year. The museum board announced officially this week that the festival was scheduled for September.

The DeWitt County Museum Association board of directors announced plans are underway for the festival on Sept. 25-26. The DCMA Festival Committee and the museum board made the decision, "after a great deal of consideration." The

festival committee co-chairman consulted with DeWitt County Public Health Administrator David Remmert before recommending the festival go on.

The festival plan hinges on Illinois meeting the requirements to reach the "Bridge Phase" of the state's reopening plan,

but museum manager Joey Long said the mood was one of "cautious optimism."

Festival committee cochairman Terry Ferguson told the museum board that Remmert suggested they, "go ahead and plan for a normal festival and hope for the best."

# All outside Chicago will be vaccine eligible April 12; reopening changes announced

'Bridge' phase raising limits to take effect when 70 percent of seniors vaccinated

COVID-19 vaccinations intensive care beds being in Chicago, noting the state announced a "metricbased" phase-in to greater reopening Thursday. The so-called "bridge phase" to reopening can begin when 70 percent of seniors 65 years of age and older have received at least their first dose of the vaccine, according to the governor. # Plaintiffs file for dismissal of suits against county, Enel

### RPC vote fails to recommend rescission of wind energy permit

CLINTON The same week the Regional Commission Planning voted to not recommend the county rescind a special use permit for the Alta Farms II wind

energy project, plaintiffs opposing the project in two lawsuits against the county filed to drop their suits.

On Wednesday, Mar. 17, a suit brought against DeWitt County and Enel Energy was dismissed without prejudice at the plaintiffs' request, according to circuit court records. The suit was filed in Oct. 2020 by 69 residents living within the footprint of the planned wind project.

The suit alleged the

county board failed to follow the county's wind energy ordinance when it granted Enel Energy the special use permit in 2020. Among the points of the suit, plaintiffs claimed the county also failed to require a complete decommissioning plan for the project.

Concerns the of residents filing the suit include safety issues caused by potential wind tower interference with weather radar, sound levels and negative effects on surrounding property values, among others.

The day before the suit was dropped, a tie vote taken by the county's Regional Planning Commission resulted the commission's in not forwarding а recommendation to the county board to declare Enel's special use permit null and void. The RPC vote was 3-3 with one abstention.

# Plan for summer school approved

CLINTON - Retired teacher Karl Diener spoke to the Clinton school board Tuesday night to ask them to reconsider their policy requiring remote learners to remain remote through the end of the semester. Diener asked that these students be allowed to return for the final quarter of the 2020-21 school year if they so choose.

The Clinton school board approved its school opening plan in July 2020. Parents who chose remote learning were to keep their students remote until the next semester.

Superintendent Curt Nettles said in October the board discussed the possibility of letting remote students return to in person learning

prior to the end of the semester, but ultimately decided not the change its policy.

Nettles said some students did choose to switch from remote learning to in-person learning with the new semester in January.

Due to the changes in Covid restrictions, some board members expressed a desire to consider changing the policy and allow remote students to return to the classroom. However, because the topic was not on the meeting agenda, no action could be taken.

Board president Dan Matthews said: "We made a policy for the year. I think next time we set policies we need to leave a little wiggle room, but I think we have a good thing going. We have a summer school opportunity now. I feel strongly that we have to stay the course."

said notices Long to organizations and vendors to reserve their spaces for the festival went out "a little later than normal." But, she said, in general, the planning and preparation process was moving along pretty much as usual.

"We were holding back and waiting to see what exactly was going to happen," Long said. "Because it changes so much even week-toweek."

Long usually starts with some of the festival planning as early as January but held off this year to gauge the situation.

"We're on track about as much we have been in years previously," Long said. "But just maybe a few weeks behind because we wanted to see what kinds of changes might take place."

The museum was closed for the season in 2020, and special events mostly were canceled because of the state COVID-19 restrictions.

"I made the best of the circumstances as did the board of directors," Long said.

the closure, During however, the museum anything was but inactive. New programs were implemented, such as the Porch Post outdoor presentations. The Homestead Breakfast was changed to a "grab & go" drive-through event, and Santa Night was a drive-by event.

Long has increased the museum's social media outreach, regularly posting photos of museum artifacts accompanied by stories of local history. She also applied for grants to support new projects and offered "porch pick" shopping, via online/ telephone ordering days at the museum gift shop.

The Homestead Gazette newsletter, mailed DCMA to members, continued, and a rebranding of the museum will include a new logo and website.

"Through all of these efforts, we were able

to continue to engage with the public and uphold the museum's mission statement and at the same time be in complete compliance of all public health mandates put forth by the State of Illinois and many projects (maintenance, educational, etc.) were launched," Long said. The museum's annual

season normally would begin on April 1, but to protect the health and safety of museum visitors and staff, Long said they currently were working on an opening plan "as requirements and mitigation recommendations continue to evolve.


# What is important?

Following the meeting, Nettles added, "At this point the board is not poised to take any action to change the policy to allow (return to in-person learning)."

#### Summer School

The board approved a plan for summer school through 2023. "It doesn't mean we have to do summer school, but we can," said Nettles.

Kindergarten through

8th grade students will be invited to summer school based on academic need. High school students will attend for credit recovery.

Summer school classes will be held from June 7 to July 1, Monday through Thursday from 9 a.m. to 12 p.m. with Covid protocols based on whatever is in place by the state.

"I think we'll do whatever we need to do to help (students)," said Nettles.

In other business, the board:

• Heard a presentation about Douglas School's after school tutoring program.

• Approved a bid of \$563,396 from Taylor Roofing, Belleville, to replace the roof at Clinton Junior High School.

• Approved a bid of \$51,200 from Henson Robinson of Springfield, to replace the water heater at CJHS.

· Changed the date of the April board meeting to 6:30 p.m. on April 26.

Approved the employment of Scout Duncan Savage, Douglas kindergarten teacher for 2021-22; Lori Berger, Douglas leadadministrative assistant; Karen Castillo, CJHS aide; and Madi Nettles, Jacob Phillips, and Jared Wisler, CJHS girls' track coaches.

Opponents of the wind project had hoped the RPC would support rescinding the permit. The commission majority had, up to that point, backed the effort to stop the permit being granted. Had the RPC approved the recommendation, it would have gone before the full county board on Mar. 18. The board ultimately canceled its scheduled meeting because of a power outage. The meeting was rescheduled for Mar. 25.

In February, an attorney representing the plaintiffs in the suit told county board members they would be legally justified in declaring the special use permit null and void. Since the lawsuit was dismissed without

prejudice, plaintiffs would be free to refile their case in the future.

On Mar. 17, the Village of Wapella also filed to have its similar suit against the county and Enel dismissed.



The state also updated current Phase 4 mitigations so that anyone with proof of full vaccination or a negative COVID-19 test 1-3 days prior to an event or outing do not count against capacity limits.

The bridge phase will include higher capacity limits at places like museums, ZOOS and events and spectator increased business operations, according to the governor's office.

The largest increase is to social events, which can allow 250 people indoors and 500 outdoors. Previously those were capped at 50 people.

Recreation activities are allowed with groups up to 100 or 50 percent of capacity indoors, while outdoor recreation is limited to groups of 100, with multiple groups allowed at the same site.

Ticketed recreation events are allowed to hold 60 percent of the facility's capacity.

In the bridge phase, restaurants and bars can increase capacity from 25 percent to 30 percent, and outdoor capacity is allowed up to 50 percent for standing areas. In seating areas, parties of up to 10 are allowed to sit six feet apart.

For businesses, offices, retail stores and fitness centers, capacity will increase from 50 percent to 60 percent. Amusement parks and museums can increase from 25 percent to 60 percent. Theaters and zoos can have up to 60 percent capacity as well.

But the state can revert back to an earlier phase if it "experiences an trend" increasing in COVID-19 transmission rates and hospitalizations over a 10-day period.

Illinois hospitalized with COVID-19, including 252 in the ICU and 100 on ventilators. All of those numbers were close to pandemic lows.

"Combining these decreasing trends and cases and hospitalizations and deaths, with increasing vaccinations," Illinois Department of Public Health Director Dr. Ngozi Ezike said at the news conference. "That is clearly a recipe for ending this pandemic. We cannot lose our momentum. To do this, we will continue to wear our masks."

be mandatory in the state until the U.S. Centers for Disease Control and Prevention determine that they are no longer needed, the governor said.

As of Thursday, Mar. 18, the state was averaging 99,210 vaccine doses administered daily on a seven-day rolling average. Vaccine information and locations can be found at coronavirus.illinois.gov, and Ezike noted the state has a hotline to make appointments for those without internet access at 833-621-1280.

"Deliveries continue to rise and are expected to increase by millions spring," more this Pritzker said. "With the increased supply, Illinois is now averaging 100,000 vaccinations a day. That's about 1 percent of all adults in Illinois getting a shot each day, and I expect that number to continue to grow in the weeks ahead."

• 1961: Intense low pressure produced high winds of 50 to 80 mph across much of Illinois. At the Joliet airport, a wind gust of 100 mph was recorded before the wind gage was blown away. A gust of 74 mph at Capital Airport in Springfield caused damage to a hangar. In Dwight (Livingston County), one person was killed in a car accident when a dust storm reduced visibility to near zero.

#### BRIDGE BITES

CREATING AN ILLUSION


In a rubber bridge or team game, this would be a pretty dull deal, with N-S making 10 or 11 tricks in about 30 seconds flat. But in a duplicate bridge game, where overtricks are well rewarded, this dull deal suddenly becomes most interesting!

When this deal was played, all the West players led a Diamond to East's Ace, and a Diamond was returned, South playing the Two on the first trick, followed by the Nine. The West players knew that, if East had two remaining Diamonds, he would have returned the higher one at Trick 2. Therefore, Declarer had the missing Ten, and there was no point in ducking the second Diamond, he had to take his King while he still could. The defense won the ♥A later and it was just 10 tricks for Declarer.

But at one table Declarer created an illusion by playing the Diamond Nine and Ten on the first two tricks. Now West had a chance to go wrong as, in this case, the missing Diamond was the Two. In West's mind, unless Declarer was being diabolically devious (which we know to be the case!), the missing Two was surely with East. So West ducked the second Diamond and sat back, patiently waiting for East to get in and fire back a Diamond. He's still waiting, and it was 11 tricks (and a top board) for Declarer.


In the post mortem West apologized for not grabbing the **•**K while he could, but East could have saved the day. He could count Declarer for 18-19 HCP, leaving only 3-4 for West. That being so, West presumably had the ♦K and no entries, and the defense could never score the long Diamonds. So East must cash the ♥A at Trick 2, making it clear to one and all that the defense must take its three tricks and give up.
