# Only three new laws began on Jan. 1

**SPRINGFIELD** — When a new year begins in Illinois, there typically are dozens if not hundreds of new laws going into effect.

Not this year. Like so many other things in 2020, the legislative spring session was stunted by COVID-19. Once the global pandemic reached Illinois in March, the General Assembly would meet for only four more days — wrapping up the odd session during masked and socially distanced gatherings at the Capitol and Bank of Springfield Center. The fall veto session was scrapped altogether.

As a result, only three new laws will take effect on Jan. 1, 2021. Here's a look at them, as well as the next increase in the minimum wage that will be applied Friday:

Insulin costs cap

Senate Bill 667 (Public Act 101-0625) amends the Illinois Insurance Code to cap out-of-pocket insulin costs at \$100 per month for all patients using a state regulated insurance plan, regardless of the amount of insulin or type of covered prescription insulin drug used to fill the insured patient's prescription.

Roughly 1.3 million adults in Illinois, or 12.5 percent of the population, have diabetes, according to the legislation.

SB 667 also provides that the Illinois Department of Insurance, along with the Department of Human Services and the Department of Healthcare and Family Services, must create a public insulin pricing report that includes a summary of insulin pricing practices and public policy recommendations to control and prevent the overpricing of insulin prescriptions.

Sen. Andy Manar, D-Bunker Hill, chief sponsor of the Senate bill, said in a statement that the legislation shows Illinoisans don't have to accept costly prescriptions as the status quo.

"We can change the fact that prescription medication costs more in the United States than any place in the world. This legislation passed because people spoke up and told their story. This historic legislation doesn't become law without them and their effort," Manar said in the statement.

Use of DNA in missing person cases

House Bill 2708 (Public Act 101-0266) amends the Missing Persons Identification Act to allow law enforcement agencies to obtain a DNA sample of a missing person or a DNA reference sample from family members' DNA, once a missing person report is made. The law also provides that law enforcement cannot retain

DNA samples from family members or the missing person after the person has been located. It also adds the National Missing and Unidentified Persons

System, a national information clearinghouse for missing persons, to the list of laboratories that law enforcement agencies can work with when trying to find a missing person. Sen. Tony Munoz, D-Chicago, who was one of the bill's sponsors, said in a news release that using the national

system will hopefully help law enforcement find missing Successfully finding a missing person requires law enforcement to move fast, and we want to make sure they

have every tool available to do their job," Munoz said in the release.

This brings the total number of cases to 2,562 as of Jan. 4. Of the 2,562 cases, 2,122 have recovered. They also reported as of Jan. 4, 12 residents have been hospitalized.

The Unified Command Team would like to remind our community that COVID-19 remains in our area and continues to be a real threat. Some people who have tested positive have had no symptoms or mild symptoms. Others have felt miserable or even been hospitalized. Although there are individuals considered at a higher risk for complications due to COVID-19, some otherwise healthy people have also become very sick. The more the virus spreads & the more cases we have locally, the risk of very ill or hospitalized individuals increases.

Please, for yourself and others, follow the state and federal recommendations. It's easy to remember as the 3 W's: Wash your hands; Watch your distance; and Wear your mask.

Also, we'd like to mention the process of contact tracing.

If your local health department tries to contact you, please answer or return their call. Some people may feel distrustful or afraid of the term "contact tracing." This is actually a strategy used for many years in public health to reduce the spread of infectious disease. Contact tracing is a critical piece of our mitigation efforts against COVID-19. # 2020 Lee County tentative multiplier announced

**SPRINGFIELD** — Lee County has been issued a tentative property assessment equalization factor of 1.0000, according to David Harris, Director of the Illinois Department of Revenue.

The property assessment equalization factor, often called the "multiplier," is the method used to achieve uniform property assessments among counties, as required by law. This equalization is particularly important because some of the state's 6,600 local taxing districts overlap into two or more counties (e.g. school districts, junior college districts, fire protection districts). If there were no equalization among counties, substantial inequities among taxpayers with

comparable properties would result. State law requires property in Illinois to be assessed at one-third (1/3)

of its market value. Farm property is assessed differently, with farm homesites and dwellings subject to regular assessing and equalization procedures, but with farmland and farm buildings assessed according to standards based on productivity. The equalization factor is deter-

mined annually for each county by comparing the sales price of individual properties sold over the past three years to the assessed value placed on those properties by the county supervisor of assessments/county assessor.

If this three-year average level of assessment is one-third of market value, the equalization factor will be one (1). If the average level of assessment is greater than one-third of market value, the equalization factor will be less than one (1). And if the average level of assessment is

less than one-third of market value, the equalization factor will be greater than one (1). Assessments in Lee County are at

33.51 percent of market value, based on sales of properties in 2017, 2018, and 2019. The equalization factor currently

being assigned is for 2020 taxes, payable in 2021. Last year's equalization factor for the county was  $\bar{1}.0000$ .

The tentative factor is subject to change (1) if the County Board of Review takes actions which significantly affect the county assessments or (2) if local officials or others can present data showing that the Department of Revenue's estimates of the average level of assessments in the

county should be adjusted. A public

hearing on the tentative multiplier

will be held between 20 and 30 days after the tentative factor is published in a newspaper of general circulation within the county.

A change in the equalization factor does not mean total property tax bills will increase or decrease. Tax bills are determined by local taxing bodies when they request money each year to provide services to local citizens. If the amount requested by local taxing districts is not greater than the amount received in the previous year, then total property taxes will not increase even if assessments may have increased.

The assessed value of an individual property determines what portion of the tax burden a specific taxpayer will assume. That individual's portion of tax responsibility is not changed by the multiplier.

# **Driver Services** Facilities set to reopen statewide Jan. 5

SPRINGFIELD — Illinois Secretary of State Jesse White is reminding the public that Driver Services facilities statewide are reopening on Tuesday, Jan. 5. Face masks are required, and social distancing and other safety measures will remain in place. White is reminding the public that driver's licenses and ID card expiration dates have been extended until June 1, 2021. As a result, people do not need to rush to visit a facility, especially during winter weather conditions.

Additionally, White stressed that many transactions can be conducted online at www.cyberdriveillinois.com instead of waiting at a Driver Services facility.

In an effort to reduce facility visits for in-person service, White has expanded online renewals for driver's licenses and ID cards. Not everyone qualifies, particularly those who are required to pass a written or road test. For qualifying drivers, individuals will receive a letter with a unique PIN approximately 90 days before the expiration date. The PIN is required to renew online. # New federal rule changes odometer discloser requirements impacting automobile industry

SPRINGFIELD — Illinois Secretary of State Jesse White is alerting the automobile industry, along with private party vehicle sellers, of a new federal odometer disclosure rule that increases the amount of time odometer readings must be declared at the time of a vehicle sale. The new federal rule takes effect Jan. 1, 2021.

The new federal rule, which was issued by the National Highway Traffic Safety Administration, is intended to help combat odometer fraud as the nation's fleet of vehicles ages. The average age of a vehicle in the United States is now almost 12 years, up from 7.6 years when the odometer rules were last changed in 1988.

Under this new federal rule, vehicles made in 2011 and newer will be subject to odometer disclosure for 20 years rather than the current 10 years. Under the old rule, a 2011 vehicle would have

become exempt from disclosure in 2021. Beginning Jan. 1, the odometer reading must be disclosed at the sale of a 2011 vehicle until 2031. For example, 2012 vehicles will become exempt in 2032, and so on.

The immediate impact is that 2011 vehicles will not become odometer exempt on Jan. 1, 2021, as they would have under the old rule. The new rule applies even if the existing title says "Exempt-Model year over 9 years old." This applies to automobile dealers and private party vehicle sellers.

Simple guidelines to help ensure compliance include:

• If the vehicle is a 2011 model or newer, the seller must enter the current mileage in the Odometer Reading section of the title upon sale of the vehicle.

• If the vehicle is a 2010 model or older, the seller may check the "Exempt" box on the title.

Due to the new federal rule, the Secretary of State Vehicle Services Department must reject paperwork for sales of vehicles 2011 or newer unless the odometer disclosure is completed. The Vehicles Services Department is unable to accept an Application for Duplicate Title and Bill of Sale or a non-secure

Power of Attorney on these vehicles. For used vehicle dealers and other businesses in the automobile industry, the new federal rule means they will be required to disclose the odometer reading on a greater number of vehicles.

Keeping victims' addresses confidential House Bill 2818 (Public Act 101-0270) amends the Address Confidentiality for Victims of Domestic Violence Act by including

survivors of sexual assault and stalking in the Illinois Address Confidentiality Program (ACP), which offers survivors protection from their abusers by allowing them to acquire and use a substitute address instead of their real address.

HB 2818 allows survivors of domestic violence, sexual assault and stalking who fear for their safety to apply to the ACP through the Attorney

General's Office. The ACP forwards all first-class mail and provides survivors with a substitute address for public records and documents, such as driver's licenses and state-issued identification

The bill also changes the name of the law, from the Address Confidentiality for Victims of Domestic Violence Act to the Address Confidentiality for Victims of Domestic Violence, Sexual Assault or Stalking Act.

In a written statement, Illinois Attorney General Kwame Raoul said ACP is an important added layer of protection and peace of mind for survivors of domestic violence, sexual assault and stalking.

"I am committed to ensuring that survivors have access to the resources and support needed to aid their recoveries, and I encourage survivors to participate in this program that can help protect them from the individuals who perpetrated crimes against them," Raoul said in the statement.

Minimum wage increase

The minimum wage in Illinois will rise from \$10 per hour to \$11 per hour on Jan. 1.

The Illinois General Assembly passed increases to the minimum wage in 2019 with legislation that raises the minimum wage \$1 every year until it reaches \$15 per hour in 2025.

In 2020, wage earners saw their hourly wage increase from \$8.25 to \$9.25 on Jan. 1, and to \$10 on July 1.

'We want to make sure that workers earning minimum wage are aware that the \$1 increase should be reflected in their paychecks for any time they work after the first of the year," Michael Kleinik, director of the Illinois Department of Labor, said in a news release. "While we fully expect employers will pay the new wage, we also want workers to be aware of the change.'



#### **Eel Mania**

Then a friend of mine whose judgment I highly respect urged me to read "The Book of Eels," I worried that interminable seclusion had finally gotten the better of her. Still, I looked it up. Its subtitle "Our Enduring Fascination with the Most Mysterious Creature in the Natural World" seemed a tad overblown, yet intriguing. It can be fun to read about something one knows absolutely nothing about. I decided to read it. It was terrific.

What makes Patrik Svensson's "The Book of Eels" one of the best books my friend has read is not only his lively take on scientific obsession but also his memoir of a childhood whose heart was the times he went eel fishing with his father.

In the 19th century, science seemed on the threshold of solving the great questions of the natural world, to the point where the famous German zoologist Max Schultze observed on his deathbed that he was leaving a world where "all the important questions...had now been settled." All "except the eel question." It is a question that goes back over 2,000 years to the Greek philosopher Aristotle. He was considered the first scientist, yet the secretive eel eluded him. He theorized that the eel emerged spontaneously from mud. For centuries thereafter, an eel answer was inevitably followed by a further eel question, even more mysterious, more intractable. Not until the twentieth century was the eel's breeding ground discovered – after an obsessive ten-year search.

The eel's mystery arises from its metamorphosis into four distinct beings during its lifetime: Life begins as a tiny larva in the Sargasso Sea, located slightly northwest of Cuba. The two-million square mile Sargasso with depths of 23,000 feet, teems with life in its vast seaweed fields. Shaped like willow leaves, these tiny eel larvae float thousands of miles in the Atlantic Ocean toward Europe. It enters European coasts and rivers as a shimmering glass eel, called an elver, a few inches long with visible insides.

The third transformation is into the yellow eel, which can move across dry land. It will live for decades in ponds and rivers, until it morphs into the silver eel, a long powerful creature that will travel the 5,000 miles back to the Sargasso Sea on its fat reserves alone. Its reproductive organs develop for the first time. It will mingle with its American siblings (Svensson wonders how they know which continent they belong to), it will spawn and perish. "The Sargasso Sea is the end of everything and its beginning." But here is the mystery: No one has ever found a mature eel in the Sargasso Sea.

Sadly, the European eel is on its way to extinction. Since no one has ever managed to breed eels in captivity, rescue is well-nigh impossible.







# Clipper Highlights: #54 Colby Fordham and #1 Matt Fuller

This week is a very special highlight for me. I get to highlight two of my best friends. Not only are these two Clippers two of my best friends, both are deserving of this highlight for what they meant to the 2008 Clipper Team and what they did on the field.

After long discussion with these highlights and those asked to provide statements, it was determined that the graduating class of 2009 was the least football talented class between the graduating classes of 2005-2010. We fell between classes

with size, speed, great athleticism, and football IQ. Between All State Rushers and an All State Receiver. We sailed the ships' direction toward success despite a brutal Big Rivers schedule and difficult playoff draw. Much of that success was in large part due to the contributions of these two Clippers.

I'm so honored, taken back to a great time, and incredibly proud to announce our two Clipper Highlights; #54, Colby Fordham, and #1, Matt Fuller.

Colby was a 2009 graduate of Amboy High School, three sport Clipper athlete, and arguably one of the most naturally blessed athletes of the modern era.

Colby would have easily been called up to the Varsity ranks his sophomore season, 2006, if it hadn't been for a torn labrum. Colby tore his labrum his freshman season of baseball and was unable to play Clipper football as a sophomore.

Battling through ankle and lower extremity injuries in the 2007 Clipper campaign, Colby played a vital role in the offensive and defensive lines on the 3A Clipper Quarterfinal team. A caliber player like Colby added size, depth, and knowledge to an already loaded 2007 Clipper team.

Going into the 2008 season, Colby's senior season, he went through a massive growth spurt. As the most athletic and biggest Clipper on the team at 6'3" 215lbs, Colby was not going to let anything get in the way of Clipper tradition and pride, or, at the time, future All State Running Back, Cody

Richardson.

Colby paired up with Clipper great, Levi Kaleel, on the right side of the Offensive Line making for a scary good power run and triple option attack. There wasn't one opponent in the conference or the playoffs that would out want or out prepare Colby. As I watch our old films, his athleticism was second to none in terms of great Clipper linemen which is no surprise why he was a Unanimous 1st Team All Conference and All Area selection at both Offensive and Defensive lineman

I asked several former Clipper teammates to provide a statement on their time with Colby as Clippers. They are as follows:

Matt Fuller shared, "Colby was a guy who led by example. Not extremely vocal but always did his job on the field. A student of the game who understands the sport as well as anyone I know. I think the greatest compliment I could pay him is the fact that you never had to worry about whether or not he was prepared or ready to go. You always knew he was going to do what he was supposed

Taylor Payne shared, "Colby's size combined with his pure athletic ability was a force to be reckoned with. Qualities needed for strong side OT and Defensive End/ Line. If he wasn't one of our biggest and needed linemen the kid could have been one hell of a Tight End." Jeremy Wolf shared,

"Fordham let his play do the talking for him, a model defensive end, he gave every team we faced, a problem to block. On the offensive end, he was our sure thing strong tackle. Always made his blocks and moved down field. Played damn near every minute of every game."

Pat McCaffrey shared, "Colby was a force to be reckoned with! Always seemed like he was making the block that sprung someone for a touchdown or on defense it seemed like he was always in the opposition's backfield."

All statements gathered were by those in the same graduating class as Colby. However, there isn't enough room on this page, for more

from our grade and others, that could share more about Colby's athleticism.

My most favorite memory of Colby was our senior season at Ottawa Marquette. Marquette fumbled near their own end zone, Colby read the play, saw the football, and scooped and scored. One of the best and most athletic plays I've seen from the defensive lineman position.

Amboy football was built by men like Colby. Men who work hard, love their families, and give all they have to the things they are most passionate about. It's been 12 years since our time on The Harbor but to this day Colby remembers the tradition, the brotherhood, and the lights.

So, to one of my best friends, #54, Colby "Big" Fordham, thank you for your contributions to Amboy Football. Thank you for your lifelong friendship. From all of us in the Class of 2009, thank you for being among the biggest reasons we were able to keep the ship sailing forward. Sail on!

Matt was also a 2009 graduate of Amboy High

Unlike Colby, Matt did not learn of the tradition and history of Amboy football early on. Matt's Clipper journey began in Jr. Tackle. I remember because I was the one who threw Matt his first touchdown, which is a bond only few will know. Matt was our star all through Amboy Jr. Tackle and into High School.

Out of all the great Clipper skill position players, in our entire history, I would argue that Matt's hands were more sure than any of the best before, during, or after his time. Matt could catch anything, which made him our best possession wide receiver in his two Varsity seasons.

Matt's Junior season, 2007, he played both ways as a Cornerback and Wide Receiver. Complimenting, All Stater, Anthony Wells, Matt understood his role and often required our opponents to put their second best pass defender on him. Matt took the loss to Aurora Christian our Junior season personally and used it as fuel going into our Senior season.

I remember it like yesterday, summer 2008, I received a phone call from Matt before the season began. Matt informed me that we had been pre-season ranked 4th in 3A to begin the season in an independent poll. At that moment in time, I realized Amboy Clipper Football meant just as much to Matt as any player, on any team, of any decade. We ended the season in the second round of the 3A playoffs, earning an 8-3 record. No all conference or all area honors were earned by Matt but take him away from our 2008 Clipper Team and we might, generously,

Not the biggest, not the fastest, not the most athletic, but the one who cared the most by far. The one who wasn't going to let any opponent trash talk or intimidate even the quietest of Clippers. Matt was always there. Matt was definitely the guy you loved to have as a teammate but hated playing against. In a conference like the Big Rivers, Matt was a necessity. The same teammates for

Colby Fordham were asked to provide a statement for Matt also. Here is what they Colby Fordham shared,

"Matt was our enforcer, he always knew what to say, how to say it, and when to say it. No one questioned him." Taylor Payne shared,

"Matt, he was our vocal leader, he did a lot of talking, like an abundance of talking. Matt was smart on the field. He knew his limitations and made up for it with positioning himself at cornerback to be successful and at Wide Receiver the kid had very good hands, he always did from a young age. Great teammate who always had your back."

Pat McCaffrey shared, "Matt and Colby were great teammates! With Matt it didn't matter how big the game was he always showed up cool calm and collective and did his job to the best of his ability."

Jeremy Wolf shared, "Fuller was always the hype man, he could get anyone on Football Alumni. To have the team fired up and ready to played Amboy football for knock the crap out of someone. I remember at Morrison our senior year, he had us all so jacked even Coach Jones had to settle us down some. We won in triple overtime. He also always came up with the big clutch play when you needed him to, whether it was

a one handed interception (Ottawa Marquette) or a deep ball play, one things for sure, his hands weren't going to let you down. He never dropped anything.'

For those that know him, love him or hate him, Matt Fuller was the passion and spark of the 2008 Clipper Team. He meant so much to our team and gave us a confidence that propelled us, a class of mediocre talent, to a 7-2 regular season record and 8-3 overall record.

So, to #1, Matt Fuller, thank you for your contributions to Amboy Football. Thank you for your great hands as they sure made me look better than I was, on more than a few occasions. You've been my best friend for as long as I can remember and even though nothing can replace the times we have had as Clippers, our lives now give me just as much excitement and joy. Sail on!
