COVID-19 vaccine appointment request form available in Lee County

LEE COUNTY — Lee County Health Department now has an appointment request form for all residents who are eligible for COVID-19 vaccination under Phase 1B.

As a reminder, Phase 1B is expanding to residents age 65 and older, and frontline essential workers.

The form is available on the front page of the county health department's official website at www.lchd.com.

Please do not complete this form if you have already called LCHD to request an appointment.

If you have provided your information to a staff member via phone, Facebook Messenger, or email, then you are already on the call list and will be contacted for scheduling as soon as possible. If you have left the health department a voicemail to request scheduling, a staff member will return your call as soon as possible to gather more information and proceed scheduling.

Upon completing the form, you will automatically be added to the call list, and an LCHD staff member will call you for scheduling at their soonest availability.

Region 1 lifts Tier 3 mitigations, now under Tier 2 mitigations

NORTHERN ILLINOIS - Gov. Pritzker announced Region 1 is now able to lift Tier 3 mitigations under the state's guidelines on Jan. 15.

Lee County COVID-19 **Update: Jan. 15, 2021**

LEE COUNTY — The Lee County Health Department is saddened to report 1 additional death in the county after confirming COVID as the cause. Age breakdown is as follows: 1 resident in her 50s. This brings the total number of deaths in Lee County to 54.

The health department also reported 5 cases were from congregate living facilities with 5 Dixon Correctional Center.

Due to the weekend and Martin Luther King, Jr. Federal Holiday, this article will only cover from Jan. 12-15.

Between Jan. 12-15, the Lee County Health Department has reported a total of

97 new cases have been reported, however, 40 of those positives were between Jan. 1 and 11 and were delayed in being reported to the health department, Including the case listed above. Here are the ages that were announced: 7 under the age of 12, 13 in his or her teens, 10 in his or her 20s, 10 in his or her 30s, 11 in his or her 40s, 10 in his or her 50s, 13 in his or her 60s, 15 in his or her 70s, 2 in his or her 80s, and 1 on his or her 90s.

This brings the total number of cases to 2,779 as of Jan. 15. Of the 2,767 cases, 2,271 have recovered. They also reported as of Jan. 15, 14 residents have been hos-

pitalized.

Mobile Testing The Lee County Health Department announced the State of Illinois is hosting a community drive-through test site on Saturday, Jan 23 and Sunday, Jan 24, from 8 a.m. - 4 p.m., at the Dixon Elks, 1279 Franklin Grove Road, Dixon. Simple nasal swabs will be used, and you will be called with results within 4-7 days. There is no cost for the testing.

Illinois lawmakers passes sweeping police reform bill

By introducing a 764-page amendment at 3:51 a.m. and shoving it through in the middle of the night before the people voting on it even had a chance to read it," the group said in a statement.

Illinois could look different after a sweeping criminal justice bill was passed by lawmakers in Springfield.

House Bill 3653, which passed by a 60-50 vote on Jan. 13, will change use-of-force guidelines, require body cameras for every police department in the state, end cash bail, and strip collective bargaining rights relating to discipline from police unions.

The Senate passed the bill in the early morning hours of Wednesday, Jan. 13 by a 32-23 vote.

The legislation, which is the work of the Illinois Legislative Black Caucus, faced opposition from law enforcement groups and Republican lawmakers.

"The time is now," said state Rep. Justin Slaughter, a Chicago Democrat who helped craft the bill. **Executive Director Jim Kaitschuck** said the measure is too broad and, if it gets approved by lawmakers. he would quit being a police officer immediately.

Some GOP lawmakers are saying they are not necessarily opposed, but the rapid nature outside the normal process is alarming and should not be passed during lame-duck session.

We are not on the right side of history," state Rep. Andrew Chesney said. "You want to pass a flawed bill that is not supported by labor, it is not supported by the sheriff's association, it is not supported by the police chiefs. Everybody that we task to keep us safe says this makes you less safe."

The legislation also will allow officers to be punished or fired based requirements.

Ogle County Sheriff Brian Van-Vickle called the reforms catastrophic to law enforcement and feels they would make policing impossible for officers who have to make split-second decisions.

As soon as the bill passed the House, a clearly emotional Slaughter put a black glove on his right hand and raised his fist into the air.

The Illinois Law Enforcement Coalition said Wednesday that the bill was pushed through in the middle of the night with little transparency or time for constituents to weigh in on the legislation.

"In the dark of night, Illinois legislators made Illinois less safe. More than 112,000 citizens so far have signed a petition to oppose

The group said it would hamper police officers.

"It ties the hands of police officers while pursuing suspects and making arrests, and allows criminals to run free while out on bail," the statement said. "The legislation includes no way to pay for any of these law-abiding, citizen-threatening measures, so taxpayers will have to pay extra for the privilege of being crime victims."

The measure next goes to Gov J.B. Pritzker's desk.

Illinois' online shoppers now get local tax hit on top of state tax

SPRINGFIELD – Burning through those online gift cards will go incrementally faster in 2021 depending on how high local sales taxes are in your local Illinois municipality.

That's because of a 2019 law that took effect with the new year.

In reaction to the U.S. Supreme Court's Wayfair v. South Dakota lawsuit, Illinois lawmakers sent Gov. J.B. Pritzker legislation that would require many online retailers, including Amazon and others, to collect state and local sales tax from online purchases. Online retailers have collected a use tax at the same rate as sales tax before the new year but the new law means where you live could add cost to the purchase.

"You're not just paying the 6.25%, you're paying 8.25% or 7% because they're taking that state 6.25% and they're taking county or other optional-to-enact taxes," said Carol Portman, president of the Taxpayers Federation of Illinois. "If it goes to me in my home in Downers Grove, it's one thing. If it goes to my office in Springfield, it's a different one."

For instance, Chicagoans buying a stuffed animal from Amazon would pay Illinois' 6.25% rate but also Cook County's 1.75% and Chicago's 1.25% taxes for a total of 10.25%. The teddy bear shipped to Carbondale would see the state tax plus Williamson County's 1% tax for a total 7.25% tax.

Sellers conducting business via an online marketplace like Amazon rely on the retail giant to collect the correct amount of taxes.



LOCAL NEWS Illinois Farm Bureau announces 78 scholarships available

BLOOMINGTON — Agriculture students and Illinois Farm Bureau® (IFB) members, spouses and children are eligible to apply for 78 college scholarships offered by the IAA Foundation, Illinois Farm Bureau's charitable arm. The scholarships, ranging from \$1,000 to \$7,500, will be awarded in total of \$124,000 for the 2021-22 school year.

"We are pleased to recognize students through our growing scholarship program," said Jennifer Smith, Development Manager, IAA Foundation. "It is a privilege to support the next generation of leaders and encourage degrees in agriculture related fields."

The Unified Command Team would like to remind our community that COVID-19 remains in our area and continues to be a real threat. Some people who have tested positive have had no symptoms or mild symptoms. Others have felt miserable or even been hospitalized. Although there are individuals considered at a higher risk for complications due to COVID-19, some otherwise healthy people have also become very sick. The more the virus spreads & the more cases we have locally, the risk of very ill or hospitalized individuals increases.

To address capacity issues reported by Illinois hospitals, IDPH, in partnership with the Illinois Emergency ManagementAgency(IEMA) and the Department of Healthcare and Family Services (HFS), has launched a surge staffing program. The program leverages the state's larger contracting power to engage multiple staffing vendors and create access to a talent pool at greater scale than any individual hospital could achieve. Hospitals with rooms available to increase capacity but lacking the personnel to staff their beds may partner with the state to procure the staff they need.

Hospital leaders have conveyed that due to the progress the state has made as well as the volatility in medical/ surgical capacity this time of year, the state's remaining metrics will appropriately monitor capacity and spread. While IDPH is working to allow regions greater flexibility in lifting the most stringent mitigations, public health officials will continue to carefully monitor hospital needs and test positivity in order to maintain the state's progress.

This is particularly critical as new variants circulate. Early studies for the SARS-CoV-2 variant B.1.1.7, which was first identified in the United Kingdom, have shown the variant may spread more

Illinois had historically relied on the buyer to remit taxes, something that was regularly ignored. Illinois and others then changed course and began requiring retailers to collect sales taxes, putting the onus on them to remit the tax.

Retailers say this puts online sellers on even ground with local shops who must charge higher prices to account for local taxes and fees.

Online retailers who sell less than \$100,000 annual gross sales or have fewer than 200 individual sales to Illinois do not have to collect the tax. The tax change gets complicated if an online retailer has a physical presence

rapidly and easily than what we have seen previously. Experts are predicting another possible surge due to this new variant in the next several months. Because of this, it is vital for people to remain vigilant and continue to wear their masks, keep 6-feet of distance, avoid large gatherings, and get vaccinated when they are eligible.

According to the fillhois Department of Revenue, an online retailer that completes a sale from a location in Illinois would apply the taxes from that location. If the business sells something outside of the state, it would then apply the 6.25% use tax.

"Illinois' sales tax structure has always been complicated and this just adds another layer of complexity to it," Portman said. "The good news is that, for brick-and-mortar retailers, there's no difference for any of their customers now whether you buy something from an online seller or if you buy it from the brick-and-mortar retailer."

New program for students available in Lee County

LEE COUNTY — The state of Illinois has enacted a program in which students can earn pathway endorsements, which will prepare your student for more college and career focus education. Partnering schools have developed course work and career experience that are specific to your student interest. Currently, Regional Office Education 47 is partnering with Sauk Valley Community College to offer three pathway opportunities that are tailored to fit each partnering school's need: agriculture, education and manufacturing

While earning a pathway endorsement, students will be focusing on four components starting with career exploration. Career exploration allows students to explore their individual interests and the career opportunities that match. While exploring these interests, students have the opportunity to job shadow, attend career fairs and visit secondary school opportunities. Students will also be required to learn about financial literacy, which will lay the foundation for a solid financial future.

When entering their pathway, a student will meet with their counselor to develop their individual learning plan that will monitor student progress through the pathway requirements. Students will lay out a four-year plan choosing course work that is tailored to their career interests. Course work will include 6 hours of dual credit that will prepare students for college admission or career opportunities.

Team-base challenges allow students to work together on a career-based project, supervised by a mentor in that field. These activities offer participants the opportunity to experience decision making and problem-solving skills, to address real world issues in their career field. Students will present completed team-based challenges to a panel of community members in their field.

The final component of the pathway requirement is the 60-hour supervised work experience. This allows the student to be hands on in the career field and learn from experienced professionals. During this experience, students will gain valuable job skills that will prepare them for their future career.

Vote by mail, remote voting, 'decoupling' bills fail in lame duck session

SPRINGFIELD — The 101st Illinois General Assembly took historic action by passing legislation to end cash bail prior to electing a Black House Speaker for the first time in the 102nd General Assembly.

But lawmakers ran out of time on several consequential measures - including bills that would have expanded vote-by-mail, allowed lawmakers to conduct business remotely during the pandemic and eliminated newly expanded income tax deductions for business owners. Another bill relating to the state's rollout of legalization of adult-use marijuana also failed to pass, as did a measure that was part of the Illinois Legislative Black Caucus' health care agenda.

House Democrats fell 10 votes short of passing a bill, endorsed by Gov. JB Pritzker, that would have eliminated certain tax deductions for Illinois business owners that were created under the federal CARESAct. Pritzker has argued this change by the legislature is needed to prevent revenues from shrinking by more than \$500 million during the current fiscal year, thus enlarging the state's \$3.9 billion budget deficit.

Specifically, the bill would end the CARES Act amendments that expanded income deductions business owners can claim as net operating losses, carryback losses or excess business losses.

In a Jan. 8 news release, Pritzker encouraged the General Assembly to "decouple" Illinois' tax law from the federal tax amendments under the CARES Act, an action that would have kept the state tax code consistent with previous years.

Pritzker claimed those changes would have preserved \$500 million in state tax revenue from noncorporate taxpayers and owners of pass-through entities, such as limited liability companies and partnerships.

During House floor debate in the early hours of Jan. 13, lawmakers on both sides of the aisle described the bill as preserving up to \$1 billion in state revenue.

Democratic Rep. Michael Zalewski, the bill's sponsor, said the proposed changes would impact about 440,000 taxpayers statewide.

Zalewski, of Riverside, tried to appeal to his caucus, but 10 House Democrats voted present while another eight did not vote on the bill, including former House Speaker Michael Madigan, of Chicago, and the newly elected Speaker Emanuel "Chris" Welch, of Hillside.

At least a dozen Republicans condemned the proposal as a last minute "tax hike" on small business owners already crushed by the pandemic.

During the House floor debate, Rep. Tim Butler, R-Springfield, said the bill amounts to the tax increase that Republican lawmakers anticipated would come up during the lame duck session. "This is the textbook definition of a late night, no one is watching, lame duck, back door tax increase. This is exactly what people hate," he said.

Zalewski characterized the proposal as an effort to prevent loss of revenue, rather than an effort to raise new revenue.

House Republicans were also critical that the Pritzker administration and the Illinois Department of Revenue did not notify taxpayers or the legislature sooner of the state's plans to decouple from the federal changes that were made in March.

During a news conference on Friday, Pritzker said he expects the legislature will bring the proposal back in the 102nd General Assembly.

"Although it didn't happen in the short lame duck session, I have a commitment from the leaders that it will be brought up in the regular session," Pritzker said on Friday in response to a question about the failed decoupling bill. "I'm anticipating that it will get brought up soon in the new session of the General Assembly.'

Remote voting, more

The remote voting bill, which passed the Senate unanimously, would have permitted the House and Senate to convene remotely and cast votes during a public health emergency where "in-person participation poses a significant risk to the health and safety," of lawmakers, their staff or the public.

It would have required both chambers to create rules for remote participation in session and committees, and it would have applied to the boards of the Joint Committee on Administrative Rules, Commission on Government Forecasting and Accountability and Legislative Audit Commission.

The Senate changed its rules during the brief May session to allow for remote hearings but the House failed to pass similar changes. Two lawmakers voted remotely in the lame duck session.

Both chambers released tentative calendars last week showing they are scheduled to meet in-person several days each month through May.

Since the pandemic hit Illinois in March of 2020, members of the House met briefly the following May and earlier this month at the Bank of Springfield Center, while the Senate continued at the Capitol for those brief sessions.

Multiple people that attended last week's lame duck session-including the chief of staff to the House speaker's office - have tested positive for COVID-19. The governor said last week he would not prioritize lawmakers in the next phase of vaccination.

The vote-by-mail bill, which passed the Senate by a vote of 40-18, would have made permanent some changes that were implemented in response to the pandemic for the 2020 general election. This would have included the use of drop-box sites to collect ballots without postage and curbside voting during early voting or on Election Day.

It also would have required the State Board of Elections to provide guidance, rather than rules, for securing collection sites. Neither bill was taken up for a vote by the full House on Wednesday.



The Plan

o: this camp is consciously and knowingly organized and arranged in such a way as to methodically exterminate thousands of human beings according to a plan. If this continues for only one more month, it is highly doubtful that one single person among us will come through." This was the last entry of a diary kept by a thirty-year-old Jewish school teacher from Yugoslavia. She had miraculously survived typhus, but was so weak, she estimated she would be dead in two weeks. Her name was Hanna Levy and her testament was called "Diary of Bergen-Belsen, 1944-1945."

Originally a POW camp, Bergen-Belsen in the heart of Germany was transformed into a concentration camp in March 1944. Unlike the eastern extermination camps Auschwitz-Birkenau and Treblinka, Bergen-Belsen was designed to kill its inmates by slow starvation and typhus, tuberculosis and dysentery, turning it into "another link in the murderous assembly line that sought to add more and more numbers to its death production toll."

Hanna, who grew up in Sarajevo, intended to join the Yugoslav partisans to fight the Germans. But the small Jewish community where she taught school talked her into staying with them. They were picked up in the summer of 1944 and Hanna arrived in Bergen-Belsen that August. She was put in charge of the 110 children in her barracks. Although she complained about conditions, "Comings and goings, cries of despair, children's sobs, dust, straw everywhere, the stench, the filth, excrement," teaching the children was a godsend.

Bergen-Belsen did provide the inmates their sole pleasure: "At the end of the day these air raid warnings are the only pleasant thing that we experience...All of Germany is being bombed." By November, thousands upon thousands of prisoners arrived from Auschwitz. Rumor had it that Auschwitz was liquidated by the retreating Germans. (Anne Frank was among the arrivals and soon succumbed to typhus.) Curiously, the Auschwitz prisoners were well fed. Hanna compared the two methods of extermination: "Back there, a brutal and cynical process, mass assassinations by gassing; here, a slow extermination, extermination, calculated in a cowardly way through hunger, violence, terror, consciously sustained epidemics....

By April 1945 (Germany surrendered May 7), food was reduced to a few spoonfuls of soup. "We don't die here, we rot to death," Hanna records. "The corpses are still here with us, in our beds. There's no one to remove them. And nowhere to put them. Everything is full. In the courtyards, too, the corpses pile up, heaps of corpses. They rise higher and higher each day. The crematory can't burn them all."

Hanna was saved when the British liberated the camp within days of her last diary entry. They found 13,000 unburied corpses and 60,000 inmates, walking corpses, as was attested to by the photographs and documentary they made and published abroad. "These documents had a lasting impact on the international perception and memory of Nazi concentration camps to this day.'

SPORTS Clipper Highlights: #28 Cody Richardson

This week we feature a Clipper that I am very thankful for. This week's highlight is twotime All State Running Back, #28, Cody Richardson.

Cody was a 2010 graduate of Amboy High School and a three year Varsity starter at Running Back.

Cody was one of, if not the most, important ingredients to Clipper Success during the 2007, 2008, and 2009 seasons. During these seasons, Amboy continued to play option football mixed with a power running game, a great defense, and strong offensive line. Over Cody's three Varsity seasons, the Clippers finished with a 26-8 record, a Quarterfinal appearance, and two second round playoff appearances. Cody sustained an injury during week 2 of his sophomore season which kept him sidelined until week 9. It's my belief that during week 9 of his sophomore season was when Cody erupted.

Despite missing seven games his sophomore season, Cody still produced the numbers to get selected Honorable Mention All Conference at Running Back. My memories of Cody during his sophomore season could go on and on but two plays specifically stick out. The first was Cody's 90 yard run at 10-0 PORTA. The highly favored Blue Jays had us backed up to our own 1 yard line when Cody broke off a 90 yard run. Cody's legs ran out of fuel on that play but he scored two plays later sealing our victory and advancing us to the Quarterfinals. During the Quarterfinal game against heavily favored Aurora Christian, late in the second quarter, Cody broke a long run into the red zone that would later produce one of Cody's touchdown receptions.

Entering the 2008 season, Cody's junior season, Cody was selected to the Sauk Valley Pre-Season All Area Team at Running Back. As the one feeding Cody the football that season, Cody's ability to score was scary. At any moment in any game Cody had the ability to break a long run or a touchdown. Cody's achievements became more impressive as he single handedly ran for 6 touchdowns in a 41-40 triple overtime win against Morrison. The following week, against Newman, Cody scored on a long run the opening drive and then caught a touchdown right before half. The biggest highlight from the 2008 season was in the first round playoff game against Spring Valley Hall. With 52 seconds remaining in the game, Cody, already with two touchdown runs, caught a 60 yard touchdown to win the Clippers the game. Watching him make the catch and run into the end zone is something I'll never forget and I'll always be thankful to him for that moment.

Cody's senior season the Clippers did something that most Amboy teams haven't done in the Three Rivers Conference. The 2009 Clippers beat #1 ranked Bureau Valley and then beat Newman at the Coliseum. The 2009 Clippers were one of the most successful teams to date in posting an 8-1 regular season record, losing only to the eventual 2A State Champion, Morrison Mustangs. The Clippers' great run ended at home against 2A powerhouse, Annawan Wethersfield in the second round. Cody stated, "the BV game was so awesome and comes second only to beating Newman that year.'

The awards, decorations, and accolades were not why Cody played the game. In speaking with Cody last night he stated, "I never played football for the individual awards or stats, I played to win because I didn't want to let my family, friends, and community down."

For those of us that know or played with Cody, he was often quiet both on and off the field but on Friday nights


there was no doubt that his mind was set on victory. Alike many other Clipper greats, Cody continued the Clipper Way.

Cody earned All Conference Honorable Mention his sophomore season, 1st Team All Conference/Area his junior and senior seasons, and several Sauk Valley Player of the Week honors. Cody is also a two-time All State Running Back.

There were only two former teammates interviewed or asked to provide a statement for this highlight. Both are classmates of Cody and fellow three year Varsity starters for the Clippers.

Former teammate and friend Levi Kaleel said the following, "He was an all around great player not only could he run but he had some of the best hands on the team. The way he could juke and stop on a dime then pick his speed back up was unreal. He never complained about anything and never asked for a break considering he got the ball 90% of the time play after play. It was a great feeling not only to me but the rest of the line knowing he was in the backfield. Made it a lot easier on us but it was a pleasure playing with him. It was a good feeling getting up off the ground and seeing him running into the end zone."

Former teammate and friend, Westin Montavon added, "Cody was an electri-

Additionally, the Board reviewed several options outlining a sports schedule framework for the remainder of the school year. The Board directed the IHSA staff to take feedback from the meeting, as well as any insight gained in the coming weeks, and bring forward viable scheduling options for a special Board meeting on Jan. 27. The Board will provide an update following that meeting.

Once state leadership allows for low-risk winter sports (boys'& girls' bowling, cheerleading, dance, girls' gymnastics, boys'swimming & diving) to begin participation, those teams will be allowed to begin practice immediately and then continue their season through the season calendar established by the Board later this month.

The IHSA successfully conducted seasons in golf, girls' tennis, cross country, and girls' swimming & diving through Sectional competition this fall, but all IHSA sports have been paused since Nov. 20.
