County and schools look to openings

Health Dept. head says this school year will be different

OREGON – The Ogle County's Health Department is working with area school administrators on plans to open schools to students this year, the head of the department told the Ogle County board at its July 21 meeting.

Kyle Auman told board members that his department is working with administrators to make sure students, faculty and staff are as safe as possible during the continuing COVID-19 pandemic.

"The upcoming school year will not look like school years past," he said.

He said they have heard

from many parents who do not want to send their kids back to school, adding that masks, social distancing and a lot of hand washing "are a must" to keep everyone safe.

Auman said the county is now averaging about three new cases of COVID-19 a day. He said areas of concern continue to be daycares and long-term care facilities.

"We've had several issues with daycare facilities," he said.

He said overall, his department has tested 13 percent of the county's population. There are currently 356 positive cases, but only one person is hospitalized with the virus.

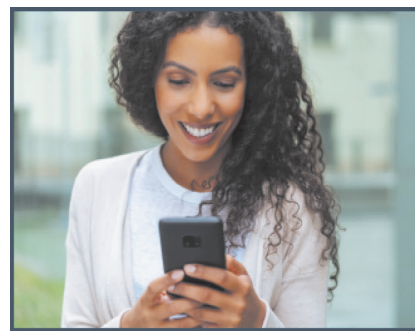

First positive mosquito pool found in county this year

Ogle County – The Ogle County Health Department (OCHD) has confirmed the first positive mosquito pool for West Nile virus in Ogle County for 2020.

A pool of mosquitoes found near Rochelle tested positive for West Nile Virus (WNV) on July 21st, 2020. The Ogle County Health Department will continue surveillance and testing mosquito pools from across Ogle County, as well as conducting mosquito abatement with methods such as larviciding to help control mosquito populations across Ogle County.

Monitoring for West Nile virus in Illinois includes laboratory tests for mosquito batches, dead crows, blue jays, robins and other perching birds, as well as testing hu-

mans with West Nile virus-like symptoms. People who observe a sick or dying crow, blue jay, robin or other perching bird should contact their local health department, which will determine if the bird will be picked up for testing.

West Nile virus is transmitted through the bite of a Culex mosquitoes, commonly called a house mosquito, which has picked up the virus by feeding on an infected bird. Common symptoms include fever, nausea, headache and muscle aches. Symptoms may last from a few days to a few weeks. However, four out of five people infected with West Nile virus will not show any symptoms. In rare cases, severe illness including meningitis or encephalitis, or even death, can occur.

People older than 50 and individuals with weakened immune systems are at higher risk for severe illness from West Nile virus.

Precautions include practicing the three “R’s” – reduce, repel, and report.

REDUCE – make sure doors and windows have tight-fitting screens. Repair or replace screens that have tears or other openings. Try to keep doors and windows shut. Eliminate, or refresh each week, all sources of standing water where mosquitoes can breed, including water in bird baths, ponds, flowerpots, wading pools, old tires, and any other containers.

REPEL – when outdoors, wear shoes and socks, long pants and a long-sleeved shirt, and apply insect repellent that contains

DEET, picaridin, oil of lemon eucalyptus, or IR 3535 according to label instructions. Consult a physician before using repellents on infants.

REPORT – report locations where you see water sitting stagnant for more than a week such as roadside ditches, flooded yards, and similar locations that may produce mosquitoes. The local health department or city government may be able to add larvicide to the water, which will kill any mosquito eggs.

Byron City Hall again open

BYRON – Byron City Hall resumed normal hours of operation on Monday, July 20, after being closed the week prior due to exposure to COVID-19.

The normal hours of operation 8 a.m.-4 p.m. Monday through Friday. Byron Mayor John Rickard made the decision to close City Hall to the public beginning July 14.

According to a post on the city's Facebook page, a worker in the building has tested positive for COVID-19. The worker has had no contact with residents coming into City Hall. Employees that work closest with the individual were notified and have been tested awaiting their results. Thorough sanitation measures were taken before the building was reopened.

Auman said 300 people have recovered, and a total of five people have died of COVID-19 in the county.

“We’ve been working diligently to respond to the various needs of Ogle County,” he said.

In response to a question from the board, Auman did remind everyone that the

county does have a mandatory mask rule, and that the county does investigate when it receives tips that worked at area businesses – like bars and restaurants – are not wearing masks and following safety protocols.

“I have nothing but respect for you and your staff for what you’ve done through this whole thing,” said County Board Chair-

man John Finrock.

In other action:

The County Board approved special use conditions for solar farms in the county by a 20-4 vote.

The board basically approved the same ordinance that it had considered in January 2019, with some changes, including to the noise ordinance.



On July 25, 1930 Charles Armour Williams (A.K.A. Chuck, Bub) was born to Charles H. and Margaret Williams of Stillman Valley, the eldest of what would become six siblings (3 brothers and 3 sisters). Growing up through the trials of the Great Depression he attended a small, one room school (grades K-9) on the corner of Armour Road and Route 72. As World War II raged, he transferred to the new Stillman Valley High School, where he excelled in several sports and became his Class President. He was a great basketball player and (from what his peers have told me) an even better baseball player. He graduated SVHS in 1948 and declined a sports scholarship (to what would become Northern Illinois University) to stay around the farm and help his family.

Chuck became a well-known local carpenter, often working with his brother Robert (Ding) and their father building houses. Many houses around Stillman were built by my dad- in fact, you might be living in one now! He worked as a carpenter for over 20 years before taking a job with the Illinois Department of Transportation Highway Department, where he worked for 25 more years. In 1967, he married Beverley Freeman, who had two kids from a previous marriage, my uncle and mom. He did his best to be a good Stepfather to them both. I came along in 1974 during a tough time for my mom. Chuck and Beverley took me in, adopted me, and raised me as their own. I took a lot of guts and compassion to raise someone else's kid, but he did it and in my humble opinion he did it well. I learned many things from dad: like how to throw a curveball, the best way to box out and rebound, ride a bicycle, and drive a car. He read me books every night before I went to bed, some of the most important being those about dinosaurs and paleontology. He took me all over the country visiting museums, historical sites, and National Parks. He was there for all my sporting events, school musicals and plays, academic events, and important moments. After high school and a bit of college, dad supported my course change to become a police officer and was there when I graduated in 1997 at the top of my Correctional Officer Academy Class; he was back two years later when I graduated from the Illinois State Police Academy. He stayed by his beloved Beverley as she fought cancer for over a year and was by her side when she slipped her Earthly bonds.

He was cautious, yet supportive, when after seven years of law enforcement I left the Ogle County Sheriff's Department to pursue my first love: paleontology. I began working at Burpee Museum of Natural History, and in fact, Jane the juvenile T. rex exists at Burpee in strong part because of his support of my interests.

Later, at the age of 73, he went with me to the Hell Creek Formation (Badlands) of Montana to see what this “dinosaur business” was all about! We followed that with a 3200-mile road trip to Alberta, Canada for more paleontological adventures. He supported me yet again when, after 14 years, I chose to leave Burpee for a job at the famous Museum of the Rockies in Bozeman, Montana, and he even braved another long road trip to come see my new museum in 2017. Those who know my dad know he is likeable; some would say loveable. He is kind to all he meets and usually has some folksy, bumpkin saying or story to go with his greetings. He can be oblivious to some things, and he and I often argue about politics (for the record, he is almost always wrong), but you can't NOT like the guy. He is a good man. As dad turns 90, I write all of this with a bit of melancholy because I had hoped to be home for his 90th birthday. Obviously, this awful COVID world makes my coming home not only impractical, but possibly dangerous, so in Montana I must stay. So my birthday present to this good man is to write this much abbreviated biography and say, despite the ups and downs, the hurdles and challenges and the times we both fell short of each other, I love you very much. Hopefully I will see you at Christmas!

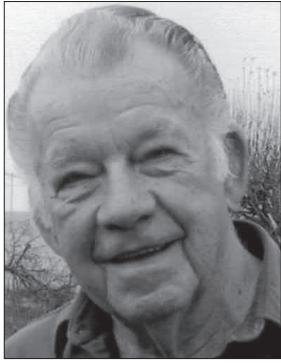

Cook: Voters should consider voting by mail

OGLE COUNTY – Laura J. Cook, Ogle County clerk and recorder, announces the COVID-19 pandemic is a continuing concern as the 2020 General Election approaches.

Cook encourages voters to consider Vote by Mail as a safe, secure and convenient option to cast a ballot. The Illinois General Assembly this year passed an election bill that provides many safeguards against the spread of coronavirus in the voting process for the November 3rd General Election. Chief among them are provisions to increase Voting by Mail throughout the state.

As of Aug. 1, 2020, all registered voters in Ogle County will receive a "Vote by Mail" application from the County Clerk's Office in the mail. The application will contain information on how to obtain a "Vote by Mail" ballot.

"Voting by Mail in the safety of your home is a great option for those con-

cerned with the COVID-19 pandemic," Cook said. "When you choose to Vote by Mail you are reducing the risk of exposure. Voting by Mail has been an option in the State of Illinois for voters, overseas citizens and military personnel for years and is secure."

Ballots will be mailed to applicants beginning Sept. 24, which is also the first day of Early Voting. The deadline for applying for a Vote by Mail ballot is Oct. 29. Ballots must be postmarked no later than Election Day, Nov. 3 to be accepted, and properly postmarked ballots will be accepted through Nov. 17.

There are security procedures in place that upon the return of the "Vote by Mail" application, the signature will be verified by the Election Staff of the County Clerk's Office. If the signature matches, the ballot will be mailed. But if there is a discrepancy, it will be taken care of immediately before the

ballot is mailed to the voter. Once the ballot has been returned to the Election Authority, there will be three Election Judges who will verify the signature on the "Ballot Certification Envelope" to the signature on the application. A ballot may be rejected for an invalid signature only by unanimous decision of the judges.

The ballot may be rejected based on a signature or lack of signature or because the ballot envelope was delivered opened. If this shall happen, the voter will be notified within two days or within one day if the rejection occurs after Election Day. The new law contains provisions for the voter to address these problems.

Electronic recycling event will be July 31

OREGON – The Ogle County Solid Waste Management Department (OCSWMD) will be accepting residential electronics from Ogle County residents for recycling on Friday, July 31, from 9 a.m.-4p.m. at the County Annex Building at 909 Pines Road in Oregon.

This event is for electronic items from Ogle County residents only, please limit seven large items per monthly recycling event.

Due to the COVID-19 pandemic and for the protection of workers and residents, the following guidelines have been put in place by the OCSWMD for the acceptance of residential electronic items:

* All residents attending the event must stay in their vehicles at all times with the windows closed.

* Residents are to show their acceptable Ogle County I.D. to county staff through vehicle window (drivers' license, voter registration card, or recent utility bill accepted).

* Electronic items must be loaded into trunk, truck bed, trailer, or rear of a van or SUV, and easily accessible to county staff to remove. Limit of seven (7) bulky accepted items per vehicle; and box or tub loaded with smaller items is considered one bulky item.

* Residents are advised to bring in only accepted items for recycling, please check the list below or visit the county website for a full list of accepted items.

* Items must be removed from original packaging prior to arrival at the recycling event.

* Microwave ovens are \$5 per unit. If you have a microwave oven to recycle please tape an envelope with payment to the outside of the device prior to arrival at the event. Cash or check, payable to Ogle County Solid Waste Management Department, accepted. Exact payment only, no change will be available for larger denominations.

* If a resident or their family member(s) are feeling ill it is advised that they stay at home and recycle their electronics at another future recycling event.

* If electronic items have been in a residence with a positive COVID-19 individual, it is advised to not bring these items in for recycling until a future recycling event.

Accepted items include all

televisions, computers, computer monitors, computer hardware and cables, printers, FAX machines, copiers, scanners, video gaming items, VCR/ DVD players, cable and satellite boxes, cell phones, tablets, laptops, radios, stereo equipment (no wooden speakers), digital clocks, holiday light strands, extension cords, phone systems, calculators, shredders (no plastic tubs), rechargeable batteries, CFL bulbs, and printer ink cartridges. Microwave ovens accepted for \$5 per unit, limit seven (7) bulky items per vehicle.

Items NOT accepted include smoke detectors, coffee makers, toasters, bread makers, vacuum cleaners, fans, heaters, air conditioners or dehumidifiers, lamps, power tools, alkaline batteries,

LED bulbs, exercise equipment, medical equipment of any kind, toys or drones, business or institutional electronic items, and any packaging from electronic items such as boxes, plastic wrapping, and Styrofoam.

The OCSWMD reminds residents that recycling events may be cancelled or abruptly ended due to weather conditions, warehouse volumes, staffing issues, events related to the COVID-19 global pandemic, or for other uncontrollable events or situations.

The 65 million-year-old specimen dubbed Sue, after its discoverer, is 42 feet long with a 2,000-pound skull and 58 teeth.

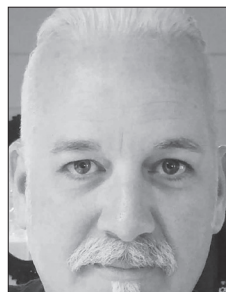

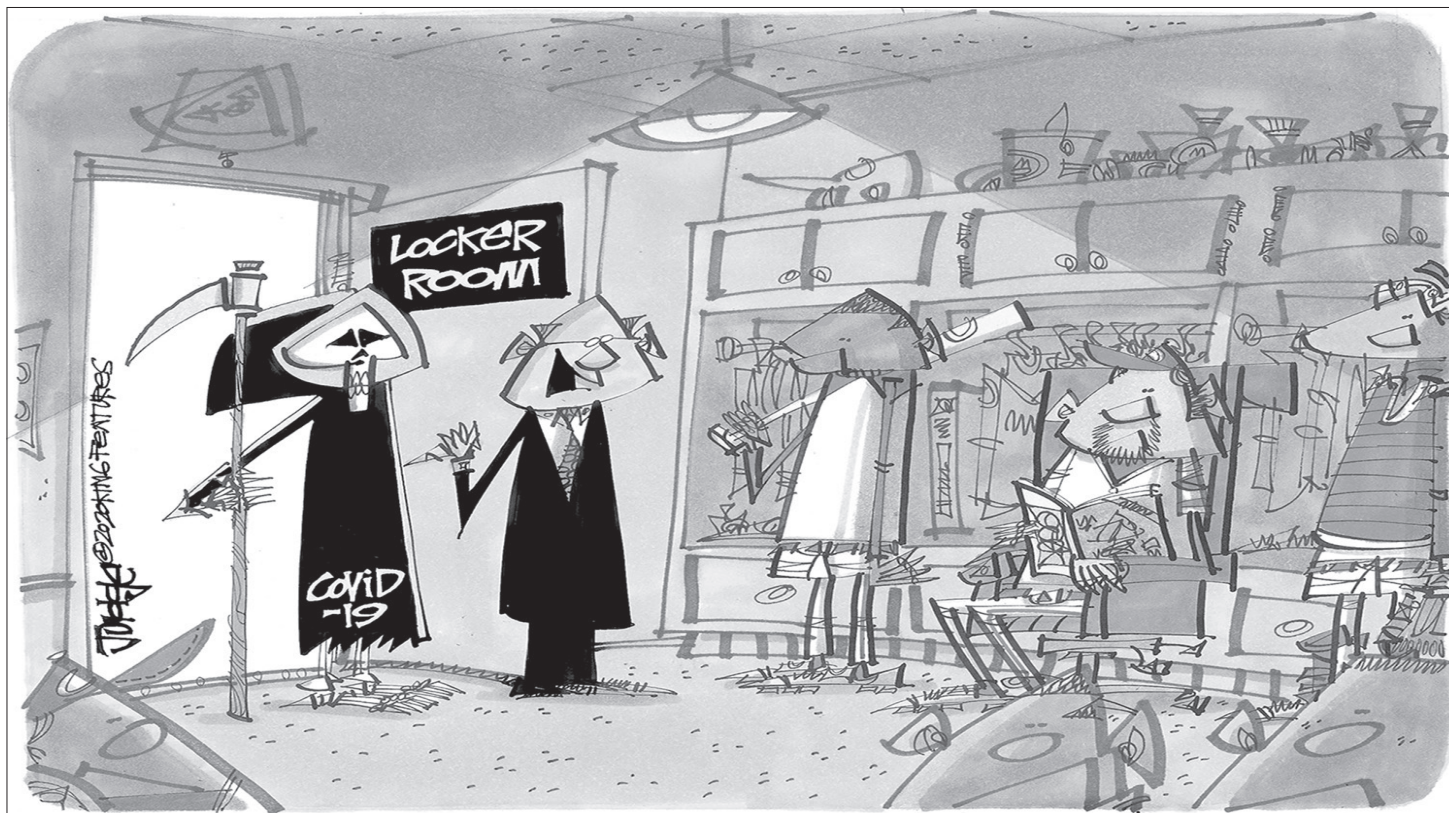
Where were the masks in front page photo?
