

# Ogle County fair cancelled

### Planning for 2021 already underway

In his first year as Fair Board President, cancelling the 2020 Ogle County Fair is clearly not what Tom Simpson wanted to do.

"It was quite tough," Simpson said. "There was a lot of meetings that took place prior to making these decisions."

But the board had to do this due to the continued uncertainty surrounding the COVID-19 pandemic.

"The first Ogle County Fair was held in October of 1853 on the lawn of the Ogle County Court House. Since then, thousands of patrons have attended the fair each year," the Board said in a release. "Our focus has always been on the health and welfare of our communities, families and friends. While we strive



each year to put on the best and most affordable fair the Global impact of the COVID pandemic has created necessary action."

On May 15, the Illinois Association of Agricultural Fairs provided, "Current resources that

focus on the COVID 19 (Coronavirus) situation." The guide has been published for the safety and best ways to protect our communities.

# Oregon works with businesses on reopening

OREGON – In response to Governor Pritzker moving the State of Illinois into Phase 3 on May 29, the City of Oregon immediately began planning to help assist our local businesses in creating outdoor seating space for use by their customers.

At a press conference on May 27, Mayor Ken Williams said that some city parking lots will be converted into outdoor seating for Oregon businesses. The conversion was expected to be completed by the May 29 opening date.

"Oregon is a friendly active community and we all look forward to the next step in controlled opening up of our businesses," Williams said. "We have an amazing and engaged group of citizens that came together to create a downtown dining and entertainment experience to serve our residents and benefit

our businesses."

Working closely with the Oregon Area Chamber of Commerce the City of Oregon has taken the following steps:

\* On May 26 the City Council voted unanimously to place a temporary moratorium on ordinance 4-11 (No alcohol allowed on City Property). This will allow alcohol service in the outdoor designated spaces on City Property by permit.

\* The City has designated the 1st and 2nd row of parking (excluding the handicapped parking space) in the 3rd Street Municipal parking lot for outdoor seating for restaurant and bar customers.

\* A 20-minute parking space(s) will be designated in the 3rd Street Municipal lot for customers to pick up and drop off.

# linois moves to Phase 3

SPRINGFIELD - Illinois advanced to the "Recovery" phase of Gov. JB Pritzker's plan to incrementally reopen the state's economy on Friday, May 29 after almost 70 days of residents living under a stayat-home restriction.

It came as Illinois was one of only two states to meet federal COVID-19 guidelines to reopening, according to a ProPublica analysis. New York is the other.

Retail shops, restaurants, barbershops, salons and fitness clubs are set to resume business, but with restrictions implemented by the Illinois Department of Public Health to combat exposure to the novel coronavirus.

All state parks, wildlife areas and historic sites will be available to visit as well, and social gatherings of no more than 10 people will be allowed.

The changes are permitted because all four Illinois regions - groupings of counties based on IDPH's emergency medical service districts - achieved specified benchmarks. Those include a COVID-19 positivity rate below 20 percent for 14 consecutive days and a stable or declining hospitalization rate.

When Pritzker announced his Restore Illinois plan in early May, he said residents should expect COVID-19 to remain a threat until it can be 'vanquished."

"Until we have a vaccine or an effective treatment or enough widespread immunity that new cases fail to materialize, the option of returning to normalcy doesn't exist," the governor said.

People will still be expected to wear facial coverings and practice social distancing.

"Non-essential" businesses and stores, closed for more than two months to in-person customers and workers, can reopen Friday with capacity limitations, social distancing observations and other safety guidance measures from IDPH.

That same guidance will be implemented for barbershops and salons. And for those workplaces that can enable remote activities, it is encouraged they do so.

Restaurants will remain closed to indoor dining, but Pritzker amended the Phase 3 plan to allow outdoor, socially distanced dining. Delivery, pickup and drive-thru are still

All of the state's 5,000-plus child care providers not in operation will be advised to reopen. Pritzker said for the first four weeks that they are open, providers will be able to serve up to 10 children per classroom.

"Once they have provided care safely for four weeks and have gotten accustomed to the new health, social distancing and sanitation routines, they will be able to expand to larger group sizes, though not yet at their fully licensed capacity,"

Fitness clubs can also hold outdoor activities, as well as one-on-one training with an instructor so long as public health department guidance is observed.

The General Assembly created a Restore Illinois Collaborative Commission to "participate in and provide input on plans to revive the various sectors of the state's

economy in the wake of the COVID-19 pandemic" when it convened for four days last

Because the commission "may request meetings be convened to address revitalization efforts for the various sectors of the state's economy," it is unclear what level of input legislators will have on the governor's reopening plan.

Republicans, who long sought more input in that blueprint, called the newly created body "window dressing."

The next step after the "recovery" phase is "revitalization." Schools and other child care programs can reopen so long as social distancing is observed, restaurants can serve in-house diners and social gatherings will be limited to 50 people or fewer.

Framers of the plan anticipate at least a 28-day period before the state can progress into that phase, meaning no sooner than Friday, June 26.

Among the criteria for entering Phase 4 will be that COVID-19 testing is available to anyone who wants it, regardless of symptoms or risk factors; a contact tracing program must be in place; hospitalization rates must remain stable or decline; and the positivity rate must be below 20 percent for 14 consecutive

this Reopening Guide. ... health and safety measures are the best ways to protect live events and the people who create them, while also inspiring patrons to return to the places where we make magic happen," said Steven A. Adelman, Vice President, Event Safety Alliance.

The Ogle County Fair Association met and reviewed the pros and cons amid COVID-19 pandemic,

along with recommendations in the guide noted. The Fair Association discussed when it's legal and reasonably safe, sanitizing the venue, increased social distancing to sanitization stations, temperature and health screening with highest priority of safety for fair goers. In the interest of protecting everyone who would attend the fair, the Ogle county Fair Association took a vote and it was unanimously decided to cancel the 167 the Ogle County Fair. The board said the health risks and added layers necessary for safety far outweigh the benefits of having the fair this year.

Simpson said the board has already "changed gears" and is focusing on the 2021 fair. He said they hope to make the fair "Bigger and better.'

"We could have never expected this to happen but putting our fair goers at risk would never be worth it in the long run," he said. "Safety has to come first. We are all looking forward to next year and making it the best fair Ogle County has ever seen.'

\* Odd Even parking enforcement in the 3rd Street Municipal Parking Lot will be suspended temporarily. (We ask the public to be mindful of the necessary parking for our local business needs as they begin to open. 2 hour and all other parking regulations will continue to be enforced.)

\* We have designated the drive thru lane of the old Community State Bank (owned by the City) for outdoor seating. The public bathroom will be open (following sanitization recommendations) for use by outdoor customers.

# Oregon will have drive-in graduation ceremony June 19

OREGON – The Oregon Community Unit School District will conduct a "Drive-In" Graduation Ceremony on Friday, June 19, beginning at 8:30 p.m. in the parking lot of Blackhawk Center, 1101 Jefferson Street, Oregon.

The drive-in graduation will include traditional aspects such as a stage, lights, music and student speeches. Graduating seniors will have the opportunity to walk across the stage while following all social distancing guidelines.

When they arrive at Blackhawk Center, students will receive one assigned parking spot for themselves and immediate family members.

Families are asked to remain in their vehicles during the duration of the ceremony. Families will drive students to the stage where students will get out of their cars, walk across the stage one by one maintaining social distancing, and return to their cars to observe the remainder of the ceremony. Student speeches will be shown on a projector of duels.

### Agencies offer free summer meals

OREGON – The Oregon Park District is excited to partner with The Oregon United Methodist Church and RiverStone Christian Church to offer anyone 18 and under free lunches this summer Monday-Friday at a drive-up location at Mix Park.

Meals will begin on Monday, June 1 and run through Aug. 12. Menus will be available at www.oregonpark.org. These institutions are equal opportunity providers

Due to Covid-19, the Northern Illinois Food Bank will be partnering with agencies to offer a boxed lunch and breakfast each day from 12-1 p.m. at our drive-up location in Mix Park, Oregon from South Route 2.

These programs have been offered in the past but have always required on-site consumption and only one meal per person.

In prior years, Ogle County had 8 sites offering meals. This summer only two of the sites will be open to the public, the Mix Park location and Mount Morris.

"The Northern Illinois Food Bank has identified that most sites chose to eliminate the offerings due to a lack of volunteers and risk associated with enforcing social distancing and the updated guidelines," said Erin Folk, executive director of the Oregon Park District.

No one will be turned away and this is open to anyone, regardless of location of residency. Please help spread



the word to ensure everyone in our county receives the food they need.

Folk said that in the past, about 25-30 meals a day have been served.

This drive-up location will also accept walk-ups, but everything will be contact-less. Anyone can request meals for children 18 and under and they need not be present to receive the meal. Meals will be placed in a trunk or seat. Drivers or anyone walking up will be required to wear a mask and volunteers will be wearing masks and gloves and comply with social distancing guidelines.

Folk said she believes this is an important option considering the, "current pandemic and the drastic effects it has had on many families."

"I am pleased to partner, once again, with Oregon United Methodist Church and River Stone Christian Church to provide meals to our county," Folk said. "A special thank you to the coordinators from each partner and the volunteers who will be assisting with meal delivery this summer."

# Tornado confirmed on May 23

OGLE COUNTY — The National Weather Service has determined an EF-1 tornado with 90 to 100 m.p.h. winds and an approximate width of 100 yards caused damage on May 23 near the intersection of Canfield Road and Rocky Hollow Road.

Trained weather spotters observed several funnel clouds and the tornado resulted in siren activation without weather warnings.

A severe storm warning was issued on May 23 at 1:33 p.m. for southwestern Ogle County by the National Weather Service.

A tornado watch was also issued beginning at 12:33 p.m. and lasting until 8 p.m. for Ogle County as conditions were favorable for tornadoes in the area. Three rounds of sirens were issued in Ogle County Saturday afternoon.

The outdoor warning siren system was updated in April. The outdoor warning sirens will be sounded in the event of a tornado warning (funnel cloud spotted or radar indicated) and/or in the event of a severe thunderstorm warning with 70 m.p.h. or more winds, whole trees downed by winds or golf ball sized hail.

## Rochelle OKs plan to reopen restaurants, bars

As part of the Illinois Phase 3 reopening plan, City of Rochelle officials approved suspension of specific municipal codes to support reopening of local restaurants and bars

The city has come up with a plan for businesses to use outdoor public spaces and the extension of liquor licenses under the limited capacity and social distancing guidelines of Governor Pritzker's Restore Illinois Plan.

An outline of plans has been

made by city officials who intend to meet with local business owners to discuss what will work for them, specifically.

We are going to meet with local restaurant and bar owners to find out what will work best for them," city manager Jeff Fiegenschuh said. "These are just guidelines."

Beginning immediately, the following opportunities and regulations will allow for local bars and restaurants to reopen:

Use of right-of-way and city

streets for public pedestrian use from 7 a.m. to 10 p.m., with a maximum use of 60 minutes.

Use of parking lots for outdoor seating from 7 a.m. to 10 p.m., with a maximum of use 60 minutes.

Within the areas designated only, the city has provisionally waived prohibitions on the public consumption or possession of alcohol. This prohibition waiver is for the consumption of packaged alcoholic beverages purchased from adjacent licensed bars/restaurants only. After hours public consumption will be enforced along with public consumption outside of the designated areas.

Local and state laws and all guidelines from the Center for Disease Control and the Illinois Department of Public Health surrounding public gatherings and alcohol consumption will remain in full effect and enforcement by the Rochelle Police Department. This applies to public intoxica-

tion, disturbances, fights, noise complaints and other statutory laws.

"We are still waiting for final guidelines – we are currently under the assumption that we are following the Department of Commerce and Economic Opportunity guidelines," Fiegenschuh said during Tuesday night's council meeting. "We want this to be fluid, we have a meeting with business owners on Wednesday to find out what their needs are."

### Driver services facilities in Illinois to reopen starting June 1

Illinois Secretary of State Jesse White announced today his office's reopening plan – beginning June 1 – with the first two months focused on serving only new drivers, customers with expired driver's licenses/ID cards and vehicle transactions.

Currently there are more than 700,000 expired driver's licenses/ID cards and 1.9 million expired vehicle registrations.

All Secretary of State departments and offices will be open for business on June 1. The reopening dates and locations for Driver Services facilities statewide are as follows:

June 1 – Monday through Saturday facilities (Chicago North, Chicago South and Chicago West) will open Monday, June 1. Expanded hours of operations are Monday 7:30 to 2 p.m., Tuesday through Friday 7:30 a.m. to 6 p.m. and Saturday 7:30 a.m. to 2 p.m.

"Throughout this pandemic, my com-

mitment has been to do everything we can to help protect the health and safety of our residents and my employees, while providing services to the people of Illinois," said White. "This reopening plan adheres to this commitment."

Protective Safety Measures

Customers and Secretary of State employees will be required to wear face masks unless a medical condition prohibits the safe use of a mask. Plexiglass dividers have been installed at all work stations and tape has been applied to the floor in 6-foot intervals to follow social distancing guidelines, limiting the number of customers inside a facility at one time.

For drive tests, employees will wear a face mask and a face shield due to the close proximity with the customer inside the vehicle. Customers will be required to wear face masks unless medically unable. Disposable plastic will be used to cover the vehicle seats during the drive test and then discarded immediately after the conclusion of the drive test.

Online Services Still Encouraged

White continues to encourage residents to go to www.cyberdriveillinois.com to take advantage of many online services – such as renewing vehicle registration stickers – from the comfort of their own home. People who conduct online transactions will avoid waiting in line at a facility.

Since March 17, through online services, the office has issued more than 775,000 vehicle registration stickers, 350,000 titles and 200,000 driver's licenses/IDs.

90-Day Extensions for Driver's License/ID and Vehicle Registration

White is reminding customers that his office extended expiration dates by at least 90 days after the governor's June 1 disaster proclamation executive order ends. This extension will ensure driver's licenses, ID cards and vehicle registrations remain valid and will help alleviate the initial rush of customers visiting the reopened facilities.

REAL ID Federal Extension

White also reminded the public that the federal government extended the REAL ID deadline by one year until October 1, 2021. White had petitioned the federal government for this extension due to the COVID-19 pandemic. People with valid U.S. passports are encouraged to consider delaying their visit to a facility to apply for a REAL ID until their driver's license is near its expiration date.

Historical Background

Following Governor JB Pritzker's Stayat-Home order, White closed Driver Services facilities to the public on March 17. His office has continued to serve the public through online services, which increased by more than 50 percent during the office closures.

#### Ogle County Courthouse and Pines Road Annex reopening to the public

The offices of the County Clerk and Recorder, Treasurer, Supervisor of Assessments, Animal Control, County Board Chairperson, County Board Vice-Chairperson, Planning and Zoning and Solid Waste will reopen to the public on Monday, June 1.

While COVID-19 is still a public health concern; these offices will be following the guidelines from the CDC and Ogle County Health Department. Before entering the building, a mask will be required, and social distancing procedures will be required and in place.

In an effort to be proactive and to better protect the public and county employees these departments may have operational changes with restrictions and limitations due to COVID-19 that the public will need to follow.



Yes, they should. And if you think it is fine to disenfranchise millions of voters, please don't tell me you love American and what it stands for.




Today, 5/20/2020, Governor Pritzker stood at a podium and admitted that he did not have the authority to violate the Constitution.

Q: Will "Young Sheldon" be returning with new episodes this fall? It's my favorite sitcom, and I love the tradition of all the new shows starting in the fall. Is that wishful thinking during this crazy year? -- P.B.

A: As of now, CBS plans to launch the fall season as scheduled. 






Other attractions in Creston include the always expanding library, periodic bingo games in the old Creston Opera House (Booster Hall), park district activities, and picnics and family reunions that can be held in one of the village's parks. A one-day Fall Festival is held at the library on Halloween weekend.

Creston Booster Park, on the southern side of town, can be rented on a first-come, first-serve basis from May 1 through Oct. 1. The park includes a covered pavilion, washroom facilities, a full functional kitchen and a playground. For information, call 815-384-4140.

For antique lovers, there's Roadhouse Antiques, located right on Illinois Route 38. Creston, which is located on Illinois Route 38 on the far eastern side of Ogle County, has the proud motto: "Come Grow With Us."

# **Davis** Junction



Mainline tracks coming and going to Rockford intersected with east- and westbound traffic at a literal crossroads, hence the name Davis Junction.

These days, one train a day heads south toward Holcomb, and into the Rochelle community near Flagg Center, however, east and westbound traffic toward Chicago is still brisk.

There are several eating establishments in the area, some within the city limits, other choices may be found at the intersection of Illinois Route 251 and 72 two miles to the east. There is a small strip mall at this intersection as well, providing health care through SwedishAmerican Medical Group, and other amenities. At the west edge of the village is a recently added Dollar General store, bringing local shopping convenience to the community.

One of the most impressive areas of Davis Junction is found at the Veterans Memorial located on Moody Avenue one block north of IL Route 72. Installed in 2014, it was designed by Richard Cody Janes who also created the sculptures of servicemen. The memorial was later updated to list the names of those were lost during the Vietnam War.

The housing industry has blossomed in Davis Junction with the development of Ogle Crossings subdivision, site of dozens of new homes and the local community park.

# **Grand Detour**

ALKING through the white wooden gates at the John Deere Historical Site in Grand Detour is liking stepping into another world, one that doesn't exist anymore. In fact, the late, great Orson Welles probably put it best when he said: "Grand Detour is like a lost world, one of those Eden's you get thrown out of."

Welles spent boyhood summers at a hotel his father once ran in Grand Detour, which is located between Oregon and Dixon on U.S. 251, on the southern edge of Ogle County.

"It was kind of a forgotten place," he said.

Although it is no longer there, Welles reportedly snuck into a local dance hall where he practiced the latest dance moves by the light of the moon.

A quaint, rustic little village of stately homes and lingering trees, Grand Detour sits right next to the Rock River. Besides a scenic view, there are places to fish, boat, camp or just enjoy a leisurely picnic.

By far, the biggest attraction in town is the John Deere Historical Site, 8334 Clinton St., where the noted blacksmith invented the first self-scouring steel plow, which revolutionized the farming industry.

Among the things you will see are is a 1950s view of Mason Street, a full collection of the New Generation series John Deere tractors, a bright red 1963 Impala, a reproduction drive-in theater, a game room and much more. You can also enjoy a 1950s ice cream social. There's also a bed and breakfast that can be rented out for special occasions. It accommodates 400, including chairs and tables for 200.

## Rochelle

OCHELLE could be known as the unofficial entertainment capital of Ogle County. Located at the intersection of U.S. 251 and Illinois Route 38, the "Hub City" is the largest town in Ogle County with approximately 9,000 people.

Among its alumni, actress Joan Allen grew up in the "Hub City." Among other credits, Allen has won a Tony Award, has three Oscar nominations, and once hosted Saturday Night Live. Comedian Tim Clue also grew up in Rochelle. He is just one of several published authors who lived in town at one time or another.

Two major motion pictures have been filmed in Rochelle, including "A Thousand Acres," and "At Any Price." The first, based on Jane Smiley's Pulitzer Prize winning novel, featured an all star cast of Michelle Pfeifer, Jessica Lange, Jason Robards Jr., Colin Firth, Michelle Williams, Elizabeth Moss, Keith Carradine and Pat Hingle.

The second featured Dennis Quad and Zac Efron, and included a memorable scene of the old Hub Theater in the downtown business district.

In 2017, the Hub Theater was purchased by a local farming family that transformed the venue into a distillery.

The Vince Carney Community Theater group is in full swing, offering a variety of innovative plays and musicals each year. They soon will be performing in their newly renovated home — the former Lincoln School — located at South Main Street and First Avenue

Once a month a free movie is shown at the Hub City Senior Center, 401 Cherry Ave. The center also offers bingo on Tuesday and Thursday mornings, as well as lunches, card games, billiards, knitting and other activities. The center has free computer service and holds a special birthday party once a month.

Train enthusiasts can find plenty of entertainment at the Ken Wise Rochelle Railroad Park, located between the train tracks on Eighth Street. The park is reported to be the second of its kind in the entire world and the first in the United States. There is a shelter, benches and grills for picnics. A stationary train greets visitors at the entrance, which all ages are invited to sit on, right across from the park office.

#### Polo Fun Facts:

- "On Any Given Sunday" is a motorcycle museum at 208 W. Mason St., Polo. It is in an old, converted Baptist church, dating back to 1876. Despite its name, the museum is by appointment only, 815-622-6870. Groups are welcome.

This year's concert is slated for Aug. 2 from 6 p.m. to 8 p.m. in Ropp Park located just west of Stillman Valley High School.




