# **Encore! Mt. Morris** members working to transform village

**MOUNT MORRIS** – If Jeff Bold, Molly Baker and the rest of the people with Encore! Mt. Morris have their way, this little village will become a hotbed of arts activity.

"The idea is to create a unique, rural and cultural arts destination in Northwest Illinois," said Bold, president of Encore.

Encore! Mt. Morris began in 2016, after about 80 people got together for a visioning workshop, organized by the Mount Morris Economic Development

group. The workshop included local small business owners and artists, along with outside city planners and others. With the former thriving publishing town now without that major employer, what could be done to revitalize the town and specifically the campus area?

'People were saying, what is Mount Morris going to be now that we are no longer going to be a printing and publishing town? What is our future?" Baker said.

Out of that retreat came "Encore! Mt. Morris, and the group hit the ground running.

"We are still, pretty much, a subset of economic development," Baker said. "We are trying to make Mount Morris a rural destination for the arts, but also make Mount Morris a place where people want to live, where businesses will want to locate because employees will want to live here because there is stuff going on."

And that is what it is all about - how to make Mount Morris an attractive place to live.

"In an Amazon world, when you live in a town of 3,000 and you can get anything overnight, what do you do to make quality

of life better for people?"

That first year, the group launched Porchfest, where musicians perform - you guessed it – on people's porches. They modeled the event after one held in Georgia.

"You can kind of pick what you want to go see," Bold said of the relaxed

The group also hosts art events in the Old Sandstone Gallery. This includes student art shows as well as art auctions. Besides special events, the gallery is open during the summer on Wednesdays from 7-9 p.m. and Fridays from 6-9 p.m.

Encore! also just hired its

third summer artist in residence, who helps design and create hands-on art experiences for the community.

And of course, there is the U.S. Straw Sculpting competition, which this year runs from Aug. 7-23. Strawfest will be on Aug. 22.

The competition was held in Rochelle its first year, and Bold said Encore! wanted it for Mount Morris, where it has been held the last four years. The event draws thousands of visitors.

Baker said they were "really shocked" at the size of the crowds for the event.

"We had people morning, noon and night," she said.

Bold said they hope to continue to grow that event.

Most of the events are free or at low cost to the community. Funding for the group comes from grants and donations. ComEd has been a strong sponsor.

Looking to the future, Baker said they are always looking for new volunteers as the group is growing. The goal of growing the local economy and making Mount Morris a great place to live are still the focus. And the

# Attorney in fatal fire case again seeks continuance

**OREGON** – More time is needed to analyze cellphone data in the case of the Byron man accused of killing his wife and son in 2016, his lawyer said during a pre-trial hearing on

Christopher Derango, lawyer for Duane Meyer, said the cellphone expert working for the defense had finished a primary analysis, but now wants the raw data, provided by the FBI, to

Derango asked for a 45-day continuance, and Judge John Roe provided

it, setting the next pre-trial hearing for Monday, April 20 at 1:30 p.m.

Meyer is accused of setting the 2016 fire in Byron that killed his ex-wife Maggie Meyer and 3-year-old son Amos Meyer.

He was charged on Oct. 9, 2019 with four counts of first-degree homicide, two counts of aggravated arson and one count of concealment of a homicidal death. He is currently being held in the Ogle County Jail on a \$10 million bond.

Separately, State's Attorney Eric Morrow said that his office has provided all of the police reports and other evidence generated by the investigation into the fatal fire. He said that includes, over 30,000 pages of documents along with many digitals files containing evidence collected during the investigation."

"If the defendant intends to use this expert at trial they will need to provide our office with the expert's report through the discovery process," Morrow said.

As for the strength of the case, Morrow was clear.

"We believed that we had strong enough case to proceed with charges against the defendant and the Ogle County Grand Jury agreed and returned a true bill of indictment," he said.

In Sweeny Todd, a barber takes revenge on those who've wronged him with the help of a struggling pieshop owner, who mysteriously begins to profit from the number of his victims. A 2007 movie adaptation of Sweeny Todd stars Johnny Depp and Helena Bonham

"At its heart it this is a story about rich vs poor, classism, revenge and what it does to your soul, and the tragedy of how that destroys people's lives. It is

a cautionary tale told with a good sense of humor," says director Jen Wygant.

Guests will see dozens of blacksmiths and other artisans crafting one-of-akind pioneer-era items while kids can decorate pumpkins, bob for apples, pet farm animals, and take horse-and-wagon rides.

"We are very excited to open our doors to the public and show off our new exhibit, enhancing the experience guests have when they visit," said Kristen Veto, manager of the John Deere Pavilion. "Coming to the John Deere Historic Site is like taking a step back in time. From watching a blacksmith demonstration to seeing how John Deere and his family lived, there is so much to explore and learn about

an important part of history."

John Deere Historic Site Exhibits

Blacksmith Shop: A highlight of any visit to the site includes seeing a recreation of John Deere's original blacksmith shop. Entering the exhibit is like walking into a time warp to early pioneer days as guests see the shop as it would have looked over a century ago. Throughout the day, resident blacksmiths demonstrate what it takes to be a skilled ironworker. Archeological Site: In 1963, an archeology team uncovered the exact location where John Deere forged his first self-scouring steel plow. While visitors look over the preserved site and see firsthand the excavated artifacts, a video tells the story of how John Deere built a thriving manufacturing business. New features uncover Deere's story according to neighbors at the time and provide a hands-on element.

Gift Shop: This one-of-a-kind

gift shop sells hand-forged items made in the blacksmith shop. A selection of John Deere licensed items and other Historic Site merchandise is available.

When visiting the John Deere Historic Site, guests can register for the free John Deere Passport Program to commemorate their experience. By collecting seals and stamps in a passport booklet, participants earn gifts and discounts along the way.

Nachusa Grasslands, in cooperation with the Byron Forest Preserve District, is offering a free introduction to the Nachusa preserve and volunteer stewardship of prairies and oak savannas on Saturday, March 28 from 9:30 a.m. to 12:30 p.m. at the Nachusa Grasslands headquarters in Franklin Grove.

If you've ever considered helping but weren't sure how to get involved, this is for you. Discover ways you can give back to the earth, find new friends, and get some exercise.

This program has you exploring hands-on land restoration and stewardship: seed harvesting, weed management, and brush control. You'll also be given a brief history of the preserve, a substantial snack (fruits, nuts, and often home-made treats), and go on a short walk to explore the prairies, oak savannas, or wetlands.

Expect to walk and work offtrail on uneven ground and put in physical work which may include bending over, lifting, carrying, and using hand tools.

Nachusa Grasslands will provide all tools and gear such as safety glasses and gloves as needed. You are expected to wear appropriate clothing (long pants, socks, sturdy shoes or boots). It's also recommended you wear long sleeves, have leather work gloves, and bring sunscreen, coat, hat, and sunglasses, as weather dictates).

This program is suitable for ages 12 – adult. Children under 18 must be accompanied by an adult responsible for them.


Programs will proceed in slightly inclement weather. If severe weather occurs such that cancellation is required, then Nachusa Grasslands will contact you with at least an



### Residents reminded to change smoke alarm batteries when changing clocks

**SPRINGFIELD** – The Office of the State Fire Marshal (OSFM) reminds Illinoisans to test and replace the batteries in their smoke alarms as daylight saving time begins this weekend and they turn their clocks forward one hour.

'The time change serves as a bi-annual reminder to test all smoke and CO alarms in your home," says State Fire Marshal Matt Perez. "If you find an alarm that is not working or is expired, replace the alarm immediately. Review your fire-escape plan with your family and hold a drill to practice your plan."

The National Fire Protection Association (NFPA) reports between 2012-2016, almost three out of every five home fire deaths in the U.S. resulted from fires in homes with no smoke alarms or nonworking smoke alarms. The chances of dying in a home fire was reduced by 54% in homes were working smoke alarms are present. In fires in which the smoke alarms were present but did not operate, more than two of every five of the smoke alarms had missing or disconnected batteries. Dead batteries accounted for 25% of smoke alarm failures. In 2019 in Illinois, 89% of pre-existing smoke alarms being replaced in homes that received the new 10-year sealed battery

alarms through the "Be Alarmed!" program was found to be non-functional or were expired.

A 2017 Illinois law requires ten-year sealed smoke alarms be installed in all homes built before 1988 or that do not have hardwired smoke detectors by Jan. 1, 2023.

"Participating fire departments in 2019 installed 4,948 10-year sealed smoke alarms in Illinois homes. There are now over 1,600 homes in Illinois protected and 3,700 residents educated on smoke alarm maintenance, home fire safety and home fire escape plans," says state Fire Marshal Perez.
