# **Everyone counts**

### Census count to begin next week with self-response invitations

**BY ANDREW HEISERMAN** STAFF WRITER

**ROCHELLE** – The upcoming United States 2020 Census will begin counting next week.

Counting will begin with self-response invitations being sent to households throughout the community. Residents can expect the invitations to arrive between March 13-20 and no later than April 1. They will include instructions on how to

respond using three different methods.

"It will include a personal identifier linked to their address, a website to respond online, a phone number to respond over the phone and instruction on how to request a paper census," said Sue Messer, assistant to the city manager/ city clerk.

The invitations will be printed double sided, English on one side and Spanish on the other. The city is also offering dif-

# VanVickle, other sheriffs file suit

**OGLE COUNTY** — A group of four elected Illinois sheriffs Monday, including Ogle County Sheriff Brian VanVickle, filed a joint lawsuit in U.S. District Court for Northern Illinois seeking a preliminary and eventually a permanent injunction against the Illinois Trust Act, a 2017 state statute that restricts the ability of law enforcement officers to coordinate with federal officials regarding the custody of illegal aliens.

The suit also seeks a declaratory judgment that the Trust Act is in fact preempted by both the U.S. Constitution and Congressional statutes and is therefore invalid and unenforceable. The suit was filed on behalf of Ogle County

### Seeks injunction of Illinois Trust Act Sheriff Brian E. VanVickle, McHenry County Sheriff Bill Prim, Stephenson County Sheriff

David Snyders and Kankakee County Sheriff Mike Downey. It names Illinois Attorney General Kwame Raoul as defendant.

The sheriffs jointly contend that the Trust Act has exposed them and their offices to litigation over the years as three of the four have been sued for alleged violations of the Act.

The suit notes that the federal government alone has broad and undoubted authority "to regulate matters pertaining to immigration and the status of aliens" and that this authority has been exercised continuously since the nation's founding and reaffirmed as recently as 2012 in the U.S. Supreme Court decision Arizona v. United States, 567 U.S. 387.394.

"Based on its enumerated powers and its constitutional power as a sovereign to control and conduct relations with foreign nations, the federal government alone has the authority to establish immigration laws, the execution of which the States cannot obstruct," the suit notes.

It continues: "The Trust Act has both the purpose and effect of obstructing federal immigration enforcement in Illinois."

ROCHELLE – Jason Harper, Rochelle Elementary District 231 superintendent, updated board members Tuesday night about an arts grant the district has received.

During its monthly board meeting Tuesday Harper talked about the Illinois Arts Council Agency \$31,500 grant and what the district will

use the funds for, saying the money will be put to use toward the district's dual-language program development and classroom materials.

Harper also discussed how the district has been handling the recent nationwide coronavirus outbreak.

BBB is reminding homeowners affected by natural disasters to beware of "storm chasers" and out-of-town contractors soliciting business. Resist high-pressure sales tactics. Some storm chasers use tactics such

as the "good deal" you'll get only if you hire the contractor on the spot. Be pro-active in selecting a contractor and not re-active to sales calls on the phone or door-to-door pitches. Disaster victims should never feel forced to make a hasty decision or to choose an unknown contractor.

ly careful of door-to-door contractors. Many municipalities require a solicitation permit if salespeople go doorto-door. Ask for identification. Check their vehicle for a business name, phone number, and license plates for your state or province.

ance checks to contractors. Get an invoice from the contractor and pay them directly (preferably with a credit card, which offers additional fraud protection over other forms of payment). Don't sign any documents that give the contractor any rights to your insurance claims. If you have questions, contact your insurance company or agent.

Be wary regarding places you can't see. While most contractors abide by the law, be careful allowing someone you do not know to inspect your roof and other areas of your house. An unethical contractor may actually create damage to get work. The same goes for attics, crawl spaces, ducts, and other places you cannot easily access or see for yourself.

BBB is also warning contractors to beware of storm chasers who offer to pay local construction companies substantial amounts of money to use the business's established name, reputation, and phone. They masquerade as a local business, collect the insurance money and then move on, leaving the real business to deal with unsatisfied customers due to bad workmanship, unfinished work, or unfulfilled warranties.

"We are going to have some park events where we will be set up to help people, as well as feed them a hot dog and some chips," said Messer. "Then we are having an ice cream social on April 1. from 3 to 6 p.m., at City Hall. We will have Culver's ice cream and El Rey radio station out of Mendota will be here too."

Residents who don't respond right away will get multiple reminders to do so. If they have not responded by May, United States Census takers will begin going door to door. All Census takers have received background checks and will have an official I.D. badge.

The city would like people to know that their information is protected

by federal law from being given to any other government agency or police station. But, the city cannot stress the importance of an accurate count, to ensure Rochelle does not miss out of valuable funding, both federally and from the state.

"Every single person not counted is a loss of about \$1,800 per year, for 10 years to our region," said Messer.

The majority of the conflict between the Trust Act and federal law revolves around the use of "detainers," which require local law enforcement officers to maintain custody of an undocumented alien for up to 48 hours to give federal officials time to discover his or her immigration status. Based on their findings, the individual may then be released or turned over to the custody of Immigration and Customs Enforcement (ICE).

However, the Trust Act bars any law enforcement agency or official from detaining "any individual solely on the basis

of any immigration detainer .... "According to the suit, the net result is the "Trust Act is in direct conflict with federal laws requiring cooperation and communication between federal and state law enforcement officials." All despite the fact that as the Arizona case decision declares: "Consultation between federal and state officials is an important feature of the immigration system."

Concluding, the lawsuit asserts that the sheriffs face "irreparable harm in the face of ongoing litigation and threats of enforcement of the Trust Act" and that "enforcement of an unconstitutional law creates per se irreparable harm."



# Filling the No. 2 position

S former Vice President Joe Biden surges to the lead for the Democratic presidential nomination, he'll soon need

to pick a running mate who will attract votes he might otherwise not receive. Just

**Scott Reeder** who those voters

are remains a matter of debate.

Both Biden and U.S. Sen. Bernie Sanders have said they are considering women for the No. 2 spot.

At least one women's organization, Supermajority, is circulating a petition asking both Sanders and Biden to "affirm their commitment to gender equity" by choosing a woman as their running mate.

So, it would appear a female candidate would be considered a plus for the ticket. But what type of background should she come from?

Maze Jackson, a top Chicago political consultant in the African American community, offered me a perspective that startled me. He contends the group Biden needs to win over are white male voters without a college education.

Back in the day, these are the folks who were called "Reagan Democrats."

Jackson contends that Biden already has the loyalty of African American voters and picking a black running mate won't provide his candidacy with the boost it needs to defeat Donald Trump.

Hillary Clinton said she would "love" to see a woman on the ticket

emblematic of the areas Donald Trump successfully wooed into his column in 2016.

"She probably wouldn't make a difference in Illinois; Biden will win here no matter what, but in neighboring states, like Iowa and Wisconsin that Trump carried, she could make a big difference," said Kent Redfield, a retired political science professor at the University of Illinois at Springfield.

Bustos has represented Illinois' 17th Congressional District since 2013 and has won re-election handily – even in 2016 -- when Trump won the district.

She leads the Democratic Congressional Campaign Committee, the official campaign arm of the Democrats in the House of Representatives. She also is a member of the Blue Dog Caucus, a group of conservative and moderate Democrats in the House.

"It would make a lot of sense for Biden to pick her," Redfield said. "The more liberal members of the party are going to vote for him anyway. They certainly aren't going to vote for Trump. But a moderate like Cheri Bustos may be able to bring over some people who otherwise wouldn't vote for Biden."

Longtime Illinois political observer Mike Lawrence said he views Bustos as a longshot for the VP nod.

"I'm a great admirer of Cheri. I'm not saying national office isn't someday in her future. But it is more likely to be someone like (U.S. Sen.) Kamala Harris," he said.

Bustos, a Springfield native, interned for Lawrence in 1985, when he was a statehouse bureau





# STATE NEWS Health officials announce first Coronavirus disease cases outside Chicago and Cook County

### As of Tuesday afternoon, Illinois is currently reporting 19 cases

CHICAGO-The Illinois Department of Public Health, Kane County Health Department, and the McHenry County Department of Health Tuesday announced the first Illinois residents outside of Chicago and Cook County to test positive at the IDPH laboratory for coronavirus disease (COVID-19).

The cases include a Kane County woman in her 60s and a McHenry County teen, neither of whom had a history of travel to an affected area and no connection to a known case of COVID-19. Public health officials are identifying and contacting all close contacts.

"As we anticipated, the number of cases in Illinois is increasing and now includes the first cases outside of Chicago and Cook County," said IDPH Director Dr. Ngozi Ezike. "The State of Illinois continues to take action to reduce spread of COVID-19 in Illinois and we again want to encourage people to start thinking and preparing now in the event they are not able to go to work, if schools are closed, if public transportation is not available, and how else their lives will be disrupted by this outbreak."

Currently, there are 19 individuals in Illinois who

have tested positive for COVID-19. At least one case acquired the virus in the community, but probably more. As IDPH continues to conduct surveillance testing, additional cases will be identified, and we will have a better understanding about the amount of virus circulating in Illinois communities.

In addition to the cases in Kane and McHenry counties, new cases include individuals in:

Public health officials are still investigating the travel history of these individuals and any potential contact with a known COVID-19 case. These most recent cases are in isolation and are doing well.

Steps to help minimize the risk of spread:

Everyone: Use the same daily health precautions you would for flu including washing your hands frequently using soap and water or using an alcohol-based hand sanitizer with at least 60 percent alcohol, covering your cough and sneeze, and staying home when sick.

Health care: Screen patients and visitors for symptoms of respiratory illness such as fever, cough, and difficulty breathing; wear proper personal protective gear such as gowns and masks when needed, and have employees stay home when sick.

Day cares, schools, universities: Review emergency plans, absenteeism policies, and cleaning procedures: identify strategies for alternative learning mechanisms such as on-line programs; and consider postponing or cancelling student exchange programs.

Businesses: Review emergency and continuity of operation plans, revisit sick leave policies, and assess schedule flexibility.

Community and faith organizations: Review emergency plans and communicate with community members if events and services are changed, postponed, or cancelled.

### **Prevent spread** of COVID-19

Illinois lawmakers received an update March 5 on the status of the coronavirus (COVID-19) from state Public Health officials who are encouraging the public to help prevent the spread of the virus.

The Illinois Department of Public Health briefed lawmakers on COVID-19 on March 5, providing an update about what the department is doing to monitor the situation in Illinois.

So far, five patients in Illinois have tested positive for COVID-19. The Illinois Department of Public Health, the Centers

for Disease Control and Prevention (CDC), and the Cook County Health Department are proactively reaching out to anyone who may have had contact with these individuals to test for the virus.

Symptoms of COVID-19 include mild to severe respiratory illness with fever, cough, and difficulty breathing. Currently, the virus has not been found to be spreading widely in the U.S. and the risk to the general public remains low. Residents are encouraged not to alter their daily routines.

However, public health officials are encouraging the public to remain vigilant about keeping germs from spreading. The CDC has some useful tips to help prevent the spread of respiratory diseases like COVID-19:

Avoid close contact with people who are sick.

Cover your cough or sneeze with a tissue, then throw the tissue in the trash.

Avoid touching your eyes, nose, and mouth.

Clean and disinfect frequently touched objects and surfaces.

Stay home when you are sick except to get medical care.

Wash your hands often with soap and water for at least 20 seconds.


Brady Shank's freshman bowling season with Rock Valley College couldn't have wrapped up any better than it did over the weekend, when Shank and his Golden Eagle teammates finished first at the NJCAA National Championship in Cheektowaga, New York.

It didn't take long for Rock Valley College to reach the pinnacle of the junior college men's bowling scene, bringing home a national title in only the program's second year of existence. 



# Nadig wins IWCOA Fresh-Soph Sectional title

### 132-pound sophomore advances to compete in state meet

STERLING — Winning an IWCOA Fresh-Soph Sectional on Sunday meant RTHS sophomore Caleb Nadig needed to beat an opponent who won over him during the IHSA season.

After defeating Jerrill Hill from Rock Falls in his first 132-pound bout, Nadig advanced to face Sterling's Drew Kested in the semifinal round. 

### Hubs overcome rough start, finish season strong

24-win sophomore group providing optimism for future

**ROCHELLE** — The Rochelle boys basketball team that closed the season in the IHSA 3A Sterling Regional this past weekend was a far different and much improved group than the one that struggled throughout the November and December months.

The Hubs stumbled out of the gate, dropping three games and finishing sixth at the Strombom Thanksgiving Tournament before compiling a 4-9 record over their first 13 games. Rochelle flipped the script as the calendar turned to 2020, however, posting two separate seven-game winning streaks and finishing 16-3 over the team's last 19 games.

"The one thing that stands out is how much these boys have grown as players," head coach Tim Thompson said. "I thought we had struggles with continuity and with being good teammates at the start of the season. We struggled to share the ball, but we started to click right around Christmas time. We started treating each other better, we shared the ball much better, and we knew those were the reasons we started seeing the results that we did."

Rochelle finished fourth in its first season with the Interstate 8 Conference, compiling a 20-12 overall record and a 9-5 record in conference play. The Hubs topped the 80-point mark five times, with their most notable victories coming near the end of the season, where they made 16 triples in an 88-46 win over Ottawa and beat Sterling for the first time since 2015.

The Hubs will graduate four seniors from the varsity team including Landan Martin, who led Rochelle in points per game (16.7), rebounds per game (6.6) and steals per game (2.4). Guards Austin Brown, Seth Gould and Ben Hickey are also departing, paving the way for Rochelle's junior class which includes two-year starter Garrett Burdin, who averaged 15.3 points per game and shot a team-high 36.1 percent from 3-point range.

"I thought Garrett grew so much this season," Thompson said. "His whole game has evolved. I thought he had a tremendous second half defensively. He's going to have to make huge strides next year because he's going to be the opposing team's No. 1 option to stop. He'll need to learn to get his shot off a bit quicker, use his screens and use more shot fakes to create space."

Rochelle will also have reinforcements coming in next season from the sophomore team, which finished 24-5 and won the Interstate 8 Conference title this winter. Sophomore starters Ryan Simmons, Tanner Lager, Zach Sanford, Adam Kemp

and Noah Brown will all see increased roles on the varsity team next season. Thompson also said that

juniors Spencer Warborg, Mike Schlenbecker and Nate Lovett are three players who could step up next

season.

"Our sophomores had a wonderful season," Thompson said. "They

have a lot of size and length and those are some traits that make up a good varsity team."


