

Walking miles In the works for warriors

South Dakota man making trek for Wounded Warriors

ROCHELLE – One man from South Dakota is walking across the country to raise awareness for U.S. veterans.

Jerry Meadows is a proud, 65-year-old Vietnam Air Force veteran, who is walking from Bemidji, Minnesota, to Jacksonville, Florida, to raise funds for the Wounded Warriors Project. Meadows chose the WWP, because it is the only organization he could find that takes care of not only veterans, but their spouses and caretakers as well.

Meadows walks up to 11 miles a day pulling his oxygen tank with him everywhere he goes, no matter the terrain. Even though he struggles with his own health issues and long days of walking can make his body ache, he pushes through to honor his fellow veterans.

"There are veterans out there who have given their life and limb for people that they don't even know," said Meadows. "This is the way that I get to pay it back to my brothers and sisters." Meadows made a promise to veterans, that by the end of his journey he would have walked a total of 1,245 miles and raised a minimum of \$30,000 for the WWP. If he does not reach either of his goals

Purchase agreement for Hickory Grove property approved

ROCHELLE — On Monday night City council members approved the purchase agreement for the Hickory Grove property.

The agreement with the Ogle County Civic Center Authority contained several provisions, including:

Purchase price for the Hickory Grove facility is \$1;

OCCCA's liabilities (which the city will assume) include City of Rochelle - \$6,600, Anderson Plumbing -\$3,234.85 and Fearer, Nye & Chadwick - \$2,500;

A due diligence period of 30 days from the execution of the agreement;

The purchaser, at the city's expense, will obtain a boundary survey prepared according to ALTA/ACSM standards within seven business days of the execution of the agreement (already underway);

Purchaser shall, at our

Although it is not included in the purchase agreement, all funds generated by the facility while in the ownership of the city, either through lease rent or auctioning of equipment will be used to either pay for the demolition of the facility or pay off the outstanding city utility bills.

Council members voted 7-0 to approve the purchase agreement.

Other items

Council members also approved a fiber license agreement with Digital Network Access Communications lease one point to point dark fiber connection from the Frontier building to the **DNA** Communications building.

According to utilities superintendent Adam Lanning, this agreement will generate \$375 per month for the city.

Council member Don Burke abstained from the vote due to his employment with DNA.

An agreement was also reached to provide Surf Air Wireless, LLC with a half-rack collocation space within the RMU Datacenter. This agreement will generate \$814 per month for the city. A change order for work on Well 8 was also approved.

Schabacker named ambassador

ROCHELLE – A Chana resident has been chosen to be an ambassador for Nothing Down, an international Down Syndrome awareness organization.

One-year-old Lane Schabacker was chosen from over 500 applications from 42 states and 11 different countries, to be one of 29 ambassadors for the organization. The mission of the organization is to provide support, advocacy, education and opportunities for individuals and families that have been touched by down syndrome.

Lane's parents found out about his diagnosis when his mother was about 12 weeks pregnant. Once the family got over the initial shock, one thing that helped them get through difficult times was seeing success stories from other families of children with Down Syndrome.

"It really helps to see other families that have a child with Down Syndrome thriving," said Lane's mother, Margie Schabacker. "If we can be that family for somebody else, that is golden."

Being an ambassador means that Lane and his family will represent the organization through community outreach, fundraising and social media promotion for the duration of 2020. This can include documentaries, viral photo and video projects, annual calendars and social media campaigns.

Each of the projects and campaigns put on by Nothing Down highlight the promise and beauty of individuals with Down Syndrome. One thing that Margie and her family would like people to know about individuals with Down Syndrome, is that there are many more similarities than differences.

"They are more alike than different, they are just like you and I," said Margie. "They may reach their milestones a little slower, but they will get there."

MALTA — The Kishwaukee College Floral Design department hosted a guest designer as part of the Artist In Residence (AIR) program offered through the American Institute of Floral Designers (AIFD) on Wednesday, Feb. 19 at the college.

Students in Janet Gallagher's Floral Design class welcomed Pete Samek, AIFD certified floral designer, for a morning lecture followed by an afternoon of design.

Pete Samek is a freelance designer, a 30-year veteran in the floral industry and is currently serving as an elected representative on the AIFD National Board. He was assistant director at the American Floral Art School for 14 years and taught floral design in Chicago, Taipei, Taiwan and San Juan, Puerto Rico. A former board member of AIFD's North Central Chapter, Samek has been an active member with the organization since 1991. Samek along with designer J. Keith White decorated the VIP entries at the 2017 Rose Parade.

Currently, Samek works in quality assurance in the floral department at FTD LLC and helped organize the 2019 Interflora World Cup competition at the Philadelphia Flower Show.

Samek works as a freelance designer and resides in Naperville.

While at the college, Samek lectured on formalinear design style, a European style that arranges plant materials in groups to emphasize clean lines and bold forms. Students learned about intentional and strong use of negative space to accentuate individual flowers, stem angles, color and textures,

radial stem placement and asymmetrical balance. Samek also covered foliage techniques such as weaving and other leaf manipulations. Following the lecture, students created individual centerpieces in formalinear style.

The AIR program is offered through the AIFD to bring together industry professionals and floral design students at

colleges and universities that have Student AIFD chapters. Kishwaukee College is one of only 14 colleges in the nation with a SAIFD chapter.

LOCAL NEWS **Alliance Francaise is like visiting** Paris without leaving the state

CHICAGO—French 4 students from Rochelle Township High School went to the Alliance Française in Chicago last week and absolutely loved their experience.

Lizzie Cartwright's students took a cooking class which was conducted completely in French. They prepared a traditional French meal of salade verte, tarte flambée and une tarte aux pommes (apple tart). For dessert: dommage, which disappeared too quickly to photograph.

Founded in 1897, with the mandate to promote French culture in Chicago, the Alliance Française is among the oldest of cultural institutions in the city.

Throughout its history, the Alliance Française de Chicago has played host to a diverse group of guests; welcoming presidents, ambassadors, royalty, authors, film directors, fashion designers, academics and visual and performing artists to its premises.

Alliance Française de Chicago is a concerned global citizen, having made important contributions to the war relief effort of World War I, World War II and to the reconstruction efforts afterwards. The Alliance held fundraisers for the war-time needs

of the American Red Cross. Members rolled surgical dressings and knit sweaters bound for Europe in Alliance facilities.

Members of the Alliance were awarded the Légion d'Honneur for their efforts in supplying grain and supplies for devastated France after World War I. The Alliance also provided complimentary French language instruction for service men and women who were deployed to Europe at that time.

Today, the Alliance Française de Chicago hosts an array of events annually like Festival de Francophonie which begins Friday with country partners from Bénin, Belgium, Burkina Faso, Cameroon, Canada, China, France, Haiti, Louisiana, Québec, Romania, Switzerland and Togo. Meet the chefs and sample the homemade cuisine tout-monde, from cochonnaille to raclette; chill out at our outdoor sugar shack, rain or snow, then shake it up on the dance floor with world rhythm music from coupé-décalé to belly dancing or French EDM.

Alliance Francaise continues its long tradition of bringing notable lecturers to Chicago. On any given day, hundreds of members and students cross the threshold.

The 15-year-old device also is only a 4-Lead monitor and therefore is unable to conduct and transmit 12-Lead assessments to Rochelle Community Hospital **Emergency Department and other** provider hospitals as dictated by the Illinois Department of Public Health Region 1 Standard Medical Orders.

Purchase of the new monitor will complete the cardiac monitor upgrade program for the fire department with each of the three ambulances outfitted with a Zoll 12-Lead Cardiac Monitor.

"Zoll is willing to extend us terms that will allow us to make a moderate payment in this budget year, with the remaining portion of the purchase price in the 2021 budget year. They are also willing to take our non-functional cardiac monitor as a trade-in," Sawlsville said.

This purchase was anticipated and budgeted, with \$5,000 in the FY2020 budget for the FY2020 portion of the device. The \$26,860.66 balance will be paid in FY2021.

New policy allows convicted felons evade federal authorities

Officials warn that radical policy shift endangers local communities



Corrections (IDOC) allows dangerous felons to be released back into Illinois communities. This is occurring



despite valid requests by federal immigration authorities to transfer the convicted felons to a designated holding facility while the individual's immigration case is reviewed and adjudicated.

In 2019, 223 individuals were transferred to the Jerome Combs Detention Center in Kankakee after serving time at an IDOC facility for their felony convictions. This occurred via a notification from IDOC at the re- quest of U.S. Immigration and Customs Enforcement (ICE). Starting in January 2020, IDOC stopped notifying federal authorities and instead allowed these individuals to be released immediately from the correctional facility into Illinois communities where they had been serving their sentence. "The public needs to know that this policy shift results in convicted felons being released back into our coun- ties and neighborhoods without notice-despite federal authorities asking that they be transferred to another facility in the judicial system," said Sheriff Mike Downey of Kankakee County. More troubling to the sheriffs and law enforcement is that there is no notice or warning given to local or federal authorities when the individuals are released. "The State of Illinois is helping convicted felons get a head start on evading federal authorities who simply want to do their job," said Christian County Sheriff Bruce Kettelkamp. "The lack of coordination is raising the stakes that a dangerous or violent altercation will occur in our communities between a recently-released felon, who knows that immigration authorities are looking for them, and any law enforcement officer. This policy undermines the rule of law, endangers our local communities and puts the lives of our first responders at risk." A review of the transfers completed in 2019 by the Kankakee County Sheriff Office found that the individuals requested by ICE and transferred to the correctional facility had been convicted of committing the following crimes in Illinois: 36 individuals were found guilty of sexual offenses against minors, including crimes against individuals as young as 5 years old; 11 individuals were found guilty of murder, attempted murder or intent to kill or injure; 19 individuals were found guilty of predatory criminal sexual assault; 33 individuals were found guilty of a criminal offense involving a weapon; 50 individuals were found guilty of drug offenses involving a substance other than cannabis; and 55 individuals were found guilty of felony-level traffic offenses including aggravated DUI, having a fourth DUI or a DUI resulting in death. The Illinois Sheriffs' Association urges Gov. Pritzker to reconsider the policy and enable IDOC to coordinate with its partner in law enforcement and criminal justice.

Leaving the Land of Lincoln

fellow sat down next to me Saturday on a flight from San Antonio to Chicago and let out a sigh.

I asked if he was heading home and he just shook his head and explained he is in the process

of moving from Chicago to Texas. The 50-something fellow said he was returning to Illinois to get his convertible and to drive it south.

I asked him why he was moving and he told me: "the taxes and the politics."

It sounds familiar.

In the two decades that I've been writing this column, I've received hundreds of letters and emails from folks leaving the Land of Lincoln. The reasons they cite revolve around employment opportunities, tax burden and the state's political future.

According to Internal Revenue Service data, Illinois has experienced a net loss of 160,000 people since 2010. That's more than the population of Springfield, Peoria, Rockford or the Illinois Quad-Cities.

Illinois and West Virginia were the only states that lost population during that time.

While middle class people make up the bulk of those leaving self? Few of us have. An inevitable consequence of losing these high earners is that they will invest elsewhere. Which means fewer jobs for Illinois. And that, of course, means more people

leaving the state. A second consequence is the tax base shrinks. This means with fewer people paying taxes, those who remain have to pay more to support the government that we have. Of course, higher taxes mean more people leaving Illinois.

It's a vicious cycle that shows little reason to abate.

In 2016, the Paul Simon Institute at Southern Illinois University conducted a statewide poll and found that 47 percent of respondents would like to leave Illinois and 51 percent would prefer to remain in the state. Just under 2 percent said they didn't know.

Taxes are the single biggest reason people want to leave, the weather is next, followed by government and jobs. Specifically, 27 percent cite taxes as the motive for departing, 16 percent say weather, 15 percent cite government and 13 percent name jobs and education.

Illinois has the second highest property tax in the nation, just behind New Jersey.

For years, politicians have denied that Illinois has a problem with population loss. Now, most acknowledge the depth of the problem. But few propose solutions. It's one of those problems that they would rather ignore than address. That's unfortunate. We deserve better. 

First month's legal marijuana sales generate \$7.3 million in tax revenue

An additional \$3.1 million comes from retail sales taxes on adult-use cannabis

SPRINGFIELD – The Illinois Department of Revenue reported Monday that the first month of legalized adult-use cannabis sales in the state generated \$7.3 million in cannabis tax revenue for the state, plus another \$3.1 million in retail sales taxes that are shared between the state and local governments.

"Today marks another milestone in the successful launch of Illinois' legal cannabis industry," Toi Hutchinson, a senior advisor on cannabis policy to Gov. JB Pritzker, said in a statement.

Last year, at Pritzker's urging, lawmakers passed a bill legalizing the production and sale of adult-use recreational marijuana. The law took effect Jan. 1.

Under that law, marijuana cultivators pay a 7-percent privilege tax on their sales to dispensaries. Retail sales, in turn, are subject to retail sales taxes as well as a special cannabis tax that ranges from 10 to 25 percent, depending on the type of product being sold and its THC content.

Those taxes are in addition to the retail sales taxes levied by the state and the local governments where the sales occur, but they do not apply to products that are taxed under the state's medical marijuana program. Pritzker's budget office had estimated that marijuana sales would generate \$28 million in the final half of the current fiscal year, which ends June 30. The Department of Revenue said Monday's report showed the state is on pace to surpass that estimate.

The state's share of the revenue is divided among several funds:

35 percent goes to the state general fund.

25 percent goes into a special fund for community development projects in areas with high arrest and poverty rates that were disproportionately affected by the "war on drugs."

20 percent goes to the Department of Human Services for substance abuse and prevention programs and mental health.

10 percent is put into the Budget Stabilization Fund to pay down the state's backlog of unpaid bills.

8 percent goes to local governments to support crime prevention, training and interdiction efforts.

And 2 percent is used to fund public education campaigns and to support data collection and analysis of the public health impacts of legalizing recreational marijuana.

"Our goal has been to build the nation's most socially equitable program that includes new opportunities for the communities most harmed by the failed war on drugs," Hutchinson said in her statement.

Pritzker says another tax increase and more spending

me repeat that. Pritzker's message

is that his tax increase must be approved in order to fund \$1.4 billion for priorities like schools, health care and public safety. He is basically holding these programs hostage. For example, Illinois' revamped school funding formula from 2017 requires the state to statutorily increase school funding by \$350 million each year. Under Pritzker's proposal, only \$200 million is guaranteed, leaving \$150 million of school funding in jeopardy.

The Governor actually has all kinds of ideas that dramatically increase overall spending and require his tax increase to implement. Many of the new programs have merit, but he ignores a simple fact. We can't afford them.

His plan also doesn't outline any of the cuts he asked his agencies to provide.

So instead of adjusting his spending to meet the state's expected revenues, he is making up a lavish wish list and then telling us he needs his new income tax increase to pay for it. This is not the way most people plan their household budgets. New taxes plus more spending

Pritzker's speech is the first step in negotiating a spending plan for the next fiscal year. Now, we need to get into the details and begin to ask the tough questions. And we want a seat at the table. We are tired of being browbeaten by Democrat leaders who are only looking out for the best interests of some of their residents, no matter what the cost to the rest of the state.

As the legislative budget process gets under way, I stand ready to work with my fellow lawmakers to make the tough decisions necessary to finally pass an actual balanced budget with structural reforms that will boost the economy and create more jobs.

Most of what we heard from the Governor on Wednesday was not unexpected. He put the best face possible on Illinois' fiscal situation; unfortunately, his glowing assessment does not square with the facts, and his spending plan relies on a huge income tax increase to implement.

He also painted a rosy picture in his first "State of the State" address Jan. 29. But are the citizens of Illinois buying it? We have been promised action and results for years, only to get more of the same old tax-and-spend policies. More recently, we were promised bipartisan discussions, but mostly we've received more empty promises and delay.

It can't be "my way or the highway." Compromise is needed. Lawmakers on both sides of the aisle and in both the Senate and the House of Representatives must work together to create opportunities for working families. We need less partisan rhetoric and more action. We can do it, and we better get busy.

"Revenue raised in this first month will soon begin flowing back into those communities to begin repairing the damage done by the failed policies of the past and creating new opportunities for those who have been left behind for far too long."

CHAMPAIGN—Rochelle senior Gavin Ansteth took some time to soak in his surroundings before entering the wrestling ring for his opening bout during the IHSA State Championships at the State Farm Center this past weekend.

INDIANAPOLIS — The Rochelle Middle School wrestling program sent five competitors to the 2020 Indy Nationals on Sunday, with four kids earning top-5 performances in the tournament.

Coach Brian Koonce began the weekend by bringing all fivekids (Eli Koonce, Erich Metzger, Quentin Berry, Kaiden Morris and Brock Metzger) to the Toss Em Up Wrestling Academy in Champaign on Friday and Saturday. The boys trained for two days, even sleeping on the mats overnight Friday, before taking in the IHSA State Championships at the State Farm Center.

The boys then competed in the 2020 Indy Nationals on Sunday, with Koonce (3-0) and Morris (3-0) taking first place in their respective brackets. Berry (3-1) finished second in his bracket, while Erich Metzger (3-2) placed fifth in his bracket. Eighth-grader Brock Metzger (0-2) battled in the High School Cadet/Jr 120-pound bracket, falling short in two tough bouts.

Adversity motivating Hub senior Gould

THERE were moments before Seth Gould's senior season where the Rochelle guard questioned whether or not he should continue playing basketball for the Hubs.

Gould's junior season ended abruptly when he suffered a serious knee injury during a home game against LaSalle-Peru. His frustrations grew after he chipped a bone in his foot over the summer, but a heartto-heart with head coach Tim Thompson helped restore his confidence.

"I lost all of my motivation for the game and I didn't want to go back because I was scared that I was going to reinjure myself," Gould said. "Coach Thompson told me that I can't be scared of getting hurt, and that I have to go out there and play my best. That's what I tell myself every time I step on the court. Coach Thompson, Mr. [Mark] Lovell and my dad have all been there for me, and they've really helped me get through my struggles." Injuries have unfortunately carried into Gould's senior season, but the versatile guard has given Rochelle's backcourt a significant boost since recovering from a broken thumb he sustained during the first game of the season against Belvidere. He helped lead a second-half road rally over Ottawa this past month, scoring 14 points off the bench, and his all-around skills are helping the Hubs close the regular season playing arguably their best basketball of the year. "I definitely try and bring an inside game to our team," Gould said. "We have a lot of good shooters and I want to be the guy who can drive the ball inside and pass the ball out to our shooters. My coaches expect me to guard one of the best players on the other team, and they definitely need me to rebound the ball."

Rochelle (17-11) has won 12 of its last 14 games, and the Hubs haven't dropped a nonconference contest since Dec. 28, 2019. Gould, who's one of only two players on the team in his third varsity season, said the team's improved chemistry and ball movement have been most significant in helping overcome a disappointing 2-7 start to the 2019-20 campaign.

"We've been playing unselfish basketball," Gould said. "We had a lot more isolation toward the beginning of the season, but we've had better ball movement and we're playing as a team. I think this season has gone better than we anticipated it would. We knew we were going to have a limited number of seniors and we weren't going to have many big men... I went through a rough stretch, but I think I'm getting my legs back and I think I've played pretty well.' The Hubs will once again have a tough mountain to climb if they hope to win their first IHSA Regional Championship since 2009. Gould has seen and experienced Rochelle's regional struggles first-hand, watching from the sidelines as the Hubs fell just short against top seed Rock Falls last season. Gould was a sophomore when Dixon eliminated Rochelle on a buzzerbeating layup, and as a freshman, Gould witnessed his older brother Caleb lead the Hubs to a 20-win season, only to drop a heartbreaker at home against Belvidere in the finals. "We're angry and we've been working hard every day," Gould said. "We come into practice every day knowing that we haven't won a regional in a long time."

"Coach [Alphonso] Vruno told me to take some time, look around and get used to the atmosphere. I thought that helped me when I was wrestling."

Ansteth (28-14) moved into the wrestlebacks Friday afternoon, where he met with Tinley Park's Ezekiel Childs and battled for all six minutes before dropping a close 4-0 decision. While he was unable to walk away with a victory, Ansteth said the experience of enjoying the state meet with his family and friends will remain long after his final season.

"I was really happy with my first match," Ansteth said. "It would've been better to come away with a win, but I was just happy to be down there. I'm going to miss being with my teammates and traveling with the team over long weekends. I'm going to miss the practices and the laughs we all shared... I enjoyed spending time with everybody over the weekend, and I enjoyed laughing and making jokes with everybody.'

Ansteth was one of two Rochelle wrestlers representing the Hubs in the state meet. Junior Ben Harvey (40-6) started strong in the 182-pound bracket, winning by fall over Triad's Kaden Marmon before getting an unfortunate quarterfinal draw against Grayslake Central's Adrien Cramer, the eventual state cham-

pion and No. 1 ranked Class 2A wrestler by the IWCOA. Cramer won the bout 7-0, but Harvey was the only wrestler Cramer didn't pin before winning the title.


"It was a fun weekend," Harvey said. "I thought my first two matches were up to my abilities. I thought I should have scored at least one point in my second match, but Cramer was really quick and he pinned everybody else he faced... I think I could have performed better, and I thought I should have been on the podium, but I'm moving on to next season."

Harvey's tough luck continued in the wrestlebacks, where the bracket paired him with Cahokia's Arnold Edwards, the No. 2 ranked wrestler in Class 2A. Although Harvey struck first with the opening takedown, Edwards scored a second-period near-fall and totaled the final five points of his 6-2 victory.

While Harvey fell short of his quest to medal for the second straight year, his first-round win over

Marmon made him the first RTHS wrestler in the last 50 years to score at least 40 victories in two consecutive seasons. As he prepares for his senior season, he'll be looking to not only get back on the podium, but walk away with Rochelle's first state championship since 2003.

"I learned not to look over anything and to always be ready for what's in front of you," Harvey said. "I learned to be prepared for the worst situation and hopefully that will help me next year... I'm hoping to really turn it up a notch next year, and hopefully I'll be able to win a state title. It's going to take a lot, and I need to put in the extra hours and dedicate myself."







Hubs primed for success after strong season

Rochelle grapplers looking to build on 18-win campaign

ROCHELLE — The Rochelle wrestling team doubled its win total from last season, and the Hubs are already primed for immediate success in the future.

The Hubs rebounded nicely from a tough 2018 campaign, compiling an 18-4 overall record this season after earning only nine victories the previous season. Rochelle (No. 22 IWCOA2A) qualified six individuals for the IHSA 2A Sectional at RTHS and advanced Ben Harvey (40-6 at 182) and Gavin Ansteth (28-14 at 195) to the IHSA 2A State Championships in Champaign.


"I thought we had an awesome season," head coach Alphonso Vruno said. "I thought we had several kids who made significant leaps forward... I felt that the kids wrestled a lot differently this year than they did last year. I thought our mentality last year was pin or get pinned, and I didn't think the kids wrestled hard for six minutes. We really

stressed that this year, and I thought the kids bought into that mentality and wrestled hard."

Rochelle closed the season with third-place performances in the Interstate 8 Conference Championships and the IHSA 2A Sycamore Regional. The Hubs will graduate seven seniors from the team including Ansteth, Zack Capes (19-18 at 285), Bryan Garza (27-14 at 170), Diego Escobar (10-9 at 160), Zeke Horn (23-20 at 152), Keegan Davis-Carter (31-11 at 138) and Hezekiah Jefferson.

"We definitely improved on our feet and I thought our kids became the attackers in the neutral position,"Vruno said. "We weren't waiting for kids to shoot on us. We wrestled with the mentality that we were going to take our opponents down. I thought the kids improved on bottom as well... We can still get better on bottom, but we were trying harder to get off bottom this year as opposed to laying on our bellies and getting pinned last year."

fiers will return next season including Harvey, Grant Thompson (22-19 at 132), Ethan Tooley (21-21 at 145) and sophomore Caleb Nadig (32-8 at 126). Juniors Ivan Pineda, Noah Messer and Ethan Albers, who missed this season

with knee injuries, could also be big contributors next season. Rochelle's freshmen and sophomores will be getting a head-start on next season with the IWCOA Fresh-Soph and Girls State Series next month.

"I'm really excited for next season," Vruno said. "Our lower weights have struggled over the last 3-to-4 years but I think that's an area we can be really strong next season... I thought Weldon [Nay] was spectacular over the sec-

ond half of the season, and we're hoping that Noah and Ethan can take over some spots at our upper weights. We'll also have Jaden [Cook] who will step in as our heavyweight next year and he's developed really well."
