Law enforcement center ahead of schedule, under budget

DIXON — On Tuesday, Jan. 8, the Lee County Board announced the New Law Enforcement Center (LEC) Construction, which began site work on July 16, 2018, is now "Under Roof," three months ahead of schedule, and forecast to complete 4-5 percent under budget.

Ringland Johnson Construction, Lee County's Design Builder and Construction Management firm recently announced the project "Substantial Completion" date has pulled forward three months, from Nov. 30 to Aug. 30, with "Final Completion" on Sept. 20.

The overall project budget is now forecast to come in 4-5 percent under the \$18,500,000 project cap. The Design/Build Guaranteed Maximum Price stands at \$16,830,347, a full 6.7 percent under the initial Design/Build budget. Unforeseen risks are always possible, but at this point in the project The firm feels confident the new Law Enforcement Center can be completed under budget.

Just before Christmas the LEC building envelope was closed in, permanent Natural Gas and Electric utilities established and temporary heat started up. This has and will allow interior work to continue unimpeded through the winter months. Major work that has completed since Christmas includes the installation of the roofing insulation and membrane system. Concrete flooring has been poured in the administrative and support areas and interior masonry wall construction continues. The number of contractors on site will continue to ramp up as interior work proceeds over the winter months. This spring exterior work will commence again in parallel with the completion of the interior work.

Several key decisions have contributed to the improvements in schedule and budget:

First, the county's decision to relocate the project from the downtown location adjacent to the new courts building to the new location on Progress Drive next to the Reagan Transit Center (Lee/Ogle Transportation Hub).

Severe weather spotter training offered in Dixon Feb. 21

DIXON — The Lee County Office of Emergency Management and Ogle County Emergency Management Agency will be hosting a weather spotter training presented by the National Weather Service on Feb. 21, at Sauk Valley Community College, 173 IL Rte. 2, Dixon in room 1K04.

SNAP benefits to continue through February during federal shutdown

CHICAGO - The Illinois Department of Human Services (IDHS) announced today that February Supplemental Nutrition Assistance Program (SNAP) benefits will be funded through the end of February, but they will be issued to Illinois customers

on or before Jan. 20. Typically, benefits are issued in the first few days of the month.

"We want to reassure our customers that SNAP benefits are funded through the end of February," IDHS Secretary James Dimas said. "However, we need to spread the word as quickly and widely as possible that these benefits will

be issued earlier than usual."

SNAP is a federal program administered by the United States Department of Agriculture (USDA) and distributed through IDHS in Illinois. January and February SNAP benefits will not be affected by the current lack of federal appropriations.

Because of the way the USDA has funded February SNAP benefits, they must be issued on or before Jan. 20. This is about a week and half earlier than usual for customers.

There is no need for customers to visit the local IDHS offices or call their caseworkers. IDHS staff will be working in the upcoming days to implement the necessary changes so customers see no disruption in their

SNAP customers will receive the normal amount of monthly SNAP benefits on their Link cards, the debit-like cards used to spend SNAP benefits and other

cash assistance. IDHS will be working to communicate the early issuance to SNAP customers in the upcoming days through the IDHS website, Link website and customer service phone line, a social media campaign and community outreach.





She preceded him in death on Feb. 23, 2010.


He was also preceded in death by three sons, Kenneth, Keith, and Joseph Daniels;

I Had My Hour

must admit that when I began reading Randy Pausch's 'The Last Lecture," I felt more irritation than inspiration. Here was a relatively privileged white guy dispensing bits of advice, such as carrying \$200 in your wallet in case you get robbed, or urging us to let nothing stand in the way of making our childhood dreams come true. It helped of course that he had loving, supportive parents and mentors who helped him in his academic career.

But once I put aside the fact that my childhood dream went no farther than to work in a butcher shop because in my house, meat was a once-a-week rarity at best, I became more open-minded to Pausch's unclouded enthusiasms. Randy Pausch was a very popular computer science profes-

sor at Carnegie-Mellon University. He was married to Jai, the

love of his life, and they had three small children. At 47 he was diagnosed with pancreatic cancer and given six months to live. His last lecture was the first of Carnegie-Mellon's Last Lecture series, which celebrated its tenth anniversary last September. Hundreds of Pausch's students and colleagues came from all over the country to listen to his lecture. Pausch, an accomplished lecturer with a broad sense of humor, talked about how his several childhood dreams all came


true in one way or another, how he blossomed as an academic who advanced the field of Virtual Reality, including a stint as a Disney Imagineer, and how he met his beautiful wife after many years of playing the field. One of his legacies is the Alice Project, which teaches kids, especially girls, to learn about computers by telling stories. It's open-source, free to everyone. He dispensed all sorts of folksy wisdom throughout the


lecture, such as brick walls are a chance for you to show what you are made of; and, you can't change the cards you are dealt, but how you play them. In his classes, he established an award for projects that were the most glorious failures. He joked about his mother introducing him as her son the doctor, but not the kind who helps people. He ended the lecture with a head fake: he said his lecture wasn't really for us, but for his kids. The lecture became an online phenomenon – over 11 mil-

Parallels between Illinois and government shutdown frightening

m I the only Illinoisan who is experiencing déjà vu, when it comes $Guest\ Column$ to the latest antics in Washington? It seems a petulant chief executive is at loggerheads with a Speaker of the House and is allowing a portion of the government to go

unfunded unless he gets what he wants. It could be Gov. Bruce Rauner circa 2015 or President Donald Trump in 2019.

The parallels are frightening.

Both Rauner and Trump are wealthy men accustomed to getting what they want. It is also worth noting that neither held any other public office before being elected to head an executive branch.

Rauner entered office with a 44-point program to reform Illinois.

He precipitated a crisis by using his veto pen and legislative allies to keep Illinois from

having a budget for 736 days. He'd hoped to harness the discontent caused by the emergency to shove his key reforms through the House.

Sound familiar?

That's exactly what Trump is attempting now. He is allowing much of the federal government to shut down as a way of pressuring By Scott Reeder House Speaker Nancy Pelosi to support his idea of building a wall along the Mexican border.

He has even said this crisis could last "years."

If there is anything to learn from Rauner's two-year misadventure, it's that these strategies rarely work. Nor should they.

Democracy is about compromise, seeking consensus, researching new possibilities and finding common ground that benefits citizens.

It's not bluster, bullying and chest thumping. Rauner envisioned Illinois House Speaker

Mike Madigan collapsing like a wet cardboard box after he applied a bit of pressure. Madigan weathered the storm quite nicely and Rauner didn't see a single one of his 44 reforms be-

The sad part is that some of the measures he advocated such as property tax reductions, education reform and worker compensation restructuring merit a public debate. And if Rauner had played his cards right he could have received bi-partisan support.

Instead he received nothing.

The proposed border wall has become emblematic of the need for immigration reform. Rather than attempting to bully a House speaker as Rauner

did, Trump should seek consensus. One thing both Republicans and Democrats can agree

on is that our immigration system is broken. It is far too hard for honest, hard-working people to legally come to the

As for Trump's wall, I view it as an expensive solution in search of a problem.

That said, Pelosi ought to bring wall funding up for a vote. More than likely the legislation would die a quick death because Trump has failed to convince a majority of members of Congress (or the American people) that a wall is needed. Elections have consequences and Pelosi's party now controls a legislative chamber.

Effective leaders in a democracy can't take a "my way or the highway" approach.

When they do, they inherit the wind.



Madigan's power runs deeper than the speaker vote

Representatives in 1983, Illinois was among a handful of states that enjoyed a AAA credit rating. In 2013, Illinois was declared the least creditworthy state in the nation. Now the state is just one notch above junk status.

Many things have changed in state government during the past 36 years. Madigan has held constant.

And that will continue, as House members this week elected Madigan to his 18th term as speaker on a 72-44 vote, following the inauguration of the 101st General Assembly. State Rep. Jim Durkin, R-Western Springs, will retain his role as House minority leader.

There was a wrinkle, however.

One House member, state Rep. Anne Stava-Murray, D-Naperville, voted "present." It was the first time in Madigan's more than three decades as speaker that a freshman Democrat refused to cast this vote for him. Stava-Murray has been a vocal critic of the speaker's handling of sexual harassment allegations in his party organization and his treatment of the #MeToo movement generally.

Her lone voice of dissent highlights the overwhelming, unique power Madigan wields as speaker and as chairman of the Democratic Party of Illinois.

Madigan holds a 21 percent job approval rating statewide, according to Southern Illinois University Carbondale's Paul Simon Public Policy Institute. Yet he is re-elected to the speakership every two years due to the pain he can inflict on

dissenters. How? What truly gives the speakership so much power is another



Then Mike Madigan first became Guest Column vote in the House – the vote for the rules of the speaker of the Illinois House of Guest Column chamber. Through the House rules, Madigan can assign committee chair positions and the \$10,000 stipends that come with them, control who votes in committees, dictate when a bill will be called for a vote, and even control what bills make it to a vote in the first place.

> No other state legislative body in the nation grants such broad powers to its House speaker.

It should be noted that Republican leadership expanded the power these rules granted legislative leaders in the 1990s. But Madigan has been happy to further expand and cement them in the two decades since Democrats took back control of the House.

The House will likely vote on its rules for the 101st General Assembly on Jan. 29.

But it's not just the rules from which Madigan draws power. He is also the only legislative leader in the nation to head a state political party. As chairman of the Democratic Party of Illinois, Madigan simultaneously controls policy, politics and purse strings.

Voting "present" for speaker will likely cost you the ability to have your bills see the light of day. But it also puts you squarely in the crosshairs for a well-funded primary opponent. Of course, Stava-Murray will undoubtedly face conse-

quences for her speaker vote. The fact that her stance is so costly is exactly why the House rules vote – granting one man extraordinary power


During the evening, the Lady Clippers will host a silent auction, Chuck a Duck 50/50 sale, shirt sale and

AMBOY — The Amboy girls' basketball program got back to school on Jan. 7 and started up with its first game of the new year against Ottawa Marquette. After a slow start, the Lady Clippers dominated the action in a 47-21 victory at the AHS gym.

Amboy trailed 6-4 after the first quarter, but it shook off the rust in the second period and exploded for 24 points while holding Marquette to just five. The third quarter was similar as AHS outscored the visitors, 15-3.

Mallory Powers hit seven of nine shots and led the Lady Clippers with 17 points. She added six assists and four steals.
