On Friday at 8 a.m., the community wide garage sales and the vendor booths downtown open for business. The food stands open at 10 a.m. and the carnival will open at 6 p.m. The carnival special for Friday night is \$20 bands for unlimited rides. LANDMARK GOES DOWN

A Sublette Village Maintenance Building was recently razed since the village has built a new maintenance building near the water tower on North Front Street. The old building was a long-time landmark. It was constructed in about 1925 by the Vaessen Brothers and by 1926 opened as an auto repair business, pictured below. Shortly thereafter they took on the Chevrolet dealership. Then in 1953 they built a new service station with a showroom for cars and offices. They still continued to use the original building as a repair shop. They operated both locations until 1976 when they built their current building at the Northwest edge of town on Route 52. They then moved their entire operation to the new location. At that time they sold the original building to the Village of Sublette and they used it for the Village Maintenance Department since that time until completing their new structure.



Construction to begin over Green River

DIXON – The Illinois Department of Transportation announces that weather permitting, construction work on the structure carrying US 52 over the Green River on the south edge of Amboy will begin on Wednesday, August 21. Sjostrom & Sons, Inc. will be starting the \$388,000 contract to make improvements to the expansion joins and bridge deck surface.

Traffic will be reduced to one lane utilizing flaggers to complete the widening work on Aug. 21 and 22. Both lanes will be open Friday, Aug. 23- Sunday, Aug. 25 for Amboy Depot Days. Beginning Monday, Aug. 26, traffic will be reduced to one lane utilizing temporary traffic signals to complete the repairs. The project is scheduled to be completed by mid-October.

Motorists can expect delays and should allow extra time for trips through this area. To avoid the work area, when feasible, use of alternate routes should be considered. Drivers are urged to pay close attention to changed conditions and signs in the work zones, obey the posted speed limits, refrain from using mobile devices and be alert for workers and equipment.

AMBOY — The Amboy City Council approved the hiring of a new maintenance worker and approved a bid for sidewalk work at its Monday night meeting.


The board met Monday night at the Amboy Community Building. All members were present.

State's municipalities seek clarifications on recreational marijuana legalization

SPRINGFIELD—The state organization representing local units of government is asking leaders in the General Assembly to make clarifying changes to the recreational marijuana law before it takes effect Jan. 1.

Brad Cole, executive director of the Illinois Municipal League, said the 1,298 cities, villages and towns in the state need guidance on four aspects of the Cannabis Regulation and Tax Act, signed into law by Democratic Gov. J.B. Pritzker in late June.

There is confusion, he said, about how law enforcers will know a person who is growing cannabis in their home is doing so legally as a prescribed medical marijuana user. Municipalities also are uncertain how they may regulate the drug. Cole is asking legislators to write what is

known as a trailer bill, a companion measure that clarifies a statute. The idea has bipartisan Sen. Heather Steans, D-Chicago, one of the

statute's framers and her chamber's sponsor, said, "We are likely to be doing a trailer bill." Republican Sen. Jason Barickman, from

Bloomington, said he thinks his colleagues spent "a lot of time on the legislative language," and any subsequent bill should be consistent with the goals of the original negotiations.

"I understand and support the idea of a trailer bill to make clarifications that the various stakeholders have brought forward. I think it's very likely we'll see one for multiple reasons, and we may see it as early as this fall," he said. "I anticipate hearing from many stakeholders about clarifications they would like to see. By and large, that's what the IML is seeking here."

In a letter to lawmakers, Cole highlighted four points the league's members would like the General Assembly to address. Each one, he said, was mentioned in his testimony before a panel of legislators in late May before the recreational marijuana bill became law.

"These are common sense issues" to determine what is legal and what is no,

The new law allows those who have a medical marijuana card to grow no more than five plants in their home without needing to be a licensed cultivation center or craft grower. The League's concern, Cole wrote in his letter, is the lack of "registration or notification requirements to municipalities or their police departments" about which residences can legally grow cannabis plants.

"We're saying, we need to know," he said. "How do we know if these are five legal plants or five illegal plants?"

Steans said the idea of "a registry had been raised," but some interest groups expressed concerns it might be a civil rights violation. She added local governing bodies would know if the plants were legal by asking whether their owner had a medical marijuana card.

Barickman said the issue is one with 'wildly different" viewpoints.

"I think you're going to have those in law enforcement presumably asking for some type of registry, and I think you're going to have others adverse to that," he said.

Also in question is a provision in the law dictating how governing bodies can regulate recreational marijuana. "No unit of local government ... may

prohibit home cultivation or unreasonably prohibit use of cannabis authorized by this Act," according to the law. Cole, in his letter, wrote that "unreason-

ably" is not defined, so towns and municipalities might be exposed to "unknown litigation as they attempt to protect the health, safety and well-being of their citizens." The League is asking the General Assembly to clarify the word's meaning. And it is seeking guidance on two regula-

tions dictating how funds are distributed and may be spent by local governments. Money directed into one account, for example, now has rules for how it may be spent.

"This is restricted money being put into an unrestricted disbursement fund," thus creating accounting confusion for local officials, Cole said.

Department of Revenue Director David Harris was copied on the Municipal League letter. In an emailed statement, a spokesperson said the department "is working to ensure successful implementation and rollout of the Cannabis Regulation and Taxation Act and works with all stakeholders to that end."

"I think what's happening right now is the multiple stakeholders are doing a deeper review of the law now that it's been set, and they're raising some questions that I think we can address through a trailer bill, providing some clarity," Barickman said.

Steans added the recreational marijuana statute created large policy changes and "lots of different viewpoints" need to be considered.

In an emailed statement, Jordan Abudayyeh, Pritzker's press secretary, seemed to indicate the governor is open to a trailer bill. The administration, she said, "is focused on ensuring the successful implementation" of the law.

"Multiple state agencies are engaged in these efforts as we move forward creating one of the most equity centric industries in the country," Abudayyeh said. "The Pritzker administration stands ready and willing to continue working to ensure Illinois has a cannabis industry that other states can look to as a model for equity and success."



Saving lives

n the late 1960s, several histories appeared which told a tale of America's refusal to come to the aid of European Jews, even in light of overwhelming evidence of wholesale mass murder and many opportunities to intervene, including the ransoming of Hungarian Jewry and the bombing of Auschwitz. This view of an indifferent and complicit America has predominated until recently. Rebecca Erbelding's "Rescue Board: The Untold Story

of America's Efforts to Save the Jews of Europe" is a powerful and convincing challenge to this view. It is the history of the independent War Refugee Board (WRB), established by executive order by President Roosevelt in January 1944. Consequently, for the next seventeen months a small group of Treasury officials and their agents in Europe managed to save an estimated 200,000 lives. The extermination of the Jews began when the German

army invaded the Soviet Union in June 1941. At a news conference in November1942, the American people were told of the horrors taking place in Europe. But to most people it sounded too farfetched, it was just war propaganda. The "New York Times" reported it on page 10. But at that time, America's ability to actively intervene was nearly non-existent, not until victory was in sight.

The first part of "Rescue Board" is a fascinating account of the dog fight between the Treasury and State departments on refugee policy. State was not only intransigent, it blocked at every turn Treasury's attempt to organize. Only the British were more adamant in refusing to help rescue Jews. But John Pehle, the executive director of the WRB, finally prevailed. Some of the WRB's successes included breaking the

Bulgarian bottleneck to allow refugees from Romania to reach Palestine through Turkey; funding much of Raoul Wallenberg's efforts to issue certificates of protection to thousands of Jews in Budapest; establishing a refugee camp at Fort Ontario in upstate New York that housed nearly 1,000 Jews. It strung along Nazi officials who sought to trade goods and trucks for Jewish lives. Without ever engaging in such trades, they kept Jewish prisoners alive for seven months until they could be liberated or receive aid. It convinced Goodyear Tire to launder \$50,000 so that the WRB could transfer the equivalent amount in Swedish Krona to a WRB agent to rescue refugees from the Baltic states just ahead of the Soviet invasion. And finally it organized the purchase and delivery of hundreds of thousands of food packages to prisoners in German concentration camps in the last months of the war. By war's end, the WRB's relief money amounted to 11 million dollars (154 million dollars today).

Israeli historian Yehuda Bauer said of the WRB: "What made the WRB such a unique body is that it was officially permitted to break practically every important law of a nation at war in the name of outraged humanity."

What moral lessons are students benefiting from this scheme learning?

ich folks in the Chicago suburbs are working a scam to bilk taxpayers and Guest Column needy youngsters out of financial-aid dollars for college.

They are having poor friends or relatives adopt their 17-year-old kids so they qualify for financial aid.

I'm not making this up.

It's about the most shameless display of entitlement I've seen -- and I've been covering politicians for more than 30 years.

After the guardianship is switched, the child from a wealthy family applies for financial aid and he or she doesn't have to claim parental income or assets. This makes them eligible for assistance including state and federal grants, which are intended for low-income students.

The rich are bilking the poor and middle class – with the help of government.

But wait, doesn't a judge have to approve a change in guardianship? Yes, that is the case.

And here in Illinois we pay circuit judges \$184,000. For that kind of dough, we ought to be getting some awfully good judgments on their part.

After all, we don't pay them to sign all of the papers

shuffled in front of them. We pay them to make wise decisions.

Where was that good judgment when they were asked to change the guardianships for 17 year-year-old kids who live in fancy neighborhoods in houses valued between \$500,000 and

The reason given to the court for these affluent youngsters to receive new guardians was so: "The guardian can provide educational and financial support and opportunities to the minor that her parents could not otherwise provide." Did the judge ever think to ask how a new

guardian would do this or whether it was in the public interest? Retired Illinois Circuit Court Judge John

Donald O'Shea, of Moline, said judges should be asking questions.

"When people come before a court to establish a guardianship, they have a clear duty to fully and fairly advise the court of the true reason why the guardianship is necessary," he said. "If wealthy parents are setting up guardianships so that colleges being asked to give financial aid to their children do not realize that the income and assets of the parents would preclude the requested award of financial

assistance to their child or children, the parents by not disclosing the true purpose of the guardianship are perpetrating a fraud on the court in an effort to defraud whoever would be ultimately providing the assistance."

Unlike some court proceedings, guardianship hearings are non-adversarial and usually only have one lawyer present. But O'Shea said questions still need to be asked.

"Our appellate court has said that the judge is not a mere umpire, and that he is not required to sit by like an alabaster bust of his grandsire. If he has any reason to suspect his court is being misused, he has a right and even a duty to ask questions to make sure the requested guardianship is being sought for a proper purpose, and not for improper purposes. A knowing failure to disclose all material facts to the court is a direct criminal contempt of court. Such direct contempt [is] punishable on the spot.'

We don't know if those questions were asked but we do know the change in guardianships were granted.

The architects of this scheme and the participating parents are without conscience. For every one of these rich kids who received a need-based

scholarship, a deserving youngster from modest circumstances was told "no." This ethical laxity goes beyond our present circumstances.

What moral lessons are the students benefiting from this scheme learning?

Be assured, they aren't good ones.

Swanson legislation creates "Cold War" veteran license plate designation addition to signing the Cold War License Plate Bill into law,

WOODHULL — State Representative Dan Swanson (R-Alpha) announced that Governor JB Pritzker signed Swanson's legislation into law on Friday creating license plates honoring veterans of the Cold War.

"Many of our Cold War veterans do not receive the recognition they deserve despite their service to the United States during a critical time in our history. It is estimated 400,000 veterans were exposed to toxins during the Cold War, more than 3,500 died of gunshot wounds or explosive devices, 364 American pilots were shot down, 269 civilians missing and many next of kin do not know the fate of their loved ones, and many (at least hundreds) were interrogated by the Soviets, never to be heard from again," said Rep. Dan Swanson, a retired Lieutenant Colonel with the United States Army and Illinois Army National Guard. "Now we can honor their service and say thank you with this proper recognition of their work in serving our Nation."

Any veteran that served in the United State Armed Forces between Aug. 15, 1945 and Jan. 1, 1992 may apply for the plate (or decal) referencing the Cold War. There are currently decals available for many theaters of action, including: Cuba, Atomic Veterans, Grenada, Persian Gulf, Laos, Panama, every major war and military operation and several others. The decals show the branch of service and include the theater of action in which the veteran served. The decals can be attached to the universal veterans plate.

The new Cold War plates have no additional fee attached and will be designed by the Illinois Secretary of State. In
