OCFB's Kern: 'Decent start' to planting season in Ogle County

Drought conditions have 'improved greatly' since last fall

OGLE COUNTY — Ogle County farmers have gotten a "decent start" to planting season, Ogle County Farm Bureau Manager Ron Kern said May 13.

Kern said that some farmers have finished their planting of corn or soybeans, but estimated that no farmers in Ogle County have completely wrapped up yet with their spring planting work. With showers that have been hitting the area multiple times per week so far this month, farmers have been working between raindrops, he said.

"I wouldn't say we're behind on planting," Kern said. "Believe it or not even with the sporadic showers, it seems like we've only been out of the fields for a day or two. These rains have been followed by sunny weather with decent winds that have dried the soil out in a pretty fair manner. I think our biggest problem is that we have not been able to get into a rhythm. We farm for 2-3 days then sit for a day or two then we farm for 2-3 days again. We've seen that instead of a nice 7-10-day window to get out there and keep going."

Kern said last year saw a dry spring that allowed for continuous planting work. He said due to the importance of rain, he won't be complaining about this year's conditions. Ogle County has been behind on moisture in fields for the past few years, but Kern said the conditions have "improved greatly" since last fall.

The crops planted so far in Ogle County have taken well to the soil, Kern said.

"From what I've seen, what we have in the ground is emerging," Kern said. "Beans and corn both. They've got an excellent stand. In other words, most all of the crop that went in the ground is coming up. It's a decent start to the year. We still have 2-3 weeks to get everything in the ground to get where we want to be come June. I think farmers would say they're mildly happy."

Workload for farmers during this time of year depends on what sort of production system they employ, whether their fields are no till, conventional till or minimum till, Kern said. Planting typically starts in the mornings and farmers wrap up by dark, unless they get behind.



OREGON — Ogle County Collector, Tiffany O'Brien, reports that property tax bills will be mailed out on May 10. The first installment will be due on Monday, June 10, with the second installment due on Tuesday, Sept. 10. This single document will contain tax information and payment stubs for both installments. Therefore, property owners need to save this bill as no additional notice will be mailed prior to the second

Payment methods include cash, check (payable to Ogle County

Collector) or credit card. In-person payments can be made at the Treasurer's office or at any bank in Ogle County. The Treasurer's office is in the old Courthouse located at 105 S. 5th St. in Oregon. Office hours are 8:30 a.m. - 4:30 p.m. Monday - Friday excluding holidays. Their mailing address is Ogle County Collector, P.O. Box 40, Oregon, IL 61061. Mailed payments must be postmarked by the due date to be considered timely. Late payments will incur a fee of 1.5% per month or part of a month after the due date

and must be remitted by mail or at the Collector's office.

Collector O'Brien's office is also offering the option of online payments. You may go to the Ogle County website at www.oglecountyil.gov and then select the Treasurer's department. Choose the Online Tax Payments link and click the Pay Now button. Fill in the information as prompted. Be sure to receive a payment conformation for your records. Please note that this service carries a fee; review the convenience fees prior to making payment.

"I saw sprayers going out this weekend to spray herbicide to get rid of weeds," Kern said. "And if you're one of those people that's lucky enough to have hay, it's probably needing a cutting right now. That requires about three days without getting rained on. There's a lot to do this time of year. And those with livestock obviously have

livestock every day. It depends on what your system is."

Kern advised the motoring public to be cautious while driving around agricultural equipment on roads during this time of year. He asked drivers to be patient and understand that farmers only can go so fast and are trying to get from field to field and off roadways as fast as they can.

"Not only pay attention to the equipment in front of you, but also pay attention to what's in front of the equipment," Kern said. "If they approach things like guardrails, mailboxes and road signs, they may have to swing out into the other lane to get around those things with their equipment. Passing lanes may close quickly when they approach those things. Try to anticipate what they're seeing out of the cab too.'

In the grander scheme of agriculture, Kern said he's expecting a possible vote on a new federal farm bill during the week of May 19-25. He hopes an end result to that will maintain crop insurance, which has become something all farmers use to manage risk. He'd also like to see more emphasis put on trade agreements, which could help with

imports, as well crop prices, which Kern said are currently "somewhat depressed.".

At the state level, the Illinois Farm Bureau has been active this year in the general assembly to get changes made to the state estate tax that impacts how farmland passes from generation to generation.

"When some of these farms pass from generation to generation, and the new generation has to sell off some of the farm just to pay the taxes, that's not a good scenario,' Kern said. "Because usually when you're passing it on to the next generation, they're farming the land. They need that land for their operation and having to sell it off to pay the taxes doesn't seem right. Hopefully that issue gets settled with the state. It's something the IFB has been working on for decades and I hope the time is right for it.'

As summer in Ogle County comes into sight, Kern detailed a small wish list to keep farmers on track for harvest this fall.

"I would love to see temperatures never get above 94 degrees and an inch of rain every week," Kern said.

Oregon Park Board: Pool project bid approved

Design contract for Park East work approved

OREGON — The Oregon Park District Board of Commissioners met on Tuesday, May 14 for its regularly-scheduled monthly meeting. The May meeting serves as the district's annual meeting each year. As such, the board appointed Brian Beckman to serve as president and Josh Messenger as vice president for the 2024-2025 board year.

The Board of Commissioners reviewed bids for an upcoming pool improvement project at Nash Recreation Center. The low bid of \$548,167 submitted by Sjostrom & Sons was approved. Improvements will include installation of a new rooftop air handler, removal and replacement of the pool storage concrete floor, removal and replacement of the epoxy flooring on the pool deck, removal of the diving board, and installation of an aqua climbing wall.

"The diving board continues to be operational, but replacement will be necessary," Executive Director Erin Folk said. "Due to FINA guidelines, diving board manufacturers cannot sell the district a new diving board due to the current pool depth. Staff has been researching replacement options and installation of a climbing wall will increase the play factor for our pool patrons."

The climbing wall

will be installed on the east side of the deep end, allowing more opportunity for lap swim during multi-use swim times. Pool improvements are slated for August.

Design and engineering work will soon be underway at Oregon Park East. The board approved a \$126,500 contract with Hitchcock Design Group to provide design and engineering services to complete the planned improvements at Park East with \$600,000 in OSLAD funding. Construction is expected begin in 2025.

The May 14 board meeting also served as the final meeting for Commissioner Maia Johnson. Commissioner Johnson was elected in April 2023 and served May 2023-May 2024.

"It has been an eye-opening experience," Johnson said. "You guys should be really proud of the park district and all that you have done and continue to do. It is quite amazing for a town this size to have. Thank you for the opportunity."

Applications for the vacant commissioner seat were advertised April 10-May 15. The Board of Commissioners will plan to appoint a new commissioner in June 2024.

The Oregon Park District's next scheduled monthly meeting is June 11 at 6 p.m.

* On June 3, 1943, a group of U.S. sailors marched through downtown Los Angeles with clubs and other weapons, attacking anyone wearing the "zoot suit" favored by many young men of color at that time. The Zoot Suit Riots spread throughout the city over the next week, marking the culmination of racial tensions against the backdrop of World War II.

* On June 4, 1876, an astonishing 83 hours after it left New York City, the Transcontinental Express train arrived in San Francisco. Many Americans could hardly imagine that a journey previously requiring months using horses could now be accomplished in under a week.

* On June 5, 1956, a young Elvis Presley performed "Hound Dog" on "The Milton Berle Show" with a gyrating enthusiasm that set off a scandal. Critical reaction was almost universally negative. In fact, one writer described Presley's hip-swinging as "tinged with the kind of animalism that should be confined to dives and bordellos."

* On June 6, 2013, Edward Snowden, a National Security Agency contractor, leaked documents to the press exposing a government-run surveillance program that monitored not just the communications records of criminals and potential terrorists, but law-abiding citizens as well. Facing multiple charges and prison time, Snowden fled to Hong Kong and later Russia to avoid extradition.

* On June 7, 1976, New York magazine published journalist Nik Cohn's article "The Tribal Rites of the New Saturday Night," which would inspire the John Travolta cinema smash "Saturday Night Fever." Nearly 20 years later, however, Cohn confessed that the allegedly real-life characters peopling the story were actually fictional.

* On June 8, 632, the prophet Muhammad died, as a result of being poisoned, in the arms of Aisha, his third and favorite wife, in Medina, located in present-day Saudi Arabia.

* On June 9, 1945, while hosting the Philadelphia Phillies, Brooklyn Dodgers manager Leo Durocher struck mocking Phillies fan John Christian in the dugout with the help of a stadium security guard. The incident led to Durocher's arrest on assault charges the following day, but he was released on bail, and actor Danny Kaye, a friend of his and acquaintance of Christian, brokered a \$7,000 settlement that closed Christian's civil suit.

* On June 9, 1772, colonists, angered by the British Parliament's passing of the Townshend Acts restricting colonial trade, board and set ablaze the HMS Gaspee, an armed British customs schooner that had run aground. British officials found no one willing to identify those involved, and the inquiry closed without result.

* On June 4, 1919, the 19th Amendment to the U.S. Constitution, guaranteeing women the right to vote, is passed by Congress and sent to the states for ratification. On Aug. 18, 1920, Tennessee became the 36th state to ratify the amendment, giving it the two-thirds majority necessary to make it the law of the land.

* On June 3, 1937, the duke of Windsor -formerly King Edward VIII -- marries Wallis Warfield Simpson, the American divorcee for whom he abdicated the British throne in 1936.

*On June 5, 1942, President Franklin D. Roosevelt issues a stern statement warning Japan to stop using poison gas in its war on China. Japan continued its use of these weapons until the end of the war, managing to keep its activities secret.

*On June 8, 1966, the rival National Football League (NFL) and American Football League (AFL) announce that they will merge. The first Super Bowl between the two leagues took place at the end of the 1966 season.

* On June 6, 1971, "The Ed Sullivan Show" airs for the last time, 23 years after its 1948 premiere. Gladys Knight and the Pips were the

musical guests.

*On June 7, 2002, Michael Skakel is convicted in the 1975 murder of his former neighbor, 15-year-old Martha Moxley, with a golf club. Skakel, a nephew of Ethel Kennedy, the wife of the late U.S. Senator Robert Kennedy, was sentenced to 20 years to life in prison. In 2018, the Connecticut Supreme Court vacated the conviction and ordered a new trial.

Crime, morals, and the case against common sense

E Americans are practical. We cast a suspicious eye on theories. We rely on common sense — self-evident ideas that nearly

But common sense used to tell us that the earth stands still and the sun revolves around it. Deep in our primitive cores, we all still believe it, no matter what science tells us. Our brains are, thanks to the whims of evolution. vulnerable to this common-sense illusion, and to

One of them is the belief that people are less moral than they used to be. Researchers Adam Mastrolanni and Daniel T. Gilbert, in an article at Columbia University's Nature website, reviewed studies, covering over 12 million people in 60 nations over a period of 70 years, regarding this idea. Well over 80 percent of the participants, in America as well as in the other countries, reported,

many others.

year after year, that moral standards were deteriorating. But the authors provided evidence to the contrary from their own research, based on how participants felt about people in their personal worlds, as opposed to society in the abstract. And they cited studies showing a significant decrease in "extremely immoral behavior" over the years.

These findings are consistent with a review that I conducted and reported on in 2009 while I was a school psychologist, as well as an article I wrote for this column in 2016. Each revealed improved moral behavior in children and in society in general, including sharp declines in teenage crime, sexual activity, and consumption of alcohol and other drugs. They're also compatible with the wealth of data cited in Steven Pinker's book, "The Better Angels of Our Nature." It reveals humankind's brutal past, and its evolution through the ages toward a kinder and less violent society, a story of moral progress that continues today.

The belief in rising crime is another example of the way common sense can deceive us. John Gramlich, at the Pew Research Center, reported on April 4 that "In 23 of 27 Gallup surveys conducted since 1993, at least 60 percent of U.S. adults have said there is more crime nationally than there was the year before..." But he also revealed that violent crime reported to the police fell by 49 percent in those years, according to the FBI. Annual surveys by the Bureau of Justice Statistics, asking people if they had been a victim of a crime during the previous six months, dropped even more sharply, falling by 71 percent.

There was an uptick during the pandemic, but the data available so far suggest that crime resumed its downward trend last year. Life in most places in modern America is, contrary to the widely held impression, probably safer than ever.

Common-sense illusions like declining morals and rising crime arise from mental limitations that we all share, regardless of social class, education, or political ideology. Psychologist Daniel Kahneman conducted extensive research on this topic. His book, "Thinking Fast and Slow," revealed that our brains rely heavily on the information that's the most readily available and that has the greatest emotional impact. They preserve precious energy by avoiding whenever

possible the hard work of logically analyzing all the facts. The media play a critical role by emphasizing

simple stories and sensational events. Mr. Mastrolanni and Mr. Gilbert cite research regarding two additional mental glitches that can result in unrealistic images of past and present morality and crime rates. One is the normal tendency to remember or imagine the good things from the past, and to forget or discount the bad. The other is our instinctive focus, encouraged by the media, on bad news about the present.

It would be arrogant and foolish for any of us to claim to be free of these mental errors. It should be no surprise that common sense, handicapped as it is by our all-toohuman brains, can present a distorted view of morality, crime, and other important issues. There is a remedy for this predicament, although it's out of favor among many in this age of populism, and its distrust of experts and expertise.

It's science and its methods of discovery and proof Common sense has a role to play when the consequences for error are small, or when we don't have time to investigate things thoroughly. For the rest, we need science and the fact-centered, logical, self-doubting state of mind that it represents.
