Kellen steps down as Mendota police chief after six-year term

MENDOTA-There is going to be a new police chief in town after Chief Greg Kellen announced his retirement at the regular meeting of the Mendota City Council on

Kellen, who has been the police chief since 2018, read a prepared statement to the mayor, public safety committee and the rest of the council:

"It is with deep regret and sadness that I notify you today of my intention to retire from the city of Mendota as the chief of police. For the past 34 years I have dedicated my life and directed my energy into serving and protecting this community to the best of my ability in the capacity of police officer. After all these years, I have only one hope and that is that along my journey I made a difference.

"I wish to thank the city of Mendota, city council, the fire and police commission, the Mendota Police Department employees, both past and present, and all the citizens of Mendota for the opportunity they have provided me to serve over the past three decades.

"The memories, the experiences, the challenges, the accomplishments and the comradery will never be forgotten, and I will treasurer them always."

Two Mendota High School students headed to Europe

MENDOTA - Sophomores Rosalinda Lopez and Addyson Allensworth are going to have a different type of summer than they've ever had before.

It starts with boarding a plane to spend a month in a different country in part of the Rotary Youth Exchange.

"I've always wanted to go

to Italy. I literally love their culture. I love the food. I love everything. It is so pretty there. I'm very excited to go," said Lopez. "I've talked to the student in Italy I'm exchanging with. Her name is Maila. She speaks Italian, English, and French. I speak Spanish, so I understand a little Italian because there are similarities in the languages. We're supposed to be learning languages through this



History of the Burlington Railroad on June 1 at Graves-Hume

MENDOTA-Historian Leo Phillipp will discuss why Mendota was so important for the railroad system at 11 a.m. Saturday,

Phillipp will explore the forgotten services and functions of the railroad to help the audience gain insight into a bygone era when the rhythmic chug of locomotives and the clatter of tracks were integral parts of everyday life.

The Chicago and Auro-

ra Railroad, a predecessor of the Burlington Route or Chicago, Burlington and Quincy Railroad, arriced in Mendota in late 1853 where it connected with the Illinois Central Railroad that had arrived earlier. This immediately made Mendota a junction point for passengers and frieght service.

The presentation will look at the growth of passenger and freight service but also discuss

long forgotten services that made the railroad important to people's everyday lives.

Phillipp, a Burlington Route Historical Society board memmber and vice president of outreach and education, has almost 50 years of experience working for the railroads.

TCOC celebrates the impact of Foster Grandparent volunteers

STERLING – The Foster Grandparent Program of Western Illinois, sponsored by the Tri-County Opportunities Council, celebrated the impact of the fifty Foster Grandparent Volunteers who serve in local communities. A volunteer appreciation banquet was held at Champ's Banquet Venue in Sterling on May 15.

Volunteers were recognized for their current year of service and honored for their milestone anniversary years, and 32 volunteers received the prestigious President's Lifetime Achievement award for volunteerism. Criteria to receive this award include volunteer service of 4,000 plus hours. The volunteers who were honored with this award have collectively served 366,907 hours volunteering their time through the Foster Grandparent Program.

The Foster Grandparent Program has been sponsored by the Tri-County Opportunities Council since 1966. Through this program, individuals aged 55 and over who meet the program's income guidelines are placed in daycare and school settings where they work one-onone with students in need of a mentor, academic help, and assistance meeting their emotional and social needs. The program's impact includes improved scholastic outcomes for students who are served as well as health and emotional benefits for volunteers who find a new sense of purpose in their volunteer roles. Income-eligible volunteers receive a stipend for their time and assistance with transportation. The Foster Grandparent Program is an AmeriCorps Seniors program funded through grants from the Corporation for National and Community Service and the Illinois Department on Aging. Foster Grandparents currently serve in Lee, Whiteside, Carroll, LaSalle and Bureau counties. Opportunities may also be available in Ogle, Stark, Putnam and Marshall counties. OSF HealthCare to build new inpatient hospital in Ottawa

OTTAWA – As part of an ongoing commitment to transform, preserve and sustain evolving health care along the entire I-80 corridor, OSF HealthCare plans to build a new inpatient hospital in Ottawa.

OSF HealthCare intends to file a Certificate of Need (CON) application with the Illinois Health Facilities and Services Review Board to build a new inpatient hospital facility to replace the current one in Ottawa. The new hospital will be built across the street, south of East Norris Drive (Route 6), on a vacant 31-acre plot of OSF-owned land. The current OSF Health-Care Saint Elizabeth Medical Center was built in the early 1970s and is at the end of its useful life with infrastructure challenges necessitating this decision.

'Over the past decade, OSF HealthCare has sustained and grown quality health care services in and around Ottawa," says August Querciagrossa, CEO of the Western Region for OSF HealthCare. "When the new hospital is built, it will be reimagined as levels and types of services offered are realigned throughout the I-80 corridor. Our intent across all our I-80 communities is to ensure current and future generations have access to care locally."

OSF HealthCare expects to submit the application to the Illinois Health Facilities and Services Review Board by the end of March with approval for the new facility anticipated by the end of 2024. A tentative opening date is expected in late 2027.

This is a multi-year plan centered on the following future-state services.

OSF Saint Elizabeth – Ottawa Campus

The new hospital will be designed with the patient at the center of the care model. OSF Saint Elizabeth-Ottawa will have a 26-bed inpatient behavioral health unit, 12 medical/surgical beds, and a state-of-the-art surgery suite, emergency services, diagnostic imaging, and ro-

bust outpatient care services. Primary and specialty care clinics, including cardiovascular care, general surgery and OB/GYN, will continue to provide services in Ottawa.

OSF is committed to growing and expanding cancer care through the Fox River Cancer Center as part of the continuum/network with the OSF Cancer Institute in Peoria and the Patricia D. Pepe Center for Cancer Care at OSF Saint Anthony Medical Center in Rockford. In addition, rehab services will be moving to the newly constructed YMCA this spring.

OSF Saint Elizabeth – Peru Campus

Due to its central location, OSF Saint Elizabeth-Peru will serve as the hub hospital within the I-80 corridor and support a full range of inpatient and outpatient services. This includes 45 medical/surgical beds, 8 ICU rooms, 11 obstetric rooms to support the regional birthing center, surgery and procedure rooms, emergency services, diagnostic imaging and robust outpatient care services.

In addition to these changes, OSF HealthCare serves residents of Mendota, Princeton, Streator, Marseilles, Spring Valley, Oglesby, Granville and Henry with a wide variety of services. "Care has advanced from traditional inpatient settings to outpatient services. These advances in medicine allow patients today to receive more efficient and effective care than previous generations experienced," says Dawn Trompeter, president of OSF HealthCare Saint Elizabeth Medical Center. 

Allensworth didn't think her trip to Les Apres, France was realistic for her. But between Stewart and Lopez, she gained the confidence and courage to say yes.

"Our teacher, Alisa Stewart, hounded us to go. When I heard Rosalinda was interested, I thought, 'Well, at least I wouldn't be the only one leaving.' I was nervous to be the only one out of the country, but we're going at the same time," Allensworth said. It's easier knowing someone else is going, too.

"I've been obsessed with Paris. Talking to the family in France, they said we could stay a night in Paris. I'm excited. It's so wild. It's going to happen. I can't even remember how long I've wanted to go to Paris because it has always been a thing. I have a room that has Paris stuff all over it.

"One year for Christmas, every gift was Paris themed. My dad, my grandma, and my grandpa were over there for the military. They always talk about it. Now I get a chance to go."

Les Apres is two hours west of Paris and one hour away from the beaches.

To say she wants to see and experience everything is an understatement.

"The people are so nice, genuine, and welcoming. When I talked to them, it wasn't awkward," said Allensworth, who is exchanging with a French student named Anais. "They made it fun and a cool family. I think the beaches will look like our beaches. I'm excited to try macaroons and croissants in France. Those

are my favorite foods and to actually try them where they were originated is exciting.

"I'm excited to hear people talk in a different language and not know what they're saying. I am trying to learn French on my phone but I'm bad about learning other languages. I'm hoping being surrounded by it will help me."

The MHS sophomores may say Stewart hounded them, but to her she just pushed an opportunity they won't always have the chance to take. After this summer Lopez

and Allensworth will both be able to say they went to countries they've dreamt about going to. "This year, a lot of the

MENDOTA - The Mendota Police Department would like to remind home and business owners of city ordinances regarding public nuisances.



IVCC, SIU form agreement

CARBONDALE — Southern Illinois University Carbondale strengthened its commitment to students in northern Illinois with an agreement to bring the expertise of a doctoral research university to qualified Illinois Valley Community College students by providing the option to earn their bachelor's degrees remotely and at a lower cost in 12 academic programs.

SIU Carbondale Chancellor Austin A. Lane and Illinois Valley Community College (IVCC) President Tracy Morris signed the agreement for the Saluki Step Ahead program today (May 8) during a virtual ceremony.

Established in 2021, the program enables students who graduate with an associate degree from partnering community colleges to complete their SIU bachelor's degrees online in accounting, business administration, criminology and criminal justice, early childhood, elementary education, health care management, history, industrial management and applied engineering, information technology, nursing (RN to BSN), psychology and radiologic sciences.

"We are pleased to collaborate with Illianother option for place-bound students in this region," Lane said. "If these students cannot come to Carbondale to complete their education, we will bring the experience and resources of a doctoral research university to them.'

Lane added that this Saluki Step Ahead agreement fits well with the university's strategic plan, Imagine 2030, and its pillars of student success and partnerships.

IVCC's roots go back to 1924 as the second oldest community college in the state. Today, IVCC has 21 associate degree programs, 59 certificate programs and four transfer degree options.

IVCC's district is more than 2,000 square

miles and encompasses all of Putnam County, a majority of La Salle and Bureau counties, and portions of DeKalb, Grundy, Lee, Livingston and Marshall counties. About 145,000 residents live in the college district. The college's enrollment for the spring 2024 semester is nearly 3,700 students, with 70% enrolled in for-credit "This is such a great opportunity for our

students to complete their baccalaureate degree completely online — and for our community, this will create even more access to bachelor's degrees," Morris said. Jim Moskalewicz, an IVCC counselor,

added that Saluki Step Ahead "offers discounted options for place-bound students seeking a high-quality online baccalaureate

The Illinois Valley Community College agreement brings SIU Carbondale to about 50 Saluki Step Ahead partnerships the university has with community college campuses in Illinois, Kentucky, Missouri, Tennessee and Texas so far. That includes pacts with 43 of the 48 community colleges in Illinois.

Students in the Saluki Step Ahead program pay the community college rate for their first two years. In the third and fourth years, they receive annual \$4,000

The teacher shortage is real

I have been fortunate to spend 22 years in the school human resources role. More recently, I have also been working as the executive director of the Illinois Association of School Personnel Administrators (IASPA) representing more than 560 educational human resources professionals in Illinois. We are here to tell you: The teacher shortage is real.

At the start of my career, it was so easy to find teachers in some areas (looking at you, high school English and PE) that filling vacancies was not a worry. The landscape has completely changed. Join any group of educational human resources folks, and you will hear us worrying about staffing shortages. We search high and low to find qualified candidates for all our positions - traveling to job fairs and posting our jobs on sites far and wide. While some districts are struggling to find a single, great candidate for a position, other districts are forced to go without. Whether it is an elementary art position or a high school science position, there are classrooms in Illinois where students do not have the benefit of a qualified teacher ... all year long.

The statistics are alarming. According to the National Center for Education Statistics, 53% of public schools reported being understaffed entering the 2022-23 school year. Nearly 20% of teachers leave their positions within the first three years, and approximately 40-50% leave within the first five years (NCES). This turnover not only disrupts continuity in classrooms but also places a significant strain on school resources as we continue to invest in recruitment and retention of new talent.

Furthermore, we know the pandemic exacerbated this issue. The challenges of remote learning, concerns about health and safety, and the overall stress of the past couple of years have driven even more teachers out of the profession. How could this not impact students decision to go into the field of education? It's no wonder that enrollment in teacher preparation programs has been declining steadily, indicating a shrinking pipeline of new educators entering the field.

As educational leaders, it is our responsibility to address these systemic issues and create an environment where teachers feel respected, valued, and adequately compensated for their contributions. This requires a multi-faceted approach that encompasses policy reforms, increased investment in education, and innovative strategies to attract and retain educators.

This year's Illinois Association of Regional Superintendents of Schools (IARSS) survey on the teacher shortage indicates that while schools are making encouraging progress in filling classrooms, more work needs to be done.

IASPA is working hard to be part of the solution.

We routinely offer professional learning to help combat the teacher shortage. This year's annual conference in January included six breakout sessions related to hiring, retention, the educator pipeline, student teachers, and creating pathways to teaching.

Our April 26 online Administrator Academy, Managing Bias In Hiring-Inclusive Hiring Practices, aimed to ensure that hiring administrators are trained to manage a fair and equitable hiring process. Since 2022, IASPA has hosted the Illinois Virtual

Educator Job Fair, an opportunity for school districts and candidates to connect in a synchronous, online fashion without needing to be out of the office or incur the expenses of travel. Our March 6, 2024, job fair included more than 1,200 candidates! The next is scheduled for June 6, 2024.

The teacher shortage is a complex issue that requires a concerted effort from all stakeholders. By investing in our teachers and administrators, supporting their professional growth, and advocating for policy reforms, we can build a stronger future for all kids in Illinois.



Dewey's victory at Manila feted – 1899

Backtracks

(The following is from Jessica Nashold's Backtracks & Sidetracks column reprinted from May 26, 1999.) By Jessica Nashold

A hundred years ago this month, warfare in the Philippine, which had followed the Spanish-American War, was winding down. Commodore George Dewey was credited with victory in an engagement in Manila Bay and was rapidly elevated to the rank of admiral. On May 23, 1899, Admiral Dewey was resting in Hongkong following his departure from Manila. He expressed regret leaving Manila but said he "could not stand the care and responsibility much longer." In his words -

It is vastly easier to be under orders than to give them.

He stated that the United States must never sell the islands. With the insurrection broken he was confident a new era for the Philippines was about to begin.

British authorities in Hongkong honored Admiral Dewey at a reception "suitable to his rank" during his stay there. At the same time, final arrangements were being made for the homecoming of the volunteer troops, including 2,500 men who were sick.

A move to take up a public collection and buy a home for Admiral Dewey was declared unnecessary in the Mendota Sun-Bulletin. Dewey's income was over \$13,000 a year, he was a widower with a son taking care of himself. In fact, "if the American people have money to be given away they will find many poor and worthy people who are homeless.' This proved to be a minority view,

as money was raised nationwide by public subscription to present to the admiral with a house in Washington, D.C. On Nov. 9, 1899, a few days after he had moved into his new home, Admiral Dewey married Mrs. Mildred McLean Hazen, widow of General Wm. B. Hazen, chief signal officer of the United States.

Figures on relative casualties during nine months in the Philippines and nine days during the Civil War Battle of the Bull Run were published. Between Aug. 6, 1898, and May 1899, total loss was 1,885-223 killed in action, 60 dead of wounds, 308 dead of disease and 1,294 wounded. At Bull Run, during nine days, total casualties were 3,284 – Union men killed 481, wounded 1,011 Confederate killed 209, wounded 1,583.

Sunday, May 28, 1899, as well as on the official May 30. On Sunday morning, members of C.A. Andress Post 135 assembled at their hall on Sixth Street and attended services at the Presbyterian church in a body. That afternoon they attended a service in the YMCA rooms – again in a body.

On Memorial Day, most business houses closed during the afternoon. At 1:30, a parade formed at city hall and accompanied by the band marched to Restland Cemetery. Soldiers' graves were decorated and there were speeches by Mayor E.S. Browne and Dr. E.P. Cook. W.R. Foster, superintendent of East Mendota School, delivered Lincoln's Gettysburg Address. School children sang patriotic songs.

Soldiers of all wars of the Union were cordially invited.

Louis Waldorf announced plans to begin construction of a two-story building at the northwest corner of Illinois Avenue and Jefferson Street. The ground floor would accommodate two stores while the upper floor would be converted into office rooms. The Sun-Bulletin commented that when Mr. Waldorf started a thing he "sees it through."

He does not spare any pains to have it of the best, and made

Still known as the Waldorf building, it has provided quarters for a variety of businesses and professions during its one hundred years.

The Kreis grocery made news when bees were attracted to a display of honeycombs in their store. On a busy Saturday afternoon, there were thousands of bees flying among the customers doing their trading. When lights came on in the display window that evening, they flew in there and couldn't get out. Many were killed.

They carried away many pounds of honey.

Ex-mayor Matthiessen of LaSalle laid out golf links on his "private grounds" at Deer Park. The Sun-Bulletin reported that the whole town of LaSalle had "gone crazy" over the new pastime. However, after observing a game, editor Mark Ruggles made this assessment –

It is altogether too slow a game for Mendota.

Mendota milliner Mrs. R.M. Bailey featured sailor hats, a popular novelty, in her advertising. Sailor hats were of white straw with stiff crowns and narrow brims. The Sun-Bulletin was happy to furnish a cleaning hint for owners of sailor hats. "Get 5 cents worth of oxalic acid and with a small brush go carefully over the hat, then rinse off with cold water."

Be careful about the acid for it is deadly poison.

Andrew Carnegie retired from business to give away his fortune of \$200 million before his death.

Carnegie says it is a disgrace to

The Sun-Bulletin pointed out that Mendota had done much for its rich citizens and asked –

What have they done for Men-

About five years later some of the Carnegie dollars came to Mendota to build a new library in 1904.

The Mendota Fire Department ordered new uniforms from Karger's clothing store. It was the good quality of the material that appealed to the boys.

It led them to order the uniforms.

A train of 15 cars of horses, with six horses to each car, passed through Mendota enroute from California to New York. It traveled at passenger train speed. The horses were all owned by a man named Higgins.

Biden has disastrously misplayed the politics of Gaza

It's bad enough that President Joe Biden is playing politics with the war in Gaza, but even worse -- at least for his purposes -- that he is doing it so poorly.

The way Bill Clinton once put it in the aftermath of Sept. 11 is that "when people are insecure, they'd rather have somebody who is strong and wrong than someone who's weak and right."

Biden is weak and wrong, and he's not doing himself any favors.

First of all, he should want the war to end as quickly as possible. As long as it continues, he'll be caught in a crossfire on his own side between the pro-Hamas left and pro-Israel moderates. The easiest way to reduce the intensity around the issue would be for the war to end, but the administration's jawboning of Israel has stayed the hand of the Jewish state and prolonged this phase of the conflict.

Also, when presented with a choice between placating a fraction of public sentiment or siding with the majority, it's usually the smart play to go with the majority. Yet, Biden -desperate to stop his bleeding among young voters who are more pro-Palestinian than the rest of the electorate -- can't

It's true that young people look at the conflict differently

According to a New York Times survey of the swing states, voters ages 18-29 sympathize with the Palestinians over the Israelis, 44-to-23, while every other age group is with the Israelis, by increasingly lopsided numbers as they get older.

There's little doubt what the majority thinks, though. The latest Harvard-Harris poll found that people support Israel over Hamas by 80-to-20, and believe that Israel is trying to avoid civilian casualties in Gaza, 67-to-33. Even voters ages 18-24 support Israel in this survey, 57-to-43, and believe Israel is trying to minimize casualties, 64-to-36.

For all the turmoil over Gaza, it's not a top voting issue. Just 2% of voters say that the Israeli-Palestinian conflict will be the most important issue in deciding their vote in The New York Times poll, and 4% of voters ages 18-29. What Biden most needs is for people to think that he's a

moderate and a steady hand. The White House may tell itself that it's achieving that with a carefully managed, in-between position. But to nearly everyone else it looks like the president has gotten pushed by the left into flirting from being stalwartly pro-Israel to impeding its war effort.

In other words, in fishing for voters who are small in number and outside the mainstream, Biden has further discredited himself and his leadership with his equivocation.

Perhaps the most astonishing finding in the Times poll is that by 50% to 35%, more voters trust Trump than Biden to handle the Israeli-Palestinian conflict, and Trump leads on this question by a little bit more among voters ages 18-29, 52-to-28.

Trump, who managed to frighten our enemies with his hit against Qasem Soleimani, while also forging a breakthrough peace deal with the Abraham Accords, does indeed look like a giant of statesmanship compared with a Joe Biden whose war policy has been written on water.

Biden has shown that it's impossible to be all things to all people, but it is possible to convince most of them that you don't know what you're doing.

Water service line grant application in the works

SUBLETTE – The agenda for the Village of Sublette meeting on May 13 was both long and bold as the trustees had plenty to discuss and vote yay or nay.

One of the most pressing issues was a grant for the village's water service line.

"We had a big committee meeting with Matt Hanson from Willet & Hoffman Associates to talk about water service lines regulations and requirements the IEPA has really pushed," said Village of Sublette President John Stenzel. "Matt told us about a grant that will help us because we have 54 unknown service lines of material.

We're going to dig around each side of the shutoff terminal to determine what type of material was used. "At the meeting, it was

approved to begin writing the grant application. The grant could possibly be worth \$30,000. That's just the inventory where you determine what it is. Replacing it is a whole other objective. We have to determine if we have to replace it.

"As of right now, we don't

"As of right now, we don't believe we have to replace the water service lines, but we can't say it 100 percent without finding out."

The approval was for \$1,500 to be paid to Willett & Hoffman to gather and start the paperwork for the grant

writing process.

The grant is generally for Sublette in whole, but there will be a target zone on older downtown homes that may need updated, improved lines.

Appointments were approved for village positions to take effect May 1.





She served as dean of instruction at Spokane Community College in Washington and oversaw the career and technical division of Academic and Student Affairs at Lane Community College in Oregon.

"I feel I've been preparing for this job for a long time. I'm able to be a leader at the institutional level and the state and federal levels. I've been part of a lot of different types of activities, from curriculum development and strategic planning to budgeting," she said.

Dr. Trier said she was attracted to IVCC and the Illinois Valley. "I like the size of college, that it serves more than one community and that it is an integral part of those communities. Seeing that the president is an alumnus was very exciting!"

Dr. Trier said she is looking forward to meeting and learning from faculty, staff and students. "That's what gets me up every day – making sure students can accomplish their goals."

City Ordinance

MENDOTA – No person shall throw, place or leave, or cause or permit to be thrown, placed or left, any ashes, dirt, filth or rubbish, grass clippings, or foreign matter in or upon any street, alley or sidewalk of the City of Mendota.

Penalty: Any person violating this section shall be subject to the penalty of not less than \$50 nor more than \$500. Imposition of any penalty for a violation of this section shall not be construed as a waiver of the right of the City to collect the cost of removal of such nuisance where it is necessary for the City to remove such nuisance.

Reminder to start seeing bicyclists

MENDOTA - The Mendota Police Department urges motorists to pay attention, be alert for bikes and share the road. MPD urges bicyclists to be predictable and observe traffic laws. Your actions affect public opinion.

Illinois Bicycle Laws

Traffic laws apply to persons riding bicycles. Bicyclists riding on a highway are granted all of the rights and are subject to all of the duties applicable to the driver of a vehicle, with few exceptions.

Lane Positioning – When riding on roadways and bicycle paths at less than normal traffic speed, ride as close as practicable and safe to the right-hand curb or edge of the roadway, except, when overtaking and passing another bicycle or vehicle proceeding in the same direction, or, when preparing for a left turn, or, when reasonably necessary to avoid fixed or moving objects, parked or moving vehicles, bicycles, motorized pedal cycles,

pedestrians, animals and surface hazards.

Lights on Bicycles – For night riding, a front lamp with a white light visible from at least 500 feet to the front and a red reflector on the rear visible from 100 feet to 600 feet are required. A rear light visible from 500 feet may be used in addition to the red reflector.

Two or More on a Bike - Bicycles shall not be used to carry more persons at one time than the number for which it is designed and equipped, except that an adult rider may carry a child securely attached to his person in a backpack device or sling.

Parental Responsibility – The parent of any child and the guardian of any ward shall not authorize the child or ward to violate any of the provision of this code.

The Mendota Police Department encourages bicyclists to wear a helmet for protection against head injuries.

you been, who have you talked to, what's your best story or your favorite story, what gyms have you been in, have you been

to all of the Illinois tourist destinations, what do you eat on the road, where is your favorite place to eat on the road, and every what is your favorite question possible.

The No. 1 question I've been asked over my 20 years as a professional journalist is, "What is your favorite

At first it was a difficult question to answer.

I have covered a lot of cool, interesting, history-making worthy events such as a rally at the Illinois State Capitol Building in Springfield to fight the pulling of a college grant, St. Bede alumnus J.A. Happ pitching in MLB games (six different stories which took place in both Chicago ballparks, Detroit, and Milwaukee), state fairs, rodeos (including speaking to the at-the-time No. 1-ranked Professional Bull Riders cowboy), Naismith Basketball Hall of Fame member Walt "Clyde" Frazier donating to Southern Illinois University, Illinois Senator Sue Rezin and State Representative Lance Yednock taking a tour of the newly bought and renovated OSF hospital in Peru, DePue boat races, two NASCAR races at Joliet Speedway with interviews with Ross Kenseth, speaking with country music singers Drew Parker and Shane Profitt in Sublette during Hops and Harmony 2023, the 2018 Hall baseball team state championship (covered on radio and in print), met US Senator Dick Durbin at the Amboy Fire Department, and many, many, many more awesome events I'll write about in a book someday.

I left out some of the happenings early on in my career from the list (Rest in Peace Dan Callahan, former SIU baseball coach who helped me mature and make sure this was the career I wanted) as I thought about more recent memories. There are events that made the question a tough answer since year one of my career in 2005.

In 2014, the answer became easier when I covered my first IHSA State Track Meet.

Since the first weekend I witnessed the jaw-dropping track and field performances to a level I had never seen before, I've been hooked and have never changed the answer to what is my favorite event to cover whether sports, news or entertainment.

The answer has been and may forever be, the state

Let's just look at this year with Mendota freshman high jumper Mariyah Elam winning only the fourth female track state championship in school history following Tracy Stroyan (1982, discus) and Sherry Hoffman (1987, long jump; 1989, long jump).

Not only did she win but she impressed herself, her coaches, her teammates and her parents as she out leaped her 4-foot-11, fourth-place finish at last year's IESA State Track Meet to 5-4.5 to claim her gold medal in the high school ranks.

There were top marks, top athletic ability, top notch determination from athletes all over the state and definitely from the Illinois Valley.

It's like this every year.

I love basketball and football. Volleyball is awesome. Baseball and softball are cool. Soccer is alright. Tennis is OK.

I never thought I'd like covering or watching track, but it is at the top of the list, even surpassing hoops.

There is no greater feat than defeating opponents on a stage as big as the one at Eastern Illinois University in Charleston. All eyes are on you. All headlines are focused on what you do. All schedules are booked around you. All attention is on the athlete and what he or she does.

Can they rise to the occasion?

Will they fail?

The anticipation for a 50-second run or a 5-4.5 jump that took 10 seconds is incredibly intriguing, unique, and addictive.

Just ask every track athlete who has ever performed, it's highly addictive.

That's what La Salle-Peru alumna Rachel Hickey won the 800-meter run in 2016 and 2018 before a career at Illinois State University and Baylor University. The same goes for St. Bede graduate Bret Dannis when he won both the 300-meter and 100-meter hurdles in 2016 and the 110 hurdles in 2017 before hurdling for the University of Illinois.

Steven Brust, Anthony Buchanan, Devin Soldati, and Marshall Walk gasped the words, 'Man, that was awesome," after they won both the 400-meter and 800-meter relays in 2019.

And who knows who may be able to have the same thoughts and sentiments after this weekend's 2024 boys state meet.

Will the favored win?

Or will the lower expected reach higher like Amboy senior Elly Jones did this year in the 100-meter hurdles when she was seeded eighth but walked away from last weekend's state meet with a fourth-place medal.

What a great competitive environment. What a fun event to create headlines and story lines.

What an awesome, easy answer to the question, "What is your favorite event to cover?"

Simply the best!

MHS freshman Elam rises to state high jump title

CHARLESTON - Mariyah Elam has gone to new heights in a year. Literally.

The Mendota High School freshman began competing in the high jump for the Northbrook Mid-

dle School track team s e v e r a l years ago and was rewarded for her efforts by taking



fourth place in Class 8-3A at the IESA State Meet in 2023 with a leap of 4-11

Fast forward to just one year later. Elam began to open eyes this season for the MHS track team when she dramatically increased her height, going 5-6.25 to win and set a new Three Rivers Conference record in the conference meet in early May.

Elam continued her dominance over her opponents in the high jump over the next two weeks, culminating with a state championship leap at the IHSA Class 2A State Track & Field Meet held May 17-18 at Eastern Illinois University in Charleston.

Elam came into the state meet tied with a competitor from Macomb with the best jump among the Class 2A sectionals across the state. In

the state preliminaries, Elam and 12 other competitors cleared the bar at 5-0.25 to advance to the finals. Then in the finals, Elam topped out with a measurement of 5-4.5 to outleap second-place finisher Jaida Linn of Hillsboro, whose best effort came in at 5-3.25. "I feel great winning the

state championship. I was praying after every jump because it was really hot outside," said Elam. "All of the girls could barely hop over the bar. I couldn't clear the first attempt on my jumps. I kept praying and trying, and I was able to get over. I guess I needed a practice jump because it was a struggle in the heat.

"I felt like I deserved to win. I put in a lot of hard work. I put in a lot of practice. I practiced four times a week, two hours each time after school. We did a lot of fitness training. I worked with coach Joe Hughes and coach Patti Blumhorst. I felt privileged to have someone like coach Blumhorst to coach me since she has done the high jump.

"She was a big help at the state meet. She brought blankets for me to sit on and she brought an umbrella to shield me from the sun. You could tell she had been there before."

"I feel great winning the state championship. I was praying after every jump because it was really hot outside. I felt like I deserved to win. I put in a lot of hard work. I put in a lot of practice." -MHS's Mariyah Elam

MHS head coach Joe Hughes said it has been outstanding to see the progress Elam has made from the start of practice in March up until her high jump state title just two months later. "Mariyah has been able

to exceed ours and even her own expectations in high jump this year," said Hughes. "The two biggest factors that have helped her this season are her teammates and our new assistant coach, Patti Blumhorst. Coach Blumhorst has a long history of being an incredible high jumper herself and has been able to tweak and improve some things with Mariyah from over the bar.

"The other thing that has helped Mariyah has been her team as a whole. Everyone on the team does an excellent job of encouraging each other and pushing each other to do their best each and every day. This type of family-like environment has relaxed everyone to continue to grow and improve in their events."

With her best jump being 4-11 last year, Elam has surprised herself with the great strides she has made in the event in her first year of high school.

"I had to work a lot harder because of the competition," added Elam. "Last year, I couldn't make it past 4-foot-11. This year my best was 5-foot-7. That was a pretty big, good jump. That's thanks to Coach Blumhorst fixing up my form and my pivot on my jumps."

Elam was kept busy at the state meet, competing in two other events. She finished in ninth place in the 100-meter hurdles with a time of 15.91, while she was 20th in the triple jump with a distance of 34-0.75.

"I want to jump higher next year." she said. "I want to also get better and win a state championship in hurdles. I'm going to work hard to try to return to state in all three events - high jump, hurdles, and triple jump for the next three years."

Carlos earns bid to state track meet

"The greatest thing about the state meet was these four are not from the same friend groups, but they came together and supported each other," noted Friedlein. "I think the fact they did so well was because they had each other cheering them on and there for them.

'I'd love to say it was because us coaches were there, but it was just that group of people keeping their minds light and calm. It was an all-around great weekend for them and created tons of great memories for them.'



would be nice if this were true, but in this world, we WILL have trials and tribulations. The good news is we can cheer up anyway because Jesus has overcome the world.

In John 16:33 (ESV), Jesus says, "...In the world you will have tribulation. But take heart; I have overcome the world."

No one can promise you a problem-free life, but God promises that if you will put your trust in Him, He will give you a faith that enables you to rise above the problems you face. And when you get through them, you'll be stronger on the other side than you were before you had them.

Romans 8:37 (AMP) says: "Yet in all these things we are more than conquerors and gain an overwhelming victory through Him who loved us [so much that He died for us]." Ilove this phrase "more than conquerors." But what does it really mean?

Being more than a conqueror means that before you ever have a problem, you are confident that you have whatever it takes to overcome it through your relationship with Christ. In other words, you know you have the victory before you ever

Now, in order to "qualify" for the power of God, we must first come to the place where we recognize that in and of ourselves, we are weak and we have limitations without God. The best thing we can do to live this life in victory is to continually seek God with our whole heart, realizing we're desperate for Him all the time. Spend time with Him in prayer and studying His Word every day. Then, when the storms of life happen, you will be confident that in Christ, you already have everything you need to overcome them...and you'll

experience the power of His resurrection as you rise above them!




