EPA grant, Black Bros. help City of Mendota, Reimagine Mendota move forward with project

□ 800 block of Main & Illinois planned for demo, remediation, pavilion

MENDOTA – wednesday, June 12 will go down as a day of reshaping, renovating, and progress for the City of Mendota, Reimagine Mendota, Black Bros., and the citizens of Mendota.

In a press conference on the 800 block of Main Street and Illinois Avenue, it was announced a U.S. EPA Brownfields Cleanup Grant was received for \$1,270,305 to help fund the demolition of the former Car Quest Auto Parts store and the remediation cleanup of the former Campbell Cleaners property.

The giving tree spread more limbs when Black Bros. announced it will match donations, dollar for dollar, up to \$100,000.

Reimagine Mendota, a group created in 2018 to help revitalize the city, stated what is in the works for the property after the cleanup. A pavilion, a band shelter, or an outdoor space for community gatherings are in the plans.

Mendota City Clerk and Economic Development Director Emily McConville caught up the approximately 50 people in attendance (citizens, media members, Reimagine Mendota members) the timeline of the property.

"This started in 2005 when Phase 1 was completed on the Campbell's dry cleaning lot. The results were what we expected," McConville said at the press conference.



"When dry cleaning facilities were first constructed, they were not aware the chemicals they used would contaminate the ground if it leeched to the ground. The assessment we did in 2005 showed in all likelihood, it was contaminated.

"Fast forward 15 years and we knew it was time to tackle the project. The scope of the project has changed since 2019. We thought we would tear down an unsafe building, take out some dirt, put some more dirt back in, and possibly split the lot between the adjoining neighbors. Not so simple. The roof started collapsing on the original building. We realized it was a safety hazard and we had it demolished in early 2020. We completed the environmental assessments and at that point, it was suggested to apply for the EPA Brownsfields Cleanup Grant.

"Not only was the building contaminated, but the building to the north that we're standing in front of, was built over a tank that we didn't know was there. The tank needs to come out. There were a couple of ways we could have saved the building, but they would have been very expensive. We decided to obtain the building, demolish the building, and remediate the sight properly.

City Council gets ball rolling on summer street maintenance program

Staff writer MENDOTA - The Mendota City Council approved several donation requests and got the ball rolling on the annual street maintenance program at its June 17

regular meeting. Alderman John Holland informed the council of two donation requests - one from the Mendota Area Chamber of Commerce and the other from Mendota Area Senior Services. The council agreed to donate \$7,500 to the Chamber for the annual fireworks celebration scheduled for Saturday, June 29 at Lake Mendota Park. The

council followed that up with a donation to MASS in the amount of \$6,000.

Alderman Jim Fitzpatrick's report included two resolutions to kick off the street maintenance program for 2024. The council approved a resolution for the annual Motor Fuel Tax street maintenance program, appropriating \$120,000 for the work. It also approved the annual Rebuild Illinois street maintenance program, which is a combination of the MFT and Rebuild Illinois programs. A total of \$100,000 was designated for the MFT portion and \$216,000 was targeted for the Rebuild Illinois program.

In other items from Fitzpatrick's report, the council agreed to a resolution for the annual street closures for this year's Sweet Corn Festival as required by the Illinois Department of Transportation. He also announced that the work being done at the intersection of Pennsylvania Avenue and Chicago Street should be completed on Friday, June 21, with that area reopened to traffic at that time.

Alderwoman Vicki Johnson thanked the community and everyone involved in Reimagine Mendota's successful music concert event held June 15 at the Mendota Civic Center.

During Mayor David Boelk's report, the council confirmed the appointment of Tyler Kent as interim police chief of the Mendota Police Department.

The next regular meeting of the Mendota City Council will be Monday, July 1 at 5:30 p.m.

Naturally, that took time, and after nearly a decade from when the school opened, the funding for all outdoor playing facilities was secured and fields were built so all MHS sporting events could be held at the high school. IDPH urges education on ticks, Lyme disease protection

CHICAGO – With weather warming up, the Illinois Department of Public Health (IDPH) is urging the public to get educated about how to protect themselves from ticks and Lyme disease – an infection that sickens an estimated 500,000 people each year in the United States - at the start of National Lyme Disease Awareness Month.

"Lyme disease is an infection that individuals can get from the bite of infected ticks – and it is the most common vector-borne illness in the United States with more than 500,000 people diagnosed and treated each year," said IDPH Director Dr. Sameer Vohra. "With tick season beginning here in Illinois, I encourage our residents to learn how you can Fight the Bite and protect yourself and your loved ones from tickborne illnesses. If you do find yourself with Lyme disease symptoms – fever, fatigue, headache, and a circular rash – see your health care provider immediately to prevent serious illness."

IDPH has created a fact sheet and Tick Defense Knowledge Check crossword puzzle that make it fun to learn about how to protect yourself and your loved ones from tickborne illnesses.

Director Vohra said the most important thing people can do to "Fight the Bite" is to diligently check themselves, their pets, and children for ticks after spending time in areas where ticks live, such as in and near wooded areas, tall grass, and brush. Removing ticks within a 24-hour period reduces the risk of potential disease transmission.

In addition to Lyme disease, other serious tickborne diseases include Rocky Mountain Spotted Fever, Tularemia, Ehrlichiosis, and Babesiosis. Some tickborne illnesses can be life threatening. Rocky Mountain Spotted Fever is particularly dangerous and may cause death as quickly as five days after symptom onset.

If you become ill with fever and/or rash after being in an area where ticks may have been, contact your health care provider immediately. IDPH has teamed up with the with the Illinois Natural History Survey to create an interactive Tick Surveillance Map that documents the counties in Illinois where the different tick species have been confirmed as well as the diseases they may carry.

State public health officials note that Illinoisans who are travelling out of state should be aware that there is a much higher prevalence of Lyme disease in certain geographic areas, including Wisconsin, Minnesota and parts of Michigan, and across the northeastern United States.

Following are additional tips for how to avoid tickborne illnesses and have a healthy time in the outdoors:

• Walk in the center of trails. Avoid wooded, bushy areas with high grass and leaf litter.

• Wear light-colored clothing to make ticks easier to find. Tuck long pants into socks and boots.

•Apply an EPA-registered insect repellent containing 20% DEET, picaridin, IR3535, or Oil of Lemon Eucalyptus according to label directions. The EPA has a search tool that can help you find the product that best suits your needs.

• Conduct full-body tick checks on family members (underarms, ears, belly button, behind knees, between legs, waist, hair and scalp) every two to three hours. Also check any gear or pets taken on outings.

• Put your clothes in the dryer on high for 10 minutes (or one hour for damp clothes) to kill ticks.

• Bathe or shower within two hours after coming indoors.

• If you find a black legged tick on you that may have been attached for more than three days, then seek medical attention to decide if you need an antibiotic to prevent Lyme disease.

• It is often helpful to keep the tick for species identification. Place the tick in rubbing alcohol or in a sealed bag/container to bring to your healthcare provider or local health department for submission to IDPH.

IVCC EMS graduates issued Challenge Coin

OGLESBY – Some of Nick Fish's memories as an active emergency responder still take his breath away. So, on top of preparing his Illinois Valley Community College students to save others, he wanted to offer them first aid for themselves.

After his Emergency Medical Services students completed their final handson clinical exam this spring, he gave each of them a badge of identity, unity and achievement called a Challenge Coin. The tradition originated in the military commemorating shared service, commitment and camaraderie and has been adopted by U.S. Presidents, emergency responders and businesses.

IVCC's brass Challenge Coin resembles others in that one side features the emergency services program and the IVCC shield. But the flip side strays from tradition – it contains a phone number, a name and the invitation, "Sometimes you just gotta talk."

Fish hopes the coin prompts conversations among crisis responders, reminds them to take care of their own mental health and supplies them with a resource to talk to, anonymously.

In the classroom, Fish relives his own active-duty experiences as he relates examples to students. "There have been times when I've had to pause the class and take a moment to gather my thoughts and deal with it -again. I worry about that with our students," some of whom are just out of high school with little to brace them for the impact of what they'll encounter in their careers. Still others are volunteers in their units.

Daily trauma and stress can lead to mental health issues and burnout, aggravating a workforce already stretched thin by staff shortages. Classroom training concentrates on life-saving techniques for the moment rather than resiliency or coping skills for the aftermath, Fish said.

"We focus so much on providing care for everyone else we forget to take care of ourselves," he added. He wants to banish the stigma that admission demeans the individual or dishonors the profession.

Decades ago, Dave Van Laar was an active duty EMT and firefighter who struggled. Now, as the LaSalle County Sheriff's Department chaplain, he administers aid and comfort instead of CPR.

His latest role found him again at accident and

fire scenes, watching crews battle inner demons after fires and road accidents. He had created tokens with his contact information, but after meeting Fish through presentations and activities, the two determined to produce a Challenge Coin jointly.

"Responders ... We're expected to fix it and walk away. We respond, clean up and go away. Some things you can't fix," said Van Laar. He's also known as "Chappie," which is the

contact that appears on the coin. The chaplain title isn't spiritual., he said. "No other title fits. Right now, crisis counselor, that's what I do. A lot of it is just listening and referring people to other help. Just talking through something can be helpful -- just being there in those tough situations." Van Laar knows at least one deputy who has collected 40 or 50 Challenge Coins. Besides being a lifeline to help, he and Fish envision the IVCC coins reinforcing fellowship and alliance, becoming talismans, keepsakes, prized possessions – and reminders of that important peer support.

"Talking is a form of therapy. It's important to be able to sit together after a call and to be OK with saying 'That messed with me." Fish said.

"We don't control the outcomes," Van Laar said. "I try to help first-responders understand their emotions are normal, they happen. It's OK to have those emotions but to realize we can get through them.

"That's something I didn't have 40 years ago."

of the Trojans,' is a lasting testament to the collective efforts and unwavering support of so many people.

"It has been my privilege to work for and with so many outstanding individuals. This dedication means the world to me as it underscores the values of perseverance, teamwork and dedication that Mendota is known for."

Dr. Denise Aughenbaugh, who succeeded Prusator as superintendent, said it is with great pride that the Board of Education has named the MHS athletic complex after the long-time MHS administrator.

"Jeff served Mendota High School from 1996 to 2023, and he was instrumental in overseeing the construction of the complete athletic complex at the new high school," said Aughenbaugh. "His vision was to provide the opportunity for students to participate in baseball, softball, tennis, soccer, track and football events on the MHS grounds.

"There is nothing better than walking across 'The Jeff Prusator Athletic Complex' on a warm spring day to view the competition of home baseball, softball, tennis and soccer games. We are appreciative of the beautiful athletic complex and the hard work and dedication of Superintendent Prusator and the Boards of Education in making this dream a reality."

When the new high school opened in 2003, the district had limited funds for capital projects available because all capital project money was used for the new building. The district also had maximized its bonding authority with the referendum to build the new school.

The district made the commitment to build the athletic facilities on-site as money became available. Completion of the soccer, baseball and softball fields, and the tennis courts, was made with available funds within the building and capital project funds, and the district's maintenance staff provided a majority of the labor.

"It was a slow process and we did what we could when we could," noted Prusator. "The Board was dedicated to building the best facilities we could when the time was right."

In the mid-2000s, the city of Mendota wanted to extend the TIF I District. The mayor and city council negotiated a very fair TIF agreement with the high school, according to Prusator. TIF funds from the city can only be used for capital improvement projects, and with the amount of money the district would receive yearly from the TIF payments, it was enough for the district to issue a \$2 million alternate revenue bond to fund most of the stadium project.

'The administration and Board had many discussions on the best use of these TIF funds," Prusator said. "We felt that utilizing them to build a beautiful athletic stadium was a one-time opportunity and we would never again be presented with an opportunity to build this stadium without raising the tax rate."

One hundred percent of the alternate revenue bond was funded with TIF I money and the tax rate was never

impacted. The Board was dedicated to completing the high school project by having all athletic facilities on site.

Prusator explained that during the planning process, it became evident that the TIF funds would allow the district to build a stadium that its students, parents and community could be proud of and would be one of the nicest stadiums in the area. He said the completion of the stadium was an impressive example of what can be accomplished when everyone has a common goal and the support of the community.

"I believe when the project was completed, we all felt a strong sense of pride and were proud of what a beautiful stadium that our students, parents and community get to call home for decades and decades to come," said Prusator.

"Thank you for everyone who has supported me during my time at MHS," added Prusator. "The belief and confidence that the Boards of Education had in me served as a constant motivation for me to do the best I could for this school and our community.

"I feel blessed that I was able to spend my entire administrative career working with great students, incredible and dedicated staff, supportive Boards of Education and a wonderful community.'

This is the first naming of any athletic area at the high school. The Waldorf Agriculture Building is the only other named facility. The naming of the athletic complex does not prohibit the future naming of fields and stadium at MHS.

"After several rounds of negotiating, we obtained the property in December 2022, but it was too late to apply for funding in 2023. It's probably a good thing because we had the fire on this block in August 2022, followed by fire No. 2 on Illinois Avenue in December. It led to the three remaining buildings having to be demolished."

The EPA grant application was submitted in November of 2023 and McConville received the phone call from EPA with the news of the grant acceptance in May.

"Those calls are usually not good news. I think the representative sensed it because the first thing he said was, 'This is good news.' He told me we had received the grant," McConville said. "I can't tell you how happy I am and relieved that I am to be able to give a definite answer when someone asks me, 'What are you going to do with this block?' I'm happy to say, funding will most likely be available this fall, demolition of the building will happen immediately after, engineers will finalize remediation plans, and the plans will go out for bid. The contract will be awarded, remediation will start as soon as they can mobilize, and once complete, we'll see the result will be an open space in the heart of our downtown."

A pavilion, band shelter, or some kind of outdoor space for citizens to gather was suggested highly by the over 1,700 Mendota residents who answered Reimagine Mendota surveys through the process of the Heart & Soul Grant Program over the last year.

Sally Corrigan, newly named president of Reimagine, spoke on what the project means to the city.

"We're excited Mendota has received the Brownsfields grant to assist with demolition, remediation, and to fund the planning for the space," Corrigan said. "We recognize the cleanup is going to take roughly two years. This gives Reimagine Mendota time to work on

Push for recreational field – 1947

(The following is from Jessica Nashold's Backtracks & Sidetracks column reprinted from June 18, 1997.) **By Jessica Nashold**

On the 16th of June in 1947, 50 years ago, the city council was visited by a delegation of Mendota's sportsminded citizens. Spokesmen were Russell Brecht and Marty Masear. They wanted to see a "recreational field" with a baseball diamond in Mendota.

Mayor Glenn Momeny said such a field was a possibility but thus far interested groups had not organized teams and worked out a plan. William Marmion, son-in-law of William "Doc" Wagner, said Wagner was offering a field east of Kakusha Park as a site for a ball diamond. The city was being requested to grade and roll the field.

No elaborate construction was required and no lights. The question was – Are you or are you not going to

do something about it?

The council expressed willingness to cooperate and referred the matter to the park committee with power to act. Work went forward the following week with city workers aided by volunteers.

City works had also been busy that week drilling holes in downtown sidewalks to accommodate steel posts for parking meters. Karpark Automatic Meters had been selected. They required no manual operation. Coins could be inserted – 1 cent for 12 minutes, an additional cent for each additional 12 minutes, and a nickel (or five pennies) for an hour.



A Boy Scout Camporee was held June 12-13, 1947, at Lake Mendota. Scouts from Mendota, LaMoille and Triumph took part. Tents were pitched and meals cooked by the boys. Experts demonstrated various skills. Jack Tower received his Eagle badge.

Chief Walks With the Wind and his son, White Beaver, presented Indian dances and ceremonies, inviting a few of the scouts to join in.

The boys left the park in even better condition than they found it.

Midget car races drew a large crowd to the Tri-County Fairgrounds on June 12, 1947. The lighting was praised.

The track area is as light as day with no shadow or dark spots.

*** Motorcycle races sponsored by the Bureau Valley Motorcycle Club were held June 22, 1947, also at the Tri-CountyFairgrounds.HaroldWendel

was club president. Prize money of \$600 will be divided among the winners.

The Rev. A.J. Becker celebrated his First Solemn High Mass in St. Patrick's Church, Amboy, on June 10, 1947. He has been ordained June 1 at Pontifical College Josephinum in Worthington, Ohio. house on June 17, 1947. The county Home Bureau adviser, Miss Eureath Freuermuth, gave the lesson: "Illinois Health Laws as they pertain to the homemaker." Eighty-five ladies from Dimmick, Troy Grove, Earlville and Mendota were present.

The public was informed that until further notice there would be no window service at the post office on Thursday afternoon. The lobby would remain open.

Dr. W.E. McLaughlin, who had opened a dental office in Mendota, was able to locate a house on 10th Avenue. He was bringing his family from Chicago.

At a city council meeting on June 16, 1947, city physician Dr. R.H. Musick, reported that an outhouse on Fourth Avenue was unsanitary and should be removed. Since the property was in an estate, the attorney was notified to remove the outdoor accommodations and have the opening filled within 10 days. Within 30 days, an indoor toilet would have to be installed.

E.A. Lorack opened a Chevrolet garage in the Engel building on West Washington Street.

Deliveries are slow, due to a shortage of steel and other conditions.

Emery E. Johnson was appointed assistant general manager and manufacturing manager of the H.D. Hume Co.

We legally have to wear seat belts as a passenger in a car. People still die in car accidents. I've seen a video where someone was almost decapitated because of wearing a seat belt.

Motorcyclists in certain states, not Illinois, legally have to wear helmets. Riders still die in accidents.

In some instances, hopefully more than not, the safety precautions or amended laws are useful and do what they're supposed to do, but there isn't a 100 percent rate on any of them. Things still happen.

What is the big difference between a driver's license or a state ID and a Real ID. A star? The fact you have to use a birth certificate to obtain the Real ID?

I bet if someone wanted a fake Real ID they could create a fake birth certificate. The same way people have created fake driver's license and any other identification card or paperwork that has been illegally created before.

If a Real ID is so important, why was it created four years after the event it was created for? Why is the deadline for the Real ID to come into effect in 2025? I don't math the greatest, but that is 24 years after 9-11 and 20 years after the act was acted.

The answer is easy, it's not important.

It's just another made up, created out of angst or panic idea that we could do without. Instead of doing without, it's put into existence, and we're forced to move with the hoops of the Illinois Secretary of State's office, dig up paperwork and documents, take time out of our day or week, sit in lines at a DMV with office members who don't want to make the cards, spend money, and pretend having a Real ID is protecting our lives.

The war on contraception that wasn't

We don't know who they are or where they are. All we know is that some place or other, a shadowy group of powerful Republicans is meeting to figure out how to ban contraceptives.

For all we know, they also might be scheming to cover up what really happened at Area 51 and to obscure the identity of the real assassin of JFK.

If the Bilderbergers aren't involved, they should be. The Democratic charge that Republicans are somehow working to cut off access to contraception is so ludicrously unfounded that it amounts to an outlandish conspiracy theory. Yet this allegation undergirds the Democratic effort to pass a sweeping new "Right to Contraception Act" through Congress.

Sure, contraception is already legal in every state and no one is trying to ban it, but you can't be too careful. The contraception act is supposedly a -- ahem -- prophylactic measure.

The political play clearly is to offer legislation with numerous provisions that Republicans can't support and then when they vote against it, as all but two Republicans did in the Senate, to say: "See? We told you so. Republicans hate contraception so much that they blocked the 'Right to Contraception Act.'"

The Democratic maneuver generated the desired headlines all over the media about Republicans opposing a bill to protect contraception.

A key piece of the Democratic fear-mongering is that Justice Clarence Thomas said in his concurring opinion in Dobbs that Griswold v. Connecticut, which established the constitutional right to contraception, should be overturned. This doesn't mean that Thomas himself is hostile to contraception or supports bans of it -- only that he thinks Griswold is constitutionally defective.

It's an enormous leap to go from this stray remark to any serious threat to contraception. For the Thomas view to be effected in the real world, the Supreme Court would have to take up a landmark contraception case, which isn't in the offing; he'd have to get four other votes to overturn Griswold, when that isn't assured; and the justices would have to not find another constitutional source for a right to contraception, even though Thomas himself held that out as a possibility.

All that said, let's assume against all expectations that the Griswold decision is rendered a smoking ruin by Thomas and his colleagues sometime soon. Where in these United States would a serious Republican official propose to restore Connecticut's Comstock law that was at issue in that 1965 case and prohibit anyone from using "any drug, medicinal article or instrument for the purpose of preventing conception"?

Even if Republicans are quietly harboring an intention to do this, they'd be swiftly and decisively rebuked by voters if they ever tried to act on it, and that'd be the end of the war on contraception.

Again, though, all that is theoretical, not to say utterly fantastical. In reality, even the Trump administration spent roughly \$1.8 billion on domestic family planning in fiscal year 2020.

The source of the GOP opposition to the Democratic contraception legislation is sincere and doesn't reflect any secret agenda. Republicans consider the bill, correctly, a Trojan horse (no pun intended, really) for radical measures that couldn't pass on their own. The legislation would wipe away conscience protections, make it impossible to cut off contraception funding to organizations like Planned Parenthood that provide abortions, and define contraception so broadly that it could cover abortifacients.

With Senate Democrats desperate to make the most of their post-Dobbs political advantage on abortion and related issues, there's no room for good-faith objections. No, it's all demagogy, all the time. "Thanks to Donald Trump and the right-wing MAGA Supreme Court, Americans now have to question whether or not they'll have access to something as basic and widely supported as birth control," Democratic Majority Leader Chuck Schumer said.

Of course, they don't have to question any such thing, but Democrats want them to question it, based on innuendo and shoddy, politically motivated reasoning.

NCAT implementing additional route to its service

OTTAWA – North Central Area Transit (NCAT) is adding an additional route to improve access. Beginning July 1, NCAT will be providing service between Streator and the LaSalle-Peru area daily, which includes trips to Utica, Oglesby, Mendota and Spring Valley.

Currently, NCAT provides service between Streator and the L-P area on Tuesdays and Thursdays only. Expanding to five days a week will help serve IVCC students, individuals needing to see medical or dental specialists, and perhaps even open opportunities for employment.

"We're happy to help people get where they need or want to go, no matter where they are going," stated Kim Zimmerman, NCAT transit director.

Since NCAT will only be running one bus between the two locations, they ask riders to be patient as they may have to arrive earlier or be picked beginning of fall will have Hops & Harmony and Pullin' in the Park on September 7-8.



HOLLYWOOD -- Julia Louis-Dreyfus has recovered from cancer and is back in front of the cameras to shoot "Thunderbolts" for Disney and Marvel. She holds the record for winning 11 Emmy Awards (the most for any performer) -- nine for "Veep," one for "Seinfeld," and one for "The New Adventures of Old Christine." She's also won nine awards from the Screen Actors Guild, two from the Critics' Choice Awards, and a Golden Globe Award.



OGLESBY – Not many disc golf course designers can say they've been grounded by an eagle, but Wes Black can. And on his first course, too.

Disc golf courses have sprouted like mushrooms throughout the Illinois Valley, beckoning serious golfers and amateurs alike to Oglesby, Mendota, LaSalle, LaMoille, Streator, Peru, Princeton, or Ottawa. Black has had a hand in designing most of them in the last 15 years, and his name has become synonymous with the sport.

Black teaches math at Illinois Valley Community College, where he and faculty colleague Ryen Nagle and Nagle's dad, Dan, conceived the idea for a nine-hole IVCC course, which opened in 2010. Ryen had just introduced Black to the game, but the novice's passion quickly

The original design "took hours and hours of thought. And I don't know how many times I walked that site and thought about the flow,"Black said. Variety is the spice in disc golf, he added. Holes should demand long throws and short ones, breaks to the left and to the right, and be spaced so "you don't have to walk a long way to the next tee pad or to the basket or be throwing

But then one exceptional obstacle flew in. A bald eagle, which is also IVCC's beloved mascot, came home to roost in a nest just above Hole 1's basket. Soon after opening, the course shut down so the eagle - still an endangered species at the time-wouldn't be disturbed.

Actually, the raptor had done them a favor - sort of. The pause gave designers time to re-envision

the course, to what Black concedes is a better layout. Hole 1 was relocated just inside the entrance gate, tee pads were poured concrete and expanded, and Hole 5 became more challenging by setting the basket on a manmade hill.

Land availability, support and funding spurred the growth of disc golf courses in the Illinois Valley. Courses need about an acre per hole, and land must be cleared and prepared. Baskets can cost about \$400 each, tee pads as much as \$1,000. Public contributions and volunteers are pivotal to progress and completion.

The courses are free to play and there are no added fees like in ball golf. The unique settings and challenges appeal to players in the area and beyond seeking that low score or gravity-defying hole-in-one.

"People will drive well over an hour to play a course," says Black, who had recently spent two days playing over seven courses in the Quad Cities. "That's what people do, to see what this course or that course has that's different.'

Black estimates he's played more than 70 courses in a dozen different states - including Hawaii, where the vacationing Black found himself fending off banana plants and pineapple plants unlike any Midwest vegetation. There's even a tournament held inside a prison.

Anyone of any ability and age can play, which may help explain disc golf's popularity. On average, a new course opens every day somewhere in the United States, Black says. The sport has a pro circuit, dedicated media channels, and phone apps to share scores and observations.

Black has further ignited local interest through clinics he organizes for youth and adults.

Many local courses offer 18 holes of play. Some, like Streator's Marilla Park, which opened in 2012, feature giant tree obstacles, while others, like LaSalle's Rotary Park (2024) or Peru's Baker Lake (2018), present water hazards to delight and challenge a golfer. Several holes present golfers with two different tees to drive from.

Wind is a disc golfer's biggest headache. "You think you're throwing well and the wind takes it away. You throw into the wind and it just goes out like crazy and if you throw with the wind, it just pushes it to the ground," Black said. Golf discs are specially designed to battle the elements. Black carries as many as 20 discs and puts them in play as he needs to drive, to putt or to approach.

You'll likely find him at a course near you, facing down the challenges he created when he's not enjoying his other hobbies, such as ice climbing, running, kayaking and adventure racing. "I'm an outdoorsy guy," he says.



Alternatives to walking your dog in the summer

Walking your dog daily is an excellent activity for dogs and owners, alike, because it brings mental and physical stimulation to your pet and creates an unbreakable bond between you and your furry friend. However, as summer approaches and the temperature begins to rise, owners should be aware of the risks associated with walking pets in the heat.

Dr. Lori Teller, a clinical professor at the Texas A&M School of Veterinary Medicine & Biomedical Sciences, has some tips on identifying signs that it may be too hot to walk your pet and suggestions on ways to exercise them more safely on hot summer days.

Recognizing When It's 'Too Hot To Walk'


It is important to pay attention to your dog and know when it might be too hot to take them for a walk.

"When it is hot outside, many dogs can be adversely impacted and suffer from heat exhaustion or heat stroke," Teller said. "Dogs cannot sweat, and panting is not an effective mechanism for cooling off, so dogs do not have efficient ways of handling excessive heat."

Teller also said there is no specific temperature that is too hot for dogs.

"A good rule is to avoid the hottest times of the day in the summer and limit walks or runs to early morning or late evening times when the temperatures have dropped some," Teller said. "It may also be a good idea to consider booties to protect your dog's feet from the hot pavement."

In addition to being mindful of the time of day, owners should be extra cautious with both very young and older dogs as well as those with underlying medical conditions.



"Dogs with respiratory disease, heart disease, obesity and breeds with flat or smushed faces — such as pugs, boxers, bulldogs, Shih Tzus, and more — are more likely to be heat-intolerant, or sensitive to the warmer temperatures."

Another consideration for owners is how adjusted your dog is to the climate.

"Dogs that have recently relocated from cooler climates are also less likely to be acclimated to warmer temperatures," Teller said. **Identifying When A Pet**

Is Overheating

While prevention is the best way to keep pets safe from overheating, Teller said it is also important to know the signs that a dog is struggling with the soaring temperatures. This is especially true for owners who take summer road trips that include outdoor breaks for their pets or who experience an air conditioning outage in the summer months.

Some signs to look out for in case your pet becomes overheated include anxiousness or restlessness, excessive panting or drooling, vomiting or diarrhea, abnormal gum or tongue color, unsteadiness while walking, or collapsing.

"If your pet appears to be overheated, place some cool, wet towels around your pet and seek veterinary care immediately," Teller said. "Time is definitely of the essence."

Alternative Ways To Exercise Your Pet

While the heat may pose challenges for keeping your dog active, exercise is important year-round to keep dogs healthy.

"Exercise is a great way for more active dogs to burn off some energy, and it can help lessen anxiety in dogs that are stressed," Teller said. "It also promotes heart and joint health and helps with weight management. Just remember to consult with your veterinarian before beginning any exercise program to discuss what is most appropriate for your pet's current health status."


There are many alternatives to walks during the heat of the day that still get you and your pet outside of the house.

"Dog owners can explore indoor areas such as places to participate in flyball, agility or even doggy social events," Teller said. "Swimming or dock diving is also a great activity for dogs that enjoy water."

If leaving the house is not an ideal option, Teller recommends owners find opportunities to exercise their pet indoors.

"At home, people can make use of long hallways for a game of fetch or create a dog-safe obstacle course," Teller said. "Some dogs will chase a laser point, like those used for cats."

Finding ways to exercise your dog during the summer can be challenging, but mentally and physically stimulating our furry friends without the risks of heat exhaustion and heat stroke can be fun for the whole family. By planning ahead and finding alternatives to daily walks, you can keep your dog happy and healthy all summer long.

Signs your dog may be dehydrated

Water is essential for mammals' bodies to operate at peak capacity. The American Kennel Club says water is necessary to lubricate joints, facilitate digestion, regulate body temperature, and cushion internal organs, among many other functions. Similar to humans, pets that fail to consume enough water can face dire consequences.

Dehydration is a medical term for when the body has lost more fluid than it has taken in. Dehydration can occur at any time, but it is even more common during the warm weather months. Dogs quickly can become very sick from dehydration. That is why every pet owner should learn how to recognize the symptoms of dehydration in their dogs.

The Veterinary Emergency Group says symptoms of mild dehydration can include:
Dry nose, although this also can be a signal of other problems, like fever.
Excessive drooling occurs as the dog tries to cool down its body.

Understanding the season of summer sores in horses

With the notorious summer heat creeping back in, horse owners may begin to worry about the sores their equine friends can develop during the scorching season.

Dr. Dustin Major, a clinical assistant professor of large animal surgery at the Texas A&M School of Veterinary Medicine & Biomedical Sciences, offers insight for horse owners on summer sores and the potential parasitic harm they can bring to horses during the warmer months. Where things go awry is when the fly carrying the parasitic larvae is drawn to a moist membrane such as the eyes or an open wound; if a larva is dropped in one of these vulnerable areas, it can burrow into the horse in search of their intended tissue within them," Major said. "They tend to be mildly painful and can be extremely itchy, to the point that some horses will self-traumatize by rubbing the sore."

Major encourages owners to contact their veterinarian as soon as a sore appears to help determine if it is a summer sore or a symptom of a separate infection. "However, debridement, or removal of the infected tissue, is often necessary, in which case veterinary intervention would be indicated," Major explained.

Major also said it is crucial to keep your veterinarian updated on the horse's

The Site Of The Crime Cutaneous habronemiasis,

or summer sores, are the result of a parasitic infection that occurs when the life cycle of stomach worms — such as Habronema muscae, Habronema major, or Draschia megastoma — is disrupted.

In the typical life cycle, these worms harmlessly pass through the horse's digestive tract, and their eggs are excreted by the horse. After hatching into larvae, they are ingested by maggots within the manure. Once the maggot has matured into a fly, the parasite then uses the fly as a means of transportation, continuing the cycle as the larvae are dropped off into the mouth of the horse, making their way into the stomach where their life initially began.

— leaving the horse with a painful, itchy sore.

"It's important to understand that horses that develop summer sores do so because they have an increased inflammatory response to these larvae, so horses that are prone to making summer sores are more likely to experience this reaction," Major explained.

What To Look For

Sores that appear on a horse's eye, mouth corners, lips, sheath, urethra, or open wound are easily noticeable and unable to heal without veterinary care.

Major said it is easy to mistake summer sores for other infections, but they have one distinction — yellow spots known as sulfur granules. Sulfur granules appear as small, yellow, and hard particles within the granulation tissue of the ulcerated area.

"These wounds typically appear as round-to-irregular ulcerative sores with unhealthy-looking granulation

Prevention And Treatment

Summer sore prevention begins at the core of the issue — flies.

"Fly control is vital in the summer and key to preventing summer sores," Major said. "This can include barn sprayer systems, fly predators, feed-through products, picking feces out of stalls and paddocks, and using fly masks and fly sheets.

"Additionally, horses that are susceptible to the development of summer sores may benefit from additional deworming with an avermectin product (e.g., ivermectin) during fly season to limit the larvae within the horse and environment," he said.

Treatment typically includes the prescription of a steroid and triple antibiotic ointment for topical application, which can be used on early lesions. recovery, or lack thereof, to avoid prolonged treatment and further debilitation of the horse's health.

"When in doubt, it's much better to have the vet out early, because more complicated lesions can be difficult to clear up and often require multiple debridements, if not more significant surgical intervention," Major added.

With ample knowledge and the ability to correctly identify summer sores, horses can be treated at home when the festering sore is spotted early on by their vigilant owner. Ensuring your horse remains free of summer sores this season is key to a healthy and happy summer for all.

Sticky gums

As the dog becomes more dehydrated, the following symptoms can develop:

- Loss of elasticity of the skin.
- Loss of appetite.
- Thickening of the dog's saliva.
- · Gums may go from sticky to dry.
- Excessive panting may begin.
- Vomiting or diarrhea also may occur.

• Dehydration causes the body to redistribute fluid lost, and fluid may be pulled from the eyes, causing the eyes to appear sunken.

If a dog appears to be dehydrated, you can start offering small amounts of water to slowly rehydrate the animal, says Northeast Veterinary Referral Hospital. It's important to call the veterinarian and get further advice regarding how to address dehydration. Some vets may suggest offering an electrolyte-enhanced fluid like Pedialyte so electrolyte loss does not affect organs. The vet may want you to come into the office so the dog can receive intravenous fluids, says the American Kennel Club.

The best way to treat dehydration is to prevent it in the first place. Provide dogs with a constant supply of clean, clear water at all times. The amount of water needs to increase if the dog is spending time outdoors in hot weather or exercising.

Cats also are prone to dehydration and can exhibit the same symptoms as dogs. So cat owners also must be diligent in checking for dehydration symptoms in their pets.

Shot clock to be implemented in high school hoops in '26-27

35-second clock will be required for varsity boys & girls

BLOOMINGTON - The Illinois High School Association (IHSA) Board of Directors met for its regularly scheduled meeting at the IHSA office in Bloomington on June 10, where the Board made decisions on two state final sites and approved the addition of the shot clock in the sport of basketball beginning in 2026-27, while also adjusting the state final schedule for America's Original March Madness

Basketball

The IHSA Board of Directors approved two recommendations brought forth by the IHSA Basketball advisory committee.

A 35-second shot clock will be required for usage in varsity girls' and boys' basketball games beginning with the 2026-27 school year. Use of the shot clock for lower-level (freshman, sophomore, junior varsity) contests will be determined by conferences and via mutual agreement by competing teams in non-conference games.

'The IHSA has allowed the shot clock to be used in tournaments and shootouts the past two seasons, and the overwhelming feedback we have received from coaches is that it is time to embrace the shot clock in all varsity contests," said IHSA Executive Director Craig Anderson. "We believe the two-season lead time will provide our schools with ample opportunity to install the shot clocks and get comfortable with them from both a coaching and game administration perspective.'

Additionally, the committee recommended a new state final time schedule that will ensure a two-day experience for all participating teams.

"It's been fairly unanimous in the Illinois high school basketball community that moving the state tournament to a single-weekend format has been a success," said Anderson. "Our coaches believe this new schedule will



provide an even better experience for all the student-athletes, coaches, and fans. We look forward to seeing it play out when we celebrate America's Original March Madness next winter."

Bass Fishing

The IHSA Bass Fishing State Finals will be contested at Lake Shelbyville in Shelbyville beginning in 2025. The host bid was prepared and supported by Shelbyville High School, the city of Shelbyville, Lake Shelbyville, the U.S. Army Corps of Engineers who oversee Lake Shelbyville, and several local community chambers of commerce. The five-year hosting commitment will encompass the State Finals in 2025, 2026, 2027, 2028, and 2029.

The IHSA became the first high school state association in the country to hold a high school bass fishing state championship when the inaugural IHSA State Finals were held in 2009 at Lake Carlyle.

Girls' Flag Football

Willowbrook High School in Villa Park will serve as the host of the inaugural IHSA Girls' Flag Football State Finals in the fall of 2024. The three-year hosting contract will debut on Friday and Saturday, Oct. 18-19, and then return to Willowbrook High School for the 2025 and 2026 state finals.

In February, the IHSA announced at Halas Hall in Lake Forest that Girls Flag Football would become the 32nd sport to contest an IHSA State Series.


The following are six ways to stay properly hydrated to avoid adverse reactions during hot summer days.

1. Consume a glass of water when you wake up. Start the day off with some water to give you an energy

3. Certain foods are hydrating as well. Hydrating foods include cucumbers, celery, tomatoes, watermelon, strawberries, grapefruit, and peppers. The Mayo Clinic says the average person gets 20 percent of his fluid intake from food.

4. Make water more fun. Add unsweetened flavoring to water if you find plain water too bland. You can squeeze in lemon or lime juice, or float cucumber or

electrolyte powders and drinks. Working out in the heat or sweating profusely can unbalance electrolytes in the body. The Cleveland Clinic says electrolytes are substances that help the body regulate chemical reactions and maintain balance between fluids inside and outside of your cells. They include sodium, calcium and potassium. An electrolyte-infused beverage can help replenish these lost substances

Freedom from struggle

I'vebeenasked, "Joyce, how do you live the Christian life?" My answer surprises a lot of people. I tell them, "You can't live the Christian life." I then say, "Only God can live it through you!"

One of the greatest lessons I have ever learned is that we can't change ourselves-it is only by God's grace that we can overcome our weaknesses and become more like Him. We struggle and get frustrated when we try to do things apart from God's grace and strength. The most frequent prayer we should all pray is, "God, help me!"

Years ago, when I first started reading the Bible and getting serious about God, I began seeing all of the things I needed to change-there were so many! I needed to clean up my mind and my mouth; I had to overcome being so negative and judgmental, and my behavior toward my husband Dave also had to improve.

I immediately went to work trying to do it myself. However, I ended up very frustrated and made little progress. Why? Because I was spending all of my own energy trying to something only God can do!

Maybe you're in the same place. You want to break a bad habit or change your behavior in some way, but you are frustrated and discouraged by a lack of progress. Here's the good news: God never intended for you to do it alone. In fact, there's nothing worse than trying to fix something only God can fix!

So, what is our part? Our part is to study God's Word, especially in the



areas where we have a weakness, and spend as much time with the Lord as we can—whether it's talking to Him in prayer or even just sitting quietly in His presence.

This same principle applies to our relationships with other people-we can't change them! The greatest thing we can do is pray for others, love them, and allow God to change them Himself.

When my children were young, I was certain that a couple of them would never make it on their own. My daughter Laura was extremely messy, unorganized, and couldn't keep track of anything. My youngest son, Daniel, struggled his way through school, and I was convinced I would be taking care of him the rest of my life.

I spent so much time worrying and pestering and trying to change them on my own. Most of the time my efforts only seemed to make things worse! Yes, I needed to be a good mother and help them in every way I could. However, instead of worrying, struggling, and making us all miserable, I could have been praying, trusting God, and choosing to believe everything would work out well in the end.

You see, whether it's ourselves or someone else, the Lord wants us to seek His help, then rest in the knowledge that He is on the case. God doesn't want us to struggle; He wants us to believe. He wants us to relax and enjoy our lives even while we're waiting to see things change.

Today, my daughter Laura is so organized that one of her jobs is to help keep my life organized! And Daniel? The boy who barely made it through school is now the CEO of U.S. Operations for Joyce Meyer Ministries, and he does a fantastic job! Now I look back and realize how much time and effort I wasted worrying and struggling when God had things under control all along!











