### Illinois joins \$80 million enforcement action against Block/Inc., Cash App for BSA/AML violations

CHICAGO – Illinois and 47 state financial regulatory agencies have taken coordinated action against Block, Inc., for violations of Bank Secrecy Act (BSA) and anti-money laundering (AML) laws that safeguard the financial system from illicit use.

More than 50 million consumers in the United States use Cash App, Block's mobile payment service, to spend, send, store, and invest money.

"This enforcement action demonstrates the Illinois Department of Financial and Professional Regulation's (IDFPR) continued commitment to ensuring the integrity of the financial services industry and protecting consumers," said IDFPR Secretary Mario Treto, Jr.

"The Department will continue to take action, including collaborating with fellow regulators, to ensure compliance with all applicable laws." In the multistate settlement signed this

week, Block agreed to pay a \$80 million penalty to the state agencies, hire an independent consultant to review the comprehensiveness and effectiveness of its BSA/AML program, and submit a report to the states within nine months. Block then will have 12 months to correct any deficiencies found in the review after the report is filed.

"IDFPR makes every effort to identify risks to the financial services industry and consumers," said Division of Financial Instutitions Director Francisco Menchaca. "Protecting Illinois consumers is our top priority."

State regulators in Arkansas, California, Massachusetts, Florida, Maine, Texas, and Washington State led the multistate enforcement effort. Block cooperated with the states in the settlement.

Under BSA/AML rules, financial services firms are required to perform due diligence on customers, including verifying customer identities, reporting suspicious activity, and applying appropriate controls for high-risk accounts. State regulators found Block was not in compliance with certain requirements, creating the potential that its services could be used to support money laundering, terrorism financing, or other illegal activities.

Through a strong, nationwide regulatory framework, state financial regulators license and serve as the primary supervisor of money transmitters. States license more than 700 money transmitters, and 99% of transmission activity through those firms is governed by the state-developed Money Transmission Modernization Act (MTMA). To protect consumers and enforce safety and soundness requirements, state regulators regularly coordinate supervision of multistate firms and, when necessary, initiate enforcement actions. This coordination - Networked Supervision supports consistency and collaboration, while preserving the authority of individual states to take direct action. Additional information on the state regulatory framework for money transmission can be found here.

State financial regulators license and supervise more than 33,000 nonbank financial services companies, including mortgage companies, money services businesses, consumer finance providers, and debt collectors.

Illinois residents who have questions about the enforcement action should visit the IDFPR Division of Financial Institutions website. Residents can also visit NMLS Consumer Access to verify that a company is licensed to do business in Illinois.

### Better Business Bureau reveals 2024's Top 10 local scams

**ROCKFORD** -The Better Business Bureau of Chicago and Northern Illinois has released its annual Scam Tracker report. Online Shopping scams have topped the list for the fifth consecutive year, driven by a robust economy, low unemployment, and strong holiday spending. The top three scams from last year remain unchanged, with Phishing and Employment scams continuing to follow closely behind.

Notably, Investment scams have surged into the top 10, fueled by increased fraudulent social media messages and ads, particularly those promising quick riches through cryptocurrency. "Fraudsters take advan-

tage of new technology and current events to steal people's money, identity, and savings," says Dennis Horton, Senior Director of the Rockford Regional Office of the Better Business Bureau. "The results show that con artists keep coming up with various schemes and ways to entice all age groups to snare as targets.

Scammers continue to add twists, even setting traps with AI and deepfake technology. They conduct fake virtual or phone interviews, especially in employment scams. One thing always remains the same – playing with people's emotions and rushing them to make a quick buying decision are fraudsters' favorite tools.

Horton adds, "The only way to stop scammers is not to give them your business, which requires vigilance.'

- Online Purchase: Numerous reports of online scams involving fake websites, fraudulent transactions, and non-delivery of purchased items. Shoppers have lost money through various schemes, including fake product sales,

unauthorized charges, and phishing attempts. - Phishing: Scammers often impersonate legitimate organizations or individuals to gain trust. Victims receive emails, messages, or phone calls that appear to be from trusted sources. The communication usually contains a sense of urgency, prompting people to act quickly. Scammers request sensitive information such as passwords, credit card numbers, or social security numbers. People may be directed to fake websites that mimic legitimate ones to capture their information. Phishing

theft, financial loss, and unauthorized access to personal accounts.

- Employment: There have been several job offer scams in which individuals were promised employment but asked to provide personal information, pay for training, or purchase equipment. These scams often involved fake companies and fraudulent checks. - Debt Collections: Scammers pose as legitimate debt collectors or law enforcement officials. People receive threatening calls or messages demanding immediate payment of a supposed debt. Scammers often use aggressive tactics, including threats of arrest, lawsuits, or wage garnishment. People are pressured to pay using untraceable methods such as wire transfers, prepaid cards, or cryptocurrency.

### Agency issues first report on Sickle Cell gene, cell therapy treatments

CHICAGO — As required by Executive Order 2024-01, the Illinois Department of Healthcare and Family Services (HFS) submitted to the Governor and the General Assembly its first report from the Advisory Council on Financing and Access to Sickle Cell Disease Treatment and other High-Cost Drugs and Treatment. The report evaluates the success and challenges of various value and outcome-based payment approaches implemented in other states and includes recommendations for financing and increasing equitable access for these drugs in Illinois. In fulfillment of the Executive Order, the advisory council met six times over the past six months, culminating in the production of this report. The full report can be found here.

"When I signed the Executive Order to create this council, it was with the clear goal of making life-changing gene and cell therapy treatments affordable and available to every Illinoisan," said Governor JB Pritzker. "These recommendations are

a critical step forward in that effort, and Illinois remains committed to advancing this work to make transformative care more accessible."

"Ultimately these recommendations are centered around the goal of promoting equitable access to healthcare for all Illinoisans," said Acting HFS Director Elizabeth M. Whitehorn. "The state will continue to collaborate with other states, federal policy makers and stakeholders to build on these recommendations and ensure that Medicaid patients in Illinois are able to access the best care no matter their backgrounds."

The healthcare landscape is rapidly evolving with the increasing availability of advanced treatments for serious and often life-threatening diseases. In the next decade many new cell and gene therapies are expected to become approved and available for use. Many existing and expected cell and gene therapies will target children and young adults, who are disproportionately insured by state

Medicaid programs. These therapies can often have high prices, often exceeding one million dollars per patient.

"A new age in medicine is upon us. The ability to address debilitating diseases at their root cause has the potential to change patient's lives in ways that were previously unimaginable," said Dr. James LaBelle, Director of the Pediatric Stem Cell and Cellular Therapy Program at the University of Chicago. "I hope that access to these therapies will be dictated only on biology and not by lack of accessibility or cost. I commend the Governor and HFS for being at the forefront of addressing how to bring current and future transformative high-cost drugs, including gene therapies, to those in need throughout the entire state."

In addition, many patients battling rare diseases face significant challenges to accessing available care even when a break-through treatment exists. Specialized provider shortages, a lack of geographically proximate care, and other financial and logistical barriers all stand as potential impediments to patient access to current standard of care practices. The recommendations in the report also aim to address these challenges.

"As a caregiver representative and oftentimes spokesperson for the Sickle Cell community, the creation of the Advisory Council was definitely a step in the right direction. Convening key stakeholder experts together in order to combat the many challenges, barriers and access to care that the rare disease community continues to face gave us a much-needed

platform," said TaLana Hughes, MPH Caregiver and Executive Director of the Sickle Cell Disease Association of Illinois. "As a council faced with the task of creating recommendations focused on the development of payment models and financing structures with a very tight timeline, we dove in. Many very thorough, healthy debate meetings led us to what we believe supports equitable access while contributing to a much larger national effort to formulate solutions."

The report's recommendations are grouped into three categories and include the following recommendations:

Recommendations for HFS on Financ-

ing CGT and Other High-Cost Therapies include:

Ensuring that cell and gene therapies (CGTs) and other high-cost drugs are con-

sidered "covered outpatient drugs" to entitle the state to rebates and discounts on their use. Evaluate the federal Cell and Gene Therapies (CGT) Access model and determine whether participation may improve access

benefits and cost reductions.

Exploring all discounting and rebating strategies to help mitigate any financial burdens that may come with coverage for

these drugs and therapies.

Recommendations for HFS on Ensuring Equitable Access to CGT and Other High-Cost Therapies include:

Consider stratifying managed care customers with Sickle cell disease and other rare disease as high-risk early in diagnosis to enable timely access to specialized care coordination.

#### IDFPR, Illinois Attorney General warn of new scam targeting student loan borrowers

CHICAGO – The Illinois Department of Financial and Professional Regulation (IDFPR) Division of Banking and Illinois Attorney General Kwame Raoul recently issued a warning for a new scam that seeks to take advantage of student loan uncer-

Scammers contact student loan borrowers and make false promises that they can guarantee lower monthly payments or loan forgiveness, often demanding upfront fees to do so and promising immediate results. Borrowers typically can request these services for free from the U.S. Department of Education or their student loan servicer. Scammers utilizing this scheme are known to have contacted targets by phone, text, email, and regular mail, and may falsely claim to have ties to government agencies (including the Department of Education).

While a few companies may offer legitimate student debt relief services, many make false promises to student loan borrowers and fail to deliver on the services they're paid for.

"The current landscape for loan repayment is especially confusing due to pending legal challenges to federal relief programs, and scammers may try to exploit that uncertainty," said Illinois Attorney General Kwame Raoul. "Borrowers should get their information from the tion or their student loan loan servicers (learn servicer, so they do not put themselves at risk of potential scams. I also encourage borrowers who have questions or concerns to contact my office. I will continue to advocate in support of students and will work to hold institutions that defraud students accountable."

"It is disheartening to learn of yet another scam targeting uncertain financial situations, but borrowers should take heart in knowing there are steps they can take to avoid falling victim," said IDFPR Secretary Mario Treto, Jr."Remember, you do not need to pay for student loan assistance. Borrowers should contact their loan servicer or the U.S. Department of Education to get the help you need."

"Consumer financial education, including creating awareness of scams that prey on Illinois residents, is one of our top priorities," said Susana Soriano, Acting Director of Banking. "The Division of Banking will continue promoting legitimate avenues for borrowers to learn about student loan forgiveness programs and initiatives."

Consumers can identify this scam by being on alert for these red flags:

• Promises of immediate loan forgiveness or cancellation. Student loan debt relief companies cannot forgive student loans. Any changes to federal student loan repayment plans will be made through one of the more about federal student loan repayment programs for free from the U.S. Department of Education). Private student loan borrowers should also contact their student loan servicers for accurate informa-

- Requests to sign a power of attorney form. Legitimate student loan assistance programs will not typically require you to sign an agreement giving them legal permission to act on your behalf.
- High-pressure sales tactics attempting to force you into acting immediately by creating a false sense of urgency. Phrases used may include:
- o "Savings Plans Available for a limited time only!"

o "Results Guaran-

- teed!" o "Call Now!"
- o "Get Your Student Loans Forgiven Now!"
- For federal student loans, requests for your Federal Student Aid username and account in exchange for help with your student loans. Borrowers should never share their login credentials.
- Statements claiming relationships with government agencies, including the Department of Education. Again, borrowers should contact their student loan servicers for accurate information. Borrowers contacted by these scam companies should not engage with them, but should reach out to their student loan servicers or the U.S. Department of Education if

### Rezin introduces legislation to protect Illinois' energy infrastructure, national security

**SPRINGFIELD** - In an attempt to address growing concerns about Illinois' energy demands and potential national security risks, State Senator Sue Rezin (R-Morris) has introduced legislation to prohibits data centers owned by foreign adversaries from operating in Illinois unless they generate their own power on-site, ensuring they do not

infrastructure. "With Illinois already facing an increased demand on our energy grid due to rapid data center expansion, we must take action to secure our infrastructure

strain Illinois' energy

and prevent potential threats," said Sen. Rezin. "This legislation ensures that foreign-owned data centers from known adversaries do not compromise our energy stability or burden Illinois residents with increased utility

costs." Senate Bill 3890, also known as the Data Center Construction by Foreign Adversaries Act, requires Illinois' regulatory agencies to jointly assess any proposed data center's energy impact before allowing the construction of the center if it will be owned by a company tied to a foreign adver-

sary. This assessment

aims to confirm that the facility's energy consumption is fully self-sustained, whether by on-site natural gas generation, battery storage, or renewable sources, so that no additional burden is placed on Illinois' energy grid. The bill responds to

a concerning trend of foreign entities acquiring land in the Midwest for industrial purposes, a trend that experts warn could jeopardize national security.

"Senate Bill 3980 is a necessary safeguard for Illinois and our national security,"

continued Sen. Rezin. "We have to be vigilant about protecting our state's resources and shielding our energy infrastructure from unnecessary risks."

Senator Rezin believes that SB 3890 will prompt thoughtful dialogue among legislators on how best to

balance Illinois' growing technology sector with the pressing need for energy security and national safety. If the legislation isn't taken up before the conclusion of the 103rd General Assembly in January, Senator Rezin intends to refile the measure in the spring.

#### Single-weekend state final formats coming to IHSA baseball, softball in 2026

**BLOOMINGTON** – The Illinois High School Association (IHSA) Board of Directors met for its regularly scheduled meeting at the IHSA office in Bloomington on Jan. 15, where the Board approved a pair of advisory committee recommendations aimed at bringing the IHSA Baseball and Softball State Final schedules in alignment with other multiclass IHSA sports.

In recent years, the IHSA has made changes to its State Final schedules in boys' soccer, girls' soccer, girls' basketball, and boys' basketball. Each sport previously held their state final tournaments over the course of two weekends, contesting different classes on each weekend. Girls' and boys' basketball moved to a single-weekend state final format in 2021-22, and girls' and boys' soccer followed suit in 2023-24.

The changes approved by the Board at its meeting set the stage for baseball and softball to follow suit with single-weekend state final formats beginning in 2026.

"The move to a single-weekend state final format in basketball and soccer has been very well received overall, which led our baseball and softball advisory committees to seek out a similar format," said IHSA Executive Director Craig Anderson. "I believe this has the potential to create an exciting culminating weekend for both sports."

The schedule will call for the IHSA Softball State Finals in all four classes to be held in Week 48 of the IHSA calendar, which is when the IHSA Class 1A/2A Softball State Finals are currently held. The IHSA Baseball State Finals in all four classes will be held in Week 49 of the IHSA calendar, which is when the IHSA Class 3A/4A Baseball State Finals are currently held.

The IHSA's hosting contract for the Softball State Finals at Louisville Slugger in Peoria runs through the 2025 state tournament.

"We believe that Louisville Slugger is the premier softball facility in the state," said Anderson. "We have enjoyed a fantastic partnership with the staff there and it is our intention to hold the IHSA Softball State Finals there in 2026, and beyond, as the tournament transitions to the single-weekend format. We believe there is mutual interest from Louisville Slugger, and the many community partners that help put on the event and expect to be able to work together to make this official very soon.'

The IHSA currently has a baseball state final contract for the 1A/2A tourney weekend at Dozer Park in Peoria, and a state final contract for the 3A/4A tourney weekend at Slammers Stadium in Joliet. The 1A/2A contract in Peoria runs through the 2025 state finals, while the 3A/4A in Joliet contract runs through the 2026 state finals.

"We intend to honor our current baseball hosting contracts and are open to multiple options in 2027 and beyond," said Anderson. "Those options include holding the state finals at multiple venues in one city or continuing to contest the different classes at two sites on the same weekend. We have deep ties in both ballparks and communities, and will continue to work with both hosts, along with other key Illinois high school baseball constituents, to determine the best course of action for hosting the State Finals in the single-weekend format."

The IHSA Board of Directors also indicated they will explore authoring a by-law proposal in the fall of 2025 that would bring alignment to the season lengths of both sports.

The IHSA will be releasing the dates for the remaining 2025-26 State Series rounds (Regional, Sectional, Super-Sectional) to schools in the near future.




