### Council hears about 175MW solar project

The 825-acre plan much larger than community solar projects

CLINTON — The solar energy presentations keep coming as companies take advantage of the state's encouraging policies toward developing the industry in Illinois.

Community solar projects have increased 30 percent since 2021 because of the state's solar policies and incentives. Another in a line of companies presented its plan last week to the city council.

The city heard recently about a much larger solar project. Chase Ford, senior development manager with Nexamp, gave a survey of the company's proposed Prairie Flats solar project during last week's city council meeting.

The 825-acre project is much larger than the 20-60-acre plans the council previously has been approached about.

"I really wanted to talk through our project, where it stands with the city and also touch on who Nexamp is," Ford said. Nexamp was formed in 2007 by two U.S. Army veterans of the Iraq war.

"They came back and had a strong viewpoint that all different types of energy needed to be developed domestically," Ford said.

Nexamp now has 500 employees in a company that is investor-backed. Nexamp functions as owner/operators of most of its solar projects.

"That's the intent for the vast majority of our projects, and that's the intent for this project," Ford said.

Nexamp's primary investors are Generate Capital, an investment bank based in San Francisco, and John Hancock Insurance, with some investment from Diamond Capital, which is owned by the Japanese company Mitsubishi.

Illinois has been an important growth area for Nexamp, Ford said. The company now has about 80 employees in the state, with Chicago operating as a second company headquarters.

"The vast majority of our jobs and hiring are out of Illinois," he said. "So, we've really been focused on areas in the Midwest."

### Twin City Amateur Astronomers donates telescope to Warner Library

CLINTON – The Twin City Amateur Astronomers (TCAA) last week donated a 4.5-inch aperture Zhumell reflecting telescope on a Dobsonian mount to the Vespasian Warner Public Library.

The donation, valued at approximately \$500, was made possible through a grant from the Astronomical League, an international organization supporting amateur astronomy with over 10,000 members, with support from the TCAA.

The donation aims to provide young astronomy enthusiasts access to a quality telescope, enabling them to explore the

night sky. The Warner Public Library was chosen because it does not yet have a loaner telescope, and due to the strong local interest in astronomy, as demonstrated by the popular Weldon Springs State Park programs.

The donation is part of the Astronomical League's Library Telescope Program, a national initiative that has placed over 40 telescopes in libraries across Illinois and many hundreds more nationwide. The program seeks to make astronomy


accessible to the public by equipping libraries with easy-to-use telescopes for patrons young and old to check out, much like a book.

Nexamp is currently constructing or already operating more than 20 solar projects in Illinois with another 30 planned for the state.

"So, we've really focused on Illinois," Ford said.

The Prairie Flats project is planned for an area bordering northeast Clinton, extending north from Road 750N and east of the Trinity Structural Towers facility. A portion of the proposed project extends south of 750N, surrounding one home. The solar facility would connect to the grid at the substation located west of Route 51.

"This will be a 175-megawatt project, so quite a bit larger than some of those others you've been looking at," Ford said.

A number of developers have approached the city about commercial solar projects and their desire to be annexed into the city.

"We have two landowners under option for lease," Ford said. Totally about 900 between the two."

commissioners expressed concern about the project surrounding a home, which is considered of historical significance.

Ford said he was working to contact the owners of the home. He said previous representatives of Nexamp talked to the owners to explain the company's plan.


"This was roughly two, three years ago," Ford said.

"They would be totally surrounded by solar panels," said commissioner Dan Ballenger.

Ford said he would be in contact with the homeowner soon.

If the city chose not to annex the project, it would fall under the county's solar energy ordinance. There is no indication yet how the council would decide.

During a recent public comment meeting, hosted by the city council, residents, in general, were not in favor of solar projects abutting the city limits or being annexed into the city.



### It takes a woman

When it comes to relations between the sexes, I must admit the guys often just don't get it or ignore the facts in front of them.

Congresswoman Anna Paulina Luna, this past week, came very close to stopping all action in the U.S. House of Representatives until her concern was addressed by the Speaker of the House, Michael Johnson.

Even if you disagree with Lana's political preferences, she is striving to best have representatives serve their respective constituencies. This is a bipartisan proposal that warrants serious consideration. It takes a woman.

### Democracy floundering







Some of these foods to which the person is allergic can consume small amounts. Food intolerance simply means severe circumstances even in small amounts. It can even cause death.

We are also taught which foods and herbs are healthy for and helpful to the body. There are many books produced that claim they can teach you not only healthy cooking but also which foods are best for certain ailment. I cannot judge on such books since I lack the time to read them. For the most part, I believe they are good and worth reading by the naivest. Chefs have their own books that cover such needs. this with you.

Some may feel I was redundant by saying "healthy for and helpful to the body". Healthy foods are those foods that provide nourishing building blocks for a healthy body. You have heard it said that fish is brain food. Foods that are helpful to the body are foods that counter act the harm other foods are doing to your body.

Although cinnamon adds flavor to foods, it also reacts with sugar in the bloodstream reducing the harmful effects. ### Social Security to recover overpayments

Word is that Social Security is going to "claw back" any overpayment to the tune of 100 percent of the monthly benefit check until it's all paid back, inciting panic across the land.

But it's not necessarily true.

That recovery benefits will only affect overpayments that began on March 27 of this year. Yes, they'll take full payments until that overpayment is repaid. But any overpayments made prior to that date will be made at the rate that was in place before: 10% of the benefit check.

So, if your check is usually \$1,000, the amount they'll take out is \$100, not your full check. It will be the same if you receive Supplemental Security Income (SSI). They'll take 10%, not the full check.

Not that having any amount deducted will be easy.

Before you start to panic that you might get the "overpayment" dreaded letter from Social Security, here are a few facts, courtesy of a report by Social Security's Office of the Inspector General:

Overpayment (and even underpayment) doesn't happen very often, in less than 1% of benefits paid.

There are two main reasons why an error can occur: People report the wrong information about their income or fail to make corrections if there are changes (especially those who are under full retirement age and still working), and there are problems with Social Security's processing, specifically errors made when workers enter the data.

If you receive the overpayment letter, you might be able to waive the recovery of the amount owed, especially if the overpayment was not your fault. Go to the Social Security website and look for SSA form 632 (www. ssa.gov/forms/ssa-632. html). If that doesn't go well, you can appeal by using SSA form 561 (www.ssa.gov/forms/ssa-561.html).

You can also try calling them at 800-772-1213. If that doesn't work, look for a Social Security office in your area by going to secure.ssa.gov/ICON/ main.jsp and putting in your ZIP code.

### Turner legislation to support veterans and young farmers passes Illinois Senate

SPRINGFIELD — Two key pieces of legislation sponsored by State Senator Sally Turner (R-Beason) unanimously passed out of the Illinois Senate this week, moving one step closer to becoming law.

Senate Bill 39, which ensures affordable housing for at-risk veterans, and Senate Bill 2372, which seeks to improve farmland access for young farmers, will now head to the House for further consideration.

"Our veterans and our farmers are an invaluable part of our communities, and these bills reflect

commitment supporting them," Senator Sally Turner. "Whether it's a veteran facing homelessness or a young farmer struggling to access land, these pieces of legislation offer practical solutions to those challenges.

Senate Bill 39 ensures that the electric vehicle charging requirements in the 2023 Electric Vehicle Charging Act do not apply to tiny homes built for veterans who are homeless or at risk of homelessness. These homes, constructed and funded by nonprofit organizations such as the Central Illinois Veterans Commission (CIVC), provide critical support for those who have served the

Meanwhile, Senate Bill 2372 creates the Farmland Transition Commission, which will study the barriers individuals aged 25 through 40 face when trying to purchase or farmland. The access Commission will meet quarterly submit and annual recommendations to the Governor and General Assembly to help improve farmland transfer

opportunities.

"These measures focus on securing opportunities for those who have served our country and those who will shape its future," continued Senator Sally Turner. "Ensuring veterans have access to stable housing and young farmers have a pathway to land ownership strengthens our communities, supports our economy, and upholds the values that define Illinois."

With unanimous passage in the Senate, both bills will now move to the House for further consideration.





#### **BRIDGE BITES**

#### INTRODUCING DR GOODLEAD

This week we feature a terrific opening lead, found in real life by John Brady of Jacksonville, FL (known to some as Dr Goodlead).



N-S Vulnerable South West North East 1♥ **Pass All Pass** 4

Imagine yourself as East, if you will. looking at the N-E hands. West, the good doctor, leads the Spade Ten. A strange-looking lead, don't you think? It's not fourth best, not top of a sequence. Has the doctor's legendary common-sense finally deserted him?


While you are puzzling over that bizarre opening lead, Dummy plays the ♠Q and you gleefully ruff. What next, Mr East? West found a grand opening lead, and life would be even grander if only you could get back to West's hand for a second ruff. If that is to happen, West must have ♦A or ♣A. Any clues as to which?

The opening lead is your much-needed clue. West led an unnecessarily high Spade, and is trying to tell you something. Yes, he is advertising the Ace in the higher-ranking side-suit! So, after ruffing, you shoot back a Diamond to West's Ace and get your second Spade ruff. Down one!

Doctor G's lead from ♠KT5432 was not without risk, but he saw no appealing alternative, and he reasonably concluded that East had no more than two Spades (due to non-support in the auction). He didn't necessarily expect a void, but singleton was also a possibility (in which case West would later win the ♥A and give East a second-round Spade ruff).

What just happened was a Suit Preference signal, whereby, in certain situations, the play of a high card says "I have the higher-ranking suit", vice versa with a low card. This defensive signal is a rare bird on opening lead, it usually comes later in the hand and even then only in specialized situations. Dr Goodlead gave us the caviar, we'll have some meat-and-potatoes examples in later Bridge Bites.

### Missing inventory

If you're getting care at a Department of Veterans Affairs facility and staff can't find the equipment or supplies needed for your treatment, somebody has goofed up, likely somebody in inventory control.

One hospital alone, as investigated by the VA Office of Inspector General, was supposed to stock \$203 million in equipment and \$5.5 million in expendable supplies. In verifying the accuracy of the inventories, 82% of items in a random sample of surgical or medical items were found to be incorrect. That's 49 of the 60 items checked. As an example, inventory records showed over 1,100 decontamination gowns. In reality, there was one gown.

Then there were the over 1,500 expired items, the 94% of items that were not in the locations where they should have been and the new supplies found in dumpsters.

Interestingly enough, the Veterans Integrated Service Network (VISN) had conducted quality control reviews two years in a row, which meant they received documents and information from the facility. Their on-site reviews didn't find the deficiencies the VAOIG did: missing data, expired supplies, inventory discrepancies, missing medicine cabinets,

lack of correct use of the barcode system and more. Then there was the lack of

And the VISN reviewers -- because they lean heavily on data supplied to them -- apparently didn't notice the unlocked bins of veteran files, containing and personal health information, sitting outside the warehouse door.

The finger of blame for the expiration of biological and non-biological implant items can be pointed in several directions: staff because they weren't tracking the inventory, the various departments that used different methods to track their items, vendors that weren't made responsible for monitoring the items they supplied. And when problems did surface (damage and loss, for example), no one investigated.

The end result of this VAOIG inspection was chilling: Patients were medically at risk because of expired implant items and financially at risk due to their personal and health information sitting in bins outside the warehouse

## Despite two decades of education and enforcement, drivers still failing Scott's Law

Last year, Illinois State Police reported the highest number of crashes involving troopers

SPRINGFIELD For a moment, Illinois State Trooper Alex Womack was flying, tumbling in mid-air, alternately seeing sky then ground.

He doesn't remember hitting the road.

He regained consciousness and realized he had been hit by a truck and was lying in the middle of a darkened interstate near East St. Louis, unable to move with cars traveling 70 mph headed toward him. He remembers seeing the oncoming headlights.

"I was able to raise my one arm off the ground," Womack said.

An oncoming driver saw his upraised arm in his headlights and slammed on the brakes, managing to stop just feet away. That shaken driver pulled the injured trooper off the roadway to safety.

Womack had just become the 19th of 26 Illinois state troopers involved in a Scott's Law crash in 2019 — a year when two troopers were killed and a dozen, including Womack, were injured. Those crashes spurred legislative changes and heightened public awareness campaigns.

Scott's Law, also known as the Move Over Law, requires that all vehicles move over, if possible, ticket violators and campaigns or slow down when passing a stopped or disabled emergency vehicle with its flashing lights on. It was passed in 2001. Since 2019, state police have been involved in 140 crashes caused by drivers violating the Move Over Law.

In 2024, there were more crashes than in the past five years — 27 in all — including a fatal collision that killed Trooper Troy Clay Carns, an 11-year veteran and father of two. Carns died Dec. 23, 2024, after he was struck while clearing debris from the highway after a crash on Interstate 55 near Channahon.

The crash that killed Carns happened 24 years to the day after Chicago Fire Department Lt. Scott Gillen died after he was struck by a passing car at an accident scene. The legislation that later became known as Scott's Law was named for

The 2019 deaths of two troopers in an eight-week period once again put the Move Over Law in the spotlight.

On Jan. 12, 2019, Trooper Christopher Lambert died after a crash on Interstate 294 in Cook County. On March 28, 2019, Trooper Brooke Jones Story died in crash on U.S. 20 in Stephenson

One of Brendan Kelly's first duties as the newly appointed director of the Illinois State Police was delivering the eulogy at Jones Story's funeral.

Since then, one of Kelly's missions has been to educate the public on the Move Over Law, including enforcement details to to educate drivers. In 2019, ISP issued nearly 6,300 citations for violating the Move Over Law — which was nearly 5,300 more than the combined totals of the two previous years.

"We will continue to hammer home this message as long as it takes because this is a matter of life and death for our officers and for the safety of the public," Kelly said.

A person who violates the Move Over Law now faces a minimum fine of \$250 up to a maximum of \$10,000 for a first offense. If the violation results in injury to another person, the violator's driver's license will be suspended for up to two years.

In the wake of the 2019 deaths, Gov. JB Pritzker formed a task force that recommended changes in the law and stiffer penalties for violators, improvements in protective equipment and lighting for trooper, and public awareness campaigns.

Three days after the task force released its first report, there was another crash.

On Feb. 15, 2021, Trooper Brian Frank, with his marked squad car's emergency lights activated, stopped in the left lane of Interstate 55 northbound near Route 30 near Joliet to block traffic for a crash that had just occurred. While still inside his squad car, a black Cadillac struck the rear of Trooper Frank's squad car, leaving him with serious brain injuries.

Lauren Frank, Trooper Frank's wife, became an advocate for the Move Over Law, including advocating for a bill on Aug. 12, 2021, that strengthened the penalties against violators.

Brian Frank continues to recover from his catastrophic brain injury and remains in a "minimally conscious state."

Brian Angel Casillas, the driver who hit Frank, received a 15-month prison sentence.

The Move Over Law protections were further expanded this year. Beginning on Jan. 1, drivers must change lanes, reduce speed, or stop when approaching or passing any emergency vehicle, including police, sheriff, ambulances and maintenance vehicles, with the flashing lights activated. Drivers are also required to yield the right-of-way to any authorized vehicle or pedestrian actually engaged in work on a highway or a construction zone.

ISP is also employing technology to reduce Scott's Law crashes. Late last year, the agency announced a partnership with HAAS Alert — a company that provides safety alerts to drivers, notifying them of ISP activity in the road ahead and urging them to slow down and move over. HAAS provides real-time GPS-based traffic information in Chrysler, Dodge, Jeep, Mercedes-Benz, RAM and Volkswagen vehicles.

ISP provides information about crashes, traffic stops, motorist assists or debris on the roadway, which is then pushed out to invehicle GPS systems. As drivers approach the GPS location of the trooper, they will see a police icon and receive an alert to slow down and move over.

ISP also partnered with Google to provide notifications in Google and Waze Maps to expand the alerts on their platforms.

So far this year, there have been four crashes in Illinois, injuring three troopers.

Womack, the trooper who was struck in March 2019, sustained a broken femur, humorous, compressed discs in his vertebrae. He underwent two surgeries and months of physical therapy. He didn't return to full work duties for more than a year, but he said he was thankful to be alive.

"By the grace of God, I was saved. It just wasn't my time to go," Womack said.

Kyamran B. Makharadze, 26, the truck driver who hit Womack, was charged with aggravated driving under the influence and aggravated reckless driving. He pleaded guilty in 2023 and received a year in prison.

Womack returned to work after months of recovery. Today, he said when he pulls over drivers for violating the Move Over Law, he tells them what happened to

"I hope it's a lesson," Womack said. "I work on the side of the road. That's my office. And, at the end of the day, I just want to go home."

1965: A violent tornado in northeastern Illinois took the lives of 6 people near Crystal Lake. In a single subdivision, 45 homes were destroyed and 110 had major damage. The tornado touched down near Crystal Lake, and ended 2 miles north of Wauconda. \$1.5 million damage was reported. A separate tornado in Lake County started as a waterspout on Druce Lake, and moved east to near Gurnee.

1994: Very heavy rainfall led to flash flooding across central Illinois on the 11th and 12th. Rainfall totals ranged as high as 5-1/4 inches in less than 6 hours. Two people drowned while trying to drive across flooded roads in Sangamon and Montgomery Counties.
