

#### Amboy sewer pond treatment approved for second straight year AMBOY BRANDONLaCHANCE **S SMINUTE**

Amboy News Editor AMBOY – The April 21 Amboy City Council meeting was an unadventurous one as many projects have already been taken care of and a few aldermen were not present.

But business always takes place at the Amboy Community Building when a council meeting is in session.

The Amboy sewer pond treatment through Aquafix Inc. was approved for \$24,948. Amboy Mayor Frank Stenzel said the six treatments over the summer helps with the solid waste in the



sledge pond. This will be the second straight year Amboy has provided the treatment.

One of Amboy's biggest projects, or most important, has been the replacement of the lead lines as they're older and need replaced. The paperwork has been turned in and grants have been

approved and received. The city is waiting for the official go ahead to start the project.

During the meeting, the Jurisdiction Transfer Agreement with Amboy Township was approved.

"There were a few small patches on two or three roads where the Amboy Township roads are close to ours," Stenzel said. "Through this agreement, the Amboy Township through the Illinois Department of Transportation, is going to repair a few of their roads just a few feet away from ours."

Jeff Bryant Sr., former

Amboy Fire Protection District chef, was voted in, 3-1 (Brandon Klein and Bill Bontz were not present), to be a grant writer for the city. Andy McCoy was hired, unanimous vote, for part-time lawn mowing service.

On Wednesday, May 12 the closing of the Blackstone property will be official. After years of dealing with the abandoned, condemned property, the City of Amboy is purchasing the small lot and will then have the building demolished.

There are no city plans for the property, and it will be put on the market.

### Not in Our State: Illinois urgently calls on residents to help stop hate

CHICAGO – Illinois has faced an alarming surge in hate and extremism, following national trends. Hate crimes have skyrocketed 125% statewide since 2021, with bias based on race, religion, sexual orientation, and gender identity driving over 95% of incidents.

Now, the Illinois Department of Human Rights and Illinois Commission on Discrimination and Hate Crimes urgently call on all residents to report acts of hate through the Help Stop Hate initiative—a safe, confidential service that provides support and resources.

"At this moment in time, when some are influencing or condoning hateful violence and

rhetoric, we are encouraging Illinoisans to take action by reporting all acts of hate," said Governor JB Pritzker. "Help Stop Hate not only empowers impacted individuals to break the cycle of silence and seek specialized support, but it also helps us foster a safer, more inclusive Illinois."

"The surge in vitriol, violence and hate-fueled acts in Illinois is truly distressing. It's incumbent upon every Illinoisan to make it clear: hate has no home in Illinois," said Lieutenant Governor Juliana Stratton. "Help Stop Hate is a vital tool to empower our communities by encouraging people to speak up, report what they see, and stand together against intolerance in all its forms."

Since its launch, Help Stop Hate has emerged as a vital lifeline for survivors, offering immediate relief through anonymous reporting, trauma-informed care, and connections to services-such as legal aid-to fill gaps where traditional systems fall short. The service is a statewide priority that supports targeted individuals while informing new policies for confronting hate. Still, the state faces significant challenges with underreported acts of hate, which limits the ability to prevent and respond to hate effectively.



## SRCCF grants \$1,500 toward suicide intervention training

**OTTAWA** – The Starved Rock Country Community Foundation recently awarded a \$1,500 community grant to the Illinois Critical Access Hospital Network (ICAHN) for suicide intervention training.

The grant allowed Michelle Hansen, ICAHN Director of Clinical Programs, to attend a 5-day Applied Suicide Intervention Skills Training (ASIST) for instructors in March.

Hansen will train community members and hospital staff to recognize individuals at risk of suicide and teach them intervention and safety planning.

ICAHN is a nonprofit representing 60 rural and critical access hospitals (CAHs) across the state. It was founded in 2003 to facilitate the sharing of resources, support services, grants, education, training and networking among CAH's.

support from every Illinoisan.

To further drive awareness and action, IDHR and CDHC have launched a statewide, multilingual advertising campaign. IDHR and CDHC are also partnering with local organizations and municipalities across Illinois to help stop hate. These partners include the City of Moline, the City of Urbana, the City of Champaign, and Not in Our Town Bloomington-Normal. "Illinois stands firm in its promise to uphold dignity and respect for all," said IDHR Director Jim Bennett. "When our communities are affected by hate, we respond with action. Help Stop Hate empowers individuals to heal and reclaim their safety." Acts of hate are defined as those that target people based on their actual or perceived race, creed, color, religion, ancestry, gender, sexual orientation, physical or mental disability, citizenship, immigration status, or national origin. Hate incidents are categorized into

Progress hinges on hate crimes, bias-motivated civil rights violations, and hateful, but legal expressions.

"Hate of any kind causes real harm, not only to the individual who has been targeted, but to entire communities," said CDHC Executive Director Elana Kahn. "And bigotry never sticks to one community; when it becomes acceptable to target people because of who they are, none of us are safe. Reporting is an important first step, to help get support and influence real change for a better Illinois.' Help Stop Hate allows Illinoisans to report acts of hate safely and anonymously, with no affiliation to law enforcement or immigration authorities. Personal information will only be shared with law enforcement if legally required and will never be shared with immigration agencies. Illinoisans can report online to Help Stop Hate anytime in seven languages: English, Spanish, Polish, Mandarin, Tagalog, Arabic or Hindi. The phone line is open between noon and 9

p.m. CT, Monday to Friday, to English and Spanish speakers. Additional translation services are arranged as needed. Online and helpline specialists are equipped to provide resources and referrals to social service agencies for support with physical and mental health, trauma-informed care, advocacy, and more.





### **OSF** Saint Elizabeth Medical **Center receives an "A" rating**

OTTAWA – The biannual Leapfrog Hospital Safety Grades for the Spring of 2025 have been announced by The Leapfrog Group, a national watchdog organization for patient safety, and OSF HealthCare Saint Elizabeth Medical Center has been named to the list.

Nearly 3,000 hospitals across the U.S. are assigned A, B, C, D, and F letter grades. Widely acknowledged as one of the most prestigious distinctions a hospital can receive in the U.S., the recognition showcases OSF HealthCare's commitment to patient safety and quality.

OSF Saint Elizabeth Medical Center received an "A" grade.

"Delivering exceptional care is at the heart of everything we do," said Dawn Trompeter, president of OSF HealthCare Saint Elizabeth Medical

Center. "Our Mission Partners are committed to excellence, collaboration, and continually enhancing the care we provide. We're proud of their hard work and honored by the recognition that reflects their dedication."

Three additional OSF HealthCare facilities achieved an "A" grade: OSF HealthCare Saint James - John W. Albrecht Medical Center in Pontiac, OSF HealthCare St. Mary Medical Center in Galesburg and OSF HealthCare Saint Anthony's Health Center in Alton, Ill. The study only includes hospitals of a certain size and treating a minimum number of specific conditions; therefore, some OSF HealthCare facilities, such as OSF HealthCare Saint Paul Medical Center in Mendota and OSF HealthCare Saint Clare in Princeton, were excluded from the ratings.

## **PrEP HIV Prevention now available** directly from Illinois pharmacists

**SPRINGFIELD**-The Illinois Department of Public Health (IDPH) has issued a standing order that will allow Illinoisans to obtain the HIV preventive medication known as PrEP (pre-exposure prophylaxis) directly from a pharmacist without first requiring a doctor's prescription.

PrEP is one of the most effective means of preventing HIV infection. Studies have shown that when taken as directed, it reduces the risk of HIV infection through sexual transmission by as much as 99 percent. The order, signed by IDPH Director Dr. Sameer Vohra, will make it easier for people at risk of exposure to HIV to obtain either of the two oral medications used in the PrEP regimen. It also streamlines the process for pharmacists to receive reimbursement for providing PrEP services.

HIV remains a concern in the state, although the picture is improving under Governor JB Pritzker's Getting to Zero Illinois (GtZ) program, with a goal of zero new HIV transmissions in the state by the year 2030. In 2024, there were 1,386 new diagnoses of the virus statewide, down nine percent from the previous year. Unfortunately, new infections disproportionately impact Black and Hispanic communities, accounting for more than 60% of new infections annually. IDPH's PrEP4IL program provides medication assistance to relieve financial burdens for those in need of PrEP. There were more than 900 new applications for the program last year, with significant growth among Black and Hispanic populations. The new standing order represents another important step to improve access to PrEP for indi-

viduals at highest risk.

striving to help our State get to zero," said Director Vohra. "IDPH is very proud of our PrEP4IL program and the impact it is making to reduce HIV rates. This standing order now takes our efforts even further, opening additional doors of access so more individuals and communities can have the opportunity to take this preventative treatment and dramatically reduce their risk of acquiring HIV."

Were diagnosed with an STI (sexually transmitted infection) in the past six months.

Share injection drug equipment (needles, cookers, syringes, etc.).

## **Letter to the Editor**

#### Dear Editor,

We write to you, our fellow citizens, as members of the board of trustees of the Oregon Public Library. Ours is a small library that operates on a tiny budget. The Oregon Public Library is a Carnegie Library. Ours was one of hundreds created a century ago due to the philanthropy of Andrew Carnegie. Today, there is no way our library can possibly house, nor purchase, all the materials desired by our thousands of users and patrons.

thousands of users and patrons. Therefore, we rely on interlibrary loan services which are funded by the Institute of Museum and Library Services, or IMLS. IMLS is especially important for small rural libraries and communities.

For example, if you would like to read a book we don't have in the Oregon Public Library we can get it for you from libraries in the area spanning from Dubuque to North Chicago and we can get it to you quickly. Although our local library owns approximately 14,000 items, we have access to over 5 million items through a library consortium.

These books and other materials are shared around the library system. This is made possible by the Reaching Across Illinois Library System, or RAILS, which services 27,000 square miles, much of it in rural areas. RAILS delivers five days a week to the Oregon Public Library. Over the past year, our patrons have borrowed nearly 6,000 items from other Illinois public libraries.

There aren't enough programs that help rural communities, but at a very small expense the interlibrary loan service allows our community to order materials from academic libraries, school district libraries, and libraries with significantly larger materials budgets. Local library services are vital for veterans, seniors, young children, people with disabilities, jobseekers, rural residents and low-income individuals. We ask you to please call your elected officials and let them know the value library services provide to smaller rural communities. Our voices sometimes feel forgotten. Defunding this service will not result in significant savings, but it will cause harm and loss for Oregon and the surrounding community. However, investing in interlibrary loans will pay dividends because it contributes to the strength and resilience of rural communities.





# LOCAL/STATE NEWS Supreme Court approves three proposals impacting the practice of law in Illinois

**SPRINGFIELD** – The Illinois Supreme Court and the Supreme Court Executive Committee on the Practice of Law announced the adoption of three proposals to amend and create new rules that will impact the practice of law and help to address unmet legal needs in Illinois.

The first proposal, Regulation of Intermediary Connecting Services, will regulate attorney participation in intermediary connecting service (ICS) entities. The second proposal, New Supreme Court Rule 300, will create a new Supreme Court Rule governing attorney's fee petitions. The third proposal, MCLE for Pro Bono Pilot Project, will create a two-year pilot project to allow MCLE credit for pro bono service.

Each of the proposals will take effect on July 1, 2025.

The Executive Committee worked extensively with numerous groups including the Illinois Attorney Registration & Disciplinary Commission (ARDC), the Supreme Court Committee on Professional Responsibility (CPR), the Illinois State BarAssociation (ISBA), the Chicago Bar Foundation (CBF), and the Illinois MCLE Board. These stakeholders had the opportunity to weigh in on the proposals and their feedback helped to achieve a wide breadth of consensus. Each proposal furthers the Committee's charge to provide recommendations to the Supreme Court regarding issues impacting the practice of law and unmet legal needs.

"I would like to thank the Executive Committee, bar groups and Supreme Court committees and commissions for their hard work in researching and proposing these changes to the practice of law," Chief Justice Mary Jane Theis said. "The practice of law is experiencing profound change in the areas of technology and access to justice and these updates are necessary to address them."

ICS entities are organizations which connect lawyers to clients, typically through the internet. ICSs are already in operation and have the potential to help address unmet legal needs by making it easier for consumers to find a lawyer. It was determined, however, that existing rules did not clearly address lawyer participation in an ICS, creating confusion and making some lawyers reluctant to participate. As a result, the Executive Committee proposed amendments to Illinois Rules of Professional Conduct 1.6 and 7.2 to define "intermediary connecting service" and permit attorneys to participate in an ICS when certain conditions are met. With these changes, attorneys must engage in due diligence before and while participating in an ICS to ensure that the ICS is complying with certain requirements. This due diligence can be accomplished via an annual ICS certification letter.

"The Illinois Supreme Court has been a leader in exploring ways to practice law with an eye towards meeting the unmet legal needs of Illinois residents," said Attorney J. Timothy Eaton, who serves as Chair of the Executive Committee.

New Supreme Court Rule 300 Governing Attorney's Fee Petitions is intended to encourage alternative fee agreements (which increase access to legal services by making the cost of services more affordable, predictable, and transparent) by clearly establishing that an alternative fee agreement may be the basis for an attorney's fee petition and that hourly billing records will be required only under circumstances set forth in the rule. This new rule will provide greater consistency in the presentation and consideration of fee petitions and is ultimately intended to enhance the affordability and accessibility of legal services.

The MCLE for Pro Bono Pilot Project temporarily amends Supreme Court Rule 795(d) and creates a two-year pilot project wherein Illinois attorneys can receive Continuing Legal Education (CLE) credit for providing pro bono legal assistance through Illinois Free Legal Answers, a virtual, internet-based legal advice clinic administered by the Public Interest Law Initiative (PILI). This program will allow an attorney to earn 1 hour of MCLE credit for every 2 hours of probono participation in Illinois Free Legal Answers, up to 5 credits per 2-year MCLE reporting period. PILI and the Executive Committee will regularly review the data during the pilot period to determine whether CLE credit increases volunteerism and adds value to the legal profession by expanding professional development, and most importantly, the pilot will provide a demonstrable framework for how to broaden initiatives to help people most in need.

The Executive Committee was created in 2023 and consists of 13 members appointed by the Supreme Court, including representatives from the Attorney Registration and Disciplinary Commission, the Illinois Board of Admissions to the Bar. the Commission on Professionalism, the Committee on Professional Responsibility, the Lawyers Trust Fund of Illinois, and the MCLE Board. Eaton, a partner in the Taft Law Firm, serves as Chair with Tim Bertschy as Vice- Chair.

### Illinois State Museum receives donation of items from President Lincoln's extended Springfield family

**SPRINGFIELD**-The Illinois State Museum announced the donation of a collection of items from President Abraham Lincoln's extended family in Springfield.

These family belongings are donated by descendants of the Hickox-Edwards families in memory of Catharine Officer Saxe Loucks. Passed down through five generations, they offer an exciting glimpse into the social and familial

Charles and Mary Hickox Edwards, who married in 1868. Elizabeth Todd Edwards was the oldest sister of Mary Todd Lincoln; her husband Ninian was an early friend and political ally of Abraham Lincoln.

Highlights from the donation include a never-before-seen daguerreotype of Lincoln's niece, Lizzie Edwards, taken between 1855 and 1860; a daguerreotype of Ninian Edwards with his son, Charles, taken in 1850; and Elizabeth Todd Edwards' personal copy of the Episcopal Book of Common Prayer. "As a Lincoln enthusiast, this donation is incredibly exciting to me. The people in these photographs and who owned these items were Lincoln's nieces, nephews and in-laws," said Erika Holst, curator of history for the ISM. "They were a part of the emotional fabric of his life, as he was in theirs. It's amazing to be able to look at pictures of the same faces that Lincoln

saw on a daily basis."

The public is invited to learn more about Lincoln's extended family and to enjoy an exclusive first look at these items at 5:30 p.m. Wednesday, April 23. The event will take place at the Illinois State Museum's Research and Collections Center, 1011 E. Ash St., Springfield. It is free to attend and open to learners of all ages.

## Chronic wasting disease detected in four additional Illinois counties

SPRINGFIELD-Chronic wasting disease has been detected in Putnam, Marshall, Adams, and Peoria counties, expanding the geographic presence of the disease in free-ranging deer populations in northern Illinois, the Illinois Department of Natural Resources announced.

Adams County is the first documented case recorded outside of the leading edge of the CWD endemic region.

CWD is an always-fatal neurological disease that affects the long-term health of white-tailed deer in Illinois. First documented in Illinois in 2002 near Roscoe, CWD has been detected in 25 counties across northern Illinois and now as far south as Adams County in west-central Illinois.

In early February 2025, CWD was detected and confirmed through diagnostic testing in Putnam, Marshall, and Adams counties from routine surveillance of hunter-harvested deer. Peoria County was confirmed in a 2-year-old deer exhibiting clinical signs consistent with CWD infection using the same diagnostic testing procedures. Following standard protocol, samples from Adams County underwent genetic testing to ensure genetic matches between submitted tissue samples and source deer. Affected Illinois counties now includeAdams, Boone, Bureau, Carroll, Cook, DeKalb, DuPage, Ford, Grundy, Jo Daviess, Kane, Kankakee, Kendall, Lake, LaSalle, Lee, Livingston, Marshall, McHenry, Ogle, Peoria, Putnam, Stephenson, Will, and Winnebago.

CWD management is important to the overall health of Illinois' deer herd. Aprimary goal of ongoing CWD management in Illinois includes lowering prevalence in affected areas to slow the spread of the disease. Those management efforts have kept prevalence low in the state for almost an entire generation of deer hunters.

"Illinois is a national leader in managing and slowing the spread of CWD, and over the past two decades IDNR's program has served as a model for other states," said IDNR Director Natalie Phelps Finnie.


While the World Health Organization and the Centers for Disease Control and Preventionhave not linked CWD to human transmission, they recommend against eating meat from CWD-positive deer. Hunters are encouraged to have their deer tested and avoid consuming brain, spinal cord, eyes, and other tissues known to harbor the CWD agent. Go online for additional information about CWD management in Illinois, including updates made to the program in 2024. For more information about these detections or about CWD, contact Chris Jacques, wildlife disease program manager, at chris.jacques@ illinois.gov. IDNR wildlife biologists will be available to discuss current management strategies and answer questions about CWD in public meetings anticipated to occur later this year. Meeting dates and locations will be released at a later date. Landowners, hunters, and interested citizens are encouraged to attend.

#### Illinois EPA notifies 47 community water systems of right-to-know requirements triggered by recent rulemaking

SPRINGFIELD – The Illinois Environmental Protection Agency is notifying the owners and operators of 21 Community Water Systems that there has been a detection of one or more Per- and Polyfluoroalkyl Substances in the most recent water sampling of those specified CWSs at levels exceeding newly enacted groundwater quality standards.

The Illinois EPA is also notifying owners and operators of 26 connected CWSs that obtain water from CWSs that had one or more PFAS exceedances. Existing state Right-to-Know laws require a CWS to notify all end users when groundwater contamination poses a threat of exposure to the public above the Class I groundwater quality standards.

This law establishes methods of notification and strict time frames for providing notice.

PFAS are a group of several thousand human-made chemicals that are manufactured for their oil and water-resistant properties. Since the 1940s, PFAS have been used in a wide range of consumer products, industrial processes, and in some fire-fighting foams (called aqueous film-forming foam or AFFF).

This has resulted in PFAS being released into the air, water, and soil. PFAS do not easily break down under natural conditions and are often referred to as "forever chemicals." Attached is a copy of the Public Health Notice being provided to the CWSs, which includes information on potential health effects, home water filter treatment options, and ways to minimize PFAS exposure from other sources.

On December 7, 2021, the Illinois EPA filed amendments of the Illinois Pollution Control Board's (Board) Part 620 groundwater quality regulations to preserve and protect Illinois groundwater and to ensure that the state's groundwater quality standards match current scientific data and methodologies.

The Illinois EPA's proposal included new groundwater quality standards for six PFAS, based on the most recent scientific information available:

• perfluorooctanoic acid (PFOA)

• perfluorooctanesulfonic acid (PFOS)

• hexafluoropropylene oxide dimer acid, also known as GenX (HFPO-DA)

- perfluorohexanesulfonic acid (PFHxS)
- pefluorononanoic acid (PFNA)
- perfluorobutanesulfonic acid (PFBS)


On April 11, 2025, the Board's adopted amendments to Part 620 were published in the Illinois Register, triggering this Right-to-Know notification. Attached is a complete list of the affected systems, the most recent detected concentration, and the new groundwater quality standards.

Due to the prevalence of PFAS in the environment, Illinois has been among the most proactive states in the country in developing and implementing PFAS health standards and groundwater quality standards, in order to protect its residents.


Between 2021 and 2024, Illinois EPA issued seven PFAS Health Advisories to provide guidance to local officials and CWS operators in protecting the health of water consumers, and calculated 16 healthbased guidance levels (HBGLs) which represent the concentrations in drinking water at which no adverse health effects are expected to occur.

The adoption of Part 620 groundwater quality standards will replace five of the Health Advisories with the other two, Perfluorohexanoic Acid (PFHxA) and Perfluorobutanoic Acid (PFBA), remaining in effect until an enforceable groundwater standard exists. Additionally, U.S. EPA recently set Maximum Contaminant Levels (MCLs), which are federal drinking water standards, for certain PFAS.

CWSs will need to sample for and comply with the federal MCLs for PFAS by April 2029.


