Flandreau Public Schools' teachers and students are being recognized for their talents and knowledge district wide. School Board members listened to the numerous accomplishments during the past school board meeting.

Information Technology teacher Scott Headrick has been asked to be a part of the Kindergarten through Eighth grade Computer Science Standards Advisory Committee for the State of South Dakota. Headrick is a 2001 graduate of Flandreau High School and went on to Dakota State University in Madison to receive his undergraduate degree in Business Education and master's in educational technology. He also processes an Educational Specialist Degree in Administration that he earned at the University of Sioux Falls.

This is the first year Headrick has taught within the Flandreau School District. He teaches 3-6 Computer Science, while also being the assistant Tech Coordinator and handling the district's website and social media accounts. During the spring he will also be one of the Track and Field coaches.

The last 15 years Headrick has spent teaching in the Dell Rapids School District. During his tenure there Headrick taught middle school computer science, high school business, and held the title of District Technology Intergratest for the past six years.

Headrick, along with the help of Elementary Principal Justin Kelm, resurrected second through fourth grade typing classes. Headrick teaches the 3 & 4 class, while Mr. Kelm teaches second grade.

Plans entering final stages

Official renderings of the new addition planned for the Colman-Egan School District have yet to be unveiled.

They are coming, however, perhaps as soon as the next school board meeting in March.

Superintendent Scott Hemmer gave board members a brief update — the location is easy to access given its proximity to the I29 and Hwy 34 corridors. It is also centrally located for families who work in either Sioux Falls, Brookings or Madison and considered largely affordable in comparison.

As a result, classroom sizes continue to increase as more families move into the district.

Hemmer and the board have said they hope the addition gives students and teachers currently in school the space they need, but they also hope it's enough room for the district to grow well into the future. Soil samples were taken of the ground where the addition will be located, which is just off the west and back wall of the current building, The next big meeting to nail down as many specifics as possible with the architec-

tural team is February 23rd.

What Hemmer can say with certainty is the addition will include a new preschool room, six other classrooms, a flex learning space, and a new weight room. The weight room will be a shared space for public use, how that will work is yet to be determined.

The spring election season is quickly approaching and those looking to run for a city or school board position in any local municipality have until 5:00 p.m. February 23rd to turn in a petition to run for office.

Spring elections for municipalities and local school boards are scheduled this year for April 9th. A full ballot preview will be published in this paper the week prior to the election.

One caveat to that this year in Moody County will be the City of Trent. The addition would come at the start of the 2025-26 school vear.

Also at the most recent meeting of the Colman-Egan School Board, members adopted the new calendar for the 2024-25 school year which includes two full weeks of vacation over the Christmas and New Year's holidays. Administrative contracts were also offered.

Becoming An Influencer

Who is someone who has invested in you and your success? I've had more than one person invest in me, but Greg comes to mind. He would challenge me, correct me, encourage me, provide insight and answer questions I had. We didn't always see things the same, but he helped me become a better leader of people.

Épaphras had someone in his life who invested in him as well. If you haven't heard of Epaphras that is completely understandable. Not only did he live a couple thousand years ago, but he isn't widely mentioned in historical documents. The Bible mentions him only a couple of times, but if you've spent much time in church, you've seen his influence. Epaphras is believed to have had a role starting a few New Testament churches, including the one addressed in the book of Colossians.

You may have heard of one of the key influences in Epaphras' life. It was the Apostle Paul. Paul is credited with writing (under the God's direction) about a third of the entire New Testament, and traveled the known world starting churches, among other things. That's right. This busy leader, Paul, invested in multiple people, including Epaphras. Many of the people Paul mentored then impacted additional people. Paul multiplied his impact on the world by investing in people. Paul was amazing, but he couldn't start all these churches on his own.

Even in this world impacted by technology and productivity hacks, there is a limited amount any one person can do. But, if that one person invests in others, the impact is multiplied. Some of those influenced can then mentor and influence others who can do the same. It continues to spread. Change happens. Communities are impacted.

Who, besides yourself, are you investing in? I won't speak for the school counselors or social workers, but if you reach out, I'd guess there are opportunities to mentor in our schools. Investing in our kids and grandkids should be a given. Maybe there is someone you are working with or in a group in the community with whom you can invest in. I need to warn you, though, this will take time. Most valuable lessons are better caught than taught. This means you are going to need to invest time, meaningful classes last fall. They taught the students about trick or treating safety, like checking their candy and looking both ways when crossing the street.

Currently Deputy Frias is working with Flandreau Santee Sioux Tribal Police Chief Brian Arnold, on a Bullying and Safe Relationship Course. The course is being taught to fifth through eighth grade and focuses on anti-bullying and establishing safe relationships with proper boundaries.

Deputy Frias did touch on the issue of Truancy. There have been 15 total truancy tickets issued this school year. That number may seem high, but Deputy Frias says he is seeing an improvement. He credited the improvement to better communication between the school and parents about their child's attendance issues.

Another major issue within the school that does not seem to be improving, is vaping. More details on and that issue and what Deputy Frias, the Moody County Sheriff's Department, and Moody County Boys and Girls Club are doing to help combat it elsewhere in this week's Enterprise.

The board heard from Flandreau Athletic Hall of Fame Committee member Stuart Zephier. Zephier

asked for the board to waive the \$200 rental fee for the High School Gym for the FAHOF Basketball Classic. The board approved to waive the rental fee.

The Tournament was to be held this past Saturday, February 17. Next years' tournament, which Zephier said will contain more teams, is tentatively scheduled for January 18. The goal for the Classic is to grow and incorporate teams from Minnesota, Nebraska, Iowa, and South Dakota.

The board approved a donation to the Boys and Girls Club of \$5,000 dollars from the Community Rewards funds and not taxpayer dollars. The Boys and Girls Club shared that over the past year 400 kids have used their facility and 23,000 free meals & snacks have been given out. It is the Boys and Girls Club hope to provide a safe and positive space for kids when school is closed.

Vicki Braegelmann, Elementary Para; Autumn McDonnel, HS English; and Chad Bushkofsky, HS golf coach will join the FPS staff. Bushkofsky is filling a position that was not filled during the summer of 2023, while McDonnel will fill one of two HS English positions starting next fall.

Although the Flandreau School Board learned several good news items at its February 12 regular obard meeting, they also learned that vaping by students is a huge concern.

Sheriff Troy Wellman displayed a gallon size evidence bag full of vapes, empty shell casings, and nitrous oxide cartridges to board members and those present. School Resource Deputy Frias explained that the content of the bag was everything that was either confiscated or found on school property.

Much of the content of the bag which can be seen are vapes. The vapes are both nicotine and THC. While vape detectors were installed in the bathrooms, they are inoperable due to the school's firewall. SRD Frias continues to investigate a resolution to the issue and reaching out to other SRD/SROs in the area on how they are combatting the issue.

The uptick in vaping on school premises already prompted the change in the Use of Tobacco/Tobacco-Like Products prior to the 23-24 school year. The current policy now reads as follows:

Smoking and the use of tobacco products is

against South Dakota law. No student shall possess, use, sell, or dispense any tobacco/tobacco-like products during a school activity or on school property which includes buildings, grounds, parking lots and school buses. The student shall be subject to the following penalties:

1. First Violation: 5 days in alternative learning room

2. Second Violation: 10 days in alternative learning room

3. Third Violation: Recommendation for Long Term Suspension

NOTE: Smoking of any kind, with any device will be referred to law enforcement officials for a citation. Possession of smoking-related items such as lighters, matches, etc. will also result in suspension. Such items serve no legitimate educational purpose at school. (To include cigarette, vape, vape juice, juul, e-cigarette, or any inhalation device that can contain nicotine, tobacco, or other substance considered illegal for consumption.)

The policy allowed for uniform handling of every incident and added that "smoking of any kind, with any device will be referred

to law enforcement officials for a citation." Prior to the update the SRD would handle each student on a case-by-case basis.

Now with the problem continuing the Moody County Boys and Girls Club is stepping in to assist. The Club alongside the Moody County States Attorney have established a Diversion program, as well reviving Teen Court.

The Diversion Program's mission state is to assist juvenile offenders in assuming responsibility for their criminal behavior; to hold them accountable for their actions and to teach them to make better decisions in the future, while treating them with respect and dignity; to involve the community through volunteer programs and community service opportunities; and to promote better communication between youths, parents, schools, law enforcement agencies, and the community.

Requirements of the program include an apology letter written to parents/or parties involved, weekly check-ins, and if applicable relevant classes. The program lasts 120-days and participants must remain respectful and willing to participate in aspects of the program.

Things parents can do to help combat the vaping issue is know what your kids are doing and who they are with. You can do this by checking in on social media apps, cash transferring apps such as Venmo, or best of all speaking to your children about the risks of vaping.

SB201 passes through to Senate

Senate Bill 201, a bill being closely watched by many in our area as it potentially sets the stage for carbon capture pipelines to be constructed across the state and trump local zoning ordinances in the process, advanced this past week in the state legislature.

The Senate Commerce and Energy Committee debated for about an hour and a half this past Thursday, hearing from the bill's sponsor, representatives of South Dakota ethanol industry and other agricultural groups, Summit Carbon Solutions lobbyist, as well sdlegislature.gov/Session/ Bill/25010/265775.

The bill was introduced to advance the issue of carbon capture pipeline construction in South Dakota after two companies were denied construction permits this past year, including one that would have passed through Moody County.

Local commissioners enacted in 2023 what is considered some of the toughest zoning legislation in the state in an effort to protect landowners rights and address the concerns of constituents where carbon capture pipelines and setbacks are concerned. The lobbyist for Summit Carbon Solutions told the committee that there is no pathway forward for the project "if it involves discretion at the county level." Senate Majority Leader Casey Crabtree (R-Madison), the bill's sponsor, noted that not everyone will be happy with the bill. But he said, "When South Dakota farmers succeed, all of South Dakota succeeds, and that cuts both ways. When South Dakota farmers have limited ac-

An amendment to the bill would require pipeline companies to pay counties a surcharge of a dollar for every foot of pipe, for as long as the company receives tax credits. The bill also states that the pipeline must be buried at a minimum of four feet so that it is below the level of cultivation

A separate bill designed to limit a company's ability to use eminent domain to construct a carbon capture pipeline in South Dakota failed earlier last week. House Bill 1219 would have allowed for the construction of carbon capture pipelines but regulated how companies could go about constructing them. It failed in committee on a seven to six vote.

This week will be busy as February 21st is the last day for non-budget bills to be passed in their house of origin (Senate or House of Representatives) before moving on to the other house for consideration. Bills not passed in their house of origin, by that date, will no longer be considered. The push is on!

Education, education funding and teacher pay are topics addressed at every session. In 2016 a Blue-Ribbon Task Force recommended a state sales tax increase with much of those additional tax dollars going to schools for increased teacher pay. Since that time state aid to education has gone up about 30%. Average teacher pay has increased much less. Cost per K-12 student has gone from \$8,369 in 2016 to \$10,527 in 2022 (last available data). While South Dakota is 39th in expenditures per student we are once again very near the bottom in teacher pay at 49th in the nation. It is important to remember that the state funds education. Local school boards and administrators determine teacher pay.

Legislators are verv aware of the disconnect between increased school funding and teacher pay that has occurred. When we see state aid increased, we want to make sure that it's finding its way into teachers' pockets.

Legislation has been introduced that will establish a statewide minimum teacher salary concept for South Dakota, where each district must pay a \$45,000 base salary and then increase the base salary each year based on legislative increases to educational state aid. Most districts are at or above the proposed minimum requirement, but 37 school districts are behind. Based on a 4% potential legislative increase this session, the minimum becomes \$46,800. That can create challenges in some school districts, but it's a message from the state that we expect them to prioritize teacher salaries.

The legislation also reauires school districts to reach an average teacher compensation goal each year specific to each district. Compensation includes benefits such as insurance, and retirement plans. The inclusion of both average salary and average compensation gives districts the flexibility to prioritize between salaries and other benefits for teachers.

School districts have until 2027 to meet new requirements. Under the proposed legislation, here's how area school districts would fare. Garretson (\$2,924 over requirement), Dell Rapids (\$2,102 over requirement), Flandreau (\$968 over requirement), Colman-Egan (\$280 under requirement), and West Central (\$6,220 over requirement). The bill sets financial consequences for school districts that don't reach their district-specific average compensation or the minimum teacher salary, with the department of Education decreasing state funding to the district by \$500 for each teacher employed by the district. There is also a waiver process that may be requested by schools, for valid reasons, when expectations are not met.

salaries/com-Teacher pensation is an important topic. This is an issue I will monitor closely as we near conclusion of the legislative session.

RESOLUTION GIVING APPROVAL TO CERTAIN SEWER FACILITIES IMPROVEMENTS; GIVING APPROVAL TO THE ISSUANCE AND SALE OF A REVENUE BOND TO FINANCE, DIRECTLY OR INDIRECTLY, THE IMPROVEMENTS TO THE FACILITIES; APPROVING THE FORM OF THE LOAN AGREE-MENT AND THE REVENUE BOND AND PLEDGING PROJECT REVENUES AND COLLATERAL TO SECURE THE PAYMENT OF THE REVENUE BOND; AND CREATING SPECIAL FUNDS AND ACCOUNTS FOR THE ADMINISTRATION OF FUNDS FOR OPERATION OF THE SYSTEM AND RETIREMENT OF THE REVENUE BOND AND PROVIDING FOR A SEGREGATED SPECIAL CHARGE OR SURCHARGE FOR THE PAYMENT OF THE BONDS

WHEREAS, one of the purposes of SDCL Chapter 9-40 (the "Act") as found and determined by the Legislature is to provide for financing the acquisition, maintenance, operation, extension or improvement of any system or part of any system for the collection, treatment and disposal of sewage and other domestic, commercial and industrial wastes; or any system for the control of floods and drainage; or any combination thereof, together with Colman City

ery of the Revenue Obligation Loan Agreement (the "Loan Agreement"), the form of which is on file with the Finance Officer (the "Finance Officer") and open to public inspection, between the City as Borrower and the District, is hereby in all respects authorized, approved and confirmed, and the Mayor and Finance Officer are hereby authorized and directed to execute and deliver the Loan Agreement in the form and content attached hereto, with such changes as the Attorney for the City deems appropriate and approves, for and on behalf of the City. The Mayor and Finance Officer are hereby further authorized and directed to implement and perform the covenants and obligations of the City set forth in or required by the Loan Agreement. The Loan Agreement herein referred to and made a part of this Resolution is on file in the office of the Finance Officer and is available for inspection by any interested party.

3.3. Approval of Revenue Bond. The issuance of a revenue bond in a principal amount not to exceed \$758,100 as determined according to the Loan Agreement in the form and content set forth in Appendix B attached to the form of Loan Agreement (the "Revenue Bond") shall be and the same is, in all respects, hereby authorized, approved, and confirmed and the Mayor, Finance Officer, and other appropriate officials shall be and are hereby authorized and directed to execute and seal the Revenue Bond and deliver the Revenue Bond to the District, for and on behalf of the City, upon receipt of the purchase price, and to use the proceeds there of in the manner set forth in the Loan Agreement. The Mayor and Finance Officer are hereby authorized to approve the final terms of the Revenue Bond and their execution and delivery thereof shall evidence that approval. The Revenue Bond shall be issued under the authority of SDCL Chapter 9-40 and SDCL Chapter 6-8B, and the provisions of the Act are hereby expressly incorporated herein as provided in Section 19 of the Act.

3.4. Pledge of Revenues. The Revenue Bond together with the interest thereon, shall not constitute a charge against the City's general credit or taxing power, but shall be a limited obligation of the City payable solely out of the Project Debt Service Account, which payments, revenues and receipts are hereby and in the Loan Agreement pledged and assigned for the equal and ratable payments of the Revenue Bond and shall be used for no other purpose than to pay the principal of, interest and Administrative Surcharge on the Revenue Bond, except as may be otherwise expressly authorized in the Loan Agreement (including the purpose of securing Additional Bonds issued as permitted by the terms thereof). The City covenants and agrees to charge rates for all services from the Project or establish special charges or surcharges which will be sufficient to provide for the payments upon the Revenue Bond issued hereunder as and when the same become due, and as may be necessary to provide for the operation and maintenance and repairs of the Project, and depreciation, and the Rate Resolution shall be revised from time to time so as to produce these amounts. The City hereby reserves the right to determine on a periodic basis the appropriate allocation of operation and maintenance expenses, depreciation, repair and reserves associated with the facilities financed with the Revenue Bond, provided that such determination of allocable operation and maintenance expenses shall in no event abrogate, abridge or otherwise contravene the covenant of the City set forth in this Section 3 or

any other covenant or agreement in the Loan Agreement. SECTION 4. <u>Special Charge or Surcharge for Revenue</u> Bond.

4.1. The City does hereby create the Revenue Bond Spe cial-Surcharge District (the "Surcharge District") which shall include all users which benefit from the Project. There shall be charged a special charge or surcharge pursuant to Section 15 of the Act for the services provided by Project financed by the Revenue Bond. The special charge or surcharge shall be segregated from other revenues of the System and shall be used for the payment of the Revenue Bond. The special charge or surcharge shall create net income, remaining from time to time after first paying all reasonable and current expenses of maintenance, repairs, re-placements and operation, sufficient to fund interest, reserve and debt service fund annual requirements and shall be 110% of the debt service requirements on the Revenue Bond.

4.2. Rates and collection. The rate herein specific will be collected as a special charge or surcharge for the Project. This special charge or surcharge shall remain in effect until such time as the Revenue Bond is defeased or paid in full.

4.3. Initial Surcharge. The initial special charge or surcharge shall be set by resolution and collected at the same time as other charges of the utility. All users within the Surcharge District which benefit from the Project, current and future, shall be charged the special charge or surcharge. The special charge or surcharge is found to be equitable for the services provided by the Project. The special charge or surcharge shall begin at such time as will produce sufficient revenue to pay principal of, interest and Administrative Surcharge on the Revenue Bond when due.

4.4. Segregation. The Finance Officer shall set up bookkeeping accounts in accordance with South Dakota Legislative Audit guidelines for the segregation of the revenue, special charges and surcharges

4.5. Periodic review. The amount of the surcharge shall be reviewed from time to time, not less than yearly, and shall be modified in order to produce such funds as are necessary and required to comply with the Loan Agreement's rate covenant and to pay principal of, interest and Administrative Surcharge on the Revenue Bond when due. The surcharge may be set by resolution in accor-

Surplus Account or any other account of the Fund to any other fund of the City, nor shall such moneys at any time be loaned to other municipal funds or invested in warrants, special improvements bonds or other obligations payable from other funds, except as provided in this Section.

SECTION 7. Approval of Paying Agent/Registrar. The Revenue Bond shall be payable at the office of U.S. Bank National Association, St. Paul, Minnesota, hereby designated as paying agent and registrar.

SECTION 8. Approval of Bond Counsel. Meierhenry Sargent LLP is hereby retained as Bond Counsel with respect to the Revenue Bond.

SECTION 9. Tax Matters. The Interest on the Revenue Bond shall be excludable from gross income for federal income tax purposes under the Internal Revenue Code of 1986, as amended ("the Code") and applicable Treasury Regulations (the "Regula-

SECTION 10. Covenants. The City hereby covenants and agrees with the District and other owners of the Revenue Bond as follows:

10.1. The City will punctually perform all duties with reference to the Project, the System and the Revenue Bond required by the constitution and laws of the State of South Dakota and by this Resolution

10.2. The City agrees and covenants that it will promptly construct the improvements included in the Project.

10.3. The City covenants and agrees that pursuant to Sections 25 through 27 of the Act, the lawful holders of the Revenue Bond shall have a statutory mortgage lien upon the Project and the extensions, additions and improvements thereto acquired pursuant to the Act, until the payment in full of the principal and interest on the Revenue Bond, and the City agrees not to sell or otherwise dispose of the System, the Project, or any substantial part thereof, except as provided in the Loan Agreement and shall not establish, authorize or grant a franchise for the operation of any other utility supplying like products or services in competition therewith, or permit any person, firm or corporation to compete with it in the distribution of water for municipal, industrial, and domestic purposes within the City.

10.4. The City covenants and agrees with the District and other owners of the Revenue Bond that it will maintain the System in good condition and operate the same in an efficient manner and at a reasonable cost, so long as any portion of the Revenue Bond remains outstanding; that it will maintain insurance on the System for the benefit of the holders of the Revenue Bond in an amount which usually would be carried by private companies in a similar type of business; that it will prepare, keep and file records, statements and accounts as provided for in this Resolution and the Loan Agreement. The Revenue Bond shall refer expressly to this Resolution and the Act and shall state that it is subject to all provisions and limitations thereof pursuant to Section 19 of the Act.

SECTION 11. Depositories. The Finance Officer shall cause all moneys pertaining to the Funds and Accounts to be deposited as received with one or more banks which are duly qualified public depositories under the provisions of SDCL Ch. 4-6A, in a deposit account or accounts, which shall be maintained separate and apart from all other accounts of the City, so long as any of the Bonds and the interest thereon shall remain unpaid. Any of such moneys not necessary for immediate use may be deposited with such depository banks in savings or time deposits. No money shall at any time be withdrawn from such deposit accounts except for the purposes of the Funds and Accounts as authorized in this Resolution; except that moneys from time to time on hand in the Funds and Accounts may at any time, in the discretion of the City's governing body, be invested in securities permitted by the provisions of SDCL 4-5-6; provided, however, that the Depreciation Fund may be invested in such securities maturing not later than ten years from the date of the investment. Income received from the deposit or investment of moneys shall be credited to the Fund or Account from whose moneys the deposit was made or the investment was purchased, and handled and accounted for in the same manner as other moneys therein.

SECTION 12. Consent to Appointment. In the event of mismanagement of the Project, a default in the payment of the principal or interest of the Revenue Bond, or in any other condition thereof materially affecting the lawful holder of the Revenue Bond, or if the revenues of the Project are dissipated, wasted or diverted from their proper application as set forth in the Loan Agreement, Revenue Bond, or herein, the City hereby consents to the appointment of a receiver pursuant to Section 33 of the Act, and agrees that the receiver will have the powers set forth therein, and in Sections 34 and 35 of the Act to operate and administer the Project, and charge and collect rates as described therein.

SECTION 13. Severability. If any section, paragraph, clause or provision of this Resolution, the Loan Agreement, the Revenue Bond, or any other Loan Document shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this Resolution or said Loan Agreement, Revenue Bond, or any other Loan Document.

SECTION 14. Repeal of Resolution. At such time as the Revenue Bond is defeased or paid in full, this Resolution and the spe-cial charge or surcharge shall automatically be repealed without any further action of the City.

SECTION 15. Authorization of City Officials. The Mayor, Finance Officer, City Attorney and City officials shall be and they are hereby authorized to execute and deliver for and on behalf of

extensions, additions, and necessary appurtenances; and,

WHEREAS, a municipality is authorized by Section 6 of the Act to issue revenue bonds to defray the cost of extensions, additions and improvements to any utility previously owned without pledging its credit and is authorized to pledge the net income or revenues from the Project in accordance with Section 15 of the Act; and,

WHEREAS, the City of Colman (the "City") currently operates a sewer system for the collection, treatment and disposal of sewage and other domestic, commercial and industrial wastes; and for the control of floods and drainage and has determined that improvements to the sewer facilities are necessary for the conduct of its governmental programs and qualifies as an improvement, extension or addition to its sewer system; and,

WHEREAS, the City has determined to issue its revenue bonds to finance the improvements to its sewer system for the purpose of collecting, treating and disposing of sewage and other domestic, commercial and industrial wastes (the "System") and has applied to the South Dakota Conservancy District (the "District") for a Clean Water State Revolving Fund Loan to finance the improvements

WHEREAS, the City shall adopt special rates or surcharges for the improvements to be pledged, segregated and used for the payment of the Bonds

NOW THEREFORE BE IT RESOLVED by the City as follows:

SECTION 1. Definitions. The terms when used in this Resolution shall have the following meanings set forth in this section unless the context clearly requires otherwise. All terms used in this Resolution which are not defined herein shall have the meanings assigned to them in the Loan Agreement unless the context clearly otherwise requires.

'Act" means South Dakota Codified Laws Chapter 9-40.

"Loan" means the Loan made by the South Dakota Conservancy District to the City pursuant to the terms of the Loan Agreement and as evidenced by the Revenue Bond.

"Project" means the City of Colman Wastewater Collection System Improvements Project.

'Revenue Bond" means the revenue bond or bonds issued the date of the Loan Agreement by the City to the South Dakota Conservancy District to evidence the City's obligation to repay the principal of and pay interest and Administrative Expense Surcharge on the Loan.

'System" means the City's system of collecting, treating and disposing of sewage and other domestic, commercial and industrial wastes

SECTION 2. Declaration of Necessity and Findings.

2.1.1. Declaration of Necessity. The City hereby determines and declares it is necessary to construct and finance improvements to its System described as the Project.

2.2. Findings. The City does hereby find as follows:

2.2.1. The City hereby expressly finds that if the Project is not undertaken, the System will pose a health hazard to the City and its inhabitants and will make the City unable to comply with state and federal law.

2.2.2. Because of the functional interdependence of the various portions of the System, the fact that the System may not lawfully operate unless it complies with State and federal laws, including SDCL Chapter 34A-2, and the federal Clean Water Act, and the nature of the improvements financed, the City hereby finds and determines that the Project will substantially benefit the entire System and all of its users within the meaning of Sections 15 and 17 of the Act.

2.2.3. The City hereby determines and finds that for the purposes of the Act, including, in particular, Sections 15 and 17 of the Act, only the net income from the Project financed by the Revenue Bond be pledged for its payment.

SECTION 3. Authorization of Loan, Pledge of Revenue and Security.

3.1. Authorization of Loan. The City hereby determines and declares it necessary to finance up to \$758,100 of the costs of the Project through the issuance of bonds payable from the revenue of the Project and other funds secured by the City. The City hereby determines that because the Revenue Bond is issued in connection with a financing agreement described in SDCL 46A-1-49, pursuant to Section 15 of the Act no election is required to issue the Revenue Bond.

3.2. Approval of Loan Agreement. The execution and deliv-

dance with this Section. The rate resolution shall be necessary for the support of government and shall be effective upon passage.

SECTION 5. Additional Bonds. As permitted by Sections 8 and 9 of the Act, Additional Bonds payable from revenues and income of the System or Project may be issued, as permitted in the Loan Agreement, and no provision of this Resolution shall have the effect of restricting the issuance of, or impairing the lien of, such additional parity bonds with respect to the net revenues or income from the extensions, additions or improvements. The City shall have the right to issue additional bonds secured by a lien subordinate to the lien from the Revenue Bond pursuant to the Loan Agreement.

SECTION 6. Project Fund Accounts. For the purpose of application and proper allocation of the income of the Project and to secure the payment of principal, Administrative Surcharge and interest on the Revenue Bond, the following mandatory asset segregations shall be included in the sewer system account of the City and shall be used solely for the following respective purposes until payment in full of the principal of and interest on the Revenue Bond

6.1. Project Revenue Account. There shall be deposited periodically into the Project Revenue Account the net revenues as defined in Section 17 of the Act derived from the operation of the Project collected pursuant to the resolutions and ordinances of the City of Colman, South Dakota (collectively the "Rate Resolution"). Moneys from the Project Revenue Account shall be transferred periodically into separate funds and accounts as provided below.

6.2. Project Debt Service Account. Out of the revenues in the Project Revenue Account, there shall be set aside no later than the 25th day of each month into the account designated Project Debt Service Account, a sum sufficient to provide for the payment as the same become due of the next maturing principal of, interest and Administrative Surcharge on the Revenue Bonds and any reserve determined by the City's governing body to be necessary. The amount set aside monthly shall be not less than one-third of the total principal, interest, and Administrative Surcharge payable on the following February 15, May 15, August 15 or November 15 and if there shall be any deficiency in the amount previously set aside, then the amount of such deficiency shall be added to the current requirement.

6.3. Depreciation Account. There shall be established a General Depreciation Account. Out of the revenues of the Project Revenue Account there shall be set aside each month into the General Depreciation Account an amount determined by the Common Council to be a proper and adequate amount for repair and depreciation of the Project.

6.4. Project Surplus Account. There shall be established the Project Surplus Account. Revenues remaining in the Project Revenue Account at the end of any fiscal year after all periodic transfers have been made therefrom as above required, shall be deemed to be surplus and shall be transferred to the Project Surplus Account. If at any time there shall exist any default in making any periodic transfer to the Project Debt Service Account, the Common Council shall authorize the Finance Officer to rectify such default so far as possible by the transfer of money from the Project Surplus Account. If any such default shall exist as to more than one account or fund at any time, then such transfer shall be made in the order such funds and accounts are listed above.

When not required to restore a current deficiency in the Project Debt Service Account, moneys in the Project Surplus Account from time to time may be used for any of the following purposes and not otherwise:

(a) To redeem and prepay the Revenue Bond when and as such Revenue Bond becomes prepayable according to its terms; (b) To pay for repairs of or for the construction and installation

of improvements or additions to the System; and, if the balances in the Project Debt Service Account and the Project Depreciation Account are sufficient to meet all payments required or reasonably anticipated to be made there from prior to the end of the then current fiscal year, then: (c) To be held as a reserve for redemption and prepayment of

any bonds of the System which are not then but will later be prepayable according to their terms; or

(d) To be used for any other authorized municipal purpose designated by the Common Council.

(e) No moneys shall at any time be transferred from the Project

the City any and all other certificates, documents or other papers and to perform such other acts as they may deem necessary or appropriate in order to implement and carry out the actions authorized herein

SECTION 16. Effective Date. This Resolution shall take effect on the 20th day following its publication, unless suspended by a referendum

RESOLUTION GIVING APPROVAL TO CERTAIN DRINKING WATER FACILITIES IMPROVEMENTS; GIVING APPROVAL TO THE ISSUANCE AND SALE OF A REVENUE BOND TO FI-NANCE, DIRECTLY OR INDIRECTLY, THE IMPROVEMENTS TO THE FACILITIES; APPROVING THE FORM OF THE LOAN AGREEMENT AND THE REVENUE BOND AND PLEDGING PROJECT REVENUES AND COLLATERAL TO SECURE THE PAYMENT OF THE REVENUE BOND; AND CREATING SPE-CIAL FUNDS AND ACCOUNTS FOR THE ADMINISTRATION OF FUNDS FOR OPERATION OF THE SYSTEM AND RE-TIREMENT OF THE REVENUE BOND AND PROVIDING FOR A SEGREGATED SPECIAL CHARGE OR SURCHARGE FOR THE PAYMENT OF THE BONDS.

WHEREAS, one of the purposes of SDCL Chapter 9-40 (the "Act") as found and determined by the Legislature is to provide for financing the acquisition, maintenance, operation, extension or improvement of any system or part of any system of waterworks for the purpose of providing water and water supply for domestic, municipal, together with extensions, additions, and necessary appurtenances: and.

WHEREAS, a municipality is authorized by Section 6 of the Act to issue revenue bonds to defray the cost of extensions, additions and improvements to any utility previously owned without pledging its credit and is authorized to pledge the net income or revenues from the Project in accordance with Section 15 of the Act; and,

WHEREAS, the City of Colman (the "City") currently operates a water distribution system to supply municipal, industrial and domestic water to its inhabitants and has determined that improvements to the drinking water facilities are necessary for the conduct of its governmental programs and qualifies as an improvement, extension or addition to its drinking water system; and,

WHEREAS, the City has determined to issue its revenue bonds to finance the improvements to its system of waterworks for the purpose of providing water and water supply for domestic, municipal, and industrial purposes (the "System") and has applied to the South Dakota Conservancy District (the "District") for a Drinking Water State Revolving Fund Loan to finance the improvements;

WHEREAS, the City shall adopt special rates or surcharges for the improvements to be pledged, segregated and used for the payment of the Bonds

NOW THEREFORE BE IT RESOLVED by the City as follows: SECTION 17. Definitions. The terms when used in this Resolution shall have the following meanings set forth in this section unless the context clearly requires otherwise. All terms used in this Resolution which are not defined herein shall have the meanings assigned to them in the Loan Agreement unless the context clearly otherwise requires.

"Act" means South Dakota Codified Laws Chapter 9-40.

"Loan" means the Loan made by the South Dakota Conservancy District to the City pursuant to the terms of the Loan Agreement and as evidenced by the Revenue Bond.

"Project" means the City of Colman Water Distribution System Improvement Project.

"Revenue Bond" means the revenue bond or bonds issued the date of the Loan Agreement by the City to the South Dakota Conservancy District to evidence the City's obligation to repay the principal of and pay interest and Administrative Expense Sur-

charge on the Loan. "System" means the City's system of waterworks used for the purpose of providing water and water supply for domestic, municipal, and industrial purposes.

SECTION 18. Declaration of Necessity and Findings.

18.1. Declaration of Necessity. The City hereby declares and determines it is necessary to construct and finance improvements to its drinking water facilities within its System described as the Project.

18.2. Findings. The City does hereby find as follows:

18.2.1. The City hereby expressly finds that if the Project is not undertaken, the System will pose a health hazard to the City and its inhabitants, and will make the City unable to comply with state and federal law.

18.2.2. Because of the functional interdependence of the various portions of the System, the fact that the System may not lawfully operate unless it complies with State and federal laws, including SDCL Chapter 34A-3A, and the federal Safe Drinking Water Act, and the nature of the improvements financed, the City hereby finds and determines that the Project will substantially benefit the entire System and all of its users within the meaning of Sections 15 and 17 of the Act.

18.2.3. The City hereby determines and finds that for the purposes of the Act, including, in particular, Sections 15 and 17 of the Act, that only the net income from the Project financed by the Revenue Bond be pledged for its payment.

SECTION 19. Authorization of Loan, Pledge of Revenue and Security.

19.1. Authorization of Loan. The City hereby determines and declares it necessary to finance up to \$230,400 of the costs of the Project through the issuance of bonds payable from the revenue of the Project and other funds secured by the City. The City hereby determines that because the Revenue Bond is issued in connection with a financing agreement described in SDCL 46A-1-49, pursuant to Section 15 of the Act no election is required to issue the Revenue Bond.

19.2. <u>Approval of Loan Agreement.</u> The execution and delivery of the Revenue Obligation Loan Agreement (the "Loan Agreement"), the form of which is on file with the City Finance Officer (the "Finance Officer") and open to public inspection, between the City as Borrower and the District, is hereby in all respects authorized, approved and confirmed, and the Mayor and Finance Officer are hereby authorized and directed to execute and deliver the Loan Agreement in the form and content attached hereto, with such changes as the Attorney for the City deems appropriate and approves, for and on behalf of the City. The Mayor and Finance Officer are hereby further authorized and directed to implement and perform the covenants and obligations of the City set forth in or required by the Loan Agreement. The Loan Agreement herein referred to and made a part of this Resolution is on file in the office of the Finance Officer and is available for inspection by any interested party.

19.3. Approval of Revenue Bond. The issuance of a revenue bond in a principal amount not to exceed \$230,400 as determined according to the Loan Agreement in the form and content set forth in Appendix B attached to the form of Loan Agreement (the "Revenue Bond") shall be and the same is, in all respects, hereby authorized, approved, and confirmed and the Mayor, Finance Officer, and other appropriate officials shall be and are hereby authorized and directed to execute and seal the Revenue Bond and deliver the Revenue Bond to the District, for and on behalf of the City, upon receipt of the purchase price, and to use the proceeds thereof in the manner set forth in the Loan Agreement. The Mayor and Finance Officer are hereby authorized to approve the final terms of the Revenue Bond and their execution and delivery thereof shall evidence that approval. The Revenue Bond shall be issued under the authority of SDCL Chapter 9-40 and SDCL Chapter 6-8B, and the provisions of the Act are hereby expressly incorporated herein as provided in Section 19 of the Act.

19.4. Pledge of Revenues. The Revenue Bond together with the interest thereon, shall not constitute a charge against the City's general credit or taxing power, but shall be a limited obligation of the City payable solely out of the Project Debt Service Account, which payments, revenues and receipts are hereby and in the Loan Agreement pledged and assigned for the equal and ratable payments of the Revenue Bond and shall be used for no other purpose than to pay the principal, interest and Administrative Surcharge on the Revenue Bond, except as may be otherwise expressly authorized in the Loan Agreement (including the purpose of securing Additional Bonds issued as permitted by the terms thereof). The City covenants and agrees to charge rates for all services from the Project or establish special charges or surcharges which will be sufficient to provide for the payments upon the Revenue Bond issued hereunder as and when the same become due, and as may be necessary to provide for the opera-tion and maintenance and repairs of the Project, and depreciation, and the Rate Resolution shall be revised from time to time so as to produce these amounts. The City hereby reserves the right to a periodic basis the approp tion and maintenance expenses, depreciation, repair and reserves associated with the facilities financed with the Revenue Bond, provided that such determination of allocable operation and maintenance expenses shall in no event abrogate, abridge or otherwise contravene the covenant of the City set forth in this Section 3 or any other covenant or agreement in the Loan Agreement. SECTION 20. <u>Special Charge or Surcharge for Reve</u>nue Bond. The City does hereby create the Revenue Bond Special-Surcharge District (the "Surcharge District") which shall include all users which benefit from the Project. There shall be charged a special charge or surcharge pursuant to Section 15 of the Act for the services provided by Project financed by the Revenue Bond. The special charge or surcharge shall be segregated from other revenues of the System and shall be used for the pay-ment of the Revenue Bond. The special charge or surcharge shall create net income, remaining from time to time after first paying all reasonable and current expenses of maintenance, repairs, replacements and operation, sufficient to fund interest, reserve and debt service fund annual requirements and shall be 110% of the debt service requirements on the Revenue Bond. 20.1. <u>Rates and collection.</u> The rate herein specific will be collected as a special charge or surcharge for the Project. This special charge or surcharge shall remain in effect until such time as the Revenue Bond is defeased or paid in full. 20.2. Initial Surcharge. The initial special charge or surcharge shall be set by resolution and collected at the same time as other charges of the utility. All users within the Surcharge District which benefit from the Project, current and future, shall be charged the special charge or surcharge. The special charge or surcharge is found to be equitable for the services provided by the Project. The special charge or surcharge shall begin at such time as will produce sufficient revenue to pay principal, interest and Administra-tive Surcharge on the Revenue Bond when due. 20.3. Segregation. The Finance Officer shall set up bookkeeping accounts in accordance with South Dakota Legislative Audit guidelines for the segregation of the revenue, special charges and surcharges. 20.4. <u>Periodic review.</u> The amount of the surcharge shall be reviewed from time to time, not less than yearly, and shall be modified in order to produce such funds as are necessary and required to comply with the Loan Agreement's rate covenant and to pay principal of, interest and Administrative Surcharge on the Revenue Bond when due. The surcharge may be set by resolution in accordance with this Section. The rate resolution shall be necessary for the support of government and shall be effective upon passage. SECTION 21. Additional Bonds. As permitted by Sections 8 and 9 of the Act, Additional Bonds payable from revenues and income of the System or Project may be issued, as permitted in the Loan Agreement, and no provision of this Resolution shall have the effect of restricting the issuance of, or impairing the lien of, such additional parity bonds with respect to the net revenues or income from the extensions, additions or improvements. The City shall have the right to issue additional bonds secured by a lien subordinate to the lien from the Revenue Bond pursuant to the Loan Agreement. SECTION 22. <u>Project Fund Accounts.</u> For the purpose of application and proper allocation of the income of the Project and to secure the payment of principal, Administrative Surcharge and interest on the Revenue Bond, the following mandatory asset segregations shall be included in the water system account of the City and shall be used solely for the following respective purposes until payment in full of the principal, interest and Administrative Surcharge on the Revenue Bond: 22.1. Project Revenue Account. There shall be deposited periodically into the Project Revenue Account the net revenues as defined in Section 17 of the Act derived from the operation of the Project collected pursuant to the resolutions and ordinances of the City of Colman, South Dakota (collectively the "Rate Resolution"). Moneys from the Project Revenue Account shall be transferred periodically into separate funds and accounts as provided below. 22.2. Project Debt Service Account. Out of the revenues in the Project Revenue Account, there shall be set aside no later than the 25th day of each month into the account designated Project Debt Service Account, a sum sufficient to provide for the payment as the same become due of the next maturing principal of, interest and Administrative Surcharge on the Revenue Bonds and any reserve determined by the City's governing body to be necessary. The amount set aside monthly shall be not less than one-third of the total principal, interest, and Administrative Surcharge payable on the following February 15, May 15, August 15 or November 15 and if there shall be any deficiency in the amount previously set aside, then the amount of such deficiency shall be added to the current requirement

22.3. <u>Depreciation Account.</u> There shall be established a General Depreciation Account. Out of the revenues of the Project Revenue Account there shall be set aside each month into the General Depreciation Account an amount determined by the Common Council to be a proper and adequate amount for repair and

SECTION 23. <u>Approval of Paying Agent/Registrar.</u> The Revenue Bond shall be payable at the office of U.S. Bank Nation-al Association, St. Paul, Minnesota, hereby designated as paying agent and registrar.

SECTION 24. Approval of Bond Counsel. Meierhenry Sargent LLP is hereby retained as Bond Counsel with respect to the Revenue Bond.

SECTION 25. Tax Matters. The Interest on the Revenue Bond shall be excludable from gross income for federal income tax purposes under the Internal Revenue Code of 1986, as amended ("the Code") and applicable Treasury Regulations (the "Regulations")

SECTION 26. <u>Covenants.</u> The City hereby covenants and agrees with the District and other owners of the Revenue Bond as follows:

26.1. The City will punctually perform all duties with reference to the Project, the System and the Revenue Bond required by the constitution and laws of the State of South Dakota and by this Resolution.

26.2. The City agrees and covenants that it will promptly construct the improvements included in the Project.

26.3. The City covenants and agrees that pursuant to Sections 25 through 27 of the Act, the lawful holders of the Revenue Bond shall have a statutory mortgage lien upon the Project and the extensions, additions and improvements thereto acquired pursuant to the Act, until the payment in full of the principal, interest and Administrative Surcharge on the Revenue Bond, and the City agrees not to sell or otherwise dispose of the System, the Project, or any substantial part thereof, except as provided in the Loan Agreement and shall not establish, authorize or grant a franchise for the operation of any other utility supplying like products or services in competition therewith, or permit any person, firm or corporation to compete with it in the distribution of water for municipal, industrial, and domestic purposes within the City.

26.4. The City covenants and agrees with the District and other owners of the Revenue Bond that it will maintain the System in good condition and operate the same in an efficient manner and at a reasonable cost, so long as any portion of the Revenue Bond remains outstanding; that it will maintain insurance on the System for the benefit of the holders of the Revenue Bond in an amount which usually would be carried by private companies in a similar type of business; that it will prepare, keep and file records, state-ments and accounts as provided for in this Resolution and the Loan Agreement. The Revenue Bond shall refer expressly to this Resolution and the Act and shall state that it is subject to all pro-

visions and limitations thereof pursuant to Section 19 of the Act. SECTION 27. Depositories. The Finance Officer shall cause

SECTION 28. Consent to Appointment. In the event of mismanagement of the Project, a default in the payment of the prin-cipal or interest of the Revenue Bond, or in any other condition thereof materially affecting the lawful holder of the Revenue Bond, or if the revenues of the Project are dissipated, wasted or diverted from their proper application as set forth in the Loan Agreement, Revenue Bond, or herein, the City hereby consents to the appoint-ment of a receiver pursuant to Section 33 of the Act, and agrees that the receiver will have the powers set forth therein, and in Sec-tions 34 and 35 of the Act to operate and administer the Project, and charge and collect rates as described therein.

SECTION 29. Severability. If any section, paragraph, clause or provision of this Resolution, the Loan Agreement, the Revenue Bond, or any other Loan Document shall be held invalid, the in-validity of such section, paragraph, clause or provision shall not affect any of the other provisions of this Resolution or said Loan Agreement, Revenue Bond, or any other Loan Document.

SECTION 30. Repeal of Resolution. At such time as the Project Revenue Bond is deceased or paid in full, this Resolution and the special charge or surcharge shall automatically be repealed without any further action of the City.

SECTION 31. Authorization of City Officials. The Mayor, Finance Officer, City Attorney and City officials shall be and they are hereby authorized to execute and deliver for and on behalf of the City any and all other certificates, documents or other papers and to perform such other acts as they may deem necessary or appropriate in order to implement and carry out the actions authorized herein

SECTION 32. Effective Date. This Resolution shall take effect on the 20th day following its publication, unless suspended by a referendum.
