# **136th Annual Scotts Bluff County Fair**

**SCOTTS BLUFF COUNTY** – The Scotts Bluff County Fair will be celebrating its 136th annual fair at the Scotts Bluff County Fairgrounds in Mitchell beginning July 29 and running through Aug. 6.

This year's fair will feature the Scotts Bluff County Fair parade commencing Saturday, July 29 at 10:30 a.m. in downtown Mitchell.

Sunday, July 30 will be the Fair Kickoff Party beginning at 6 p.m.

Monday, July 31 will feature the PRCA Champions Challenge Xtreme Rough stock The grandstands open at 5:30 p.m.

The Outlaw Truck and Tractor Pull Heartland Division will produce a roar Wednesday night, Aug. 2, with gates opening at 5 p.m. Following the truck and tractor pull, will be the Frazier Carnival.

Uncle Kracker will perform Friday, Aug. 4.

One of the fan-favorite events takes place Saturday, Aug. 5. This event is the 40th annual Rubber Check Race. The race pits competitors against one another in a series of high-speed horse, ATV and foot races. The grandstand gates open at 6 p.m.
