Numerous shots were fired on Friday and Saturday in Blackville, leaving three teenagers injured and one residence damaged. Details are limited as the Blackville Police Department (BPD) investigates.

On Friday, May 24, 2024, individuals leaving a graduation party went to an area off of Robinson Street in Blackville not have a good description. where law enforcement later responded to calls of shots fired. According to BPD Chief Ray incidents.

Crawford, one individual was shot in the buttocks, one was shot in the hip, and another was grazed. All were teen-aged.

On Saturday, May 25, 2024 shortly after midnight, BPD responded to shots fired at a residence on Legion Road. No one was injured.

Upon arrival, law enforcement found evidence of gunshots hitting the front and side doors of the home. According to Chief Crawford, witnesses saw people fleeing the scene on foot, but did

C ince being sworn into the Barnwell Police Department (BPD) in March, officer Xavier Trumpler "has kicked it into high gear," said Chief Michael Butts. Specifically for his dedication while on a welfare call.

Chief Butts explained Officer Trumpler responded to the home of an individual who had not been heard from by their church members for a couple days. The individual was not able to newcomers, such as the four come to the door, so the officer that were sworn in at the May spoke to them through a nearby window. Although he could hear their voice, he did not leave their residence until he could physically see that they were okay. sea of patriotic colors Afilled the Veterans Memorial Park in Barnwell on May 27.

Veterans, community leaders, and residents of all ages united at the park for the annual Memorial Day program hosted by the Marine Corps League (Barnwell County Leathernecks) and Salkehatchie Chapter of the Vietnam Veterans Association.

"We don't fight for politicians; we don't fight for money. A lot of us never thought about serving for our family. We serve for each other and the comradery

serving their country.

with the men and women that you serve with is such a strong bond you can't tear apart, said speaker Sergeant First Class Jerry Smith, a JROTC instructor at Barnwell High School who recently returned from a deployment.

Smith devoted his speech to Sergeant Sean Grilley, who he called a "special young man that impacted my life.'

In 2000, Smith was working as a recruiter for the U.S. Army in San Bernadino, California. That's where he met Grilley, who wanted to join the military and become a military policeman. Smith spent 12 years as a military policeman

Officer Trumpler lifted them to a sitting position and promptly called EMS.

Chief Butts presented him with a plaque of recognition from the chief's association, the

meeting - James Thorpe, Justin Thomas, Joshua Newman, and William Beard.

Beard was promoted to Corporal and Thomas was promoted to Lance Corporal. With the addition of these officers, BPD is now fully staffed.

Also recognized at the meeting was Janell Jones, the widow of PFC Stephen Jones who died in September 2021 from complications from contracting COVID-19 in the line of duty. Jones received a plaque from the S.C. Criminal Justice

and was able to share his experiences.

As with any possible recruit, Smith said he never lied about the expectations of a soldier. "I told them all the time if you can get up early, be told what to do 24 hours a day, and don't mind being away from home, you can be a soldier." He also was upfront about the potential for deployment, particularly among military policemen.

Grilley joined the Army in search of a better way of life for him and his family, including his new wife. "He joined the Army because he wanted to serve," said Smith. "He didn't join to become a millionaire; he didn't join to travel; he didn't join to party; he didn't join for college money.'

In 2003, Grilley graduated from the Special Forces Assessment and Selection Course. Though he could have left Fort Campbell to attend Special Forces school, he chose to remain and deploy to Iraq with his platoon.

"He took that charge, the NCO (non-commissioned officer) creed, to heart. He knew he didn't want a new leader coming in to train his team," said Smith.

On Oct. 16, 2003, Grilley was killed in action in Iraq. He was just 24 years old. "Grilley distinguished

pray for the Grilley family and his wife Lucy," said Smith.

The event also paid tribute to the late Elbert Timothy "Tim" Moore Jr., who was well known around Barnwell County. The military veteran, retired educator/coach, attorney, and community leader died in a wreck in February

"This Vietnam Veterans Chapter and the Barnwell County Veterans Park meant quite a lot to him. He devoted countless hours of work and attention to help develop this setting into a fitting monument



for our veterans and SFC Jerry Smith (left) shakes hands with Ed Moore. Both

he went through. He was able to listen to others as they opened up to him. Together, they offered a chance to heal, and to grow, and to bond. I don't troubles so that we may think Dad ever missed another reunion after that. He developed lifelong friendships that spanned all across our nation," said Ed.

This also led Tim to become active in other veteran organizations, such as the local chapter of the Vietnam Veterans of America.

"As a result, the pain, the nightmares, and the fear that had always been present slowly faded. I was fortunate enough to

join him at several of these reunions. I saw a different side of Dad there. I saw him open up and speak about things I had never seen before. I was watching deep wounds heal in real time. I was watching pain go away. I was watching a new and positive spirit being born and developed," said Ed.

Just as it's important for veterans to have a support system, Ed said that's also true for non-veterans because everyone has trials and troubles.

"Paul wrote in his second letter to the Church in Corinth that God comforts us in all our comfort others. We are not meant to walk through life alone. There are people who have experienced similar troubles to us. We must remember not to try to fight these alone. We should seek help from our community and offer the same to others," said Ed.

Another concept Ed learned from his father was service.

Though he could have found a way out of serving after being drafted at the height of the Vietnam War, "Dad believed in service. Service to others, service to our community, service to our nation," said Ed.

After coming home from war, Tim went on to serve his community. Whether serving on the front lines of war or serving behind the scenes at a soup kitchen or other community organization, evervone can learn from the examples of Grilley and Moore.



himself with an exceptional display of valor above and beyond the call of duty during a fierce firefight. Grilley entered the zone of the firefight to recover a wounded comrade. Just as he had positioned the wounded soldier behind cover, Grilley was shot and killed," said Smith.

In recognition of his brave, selfless actions, Grilley was awarded the Bronze Star Medal for Valor and the Purple Heart.

Though Smith is the only person in Barnwell County who knew Sgt. Grilley, it's important for everyone to remember his sacrifice and bravery because that's what Memorial Day is all about.

Chamber welcomes new opportunity for women entrepreneurs

The Southern Palmetto Regional Chamber of Commerce was selected by the U.S. Small Business Association (SBA) to be designated as a Women's Business Center (WBC) - a federal funding initiative aimed at expanding opportunities for womenowned businesses.

According to chamber president Bob Snead, this designation will "support small businesses, women owned and women driven initiatives throughout the region for the next five years, and hopefully forever," said Snead. Funding is renewable after the five-year term.

This designation will help offer one-on-one services, training, networking opportunities, technical assistance, and mentoring for women entrepreneurs on topics such as financial management, marketing, and procurement.

"The SBA's expanding network of Women's Business Centers is meeting these new and established businesses where they are with resources to help them get funding to grow, create jobs, and strengthen our economy."

A ribbon cutting was held on May 21 welcoming guest speakers and the chamber's Rebekah Grubbs in her new role as Director of Women Driven Initiatives.

"We have a couple great speakers who are joining us from all over the state, said Snead. "I am going to leave it to the incredible and powerful women that established as a Minority I am surrounded by to talk

Grubbs described this designation as a landmark for Barnwell County; "This is going to be where we see generational changes in Barnwell," she said.







Two Republican candidates are seeking the District 90 seat in the S.C. House of Representatives. This seat represents all of Barnwell and Allendale counties, plus a portion of Orangeburg County. Demaris Johnson and Ben Kinlaw, who both reside in Barnwell County, will be on the June 11 Republican Primary ballot. The winner of the primary will face Rep. Lonnie Hosey, a Democrat who lives in Barnwell County, who has held the seat since 1999.

Demaris Johnson



emaris Johnson grew up in Williston and currently Delives there with her husband and son.

"My mother and father instilled in me Christian values, honesty, integrity, and a desire to serve others. As children we were taught the value of patriotism and the great sacrifices of our forefathers," she said.

As a teenager, she worked in the family's bakery in Barnwell. During her senior year of high school, she worked at the Barnwell County Sheriff's Office as a data entry clerk and assisted with the training of the Explorers.

While studying criminal justice at USC Salkehatchie, she continued her work at the sheriff's office.

"My education in criminal justice and my work at the Barnwell County Sheriff's Office taught me the moral and ethical values that are essential for public service," said Johnson.

After college she relocated to Jacksonville, N.C. and became a Nationally Certified Pharmacy Technician. Upon completing her training, Johnson worked at the New River Air Station Medical Clinic as a pharmacy technician. After her son was born, she moved back to Williston and worked for a local bank as a teller and later as a financial services representative.

She is a member of Rosemary Baptist Church, in which her father grew up attending. She is also a proud member of the National Rifle Association. For many years, she has volunteered as a poll worker for local elections.

Why have you chosen to run for this seat?

JOHNSON: Sometimes it is necessary to answer a question with a question. Are you pleased with our current state of affairs in our local, state, and federal government? Do you believe our current elected officials at the state level truly represent the voices and needs of our local communities? I believe the answer to these questions is a resounding 'no!" It is my desire to connect with the citizens in our local communities to hear their voices and hear their needs. I intend to make your voices heard in the South Carolina House of Representatives. Economic development has evaded our communities for far too long, negatively impacting the quality of life and the financial success and independence of our citizens. I intend to fight tirelessly to make our area and the quality of life for our citizens something we can be proud of.

KINLAW: I made the decision to run for HD-91 to move our district forward. This district is comprised of all Allendale and Barnwell counties, and the western portion of Orangeburg County. In the 2020 Census, 24 out of 46 counties lost population. The smaller and rural counties lost population, and larger areas grew at ten percent rate.

Allendale is one of 24 mostly rural counties that saw population declines over the past decade, and saw its population decline 22.8%, down to 8,039 people in 2020. Barnwell saw its population decline 8.9% down to 20,589. Orangeburg is a larger county, but their population declined 8.9% down to 84,223.

The March 2024 unemployment rate for Allendale County was 6.5%, second highest in the state, Barnwell County was 5.4% fifth highest and Orangeburg County was 4.9%, the tenth highest.

The infrastructure of our district is Allendale County has four lane road and rail, Orangeburg has two four lane roads, two interstates, rail and just over one hour from

He is completing the final year of his second term on Barnwell County Council (District 5). He serves on several boards through county council.

"We are members of Citizen of Nuclear Technology Awareness and represent Barnwell County as a member of Energy Community Alliance. We set a goal of elevating Barnwell County's profile with the Savannah River Site's leadership and attended conferences with them through ECA," said Kinlaw.

He is executive director of Keep Barnwell County Beautiful, an affiliate of Keep America Beautiful, which celebrated its first year of affiliation on March 20, 2024.

Kinlaw is a retired businessman who proudly served his country. He joined the U.S. Air Force on March 22, 1968.

Peggy currently is in her second term serving Barnwell City Council District 2, and as mayor pro tempore.

The couple have one son, Jonathan, who is married to Katie Tilley Kinlaw. They have two grandsons - the oldest is Thatcher, age 11, and the youngest is Harrison, age 9. They live in northwest Georgia, one and half hours north of Atlanta.

The Kinlaws attend First Baptist Church of Barnwell.

What are three major issues you think need to be fixed or addressed across the state?

JOHNSON:

- The three most important issues affecting our state are :
- Poor distribution of state funding and resources to rural areas compared to urban areas
- Infrastructure to support and promote economic development in the rural areas. 2. (Example: An interstate highway from Columbia to Savannah that would be a corridor for economic growth for industry with port access.)
- Education reform that mandates efficient use of public funding that will prepare our children for a prosperous future without them being saddled with debt. Example expand the state's technical college system by adding additional campuses in rural areas that lack access for rural citizens to earn an education that will prepare them to be competitive job candidates for trade and industrial jobs.

KINLAW:

- A common problem we see not only in our district, but in our state and across America is not enough labor to fill jobs. On top of this worker shortage, those who may be available do not have the soft skills industry requires. Workforce development and adequate funding for our technical schools to assist in the development of a pipeline of workers to satisfy the requirement to fill jobs.
- Infrastructure need assessment is needed to determine future economic develop-2. ment in the district.
- Affordable housing is a critical need as new industries locate to our region and for 3. people moving to the district.



How will you ensure the issues of the rural areas you represent are prioritized on a state level? (access to healthcare, gun violence, increasing rates of overdose, etc.)

JOHNSON: I will cultivate strong relationships and promote participation with the citizens in our communities. My town hall meetings in our communities will be a forum for the people to express their concerns and needs. Your voice will be heard on the floor of the S.C. House of Representatives. I will not sit idly by and allow the larger metropolitan areas like Charleston, Columbia, and Greenville to continue to have their needs met while ours are not. I believe every South Carolinian deserves to live in a community that is safe, and has adequate access to health care to include quality mental health care services and substance abuse treatment. Violent crime and drug abuse are destroying our youth. I will fight for additional law enforcement resources to combat these problems. Additionally, I intend to push for legislation that will mandate mandatory minimum sentencing for violent crime and the manufacturer and distribution of illegal substances.

KINLAW: Building foundational relationships with other legislators whose counties face similar challenges is a good starting point in moving our district forward. Over the ears I have developed good working relationships with the Executive Branch and many legislators in our General Assembly.

The examples you've listed require our state government to implement these programs to ensure the funding is established and is sustainable.

What is your first priority if elected?

JOHNSON: I am compiling a list of priorities and issues in the town hall meetings I am hosting. This data will reveal the true needs and desires of my constituents. The people will decide! I am merely their voice.

KINLAW: Our existing industries are facing a worker shortage, and this sends a message to any new industries coming to our region. We have already had a discussion with William Floyd, Executive Director of S.C. Department of Employment Workforce.

S.C. ranks 48th in terms of Labor Force Participation Rate (LFPR) and our district ranks low in comparison to other counties. The General Assembly passed H.4710 legislation and this will become effective on October 1, 2024. If we increase the LFPR by 1% in the state it means \$1.2 billion in extra payroll. The LFPR in October 2022 for S.C. was 56.7% and the U.S. was 62.2%.

What are some of your short-term and long-term goals if elected?

JOHNSON: Political power and economic success are very evident along the I-26 corridor, however, these things are clearly lacking in the more rural parts of the state. It is my belief that our state is stronger if the rural areas that are stricken with poverty begin to grow and prosper. My short-term goal is to assist in planting the seeds for this change to occur. My long-term goal is for these rural areas to become places that are desirable to live in.

KINLAW: Short-term is to work with SCDEW on increasing the Labor Force Participation Rate and workforce development. Long-term is to assess the district's needs for quality-of-life issues.

"It is an honor to fight for the expansion of knowledge, opportunities, and resources future generations need to one day take on the responsibility of making the world a better place. I live my life with a keen awareness of the legacies and traditions of past community cultivators," said Brown.

He teaches English, coaches soccer and basketball, and helps advise the student council at his alma mater, Bamberg-Ehrhardt High School.

"I strive to be a positive role model for my children and students," he said.

When not involved in the community, he enjoys spending time with his wife, two sons, their corgi Chase, and their friends and family.

Why have you chosen to run for this seat?

BROWN: This campaign aims to energize as many people as possible to maximize their potential. Like many undervalued teachers, I spend my workdays investing in the growth of the culture of the community. I am running to be part of the change our communities need. The youth need someone to represent their needs and concerns. My attempt to make a change will hopefully spark something in every individual who desires to make the world a better place. My sons are 5 and 4 years old. I intend to set a bar for them to reach for, thus elevating their unique legacies to inspire the next generation. I'm from District 40 and I think I embody the passion, ambition, and courage the next generation wants to be the foundation for the future of this area. Our people have a hard time being seen or heard here. I hope the light I am shining on our communities is bright enough for more people to give us a chance.

HUTTO: I am thankful for the citizens in my District entrusting me to serve as their State Senator for almost 30 years. As someone who has lived in rural South Carolina my whole life, I understand the challenges facing rural communities in our state. I am proud to have been instrumental in promoting funding for rural school districts, in allocating millions of dollars to improve our roads, schools, parks, and in bringing new industry into our area to allow our citizens to obtain good jobs.

How will you ensure the issues of the rural areas you represent are prioritized on a state level? (access to healthcare, gun violence, increasing rates of overdose, etc.)

What is your first priority if elected?

Public safety, education, nutrition top of mind for Allendale voters ahead of primaries

Public safety, local development and nutrition were top issues for voters who attended the Allendale Democratic Party's Candidates forum on May 23. The forum, hosted at the Allendale Courthouse, County allowed Allendale voters to ask questions to the five Democratic candidates running for office.

The election will be held at a time of reckoning in Allendale; A recent string of shootings resulted in the killing of a 14-yearold girl, as well as multiple others injured, creating community-wide discussions surrounding the root causes of gun Additionally, violence. long-standing issues like community nutrition, job opportunities, the local housing crisis and the county's financial situation were also top of mind for voters at the forum. The forum was facilitated by former South Carolina representative Wilbur Cave.

Voting and candidates The statewide primaries for office will be held on June 11, with early voting having begun on May 28. Three candidates are on the ballot for the Democratic primary in Allendale County Council's District 1: incumbent Theresa Harvey Taylor, former magistrate judge John Chaney and educator Keith Browning. District 1 includes large parts of the Town of Fairfax, Barton and southern Allendale County.

In his opening speech, Browning criticized county the county's finances.

and encouraged greater cooperation between council members.

"I'm not going to put all the blame on the council," Chaney said. "When you have five people together, there's always going to be a little confusion. But when you're at a [council] meeting, the only thing you should be concerned about is the citizens of Allendale County."

Keep Allendale County Beautiful awarded grants for litter prevention, beautification and community improvement


Keep Allendale County Beautiful (KACB), an affili-ate of the Keep America Beautiful (KAB) organization, recently was awarded three grants to help with litter prevention, beautification and community improvement throughout Allendale County. KACB became an official affiliate of KAB on February 16, 2023, as a result of SouthernCarolina Alliance's (SCA) Regional Beautification Marketing Program. SCA began leading the program, sponsored by Palmetto Pride, in 2021.

Palmetto Pride, South Carolina's anti-litter organization, has awarded KACB with the 2024 Litter Crew Grant in the amount of \$6,436, and the 2024 Keep South Carolina Beautiful Support Grant in the amount of \$10,000.

The Litter Crew Grant is open to counties, municipalities, KAB affiliates and community/youth groups. It is a competitive grant that provides funding of up to \$10,000 to pay for litter removal crews to routinely conduct cleanups throughout a year-long period of time. Routine litter cleanup helps to reduce litter on the roads and to foster community pride. KACB has formed an agreement with USC Salkehatchie's Baseball team to be their designated litter crew. The Litter Crew Grant will also help to provide supplies for the clean-ups, as well as new litter prevention signs to be placed throughout the county.

The Keep South Carolina Beautiful Support Grant is

PFC Jones served with BPD for two months before his death, and previously served with the Barnwell County Sheriff's Office and the Blackville Police Department.

Chief Butts gave council a department report from April showing 50 warnings, 46 tickets, nine arrests, 220 reports, and 462 business and residential property checks.

On May 9, Lance Corporal Molly Curley was "moved into the animal control position as a permanent position. She is handling code enforcement, animal control, and going a little bit on the road, but she is straight animal control and code enforcement," said Chief Butts.

Building friendships and strengthening bonds

olunteering has always been a big part of Shelley Brosnan's life, whether she was serving in her children's school or in their Fairfax, Va., community. When Brosnan retired, increasing her volunteer efforts was a natural next step. Serving with Volunteer Fairfax, an AmeriCorps Seniors RSVP program, she spends about 10 hours a week teaching new volunteers about helping older adults age in place, providing food for those in need and extending the capacity of local nonprofits.

"There's so much to love about volunteering," Brosnan said. "Providing purpose and serving the community are obvious reasons, but the connections I make with others are one of the greatest benefits. I just really love helping people and I've made friends through volunteering."

Brosnan's experience with volunteering is



in mentoring and tutoring relationships. Lastly, the Senior Companion Program is a way to give a helping hand to other older adults and those with disabilities, assisting them with day-to-day tasks, such as grocery shopping and transportation to appointments. They also support caregivers through respite services."

The time commitment for all programs is flexible, ranging from a few hours to 40 hours per week.

Research studies like the Harvard University Study of Adult Development, found that older adults who invest in, care for and develop the next generation are three times as likely to be happy as those who did not. Volunteers Francois Mwabi and Jerome Menyo, based in Kentwood, Mich., are two more examples of the difference it can make to serve.

Mwabi and Menyo attest to the joy of impacting youth by passing on their wisdom and sharing their culture and language with students, many of whom are refugees from different parts of Africa just as Mwabi and Menyo themselves were several years ago. The two volunteers are so popular among the students and staff that teachers had to work out a schedule for all their students to be able to spend time with them.

According to the Mayo Clinic, having a solid social network improves both physical and mental health as it can boost happiness, increase your sense of belonging and improve self-confidence. As people age, many social avenues from earlier phases of life, such as school and work, no longer exist and making friends can be difficult. The Mayo Clinic suggests volunteering as a beneficial way to make friends and improve social well-being.



"Volunteering fosters more connected and less isolated older adults," said Atalaya Sergi, director at AmeriCorps Seniors. "Our research, focused on the impact of our programs, finds volunteering can provide positive health and well-being outcomes. In our study, 84% of participants reported stable or improving health and 88% had lower feelings of isolation within one year of volunteering. Each year, we match more than 143,000 Americans with volunteer opportunities, helping build connections and address societal issues, nurturing real relationships that help people become both happier and more fulfilled."

Adults ages 55 and up, like Brosnan, can be matched with local volunteer organizations fitting their interests, skills and availability through AmeriCorps Seniors, the nation's largest national service program for older adults, which offers three signature programs. Brosnan and other volunteers nationwide play crucial roles in community resilience and connectedness.

"RSVP volunteers, such as Shelley, take on diverse activities based on community need such as delivering meals, supporting veterans and military families, cleaning parks or helping with tax prep and financial literacy," Sergi said. "Our Foster Grandparent Program pairs volunteers with youth, One of the reasons the program has such a positive impact is the intergenerational connections it helps establish. Benefits abound not only for the young, but particularly for the volunteers.

"We love being here because of the environment and the students who study here," Menyo said. "The teachers like us. I help students who speak my language. I enjoy it and they enjoy it, too."

Intragenerational pairings are fruitful and fulfilling, as well.

Masa Hunley of Philadelphia eagerly anticipates the time she spends with Deborah Washington, a Senior Companion Program volunteer. Washington, a retired mail carrier with the U.S. Postal Service, was active before retirement and saw no reason to slow down after leaving full-time work. She was paired with Hunley three years ago. Washington thinks of Hunley warmly, "almost

Washington thinks of Hunley warmly, "almost as a grandma." She spends a few hours twice a week with Hunley, helping her with meal prep, getting to appointments, watching television or playing cards together.

Serving as a companion to Hunley is "just something that I enjoy doing, as if it was my mom or my grandmom, who have both passed," Washington said. "It's like serving them and praying that, if it was my mom or my grandmom, someone would be doing the same thing. It has to be in your heart."

Washington is also thankful for the opportunity Hunley provides for "loving up on her" and feels fortunate to be able to soak up the wisdom that Hunley has learned and earned.



Employment scams target college students

any college students seek Mflexible, part-time employment to help cover school expenses. Finding a job can be challenging, and students may feel pressure to find work quickly. If this situation describes you or a student in your life, watch out for scams. BBB Scam Tracker has gotten reports of employment scams impersonating professors and university departments.

How job scams work

You receive an email to your school email address encouraging you to apply for a job. The message appears to come from your school's job placement office, student services department, or even a specific professor. The position, which may be anything from pet sitting to mystery shopping, sounds perfect for a college student. The work is easy, has flexible hours, and offers excellent pay.

When you reply to the message, things start to get strange. The 'employer" hires you without an interview. Then, they send you a check with instructions to deposit it before you've even done any work. You are instructed to use this money to purchase gift cards, money orders, prepaid debit cards, or other supplies you'll need for your new job. Part of what you purchase should be sent to your new employer. The rest of the money will be your payment.

However, the check is a fake. I can take weeks for your bank to discover involving job scams.

the fraud. By then, any money you send to your "employer" is gone for good, and you're stuck paying back the bank. In addition, the scammers now have your personal information.

One student reported this experience: "I received a message via my school email about a job opportunity with a professor. I reached out to the number and was asked for my resume and a non-school email. When I asked questions about the position, I was told the school would pay for my expenses and I would receive materials from them. They asked what bank I used and if I could deposit checks into my account. When I asked for the professor's email, the person said they were the professor. However, when I reached out to the professor personally, he said he was not looking for a research assistant and that I must have been dealing with scammers."

Unfortunately, not all students who reported this scam to BBB Scam Tracker avoided losing money. Another student lamented, "I received a job offer from what I thought was my school. I was sent two checks in the amount of \$1,650. I withdrew cash as instructed and bought Bitcoin for the "employer" and sent them a receipt. The next day, the checks bounced and over drafted my account."

How to avoid employment scams

• Do your research. Before you say yes to any job, research the company that wants to hire you. Does the company have a professional website and legitimate contact information? Search for what others are saying about their experience with this company. Do an internet search with the employer's name and the word "scam" to see if there are reports

• Beware of red flags. Scammers often send emails with many typos and grammatical errors. They offer to hire you without an interview and even pay you before you've done any work. None of these are behaviors of a reputable business.

· Examine the email address of those offering jobs to see if it matches the domain used by an actual company. Be alert to Gmail business email addresses.

• Never send money to strangers. Never send funds in cash, checks, gift cards or wire transfers to someone you don't know or haven't met. No legitimate company will ask you to pay them to get a job.

• Be very wary of some positions. Some types of jobs are more likely to be scams, such as mystery shopping or secret shopper positions or work-from-home jobs that involve receiving and reshipping packages.

Several years ago, a friend's grandmother died, leaving her fully furnished house vacant and eventually going up for sale. But before my friend could list it, a couple broke in and set up housekeeping. They were squatters. Local police in the small North Georgia town said they couldn't help because the house appeared to be occupied. Yes, it was. With trespassers. The couple eventually left, and the house was sold.

But if Flash Shelton had been around then, he could have evicted the couple much sooner, possibly in one day.

Shelton faced a similar predicament after his father died and his mother moved from Northern California to live with him in the San Fernando Valley. The house was put on the market, but, before long, Shelton was receiving calls from realtors saying they wanted to show the house, but it was occupied.

Shelton spent a day coming up with a plan. He spent the next day confirming it was legal. His plan

and to expose them on YouTube and social media if he had to. He didn't have to. He gave one of the squatters-there were five men and two women—until midnight to get their furniture out of the house; otherwise, he would give it away. The squatters didn't make the deadline, but they were out by 2 or 3 a.m.

Shelton published part of the encounter on YouTube, and suddenly he became-drum roll, please-the Squatter Hunter. His solution: squatting on squatters. His motto: "If they can take a house, I can take a house."

He made himself available for consultations with victims of squatters-he's done hundreds of them-requiring nothing more than a on squatters.

"Figure that out and let me know," he said. "It defies all common sense." His best supporters, he said, are people in law enforcement. They want to do what he's doing.

Actually, Florida has a new antisquatting law, thanks in part to Shelton. He was there to speak when the bill was signed.

If you watch Shelton at work on YouTube, you'll see that he's pretty nice to the squatters. "I have to be nice but stern," he said. His objective is to get rid of squatters. He's not looking for a fight.

And, by the way, he doesn't want to do this the rest of his life. At 56, he just wants to travel, but not to squat


