# **Barnwell teen** competes at Miss S.C. Teen USA pageant

nna Kate Richardson is the first Miss Barnwell County Teen USA to represent the county at the annual Miss S.C. Teen USA pageant held in North Charleston.

Richardson, a 17-year-old junior at Barnwell High School, competed against 38 women in the teen division at the state pageant. She was a finalist in the top 16 and was voted the People's Choice winner.

"It felt really cool that I was the first Miss Barnwell," said Richardson. "It was really cool meeting all the new girls that I've never met before and doing a state pageant because that is something that I've never done."

"It was a moment I don't think I'll ever forget; it was just one of those moments that you see your child live a dream that she's had since she was six," said Richardon's mother, Kim Bradley Richardson.

On the weekend of March 3 and 4, Richardson stepped out of her comfort zone and onto the stage at the North Charleston Performing Arts Center - something she'd worked for since starting pageants at the age of six.

Although she took a break from competing during her adolescence, Richardson found her way back to pageantry when she won a school Miss Frog Jump at the Town of Springfield's annual frog jump and egg strike in the 18 to 25 division idea of competing on a state level. pageant world. # Fairfax tire plant bringing 1,000 jobs

A Vietnamese tire manufacturing company is bringing 1,000 jobs and one million tires to Allendale County.

Tin Thanh Group is the first

Vietnamese industry to be established in South Carolina, and Allendale County is the first U.S. location for Tin Thanh Group operations.

"Tin Thanh Group will operate a world-class, state-of-the-art, tire returning facility that will eventually produce over 1 million tires here in Allendale County," said Keith Sernick, counsel to the Tin Thanh Group and economic development specialist. "We anticipate hiring, within five years, over 1,000 well-paying jobs right on this land."

Tin Thanh Group is a corporation aiming to provide sustainable energy from reusable sources that emit a lower carbon emission level for a cleaner environment.

'It's life changing, this doesn't happen everyday in Allendale, this doesn't happen everyday anywhere," said Senator Brad Hutto. "This is going to be a great opportunity for all the citizens in the area to prosper."

The group has many fields of operation such as recycled energy, closed-industry agriculture, saving and reducing emissions, biomass power, as well as the tire leasing service being brought to Allendale County. The tire service is done through a partnership with DRC Tire, a major tire manufacturer in Asia and biggest brand tire in Vietnam.

"The Tin Thanh group will be joining our very impressive automotive and tire industry. We are the national leader in the export of tires, and with

# Animal Advocates continue mission through changes

he Animal Advocates' Meowmate/Muttmate, a program through Allendale Correctional Institute in coordination with The Animal Advocates, has ended due to complications with COVID-19 pandemic regulations.

The organization's Friends for Life Foster/Adoption Center located in Barnwell houses animals from the Barnwell County Animal Shelter and gives them a longer time frame to be adopted, fostered, or sent to jail.

"A couple from Columbia came to look at a cat. The husband came out and he said, 'What do you do to these cats? These are the friendliest cats I've ever seen in my life.' I said, 'Well, we sent ours to jail,' and he just looked at me like I had lost my mind," said Vikki Scott, president of the Animal Advocates and director of the Friends for Life Foster/ Adoption Center.

In 2005, Scott founded the Animal Advocates, a nonprofit rescue organization that supports the neglected, forgotten, stray, and abused animals of Barnwell County in cooperation with the Barnwell County Animal Shelter (BCAS), Barnwell County, and the City of Barnwell.

Meowmate/Muttmate was a program that paired animals in need of love with someone to love them. It all began with John Pate, former warden at Allendale Correctional Institute, who was looking to implement a new progr

said Scott.

Even though this program was wildly successful, Scott had to end it due to complications with the COVID-19 pandemic.

"I kept it going for almost two years during COVID, but they wouldn't let me go in. So that was a problem," said Scott. "And then John, he was leaving so I couldn't get in there to train somebody. So, I just had to do what was best for the animals and take them out."

The Meowmate/Muttmate Program will not be returning in the short term.

"At this time, it's not possible due to recent changes at Allendale Correctional," said Scott.

Although this program is ending, Scott hopes inmates and their animals have benefitted from it. Not only were they able to build a relationship with an animal at a potentially trying time, but many were able to leave Allendale Correctional as certified groomers.

"You go in with one mindset and you come out...I never knew we've made such an impact," said Scott, a registered nurse.

Scott's sentiment can be found in her work in this specific program, as well as in the overall establishment of The Animal Advocates.

A 98 percent euthanasia rate at the BCAS was enough to make Scott change her focus in the medical industry from people to animals.

The Animal Advocates was born out of Scott's experience with BCAS. When Scott and her family moved to the area in 1986, she did not know about the challenges the BCAS faced until her daughter Kimberli wanted to volunteer. Scott's daughter was in middle school at the time, and was too young to be of volunteering age at BCAS. This ended the Scotts' involvement with the shelter until 2005, when Hurricane Katrina ravaged the east coast. "When Hurricane Katrina hit, we started getting supplies, and we had people here that were willing to go down and help to rescue," said Scott. "We helped rescue a lot of animals and some of them were brought back here. I fostered two at my house, and I ended up finding their owners in Ohio and reuniting them." At this time, Scott and other dedicated volunteers were compiling donations for animals and shipping them to places in desperate need of products and rescue supplies. Their team became unified under the non-profit organization, The Animal Advocates. Scott's team was nearing the end of sending supplies, and were still receiving donations. They decided to give the surplus to BCAS. "It was the first time I had been there," said Scott about her first visit to the county shelter in 2005. "I'm embarrassed to say that, but back then, the awareness was not there." The BCAS is county funded, and operates under a dedicated staff in conjunction with the Barnwell County Animal Shelter Foundation, a non-profit organization created to support the shelter and local pet owners through a low-cost/no-cost spay and neuter program. They have paid for over 3,000 of these operations. "We took [the supplies] down there, a few of us, and we just looked at each other

and said, 'This is deplorable. We got to do something. The euthanasia rate was 98 percent," said Scott. "We did try to help as volunteers."

Seventeen years ago, much like today, BCAS was in need of help from the community and support from the county. In 2005, Scott and her team of willing volunteers were not easily able to make the change they hoped for within a county-run institution.

"I'm not somebody that throws their hands up and gives up. I'm somebody that says 'We'll find a solu-tion,''' said Scott. "The only solution I know is to build a facility, get the animals out of there as quickly as we can and get them the medical attention they need and then get them homes.'

In 2006, The Animal Advocates started a low-cost/ no-cost spay and neuter program. Vouchers for free services would be handed out in areas where volunteers knew animals were not being fixed.

However, Scott still had sights on a facility capable of providing medical care, behavioral work, and then hopefully, a loving home.

The 13.5 acres of land was purchased in 2008 and the facility was built in 2013 after a capital building campaign and a substantial grant.

Built with function in mind, there are two defined wings - one for dogs and one for cats. Each comes with its own laundry unit and sterilization process, which Scott deems vital to keeping illness at bay.

Now, Scott and the employees of the facility, known as the WagStaff, have implemented numerous programs within The Animal Advocates in addition to Meowmate/Muttmate.

Scott describes her team as wonderful and loving when caring for the animals, however, they have recently been facing one challenge.

Scott and the WagStaff have a passion for their job and a love for the animals they help.

'This is very rewarding but it's also very sad," said Scott. "We see a lot of bad things and you sometimes don't like people because you know what they've done."

Although the work can cause heartache, Scott's dream of creating an animal rescue has resulted in hundreds of lives being saved.

"In 2012, I had a call from a friend of mine that was executive assistant to the warden at Allendale Correctional in Fairfax," said Scott, whose friend explained Pate was in search of an animal rescue to help him start an animal program at his prison.

After some discussion and debate between Scott and Pate, she had permission to bring nine cats to keep the inmates company.

"Next thing I knew I was in a dorm with 300 and something inmates," said Scott.

The Animal Advocates quickly became the only rescue in South Carolina to implement a cat program into a prison, according to Scott.

"I could have 24 dogs there, and they never gave me a number on cats," said Scott. "I usually kept between 25 and 35 cats. It gave us a place for at least 50 more animals so that we could save their lives."

Scott spent two or three days a week at the prison, checking up on animals and training the men on how to train the animals. Working alongside Scott was John Simpson, a veterinarian emplovee and an inmate at Allendale Correctional.

'He knew his stuff. He had worked in a vet's office since he was 16 years old and he was 53," said Scott. "Nicest guy you'd ever wanna meet, unfortunately has a drug problem, and it gets him in trouble. You would trust any animal with him. He was just wonderful."

The Meowmate/Muttmate program ran for nine years and roughly 60 animals were adopted by inmates who were released, by an inmate's family, or by prison staff.

"Over a thousand animals went through those gates,"

The other 13 awards were bestowed to individual staff members.

Vickery won five individual awards, including first place for Government Reporting. This entry included three stories on local government, including one from 2022 where Barnwell City Council held an illegal closed session.

# **Corder's Creative Corner**: Some quick thoughts on Poe

With the release of the Netflix show "Wednesday" featuring Jenna Ortega as Wednesday Addams, there has been some renewed interest in dark and gothic things. At least, there has Poe's stories. For goodness' been for me.

One thing I like about the show is that it features references. Wednesday attends Nevermore Academy. There is a Poe Cup competition where the students dress up as characters from

sake, there's even a huge statue of him in the school. Naturally, I took an intermany Edgar Allan Poe est in the show, and it reminded me of my love for Poe and his macabre sense of reality. My students will tell you that I'm a huge fan. Every other Friday I walk into school with a T-shirt displaying Poe's somber visage.

But why do I admire Poe? Well, I suppose it's because of his dark stories and how they resonate with me.

Poe is a master of exposing the darkness of the human mind. If anyone wants to find a monster, they have to look no farther than inside their own heads. And Poe makes that quite clear with his use of

tably, there are three stories where this is shown, they being "The Tell-Tale Heart," "The Black Cat," and "The Cask of Amontillado." All three stories are about narrators who commit murder, and none of them are identifiable.

In these stories, Poe is maddeningly consistent with refusing to identify who the narrators are in these stories (with the exception of Montressor in "Cask," but we don't get anything other than his last name). It is through these faceless narrators that we are easily able to assign them faces of anyone we want. As I pointed out to my students as we discussed "The Tell-Tale Heart" a few

could be anyone. It could be anyone.

What Poe does is expose the vileness and darkness of the human psyche. We all have the capability of evil. We all have the means to be vile and perverse. Poe knew this. And he tells us this. He practically shouts at us, "You'd better be careful, lest you become a mur-

derer yourself.' Stories like the ones Poe creates are pessimistic and gruesome. But they also function as a warning. A warning that prompts us to take a look inside ourselves and examine our hearts. Do you burn with vengeance like Montressor does as he broods on his anger towards Fortunato? Are you

the unreliable narrator. No- weeks ago, the murderer driven mad by a Vulture Eye to the point that you no longer have self-control? "Take heed and know thyself," Poe tells us through his stories. "We are all on a slippery slope, and if you aren't careful, you'll go tumbling down."

> There are many reasons I love Poe, but his talent for surgically opening the back of our skulls to expose the complexities and shadows of our minds to the light of the world is strongly compelling. By reading Poe, you get a taste of how vile humans can be, and by doing so, you strive to be noble and upstanding instead.

E ach year, the Barnwell Soil & Water Conservation District awards a farmer or landowner for outstanding conservation efforts.

On February 28, 2023, the District hosted a luncheon at the Edisto Research & Education Center in Blackville. Secretary/Treasurer Rebecca Davis presented a plaque to Samuel L. Grubbs, the 2022 Conservation Farmer of the Year, for his dedication to farming and natural resource conservation.

"It is not easy being a first generation farmer, but you have without a doubt put your heart and soul into this love of yours," said Grubbs' wife Ashley. "It makes me so proud to see how much you care about these crops. You sacrifice so much."

Grubbs is a row crop farmer who has conserved soil and reduced runoff by installing a grass waterway and strip-till planting all row crops. Nutrient and pest management practices are utilized on his farm to benefit crop production while minimizing impacts on the environment. Winter cover crops are planted on many acres each year to improve soil quality, according to a press release.

llendale County Hospital (ACH) is a small, rural hospital, but it recently received two big honors.

ACH received the Rural Health Provider of the Year award from the S.C. Office of Rural Health (SCORH). This award is presented to a provider of rural health services where the health status of a rural community was significantly enhanced.

"We are a small hospital doing big things. We are very devoted to good, quality patient care," said Tammy Smith, ACH's director of information technology and human resources.

ACH is a 25-bed critical access hospital and one of the only remaining independent hospitals in the state. In 2021, they were named a Top 20

ties in the state and one of the most underserved communities in the state," said Lari Gooding, ACH's CEO since 2015.

Gooding was recognized recently by Becker's Hospital Review on their 2023 list of 80 Rural Hospital CEOs to Know. This medical industry trade magazine does its own research that is supplemented with government-released data and U.S. News & World Report rankings.

#### Enforcement of County Ordinance 2022-05-389 regarding the **Barnwell County Cemetery**

Barnwell County, in March and April 2023, will increase enforcement of the county cemetery ordinance by removing "containers, artificial flowers, wreaths, statues, or memorial type items" that have been on burial plots for more than 60 days, unless they are incorporated within the headstone. This includes benches, lighting fixtures, and other mementoes. The exception to this is if the items are located within plots comprised of commercial coping and commercial gravel.

Additionally, flowers, whether artificial or cut, will be removed from throughout the cemetery if after 60 days they appear worn, frayed, etc. Removal of flowers is ongoing.

U.S. flags that are frayed and worn will be removed.

Family members are encouraged to remove above-mentioned memorial items / mementoes by March 29, 2023 if they desire to do so. County staff, to the best of its ability, will label and store the memorial items removed from the cemetery for 30 days so families can reclaim them if they desire to do so.

No plants, trees or shrubs may be planted on any plot, except by the county as part of an approved landscaping plan. Ongoing is the removal of trees and bushes currently damaging coping around the plots, or which will damage coping in the future.

All plots are to be used or reserved exclusively for the burial of human remains.

All plots and/or burial sites shall be marked with a grave marker indicating the name, date of birth and date of death of the deceased.

# Corder's Corner: Time is Short

This year marks 15 years since the actor Heath Ledger passed away. For me, his greatest role was The Joker in the Batman film, The Dark Knight. He was fantastic in the film, one of the greatest roles ever. Ledger changed acting. However, his life was cut short, and he died of drug overdose at the age of 28.

This is startling to me. I am 27, and I did not realize how young Heath Ledger was when he passed away. I find it surreal that we were basically the same age. Then I think of others who died around the same age...Kurt Cobain, Jimi Hendrix, Jim Morrison, Amy Winehouse...the whole 27 club. Talented lives cut tragically short.

Then I think of other people I admire. Edgar Allan Poe and John Lennon were both 40 when they died. 40 is an age farther down the road for me, but only by 13 years, and when you think about it, 13 years isn't a very long time. And whether you are 27, 40, 60, or 99, death comes for all of us, and as I approach 30 I find myself asking "Where did all the time go?"

What's more, I am not promised that I will even turn 30. I am not promised that I will be alive tomorrow. That all is in God's hands. Life is fleeting. As it says in James 4:14, "yet you do not know what tomorrow will bring. What is your life? For you are a mist that appears for a little time and then vanishes" (ESV). And instead of being shocked or worried or depressed by this, we should feel prompted to live our lives more fully. Not in a foolish way, but in a wise way.

There are several points we need to take away from this idea of time being short:

#### 1. Time is not something to be wasted.

We all have something we need to be doing. And that thing should not be wasting time. We should not be wasting time by staring like zombies at our television screens and phones for hours at a time. We have relationships to cultivate, vocations to heed. Will it really matter at the end of your life how many shows on Net-

flix you have watched? Will it really matter how many likes you got on Facebook or Instagram? Time is short. There are things to be done, and great, holy pleasures to be enjoyed. Pursue them in the name of God. As it says in Ecclesiastes 3:12-13 "I perceived that there is nothing better for them than to be joyful and to do good as long as they live; also that everyone should eat and drink and take pleasure in all his toil-this is God's gift to man" (ESV). Find the work that gives you pleasure and that glorifies God and do it.

#### 2. We are not promised another day.

Make the most of today, because it may be your last. And I do not say this to instill fear. I say this to instill urgency. If today was your last day, how would you live it? How would you be treating those around you; your family members, your enemies? Would you use it to spend three hours watching TikTok? Would you use it to continue holding that grudge against your ex-spouse who wounded you thirty years ago? Live today like it is your last, with the wisdom that tomorrow is still possible (that means don't sell everything you own or blow all your money on poker. There's a good chance that you'll still be alive tomorrow).

#### 3. When all is said and done, where will you be?

This life is the tiniest drop of existence in the ocean of eternity. How we live, who we believe in, all of it matters. At the end of this lifetime, we will be headed for one of two places: enjoying eternity with Jesus in Heaven, or suffering forever in the fires of Hell. And I write this because it is an urgent thing that people must know...it is the most important thing in all of existence to know. So, I ask you to consider this: if you were to die today, are you sure that you would be going to the destination that you want to go to?

Consider where you are in life. Consider what may happen next. Don't waste your life, however much of it is left to live. Embrace Jesus, and live for His Glory. Time is too short to do otherwise.







# Grandparent scams still targeting seniors

Everyone knows that one of America's most popular meals, the sandwich, was invented by John Montague.

Who? Well, you might know him as the Earl of Sandwich. The story goes that Montague was so addicted to playing cards that he refused to take breaks for meals, preferring to take his meat and cheese between two slices of bread.

The invention became so popular that it came to be known as a "sandwich" in the Earl's honor.

Truth is, Montague suffered from a gastro-intestinal disorder brought on by a severe wound received during a naval battle at the age of 17. From that point on he had to subsist on liquid meals.

Nevertheless, he may still have had a role in popularizing the sandwich. In 1748 he visited France, where he discovered that landowners provided their field workers with a noontime meal. The most common meal was made by placing meat, potatoes, vegetables, and sauce between two thick slices of bread.

He was so impressed by the economy of the meals that on his return to England he began to feed them to his workers.

Whatever the truth of their origins, there is one overriding truth about sandwiches: they taste GOOD. Everybody has a favorite – the tomato sandwich, peanut butter and jelly, ham, and cheese on rye, or chicken salad. The list goes on and on and on.

White bread is probably the most common choice for the great American sandwich. Many diehard tomato fans proclaim that white is the only bread that should even be considered for the sacred tomato sandwich. PB & J lovers often echo that sentiment.

But when it comes to other sandwiches, whole grain bread, with its nuttiness and chewy texture adds low in total fat, saturated fat, and cholesterol may reduce the risk of heart disease and some cancers.

Other options include pita bread, with its light taste as a perfect backdrop for intensely flavored fillings; or Italian, soft in the center with a crunchy crust is great for hot sandwiches.

How about raisin bread? Try ham and cheese on raisin bread, lightly grilled. Or, run English muffins under a broiler when topped with tomato slices, scrambled eggs, and bacon.

Instead of always making plain ham, turkey, roast beef, or cheese the dominant flavor of your sandwich, why not spice things up with a generous dose of Cajun seasoning or Italian herbs? You could add curry powder to chicken salad or lemon pepper and celery seeds to tuna. Slather honey mustard on your turkey or ham. Or, top your grilled chicken with hot sauce and blue cheese.

Don't forget the veggies when you think of sandwiches. Sliced tomatoes and lettuce are always popular additions, but those are just the beginning.

Consider taking your sandwich a step further. Cucumber slices are tasty on a cold sandwich. Thinly sliced onion and bell pepper quickly sautéed in a nonstick skillet add crunch, flavor, and an extra bit of nutrition. Coleslaw can be added to a barbecue or roast pork sandwich.

A well-made sandwich can be an economical, quick-to-prepare, well-rounded meal. Grains, vegetables, protein, and dairy can all contribute to making your next sandwich as good for your body as it is for your taste buds.

They are quick to fix from items already on hand whether you like them cold, toasted, broiled, grilled, or wrapped in foil and baked.

So, thanks, Earl, for the sandwich. If you never ate one, you don't know what you were missing. Or, maybe you do.

The Better Business Bureau (BBB) is still warning well-meaning seniors about "emergency" scams designed to fool them into thinking that their grandchild is hurt, has been arrested or is stranded, and in need of money.

According to recent FBI reports, the "Grandparent Scam" has been around since 2008, but they continue to plague well-meaning seniors. Retirees are an attractive target for financial scammers since they may have more disposable income and they are less likely to report being scam victims. Emergency scams play off of peoples' emotions and strong desire to help others in need. Scammers impersonate their victims and make up an urgent situation – "I've been arrested," "I've been mugged," "I'm in the hospital" and target friends and family with urgent pleas for help, and money.

One victim reported sending four transactions totaling \$4,400 over a two-day period. She was duped after receiving calls alleging that her grandson had been arrested after being in an accident. The money was initially to cover fines and representation to get the grandson released. Soon, the caller needed money to cover the medical bills for a person injured in the accident. The victim claims that the scammer not only knew details about her grandson but also allowed her to briefly speak with someone that sounded like her grandson.

We also see this scam target families with loved ones deployed overseas, claiming to need the money to get back from a weekend pass. If you don't send the money, they face being arrested for being absent without leave (AWOL).

BBB offers the following tips to avoid the Grandparent Scam:

• **Communicate.** Loved ones should share travel plans with family members before leaving the state or country. Also, discuss this scam with older family members so they are aware of how the scam works.

• Share information. Loved ones should provide the cell phone number and email address of a friend they are traveling with in the case of an emergency. Family members should remind students to be cautious when sharing details about travel plans on social media.

 Know the red flags. Typically, the grandparent receives a frantic phone call from a scammer posing as their grandchild or a so-called "officer of the court". The caller explains that the grandchild has gotten into trouble and needs help, perhaps caused a car accident, or was arrested for DUI or drug possession. The 'grandchild" pleads to the grandparents not to tell his or her parents and asks that they wire thousands of dollars for reasons of posting bail, repairing the car, covering lawyer's fees, or even paying hospital bills for a person supposedly injured in a car accident.

• Ask a personal question, but don't disclose too much information. If a grandparent receives a call from someone claiming to be their grandchild in distress, BBB advises that the grandparent not disclose any information before confirming that it really is their grandchild. If a caller says, "It's me, Grandma!" don't respond with a name, but instead let the caller explain who he or she is. One easy way to confirm their identity is to ask a simple question that the grandchild would know such as their middle name or what gift they gave the grandchild for Christmas.

• Discuss with family members. Even though the scammer will plead with you to keep this a secret from the parents, discuss the situation with someone and chances are you will find that your grandchild is safe and secure at home.

For anyone victimized by this type of distressed loved-one call, BBB recommends reporting the incident immediately to your local police department and BBB Scam Tracker. For more consumer tips you can trust or to report a scam, visit bbb.org.

Please be assured that safety is of the utmost priority in Barnwell School District 45, and an emphasis is placed on safety across our school district. As you know, our high school has been the target of recent bomb threats. The Barnwell County Sheriff's Department and the South Carolina Law Enforcement Division (SLED) are actively working to determine who sent the email threats and using their tools and resources to continue actively investigating, and we are working closely to proNational Association of School Resource Officers has shared that the motives for these continued attacks appear to be intentions to cause mass panic or disruption. It is extremely disappointing these threats continue to happen statewide, and even nationwide, and it is especially concerning to us that it has taken time away from our greatest job of educating our students.

We are fortunate law enforcement and emergency responders respond so quickly, and we have been able to activate our plans and return to normal operations as quickly as possible; however, any loss of instructional time is too much. Please be assured that Barnwell High School administration is working diligently to plan with the staff how to address any lost instructional time that has happened due to this situation, and the high school will support our students as they "catch up" on any instruction they need to recover from any lost instructional time. We are so fortunate we have a wonderful partnership with local law enforcement and emergency responders, as well as having a strong safety plan in place with a specific bomb-threat response protocol. Our administrators continue to train our staff members and students on how to execute those plans in the case of an emergency. Part of our plan includes maintaining open communication, providing accurate information to our parents, and striving to be as transparent as possible when informing our families of allegations, such as bomb threats, while still maintaining the integrity of the investigation. Parents/guardians of BHS students have been notified during and after each evacuation response, and they were also made aware prior to the high school searching bookbags upon arrival as a

During the most recent meeting with SLED, we were presented with information regarding SLED's newest recommendations to handling these threats in the safest and most efficient way. Having that meeting allowed our leaders to consider other responses to threats such as these, and the Board of Trustees and district officials are currently reevaluating how the recommendations from SLED officials could be incorporated into our districtwide BSD45 Comprehensive Safety Plan.

As part of our continued partnership with our parents and families, we ask you to please continue to encourage your children to report any behavior that could in any way compromise their safety or the safety of others. We also ask you to work with us to express to your children the seriousness of a crime such as this. Threats are not a joke or prank, and they will always be taken very seriously. If a student is caught making a threat that disturbs the school environment, we will seek consequences to the fullest extent of the law, including criminal charges and expulsion. The district is so grateful to SLED, our Barnwell County Sheriff's Department, Barnwell Police Department, Barnwell Fire Department, Barnwell County Emergency Management, Medshore, and Savannah River Site for the prompt and thorough assistance they have provided when securing the building and activating our emergency protocols. We also thank our administrators, staff, and students for quickly executing our emergency response plans. As always, we are also grateful to our parents for working together with us to ensure a safe learning environment for all of our students.

vide any information that would be helpful in the investigation.

We, along with our local law enforcement and emergency management, have met with SLED agents in person, and Special Agent Josh Deurkop from SLED's Bomb Squad unit came to meet with our Board of Trustees during a special-called work session this week. Also attending that meeting were local law enforcement leaders, emergency management leaders, district leaders, and principals. Special Agent Deurkop's first words were that we are not alone, and SLED has seen unprecedented rises in bomb threats statewide and nationwide. We can assure our families and community members that our local law enforcement and SLED consider this a huge priority in our district and across South Carolina.

Unfortunately, there have been numerous bomb threats in recent media reports, both statewide and nationwide, and many have happened in clusters. We have seen several other school districts in the state who have had bomb threats multiple days in a row, as we have recently experienced. Last week, during one of our threat responses, there were at least 12 other schools in the state experiencing the same situation. The






