# Grant to help veteran

GROVETON — In a spot of good news in the midst of the disaster aftermath, Trinity County Commissioners Court celebrated the receipt of a

grant that will help veterans in the county. Grant administrator Vicki Branch informed the court at the June 25 meeting that the county was awarded \$180,000 from the Texas Veterans Commission Veterans' Assistance Grant for 2024/2025. The funds will be used to provide services for qualifying veterans and their families beginning July 1, to June 30, 2025.

Branch said grants like these can make a significant difference in supporting veterans and their families who have sacrificed so much for

By providing food allowance, rent, utility sup-

port, and transportation support, Trinity County helps alleviate financial burdens and ensure basic needs are met. Assistive technology includes hearing aids, mobility devices, Orthotics, and other devices that will greatly improve the quality of life for veterans with disabilities.

Financial assistance may include rent, utilities (water, gas, electric), food, and assistive technology and transportation, such as hearing aids and lift chairs. Also, the money can be used to assist the repair of scooters.

Additionally, there is help for utilities and even rental assistance.

"We're trying to get them some help, the younger veterans looking to get back to work or the older ones who need help," Branch said.

Eligibility guidelines have been established using specific income brackets and other criteria to determine the need for financial assistance; veterans must be a Trinity County resident and have an honorable, general under honorable conditions, or uncharacterized discharge.

Dependents include legal spouse, child, stepchild, or legally adopted child under the age of 18: disabled adult child who requires care by an adult, adult child attending high school or college and under the age of 23, and surviving spouses must have been legally married to an eligible veteran at time of his/her death and not have remarried.

Other requirements for members or spouses include a valid state-issued ID/DL, or military ID, and a marriage license for spouse. Dependents need also a birth certificate or adoption certificate. # Fight leads to shooting, r

TRINITY — A 35-year-old Trinity man is facing an assault charge after an argument led to a shooting that forced law

enforcement officials to call out the dogs. Shyan Spikes is being held on a charge of aggravated assault with a deadly weapand may have additional charges filed according to Trinity County Sheriff's Office Chief Deputy Jeremy Carroll.

Carroll said that on Wednesday, an al-

tercation between Spikes and victim Jamie Driggers, 35, was reported. The reason was not known; however, Driggers reportedly drove past Spikes' residence, and two shots were fired in Driggers' direction.

The bullets hit Driggers and his vehicle, who then he went to a nearby house and asked for ambulance.

Carroll said that when law enforcement ficers arrived at the scene of the attack a witness told them about the shooting. Deputies began a search, which ended up in the Lake L subdivision.

From there, law enforcement officials set up a perimeter and called for the Texas Department of Criminal Justice tracking dogs. After a short period of time, as dogs were being deployed, Spikes came from 10-15 yards in woods and was arrested 700 block Darrell Hall Road, Carroll said.

The search lasted just under three Driggers, 35, was listed in

stable condition at a hospital in Houston. Also assisting in the investigation was the Trinity Police Department.

# Lake Livingston Dam under failure watch

The Trinity River Authority is confirming that the spillway of the Lake Livingston Dam and spillway have been adversely impacted by the recent heavy rainfall and flooding in the dam's drainage area, resulting in the declaration of a "potential failure watch" condition which requires continued moni-

toring and evaluation of the spillway's integrity, as well as the implementation of necessary repairs and remedial ac-

Although there is no immediate danger of either failure or breach of the dam, the potential does exist however remote it might be.

The day-to-day operation of the dam will continue as necessary, although normal gate operations may vary as conditions dictate.

This declaration is in conformance with the Emergency Action Plan as approved by the TRA, which will monitor the spillway's status and will issue updates as necessary.

# **Board approves** termination

TRINITY — After a closed session, the Trinity ISD Board of Trustees approved the termination of the district's transportation

Superintendent Dr. John Kaufman said that the contract for Robert Redmond was terminated on the night of the June 24 board meet-

According to police reports, Robert Ryan Redmond, 52, was arrested June 11 on a charge of theft of property of more than \$2,500 but less than \$30,000, a third-degree felony. He was released on a \$20,000 bond.

A special meeting was scheduled for Tuesday to discuss hiring a replacement.

• approved research into the cost feasibility of implementing a cosmetology program for the district.

# City looks for land for water storage

**GROVETON** — City officials are looking to contract with the U.S. Forest Service for land to build a second storage tank for the city's At the June 24 meeting, the Groveton City Council discussed its

latest option to improve water service — leasing land in Davy Crockett National Forest for a ground storage tank and booster pump sta-

Mayor Ralph Bennett said that the land in question is next to the city's existing Pennington connection, which is the source of city water, near the corner of Highway 287 and FM 3154.

Bennett said this will increase capacity and provide a long-term water source. He also said they are still searching for another well location for an additional water source. In other business, the council:

## FEMA assistance available for churches

FEMA may provide funds to houses of worship and other private nonprofit organizations to help pay for emergency protective measures, debris removal and restoration of facilities damaged by the storms and flooding April 26-June 5 in Texas.

FEMA's Public Assistance program may cover costs to repair or replace damaged facilities or provide funding for hazard mitigation measures during the recovery process.

Eligibility requirements include:

• The house of worship must be owned or operated by a private nonprofit organization and have sustained damage caused by the storms. • The facility must be open to the public.

•The application must include state and/or U.S. Internal Revenue S ervice documentation of tax-exempt status, pre-disaster charter and other documentation.

Organizations that provide non-critical services may be required to apply for a low-interest disaster loan from the U.S. Small Business Administration (SBA) to be considered for Public Assistance

FEMA may also be able to help if you are an employee and you lost tools or equipment required

for your job and not reimbursable by your employer.

Eligible work tools

Tools and equipment required for self-employment or required, but not provided, by an employer. Examples of tools include:

•Computers required by an employer or for self-employment when you are responsible for the replacement of the computer.

•Tools and equipment such as power tools, art materials, musical instruments, tractors, utility vehicles, lawnmowers, ladders, etc.

•Uniforms required for work when you are responsible for replacement of the uniforms.

## STAR Fund supports Texas ag producers affected by natural disasters

AUSTIN — Texas Agriculture Commissioner Sid Miller and the Texas Department of Agriculture urge all agriculture producers affected by recent severe weather disasters to apply for the State of Texas Agriculture Relief Fund Disaster Assistance Program.

This essential program provides financial support to help with clean-up and rebuilding efforts, offering crucial assistance to those on the front lines of these natural disasters. Qualifying applicants can receive a cost-share of up to 80 percent for eligible disaster recovery expenses.

"Texans are no strangers to extreme weather," Commissioner Sid Miller said. "Farmers and ranchers across the state are trying to rebuild fences, clean up their properties, and pick up the pieces from Mother Nature's latest curve ball. That's where the STAR Fund comes into play and why it was created — to help support folks during challenging times and to help them get back on their feet. TDA is committed to providing whatever help we can. I hope producers who need a little help will apply for assistance. That's what this money is for."

The STAR Fund currently has more than \$1.2 million available to support agricultural producers. Fully funded by private donations, the STAR Fund provides resources to applicants in counties that have been declared disaster areas by the Texas Governor.

Currently, assistance is available for multiple disasters, including the 2024 Panhandle wildfires and the severe storms that occurred in April and May 2024. Producers affected by these events are strongly encouraged to apply

As disasters increase in scale, support for agricultural producers has become even more important—the Smokehouse Creek Fire, for example, became the largest recorded fire in Texas history in 2024. The STAR Fund is a recognition of the harsh realities Texans face, and TDA is dedicated to ensuring that producers receive the support they need and deserve.

"Folks, I urge you to apply for these funds, because every single Texan across our state depends on our agriculture producers to provide the food and fiber to keep us alive and keep our economy strong," Miller said. "Every single dollar in the Star Fund was donated by a private person or business - none of the funding is from taxpayer dollars. This money was donated by good, hardworking people who just want to help their fellow Texans get their operations back up and running."



The Chevron deference doctrine allowed that in cases where law wasn't specific enough, a federal agency can interpret the law and courts were bound to uphold it. The new ruling puts the question of interpretation back in the hands of the courts.

Will it help? Probably, in the Problem 1 is that has yet to work, long run. But ultimately, unless the inexorable appetite of the government for control is ended, pretty soon there will be no freedom except what is granted to us by government, not endowed to us by the creator.

# Energy fund program hit with numberous applications


around your state: •Texas Energy Fund oversubscribed The Public Utility Commission of Texas announced this month that the newly created Texas Energy Fund has received 125 notices of intent to apply for the In-ERCOT Generation Loan

program. The notices request almost \$40 billion in financing for new dispatchable power generation projects. This indicates strong industry response and interest in the low-interest loan program created by the Legislature last year.

The initial program was designed to provide low-interest financing for new construction or upgrades to existing dispatchable electric generating facilities in the ERCOT power region. Currently, the program has only \$5 billion available for its various programs.

However, the intention of the Legislature was to fund the program in two stages, with an additional \$5 billion infusion next session, for a total of \$10 billion in new investment.

The In-ERCOT Generation Loan Program is one of four TEF programs



established by Senate Bill 2627 by Sen. Charles Schwertner. All four programs are designed to support the construction, maintenance, modernization, and operation of electric facilities in Texas both inside and outside the ER-COT power region.

• Teacher Incentive Allotment funds roll out to schools

This month, the Texas Education Agency announced more than \$290 million in Teacher Incentive Allotment funds have been awarded to almost 25,000 designated teachers.

The program was created by House Bill 3 (86 Regular Session) in 2019 to provide top-performing teachers with an accessible pathway to a six-figure salary. Teachers earn designations from their district's designation system, or a National Board Certification, which generates extra funding for the

This program incentivizes highquality teachers to stay in the classroom while receiving better pay. More than 300 districts have fully implemented a TIA program, including many in East and Southeast Texas, and more are working through the rigorous process to implement a program.

The Senate Business and Commerce Committee met this month to discuss interim charges including electricity market design, transmitting Texas power, and the impact of Bitcoin mining on the Texas electric grid.

The committee heard from officials at the Public Utility Commission, ER-COT, Office of Public Utility Counsel, the Independent Market Monitor, and industry representatives about how the implementation of changes made during the last legislative session are effecting the market. Additionally, the panel heard from Bitcoin miners regarding the industry's impact to the

Bitcoin mines can come online quickly and usually demand a large amount of electricity. The addition of large load to the grid can create scarcity within the market when grid conditions are tight. However, Bitcoin mines are considered "flexible load," meaning that they can reduce operations and thus reduce their electricity

The new market entrants faced skepticism from members about their operations during the hearing, especially considering the load growth projections the committee received from ERCOT. Over the next six years, ERCOT is projecting a possible addition of 40 gigawatts of load compared to last year's forecast of the same timeframe — a tremendous increase from

• Texas-based stock exchange in the works

This month, the Texas Stock Exchange announced it had raised approximately \$120 million from investors to launch the new trading venture.

The TXSE would be an alternative to the New York Stock Exchange and Nasdaq, which some view as too costly and overly regulated. The financing group, which includes BlackRock, Citadel Securities, and dozens of investors, plans to headquarter in Dallas.

The TXSE founders said they chose Texas because of its explosive economic growth and population growth. Many large companies have relocated to Texas over the past decade and Texas continues to be a pro-business state.



# Fire safety urged for Fourth

With the Fourth of July bringing a possible four-day weekend for lucky Texans, the Texas A&M Forest Service urges outdoor enthusiasts to exercise fire safety outdoors, especially when using fireworks or starting campfires to roast hot dogs and toast marshmal-

Approximately 90 percent of wildfires are caused by humans and their activities, and the Fourth of July is one of the top days for reported wildfires, according to the forest service.

Large wildfires generally are not expected, and none are prevalent currently, but north and northeast Texas has received little to no rainfall since early June. That reduces moisture content and increases the potential for

"As we start to observe typical summer weather with conditions becoming hotter and drier, we anticipate wildfire activity to increase," said forest service chief Wes Moorehead. "State and local firefighters are prepared to respond quickly, but we need Texans to be careful and prevent wildfire ignitions while conditions are hot

Anyone considering using fireworks is urged to comply with any burn bans in place, follow the warning labels on fireworks, use only under close adult supervision and keep them away from structures, dry grass and brush.

Cornyn bill would increase security for judges

lish a new resource center that would monitor threats to local judges and provide training for both judges and staff at state and local courts, The Dallas Morning News reported.

At a panel held recently at the University of North Texas law school, participating judges and prosecutors expressed support for the measure, which passed the Senate unanimously in mid-June and awaits consideration

A consultant for the nonprofit National Center for State Courts said attacks and threats against members of the federal judiciary increased 400 percent from 2015 through 2021. In Texas, security incidents involving local judiciary have increased fourfold on average since fiscal year 2017, though the number dropped slightly last fiscal year.

"This isn't partisan. It's just con mon sense," Cornyn said during a news conference after the roundtable

grand jury A federal appeals court appears to have cleared the way for officials in Texas Attorney General Ken Paxton's office to testify before a grand jury probing alleged corruption, the Hous ton Chronicle reported.

While the case before the 5th Circuit of Appeals remains under seal, last week the court last rejected an unnamed state agency's attempt to stymie federal investigators from calling

While the case is under seal, the Chronicle reported, "the dates and details line up with those in the yearslong federal probe into allegations by Paxton's former top deputies, who say the attorney general took bribes to benefit Nate Paul, an Austin developer who is a friend and donor of Paxton's." The court said that the AG officials may have evidence of a potential crime, and that the Department of Justice can invoke the "crime-fraud exception" to get around potential attorney-client privileges.

Paxton did not respond to requests for comment

#### Fewer students seek financial aid after FAFSA glitches

Nearly 30,000 fewer Texas students have filled out the federal form this year to apply for financial aid after a new rollout was beset with complications and delays, the Texas Tribune

A revamped Free Application for Federal Student Aid has resulted in hurdles that have led to fewer highschool students seeking financial aid for college, with FAFSA completion rates for Texas students dropping by 8.8 percentage points. That decline is sharper than what the state experienced during the COVID-19 pan-

"These are by far the steepest declines that I have observed," said Bill DeBaun, the senior director of data and strategic initiatives at the National College Attainment Network. "It's going to take a really significant push this summer to continue to connect students with the FAFSA completion support they need and keep them on track for the post-secondary pathways to which they aspire."

The U.S. Education Department was ordered by Congress to revamp FAFSA in 2020 to make it simpler to fill out, but the new form's release came out three months late, cutting the time high school counselors had to help students with the form. Glitches were reported by many students attempting to complete the form, The Tribune reported.

#### Abbott appoints new PUC member

Gov. Greg Abbott has appointed Courtney Hjaltman to the Public Utility Commission of Texas, filling the final vacancy on that board. The PUC regulates the state's utility industries - electric, water, wastewater, and telecommunications.

Hjaltman has been chief executive and public counsel for the Office of Public Utility Counsel since December 2022. She has worked in state service for more than 17 years.

"Courtney Hjaltman's longtime service to the State of Texas and extensive legal expertise makes her the ideal choice to serve on the Public Utility Commission" Abbott said



Lake Fork crappie fishing continues to be excellent going into the dog days of summer. Fish are in all the places they should be for this time of year. Look for crappie holding on brush piles, summer time trees, lay downs, bridges and docks. You can find fish in 14-30 feet right now but it seems like those fish will be above 14-16 feet as that is where the thermocline is showing up. One of the biggest keys to loading the boat with crappie has been finding the fish that haven't been pressured as much. We are still having a lot of success with very small hand tied jigs in 1/16 ounce. Cut the tails down shorter to get those finicky bites to hook up. Minnows are producing bites but it seems the hook up ratio is much lower and we end up losing a lot of minnows to those finicky fish. Soft plastics will work on the more aggressive crappie too. Staying off huge groups of fish, pitching and swimming jigs will also help to keep those fish put a little longer. Place 3/4 ounce weight on the end of line and hook about 16 inches above. Report by Hambone Guide Service.

GOOD. Water stained; 87 degrees; 0.41 feet below pool. Largemouth bass are excellent on chartreuse deep diving crankbaits, or Carolina rigs in 15-20 feet of water. Crappie are excellent on brush piles with live minnows or chartreuse colored crappie jigs. Catfish are slow on cut bait and live minnows. Report by Cal Cameron, Cal's ETX Guide Service.

Naconiche FAIR. Water stained; 88 degrees; 0.50 feet above full pool. We have dried out and the heat is on with water temperature rising sharply. This should set up for the fish to be in full summer mode going forward. Keep an eye on the thermocline, as this tells you the exact depth to present your offering. Even over deep water, do not go below this line. The days of Mag-worm fishing are probably here for the next several months. Carolina or Texas rig will be the norm in 6-10 feet. Worms and crankbaits are successful in the cooler evening hours. Crappie are good on grubs and crappie bites fished near the bottom at prairie branch pier. Bluegill are excellent off worms and hotdogs at the

boathouse dock.

Sam Rayburn

GOOD. Water stained; 87 degrees; 7.68 feet above pool. Water level is slowly dropping, but fishing conditions and patterns are holding steady. Summer bite is just around the corner when we will see the bass draw to deeper water points and white bass schooling. Bass are good on topwaters, or flipping soft plastics into submerged brush and points, or deeper humps and points with Carolina rigs. Crappie are in 12-16 feet of water, 20-30 feet on timber and brush. Catfish are in 22 feet of water in the creek channels. White bass are in 26 feet of water off of points on jigging spoons. FAIR. Water stained. 92 degrees. Fishing patterns are consistent. Channel catfish are in 20 feet of water on the inlet side of the power plant in the cooler water with fresh cut bait and stink bait. 
